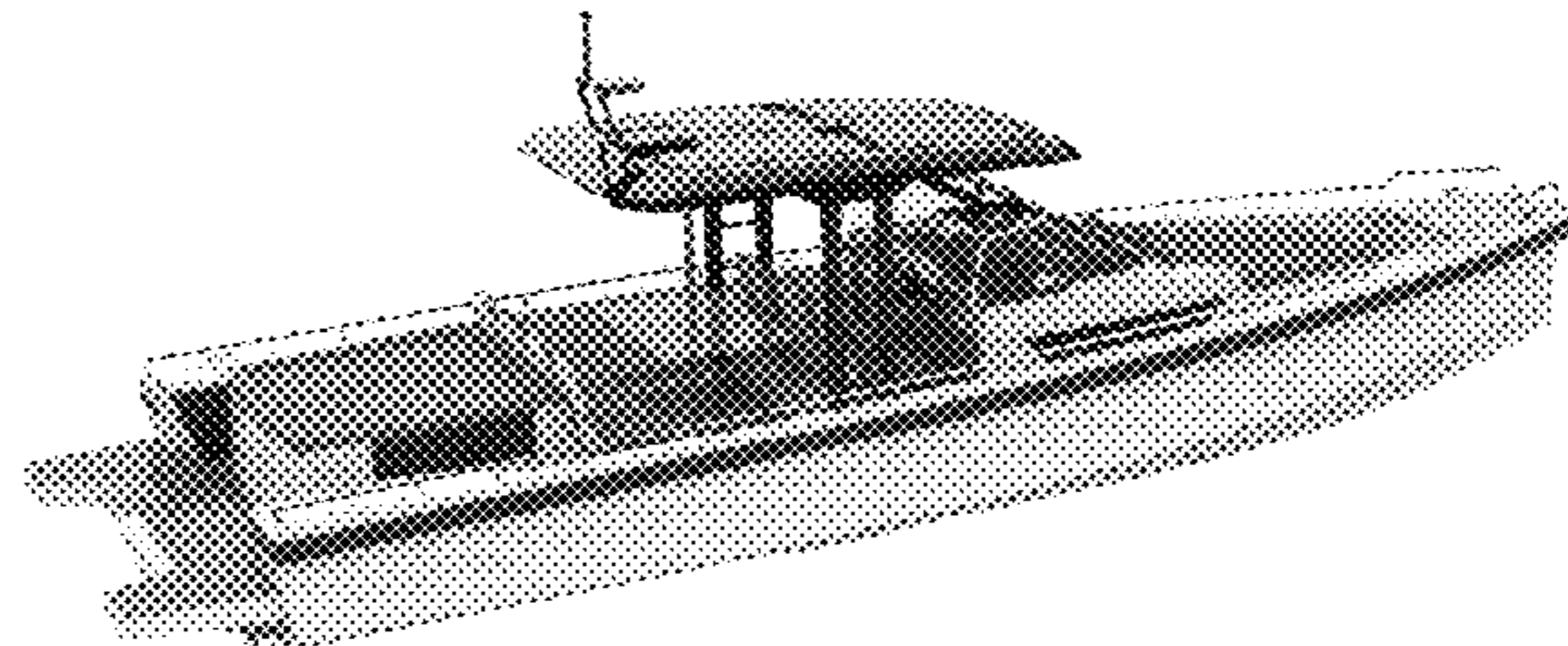
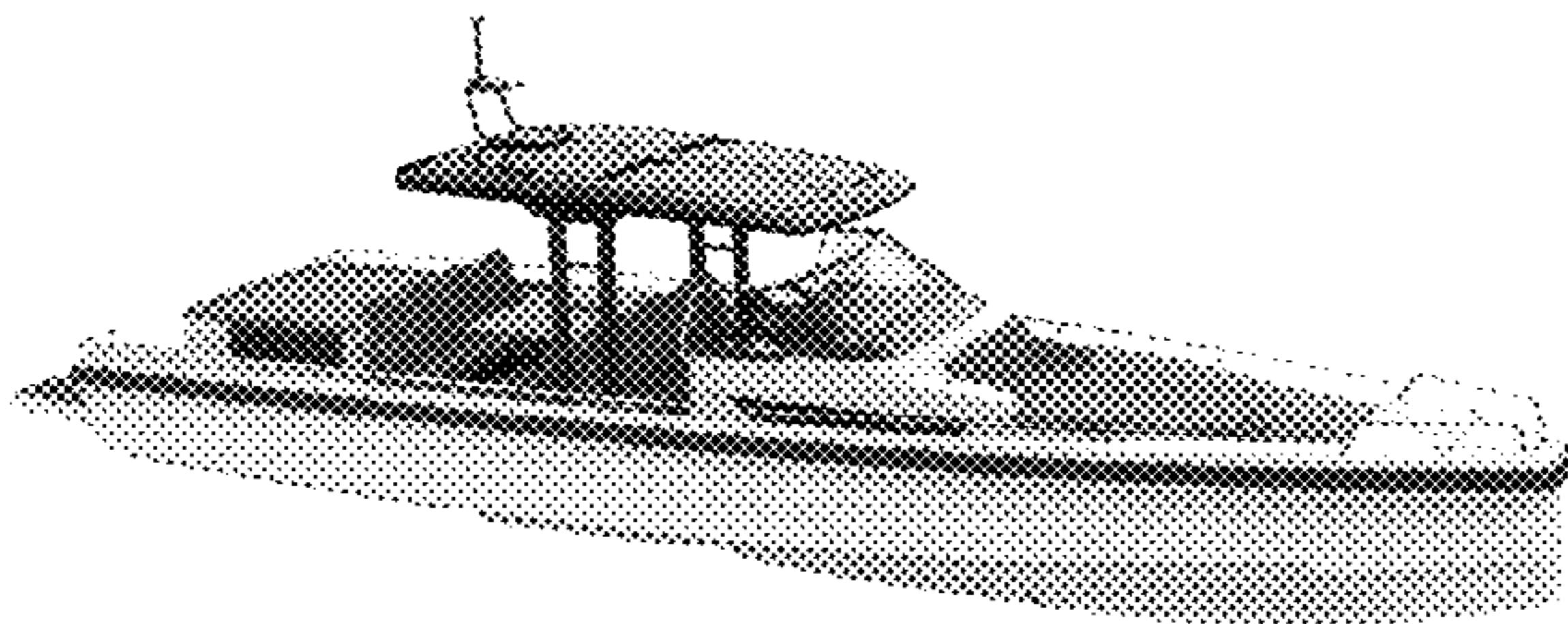
The ornamental design for a boat, as shown and described.

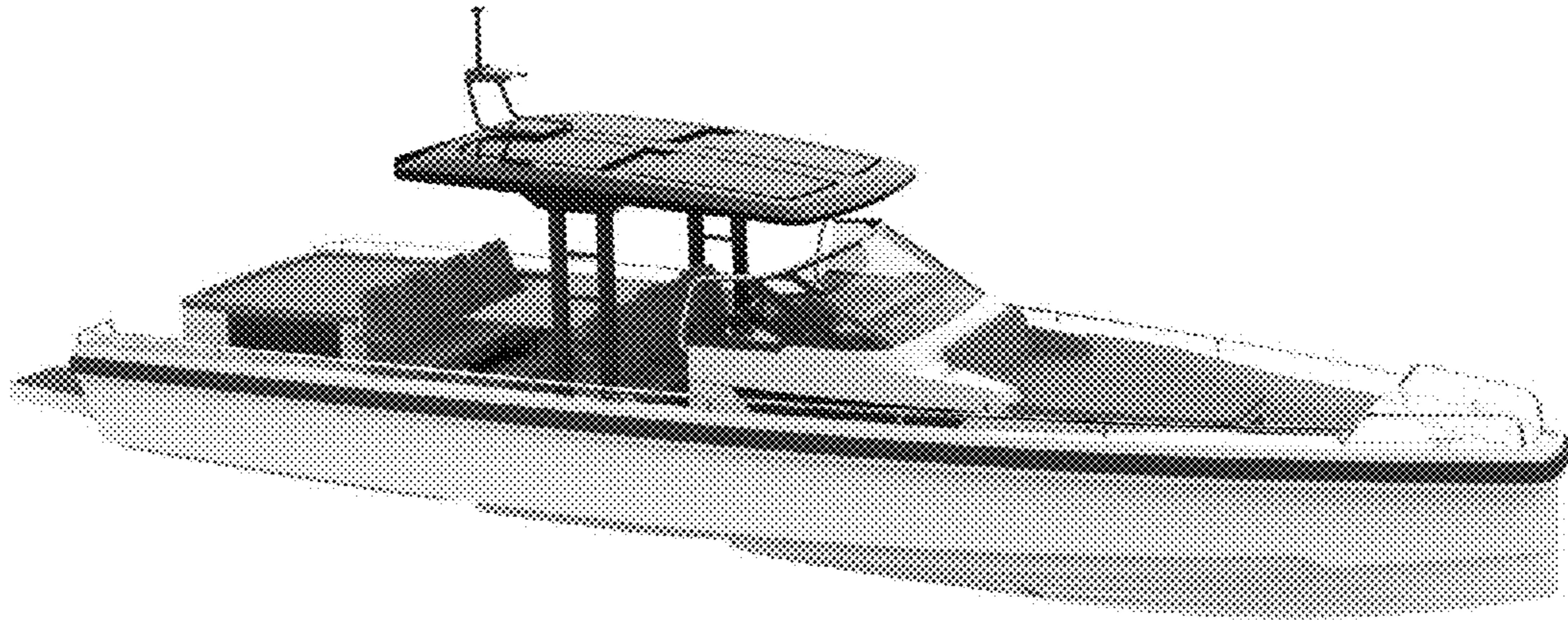

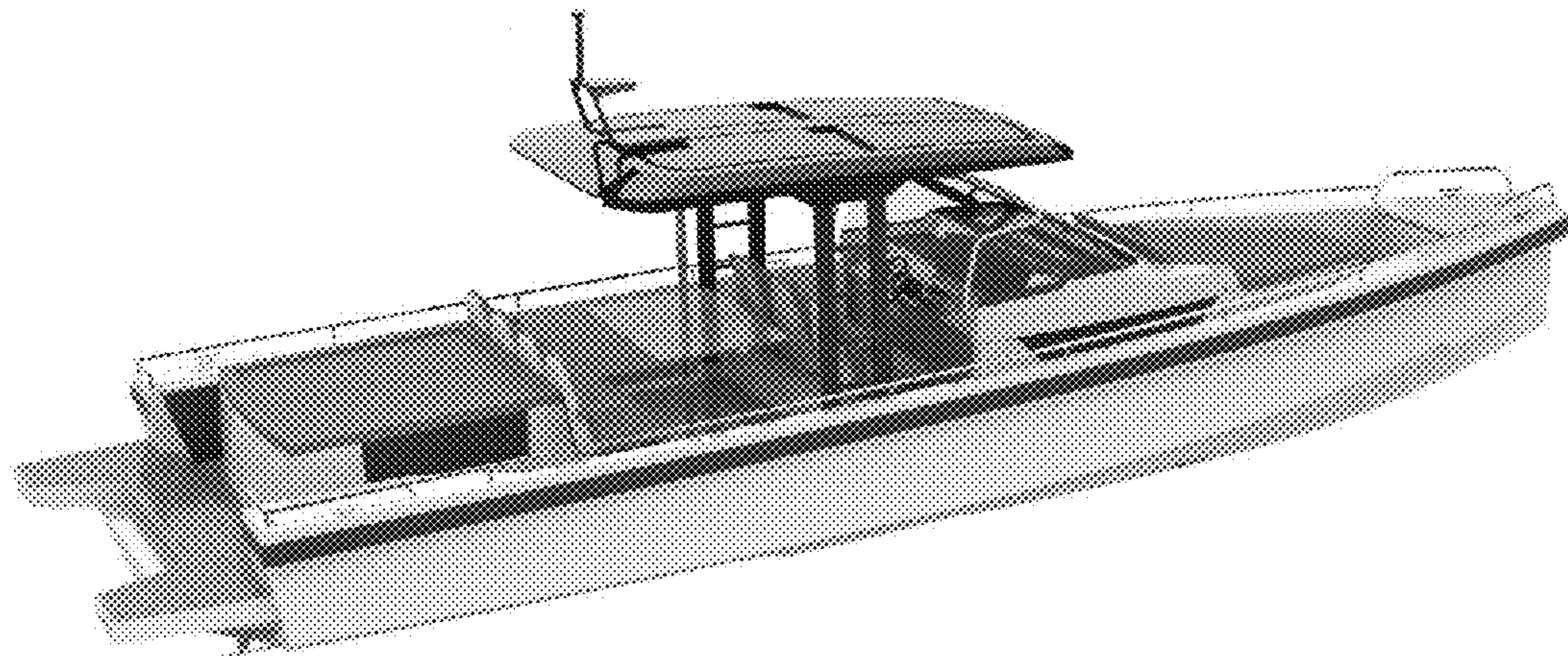

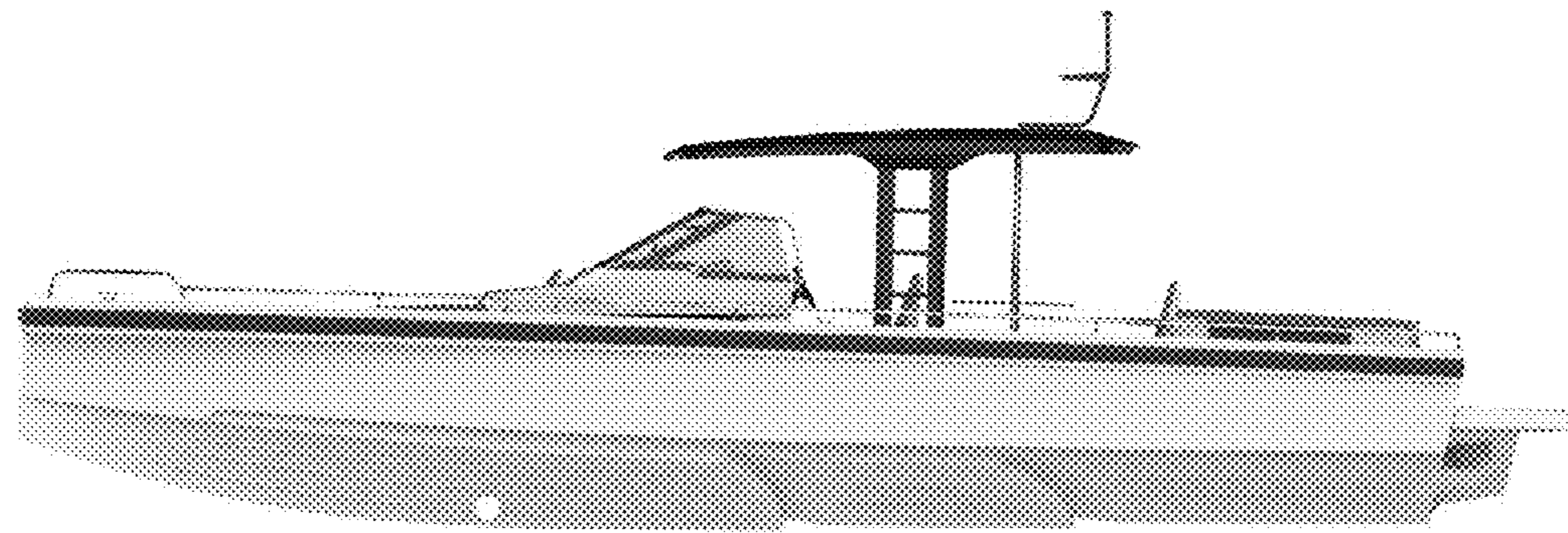

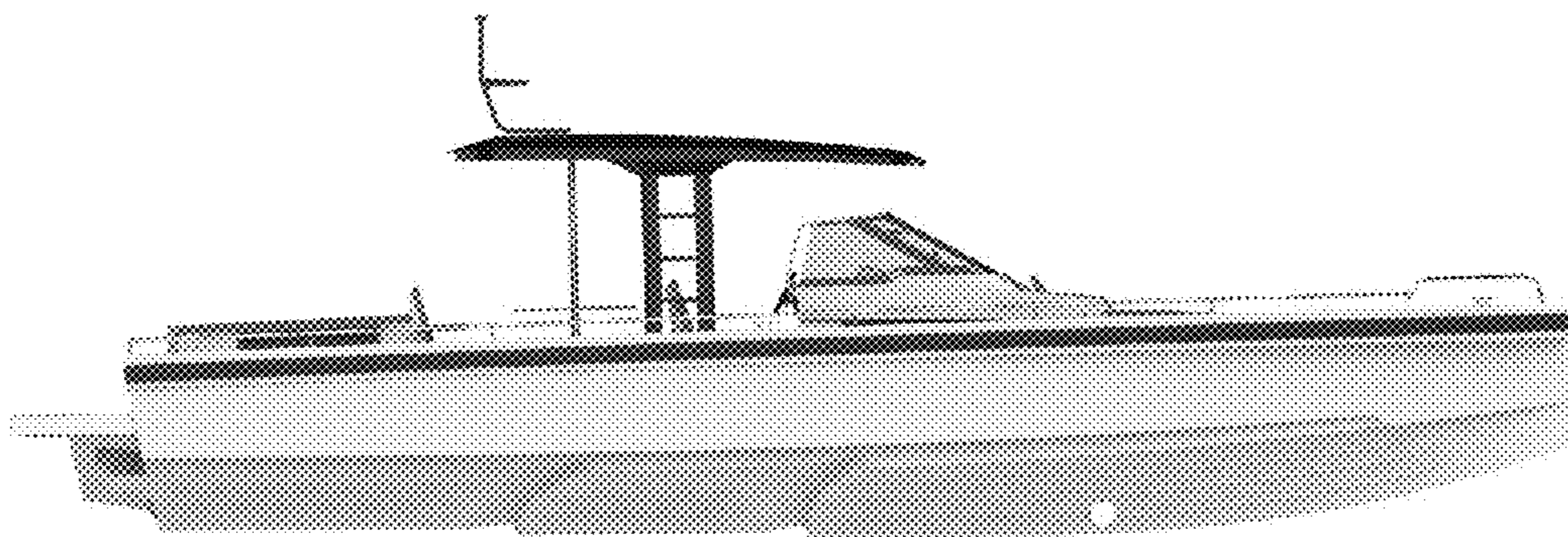

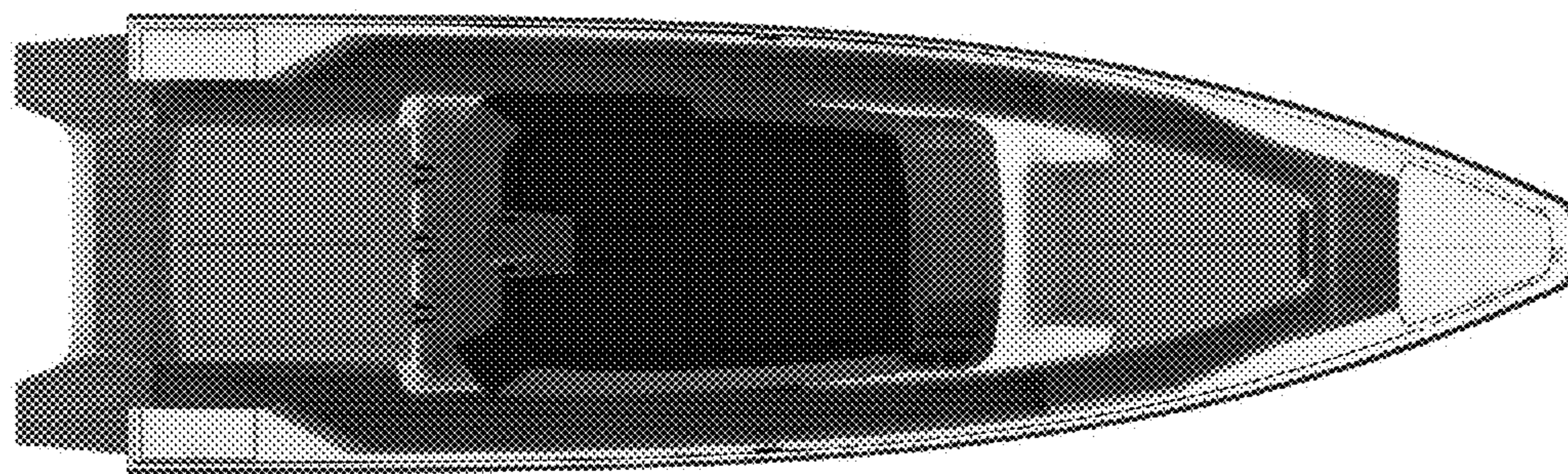

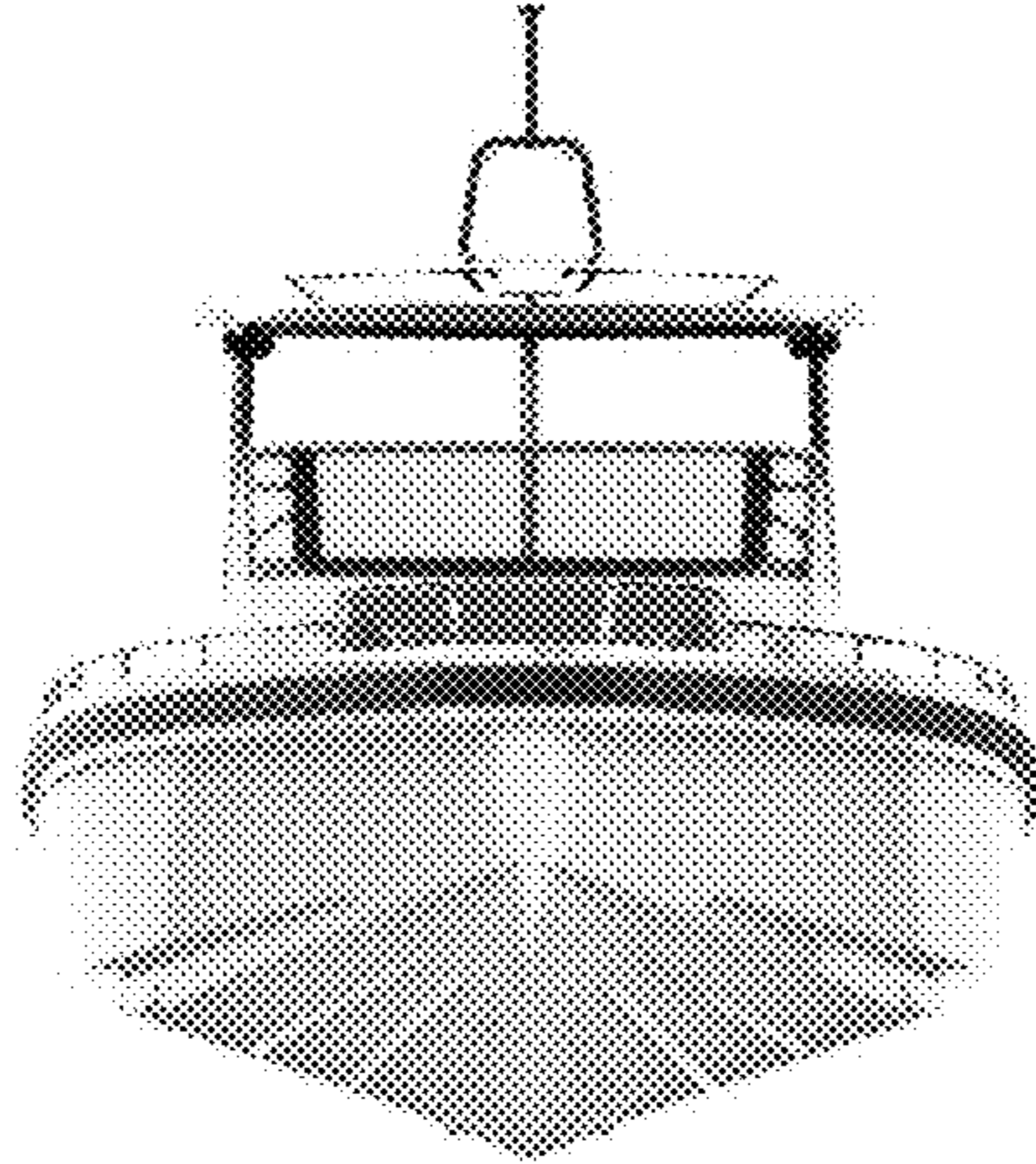

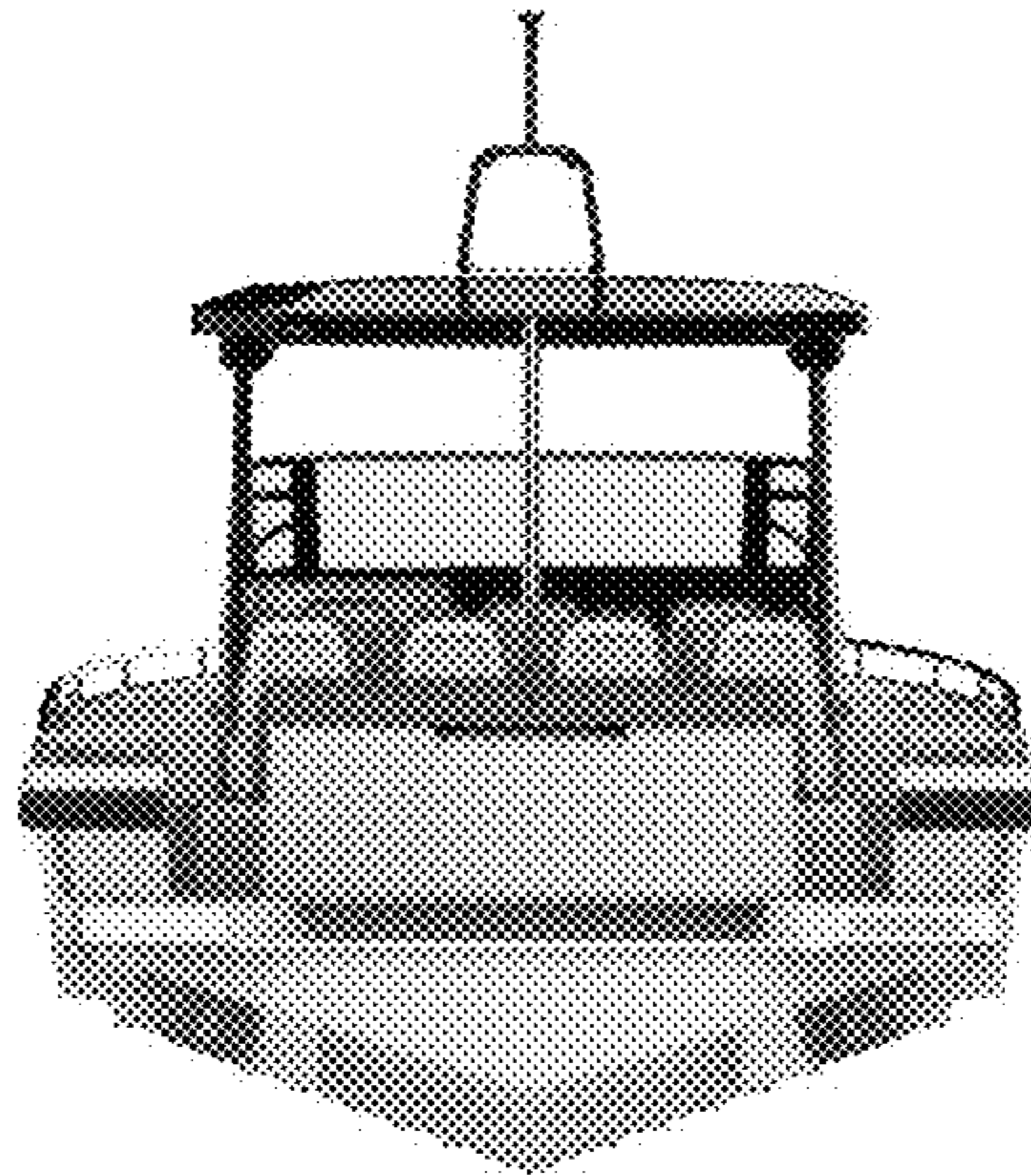

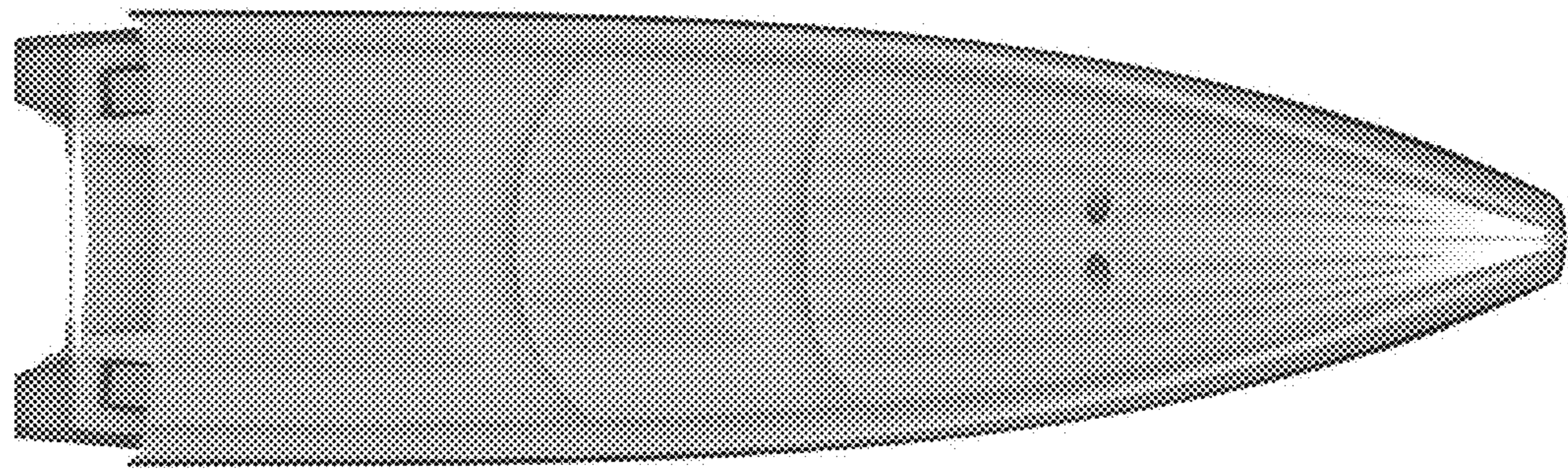
