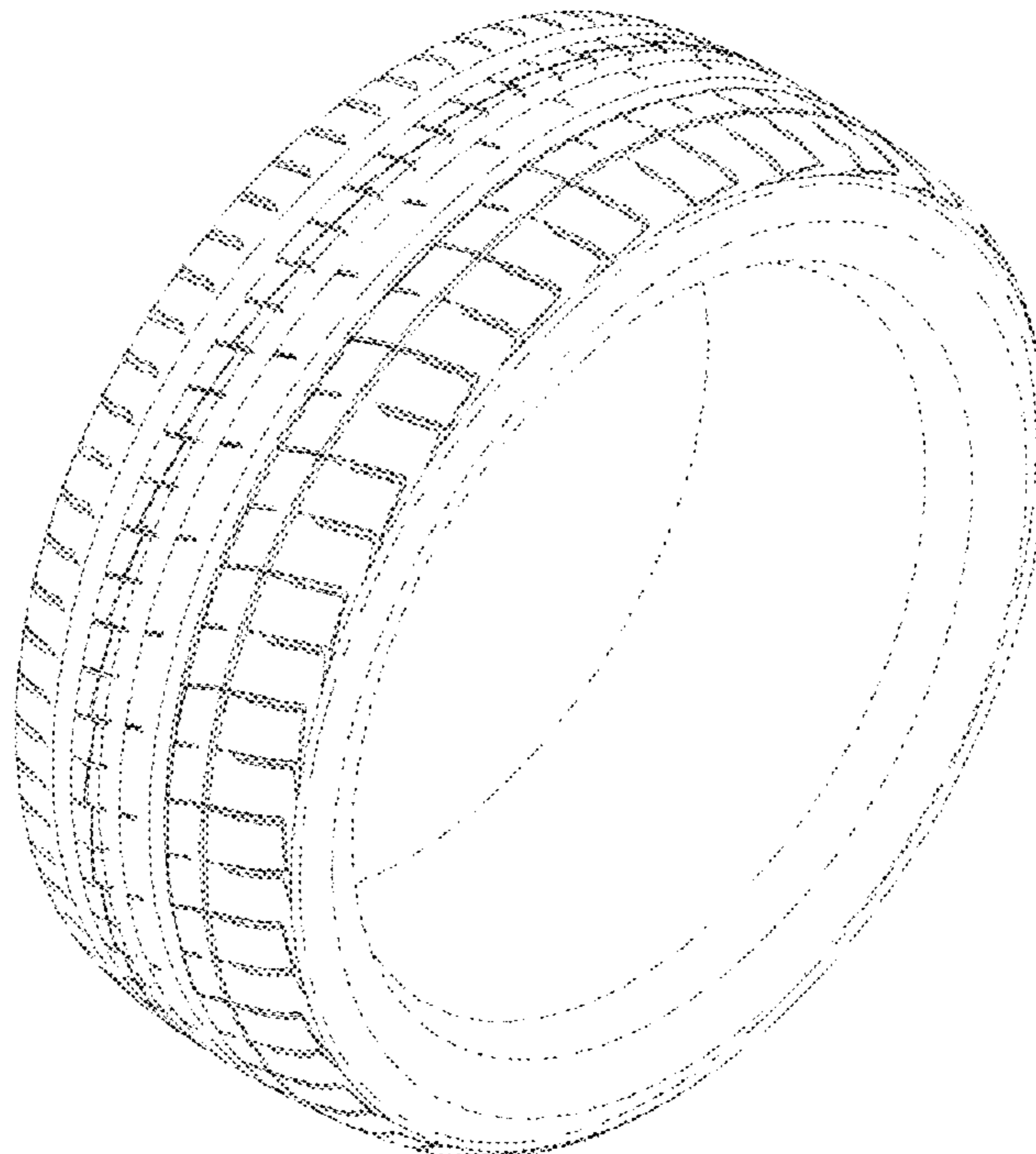
The ornamental design for a vehicle tyre, as shown and described.

DESCRIPTION

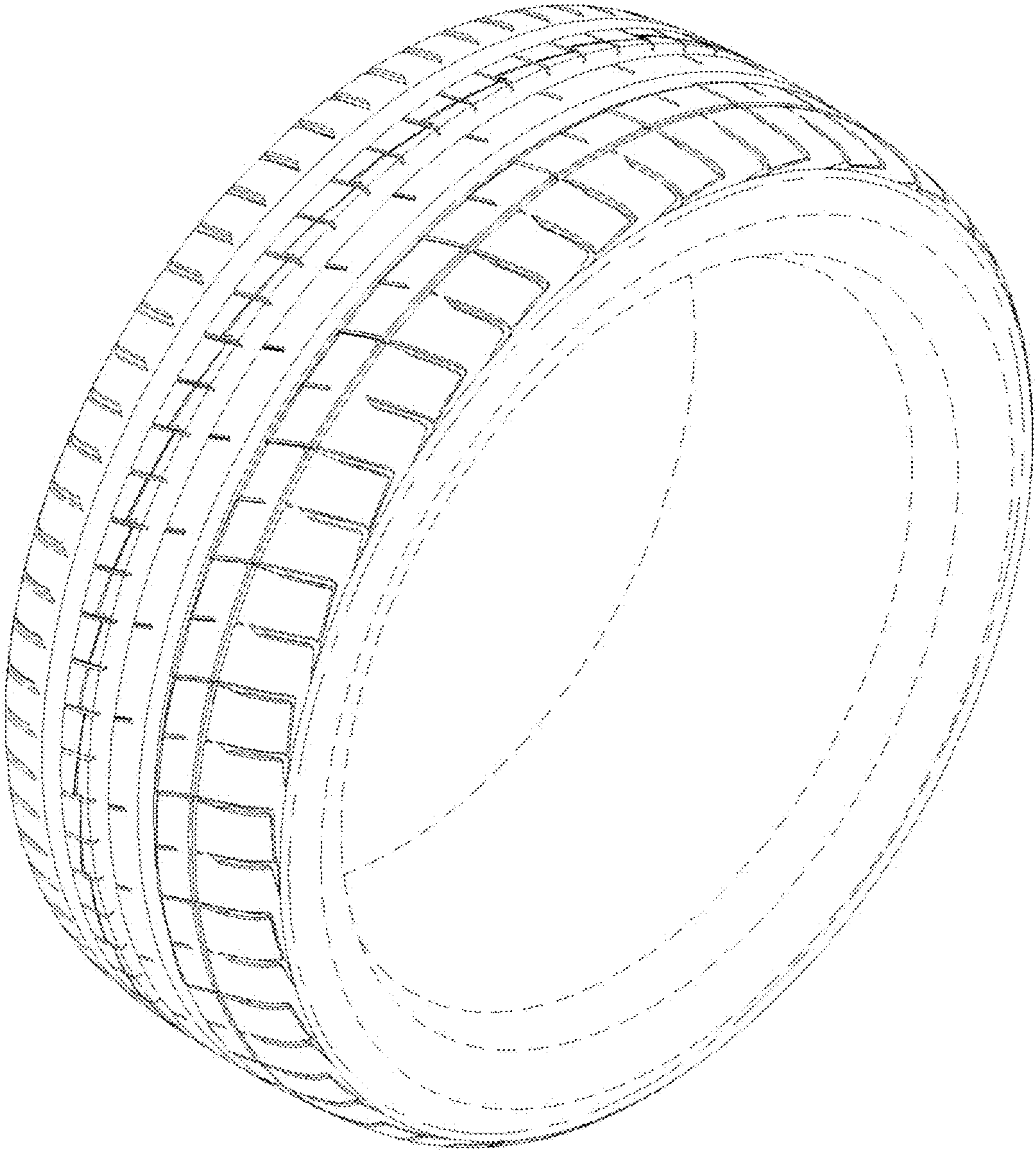
- 1. Vehicle tyre

- 1.4 : Left
- 1.5 : Right
- 1.6 : Top
- 1.7 : Bottom
- 1.8 : Enlarged

Material of the present design is synthetic rubber; the present design is a partial design of vehicle tyre, and a portion for which design registration is claimed, is represented by solid lines; an unclaimed portion is represented by broken lines; and a boundary between two is represented by dashed-dotted lines; reproduction 1.8 is an enlarged view of portion surrounded by the dot-dot dashed lines in reproduction 1.2.

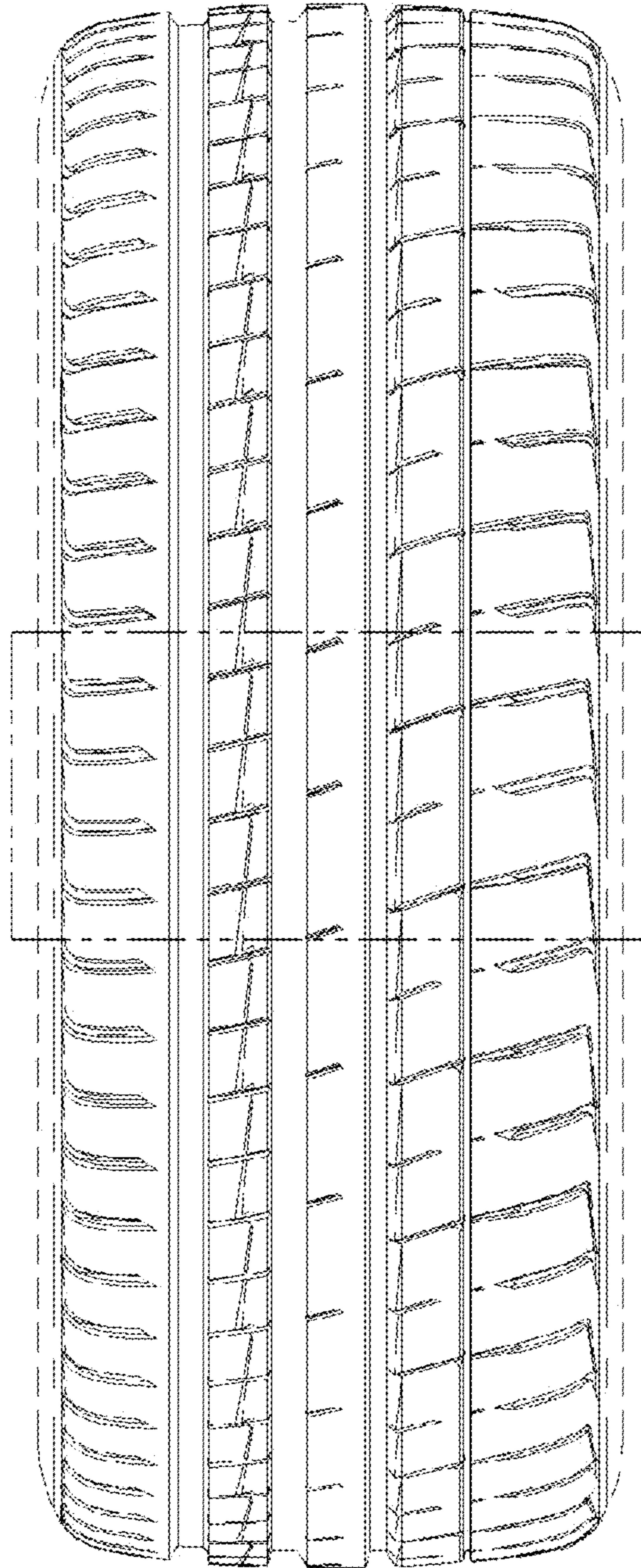

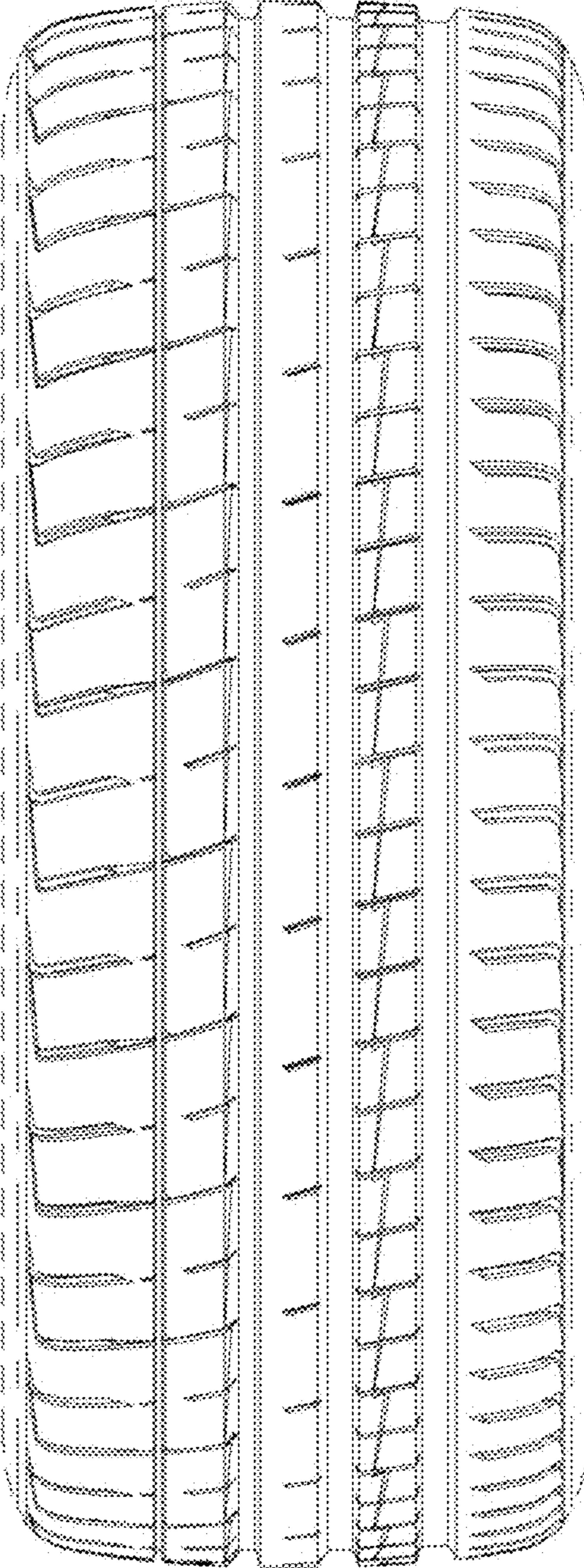

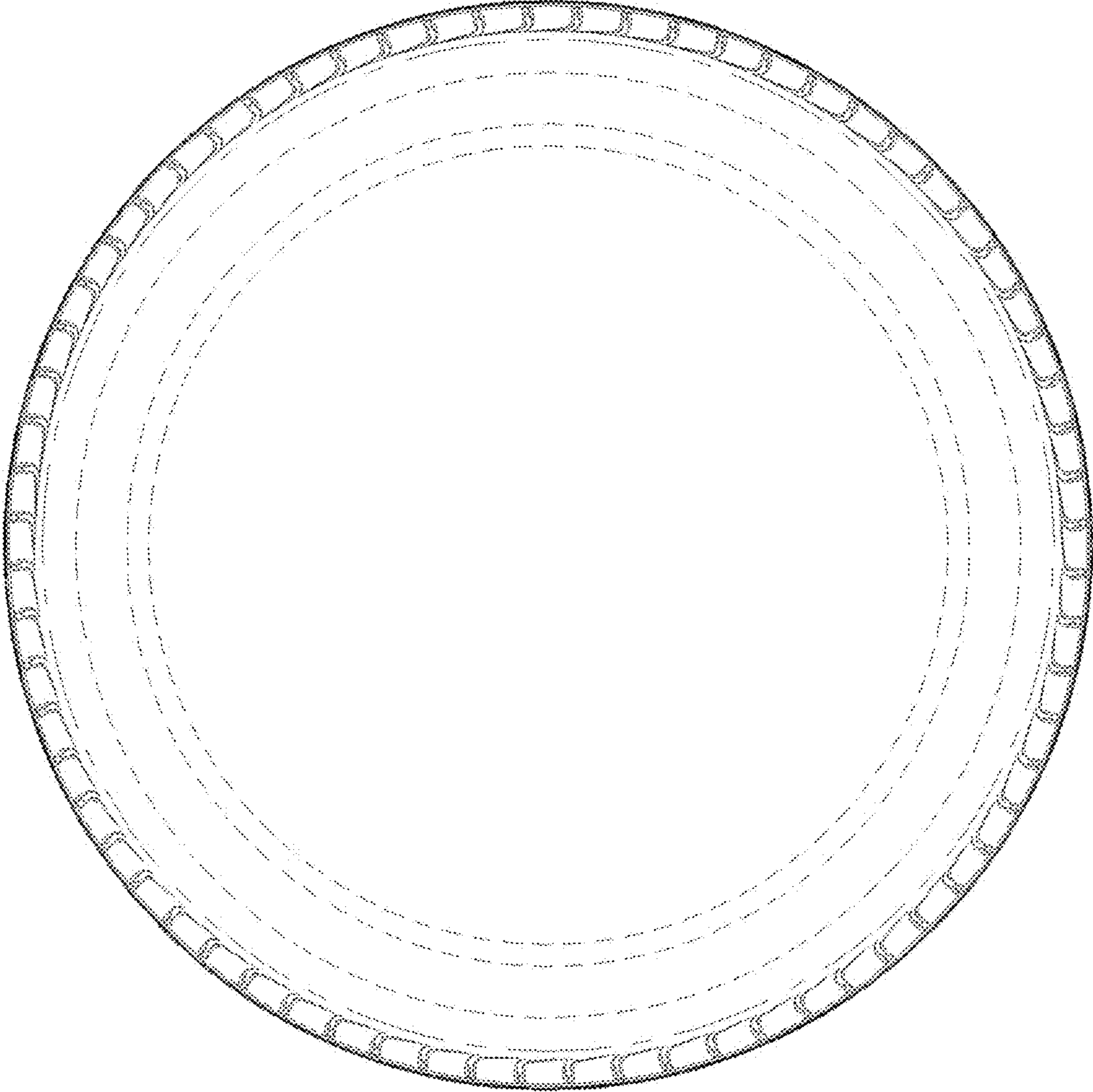

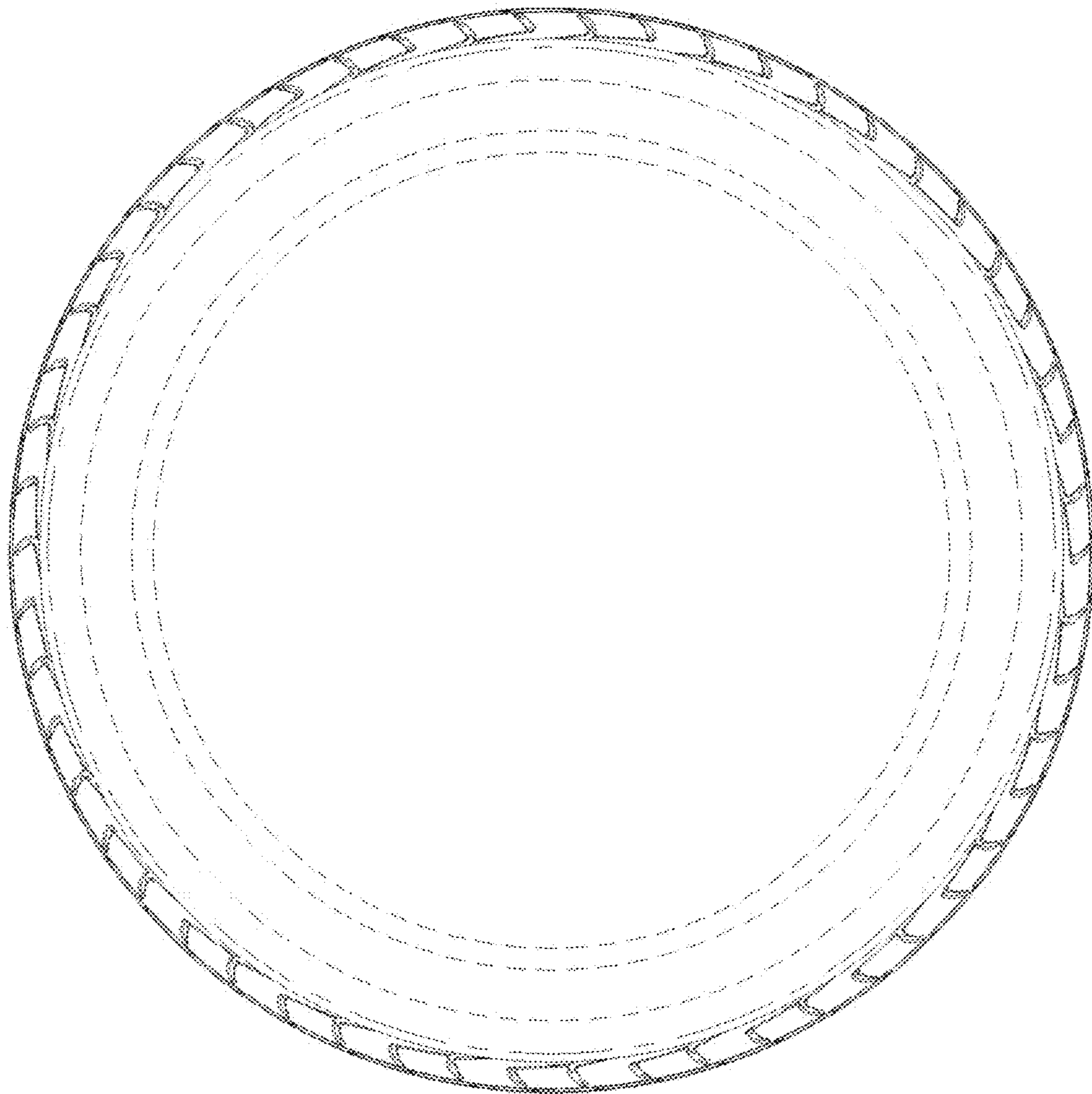

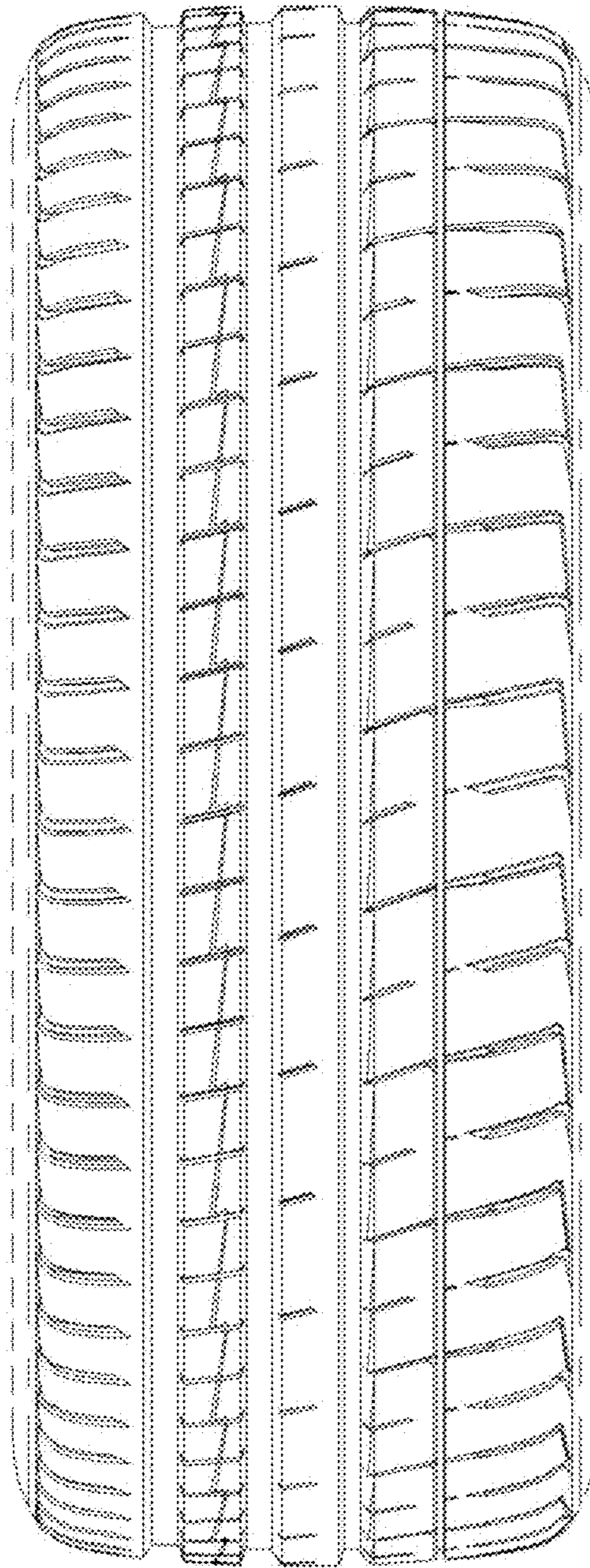

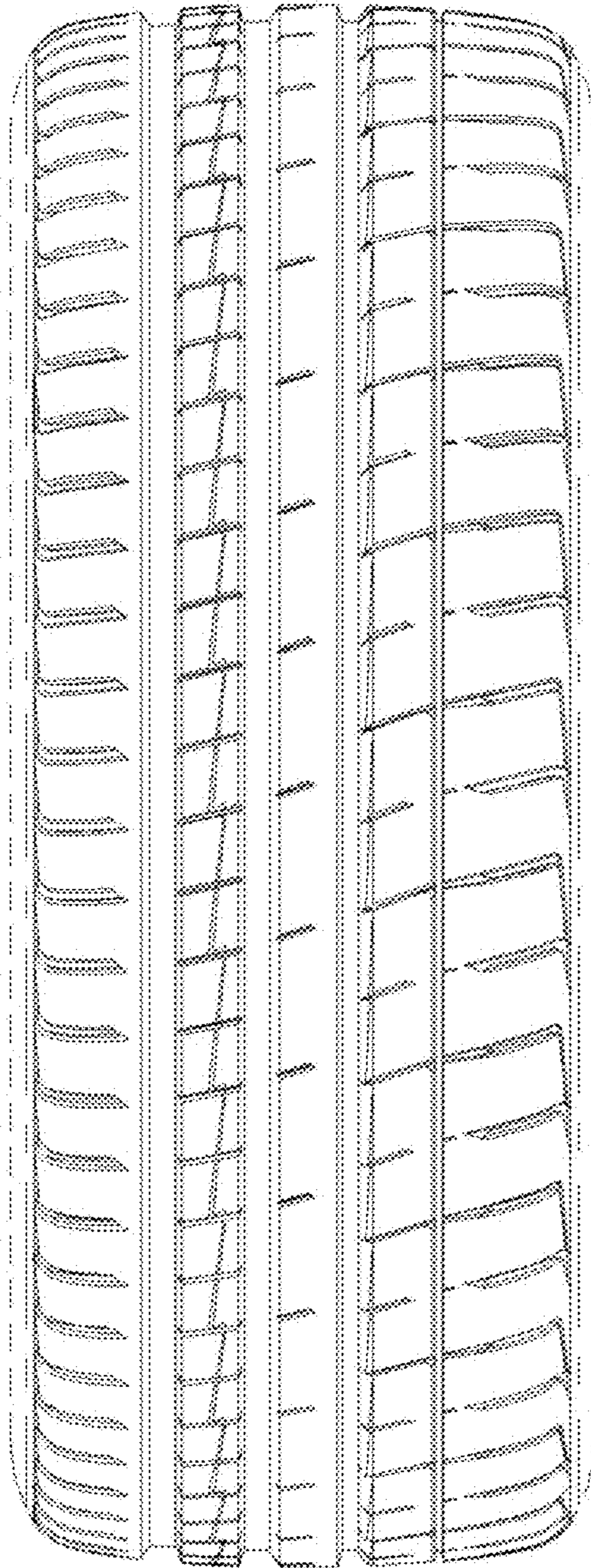
