(57) **CLAIM**

The ornamental design for a forceps with spring clip, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a forceps with spring clip. FIG. 2 is a bottom perspective view of the forceps with spring clip of FIG. 1.

FIG. 13 is a left-side view of the forceps with spring clip of FIG. 9.

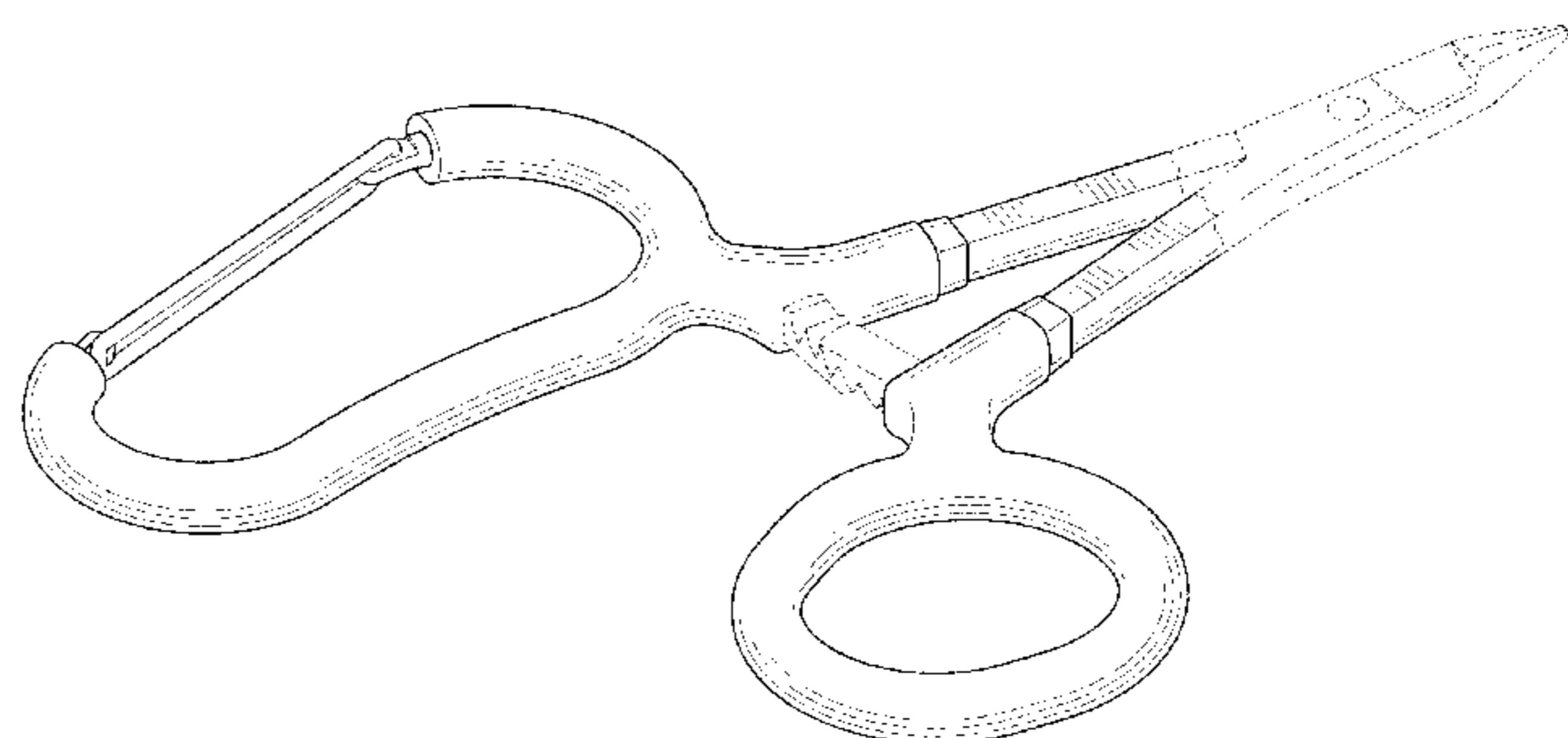
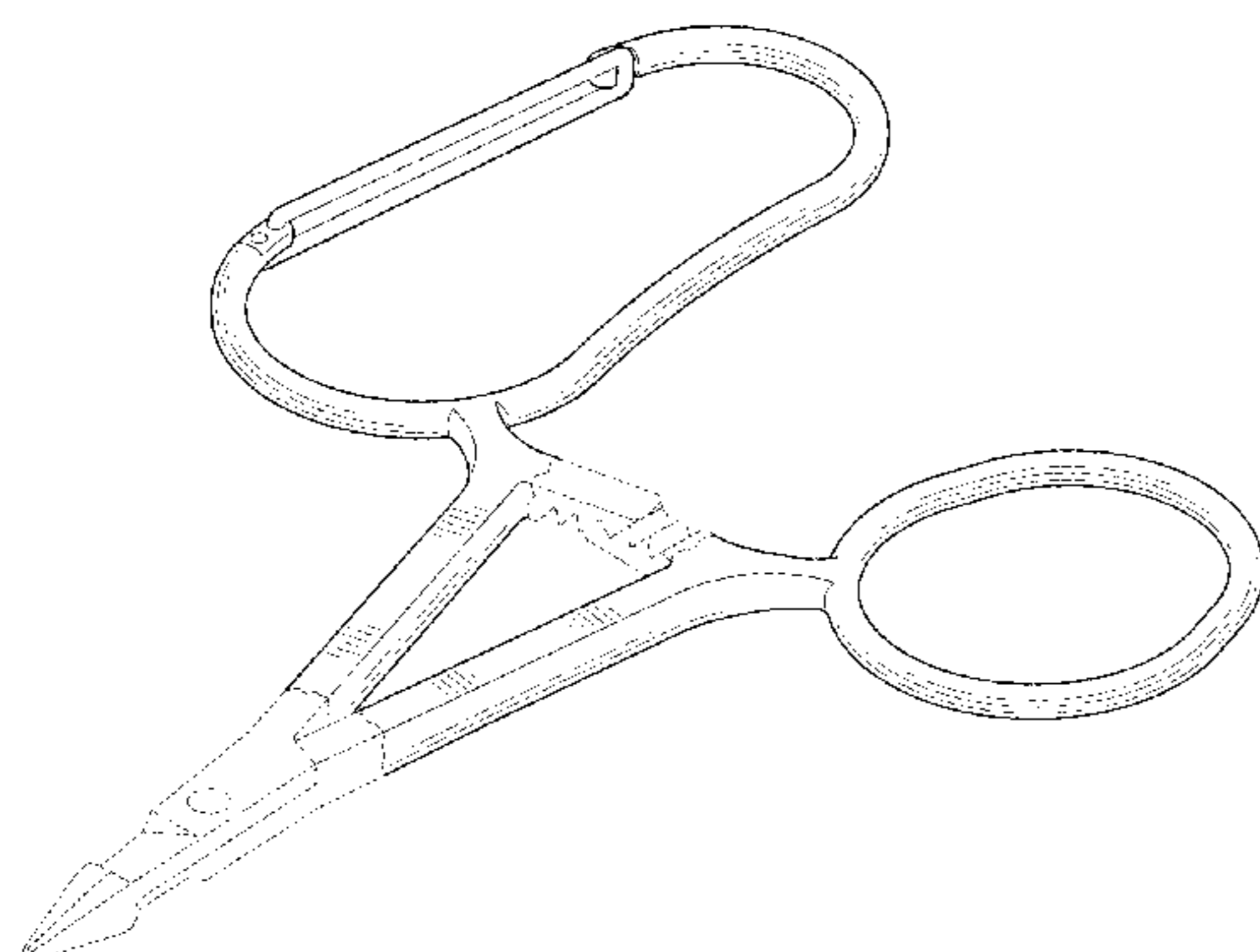
FIG. 14 is a right-side view of the forceps with spring clip of FIG. 9.

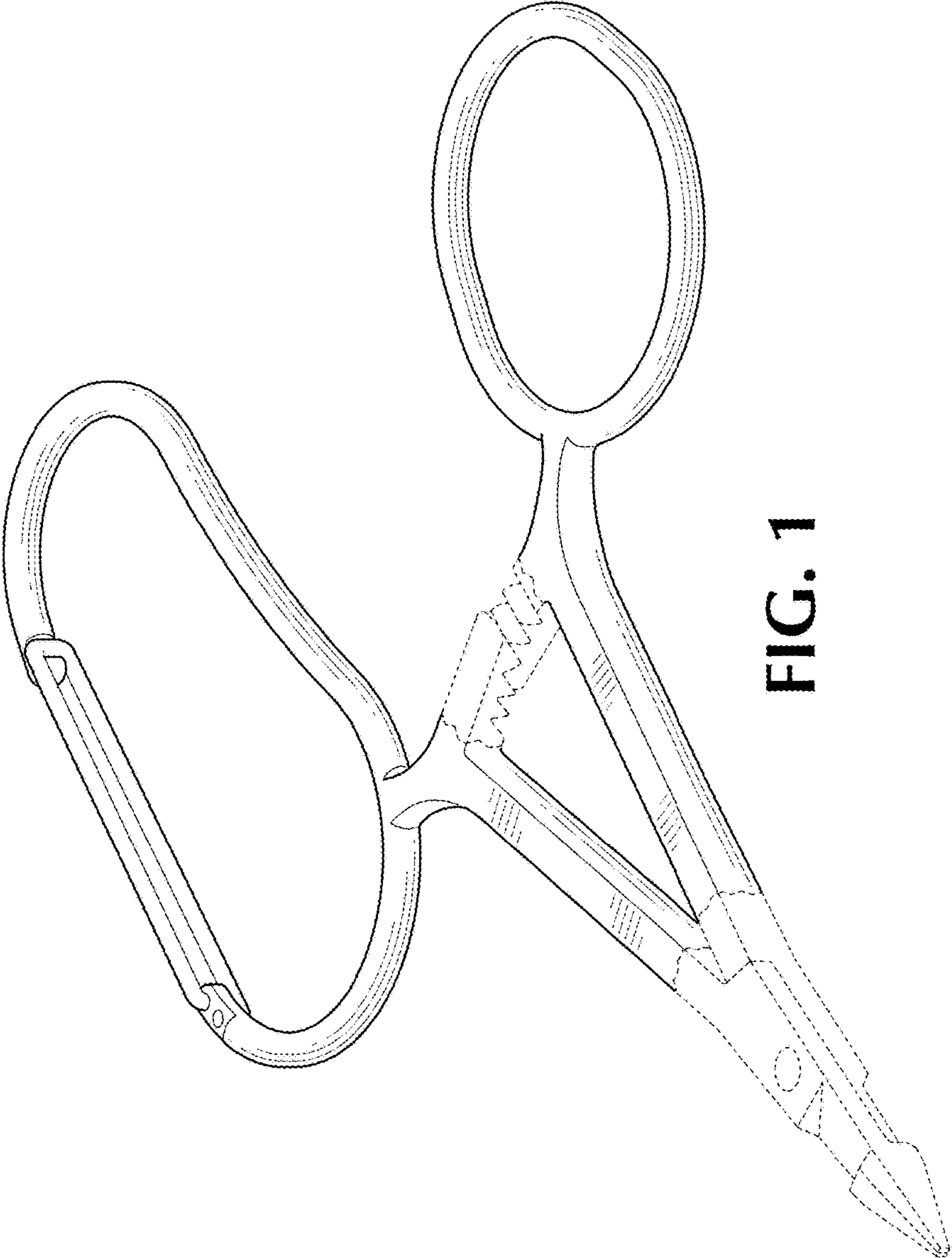

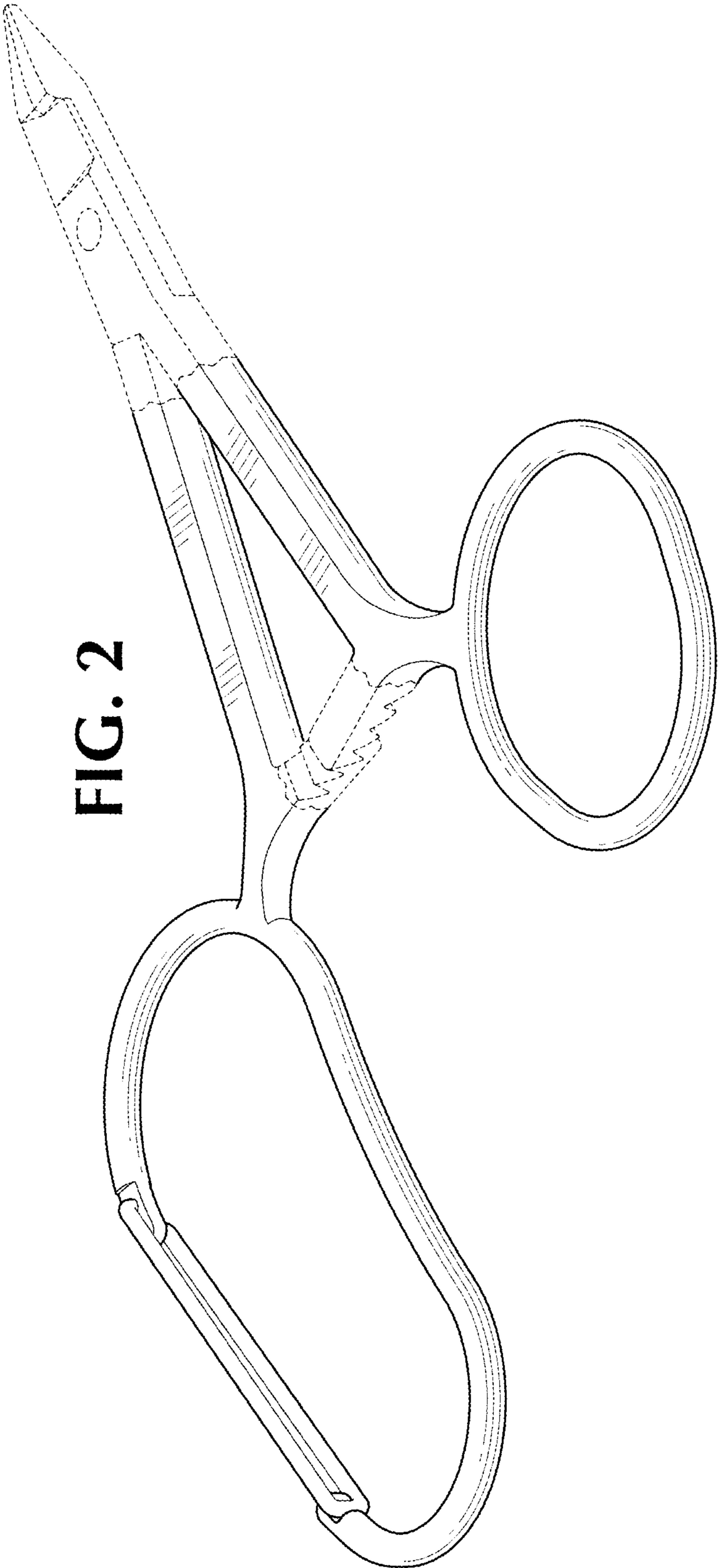

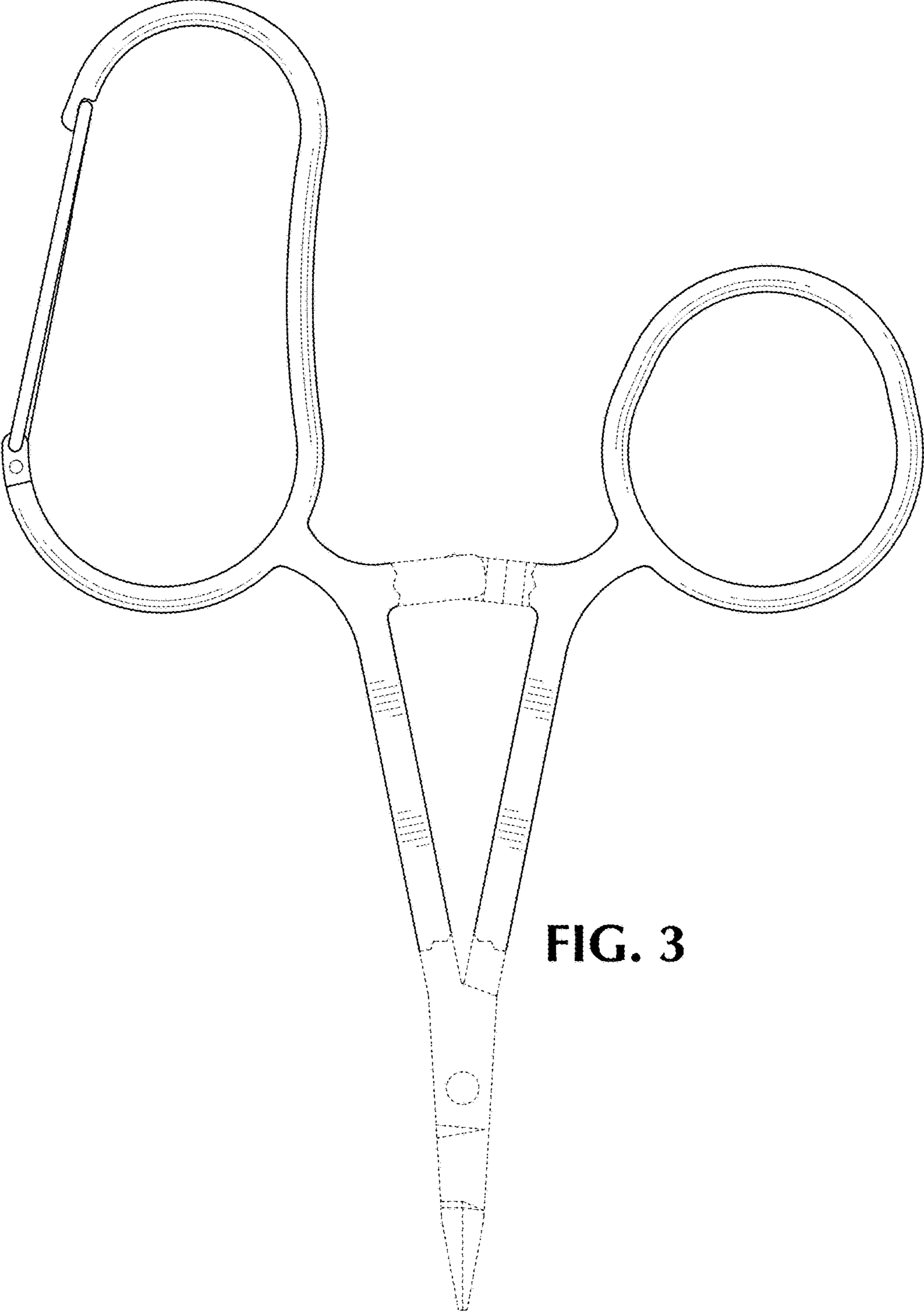

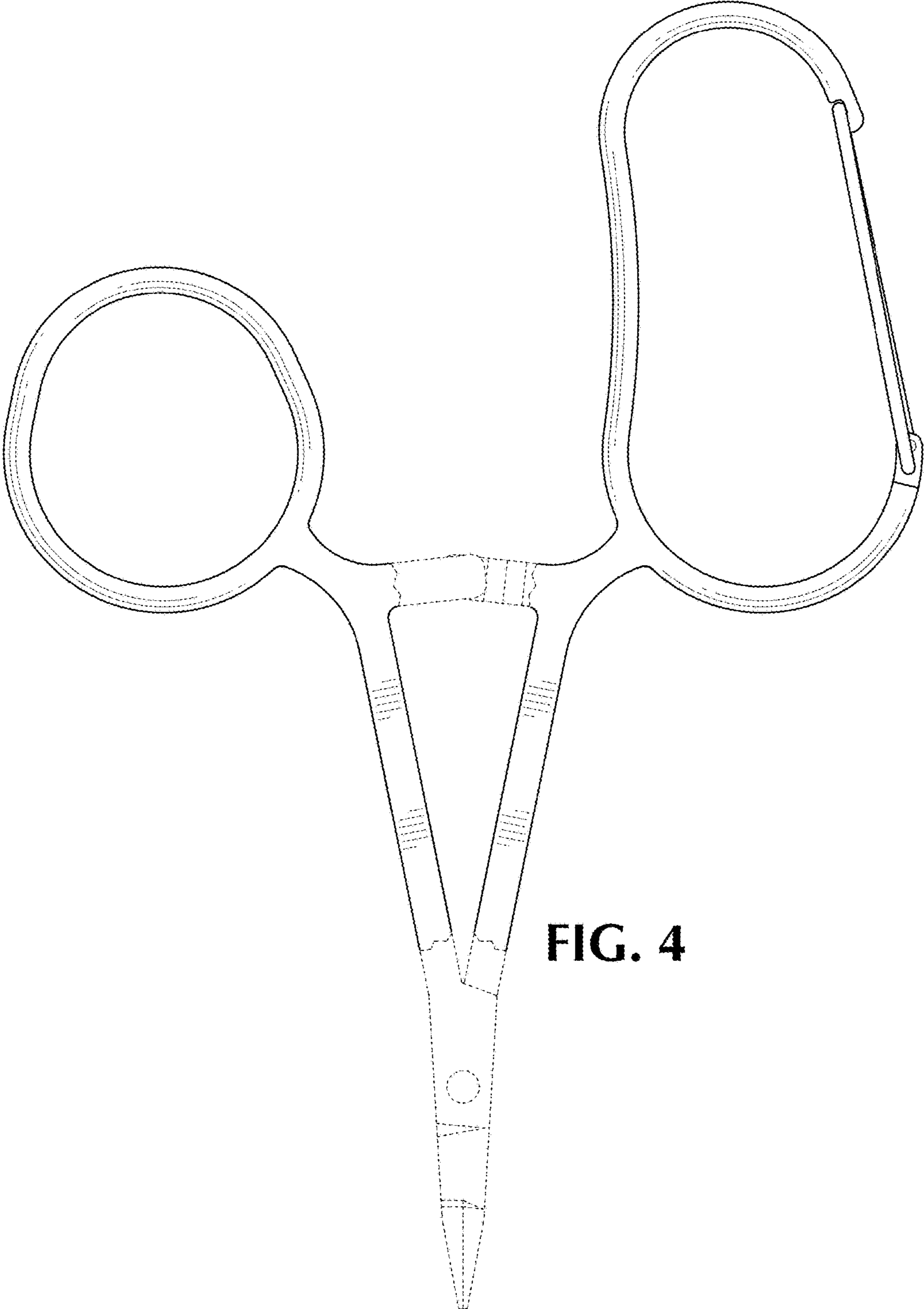

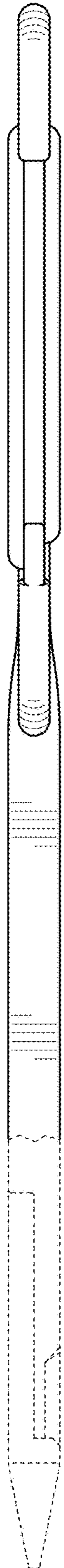

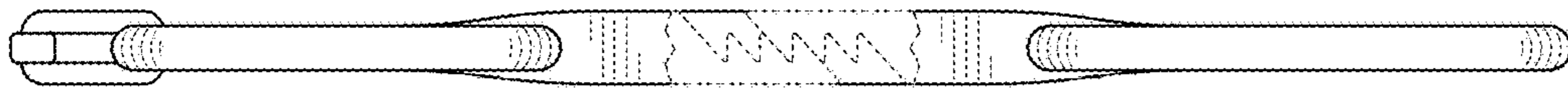

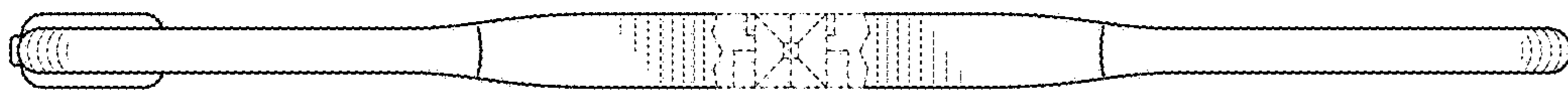

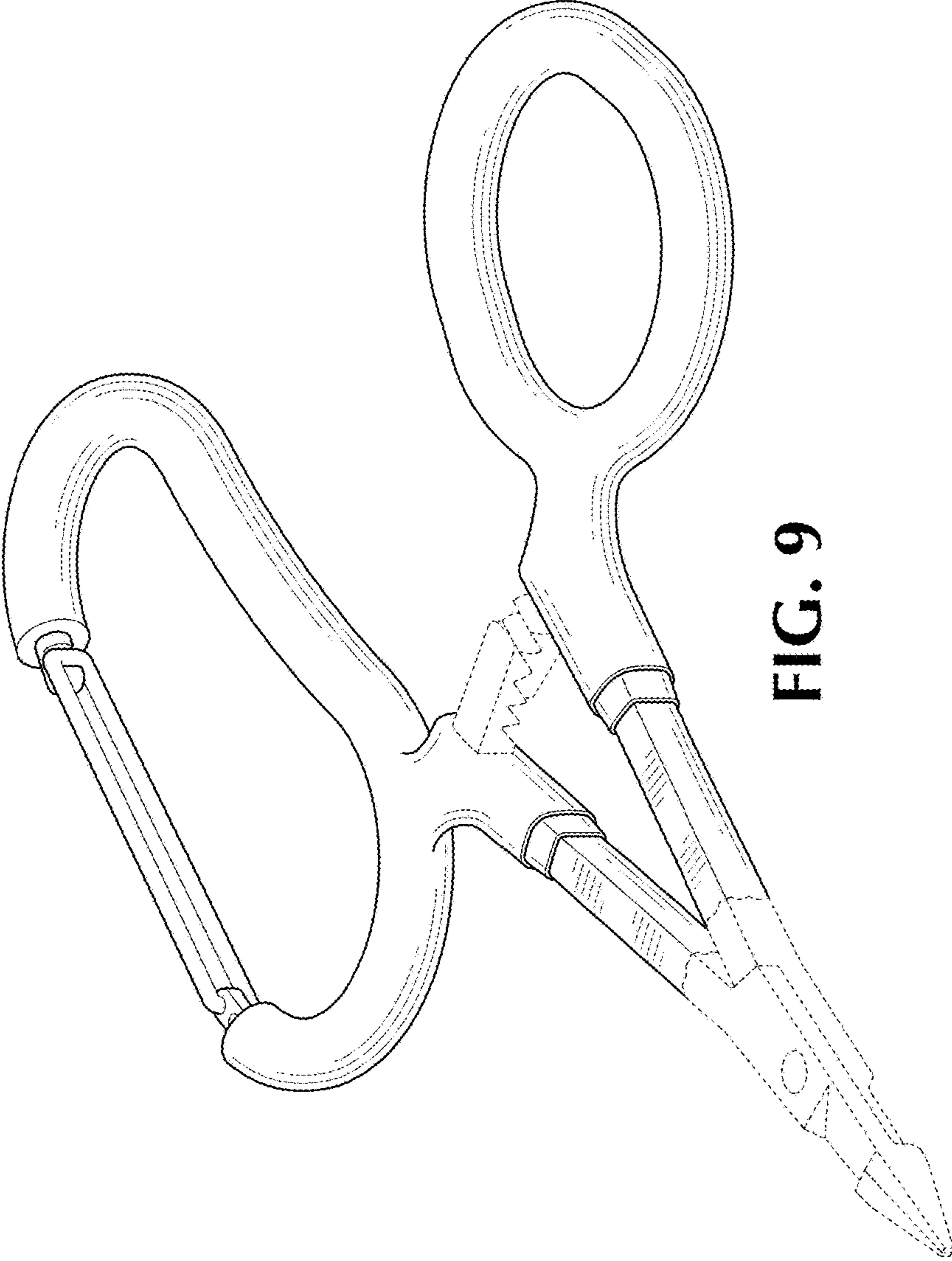

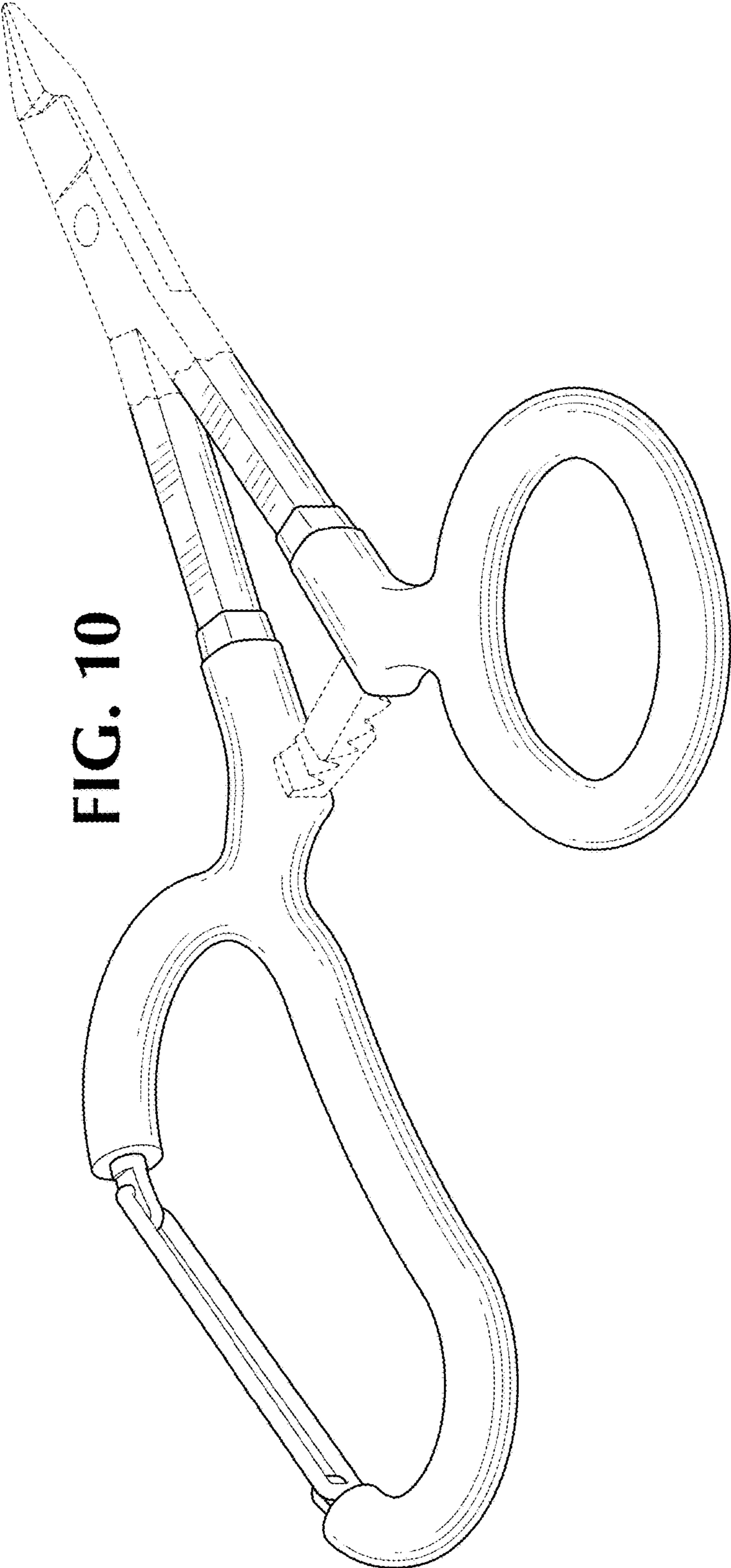

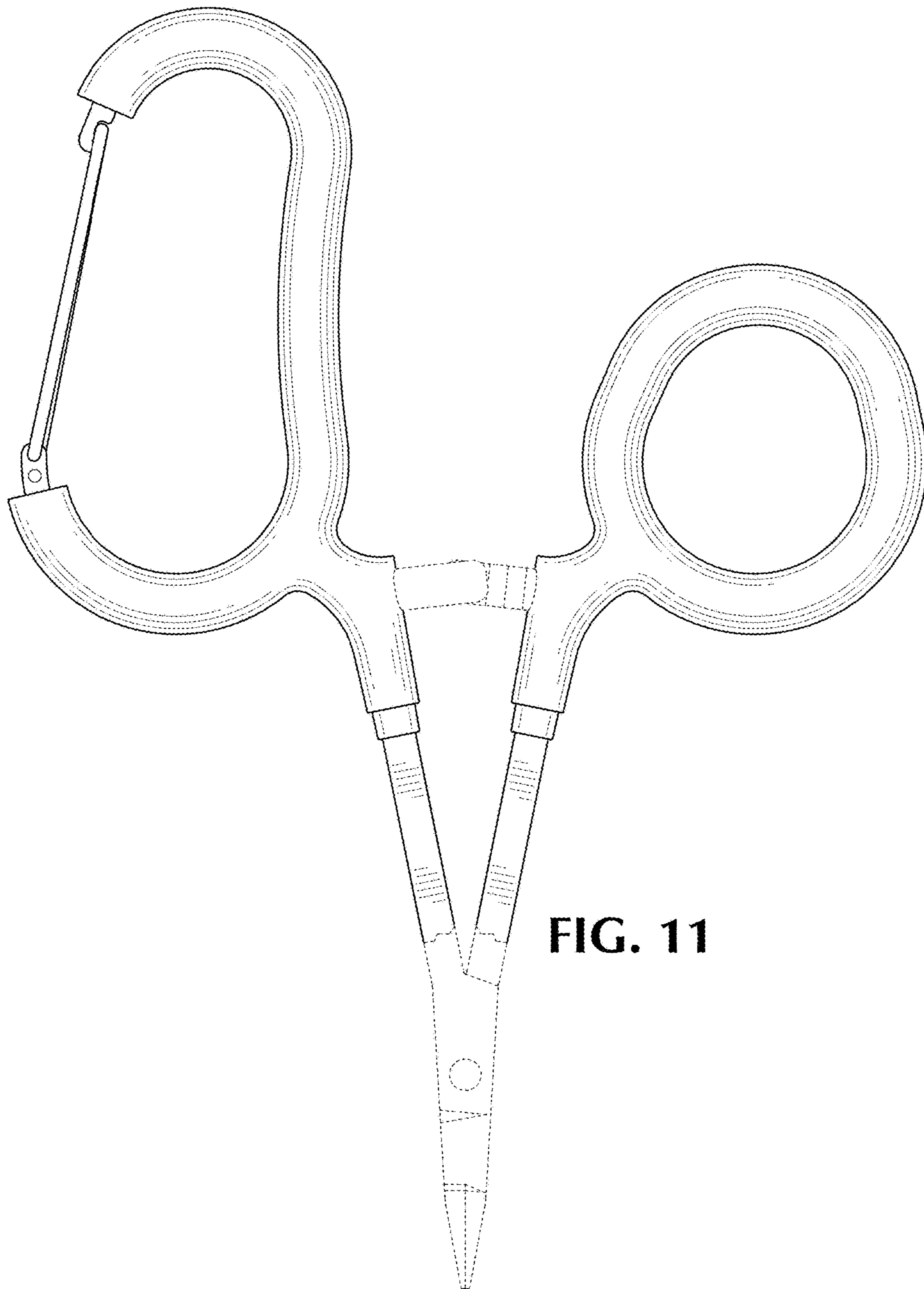

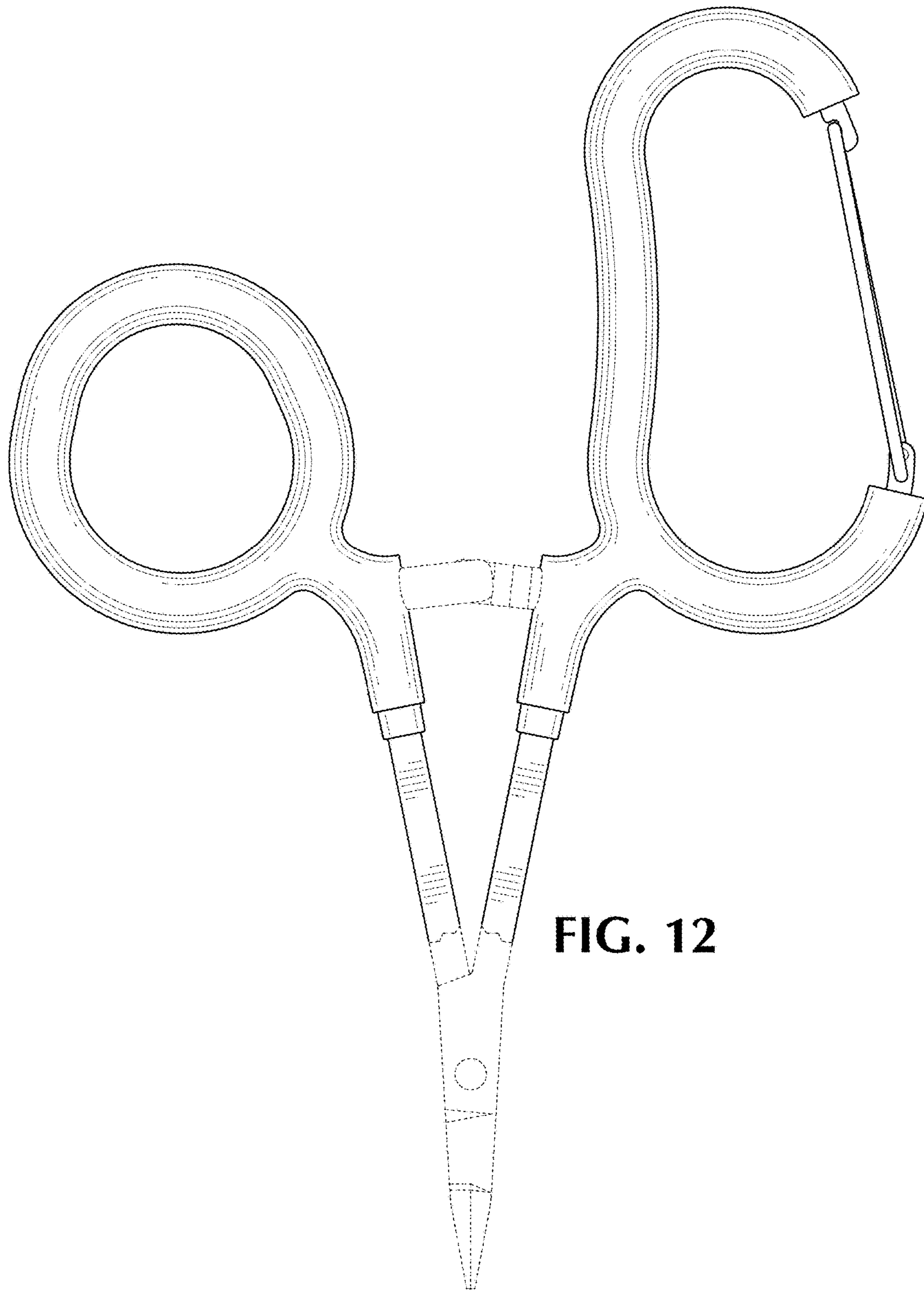

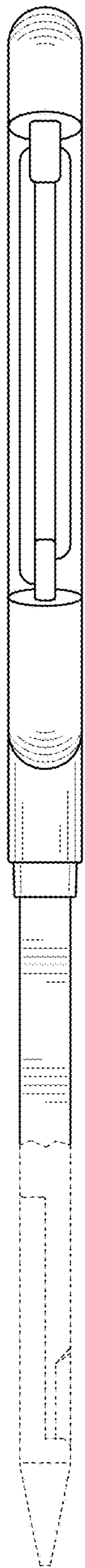

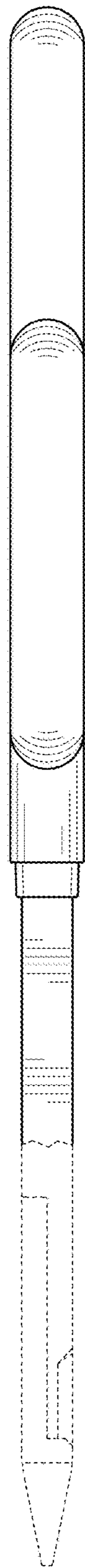

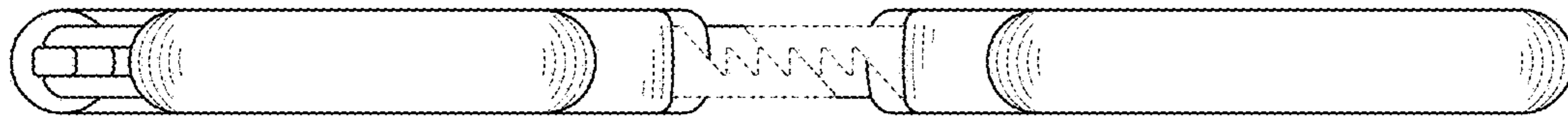

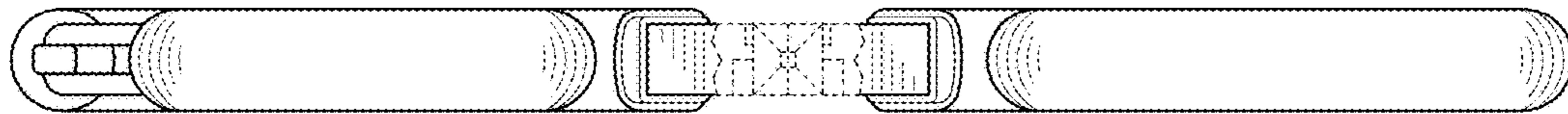
