The ornamental design for a surgical clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical clip;
 FIG. 2 is a right side view thereof;
 FIG. 3 is a left side view thereof;
 FIG. 4 is a front view thereof; and,
 FIG. 5 is a top view thereof.
 The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

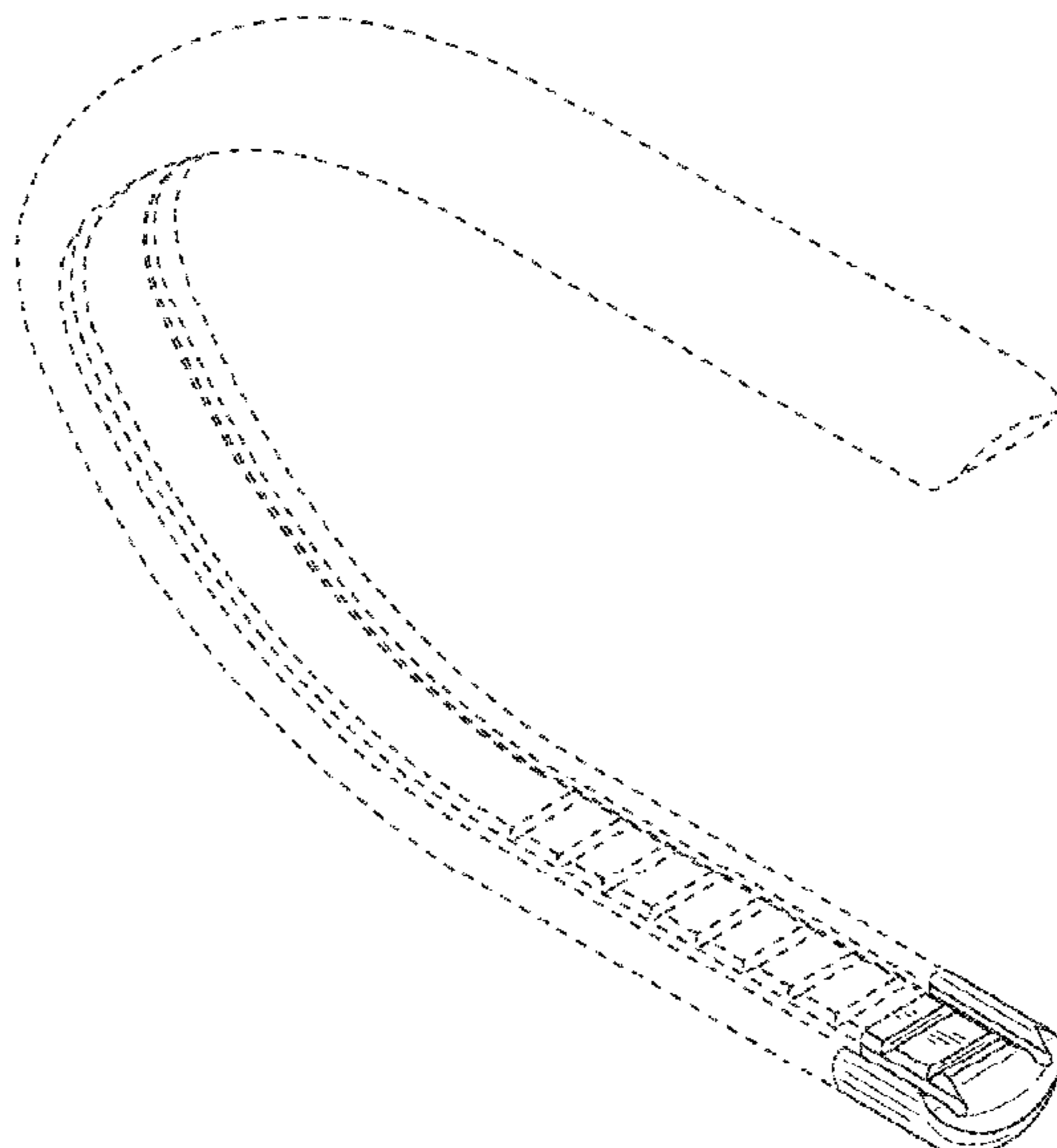

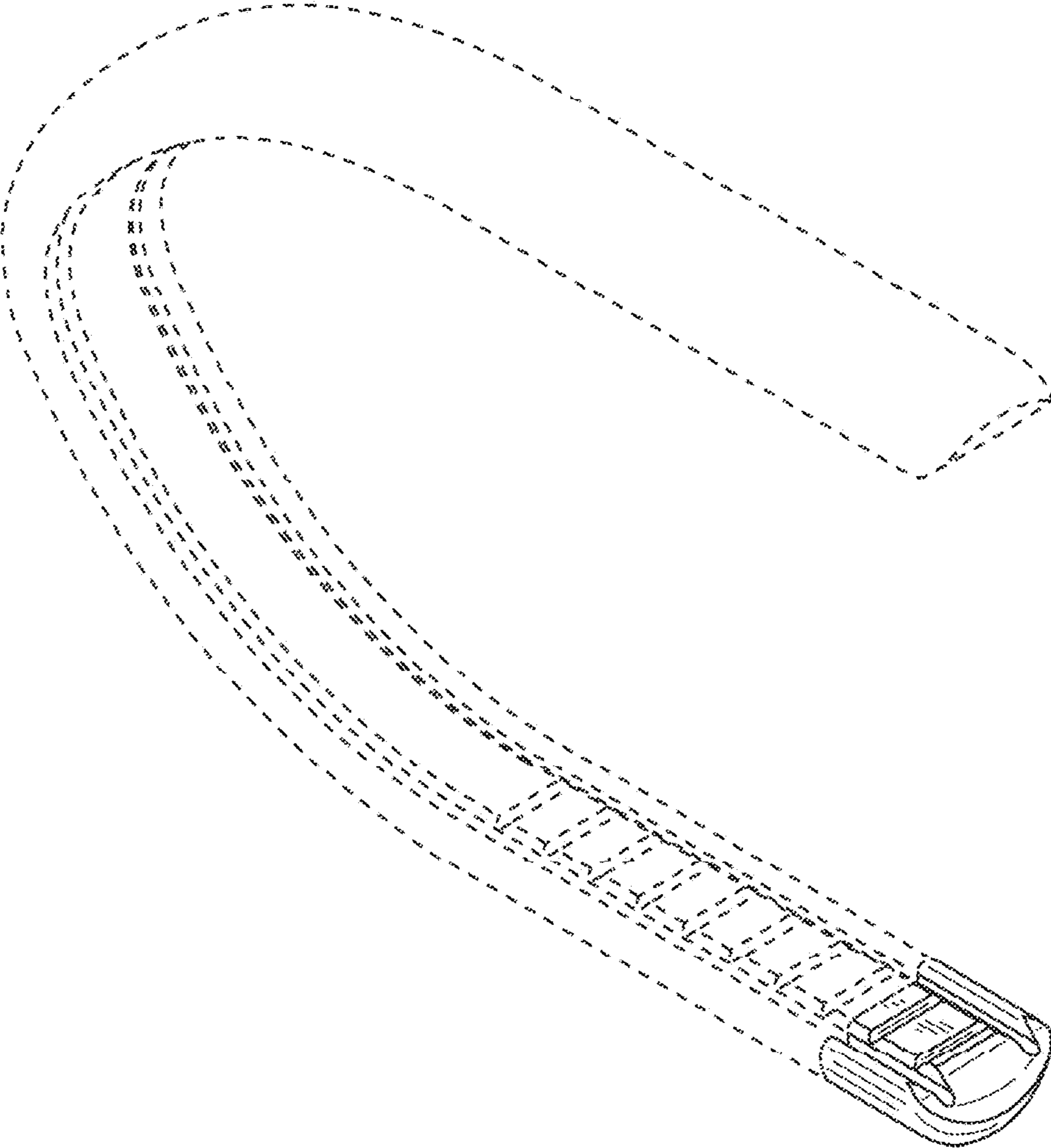

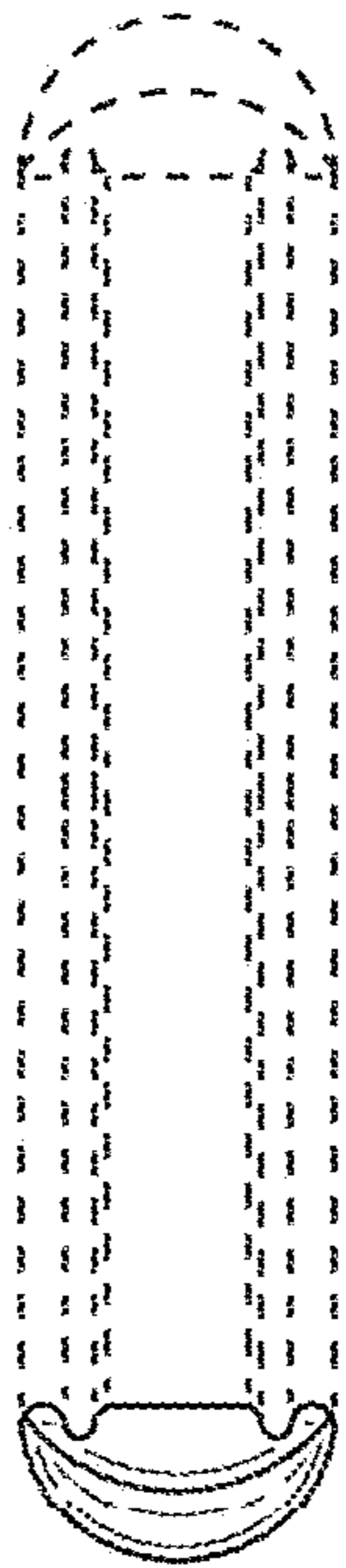

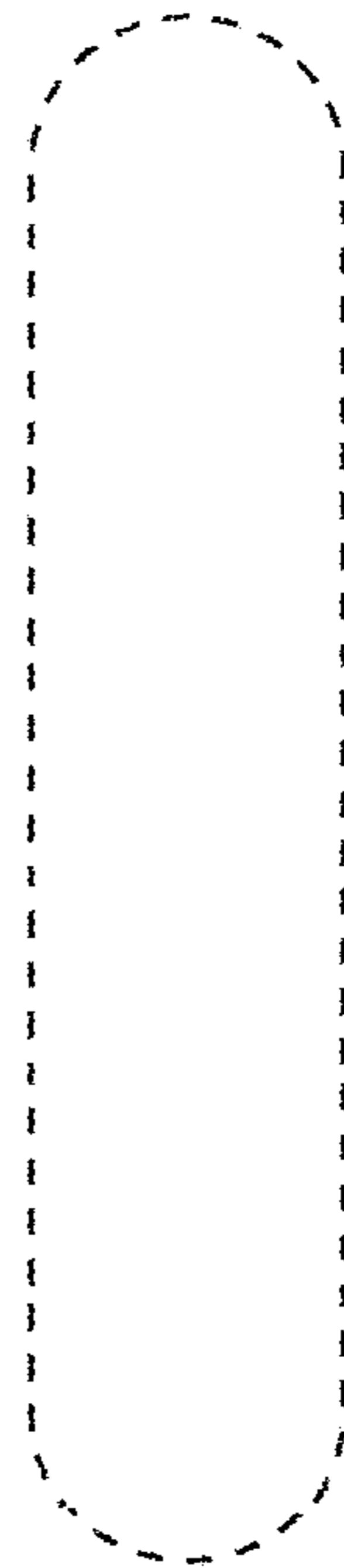

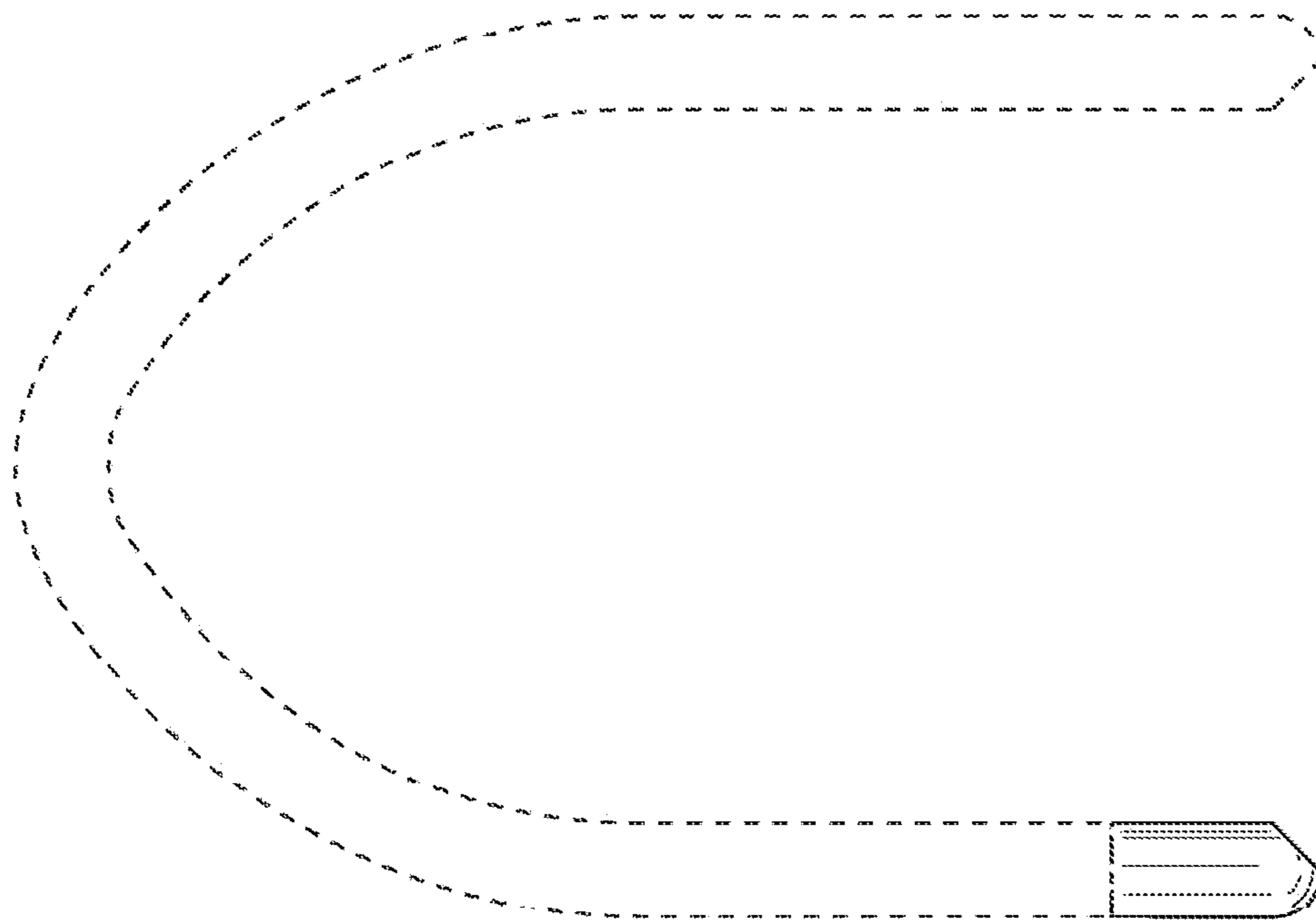
