**DESCRIPTION**

FIG. 1 is a front, top, and right-side perspective view of a lamp, according to an embodiment of the present invention shown;

FIG. 2 is a front elevational view of the lamp shown in FIG. 1;

FIG. 3 is a rear elevational view of the lamp shown in FIG. 1;

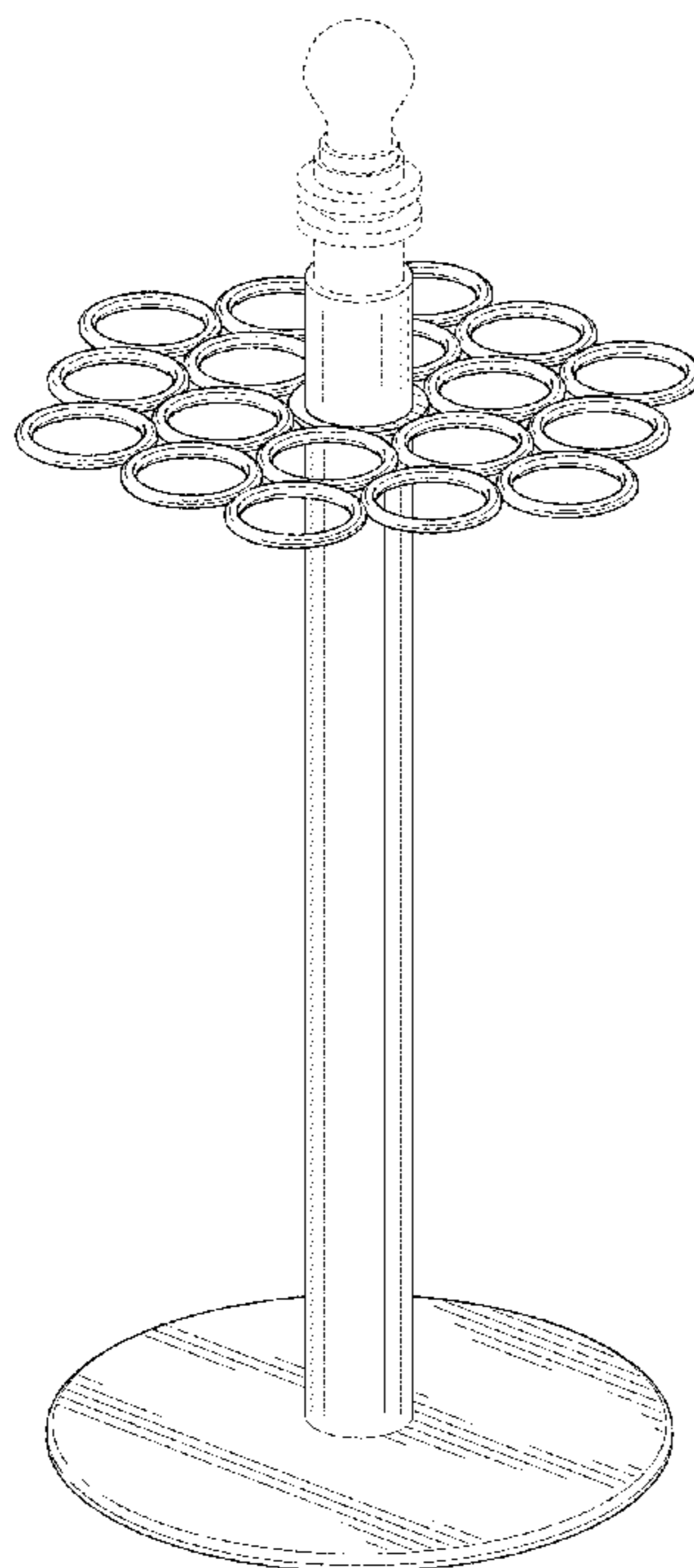
FIG. 4 is a right elevational view of the lamp shown in FIG. 1;

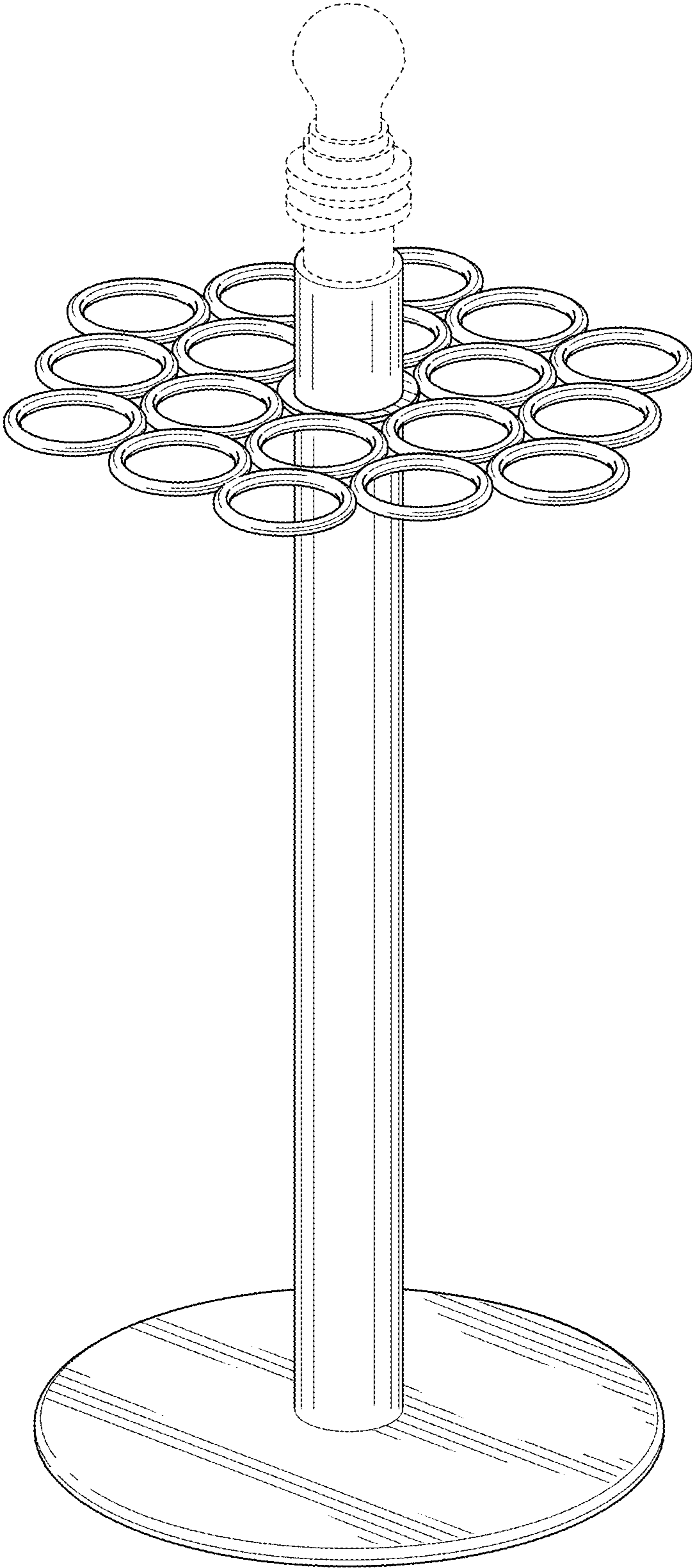

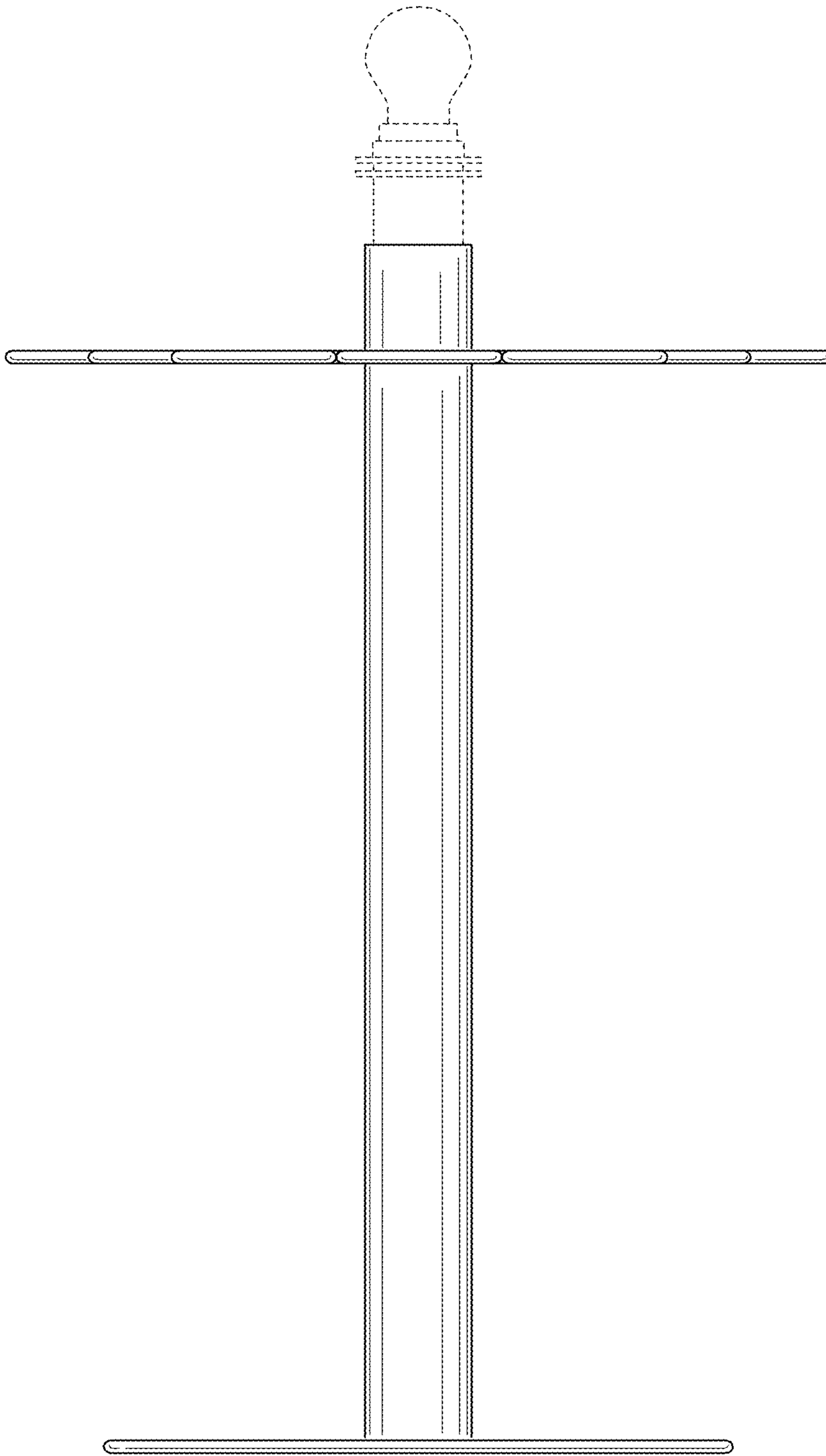
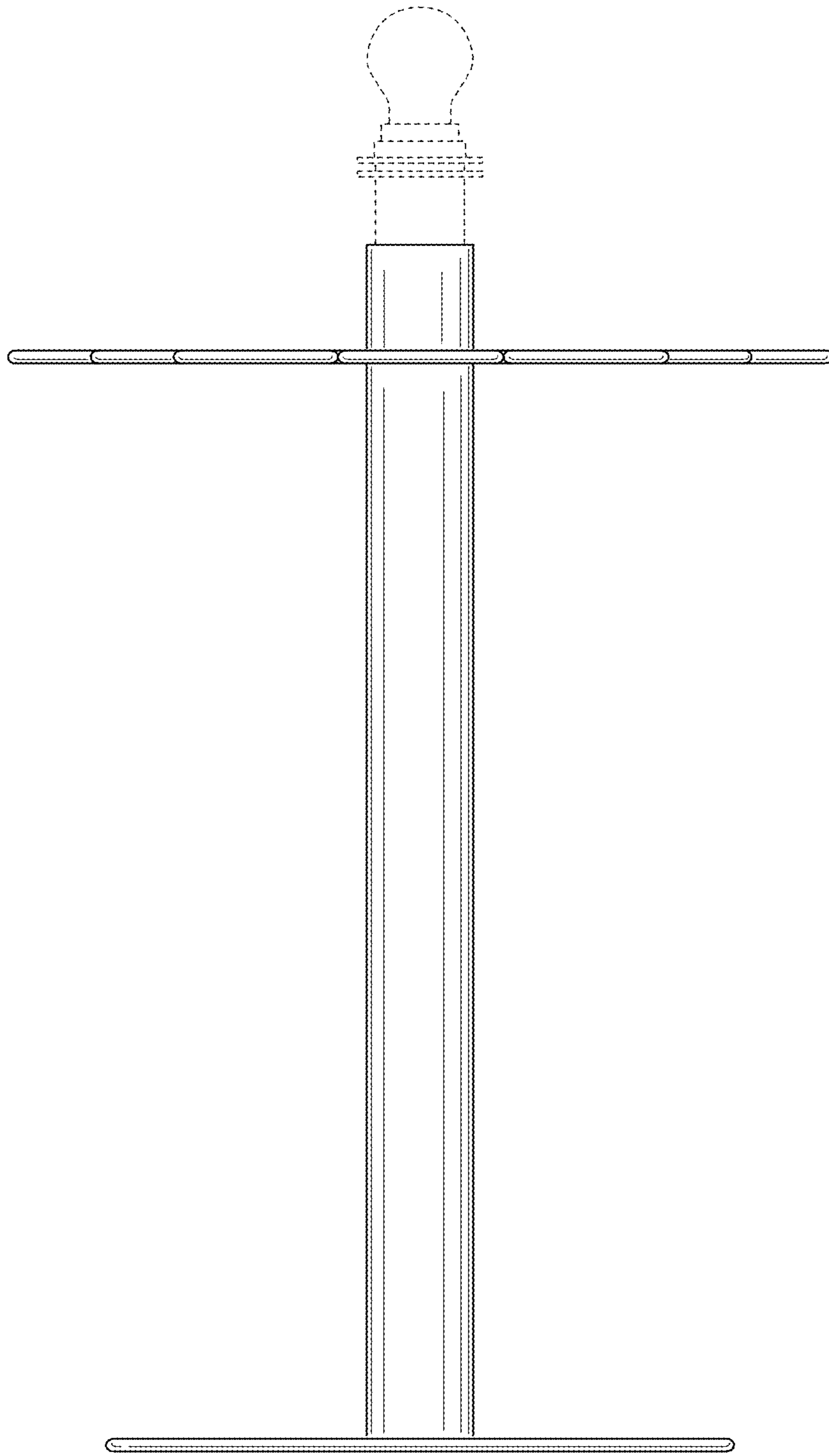

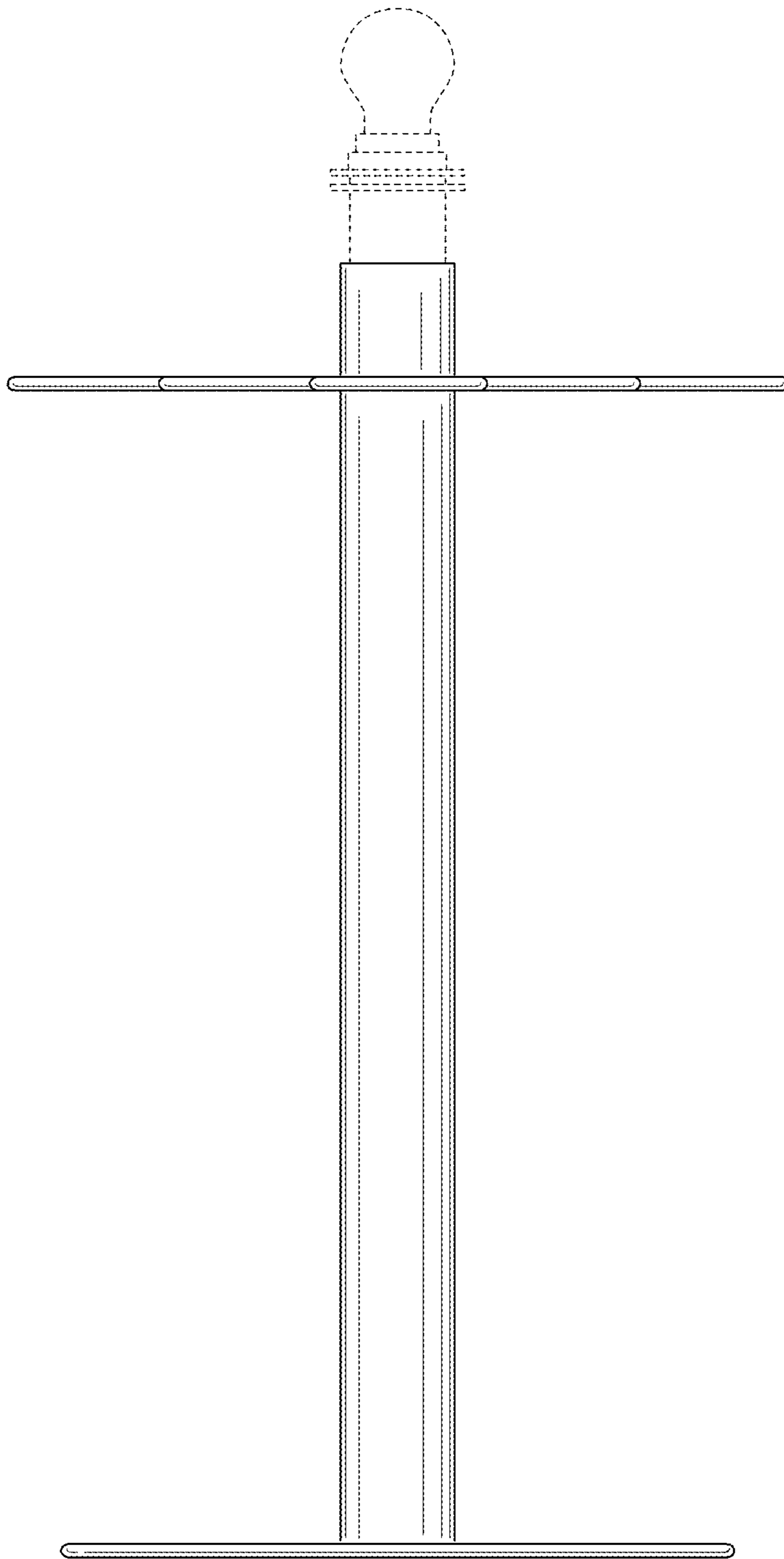
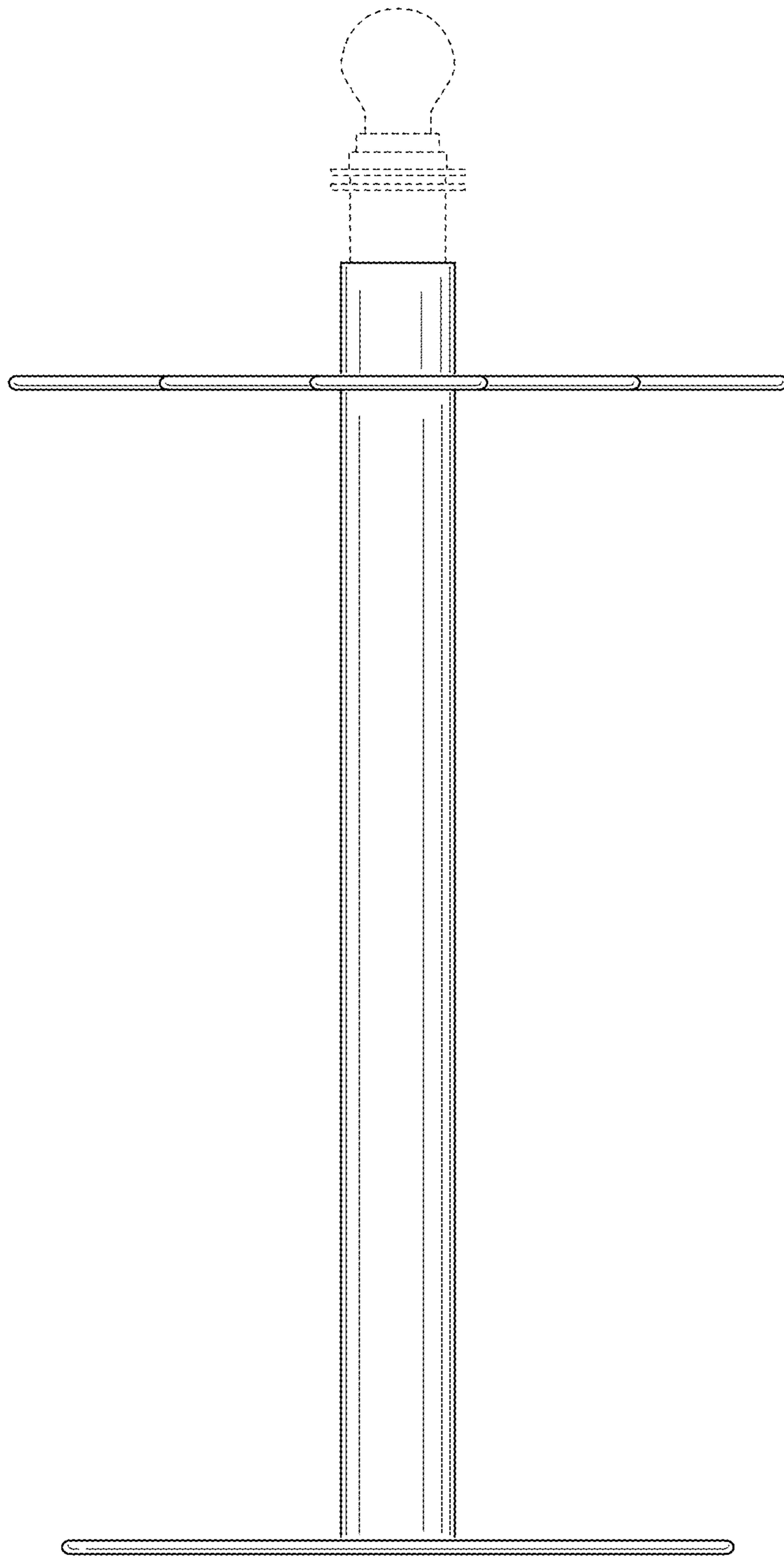

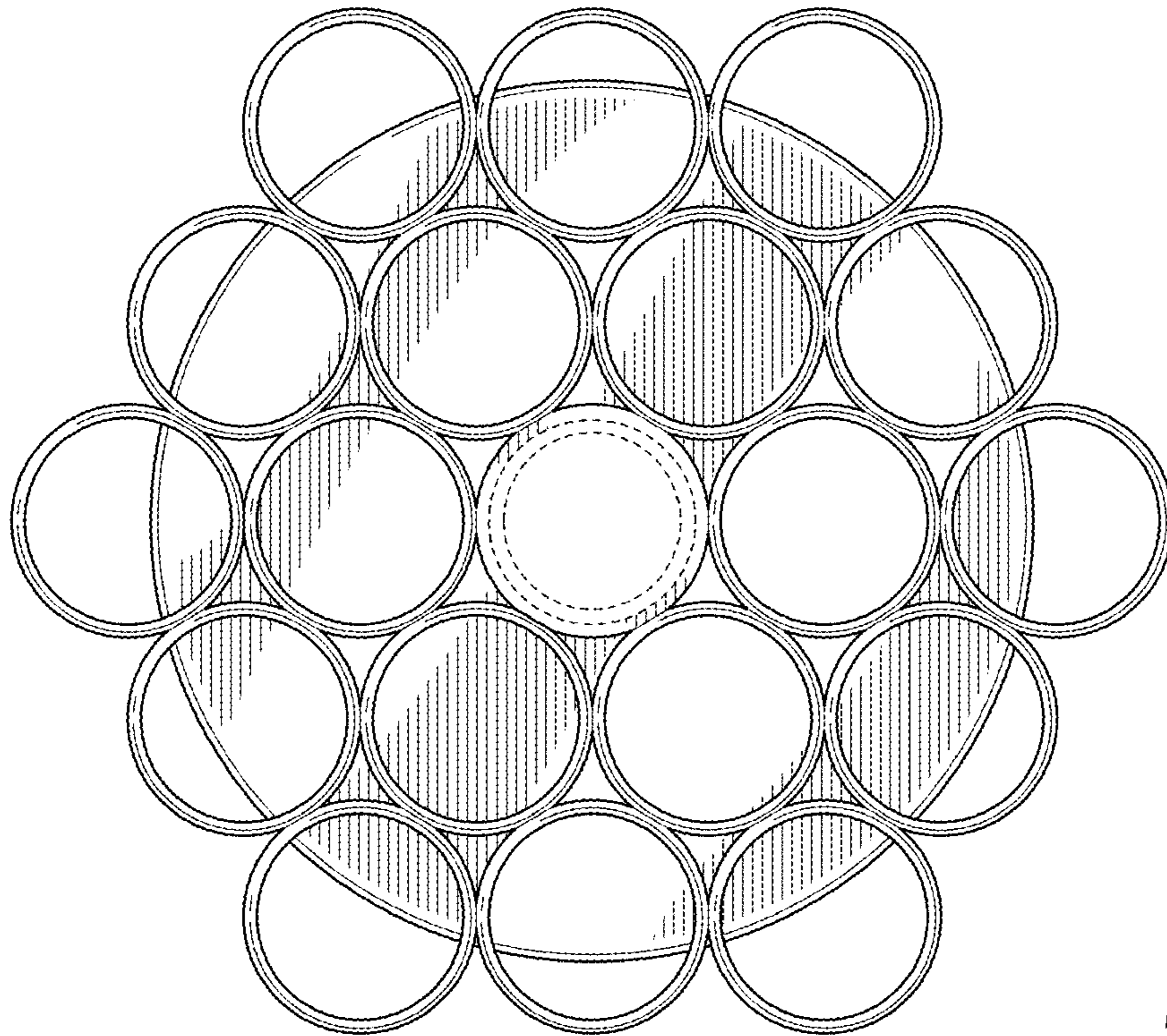

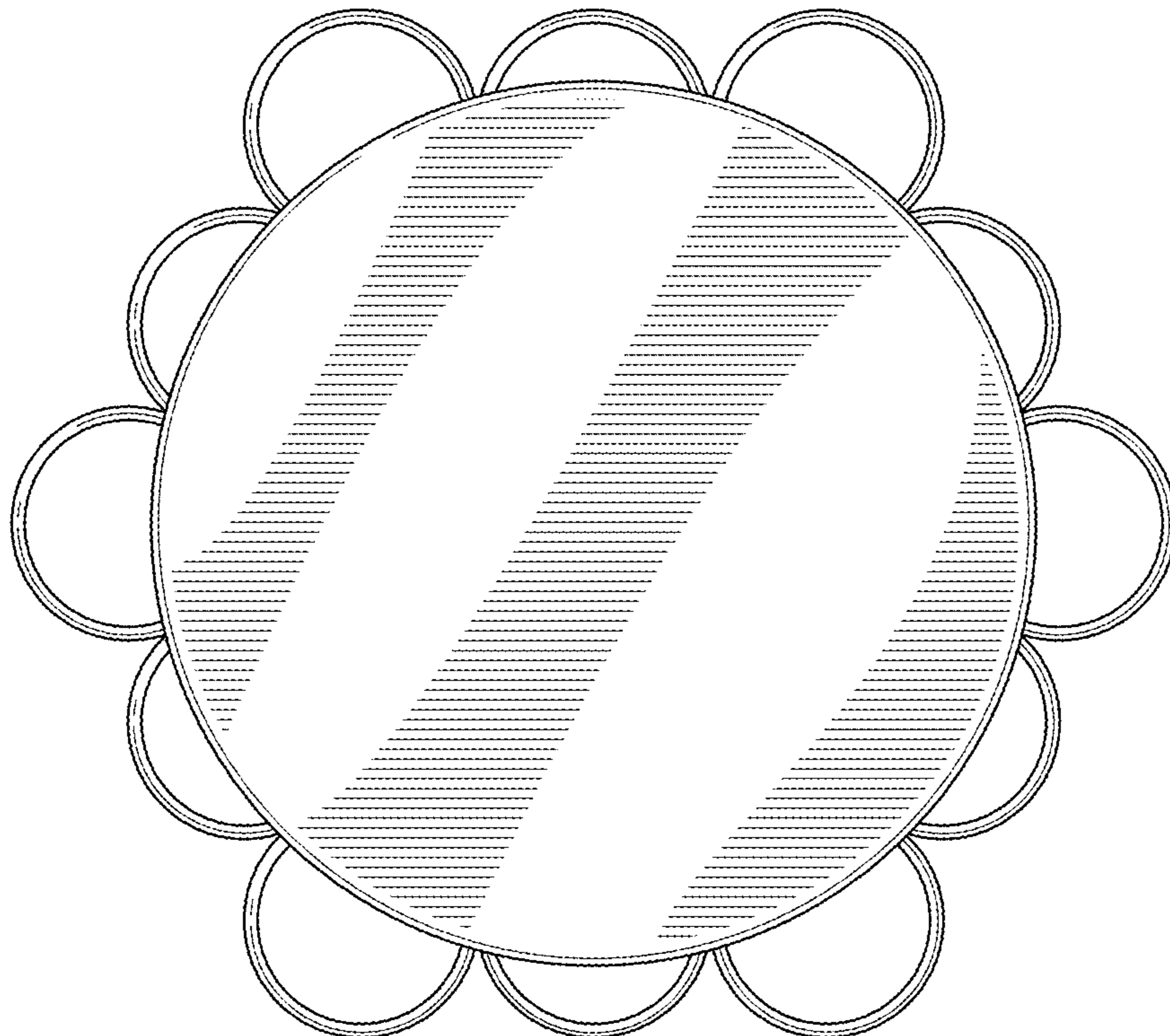
