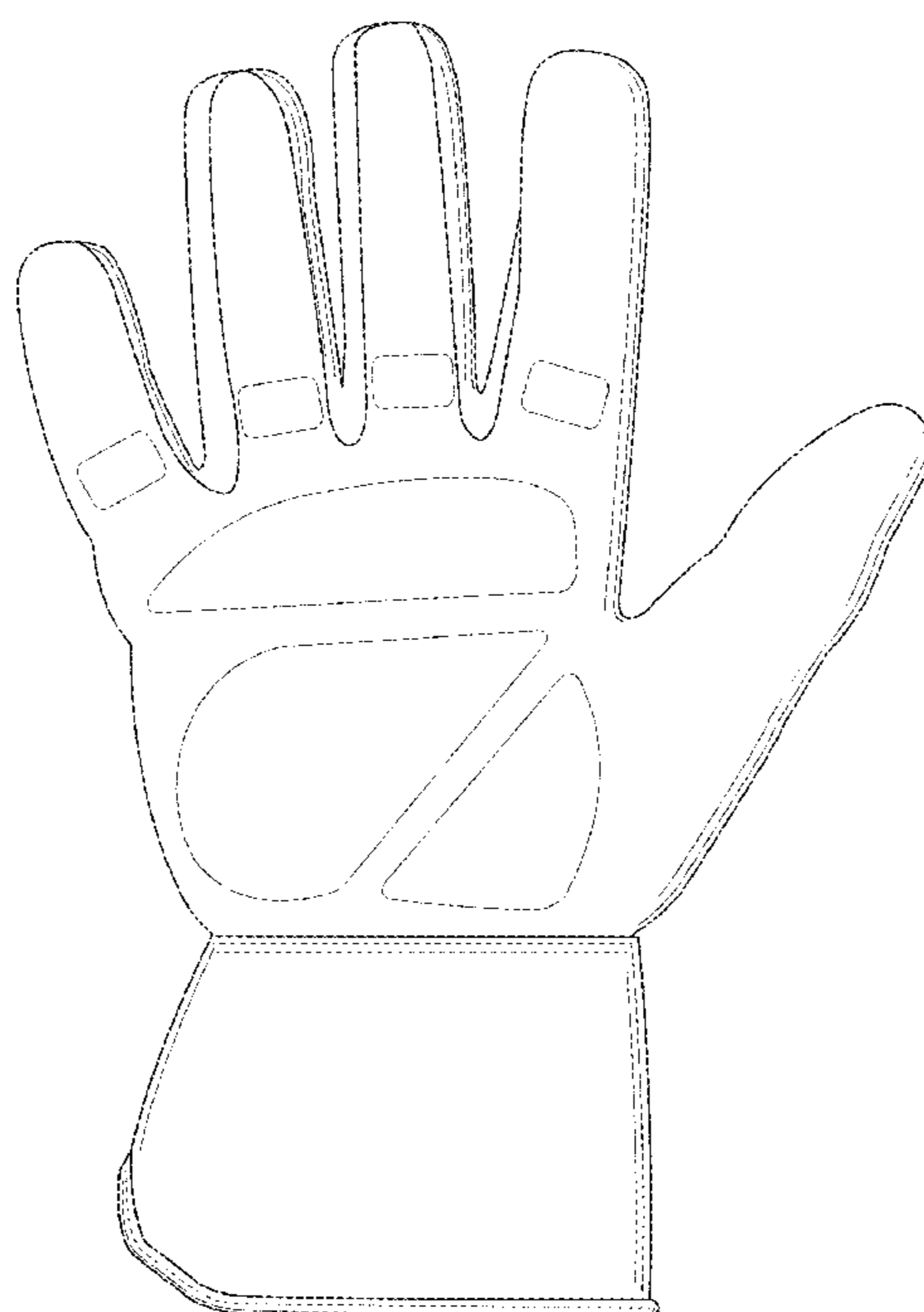

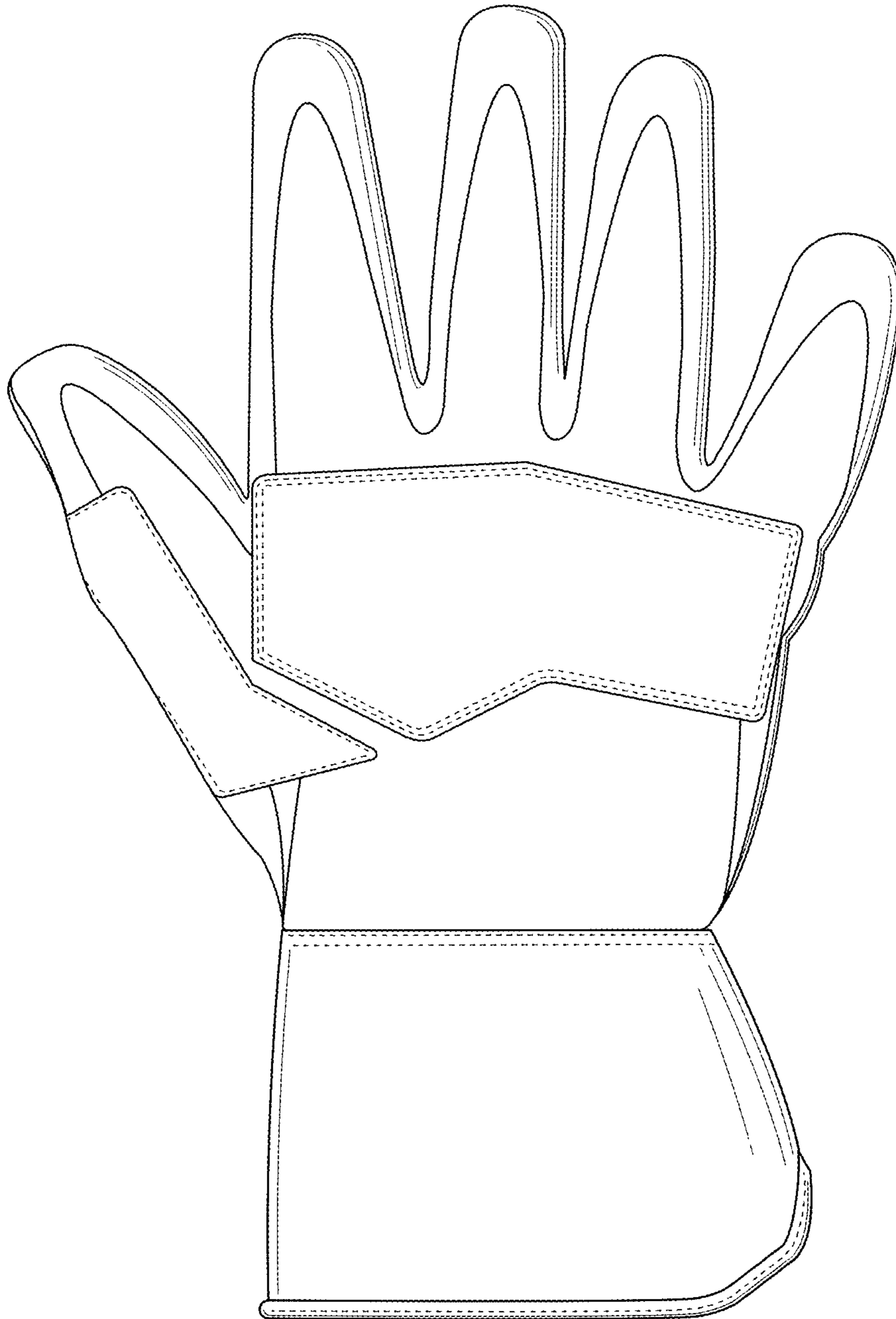
The ornamental design for a protective glove, as shown and described.

DESCRIPTION

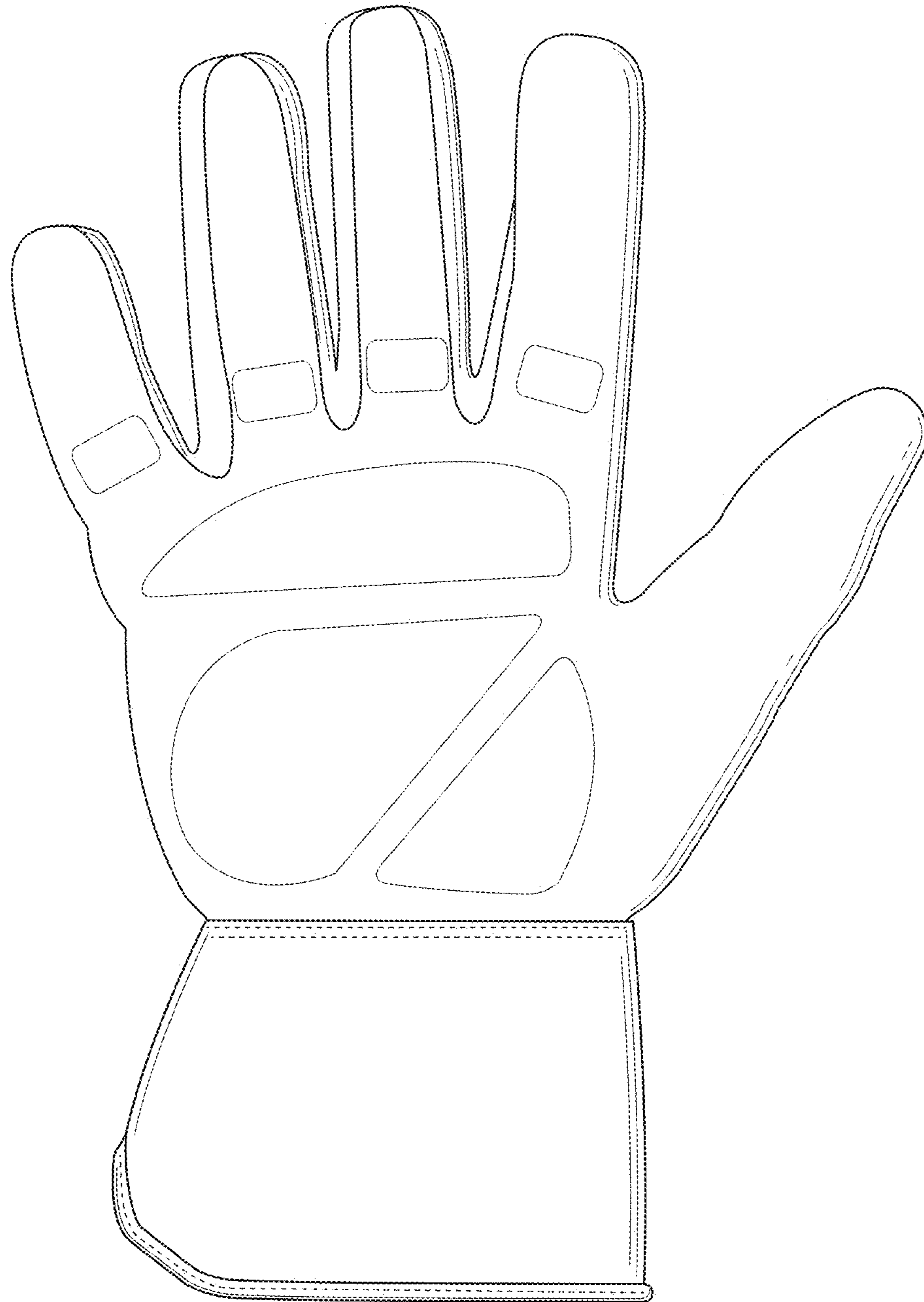
1.1 is a rear view of a right hand protective glove showing our new design;
1.2 is a front view thereof;
1.3 is a first side view thereof;
1.4 is a second side view thereof;
1.5 is a top view thereof; and
1.6 is a bottom view thereof.
The left hand protective glove is a mirror image of the right and protective glove;
The broken lines in the figures are for the purpose of illustrating stitching and form no part of the claim.

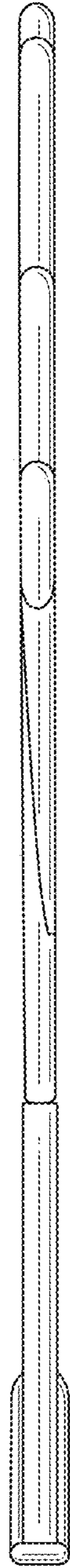

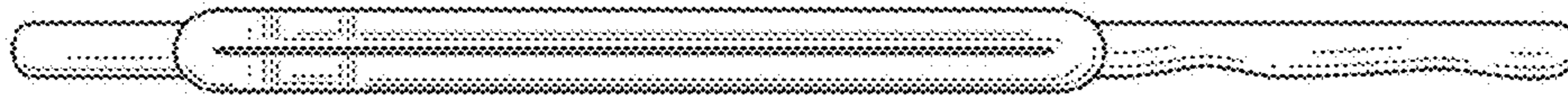
