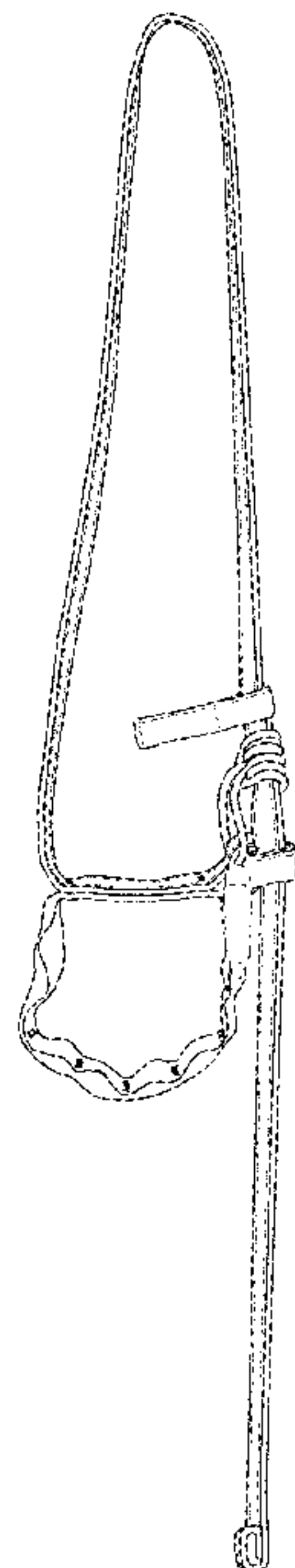

(57) **CLAIM**
The ornamental design for a fireman's carry strap, as shown
and described.

DESCRIPTION
FIG. 1 is a left side view of a fireman's carry strap showing
my new design;
FIG. 2 is a right side view of the fireman's carry strap;
FIG. 3 is a side view of the right side of the fireman's carry
strap;
FIG. 4 is a close up right side view of FIG. 3;
FIG. 5 is a side view of the right side of the fireman's carry
strap;
FIG. 6 is a close up right side view of FIG. 5;
FIG. 7 is back view of the fireman's carry strap;
FIG. 8 is a close up partial back view of FIG. 7;
FIG. 9 is a left side view of the fireman's carry strap;
FIG. 10 is a close up partial side view of FIG. 9;
FIG. 11 is a front view of the fireman's carry strap; and,
FIG. 12 is a close up partial front view of FIG. 11.
FIGS. 3, 4, 7, 8, 11 and 12 show the design in alternate
configurations for clarity of disclosure.
The broken lines shown in the drawings show unclaimed
features of the fireman's carry strap and form no part of the
claimed design.

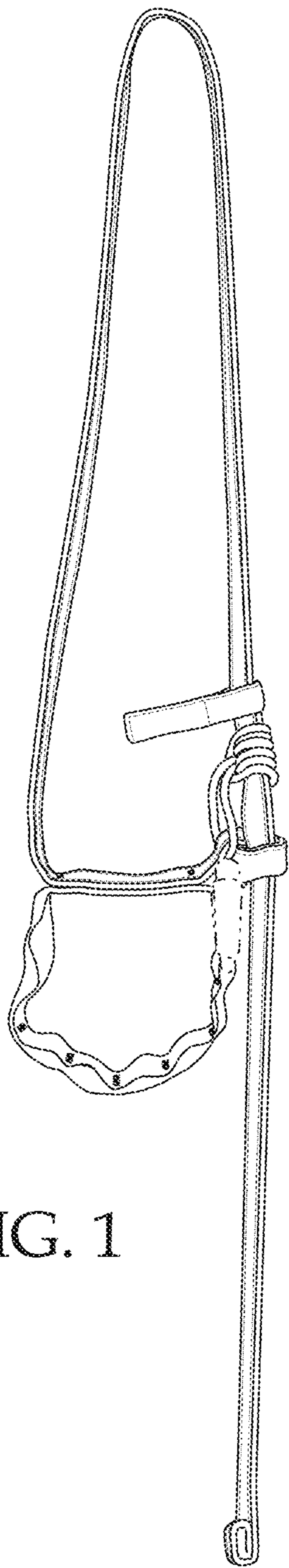

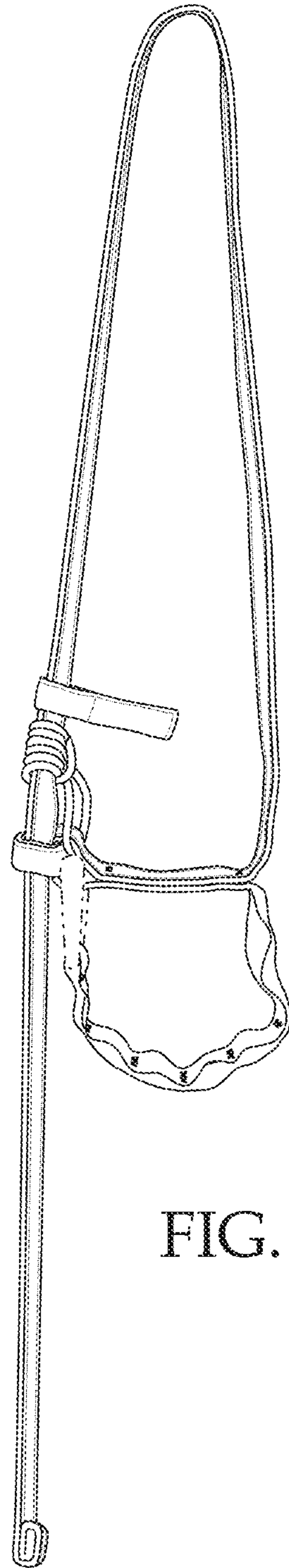
