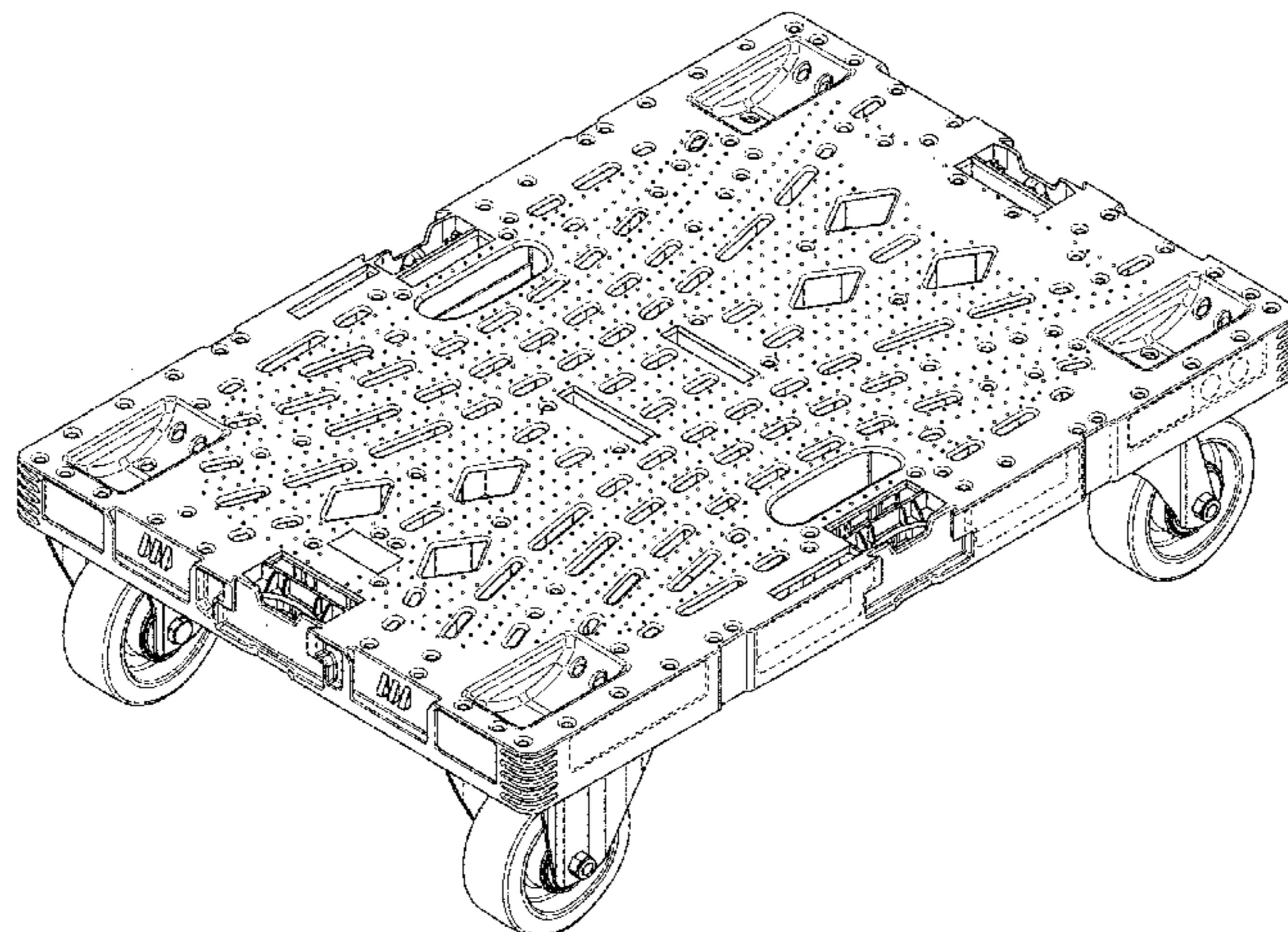
(57) **CLAIM**

The ornamental design for a wheeled quarter dolly, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a wheeled quarter dolly showing our new design;
 FIG. 2 is a left-side view thereof;
 FIG. 3 is a right-side view thereof;
 FIG. 4 is a front view thereof;
 FIG. 5 is a back view thereof;
 FIG. 6 is a top view thereof; and,
 FIG. 7 is a bottom view thereof.

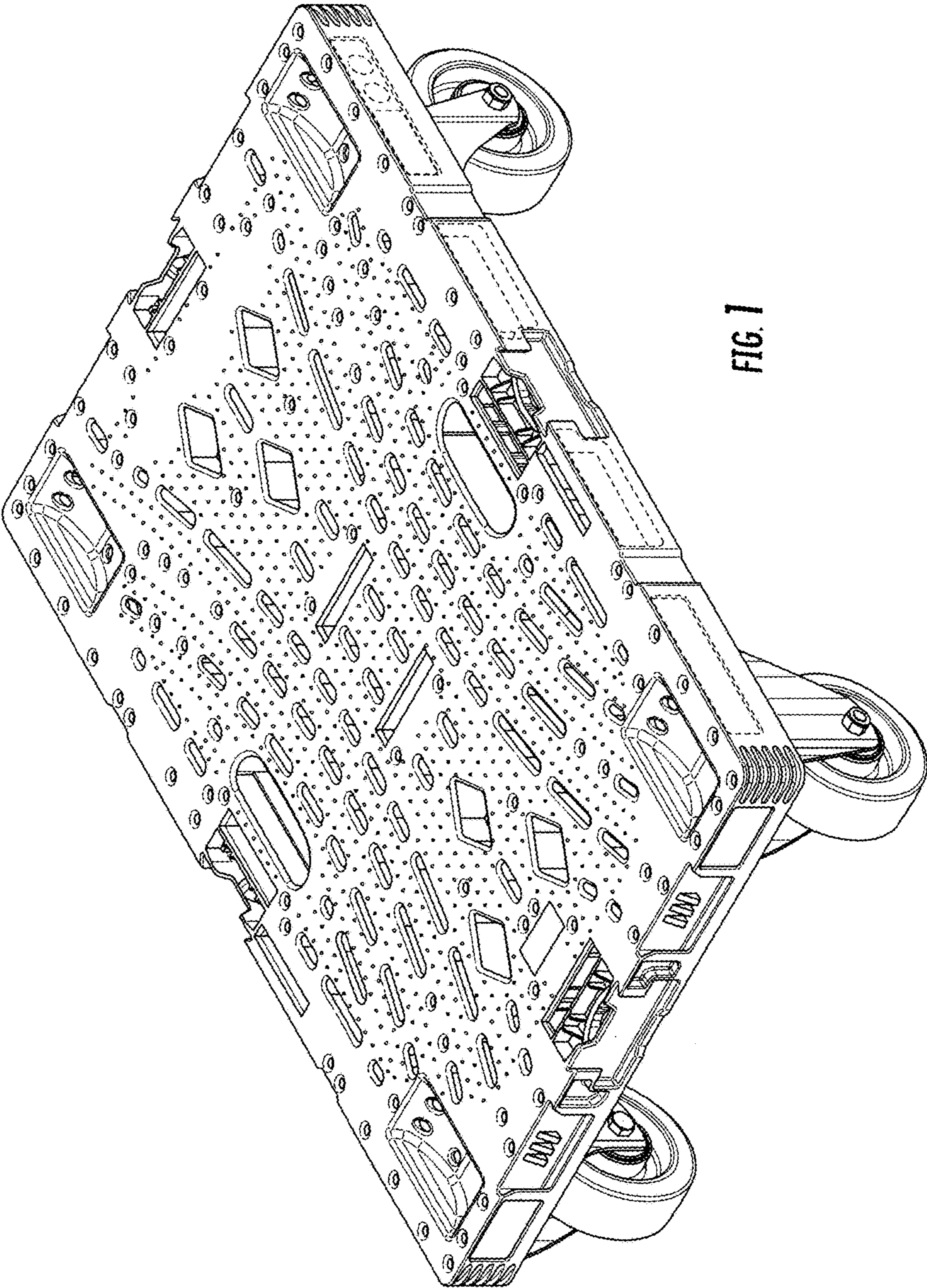

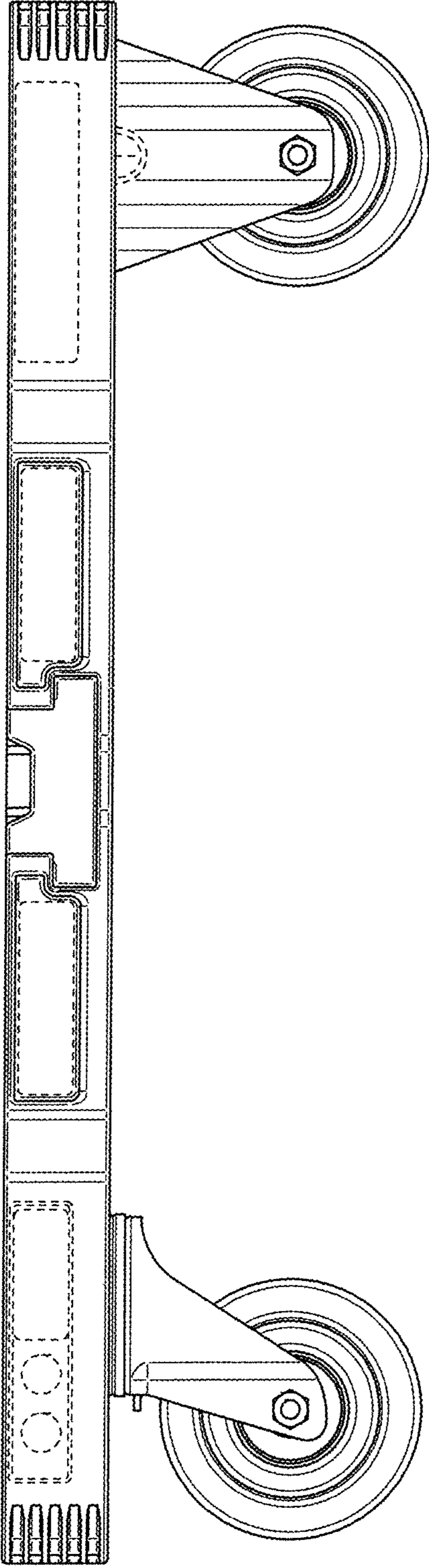

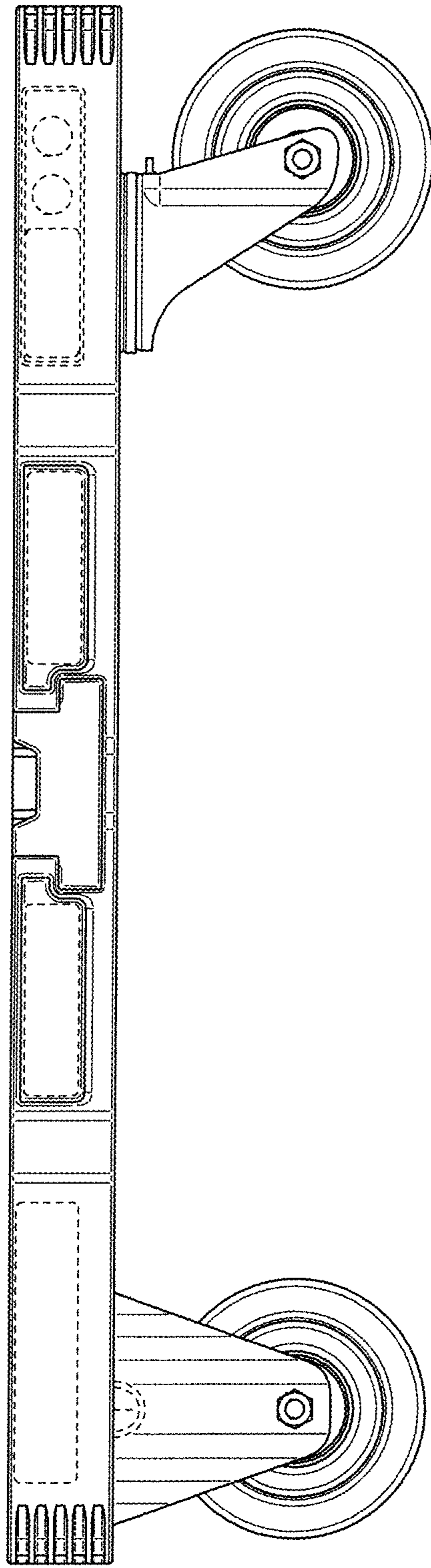

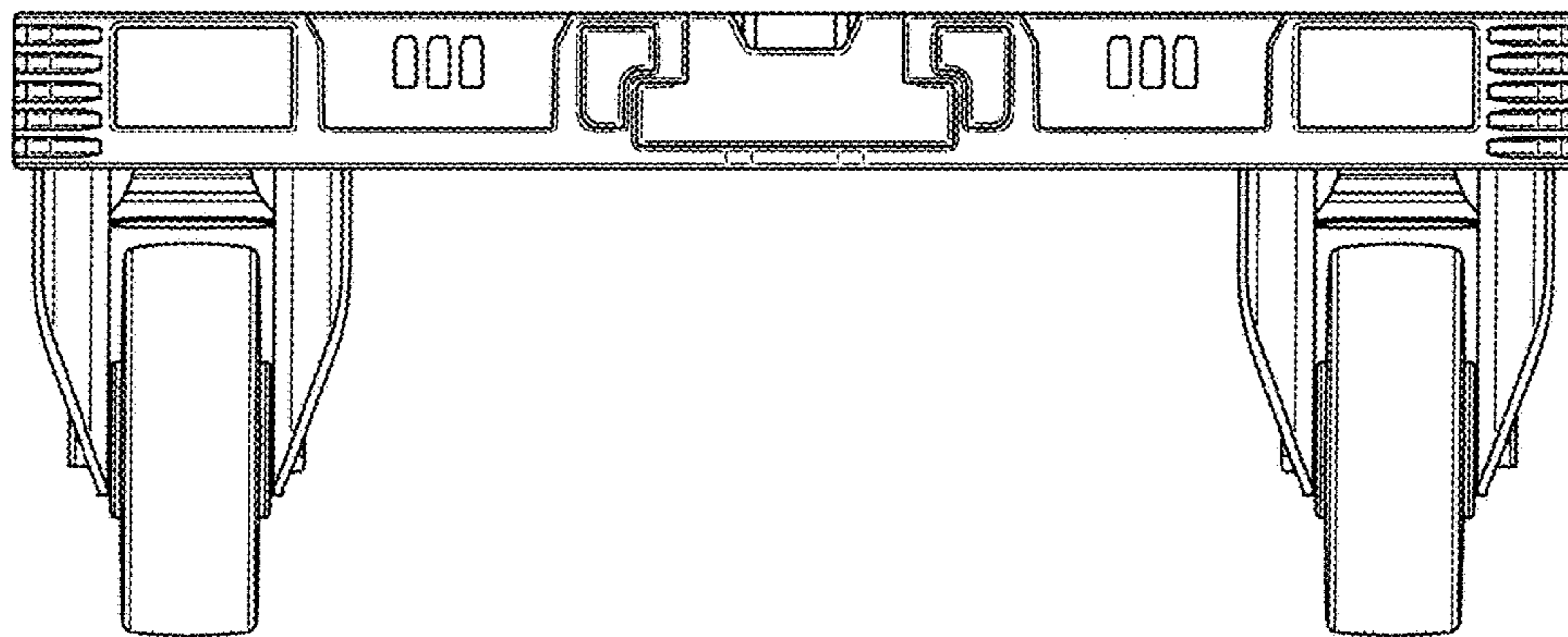

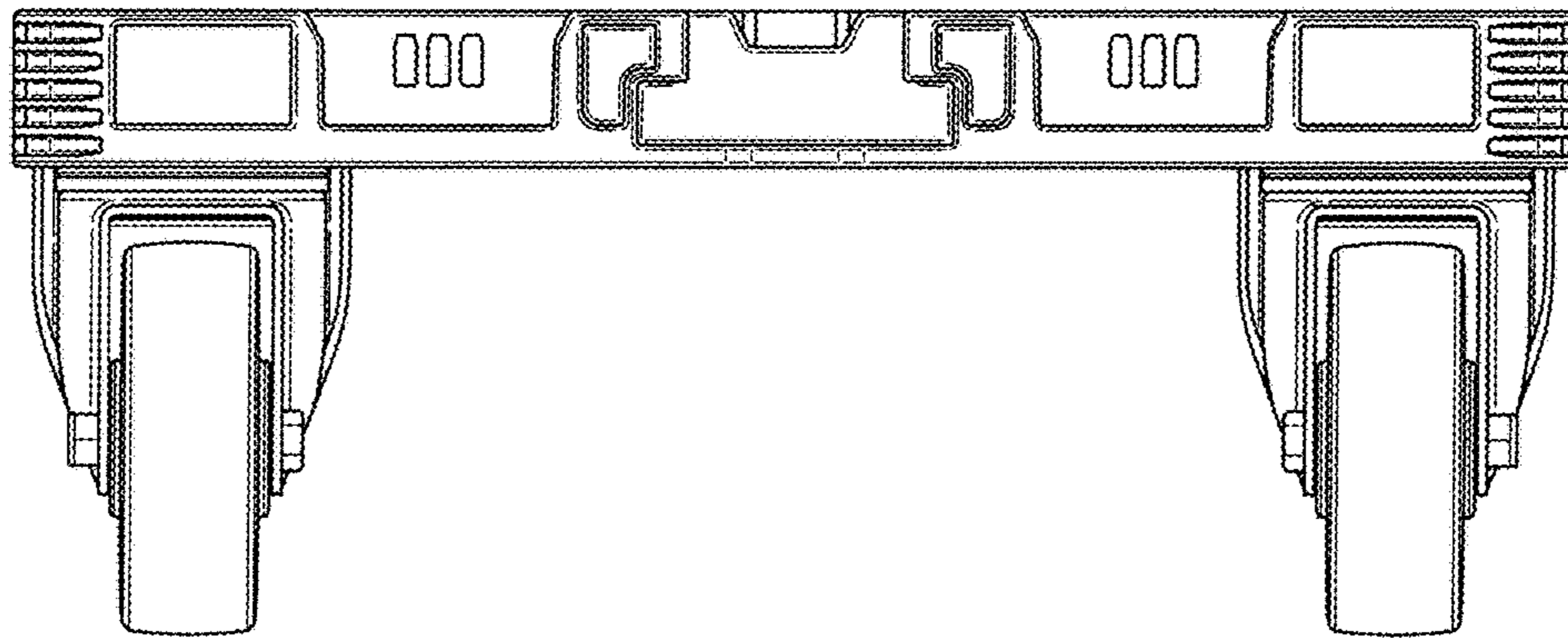

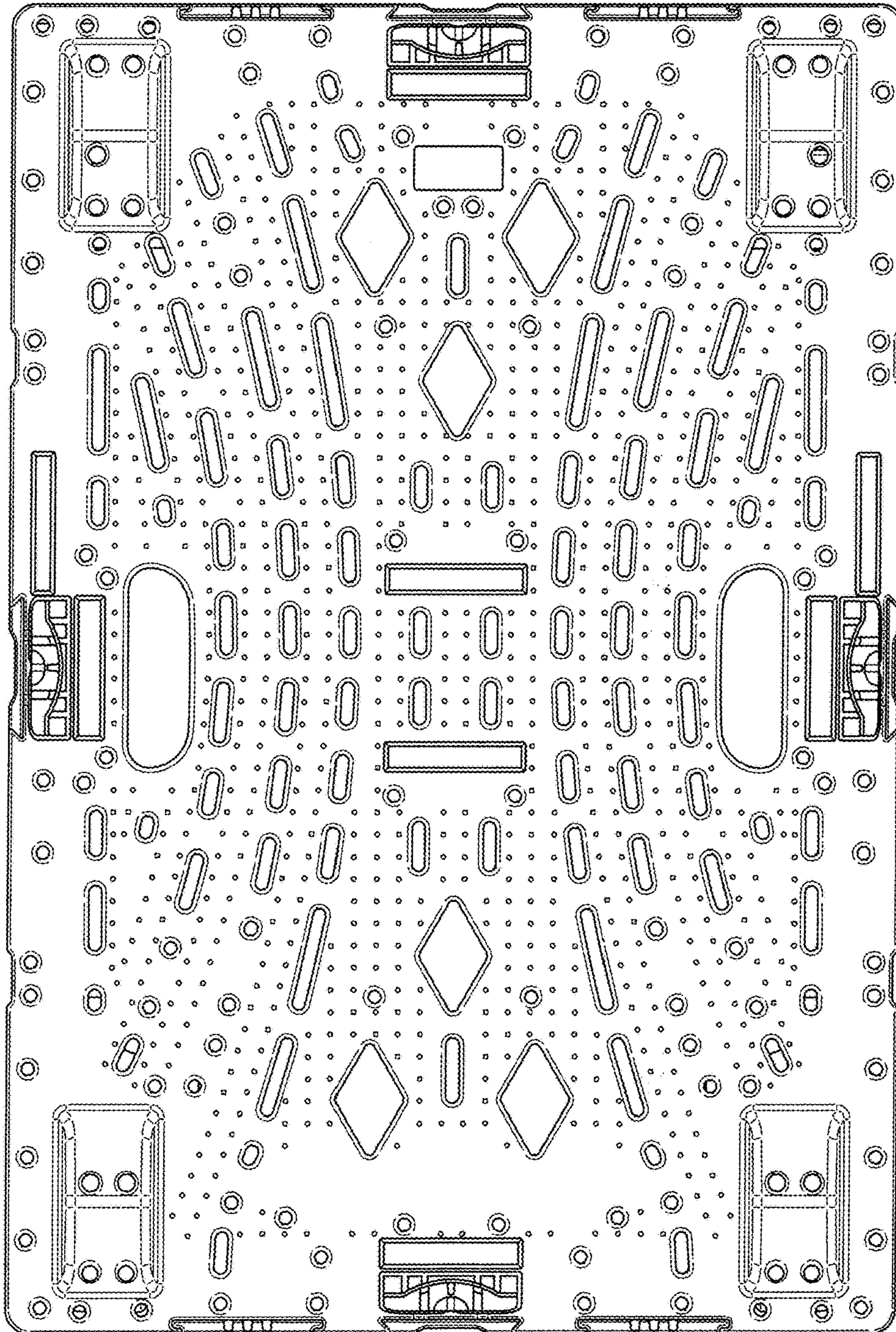
