FIG. 3 is a back view of the infant travel bag shown in FIG. 1 in accordance with a first embodiment;

FIG. 4 is a right perspective view of the infant travel bag shown in FIG. 1;

FIG. 5 is a left perspective view of the infant travel bag shown in FIG. 1;

FIG. 6 is a top perspective view of the infant travel bag shown in FIG. 1;

FIG. 7 is a bottom perspective view of the infant travel bag shown in FIG. 1;

FIG. 8 is a top perspective view of the infant travel bag shown in FIG. 1 when opened; and,

FIG. 9 is a back view of the infant travel bag shown in FIG. 1 in accordance with a second embodiment.

The dashed lines in the drawings depict decorative stitching and forms part of the claimed design. The crosshatch shading on the surface of the infant travel bag represents the material of the infant travel bag and is shown fragmentally for convenience of illustration. The stipple shading and the crosshatch shading illustrate contrasting materials.

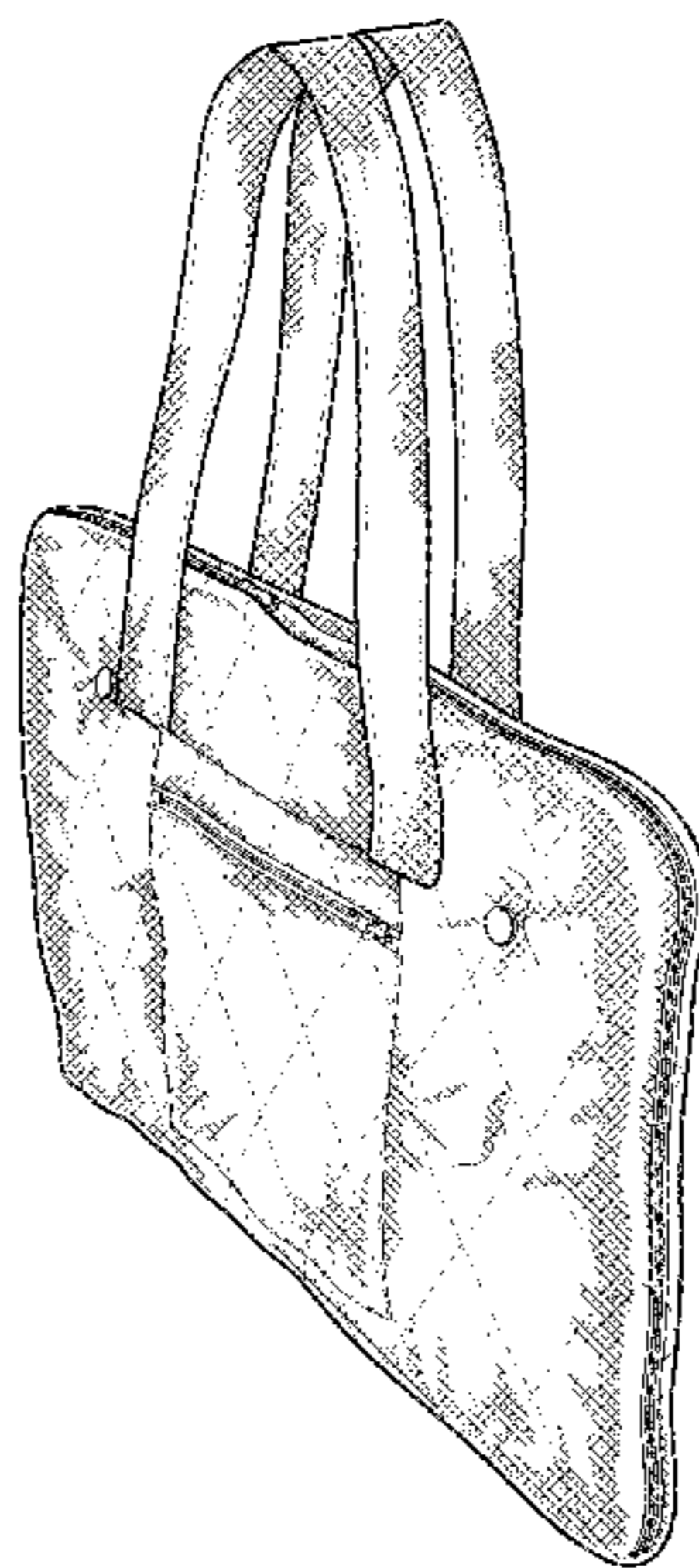

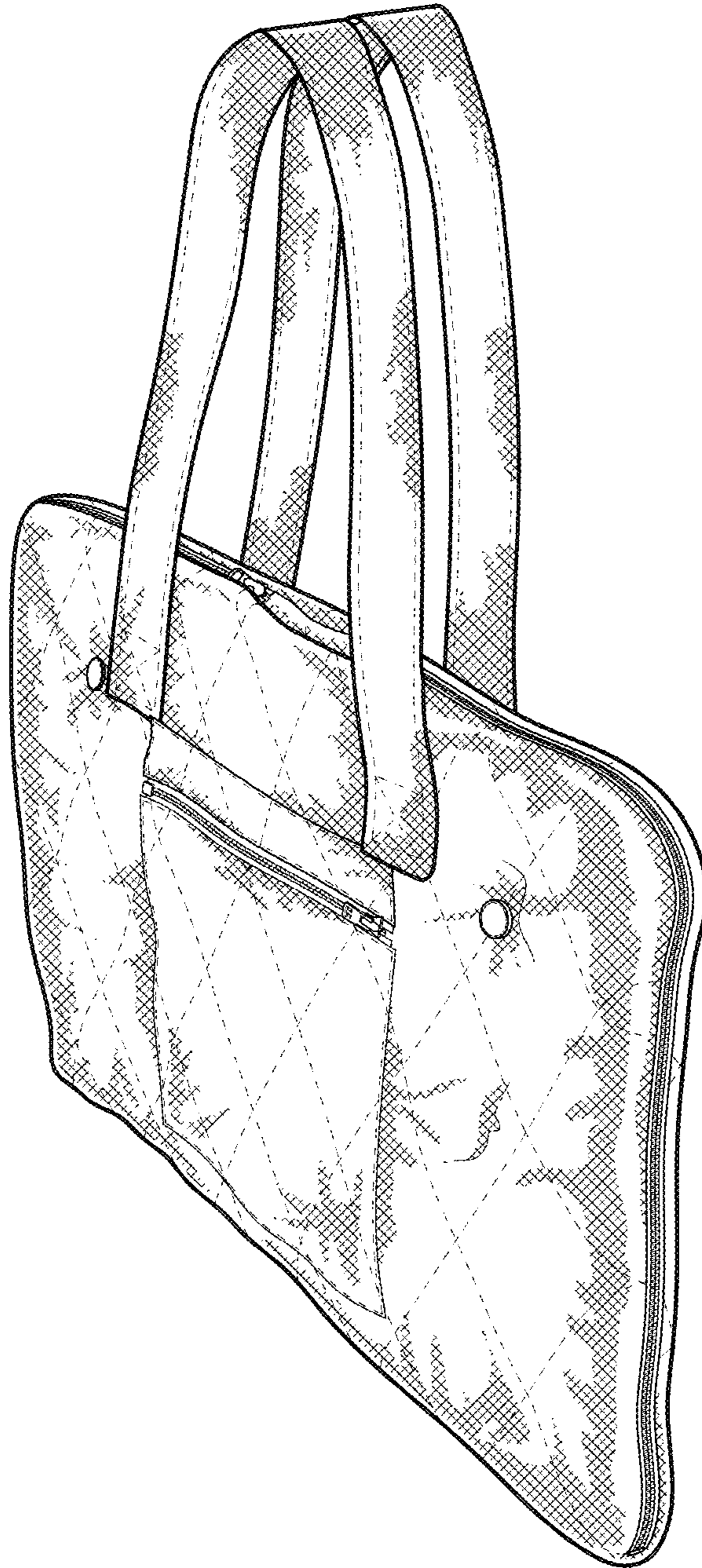

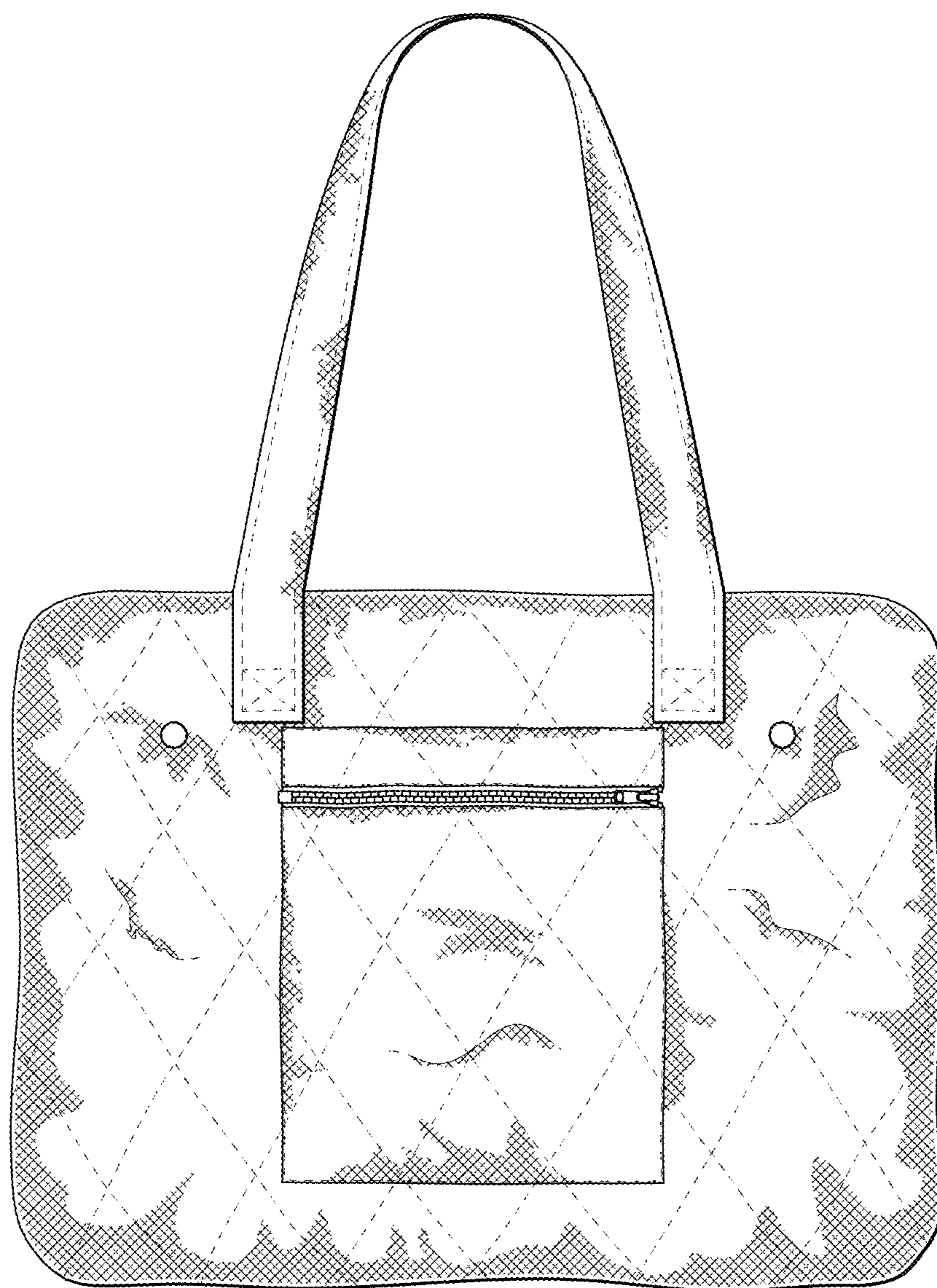

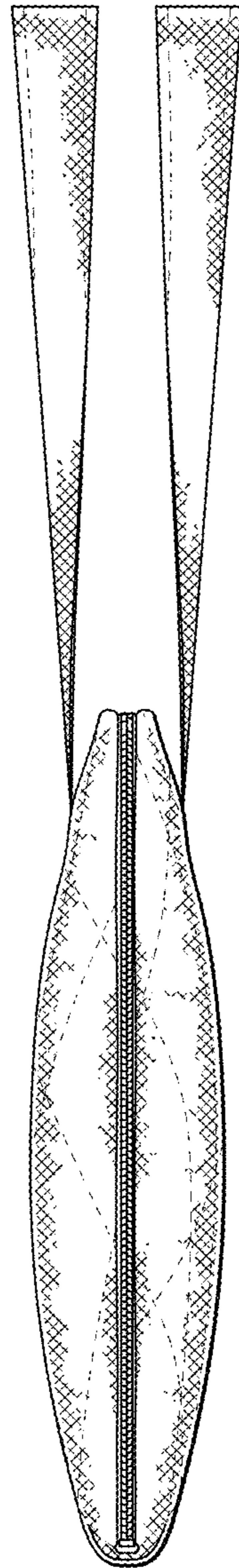

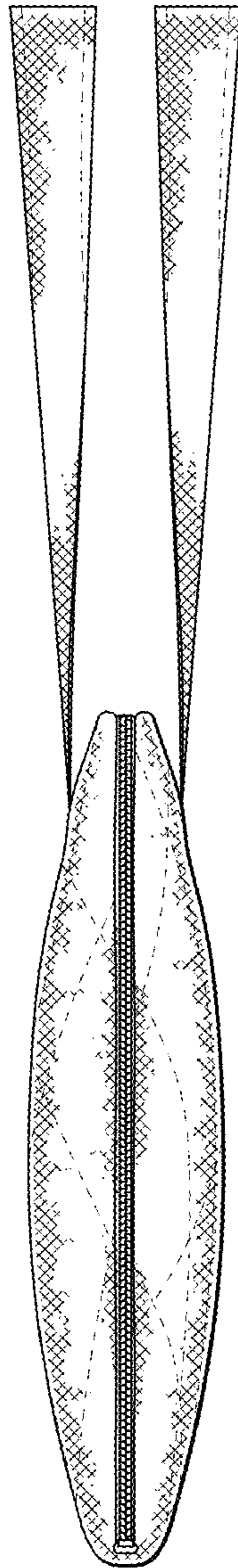

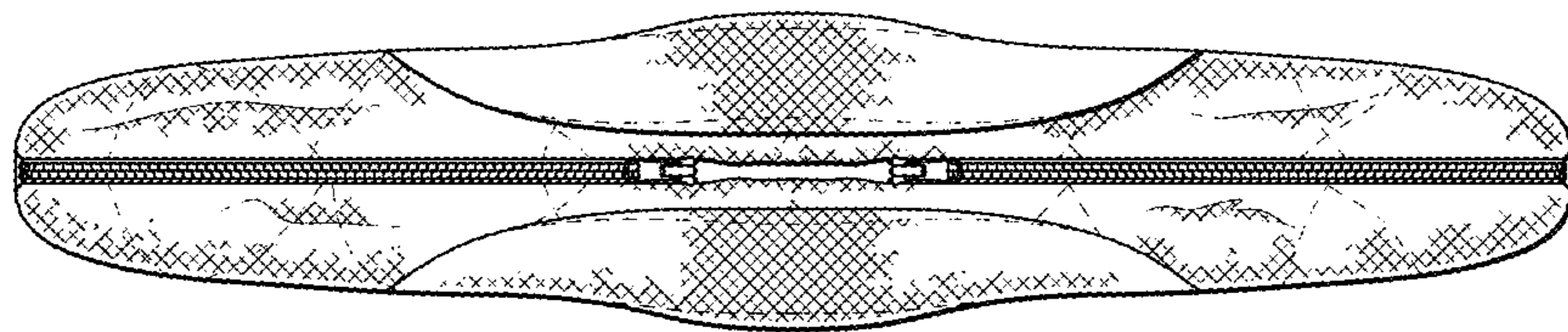

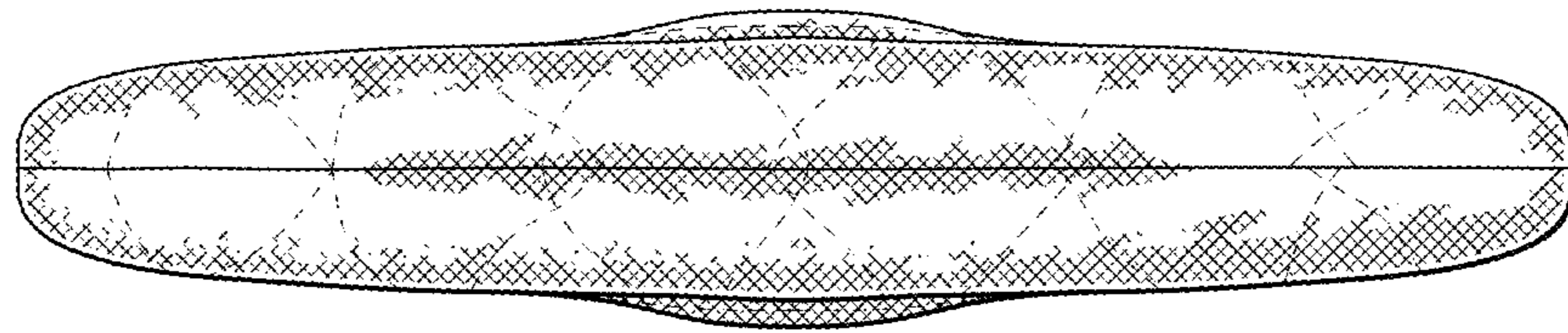

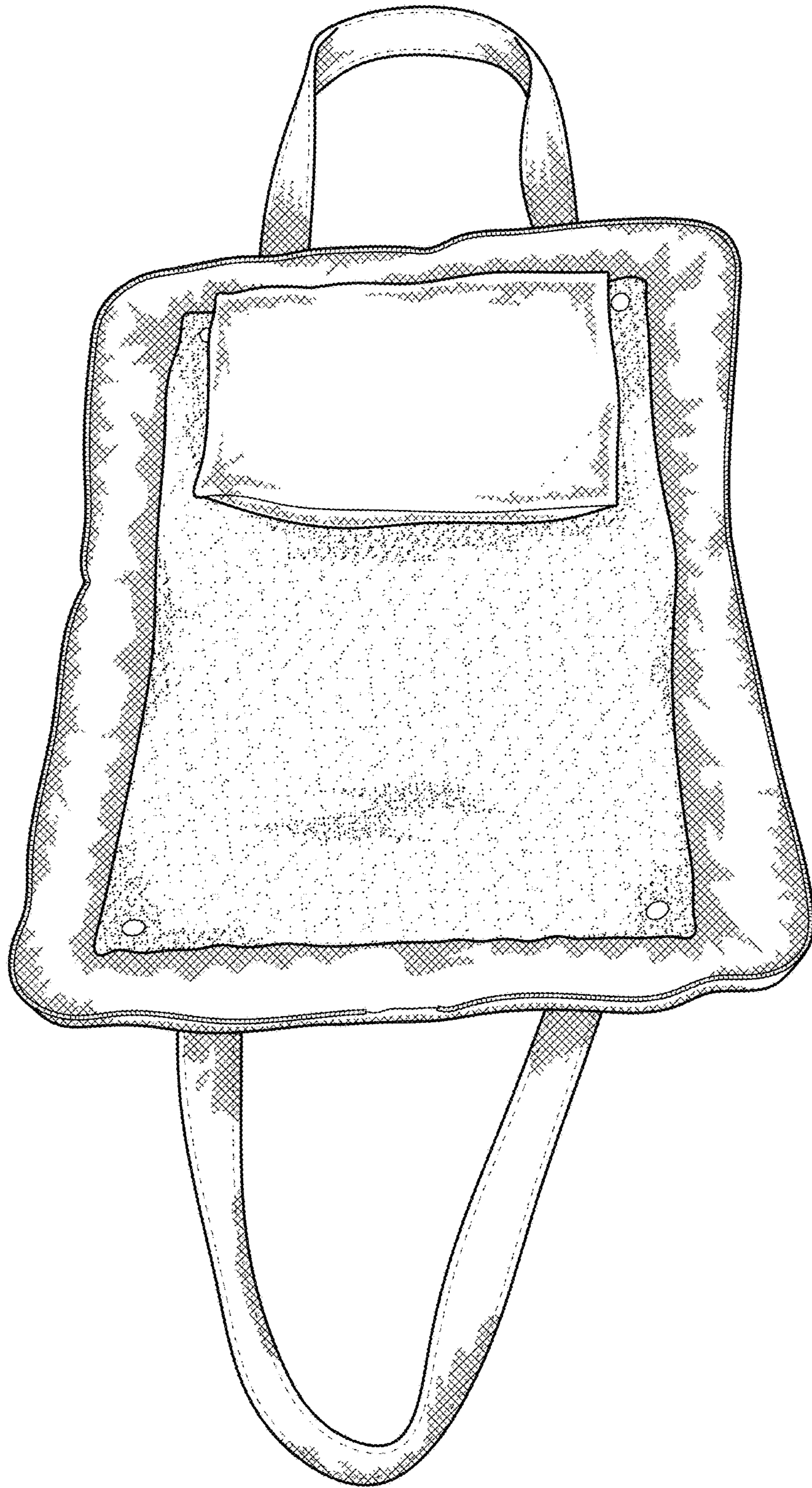
