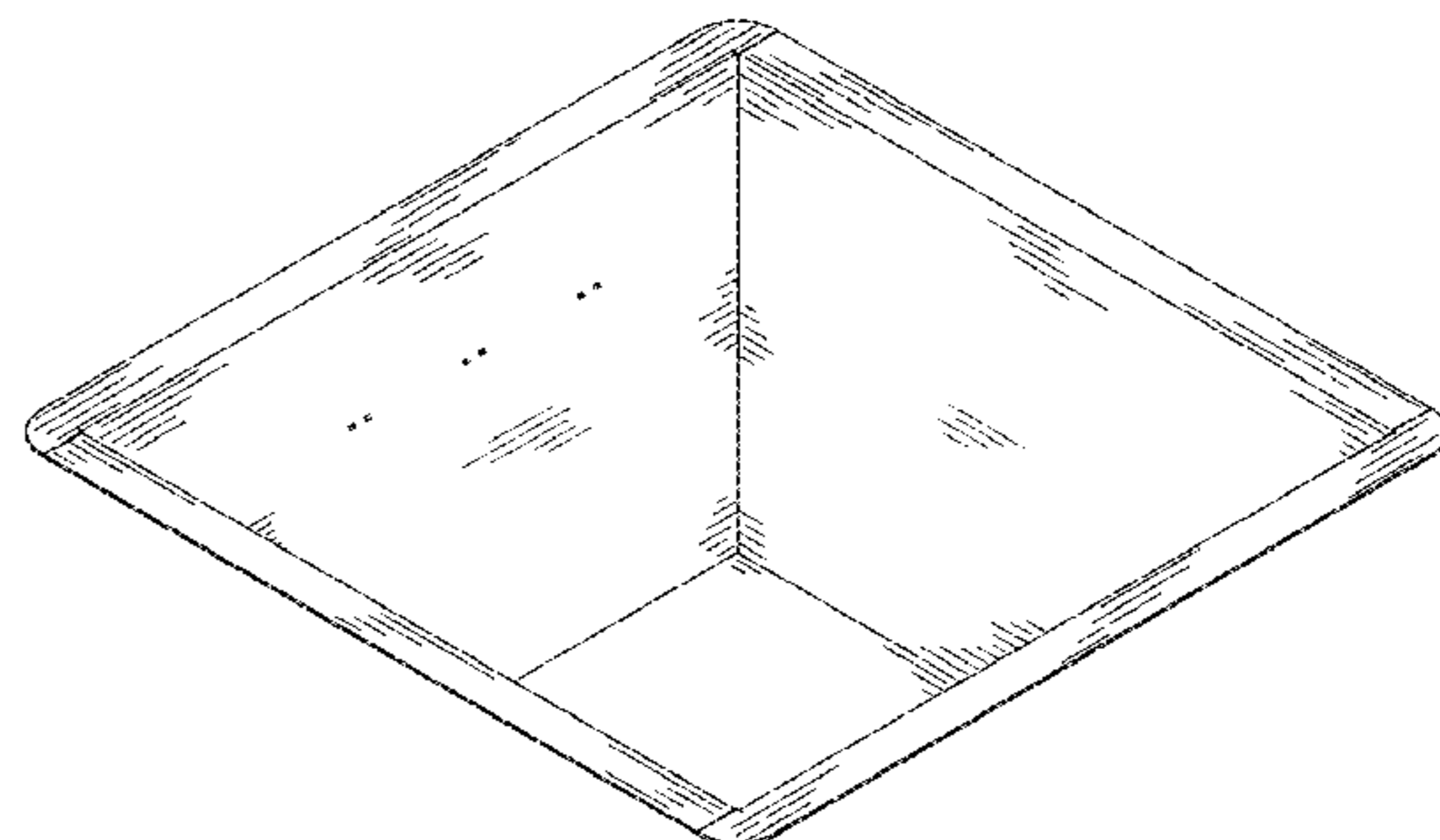
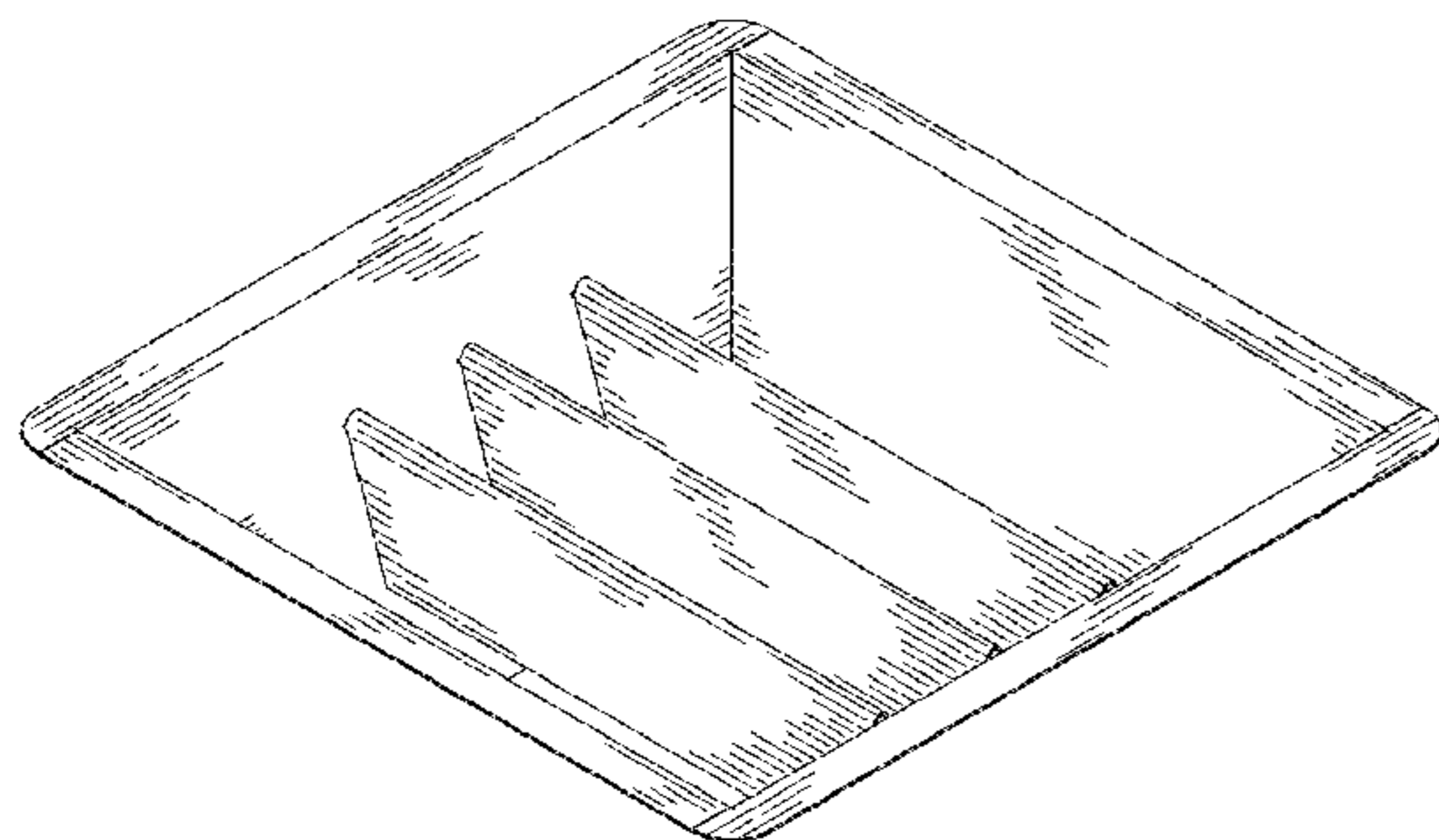
(57) **CLAIM**

The ornamental design of a sear station for a pellet grill style barbeque, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view showing my new design of a sear station for a pellet grill style barbeque in a first configuration (the rear view being identical thereto);  
FIG. 2 is a left side view of the sear station of FIG. 1 (the right side view being identical thereto);  
FIG. 3 is a top view of the sear station of FIG. 1;  
FIG. 4 is a bottom view of the sear station of FIG. 1;  
FIG. 5 is a cross-sectional view of the sear station of FIG. 1 taken along lines 5-5 of FIG. 3;  
FIG. 6 is a top perspective view of the sear station of FIG. 1;  
FIG. 7 is a bottom perspective view of the sear station of FIG. 1;  
FIG. 8 is a front view of the sear station of FIG. 1 in an alternate configuration, shown with the removable grill bars removed for completeness of illustration (the rear view being identical thereto);  
FIG. 9 is a left side view of the sear station of FIG. 8 (the right side view being identical thereto);  
FIG. 10 is a top view of the sear station of FIG. 8;  
FIG. 11 is a bottom view of the sear station of FIG. 8;  
FIG. 12 is a cross-sectional view of the sear station of FIG. 8 taken along lines 12-12 of FIG. 10;  
FIG. 13 is a top perspective view of the sear station of FIG. 8; and,  
FIG. 14 is a bottom perspective view of the sear station of FIG. 8.

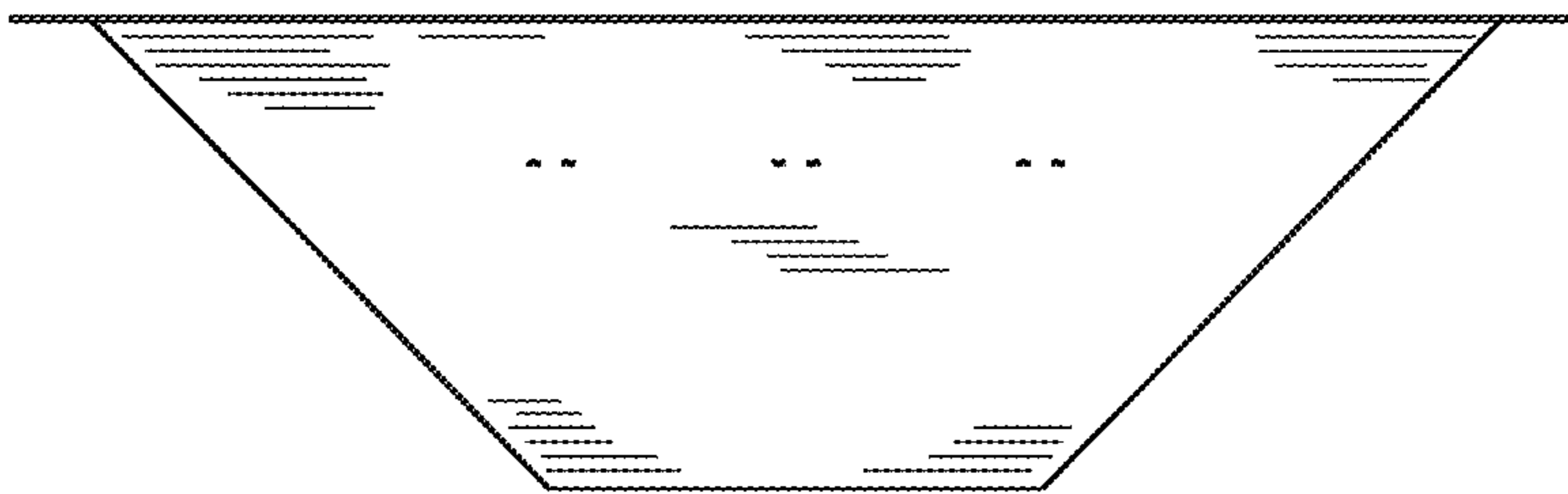

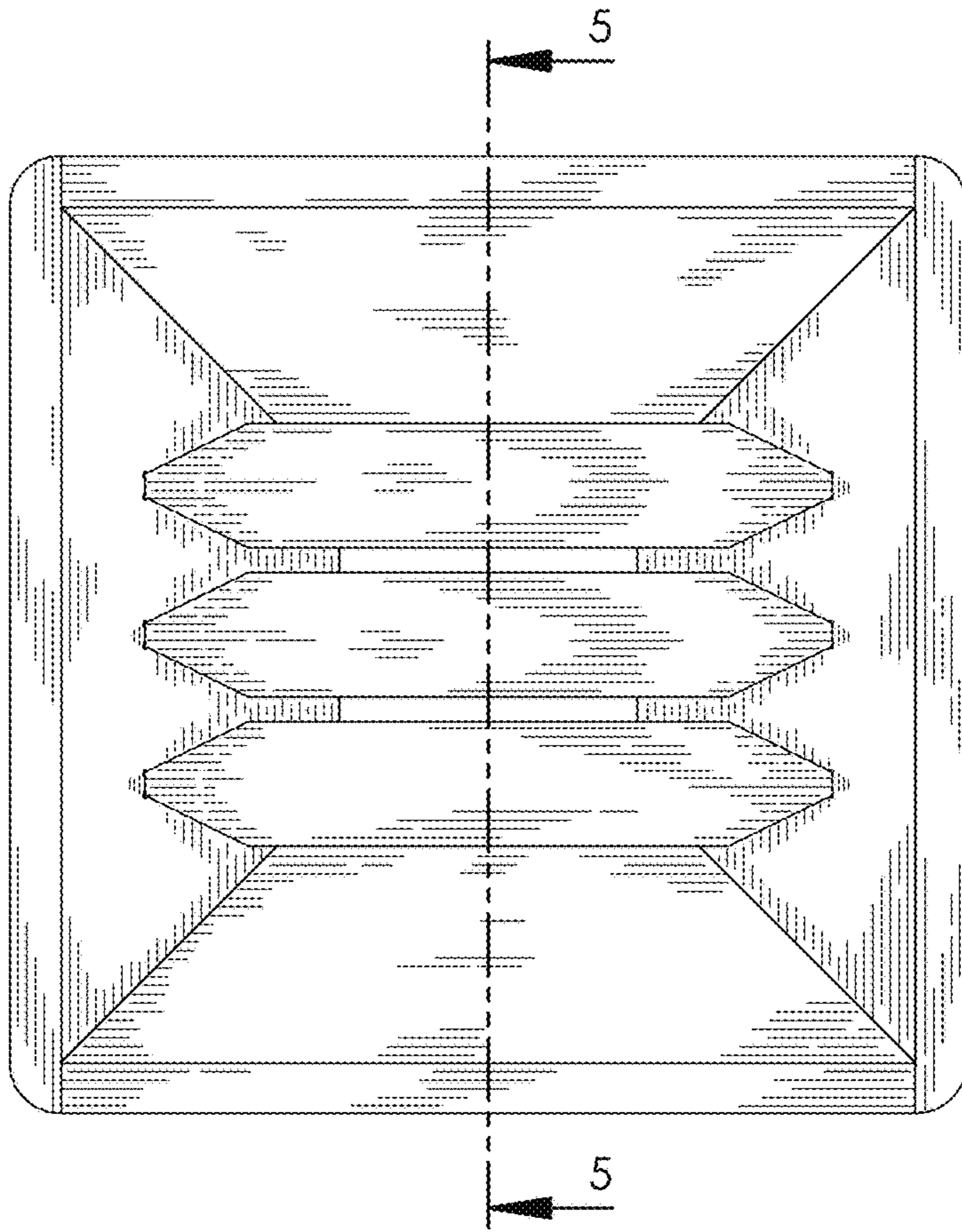

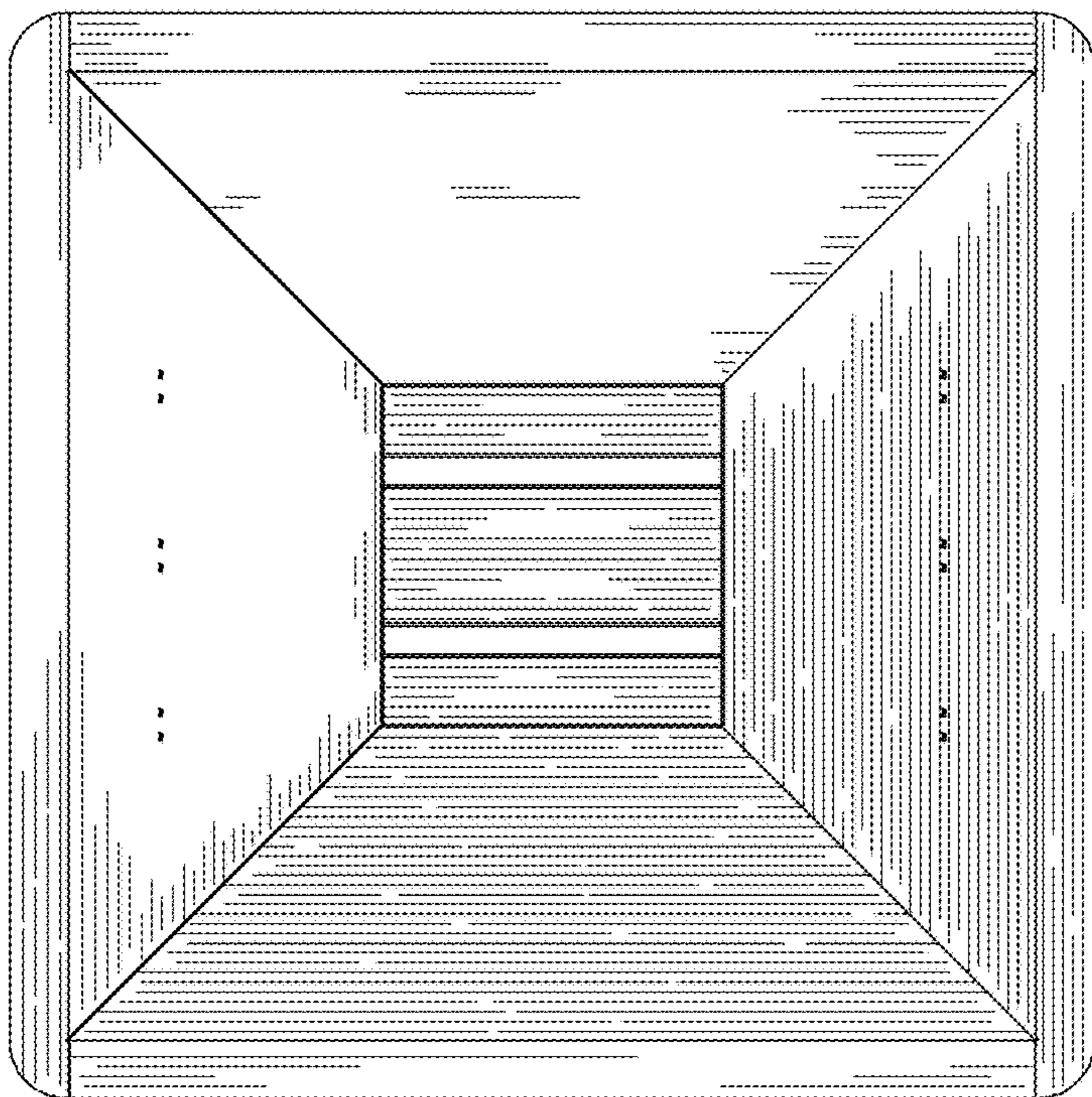

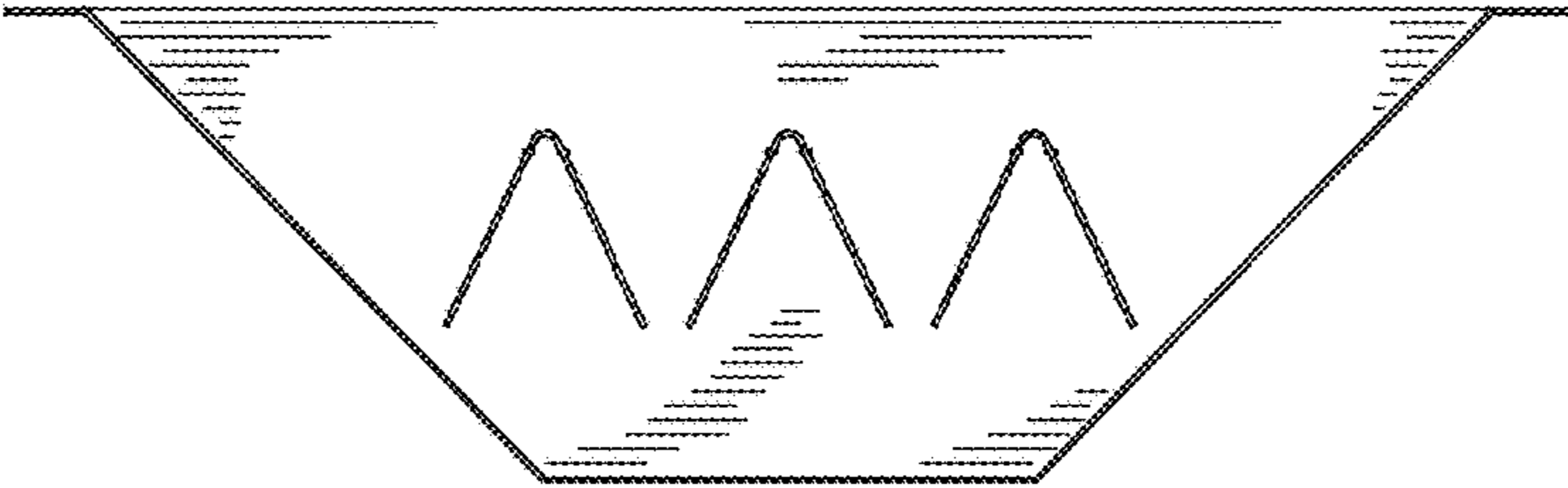

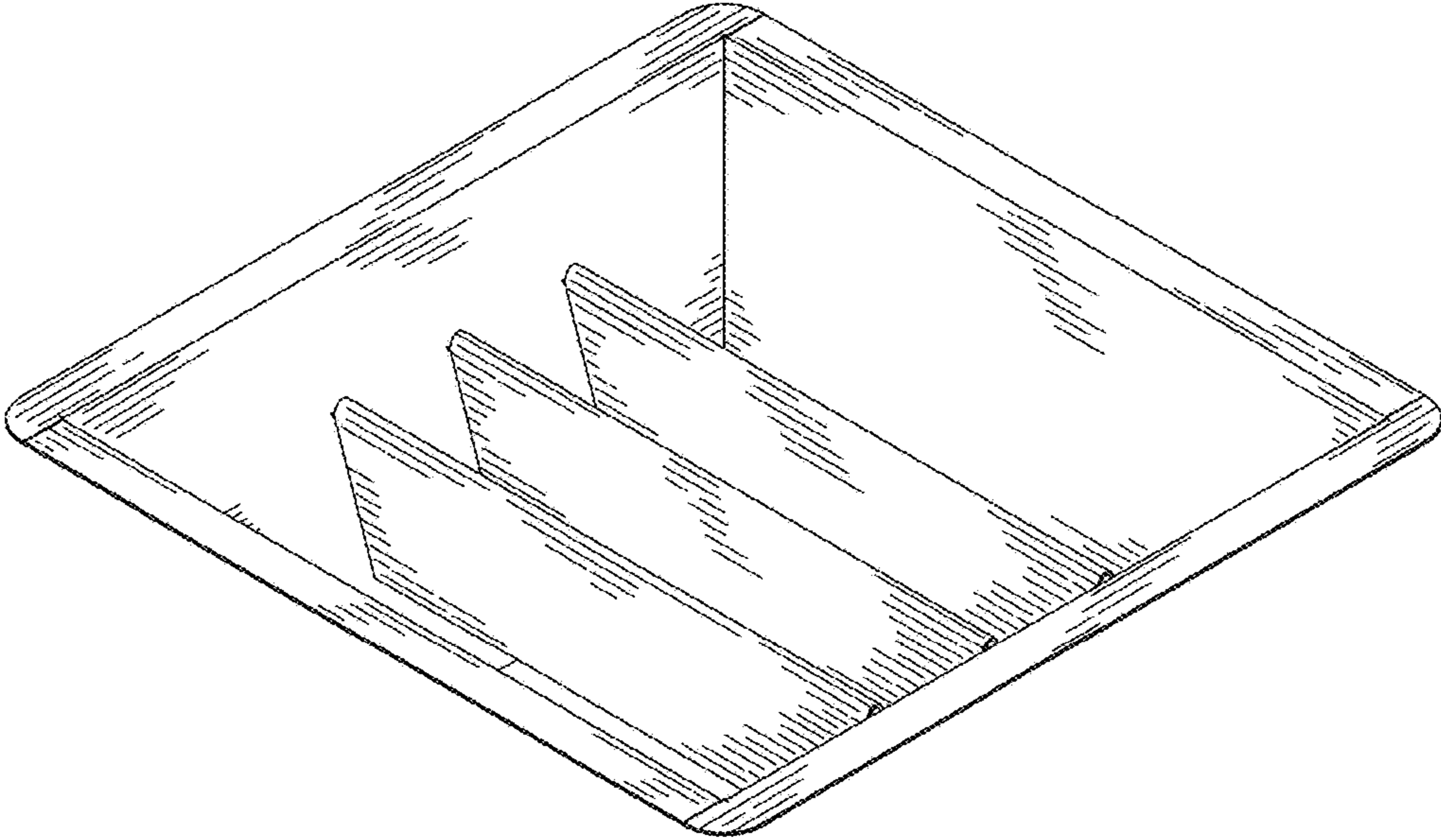

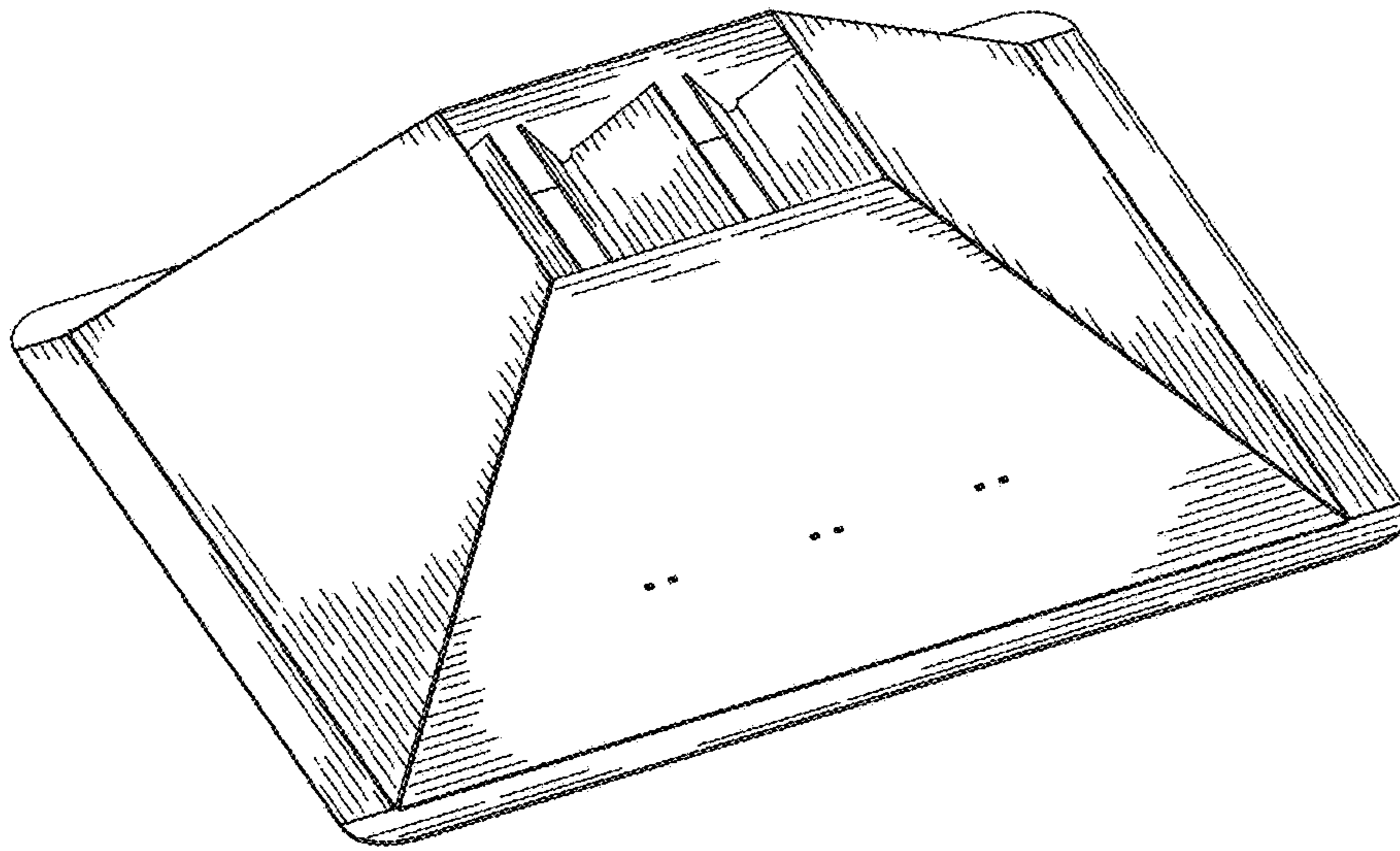

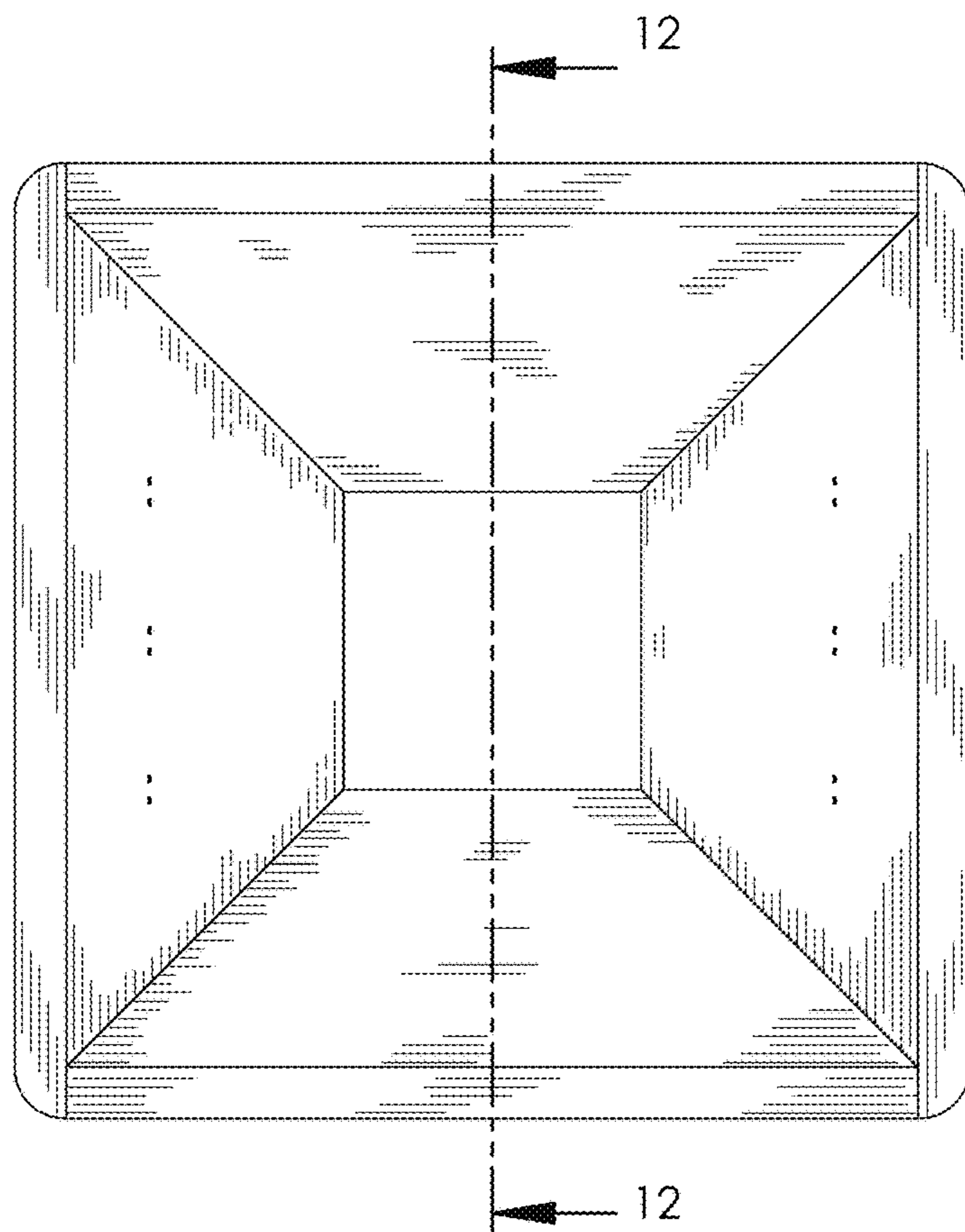

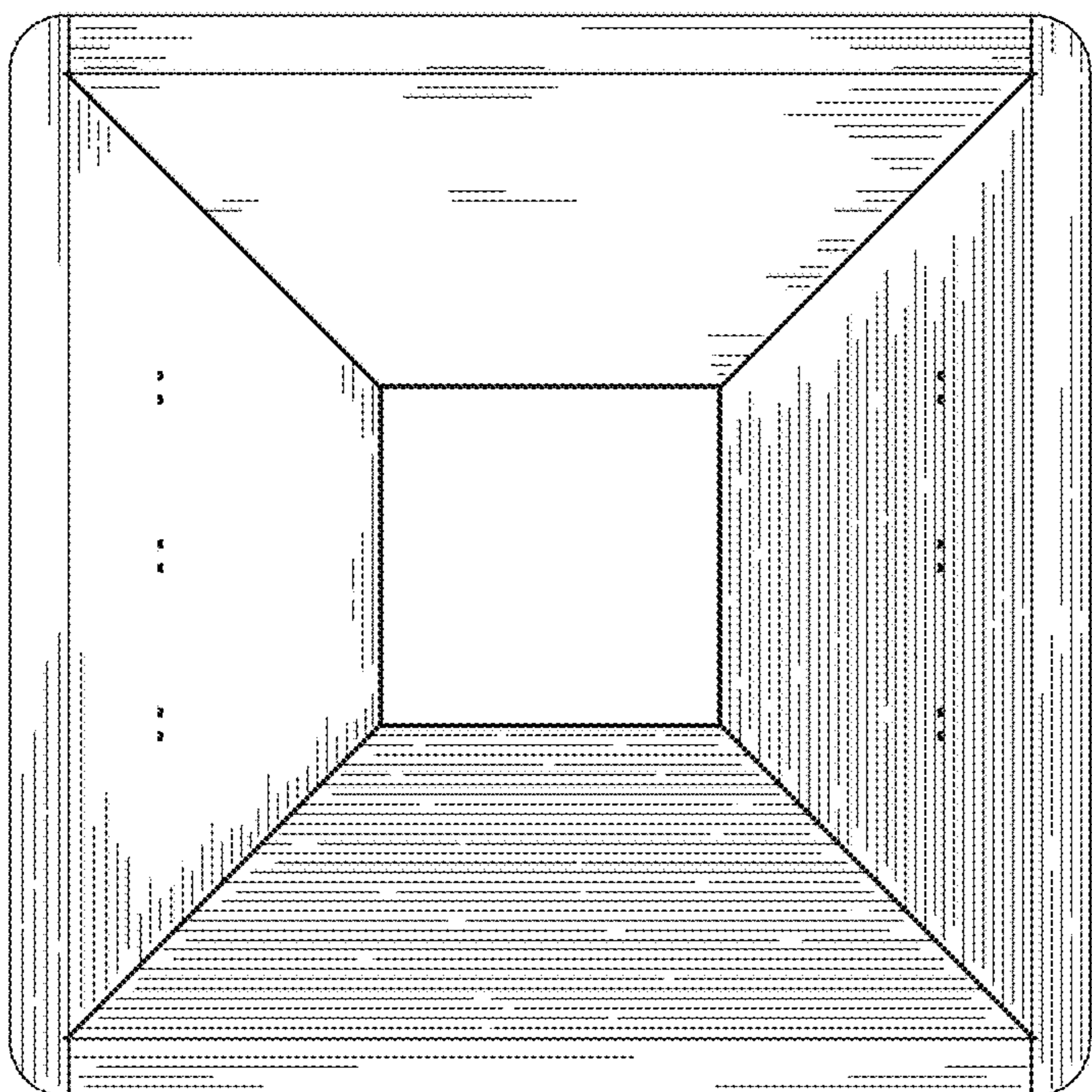

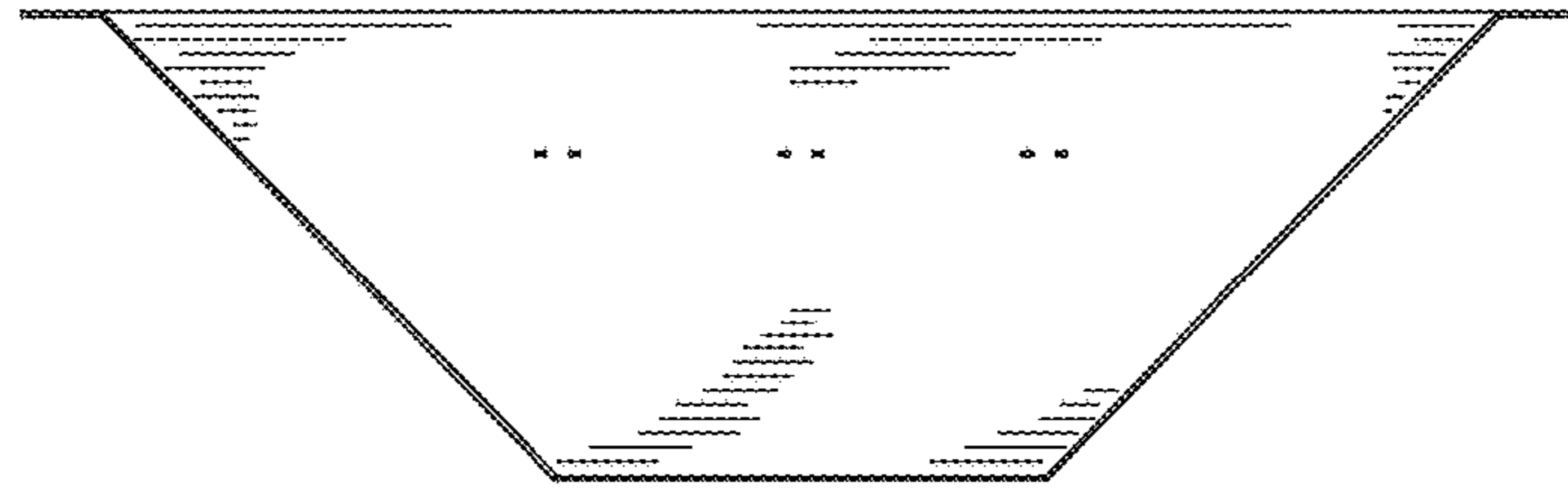

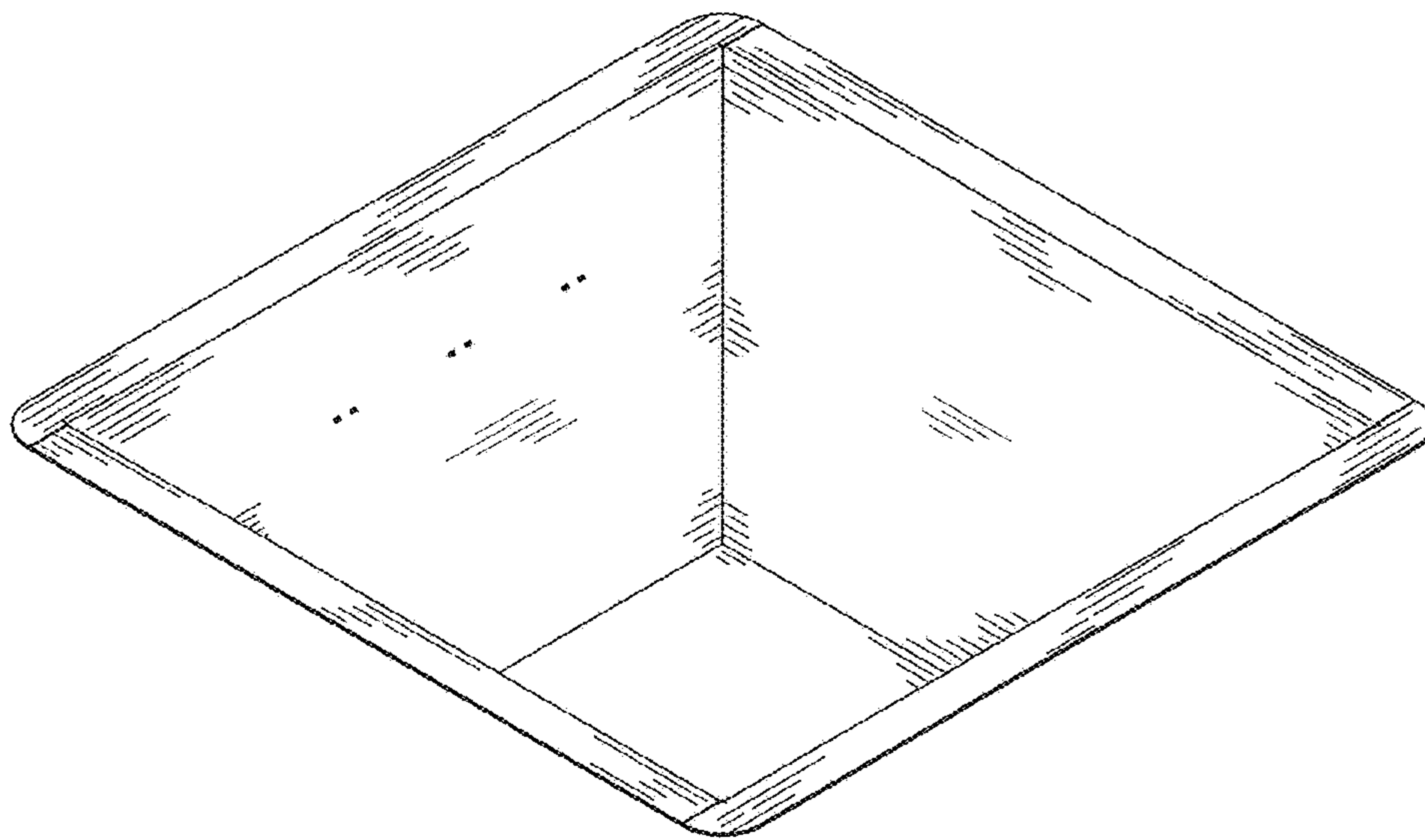

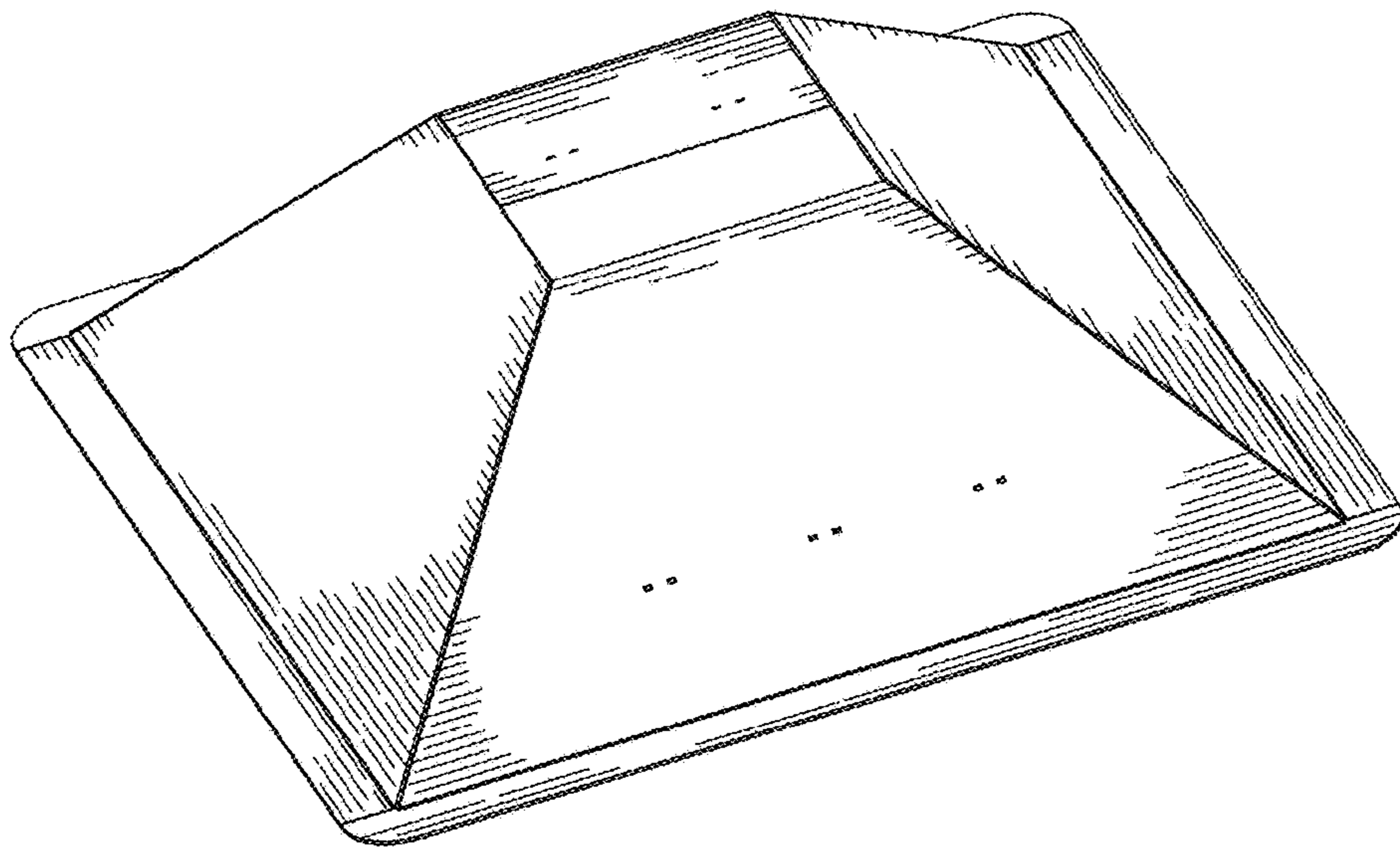
