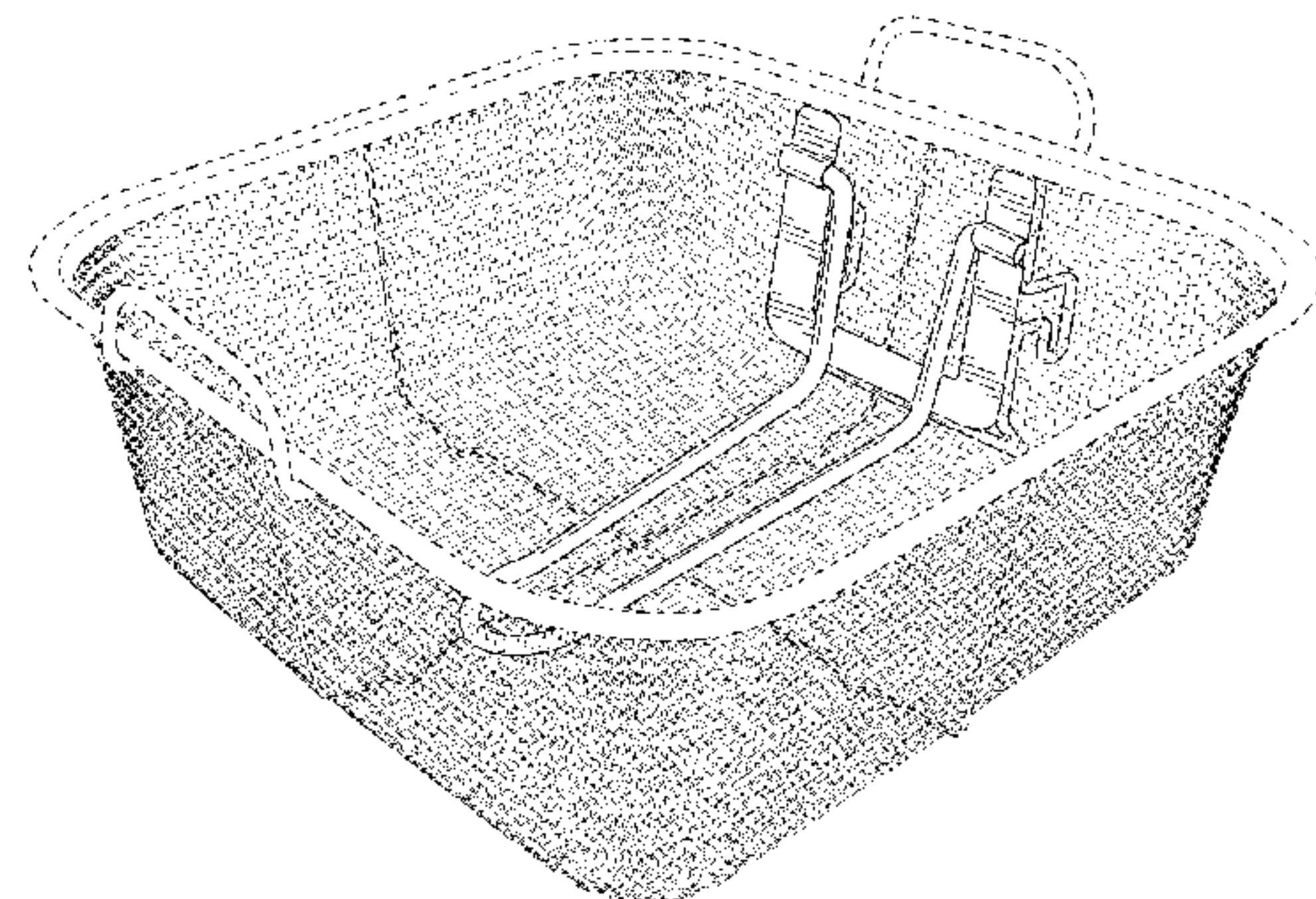
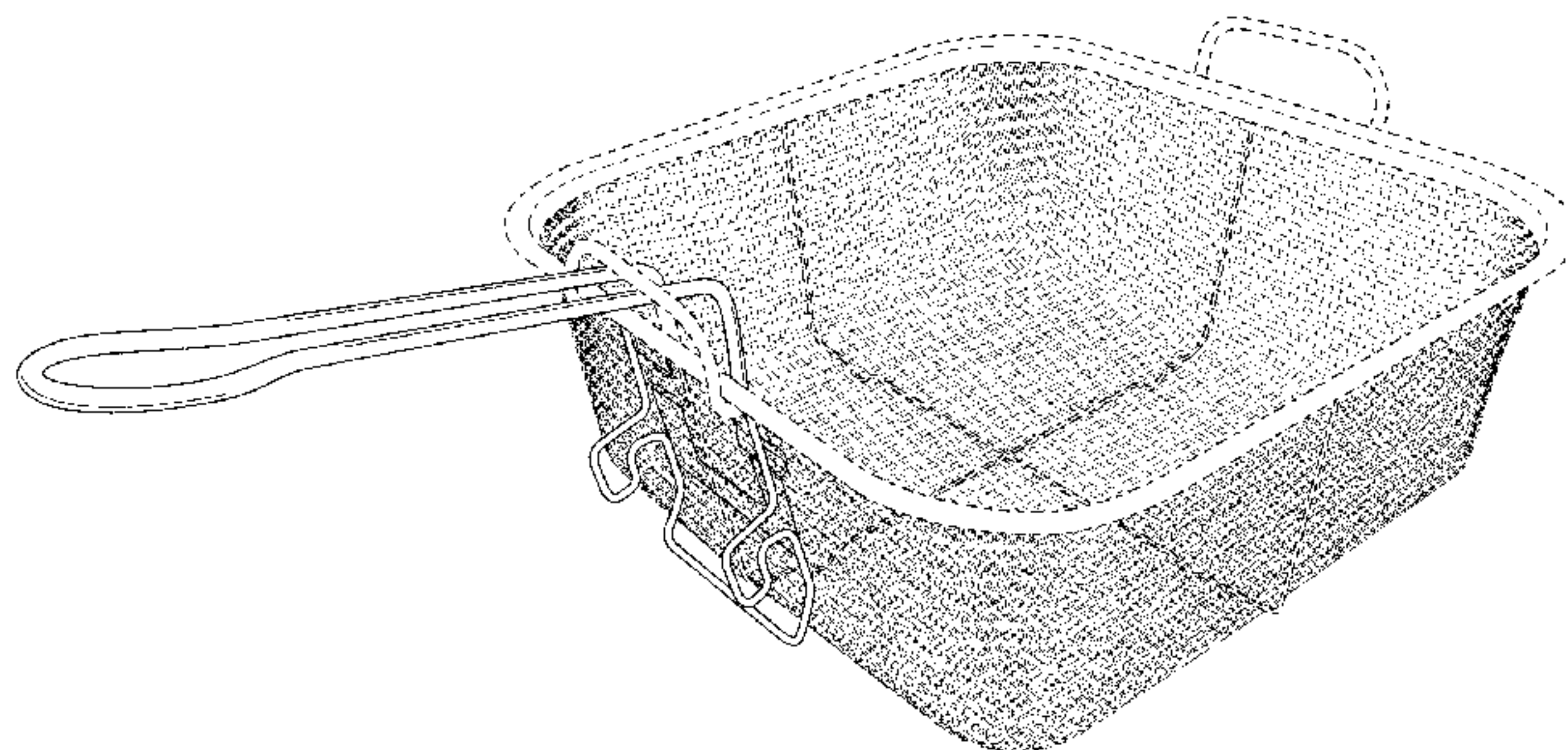
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, rear, right perspective view of a fry basket showing my design therefor;
FIG. 2 is a top, front, left perspective view with the handle in the folded position;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof;

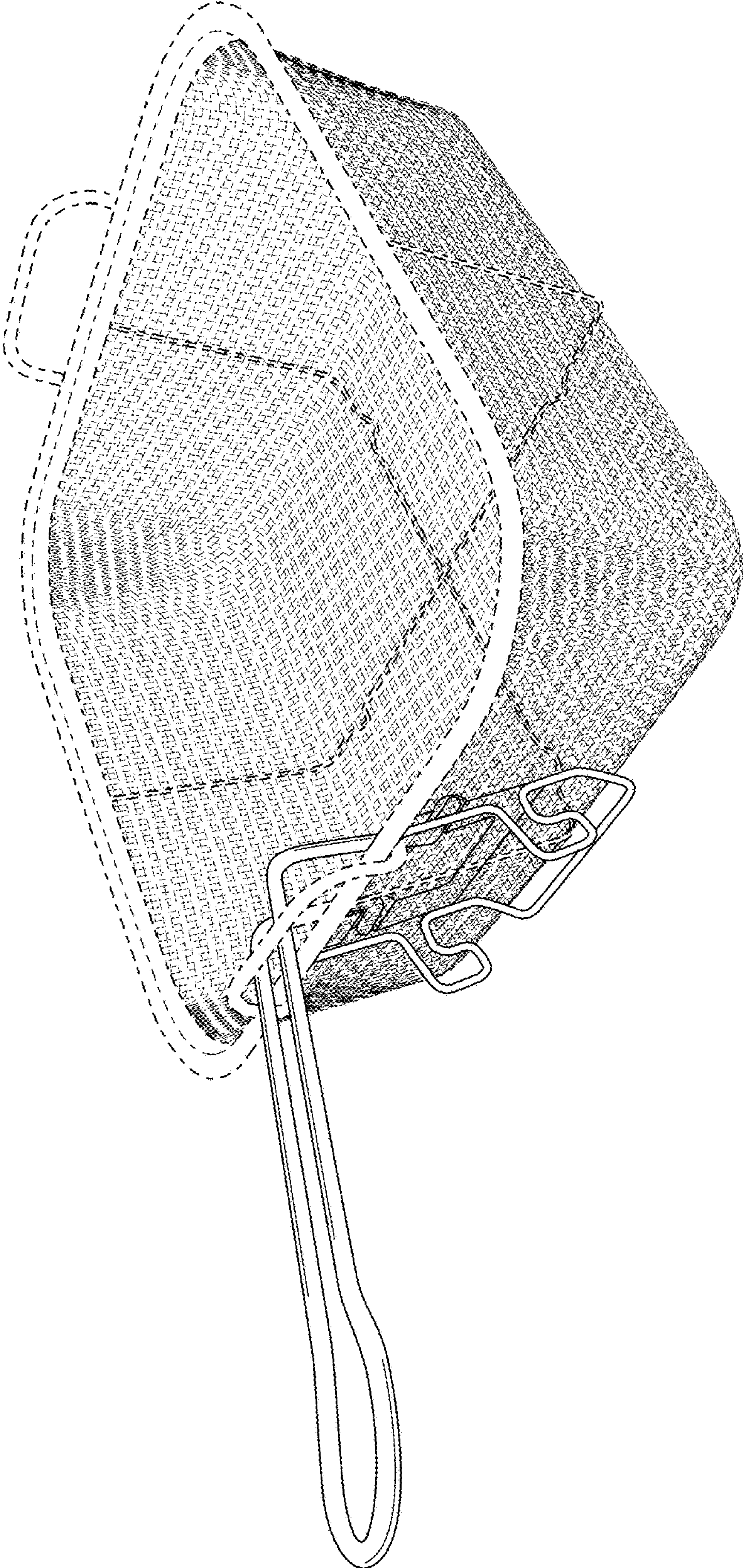

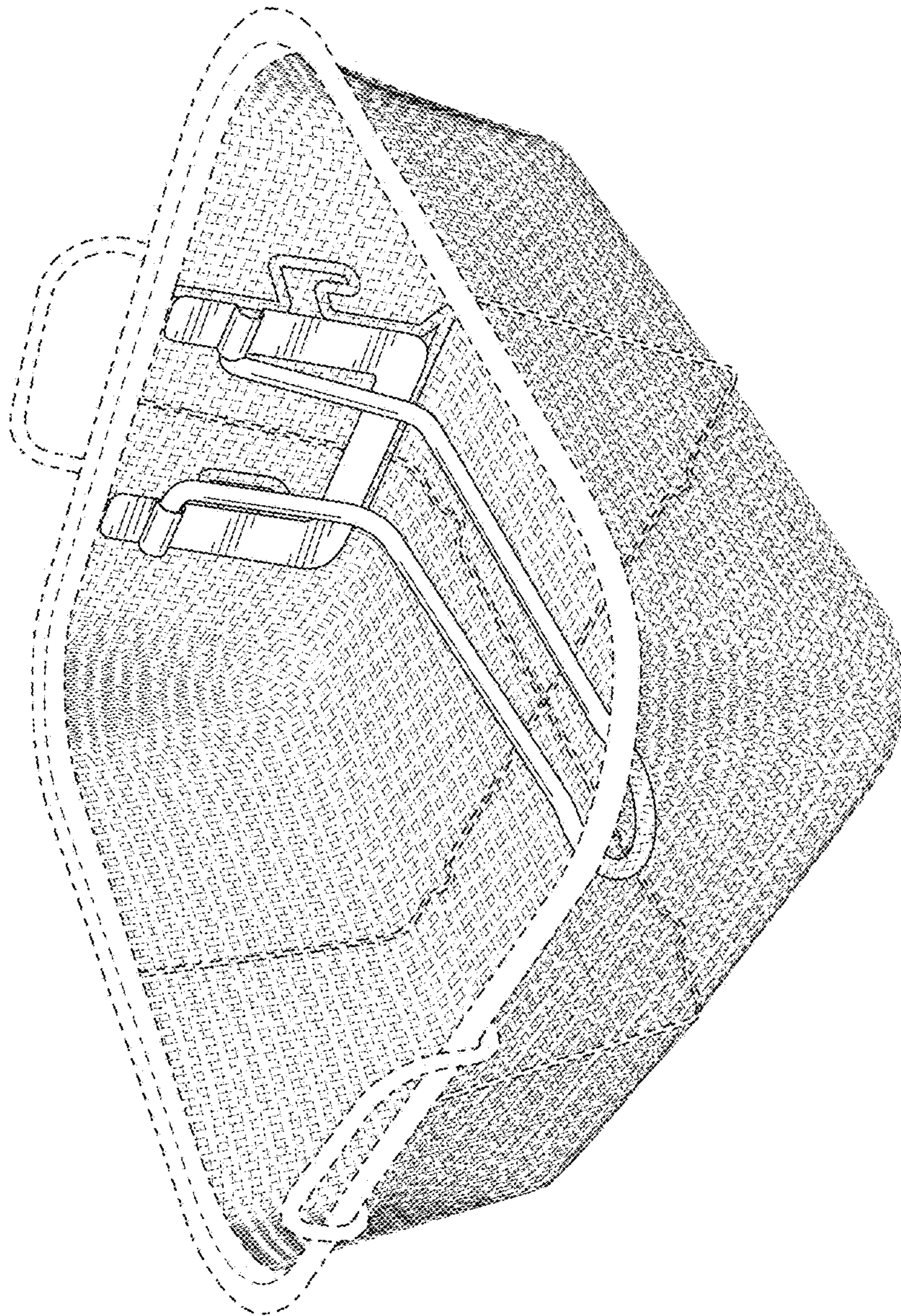

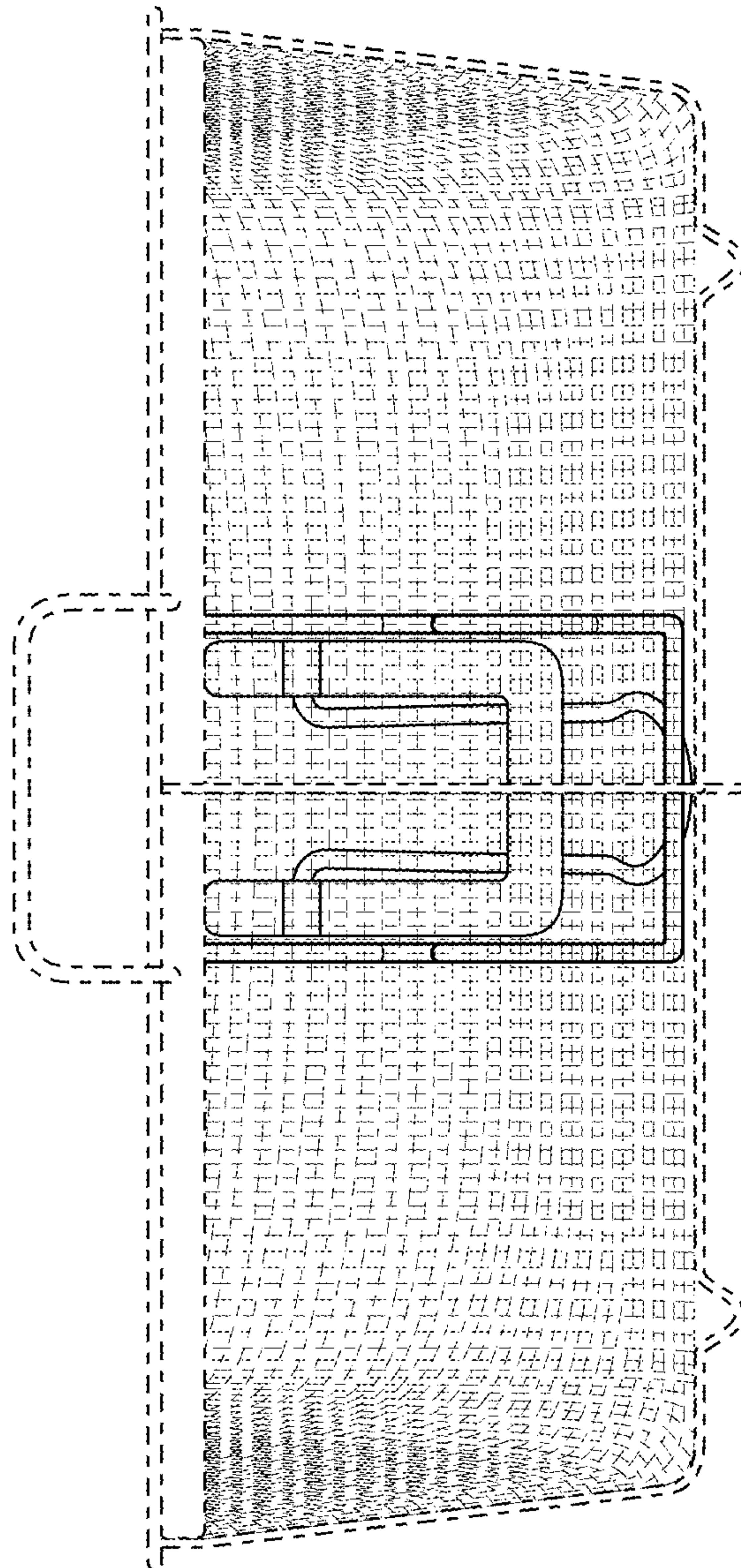

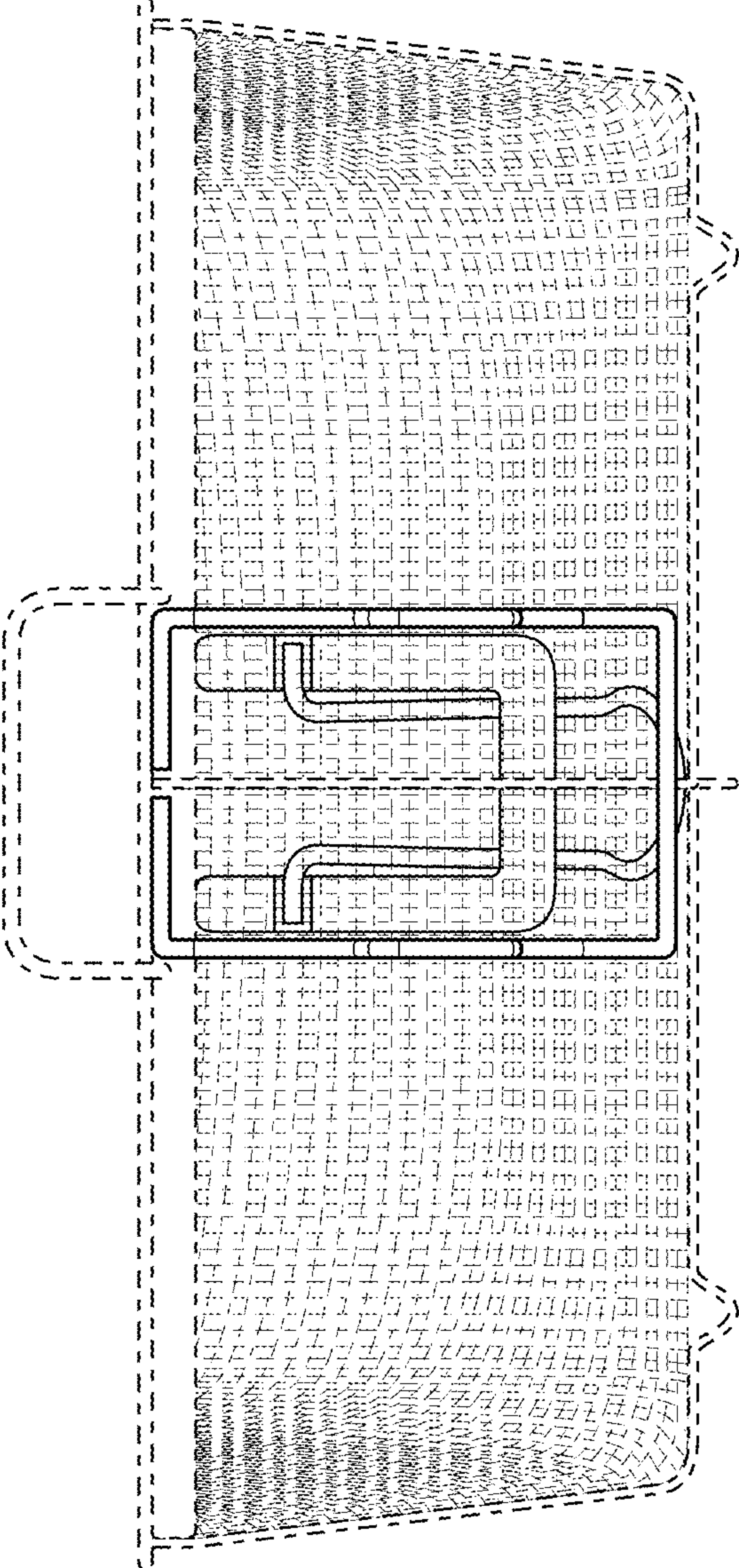

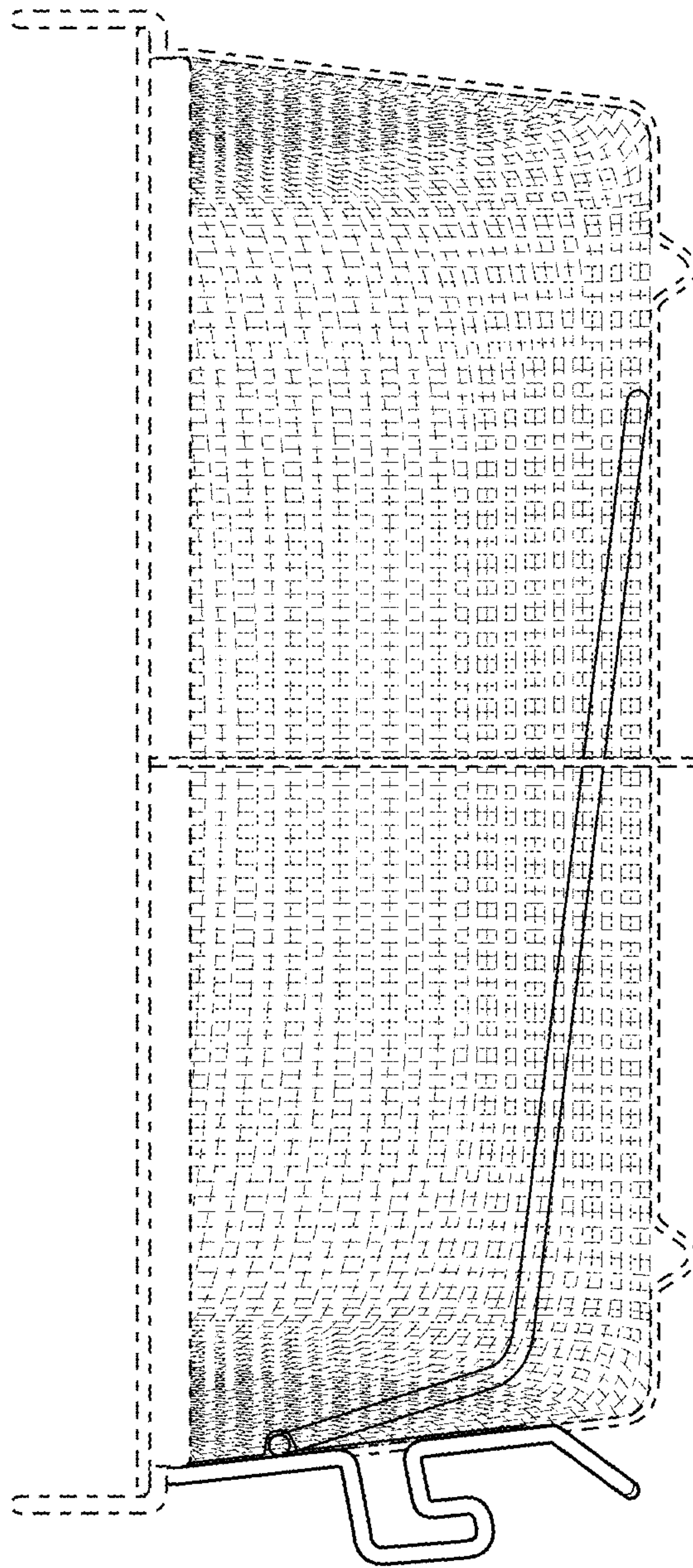

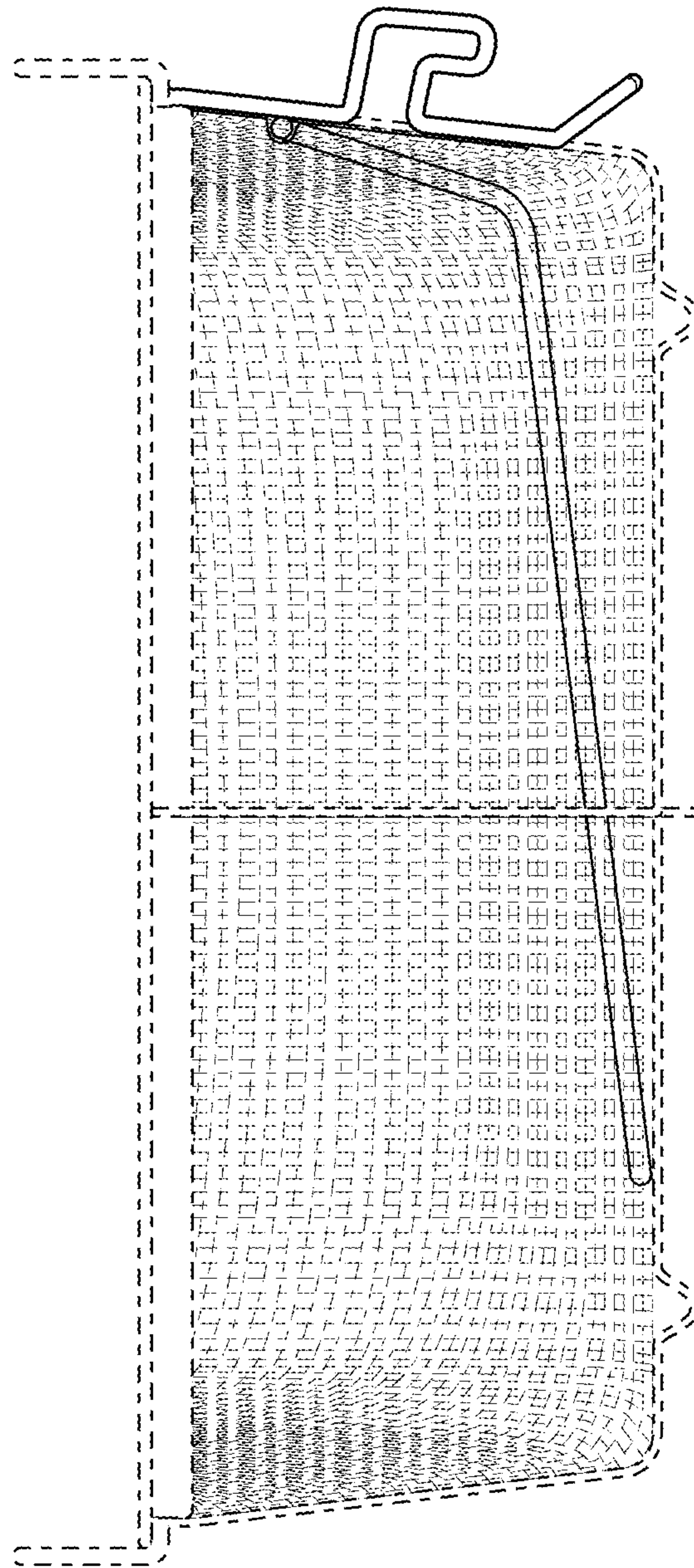

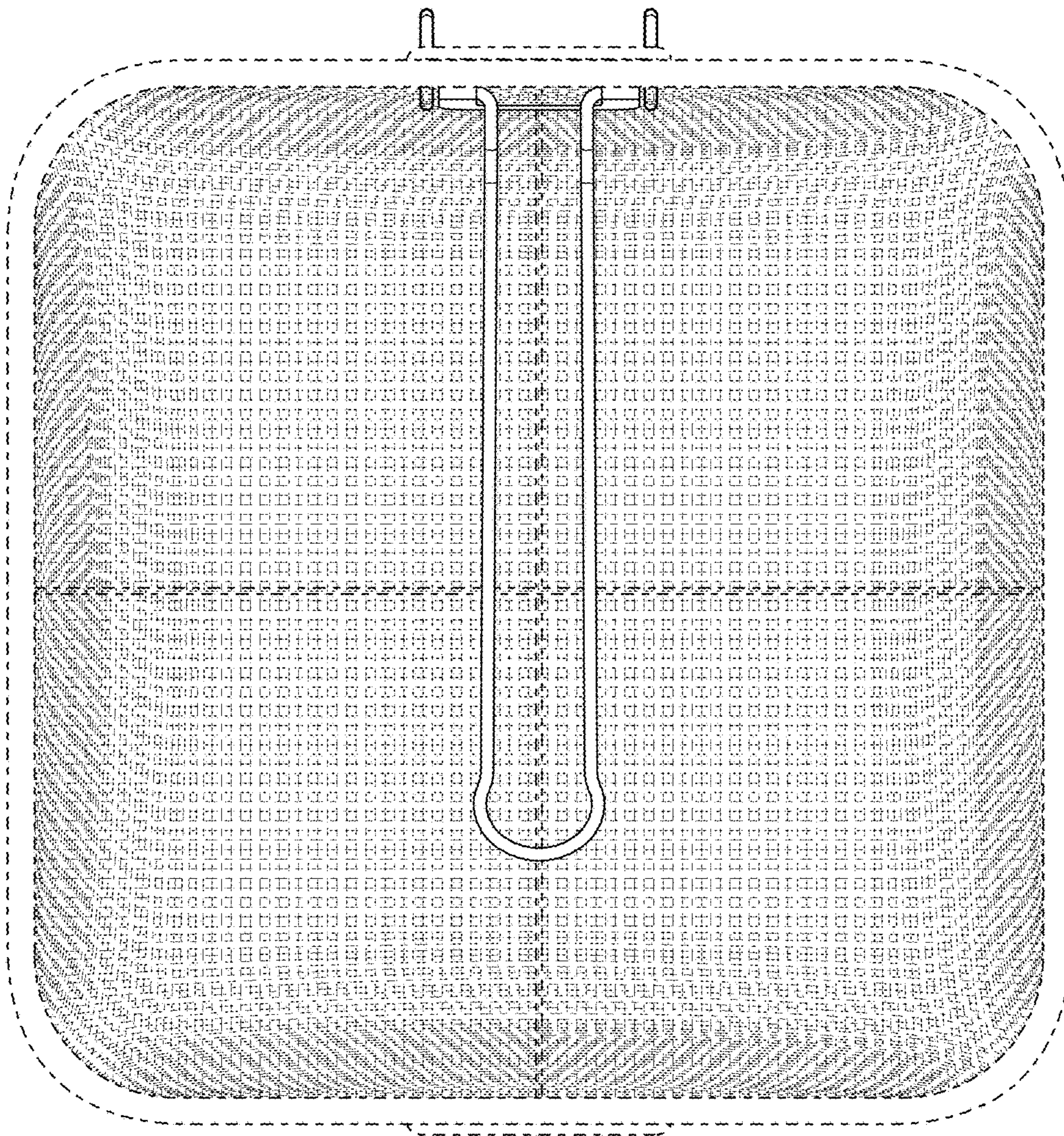

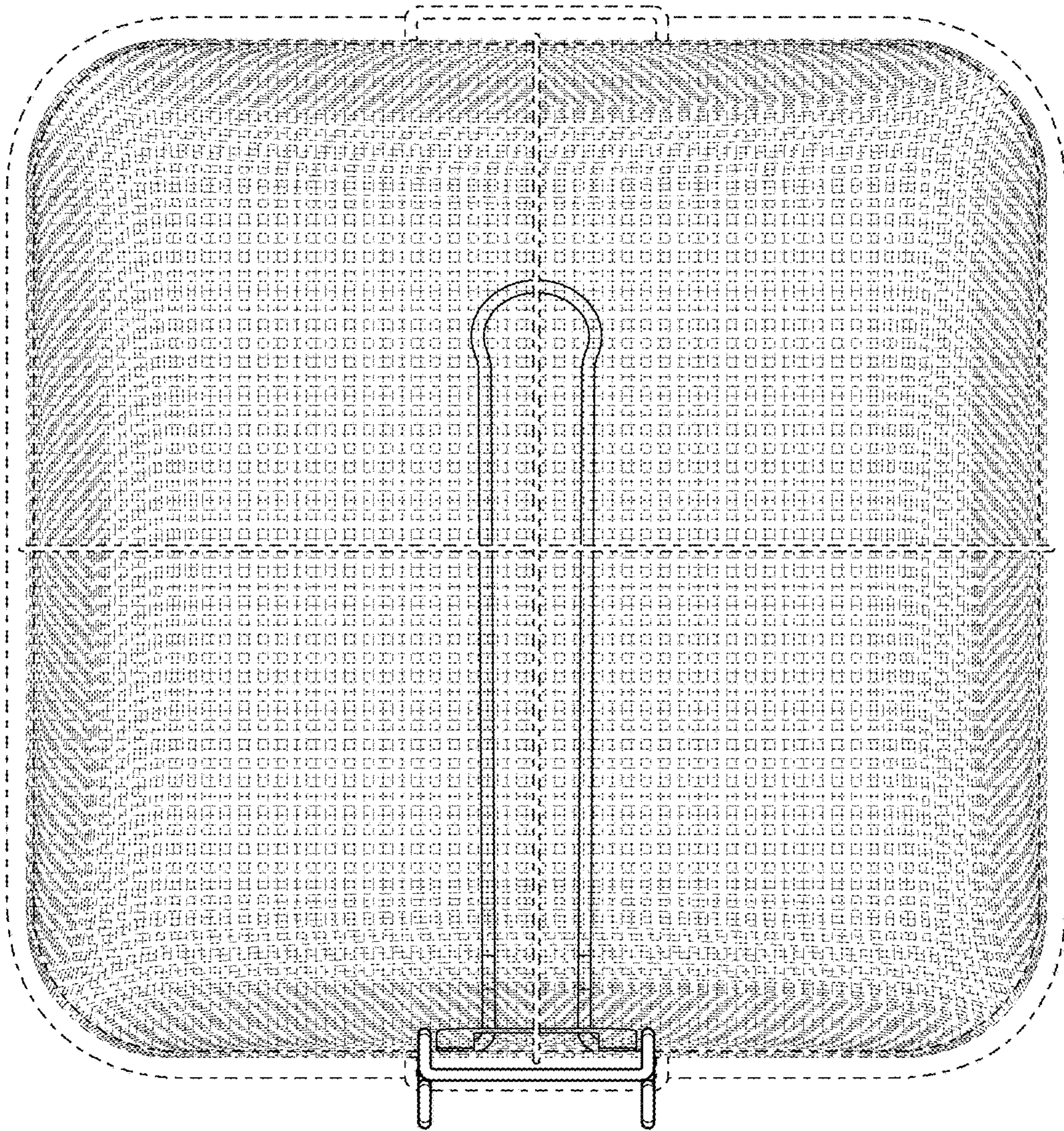
