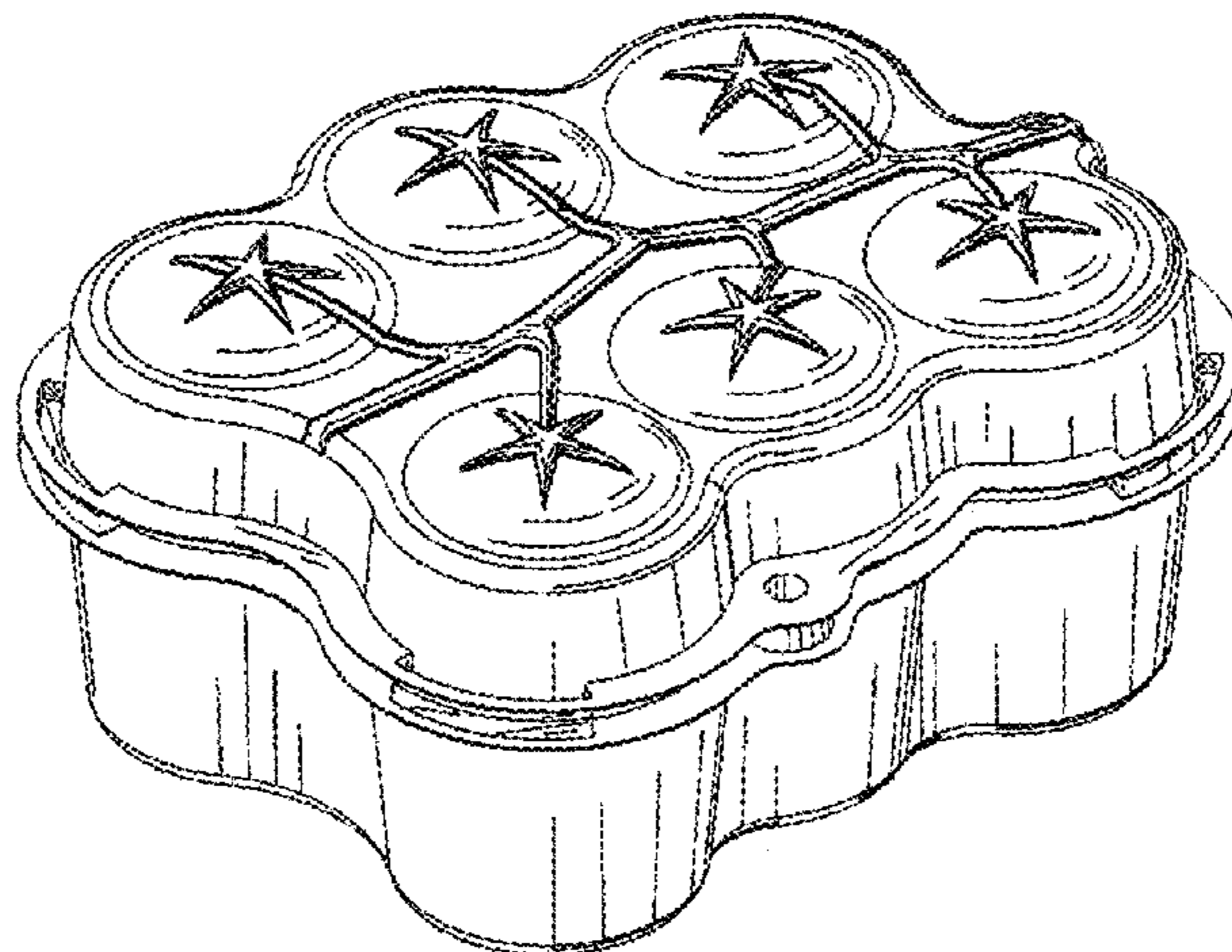
(57) **CLAIM**

The ornamental design for a cherry tomatoes-shaped container, as shown and described.

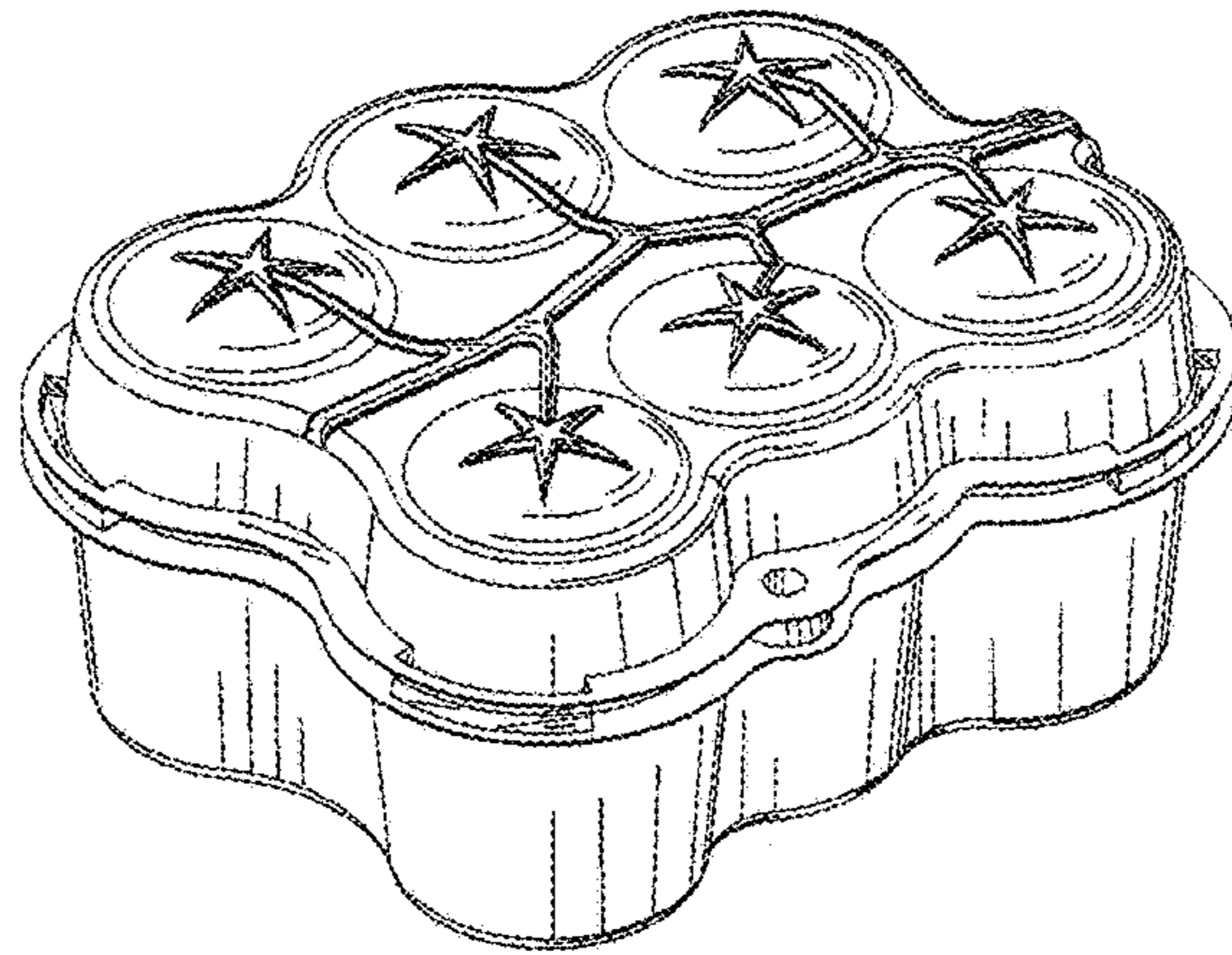
**DESCRIPTION**

FIG. 1 is an isometric view of a cherry tomatoes-shaped container of the applicant's design;

The broken lines in FIG. 4 are included for the purpose of illustrating a portion of the bottom that forms no part of the claimed design.

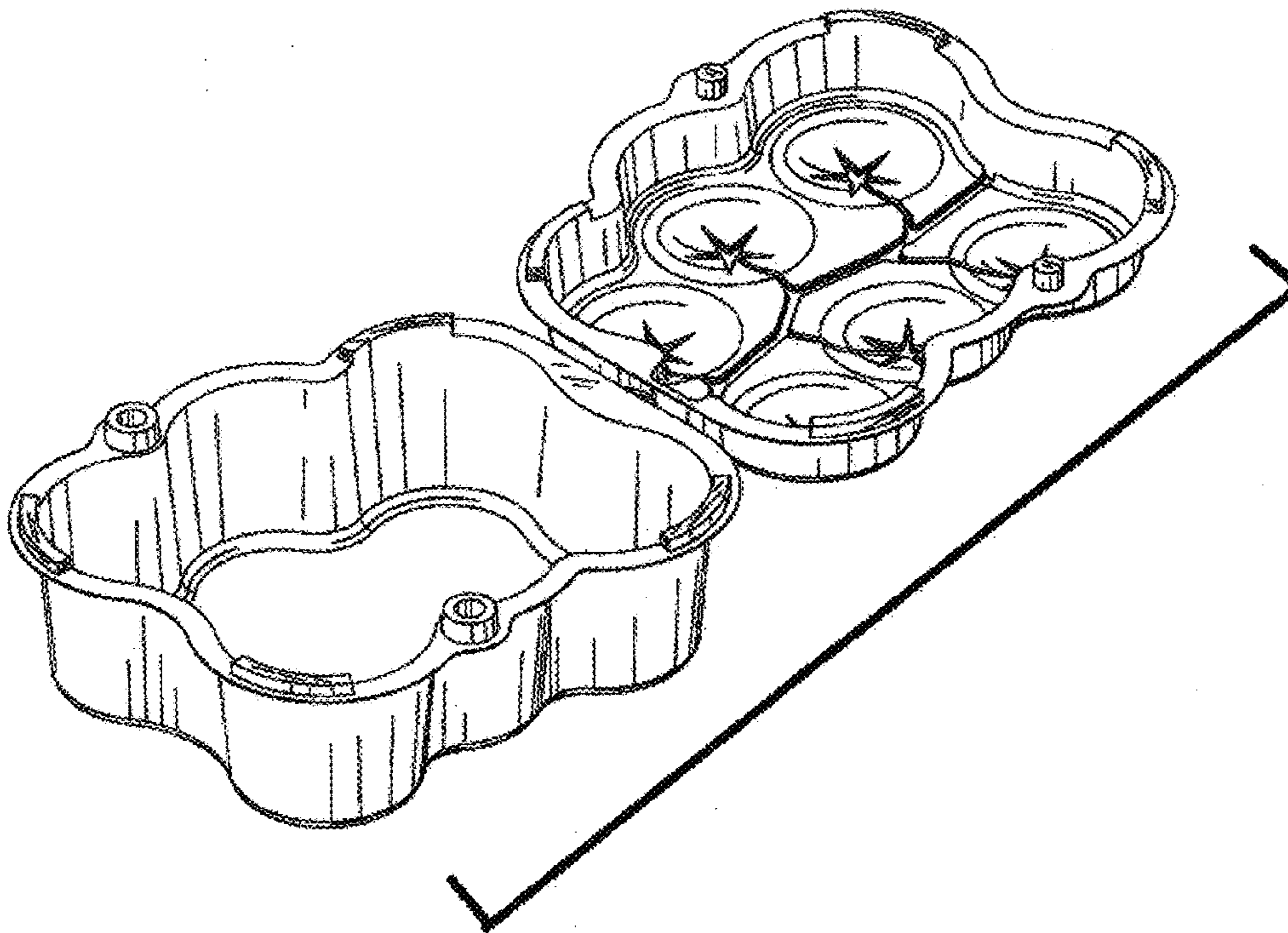

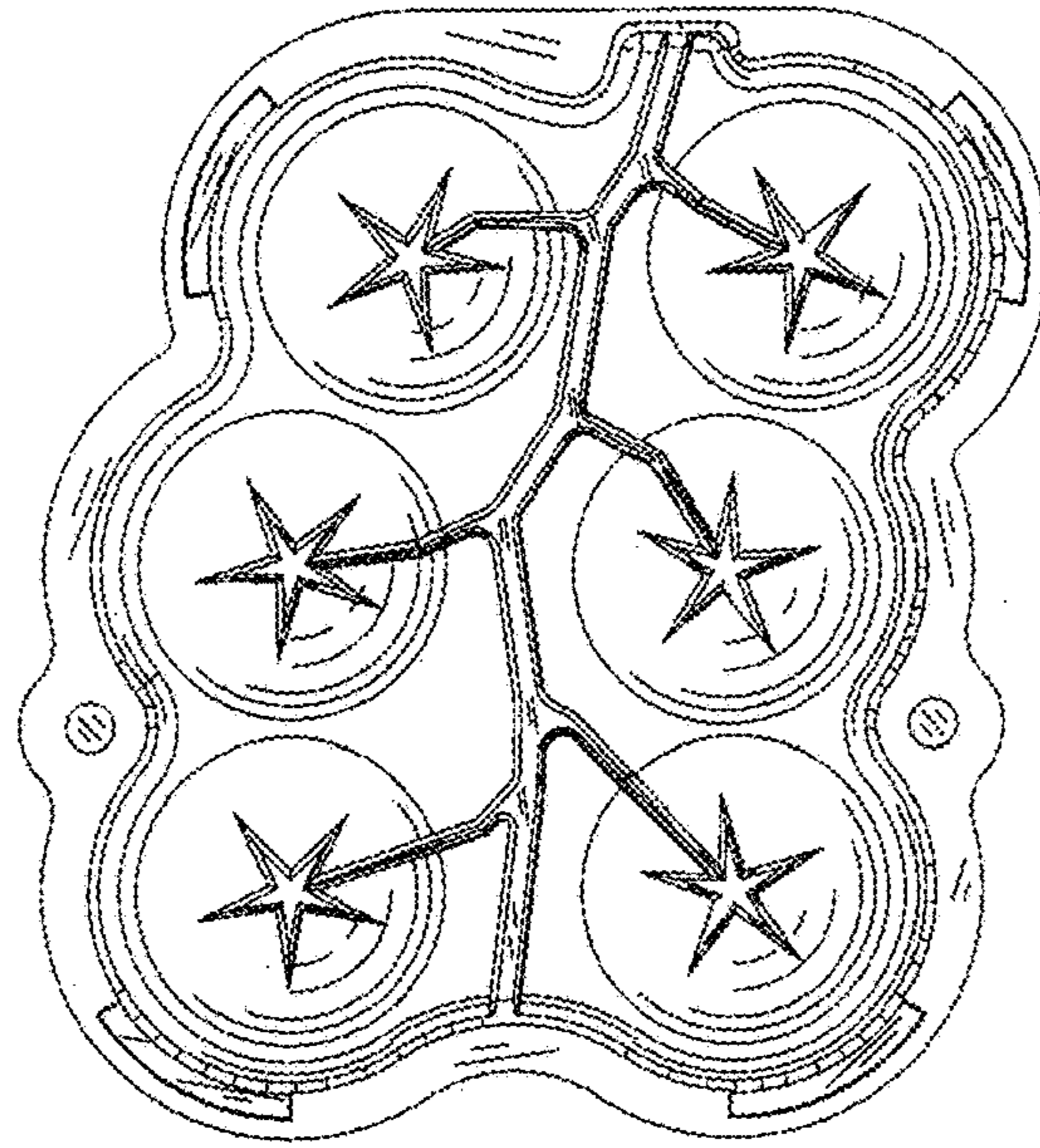

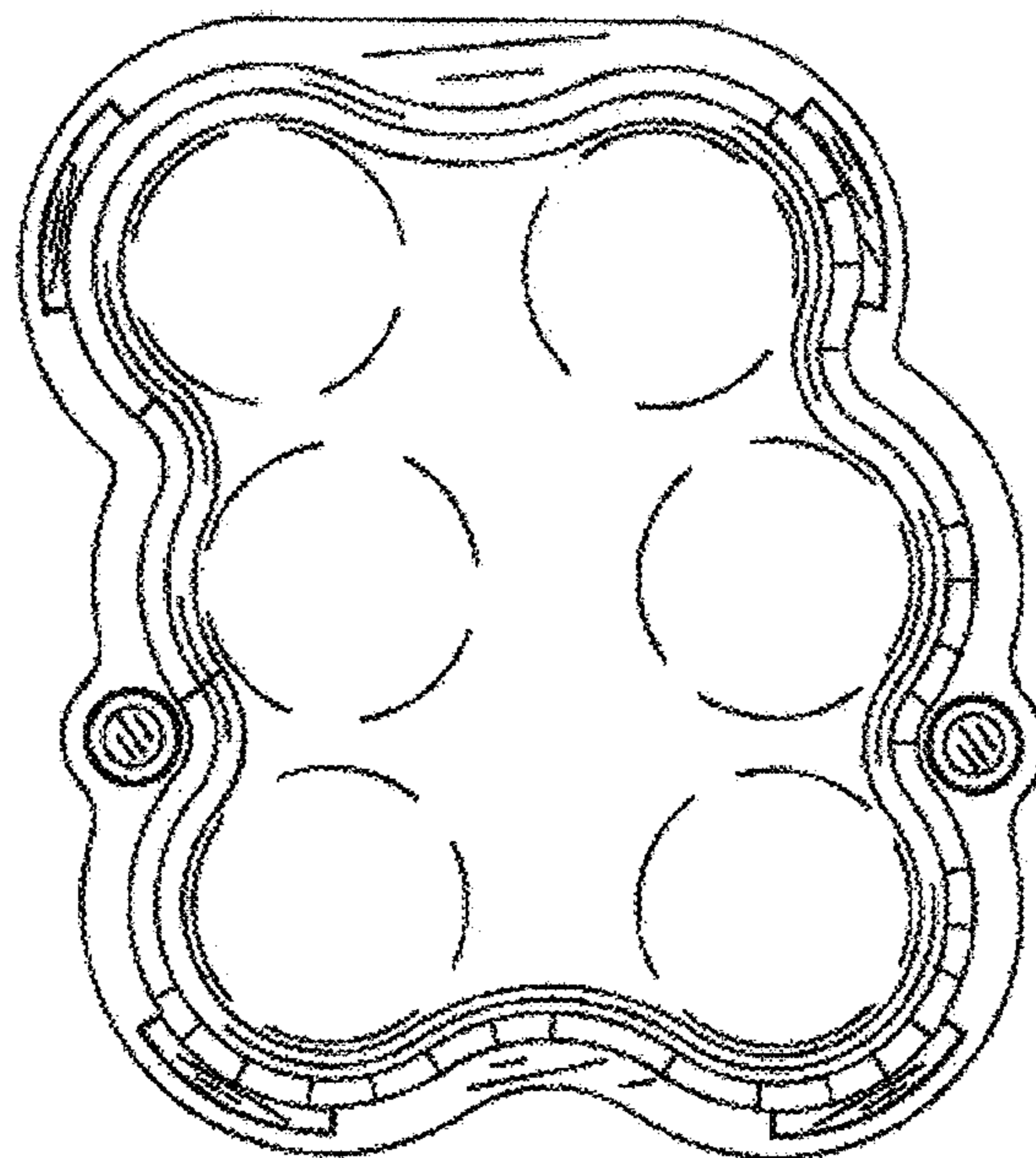

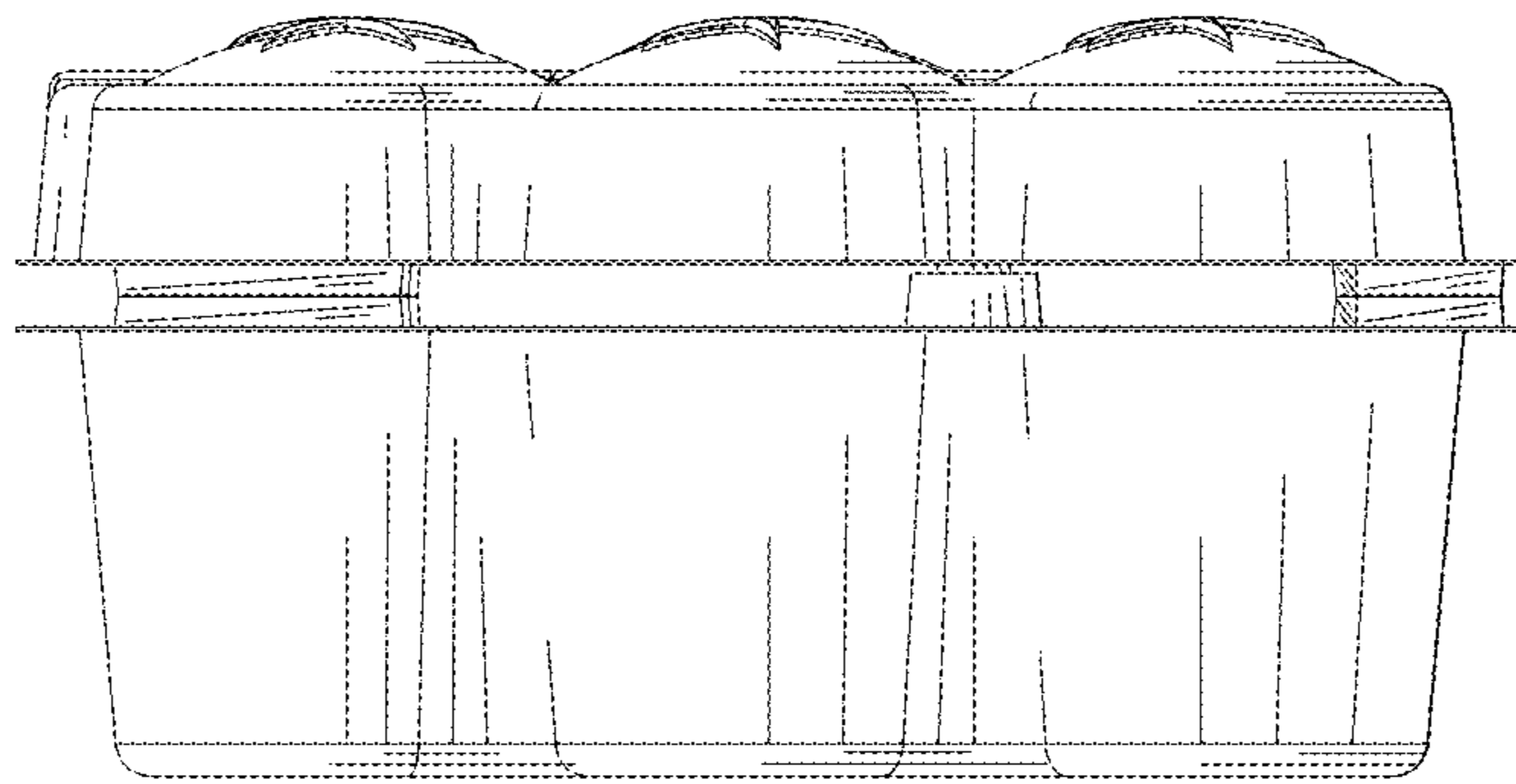

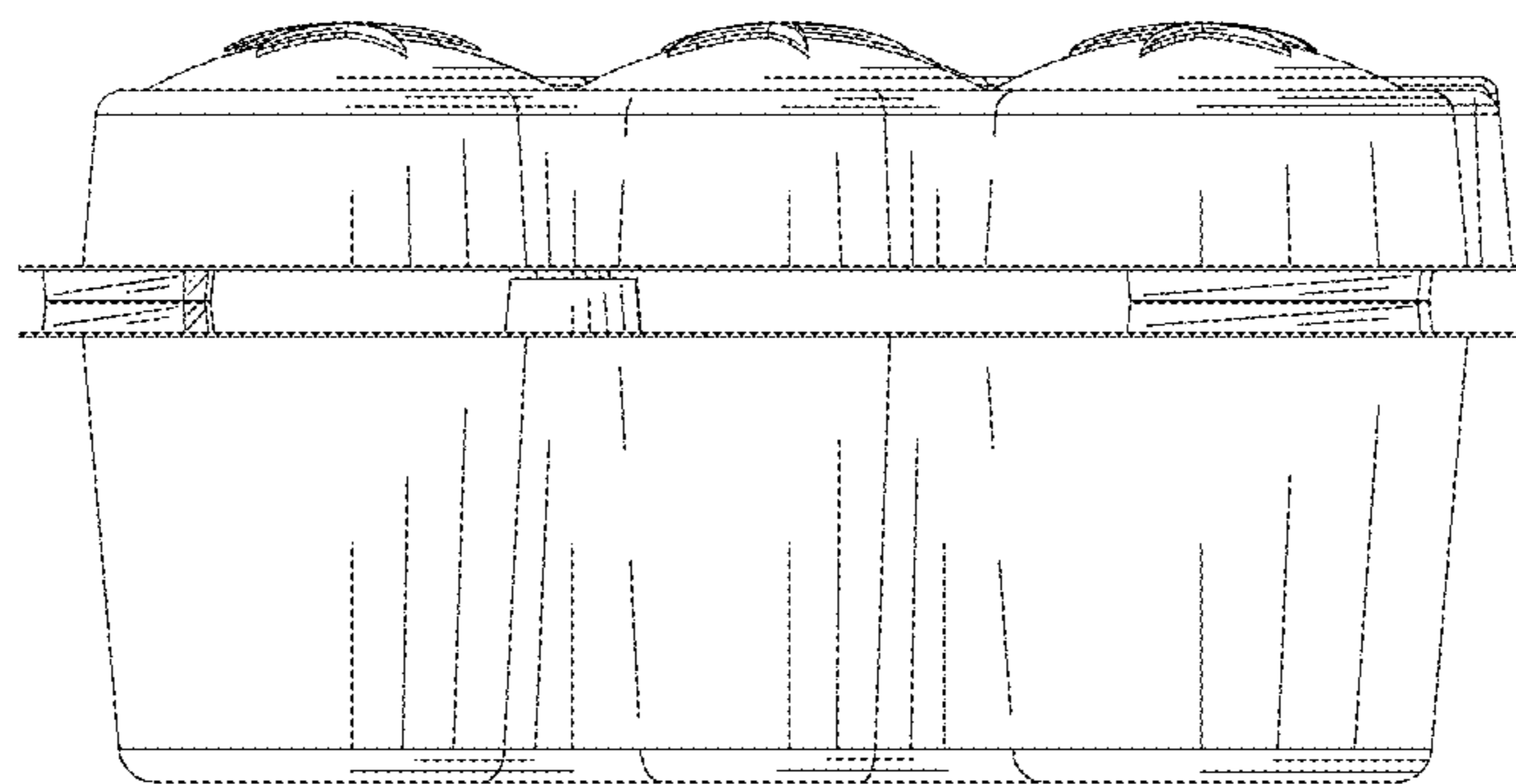

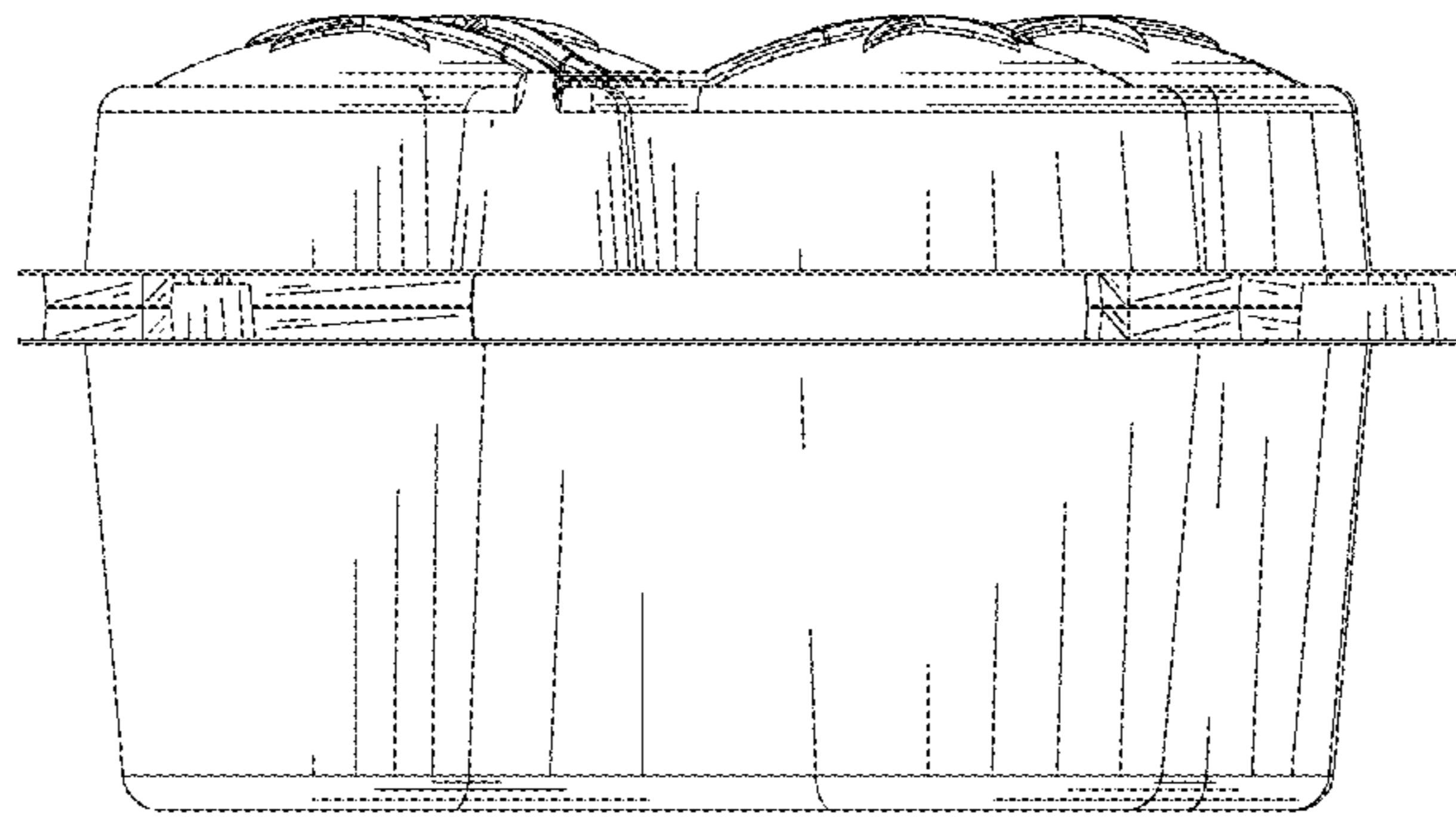
