DESCRIPTION

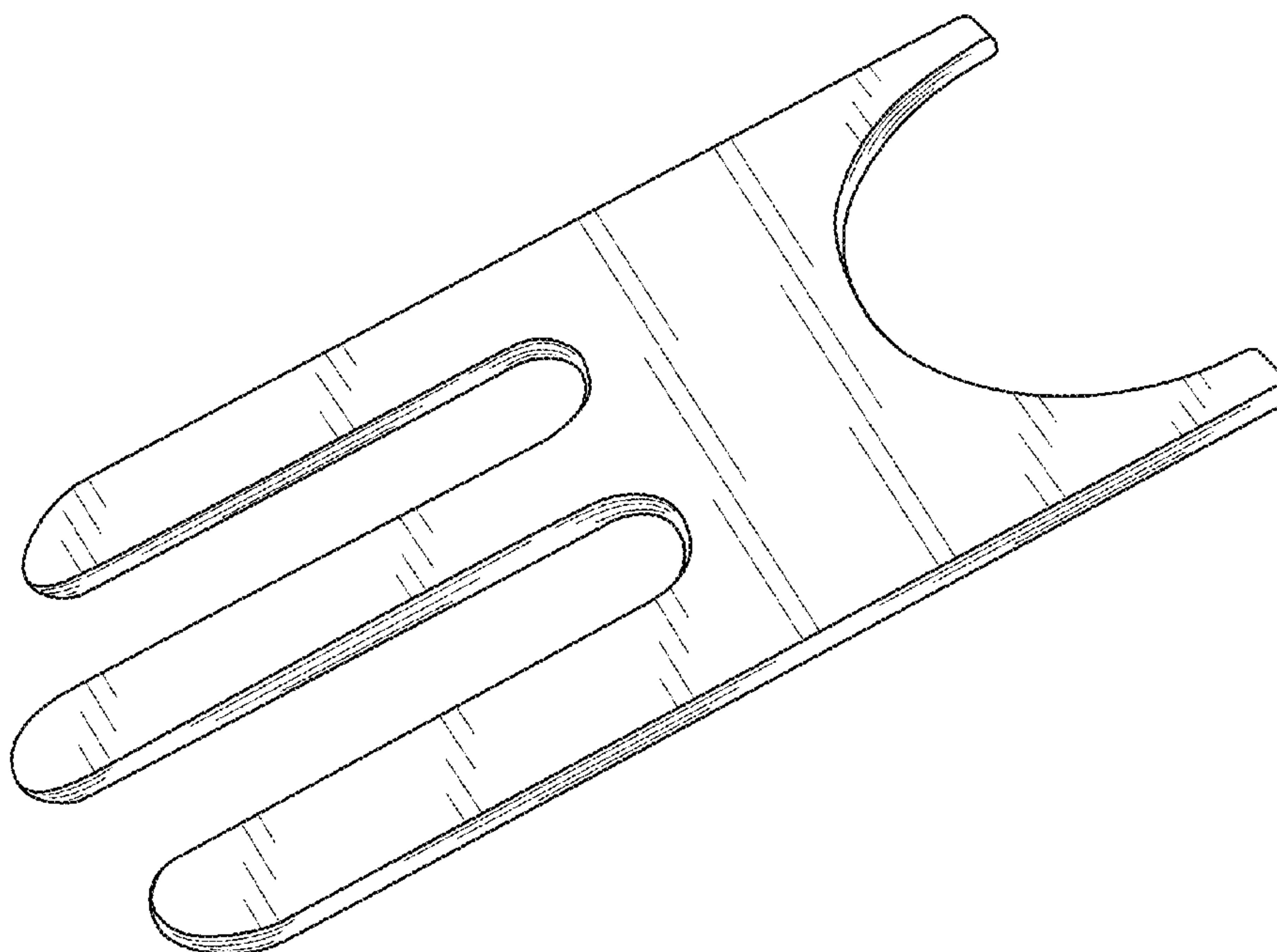
FIG. 1 is a perspective top front left view of a golf tool, showing my new design;

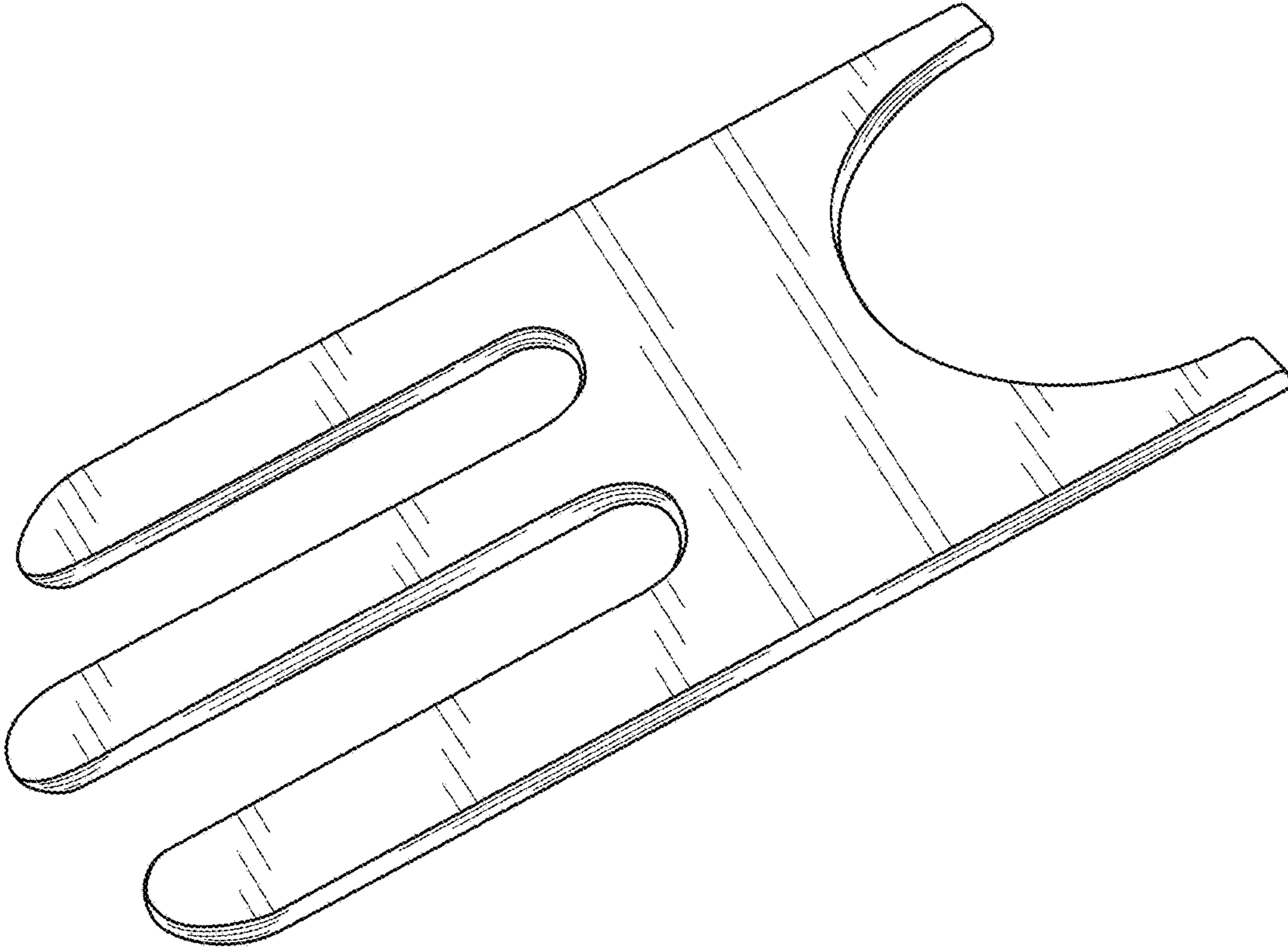

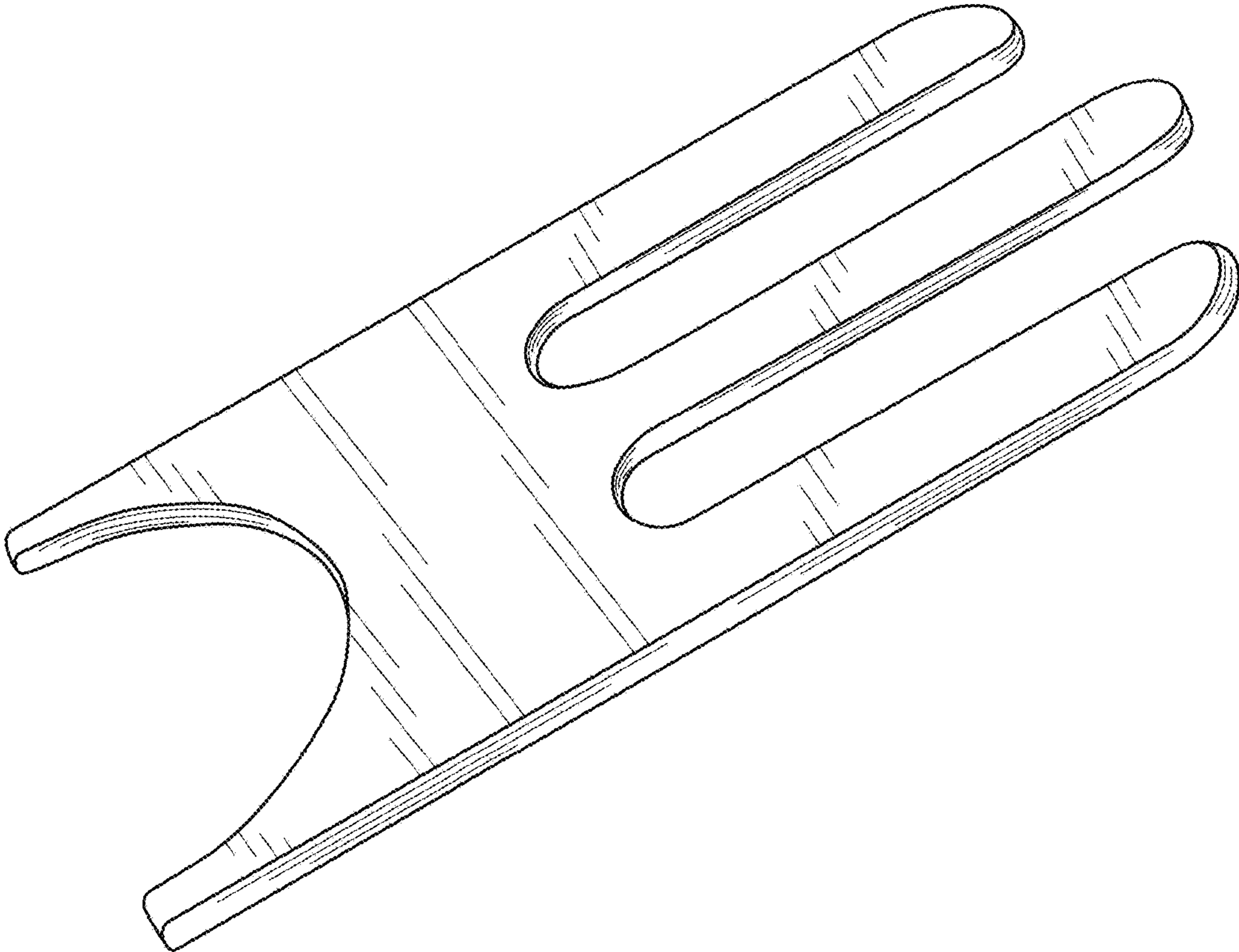

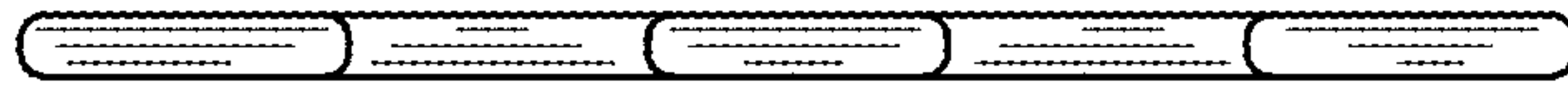

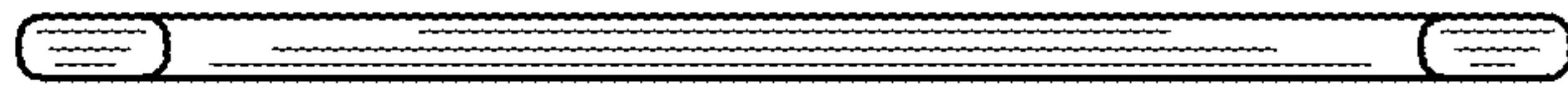

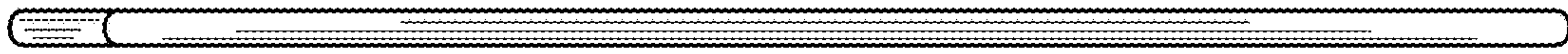

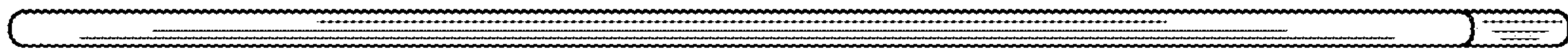

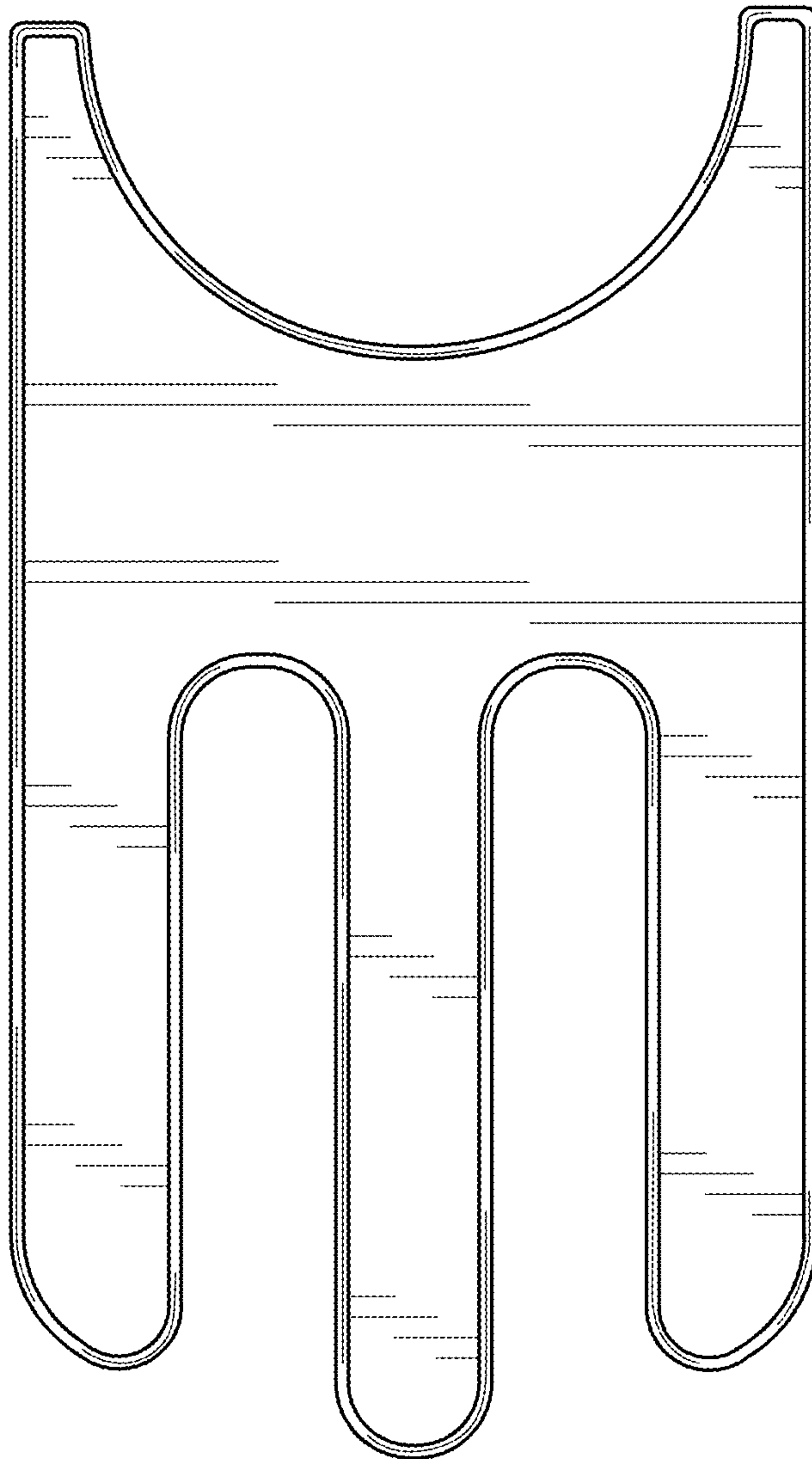

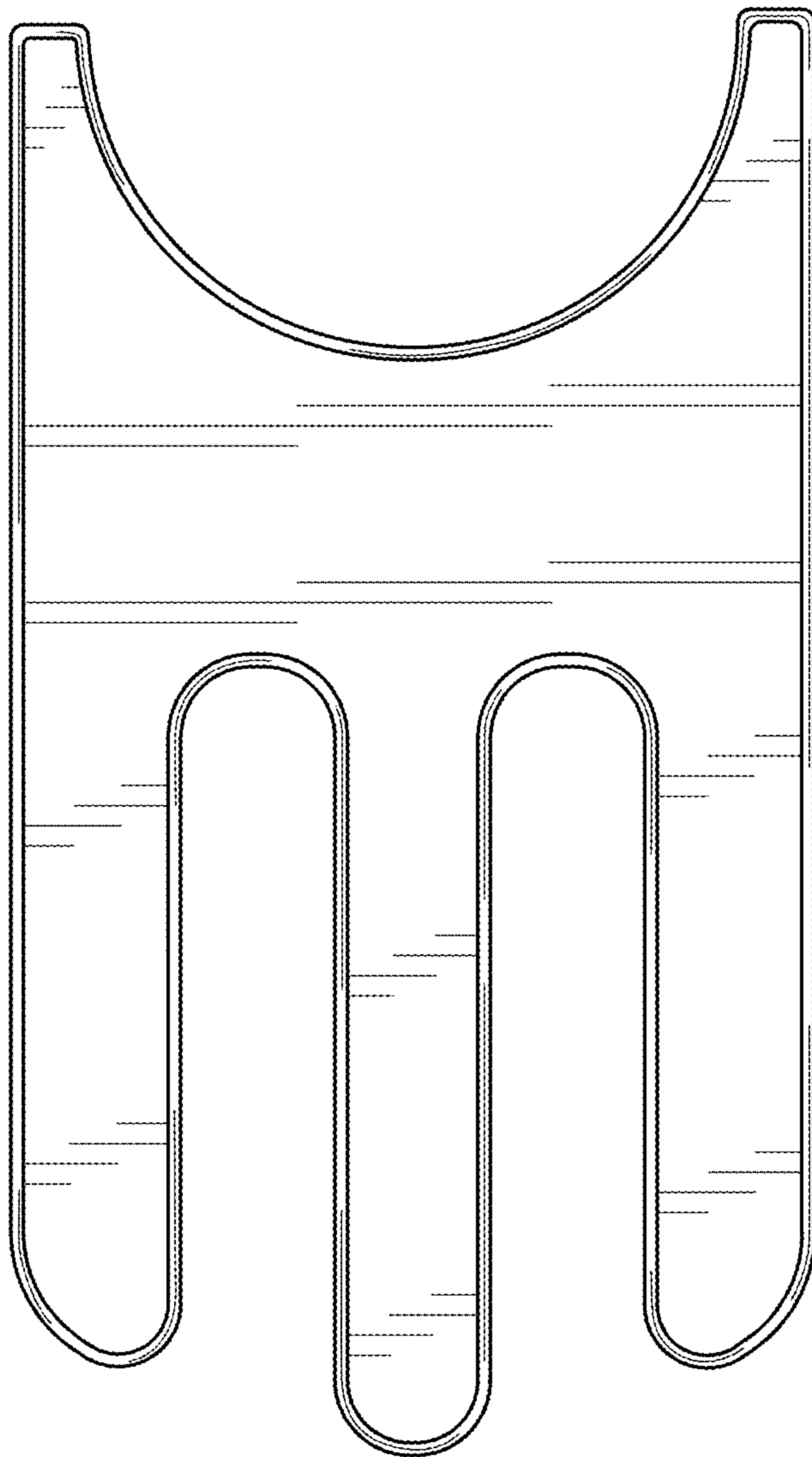
