The ornamental design for a lighting fixture, as shown and described.

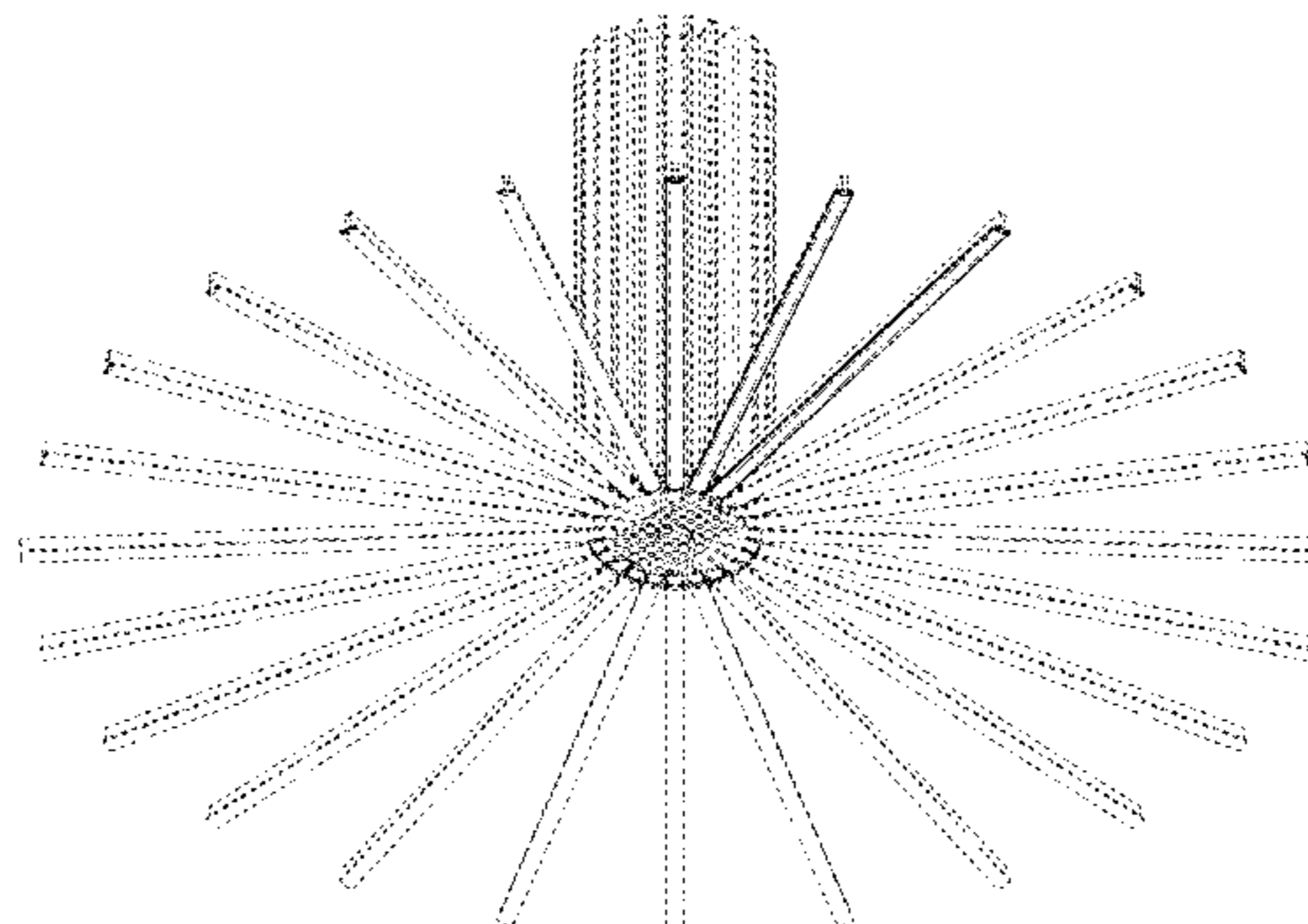
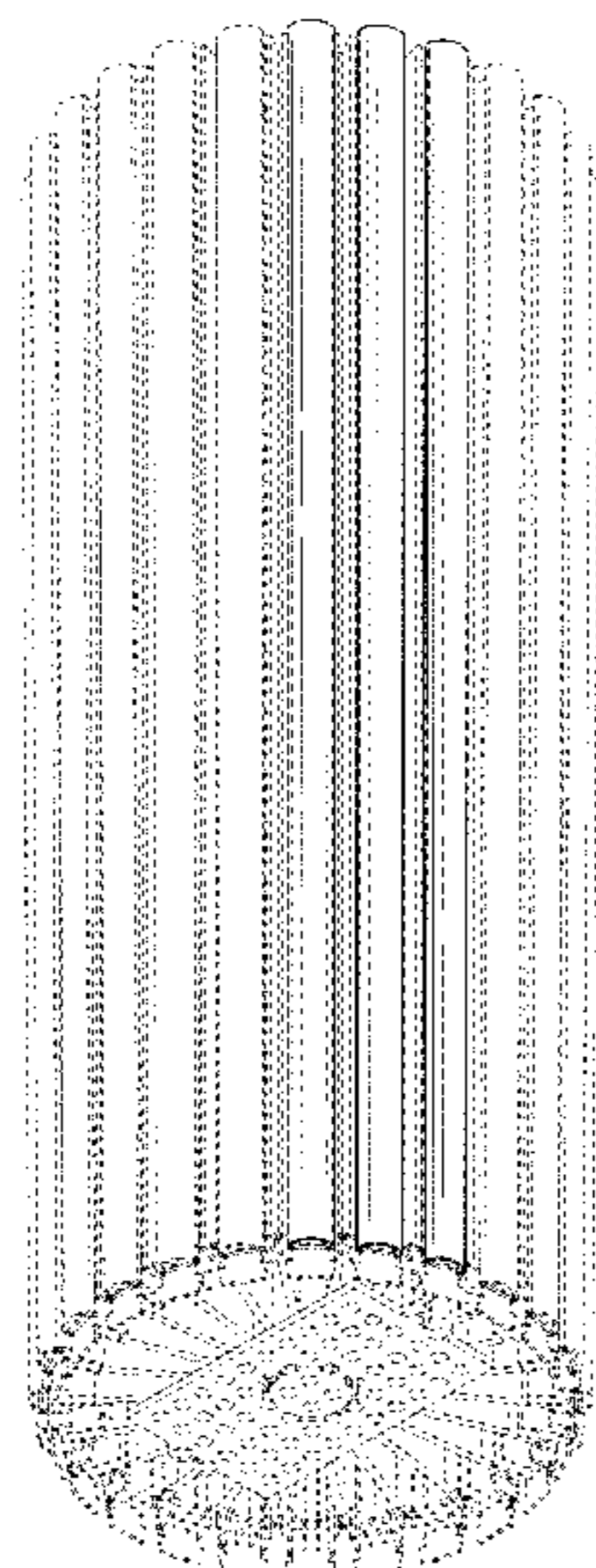
DESCRIPTION

FIG. 1 is a front, perspective view of a lighting fixture showing our new design, the lighting fixture in a collapsed configuration, according to an embodiment; FIG. 2 is a front side elevation view thereof; FIG. 3 is a back elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a top view thereof. FIG. 8 is a front, perspective view of the lighting fixture in an expanded configuration, according to an embodiment; FIG. 9 is a front side elevation view thereof; FIG. 10 is a back elevation view thereof; FIG. 11 is a right side elevation view thereof; FIG. 12 is a left side elevation view thereof; FIG. 13 is a bottom view thereof; and, FIG. 14 is a top view thereof.

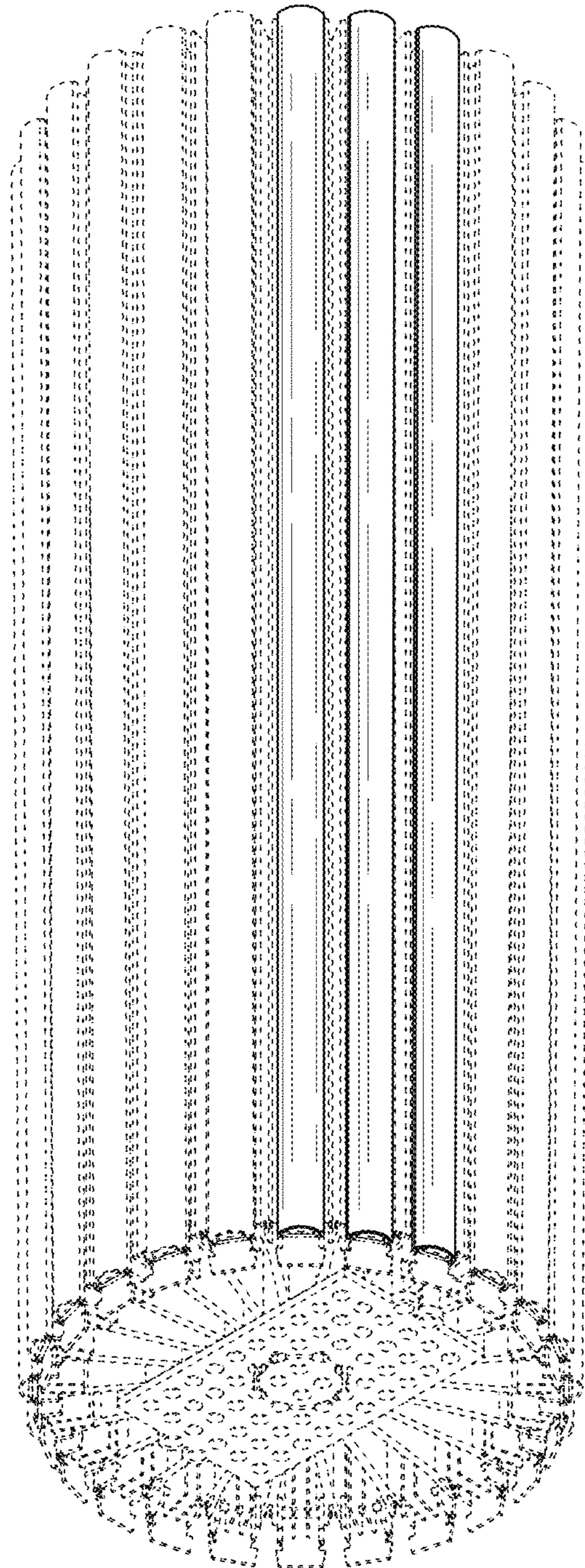

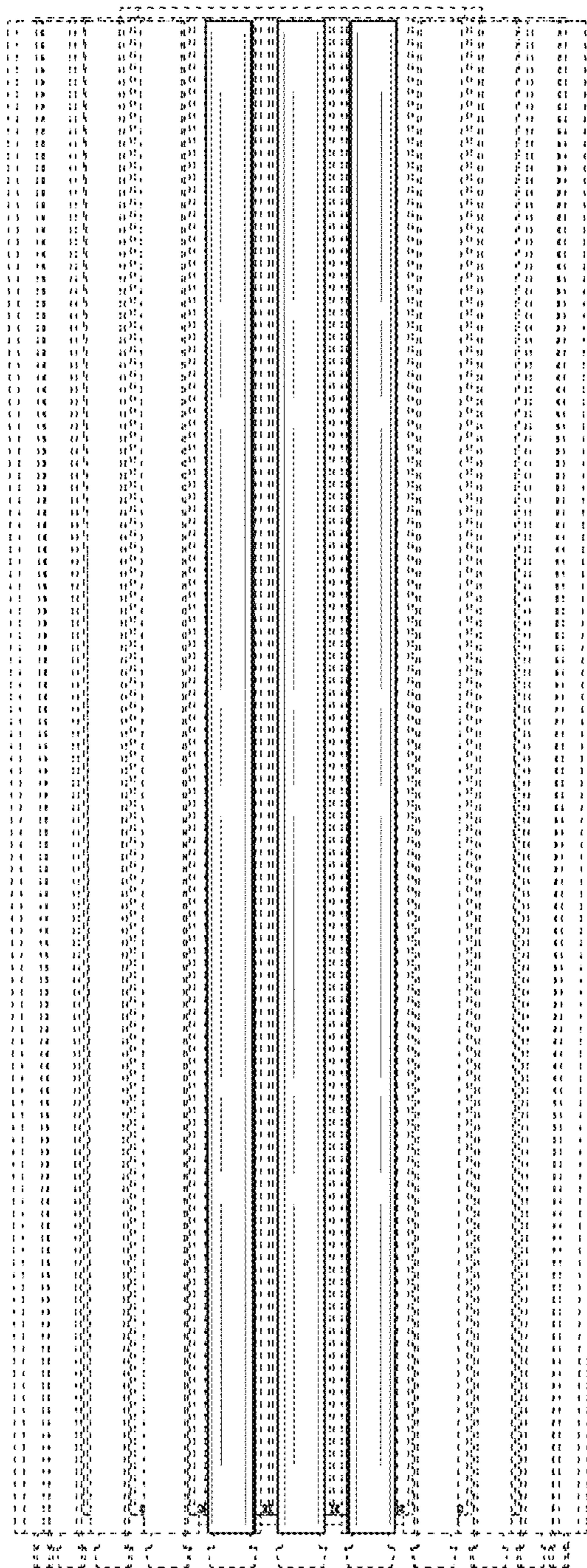

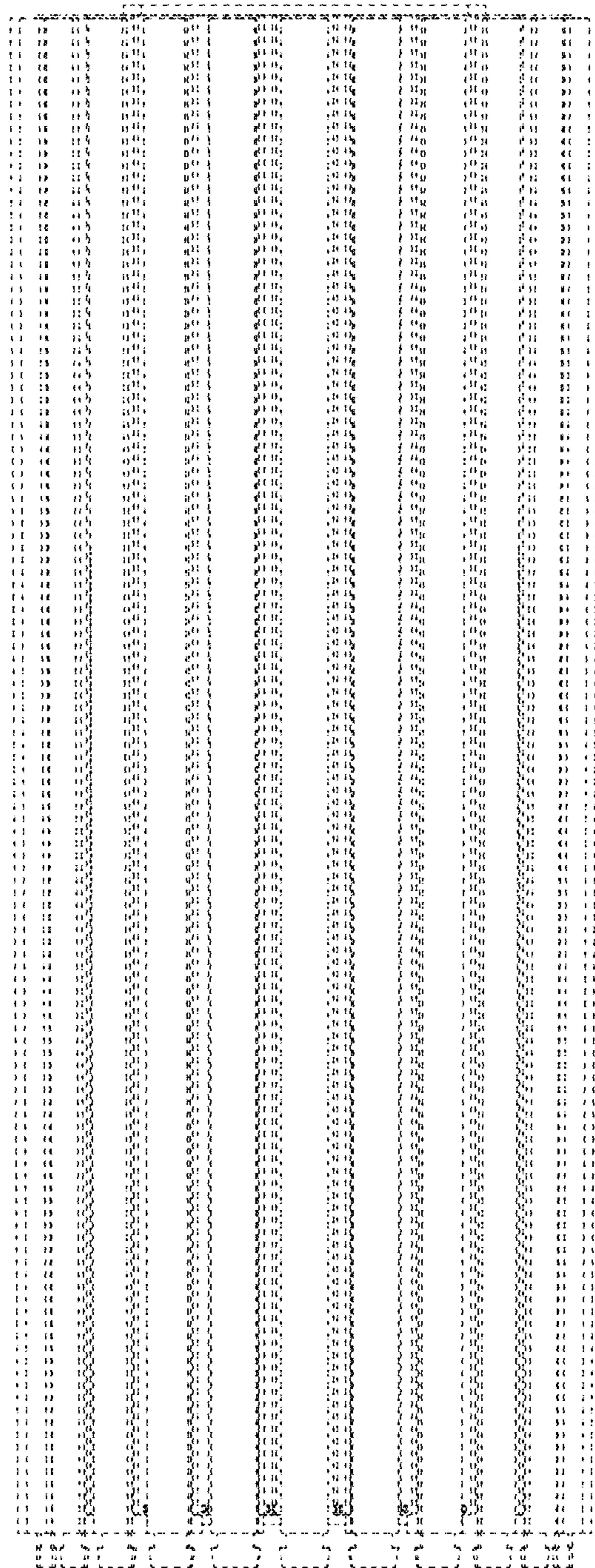

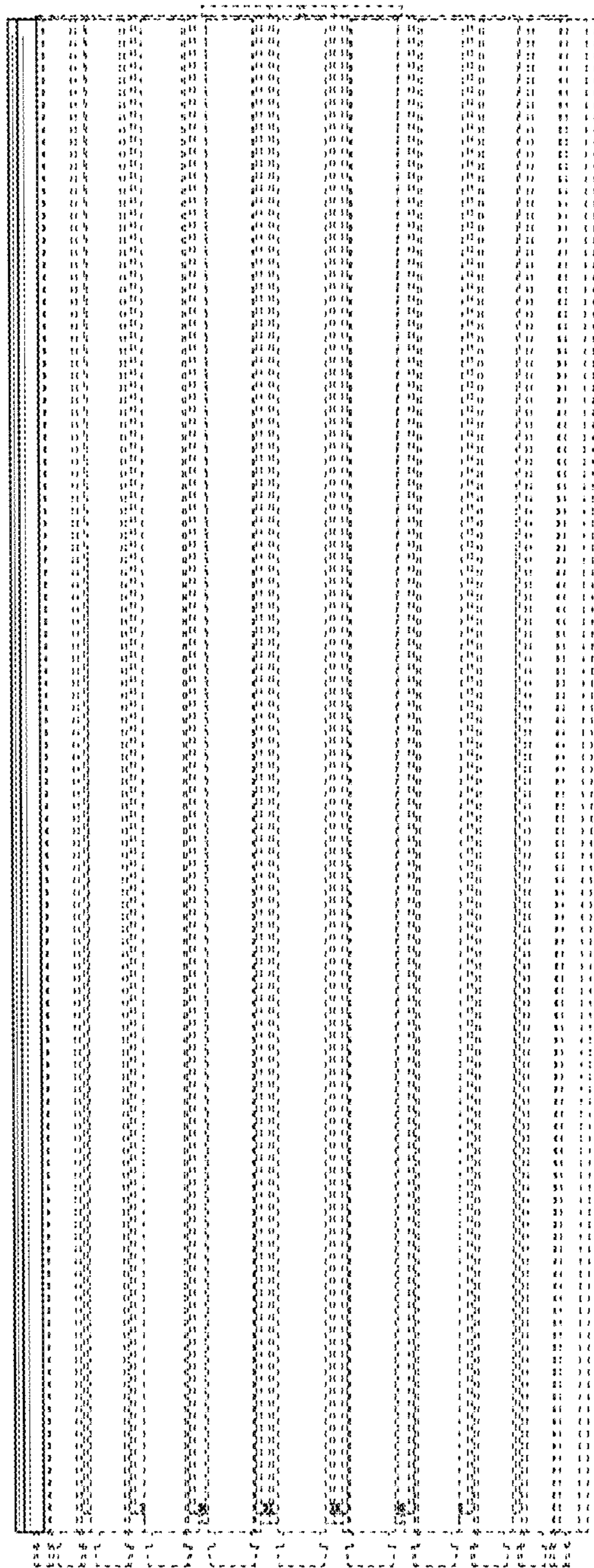

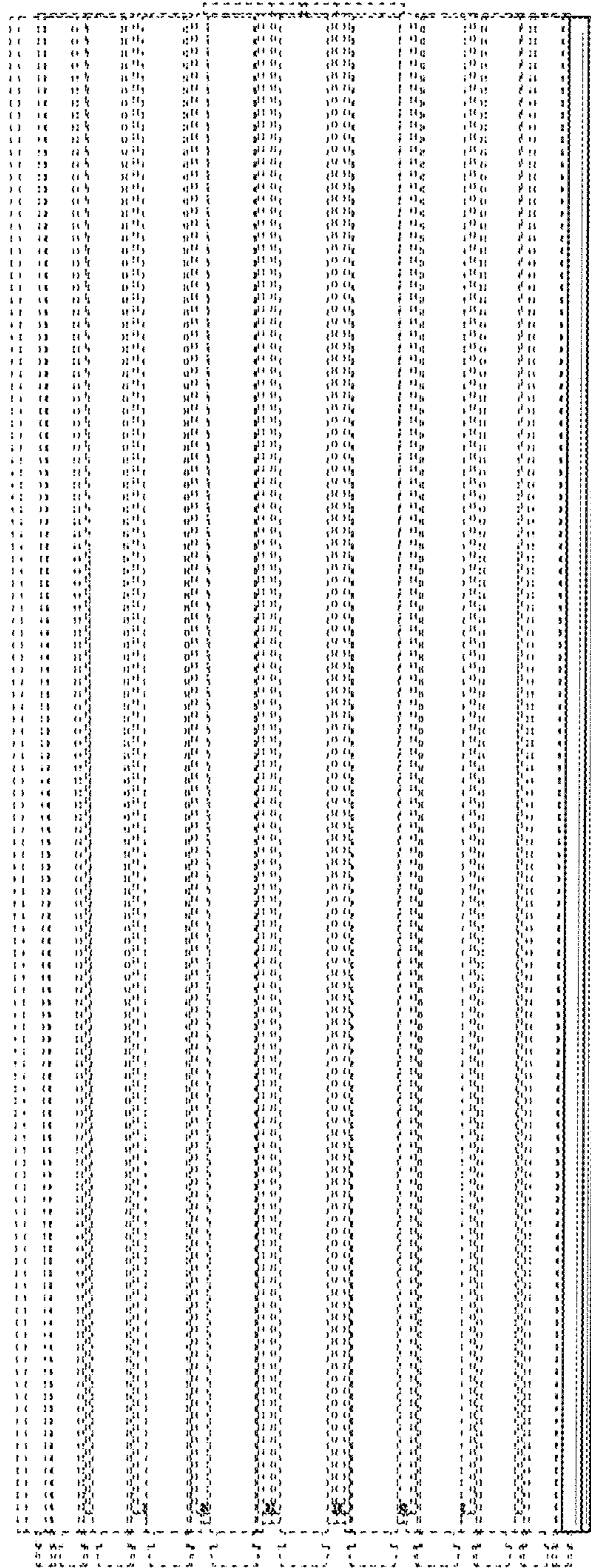

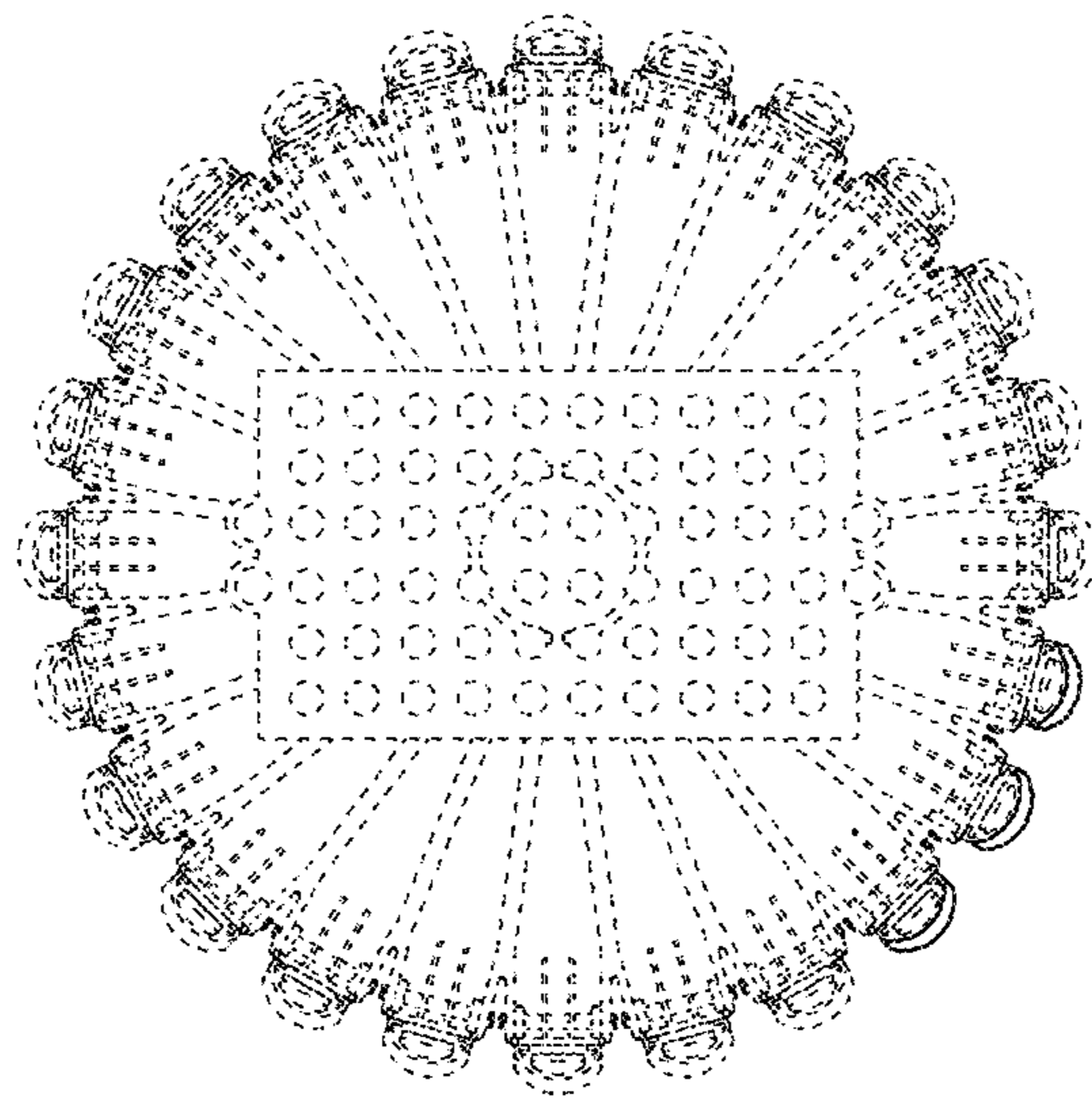

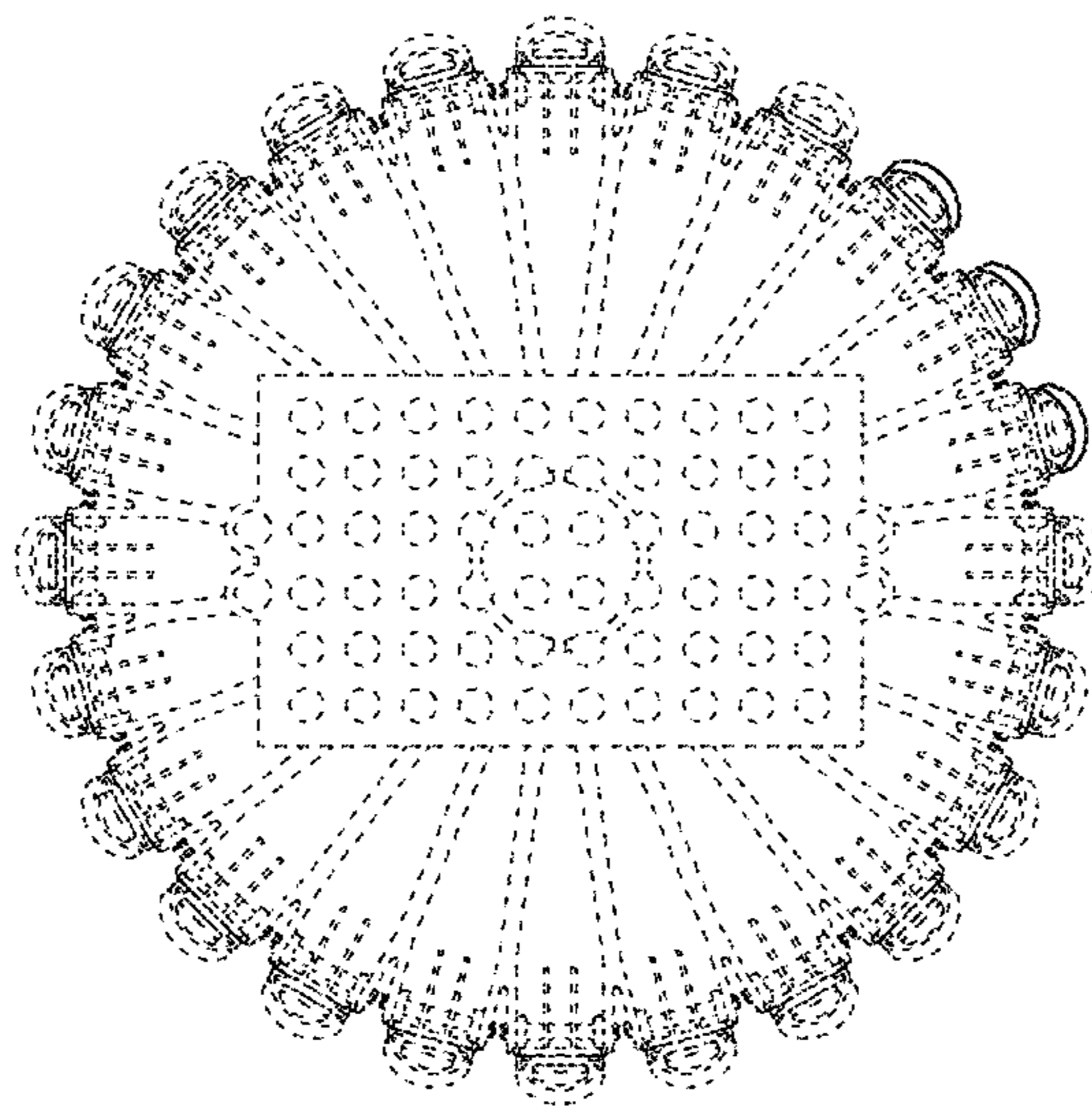

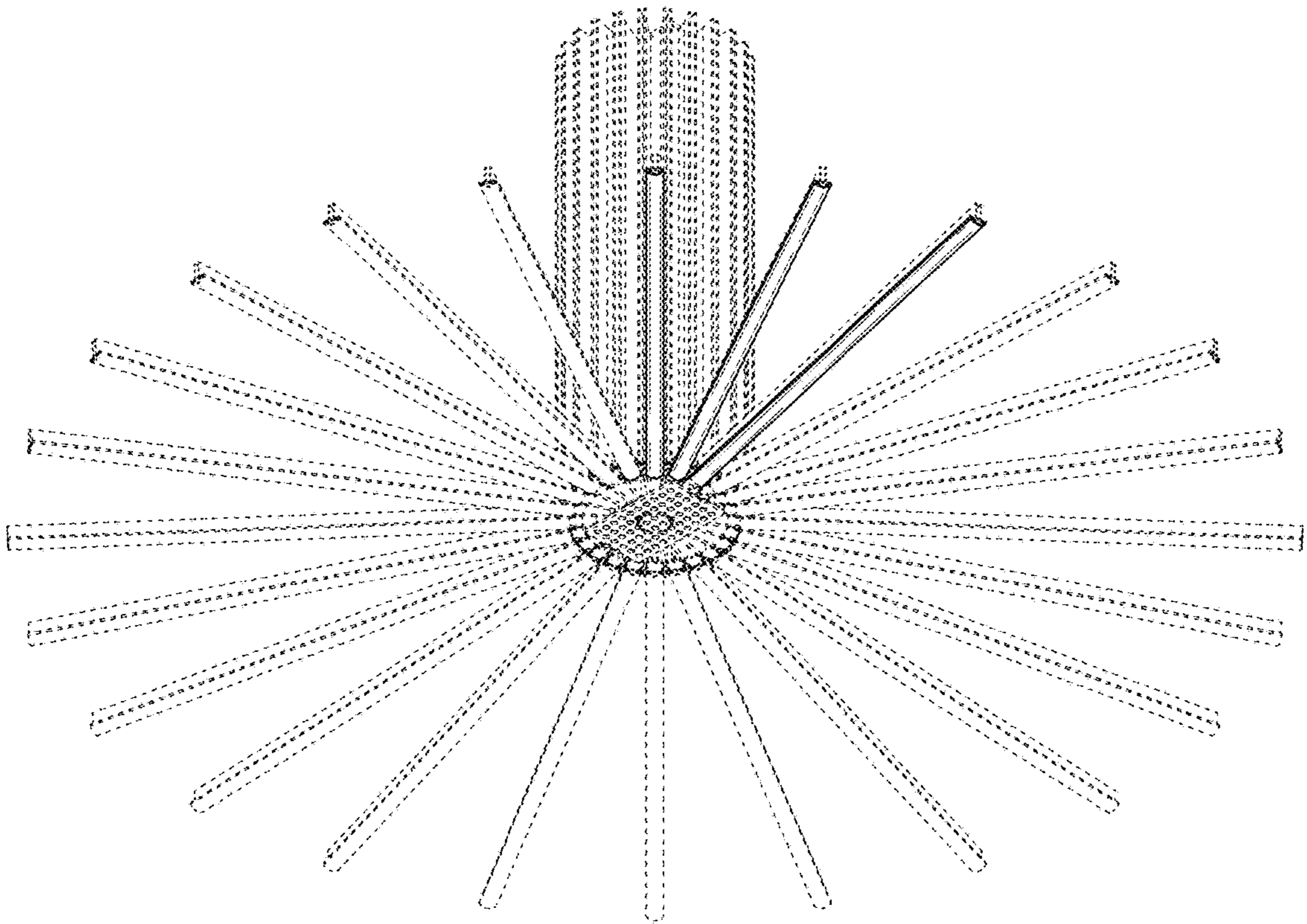

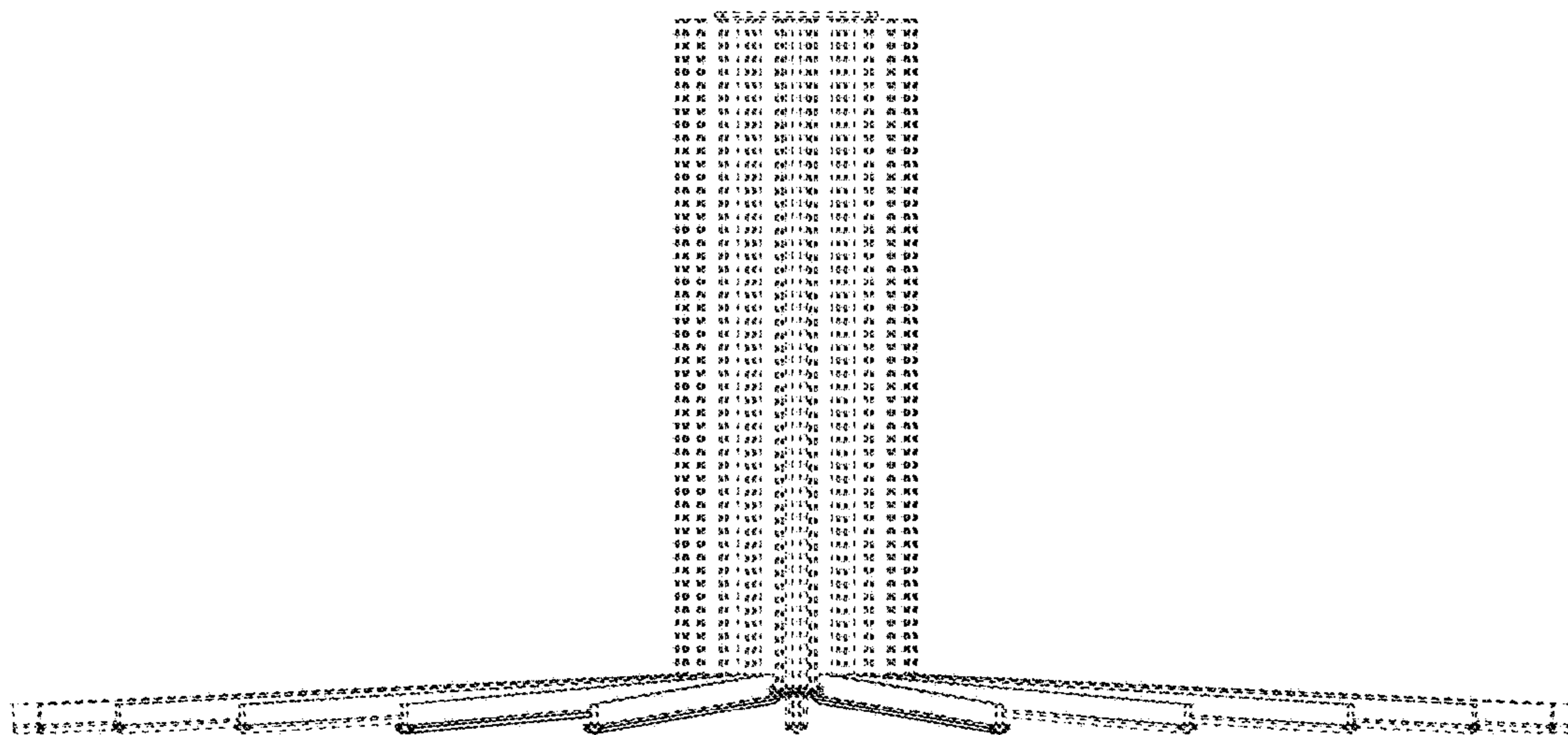

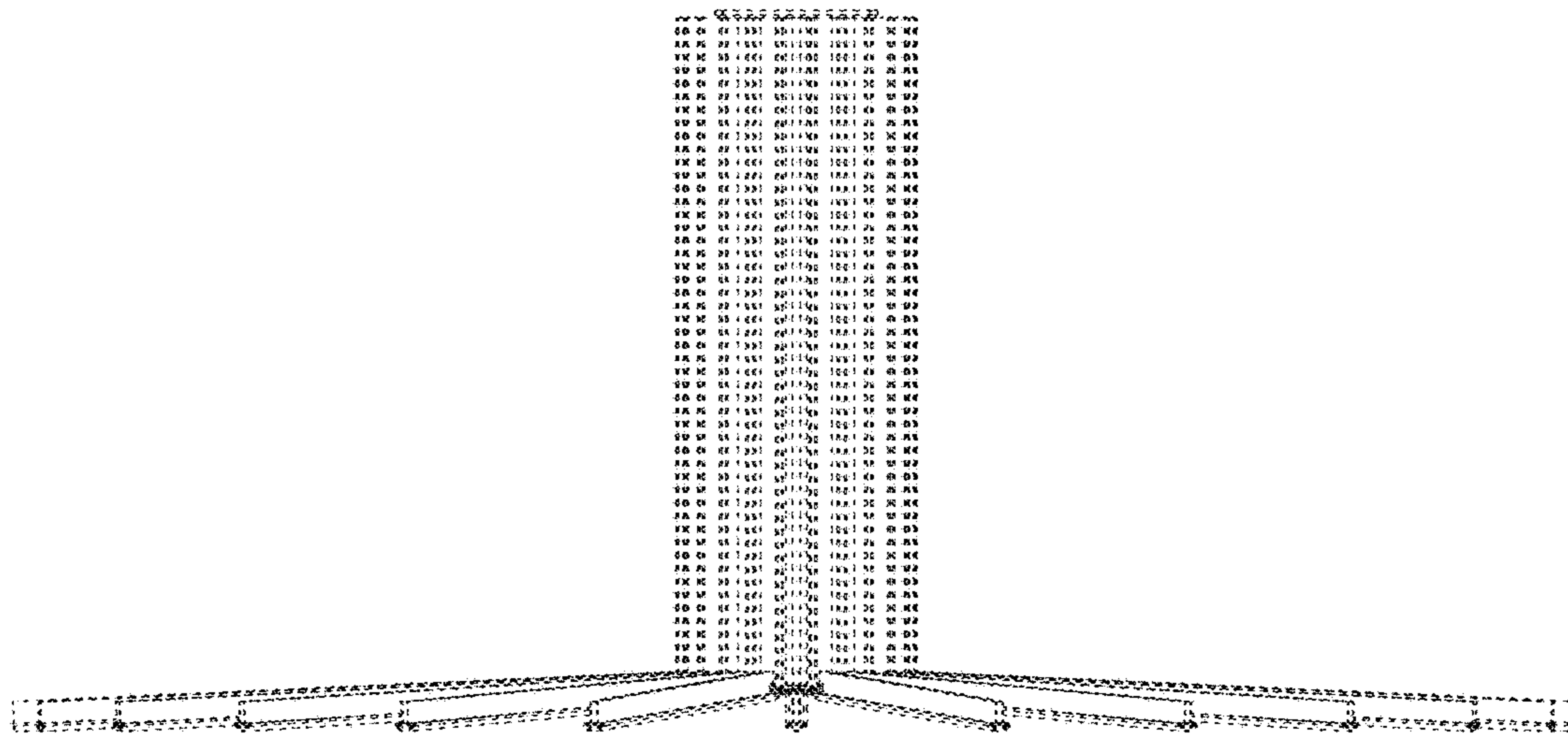

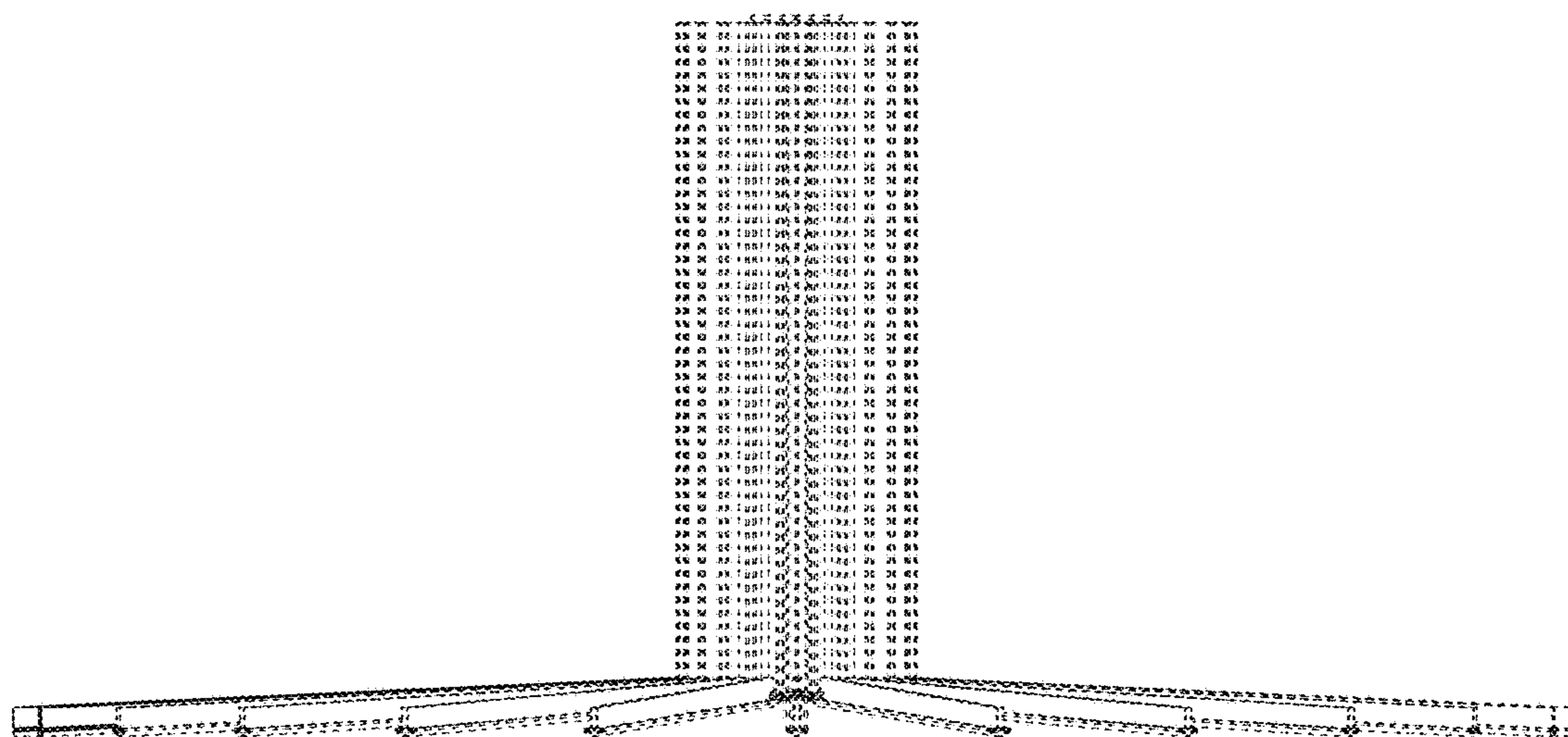

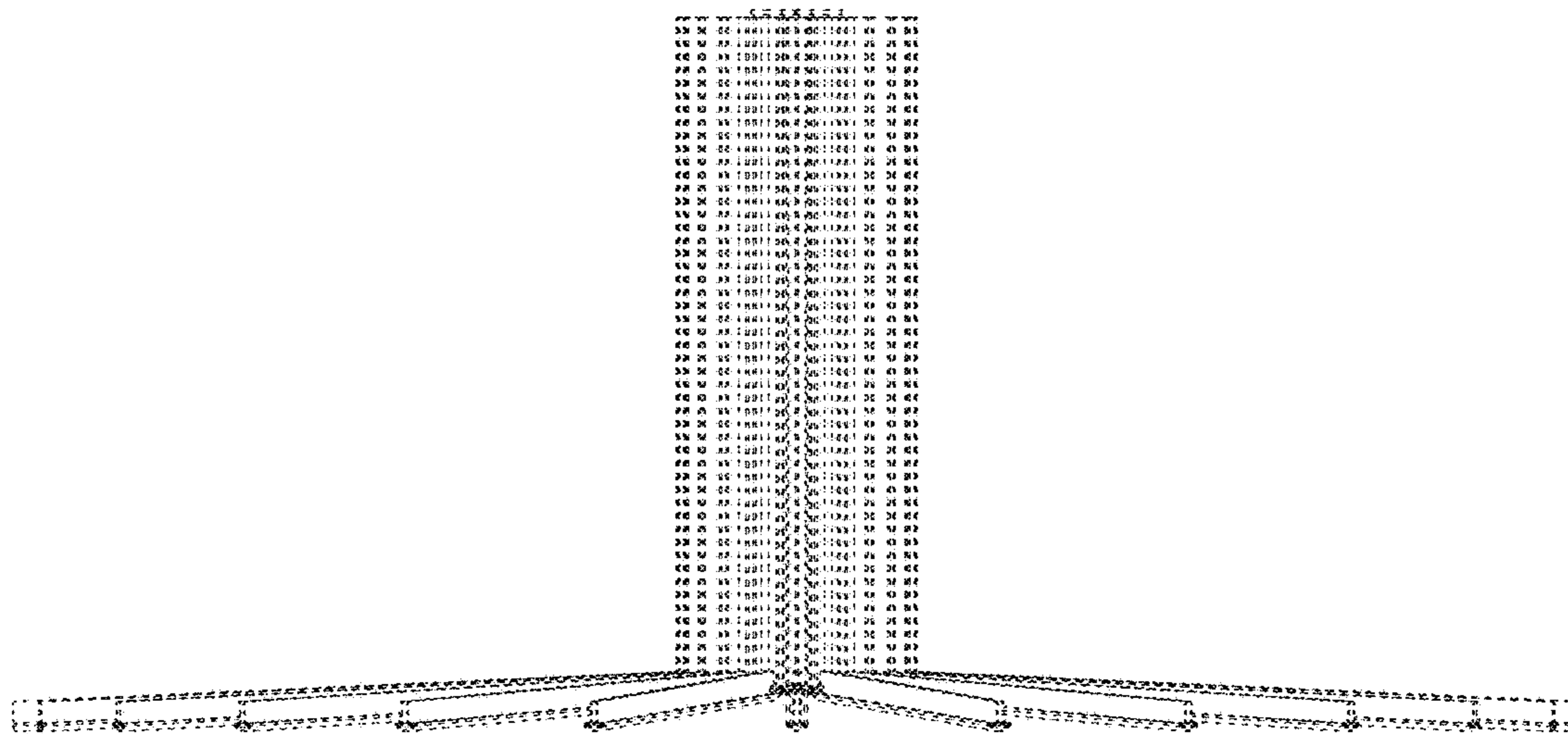

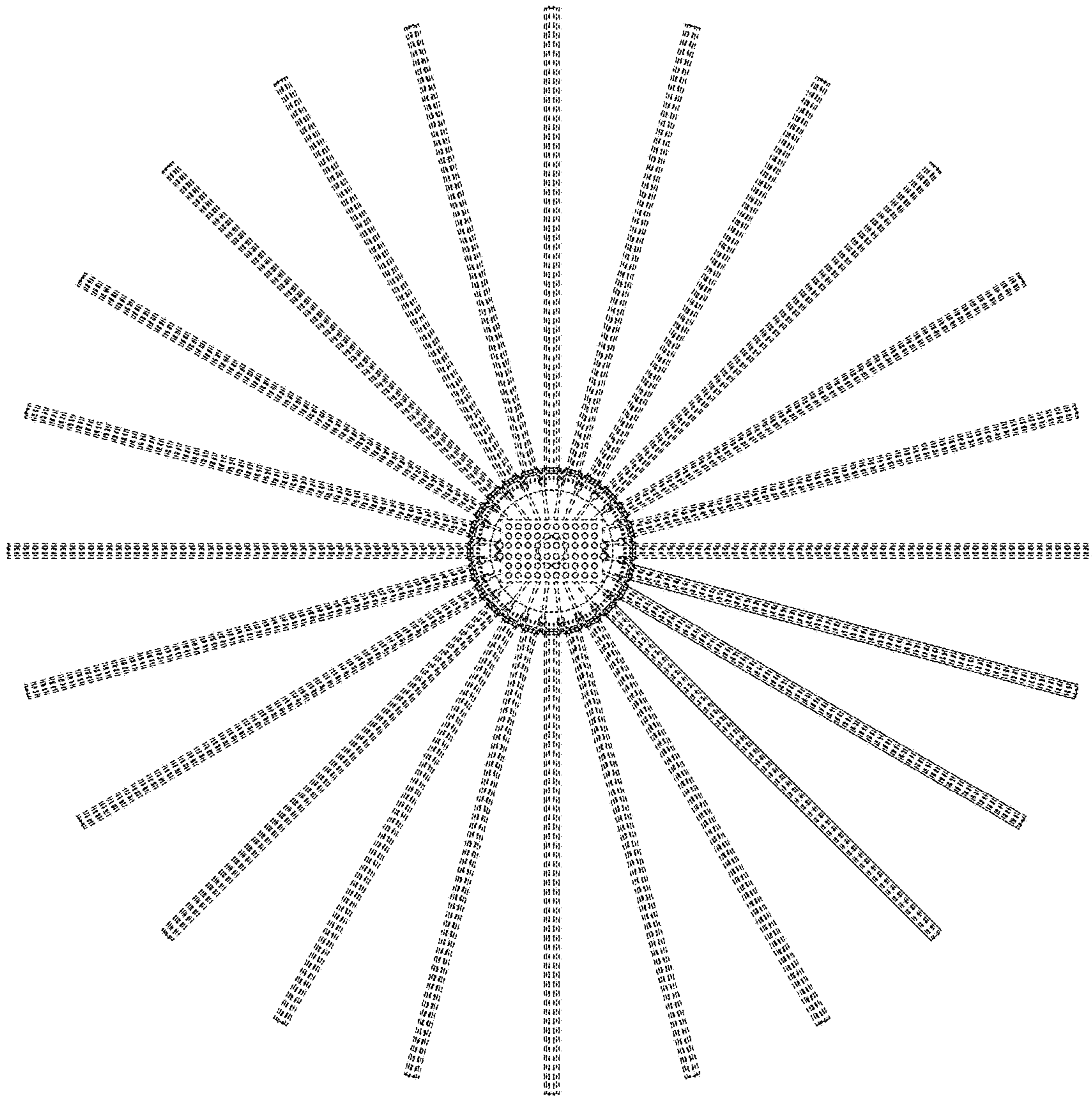

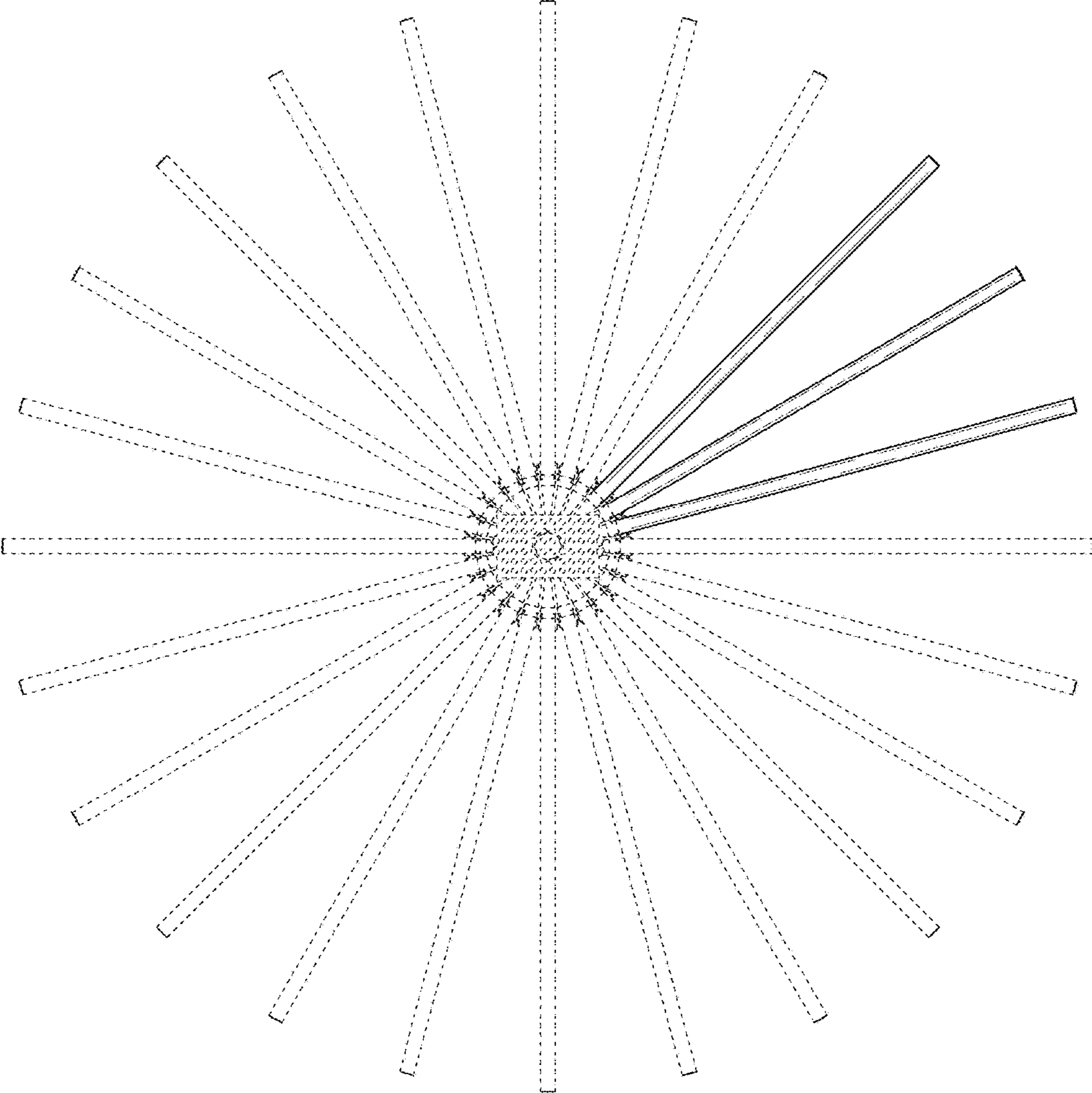
