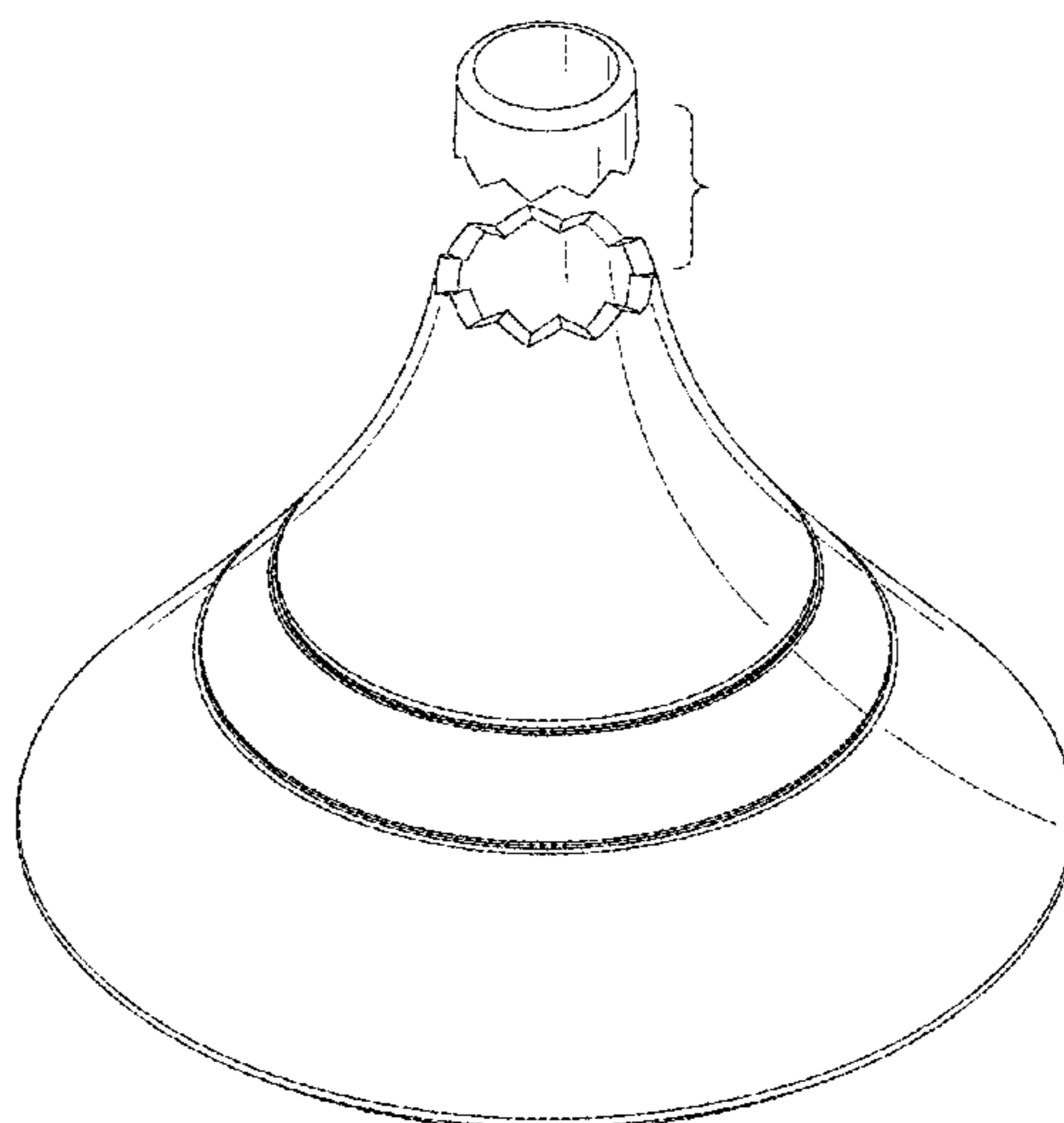
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top isometric view of a portion of cosmetic applicator in accordance with the new design;

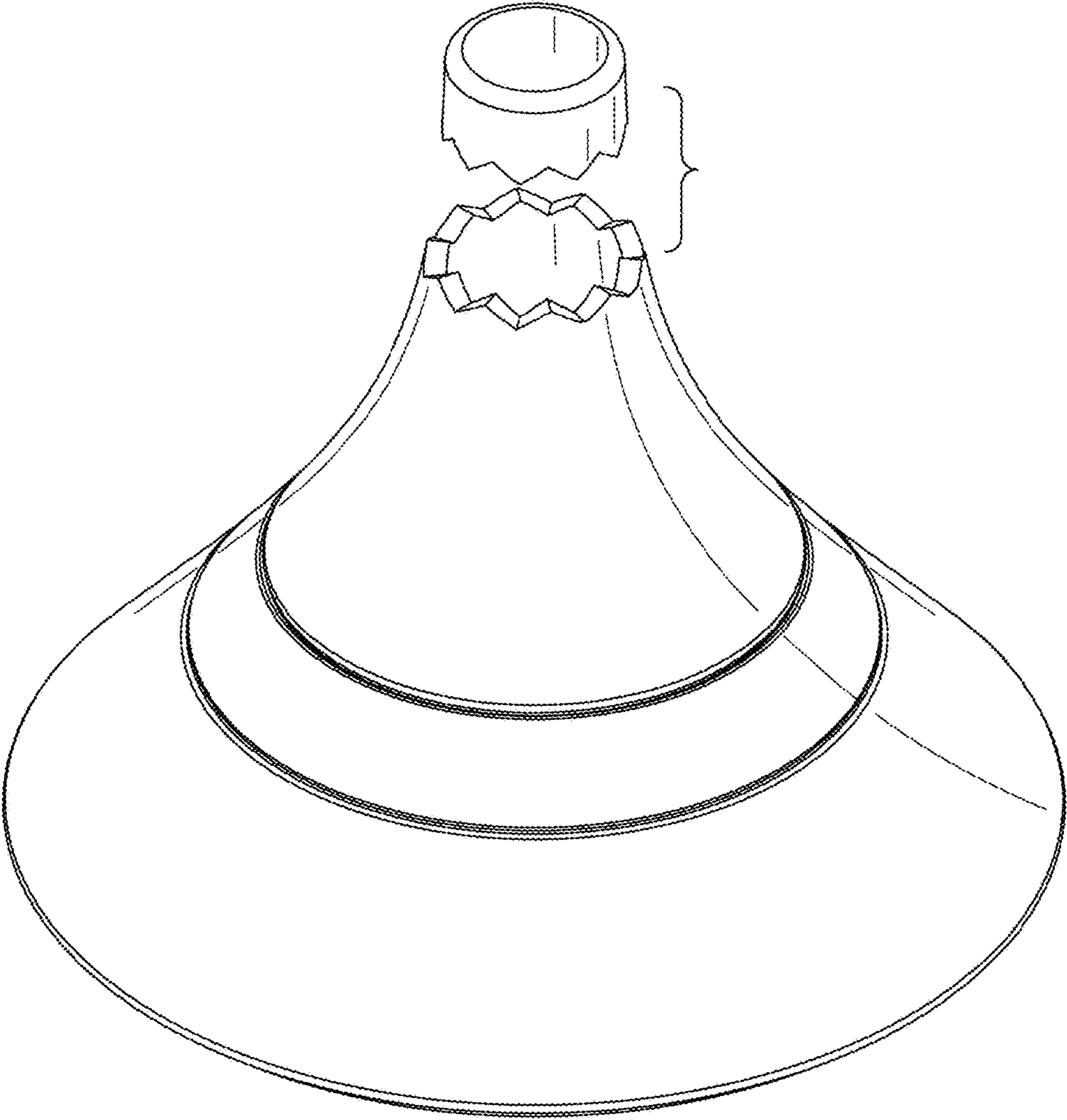

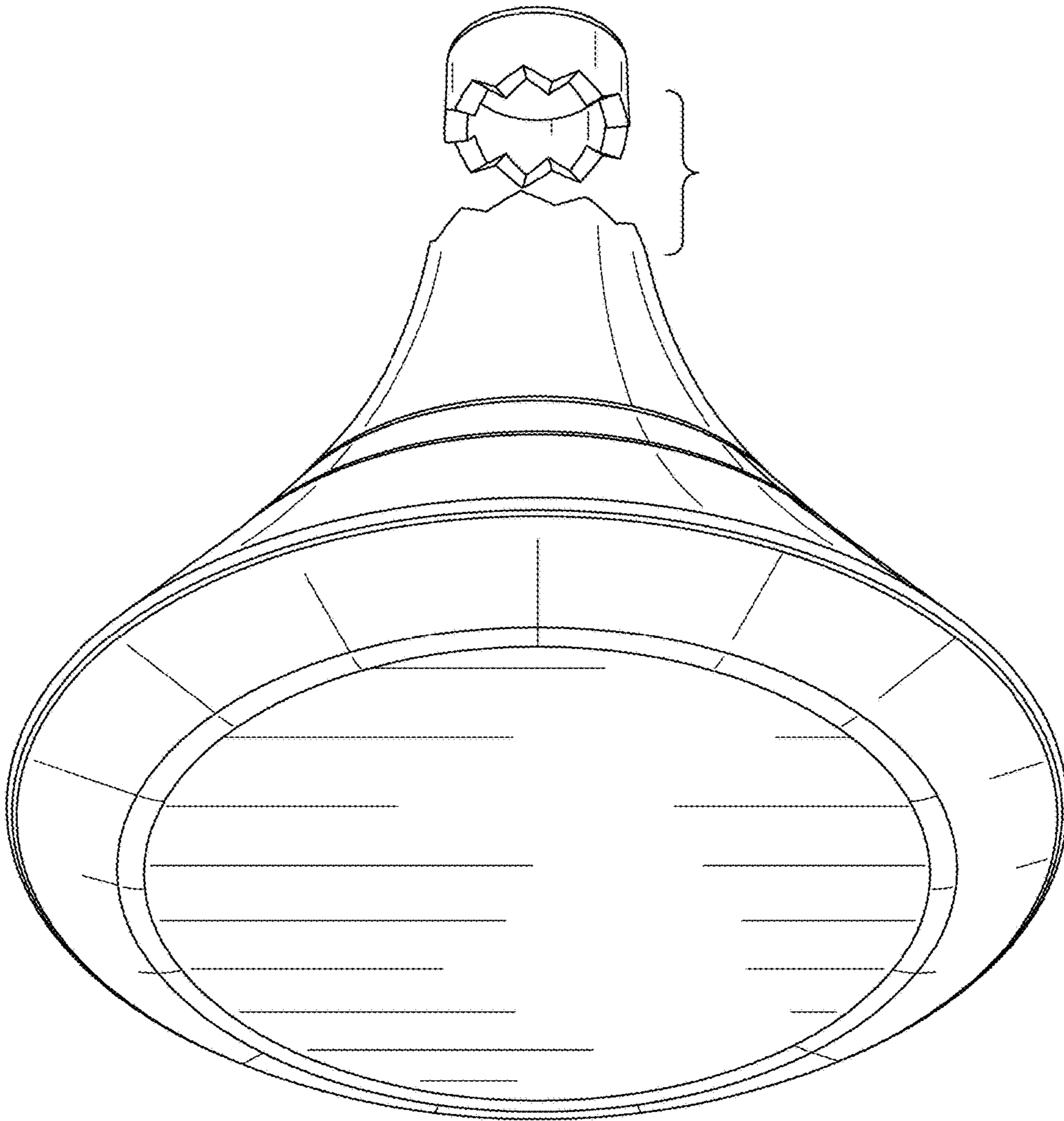

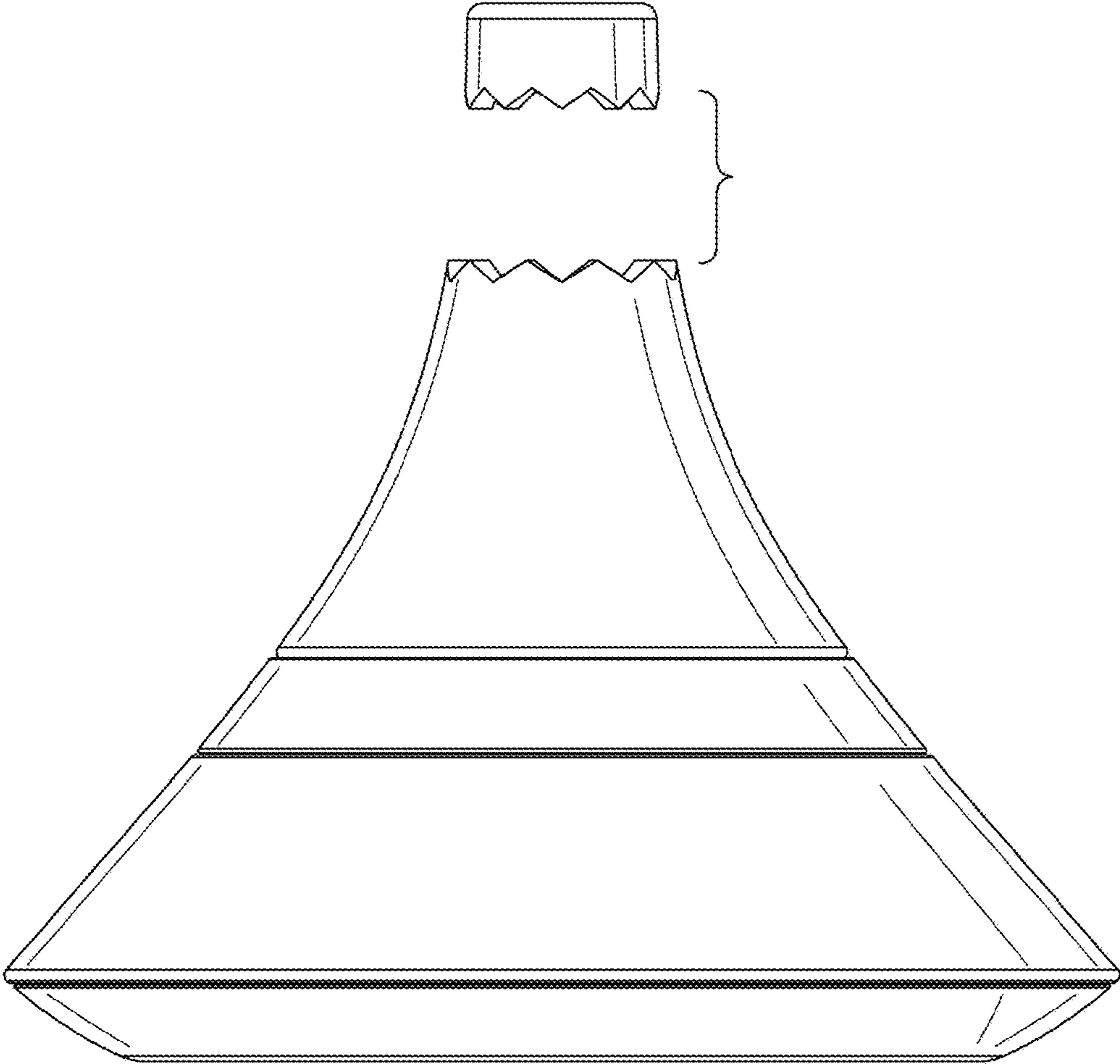

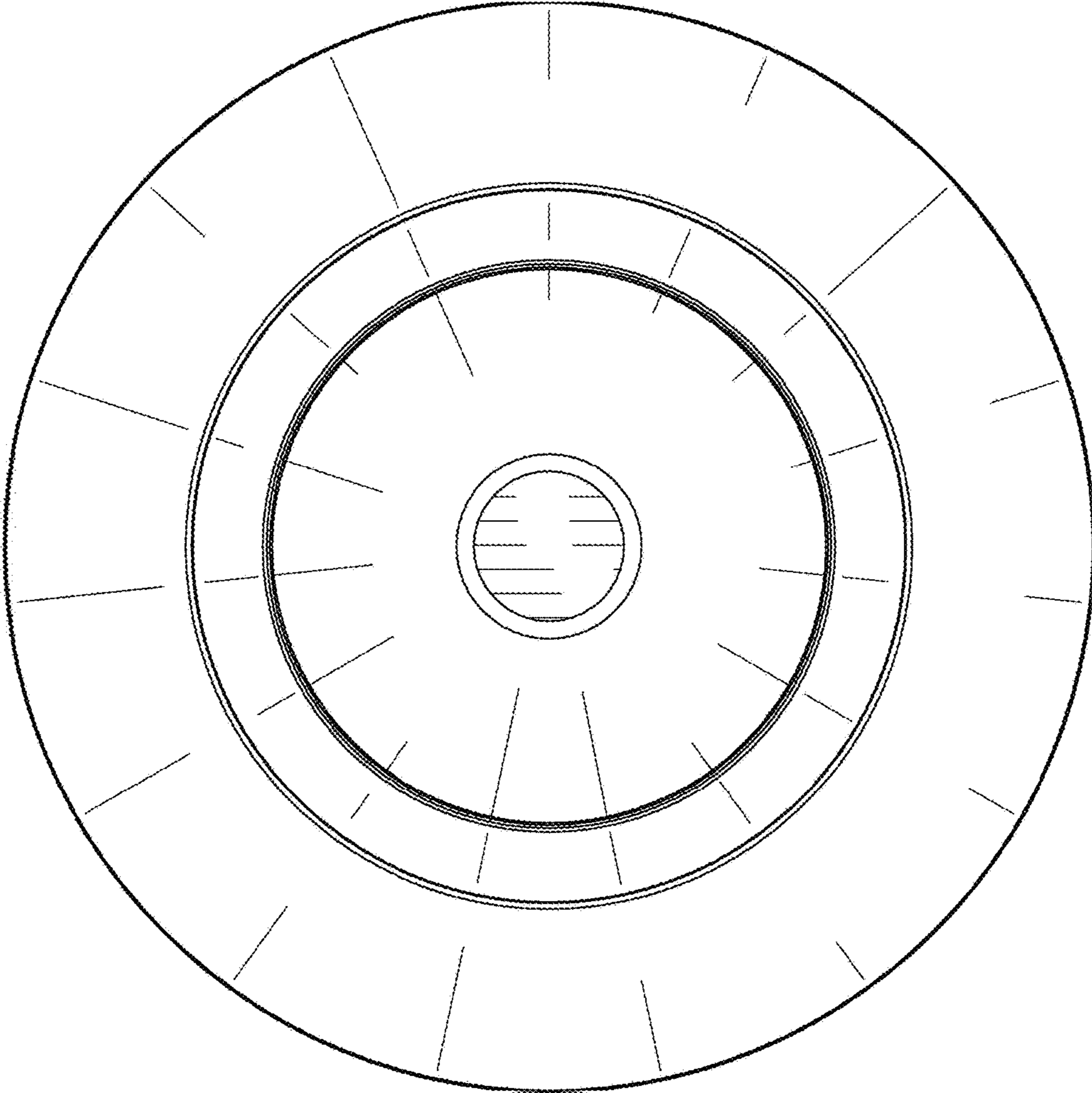

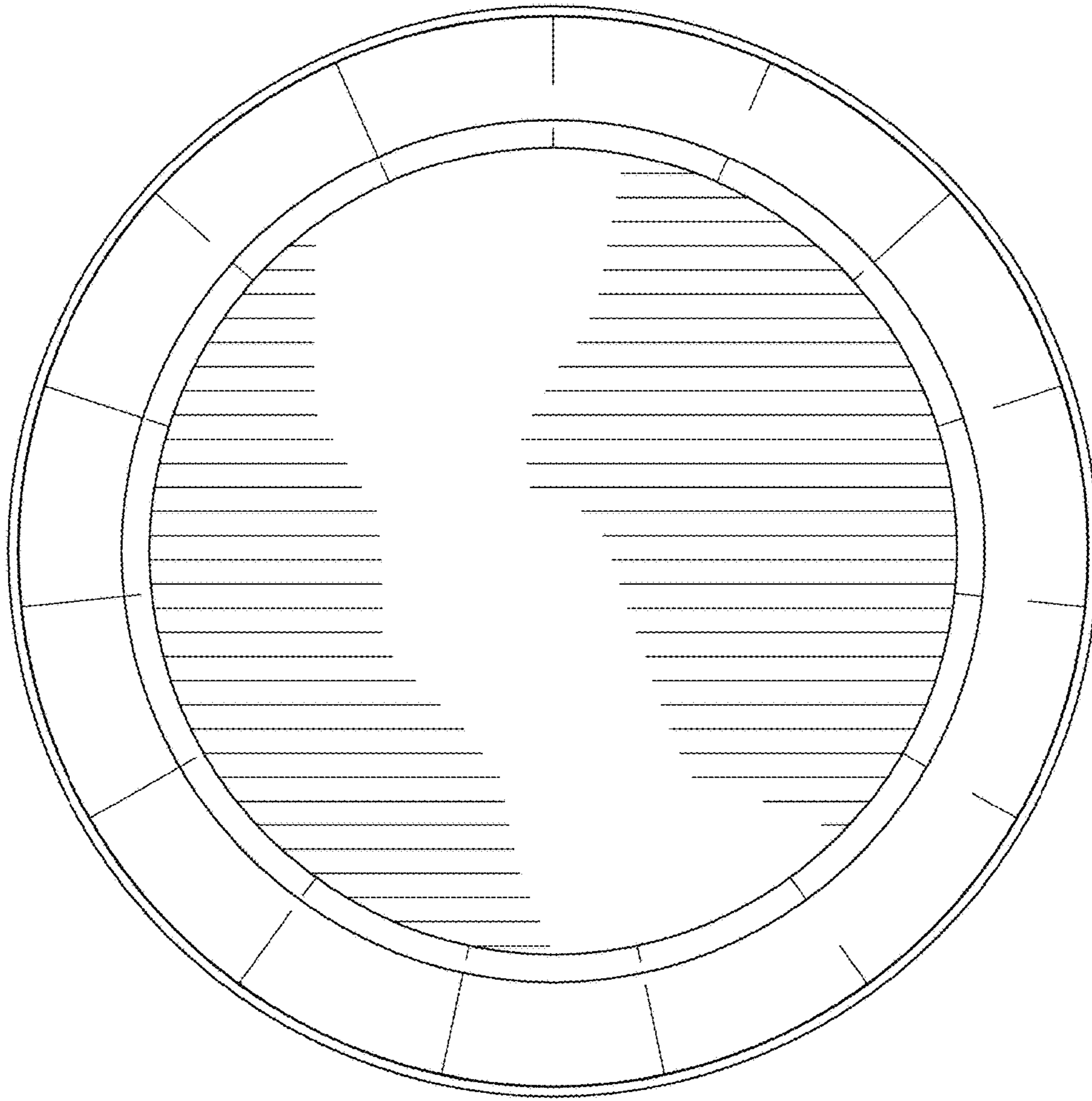
