(57) **CLAIM**

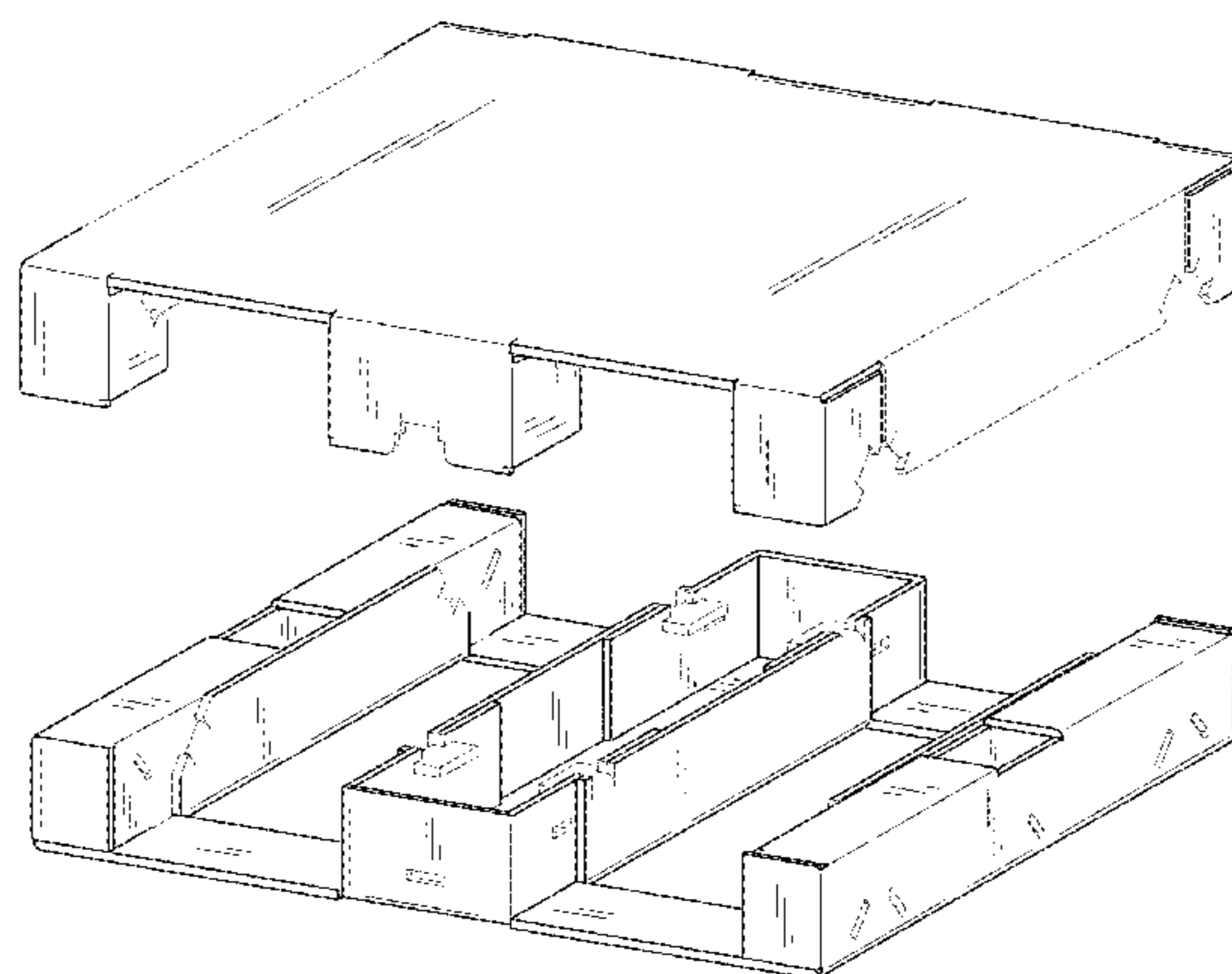
We claim the ornamental design for a foldably constructed pallet, as shown and described.

DESCRIPTION

FIG. 1 is a top front isometric view of a top blank of a foldably constructed pallet in an unfolded configuration.

FIG. 2 is a top plan view of the top blank of FIG. 1.
FIG. 3 is a bottom plan view of the top blank of FIG. 1.
FIG. 4 is a front elevation view of the top blank of FIG. 1.
FIG. 5 is a rear elevation view of the top blank of FIG. 1.
FIG. 6 is a left side elevation view of the top blank of FIG. 1.
FIG. 7 is a right side elevation view of the top blank of FIG. 1.
FIG. 8 is a top front isometric view of a bottom blank of a foldably constructed pallet in an unfolded configuration.
FIG. 9 is a top plan view of the bottom blank of FIG. 8.
FIG. 10 is a bottom plan view of the bottom blank of FIG. 8.
FIG. 11 is a front elevation view of the bottom blank of FIG. 8.
FIG. 12 is a rear elevation view of the bottom blank of FIG. 8.
FIG. 13 is a right side elevation view of the bottom blank of FIG. 8.
FIG. 14 is a left side elevation view of the bottom blank of FIG. 8.
FIG. 15 is a top front isometric view of a foldably constructed pallet constructed by folding the top blank of FIG. 1 and the bottom blank of FIG. 8 along the fold lines shown by the dotted lines and connecting the top and the bottom blank together.
FIG. 16 is a top plan view of the foldably constructed pallet of FIG. 15.
FIG. 17 is a bottom plan view of the foldably constructed pallet of FIG. 15.
FIG. 18 is a front elevation view of the foldably constructed pallet of FIG. 15.
FIG. 19 is a rear elevation view of the foldably constructed pallet of FIG. 15.
FIG. 20 is a right side elevation view of the foldably constructed pallet of FIG. 15.
FIG. 21 is a left side elevation view of the foldably constructed pallet of FIG. 15; and,
FIG. 22 is an exploded view of the foldably constructed pallet of FIG. 15.
The dotted lines shown in the figures are included for the purpose of illustrating fold lines. The dashed lines define the bounds of the claimed design and form no part thereof. The

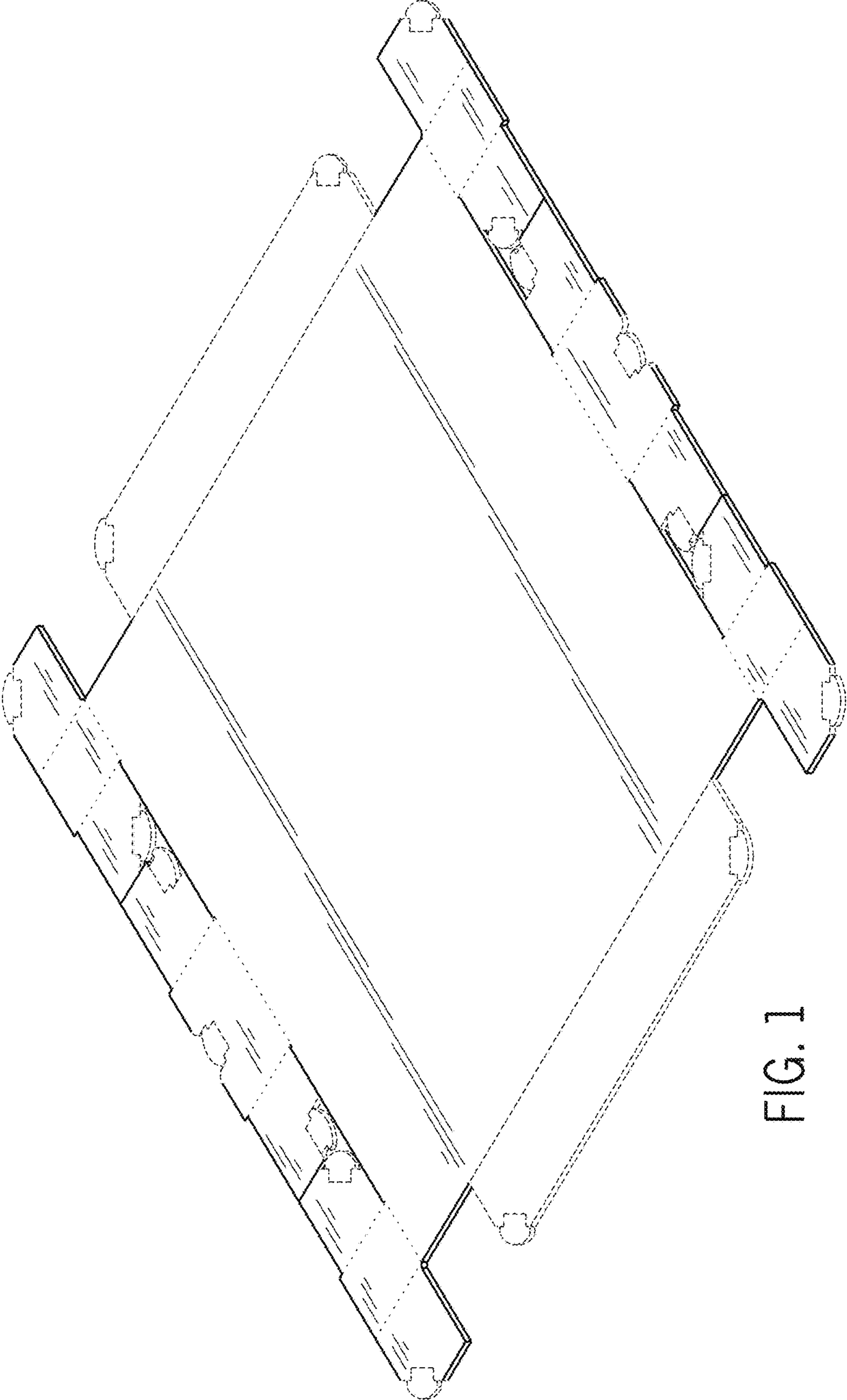

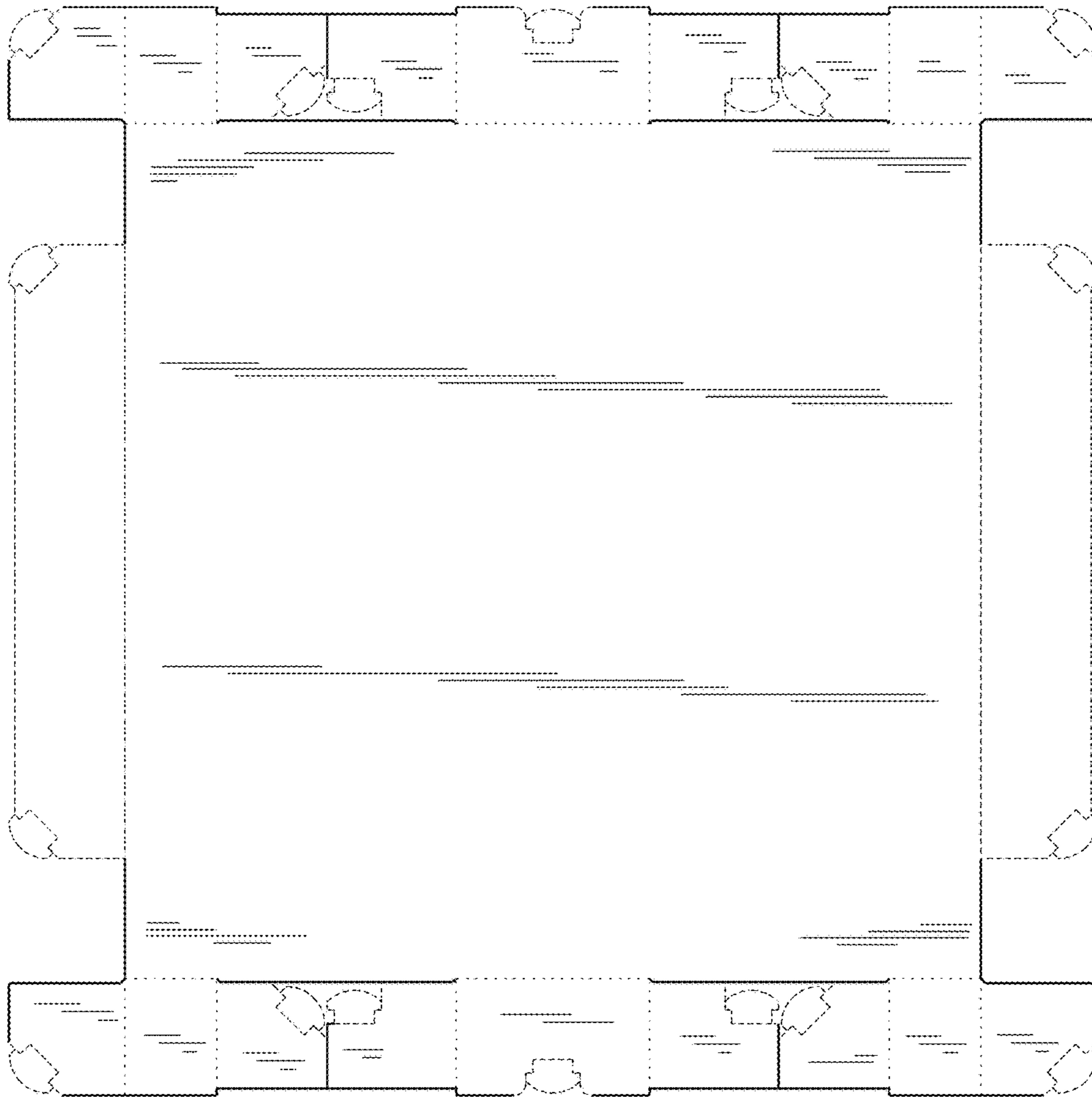

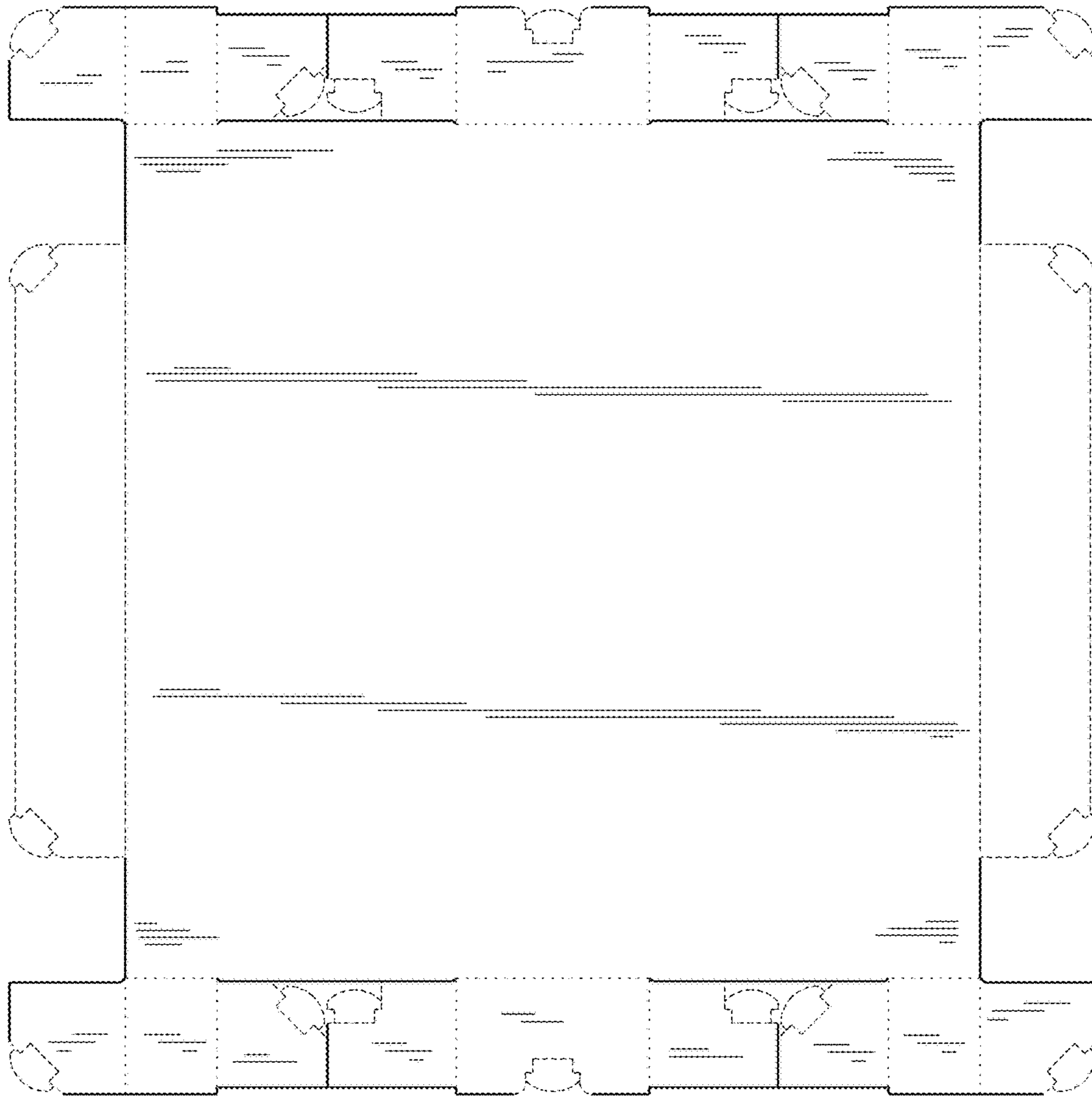

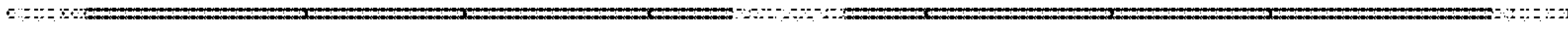

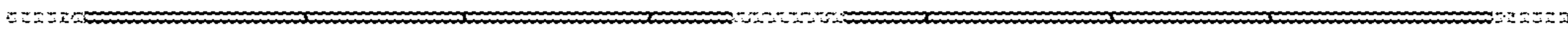

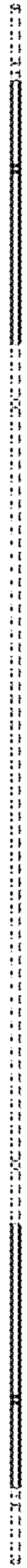

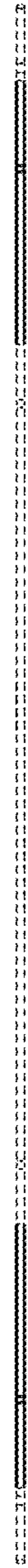

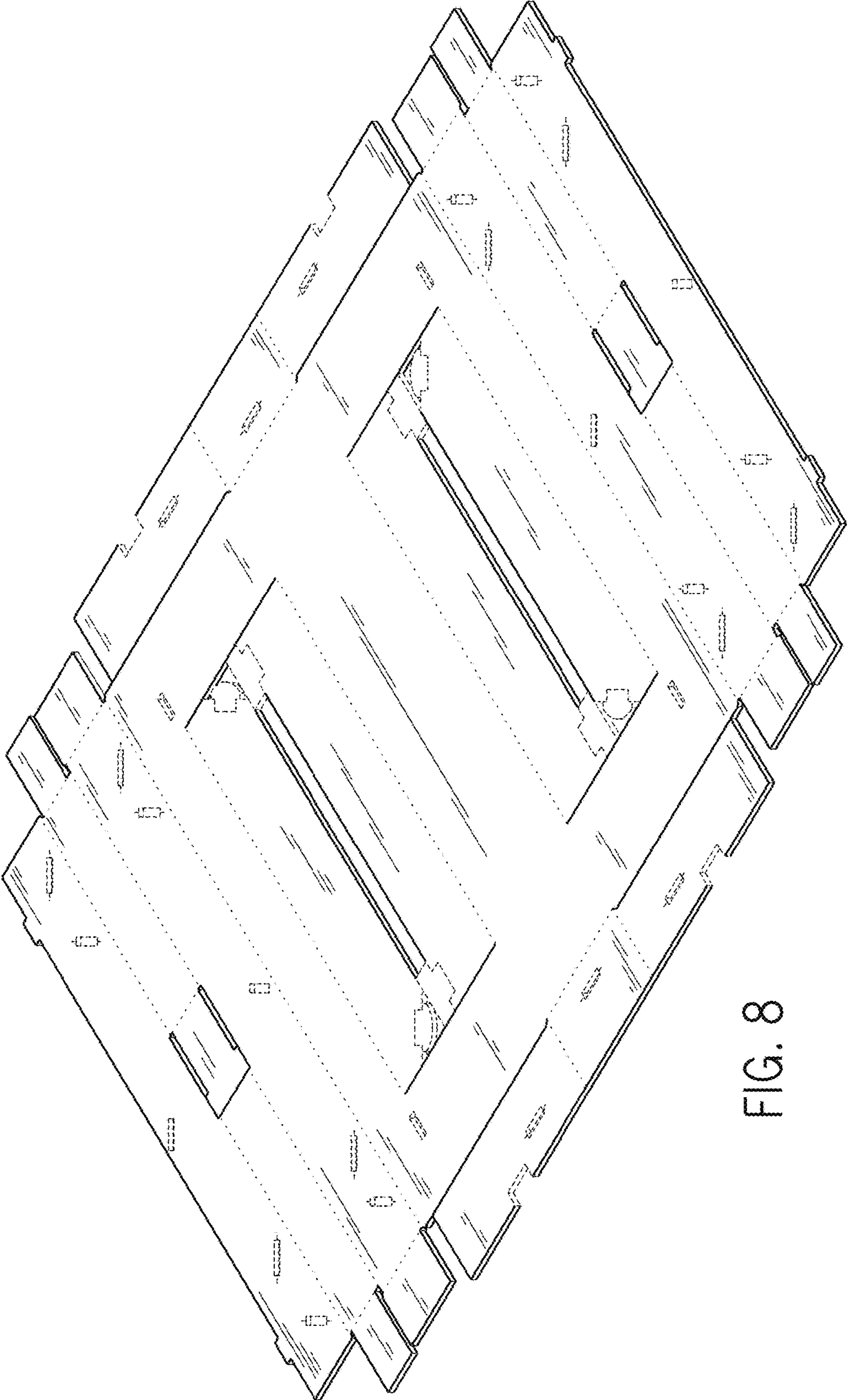

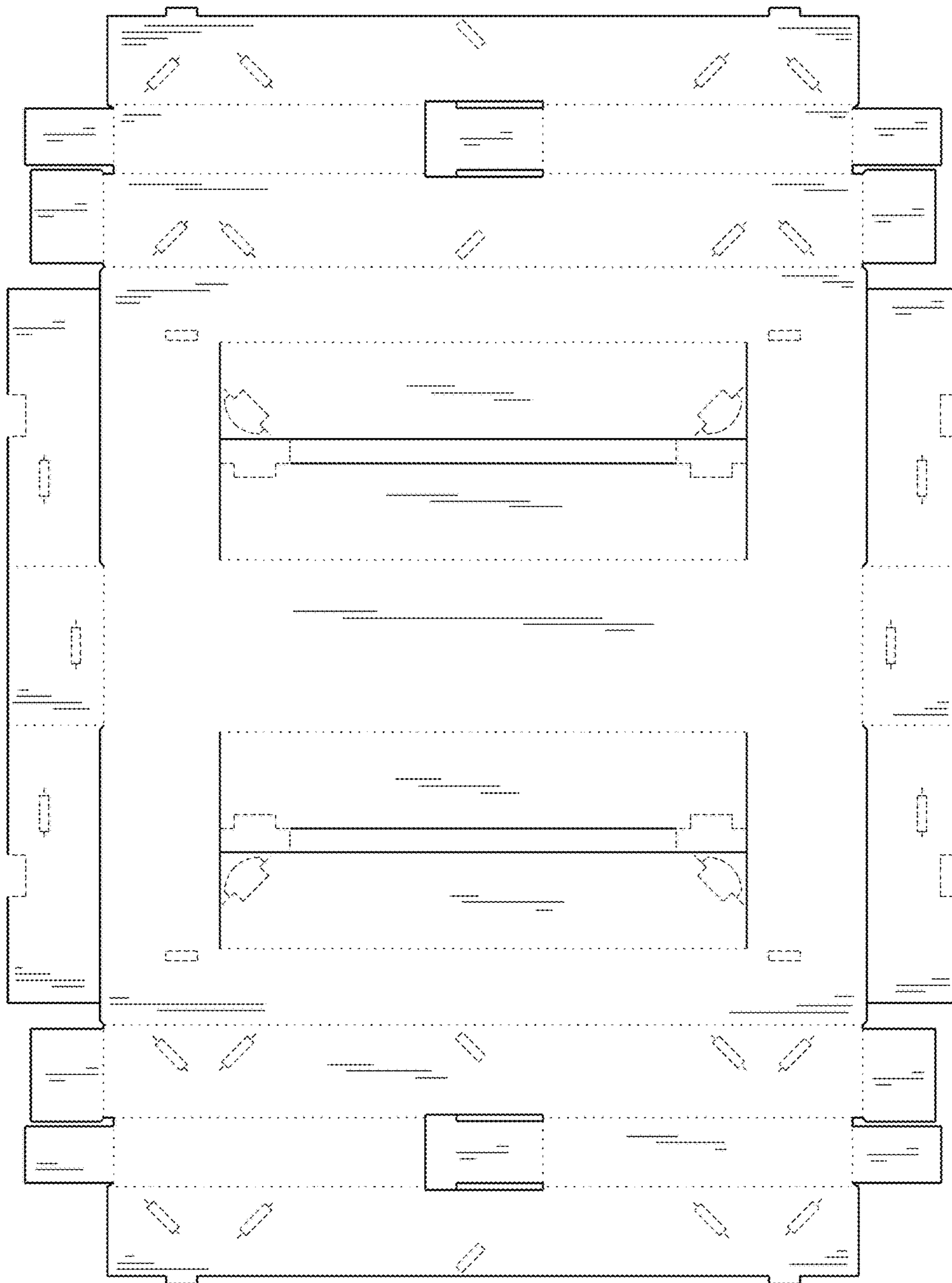

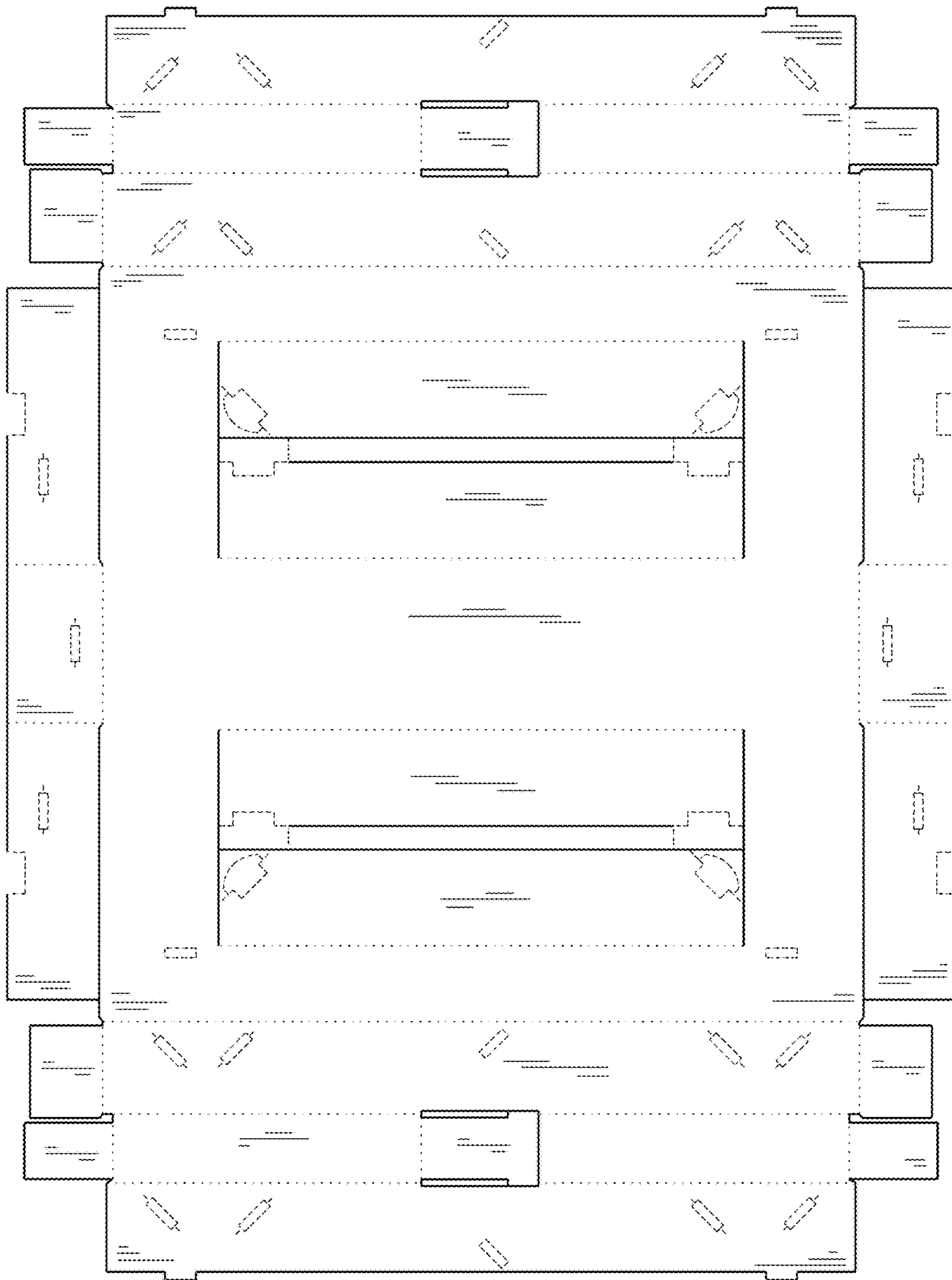

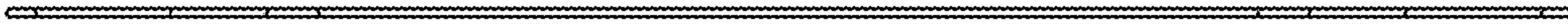

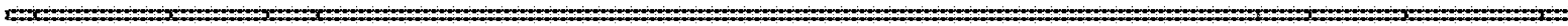

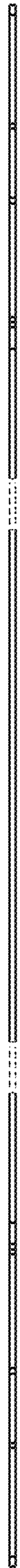

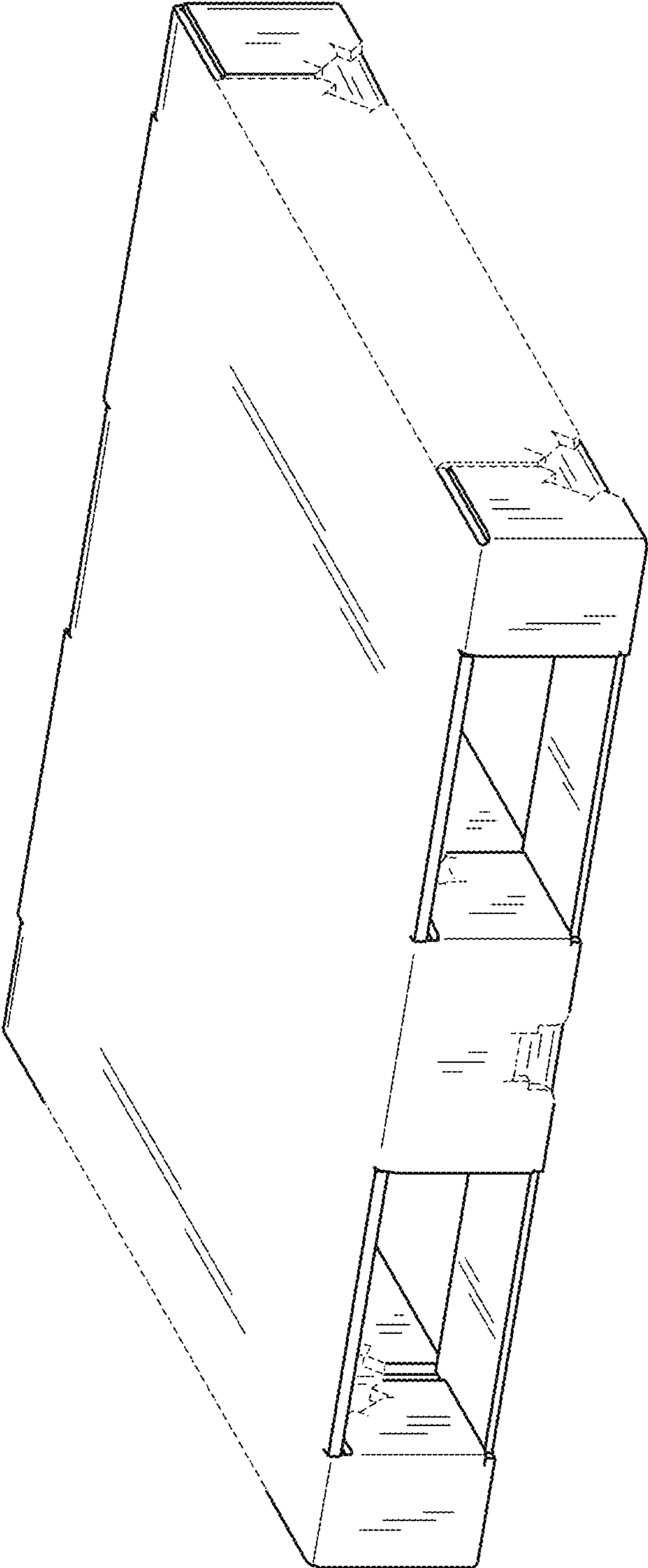

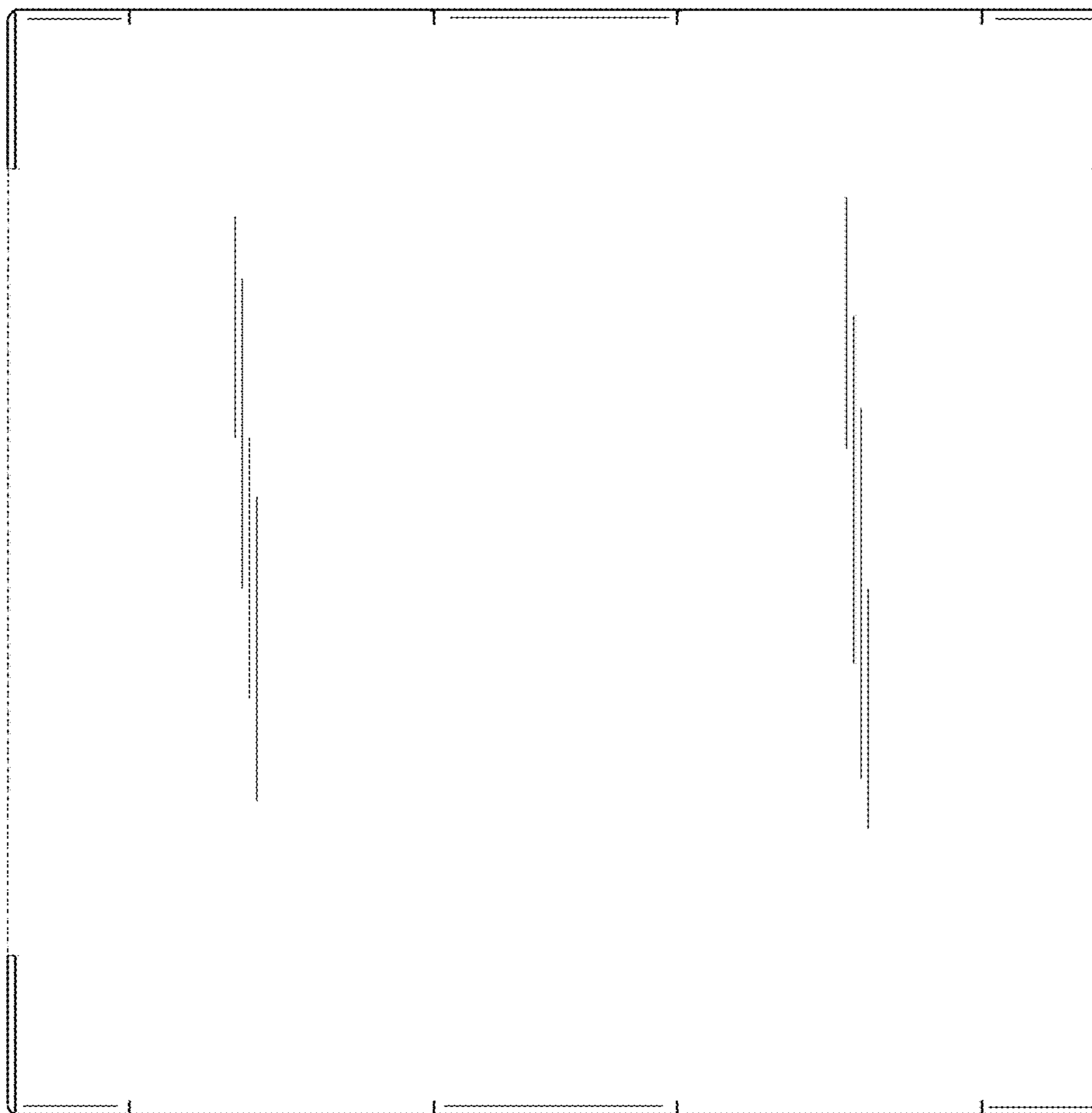

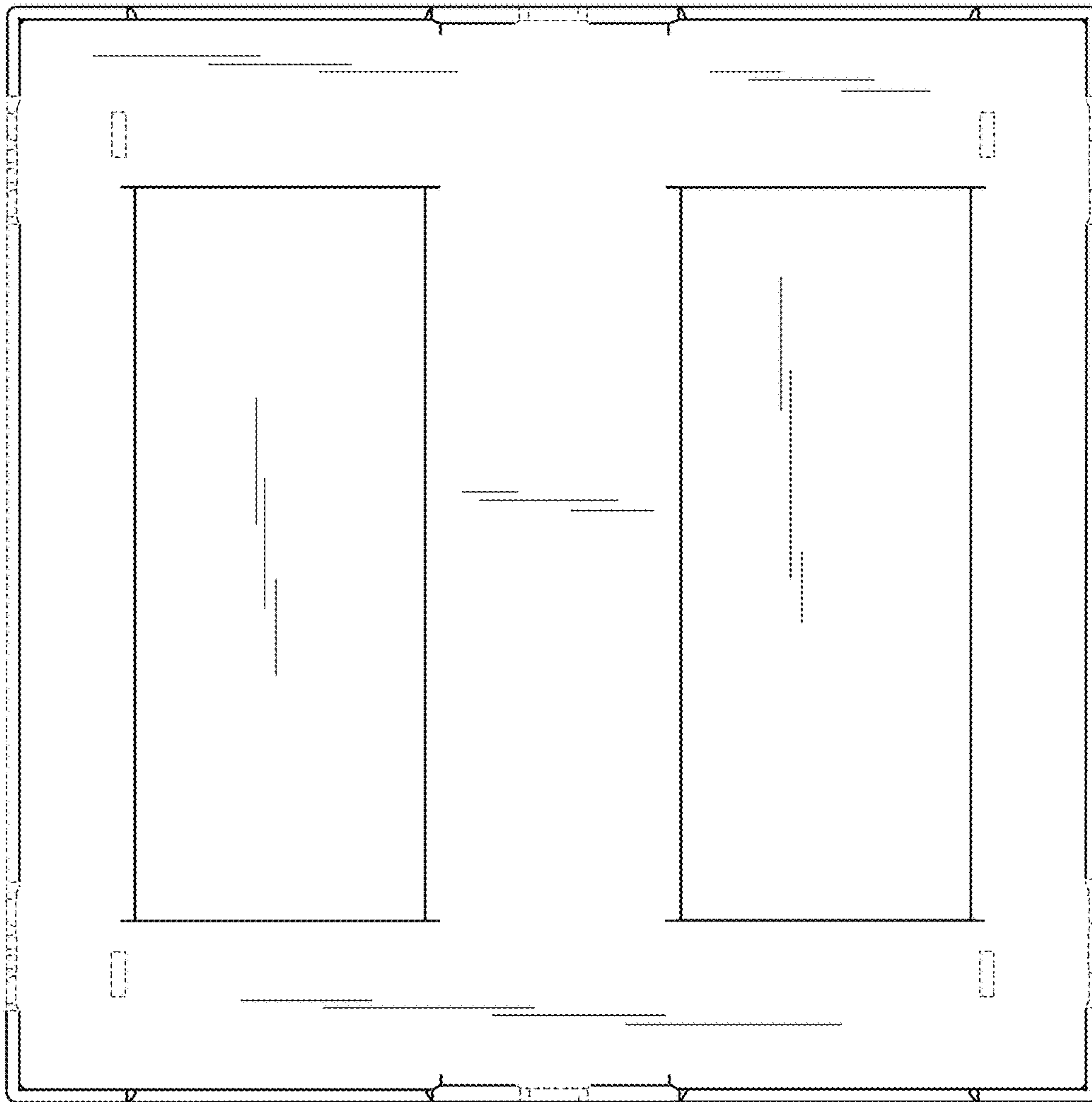

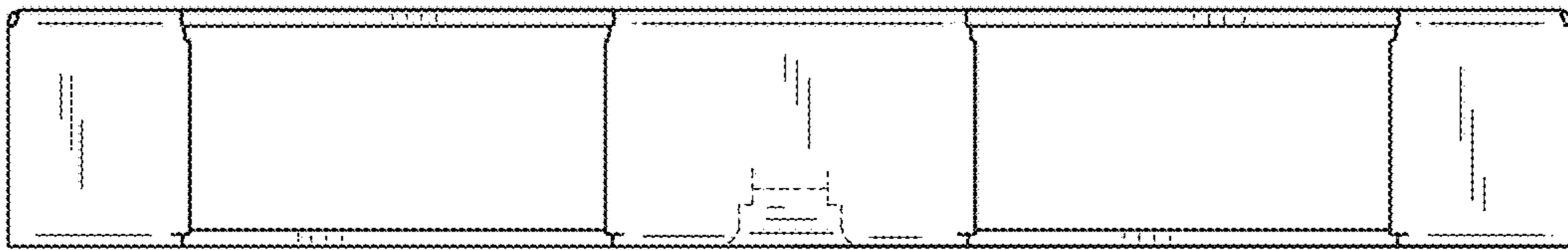

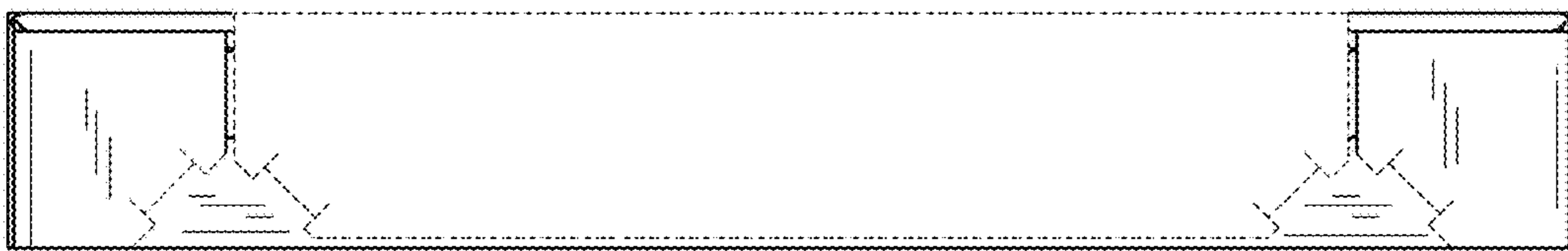

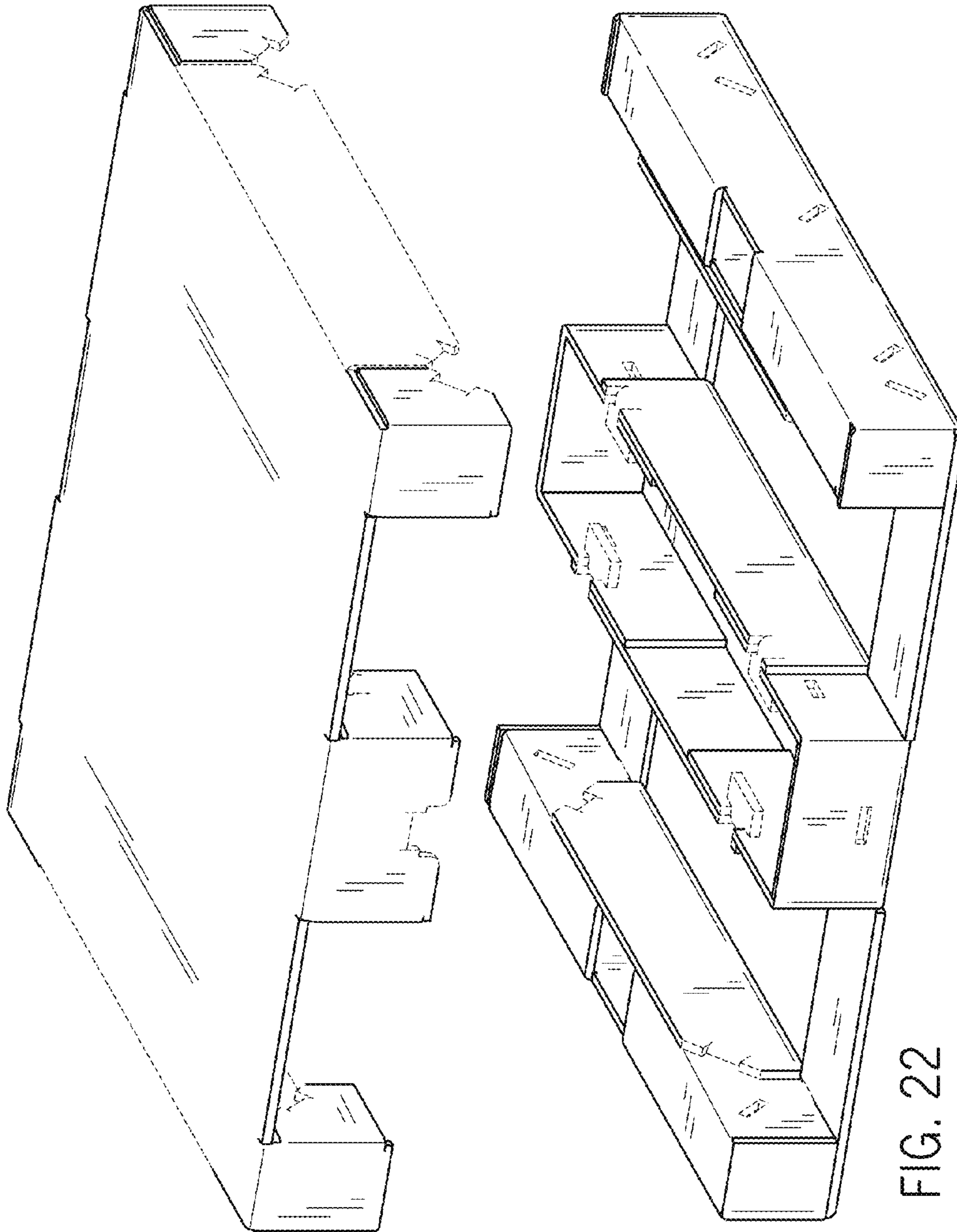
