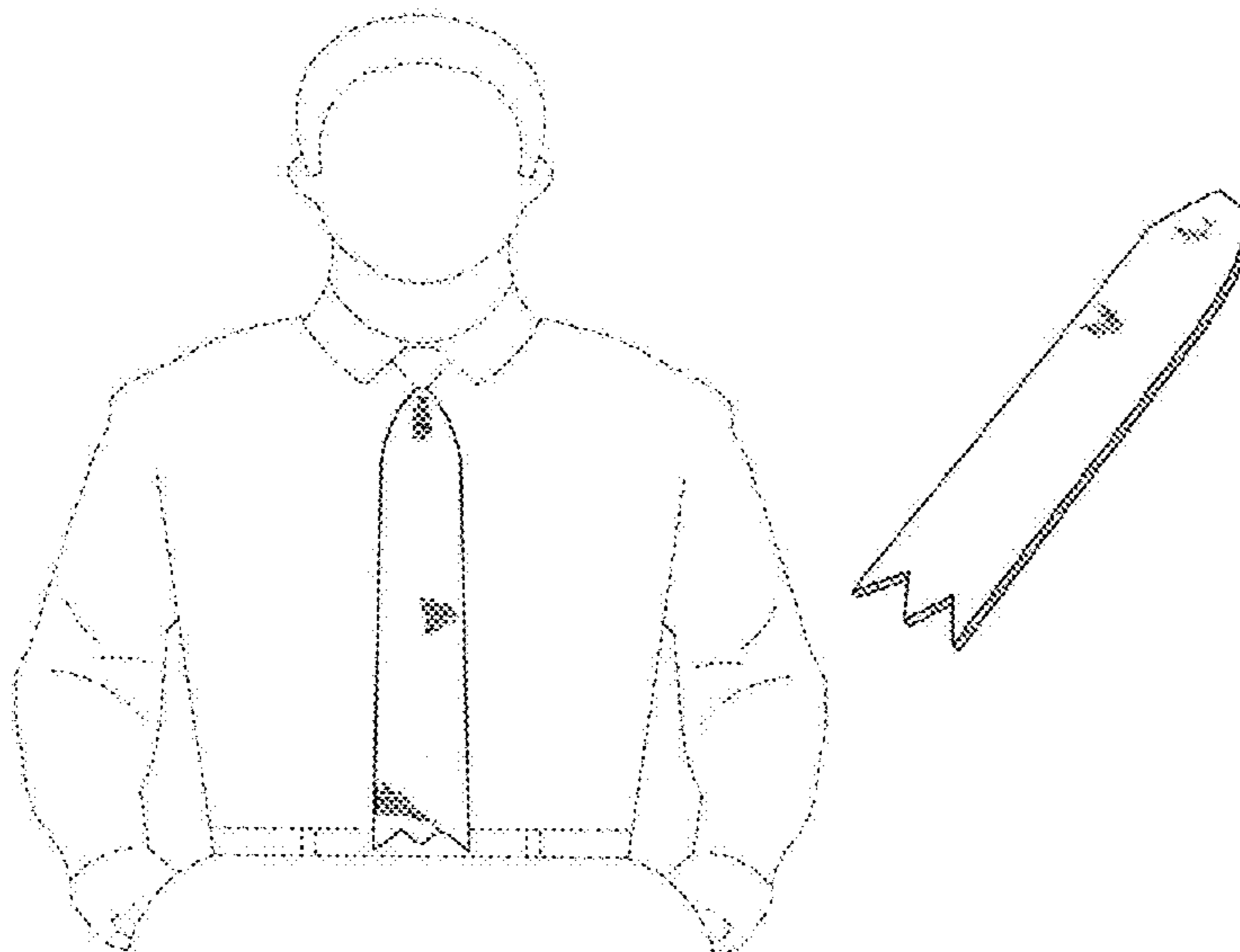
(57) **CLAIM**

A necktie, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the necktie, showing how it may appear when worn;
FIG. 2 is a front perspective view of the necktie;
FIG. 3 is a front elevation view of the necktie, showing how it may appear when not being worn;
FIG. 4 is a rear elevation view of the necktie;
FIG. 5 is a right side elevation view of the necktie;
FIG. 6 is a left side elevation view of the necktie;
FIG. 7 is a bottom plan view of the necktie; and,
FIG. 8 is a top plan view of the necktie.
FIG. 1 includes broken line depictions of a wearer wearing a necktie, which wearer forms no part of the claimed invention.

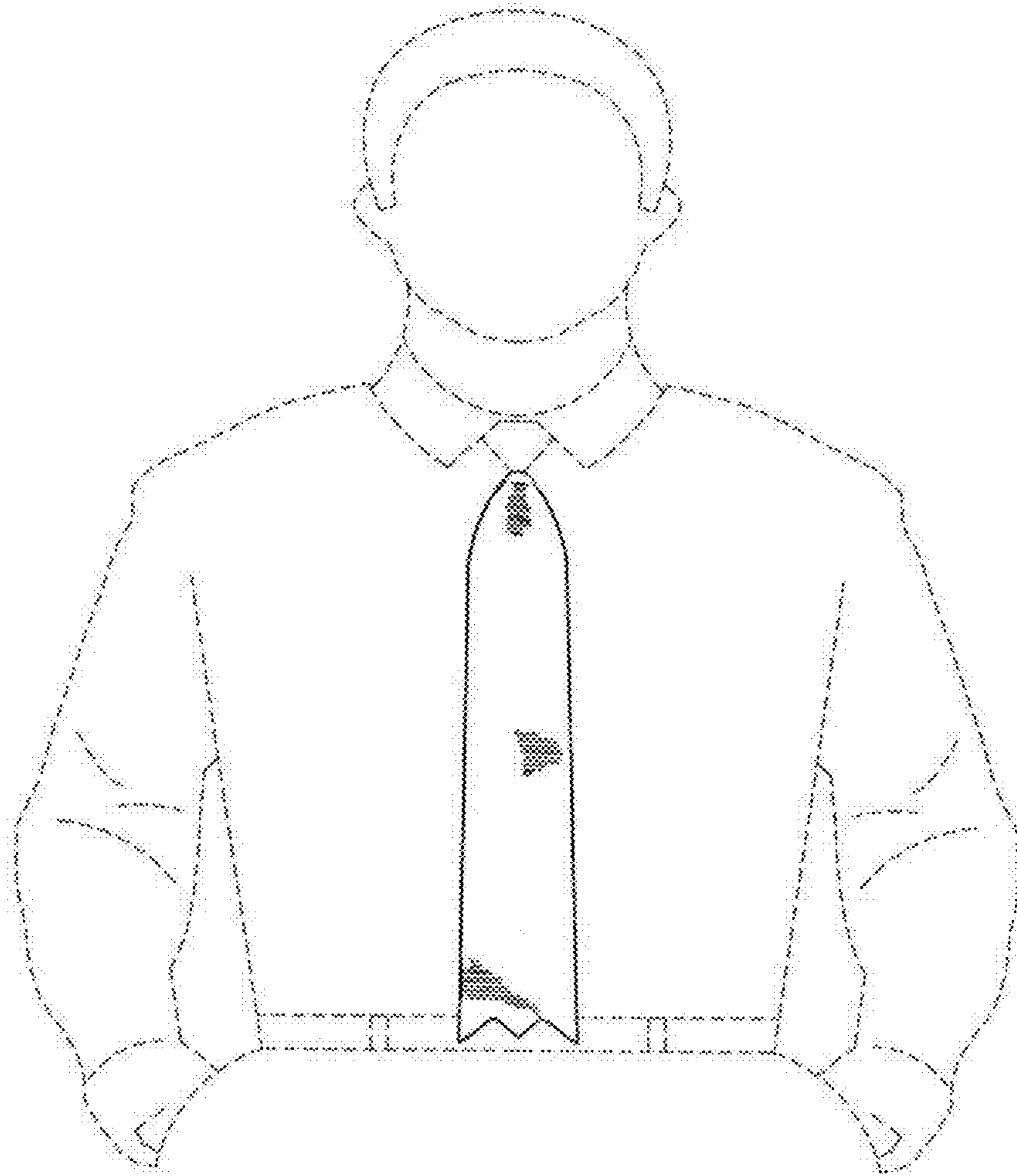

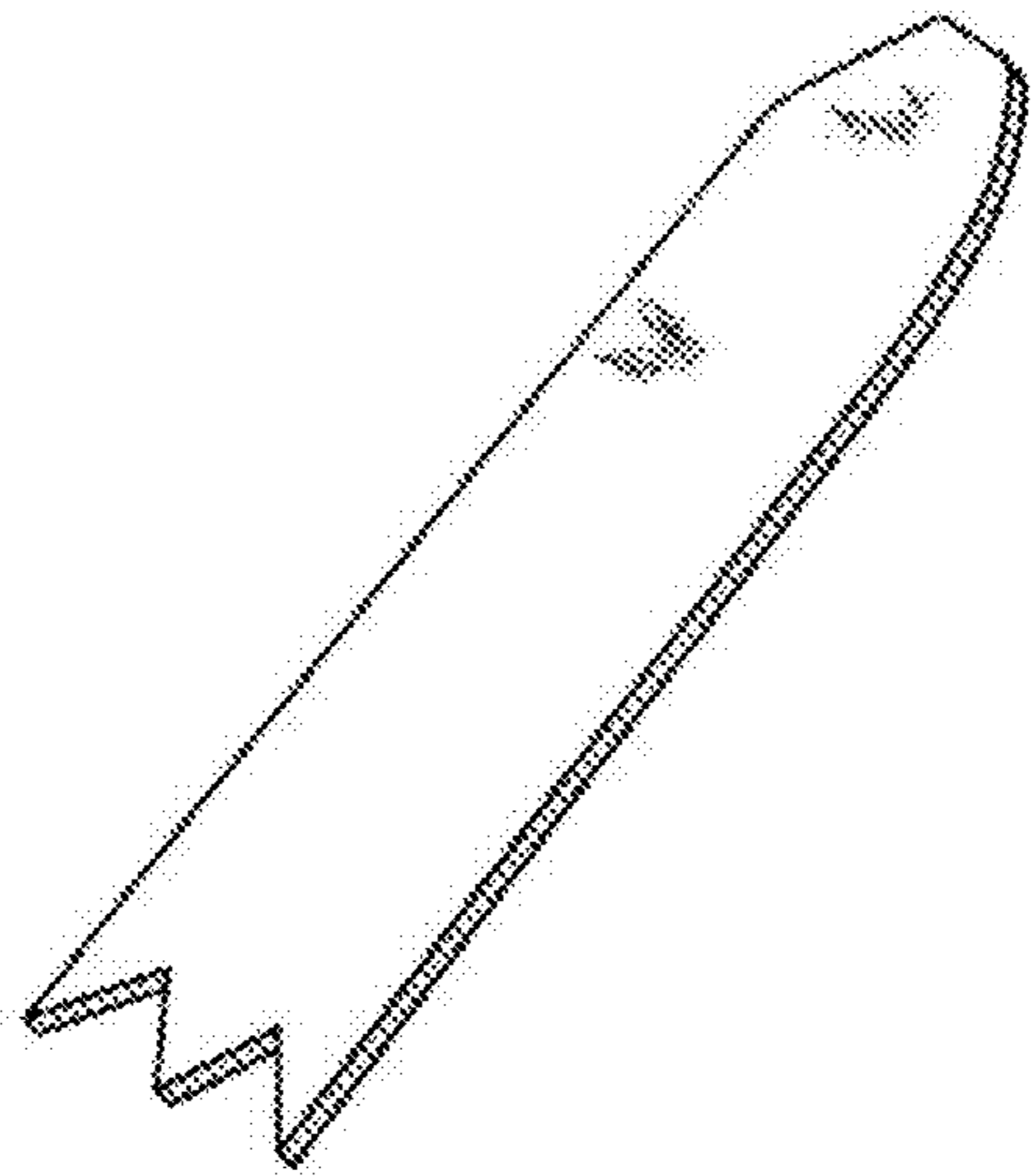

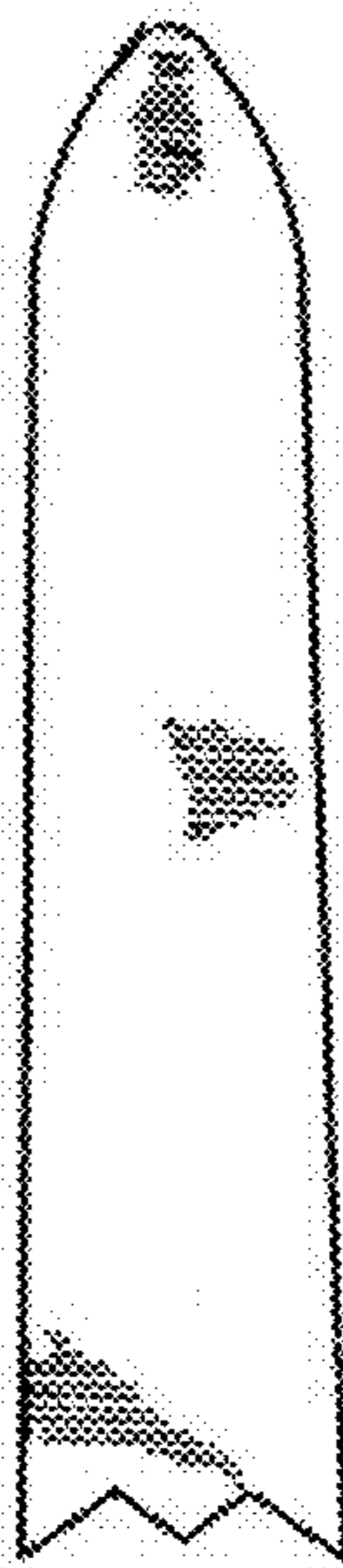

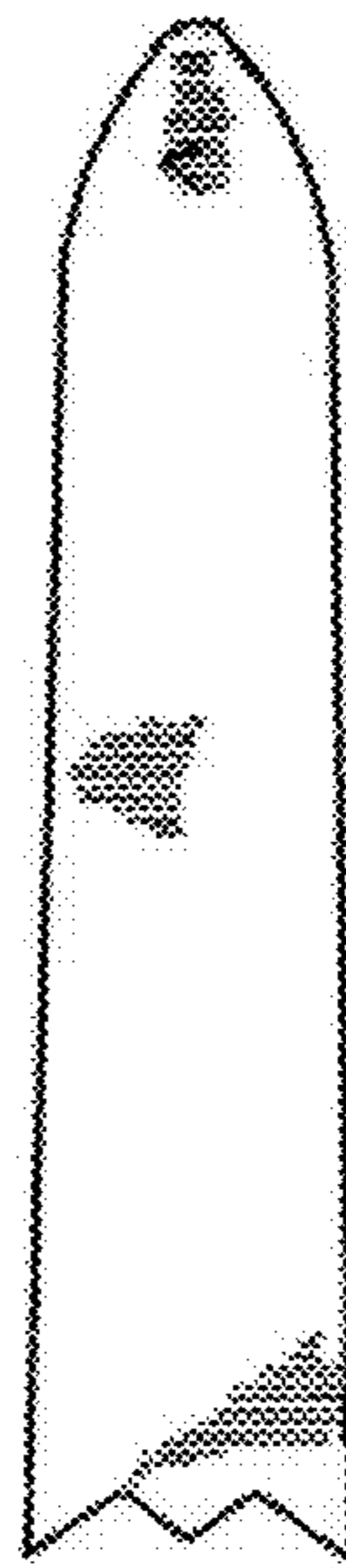

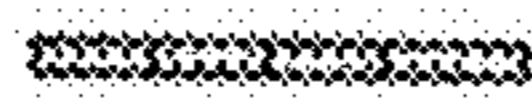

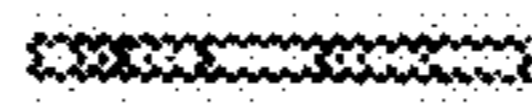
