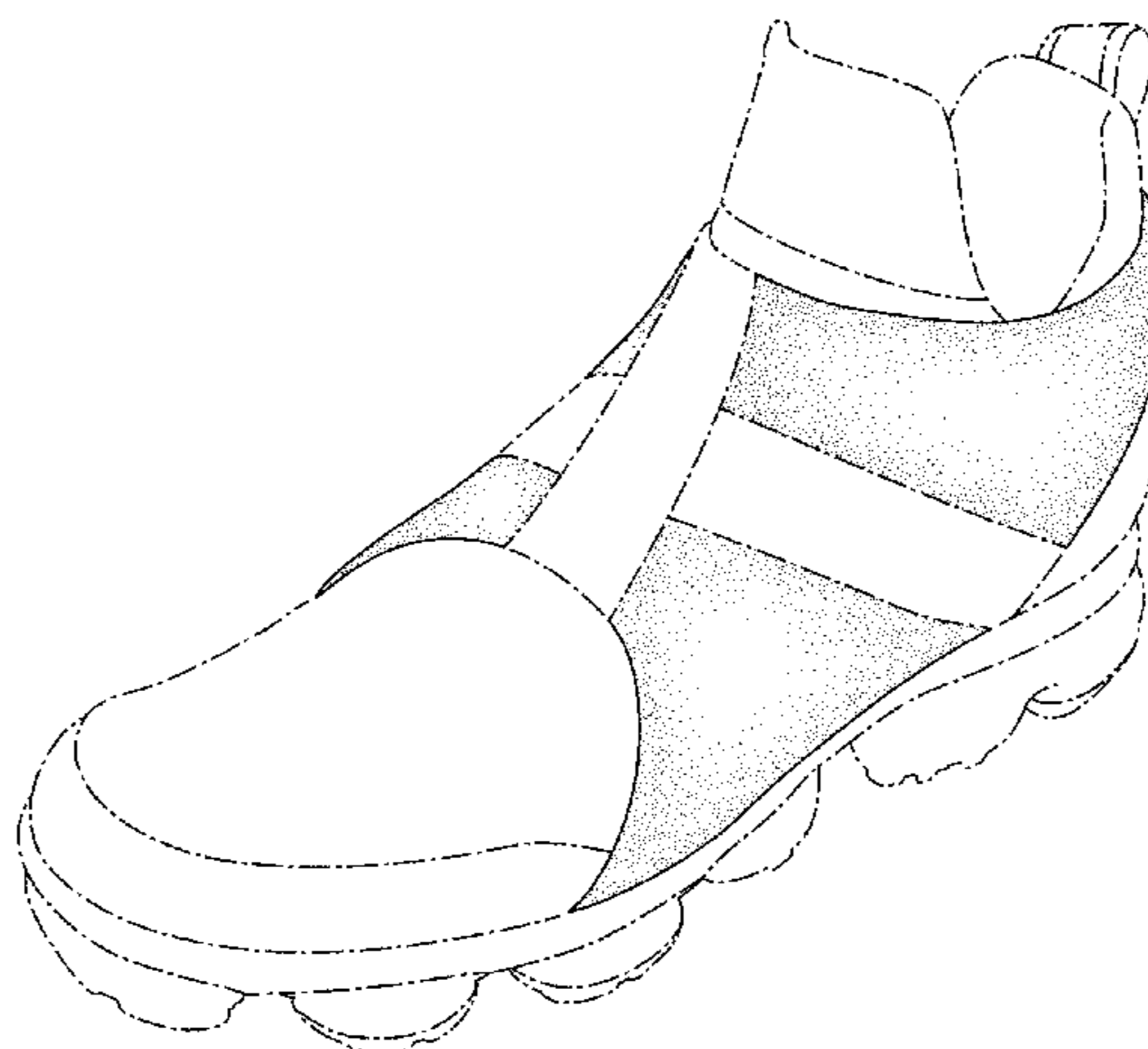
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof; and,
FIG. 4 is a rear side view thereof.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe form no part of the claimed design.

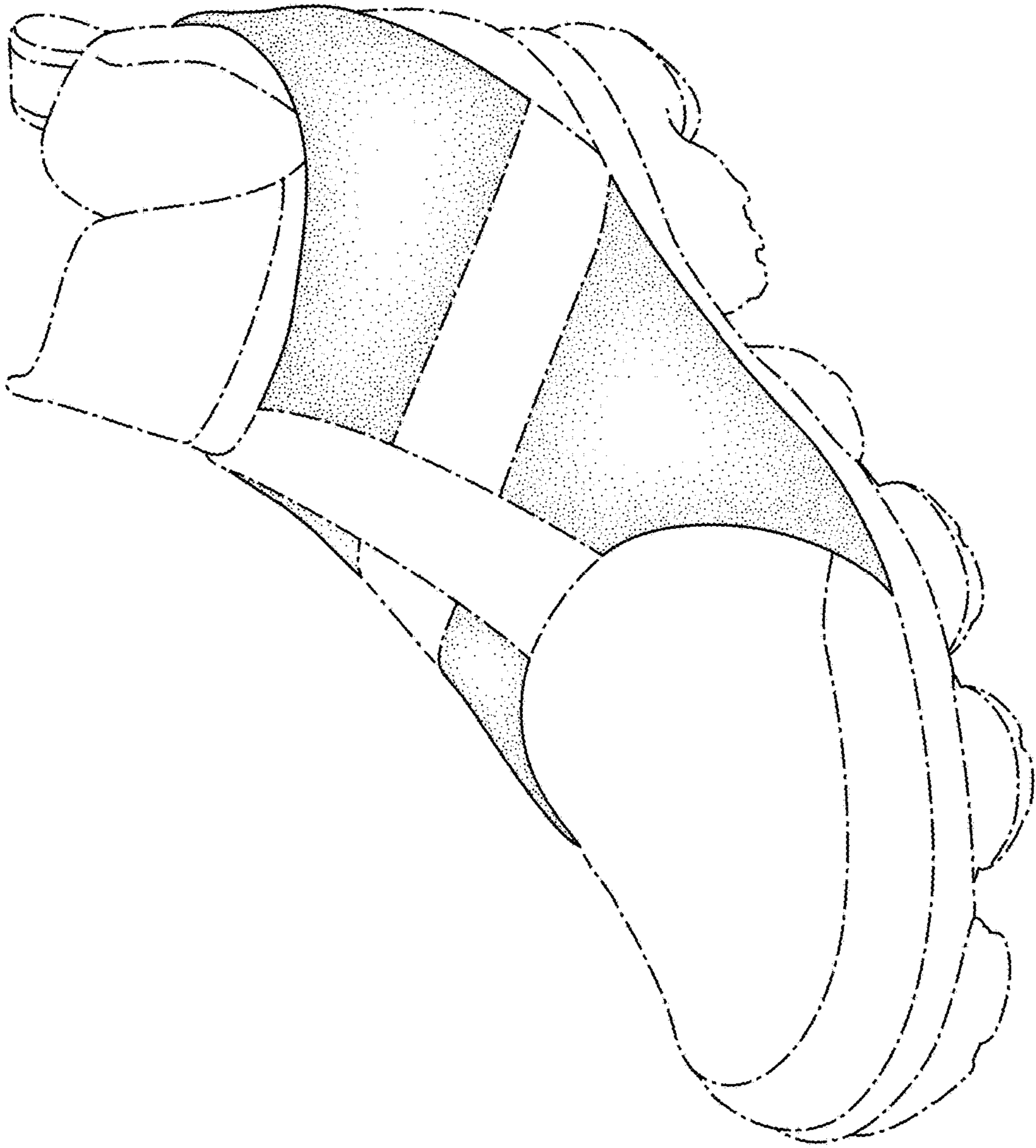

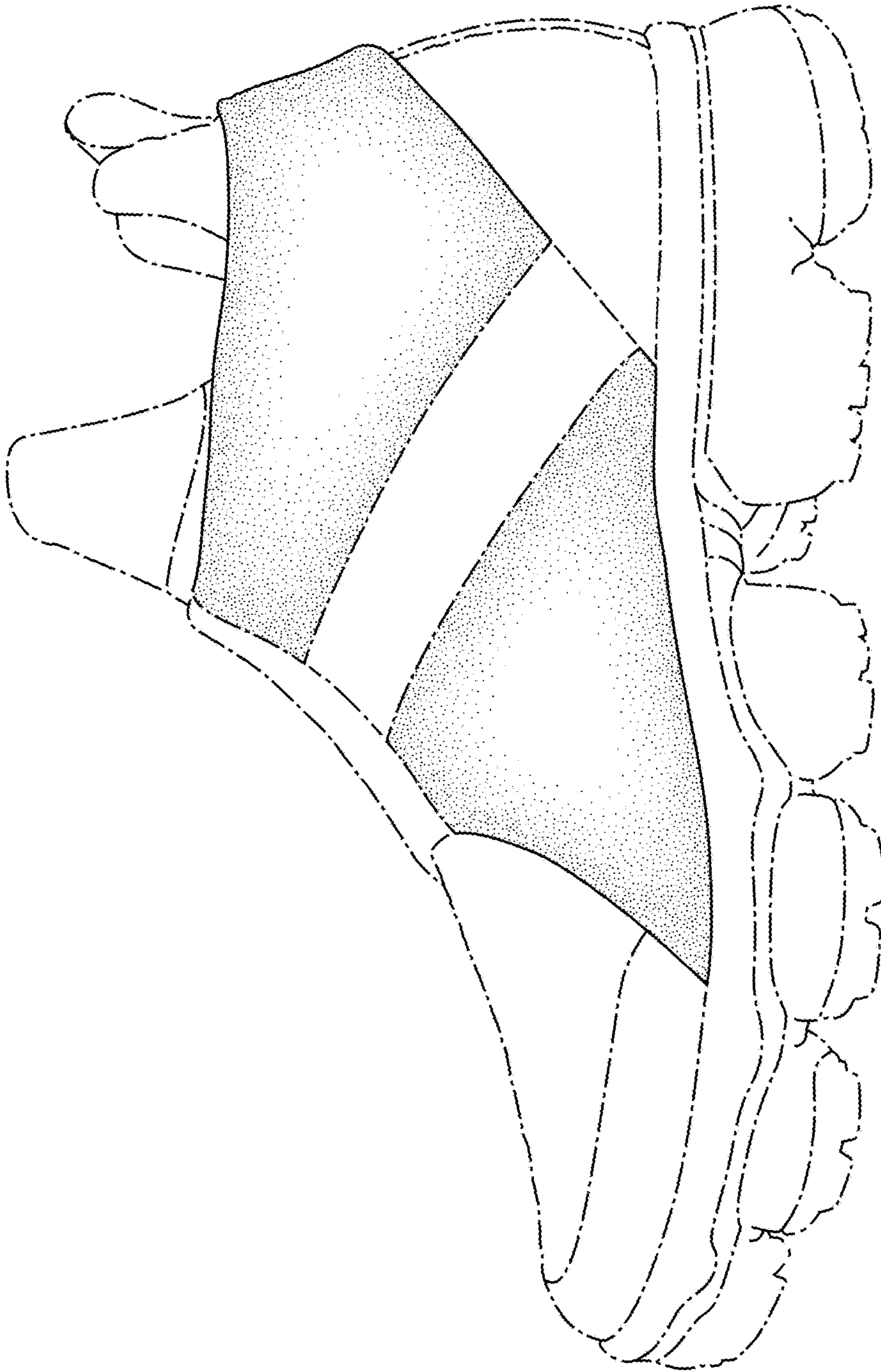

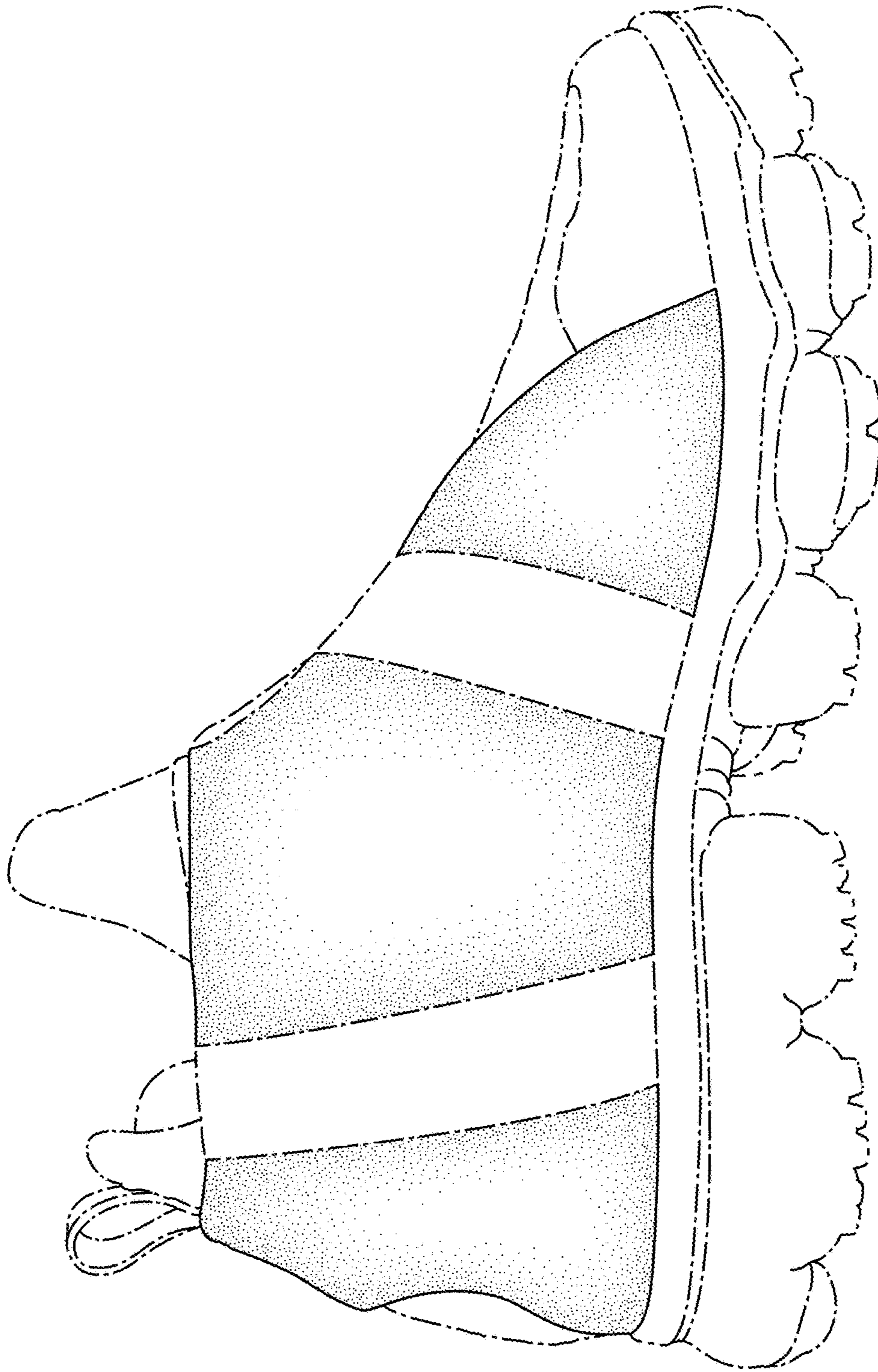

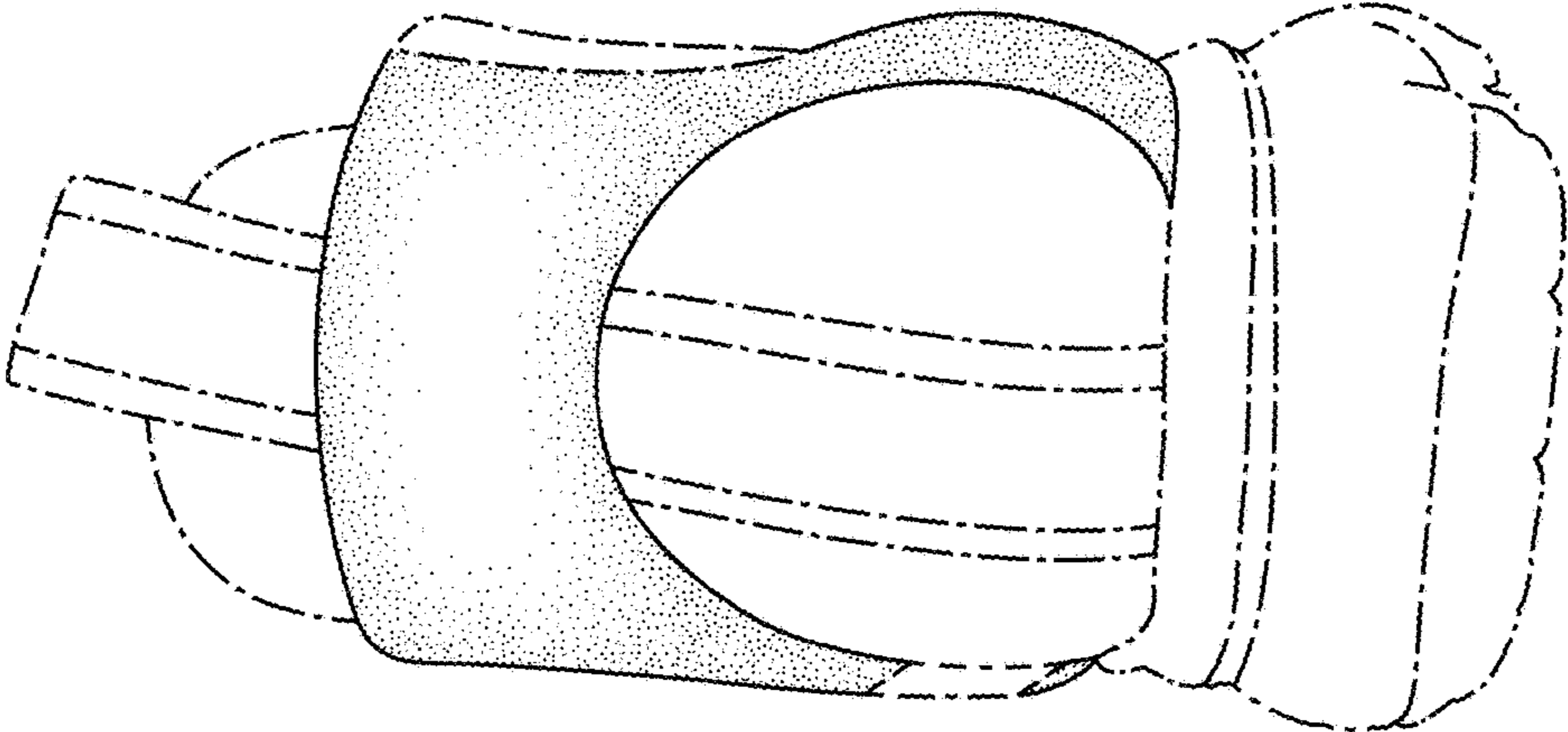
