FIG. 1 is a bottom view of a shoe outsole showing our new design;

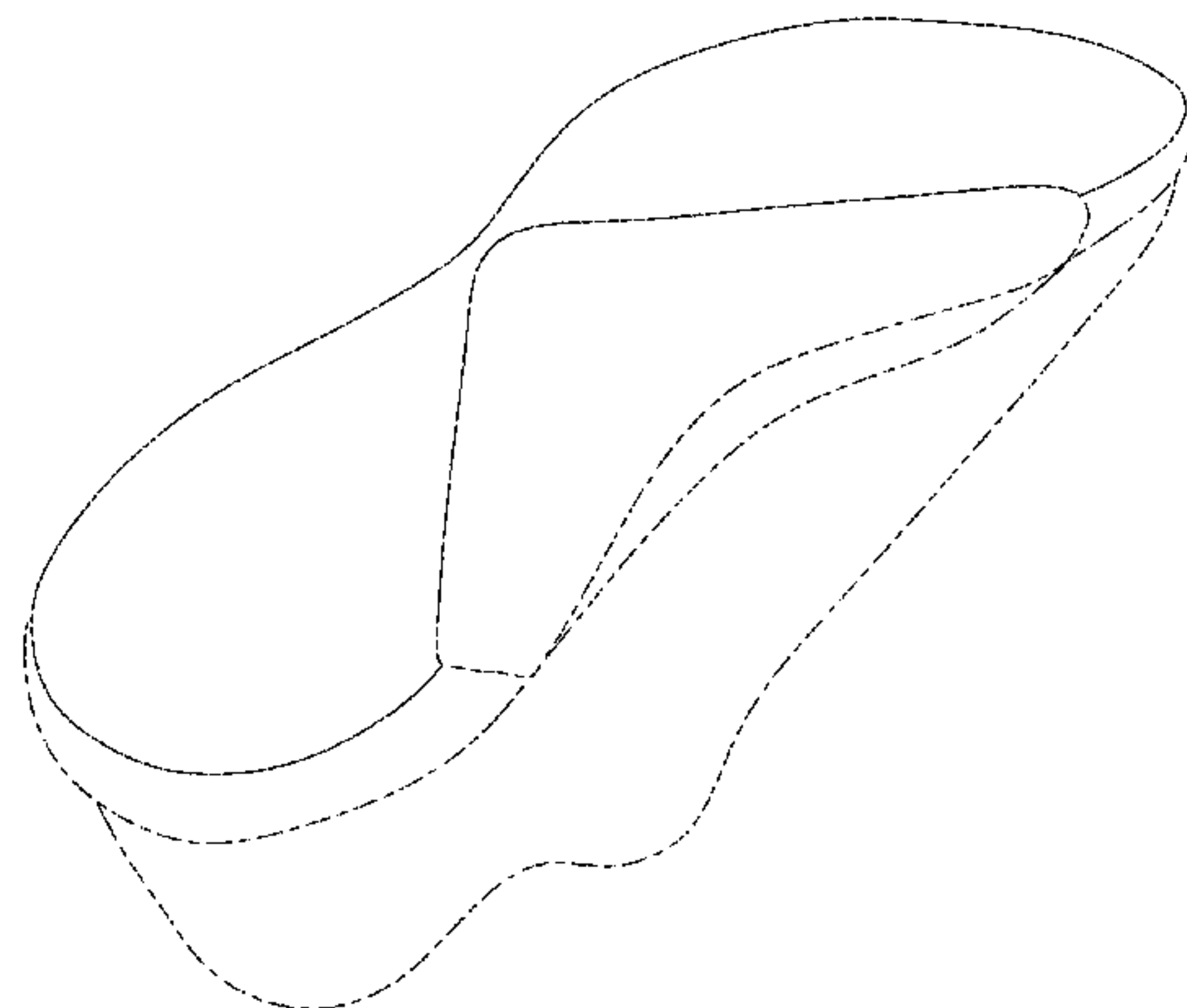
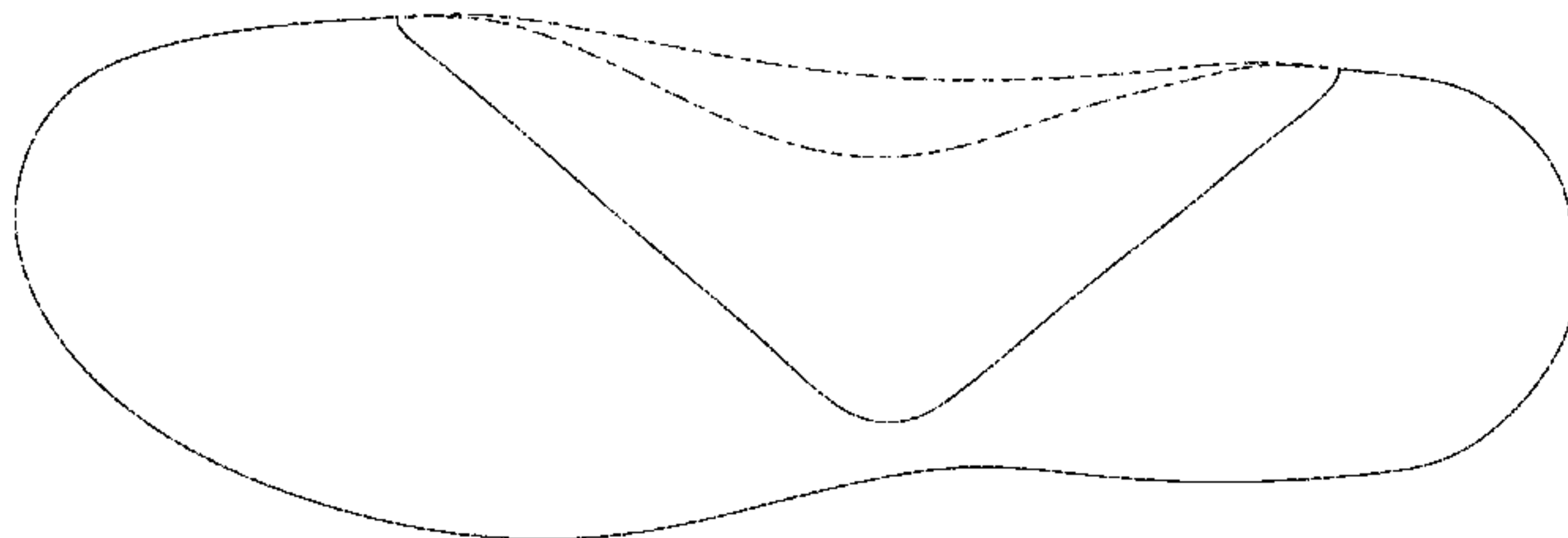
FIG. 2 is a rear perspective view thereof;

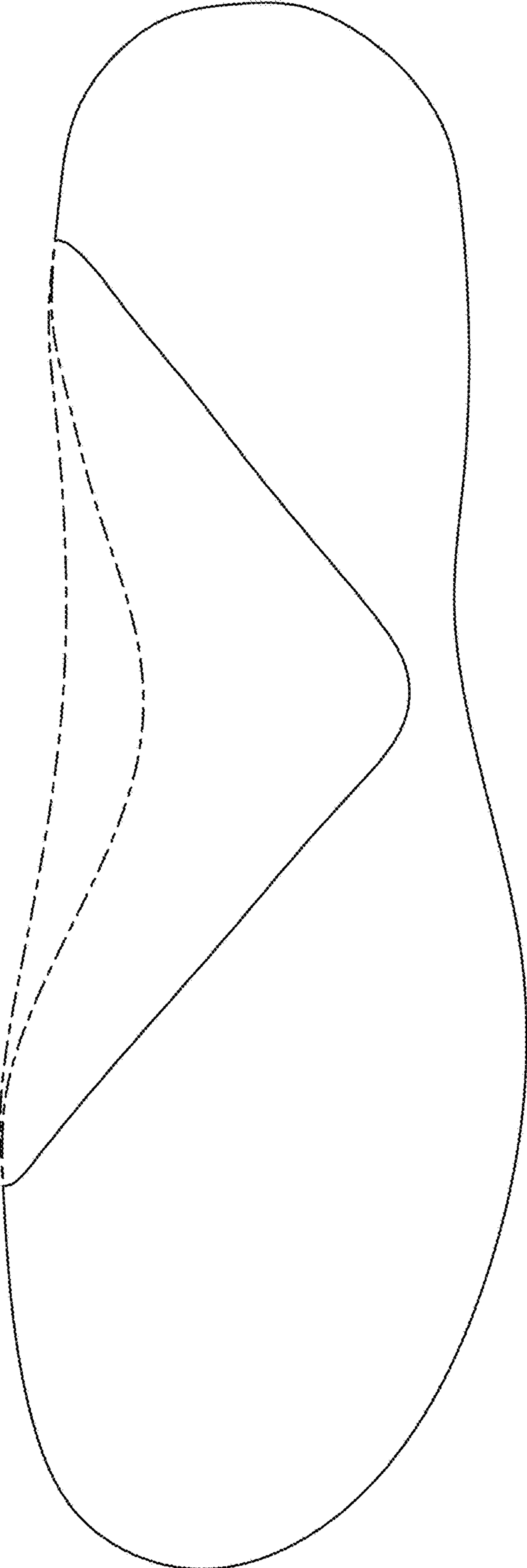

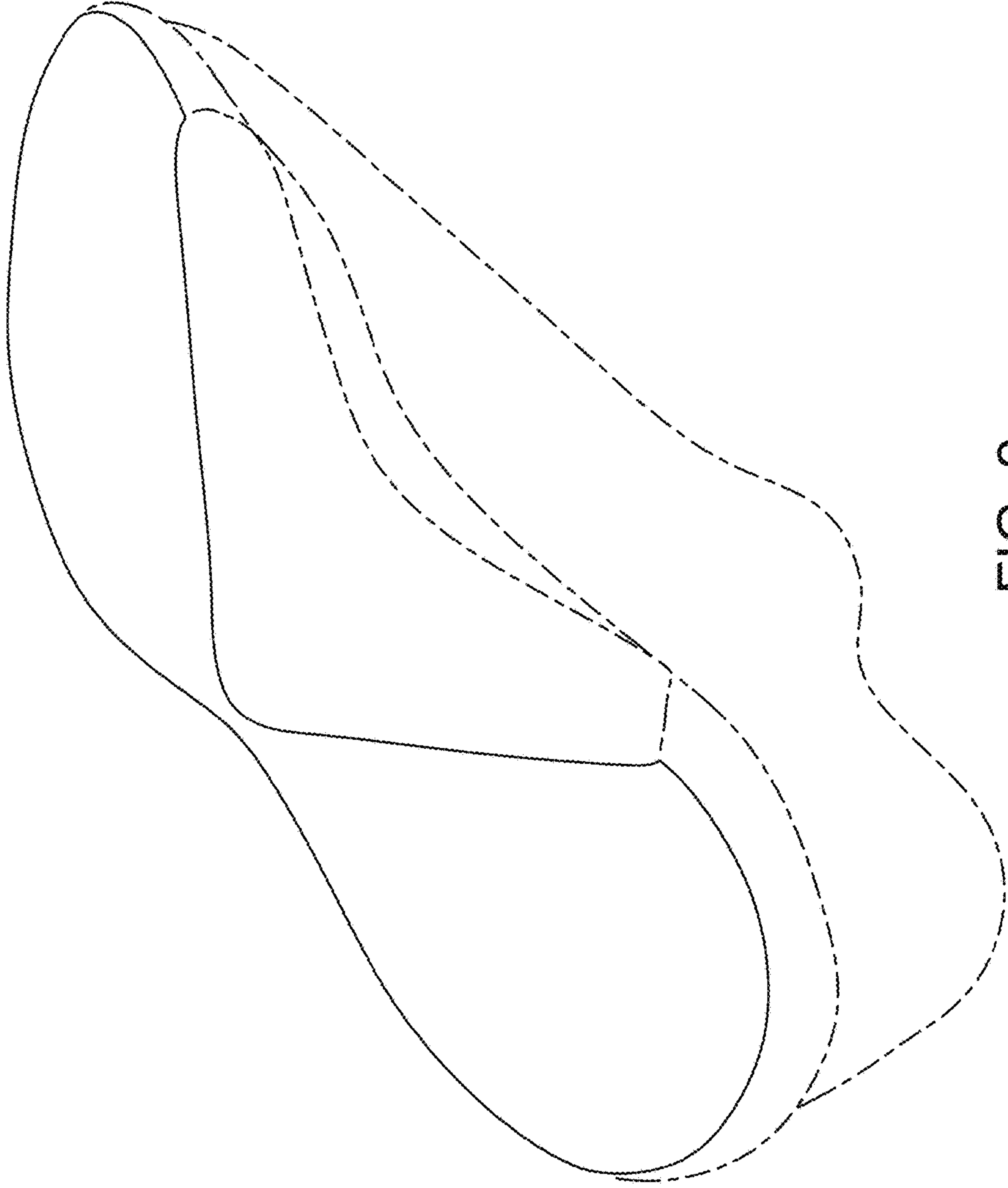

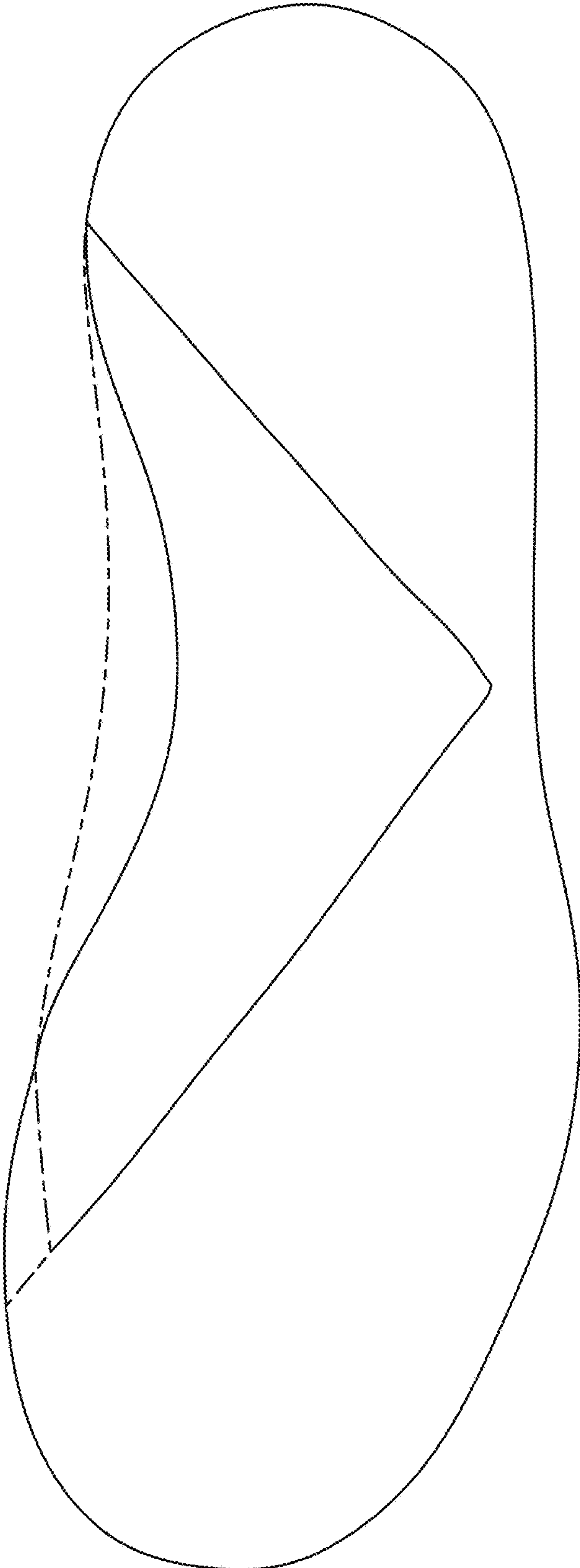

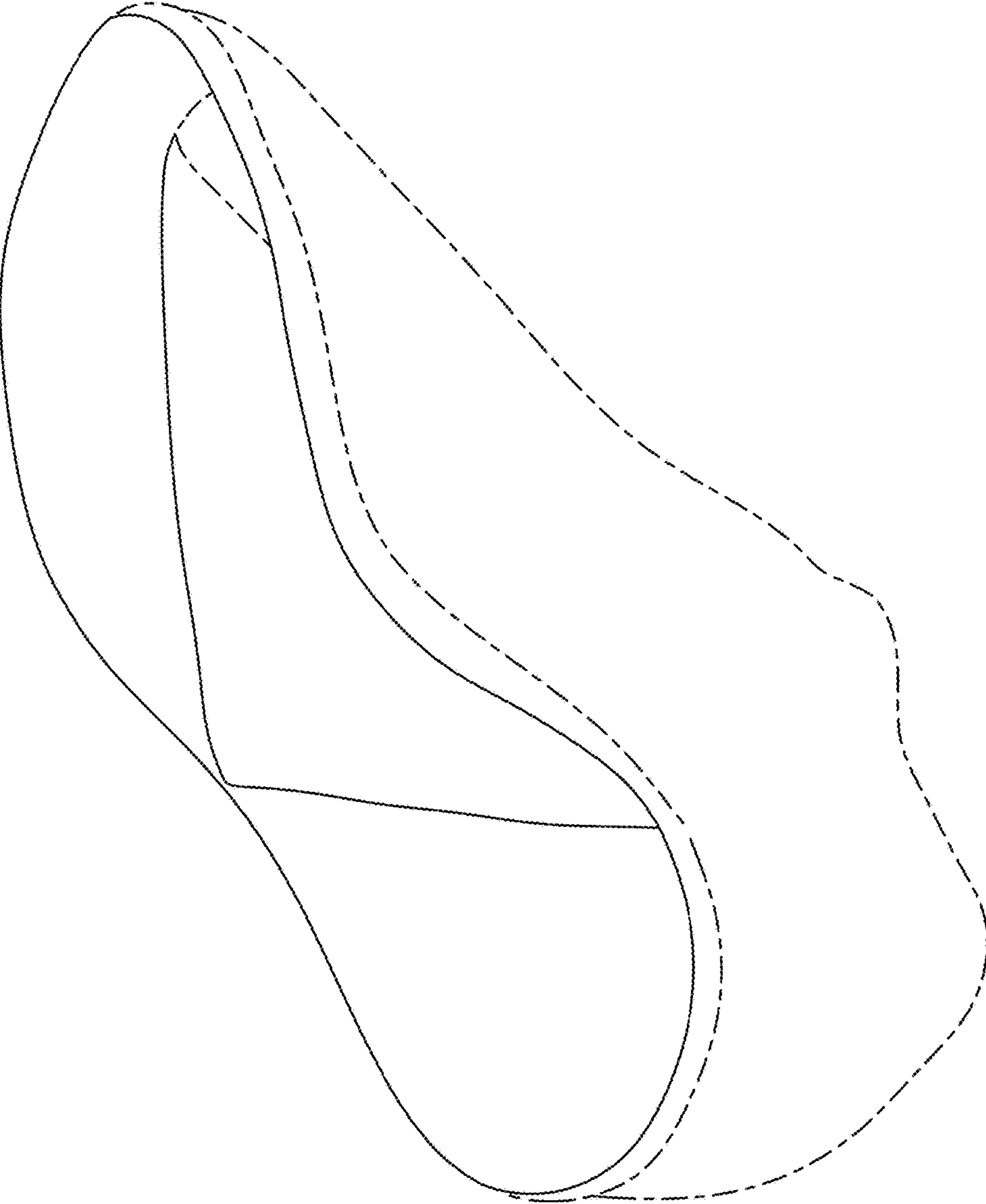
