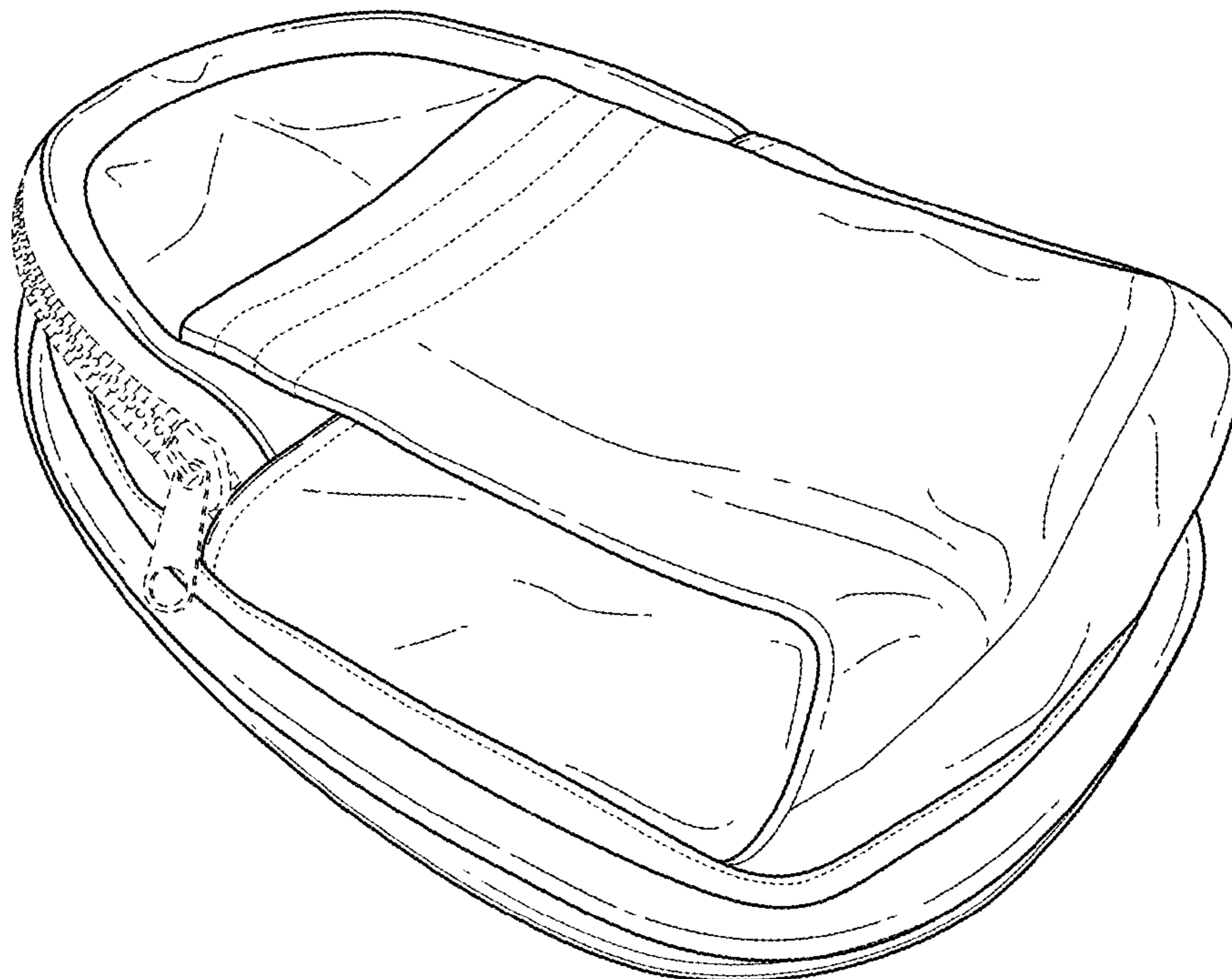
(57) **CLAIM**

The ornamental design for a sling pouch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, side and bottom perspective view of a sling pouch;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a left side view of the sling pouch showing the flexible nature of the rear pad providing an aperture between the pad and pouch portion of the sling pouch;  
FIG. 9 is an environmental view of the sling pouch when attached to a sling; and,  
FIG. 10 is a top view of the sling pouch in a squeezed configuration thereby creating an aperture between the front pouch and rear flap to allow attachment to a sling as shown in FIG. 9.  
The broken lines depict environmental structure that are for illustrative purposes only and form no part of the claimed design.

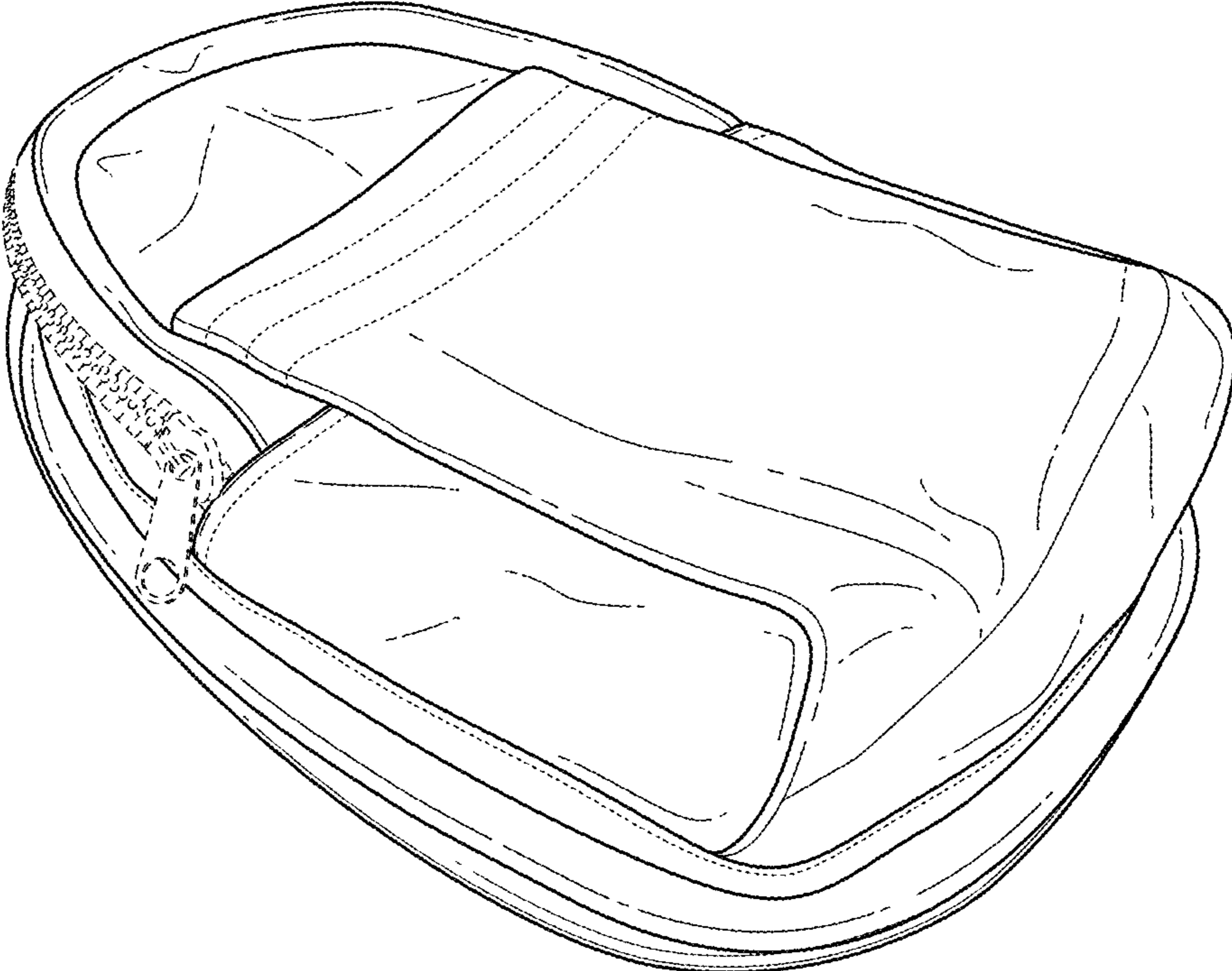

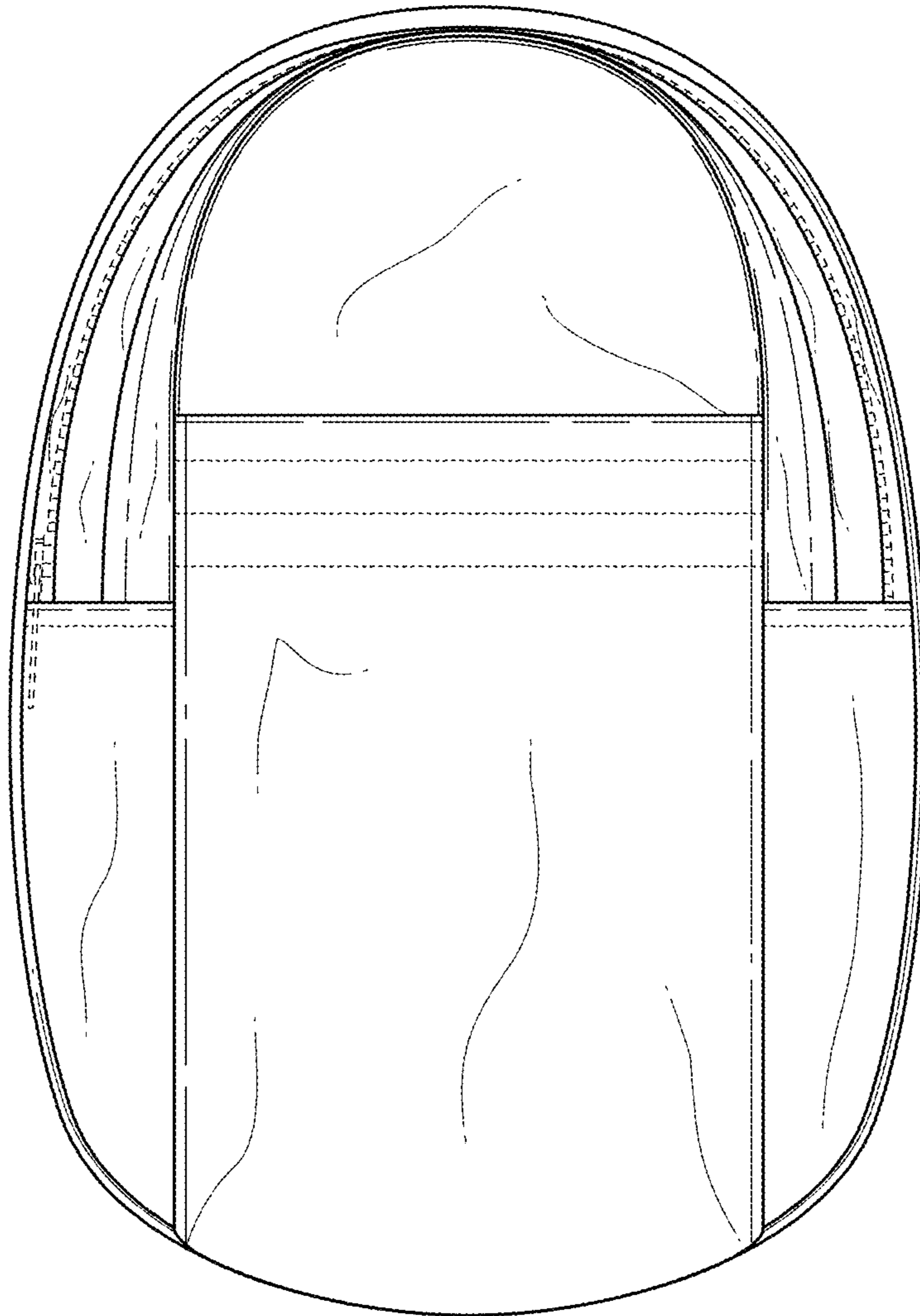

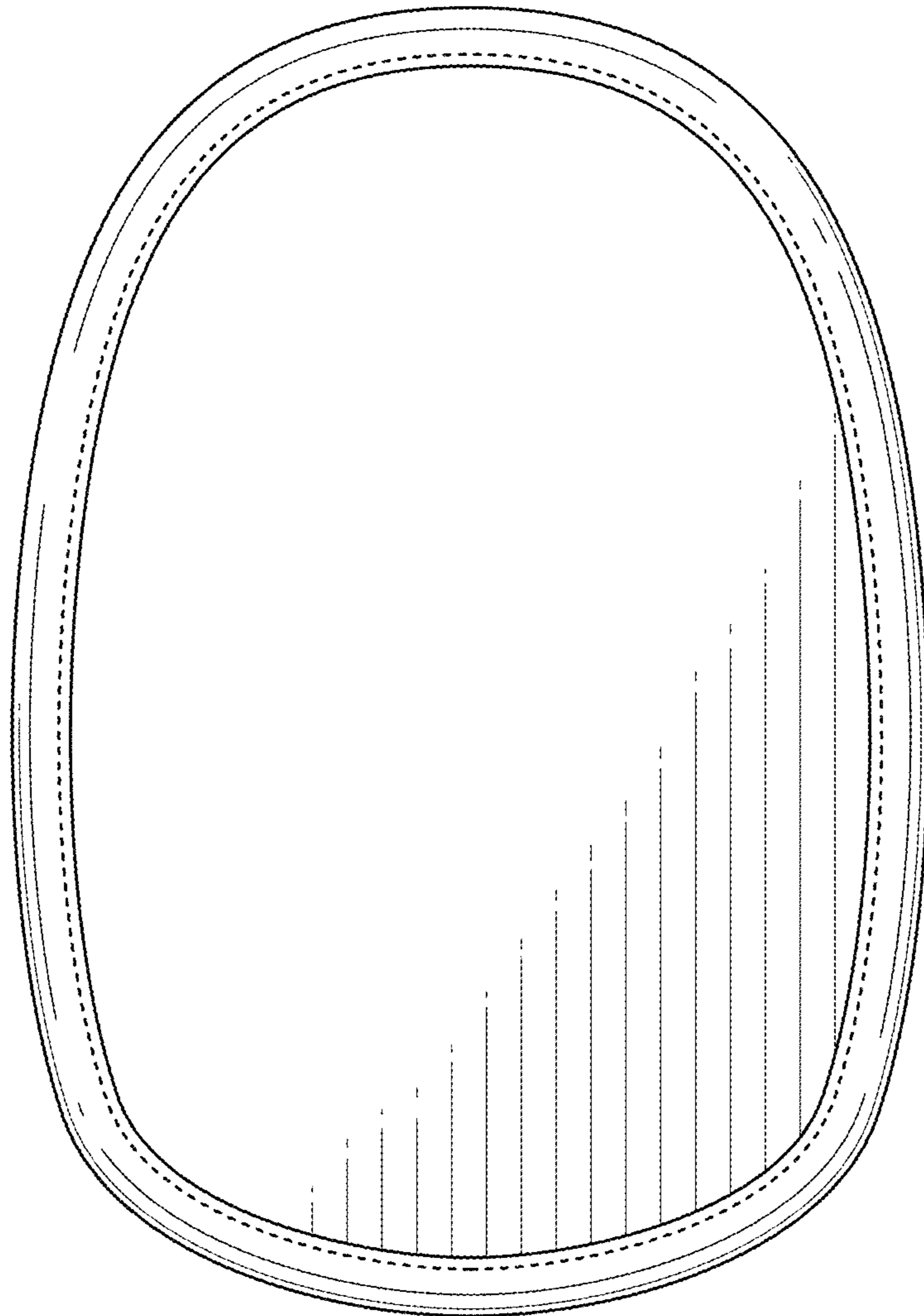

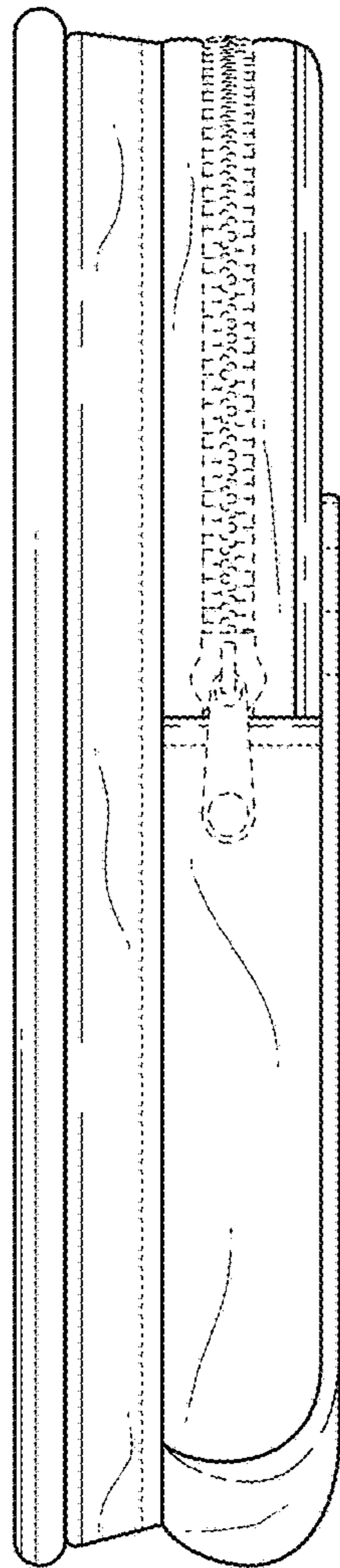

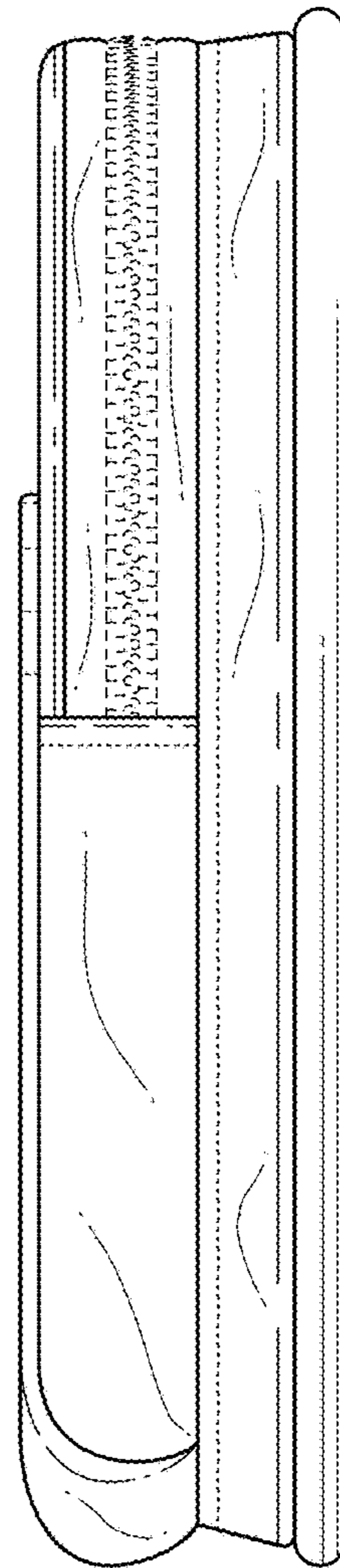

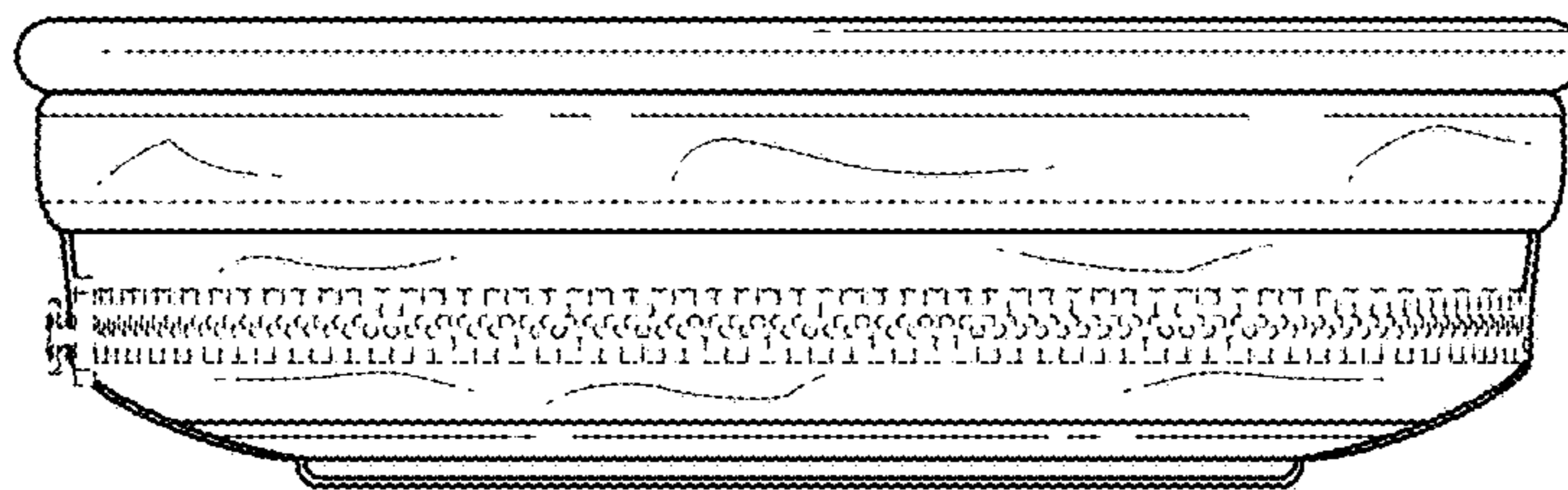

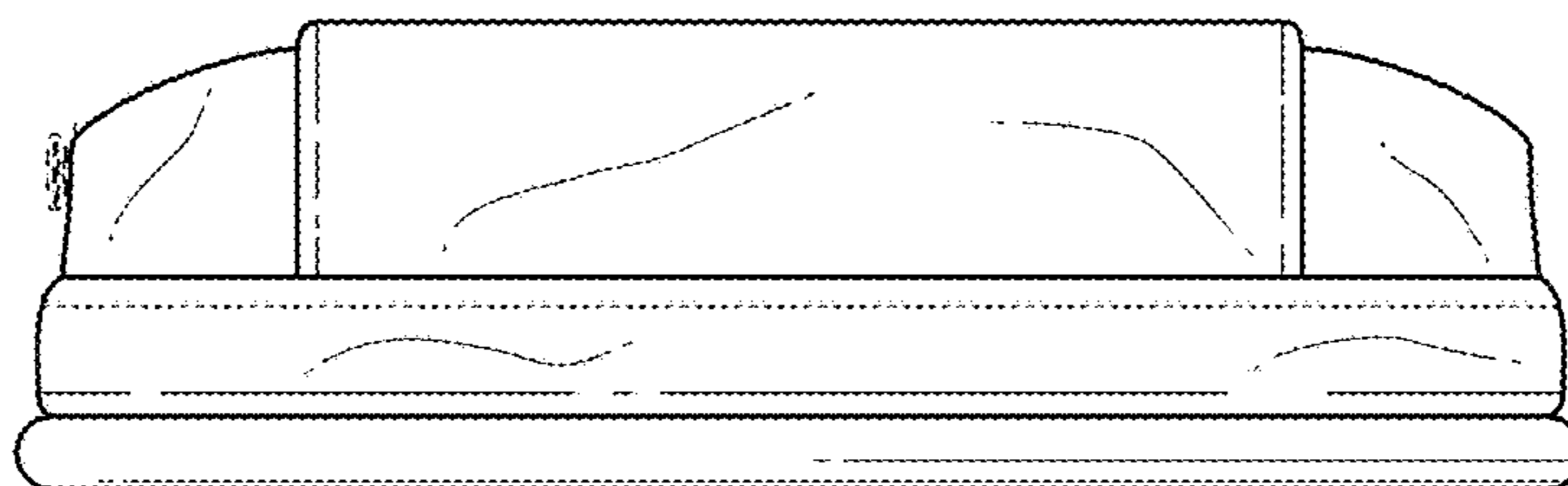

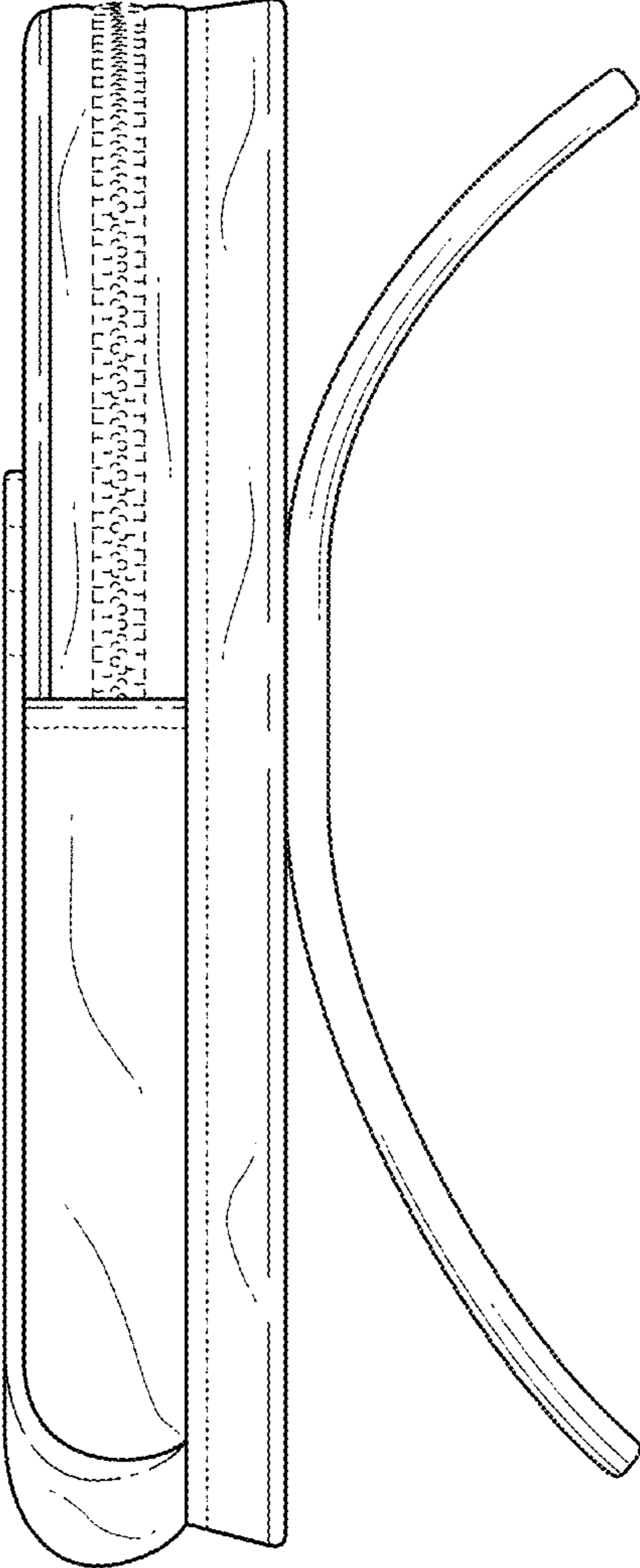

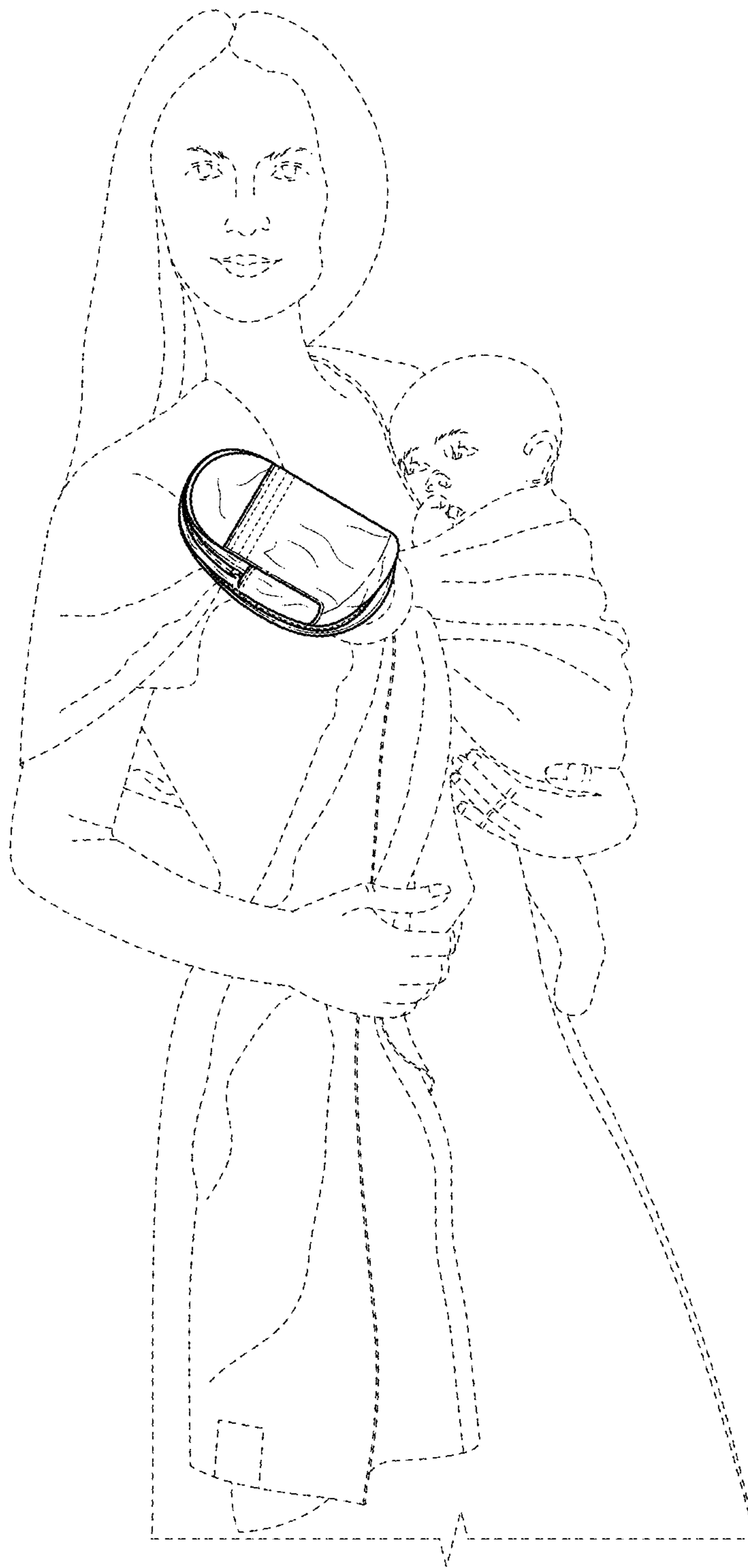

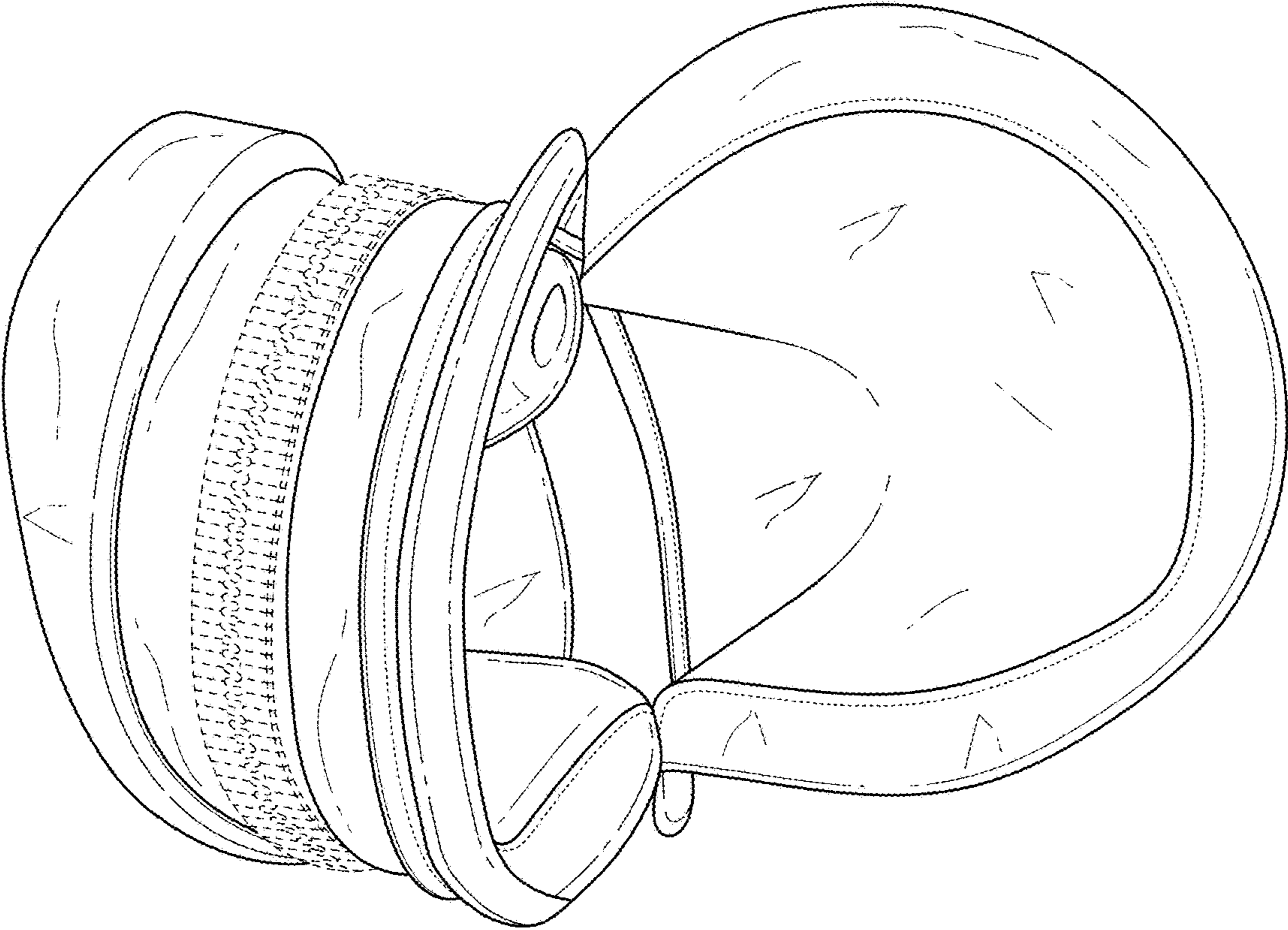
