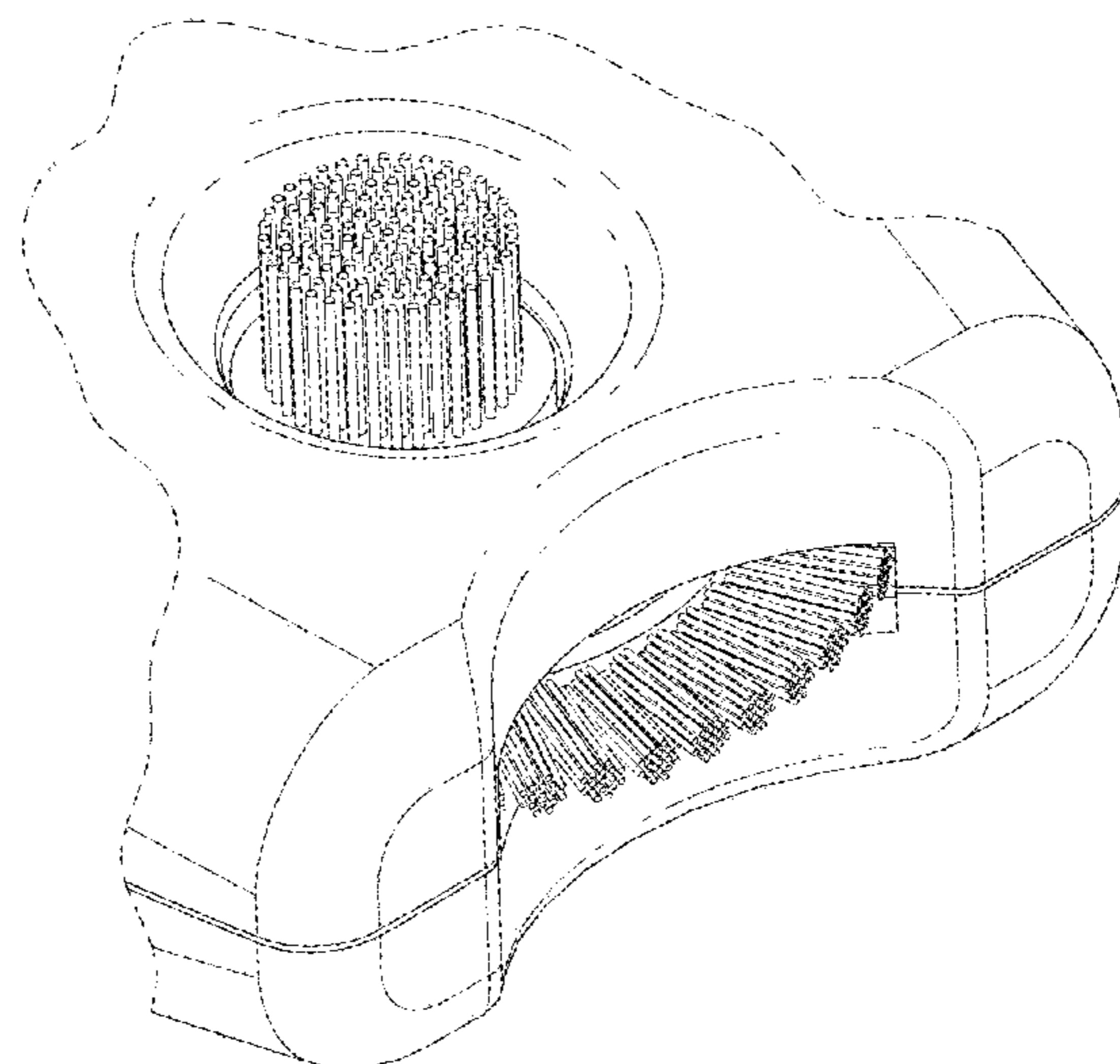
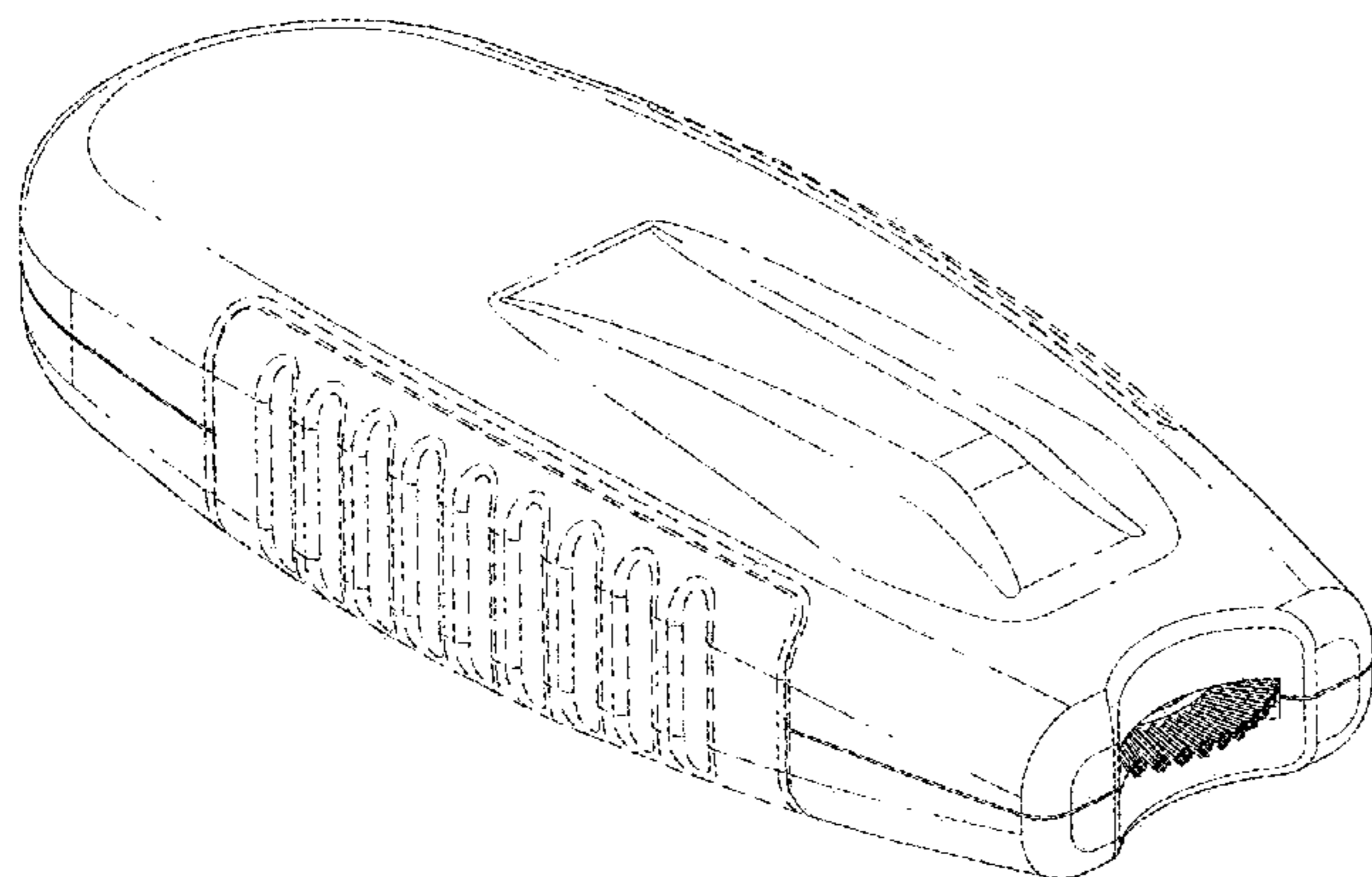
The ornamental design for a nail brush, as shown and described.

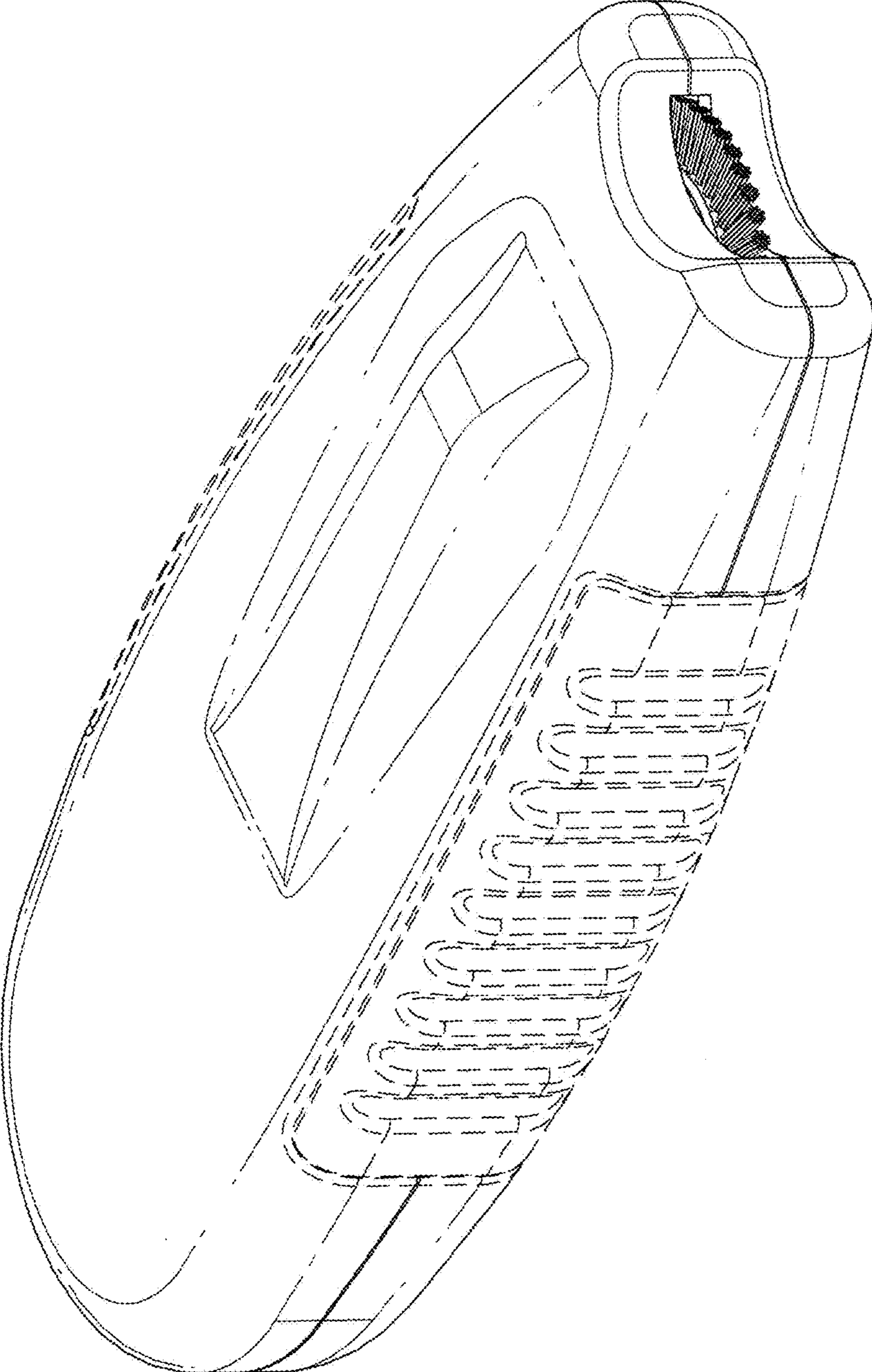

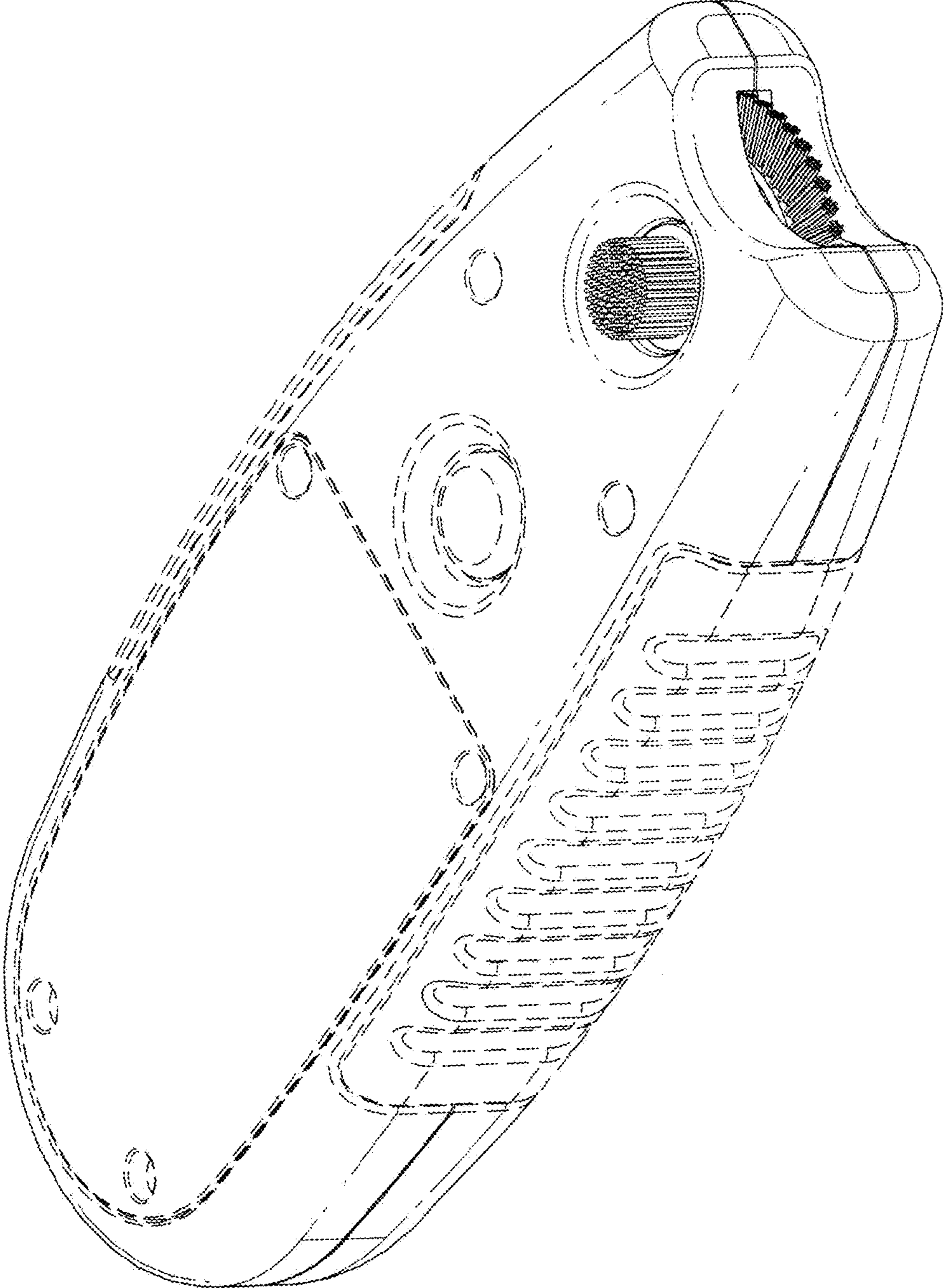

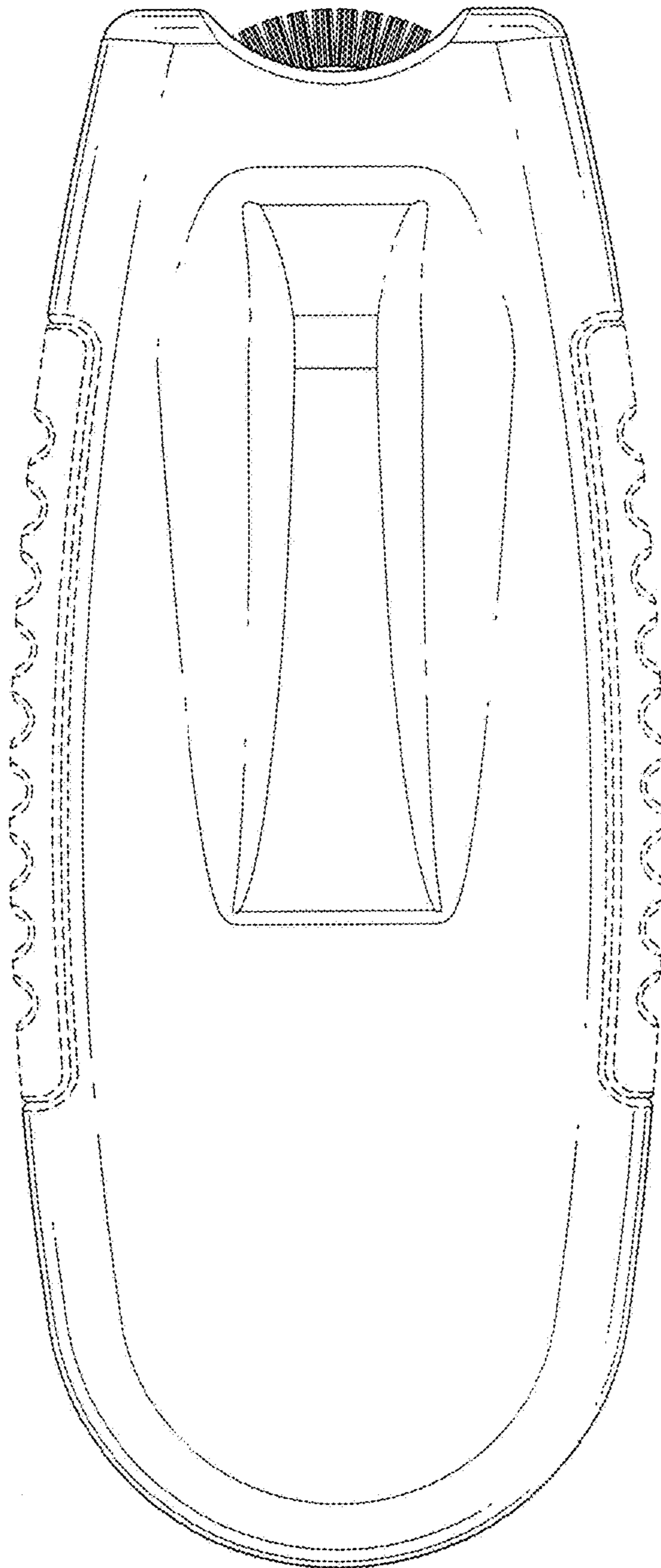

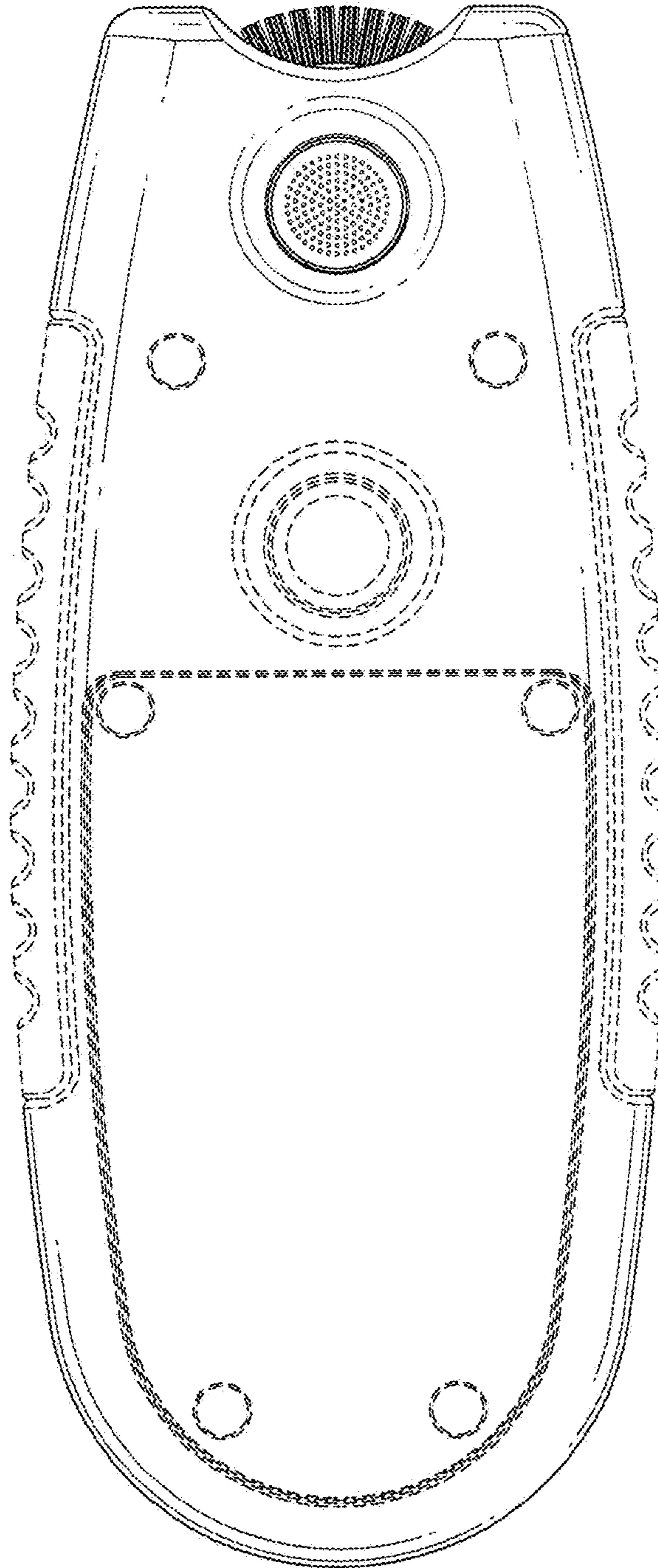

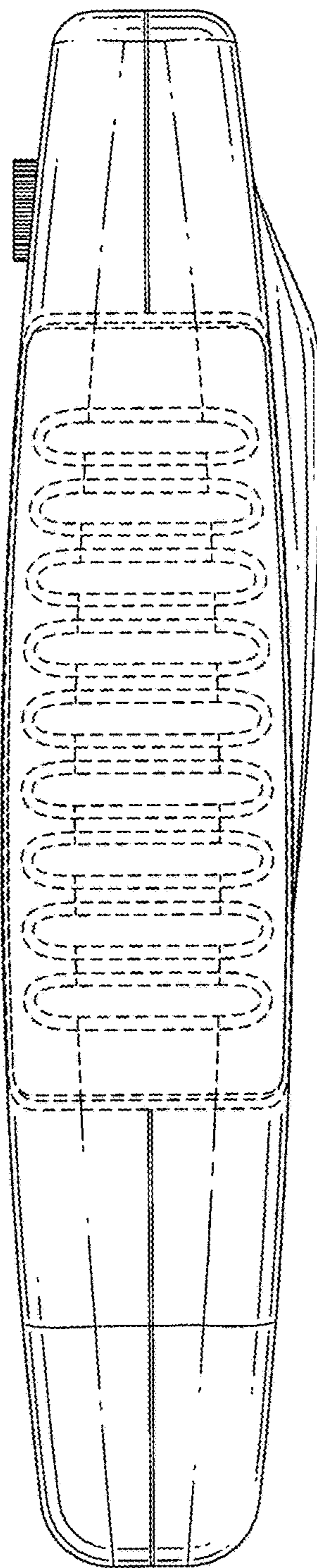

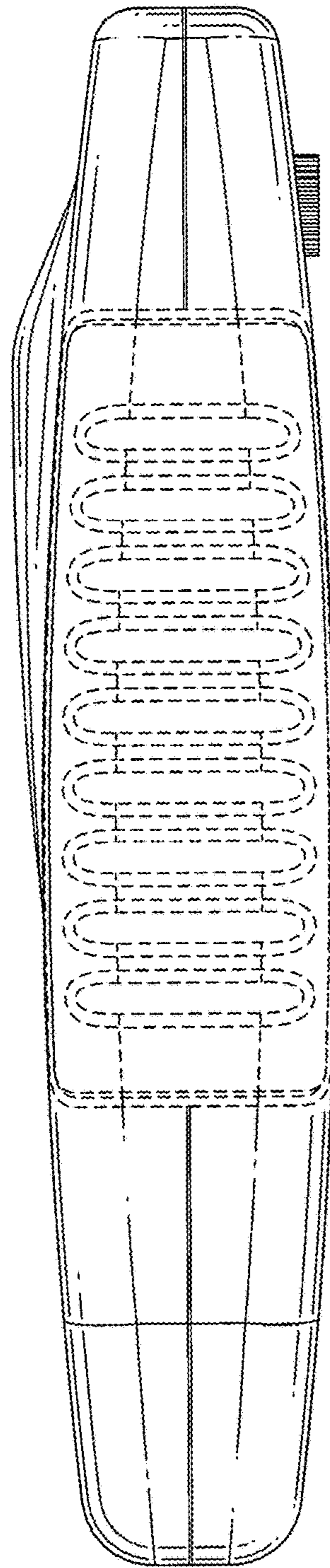

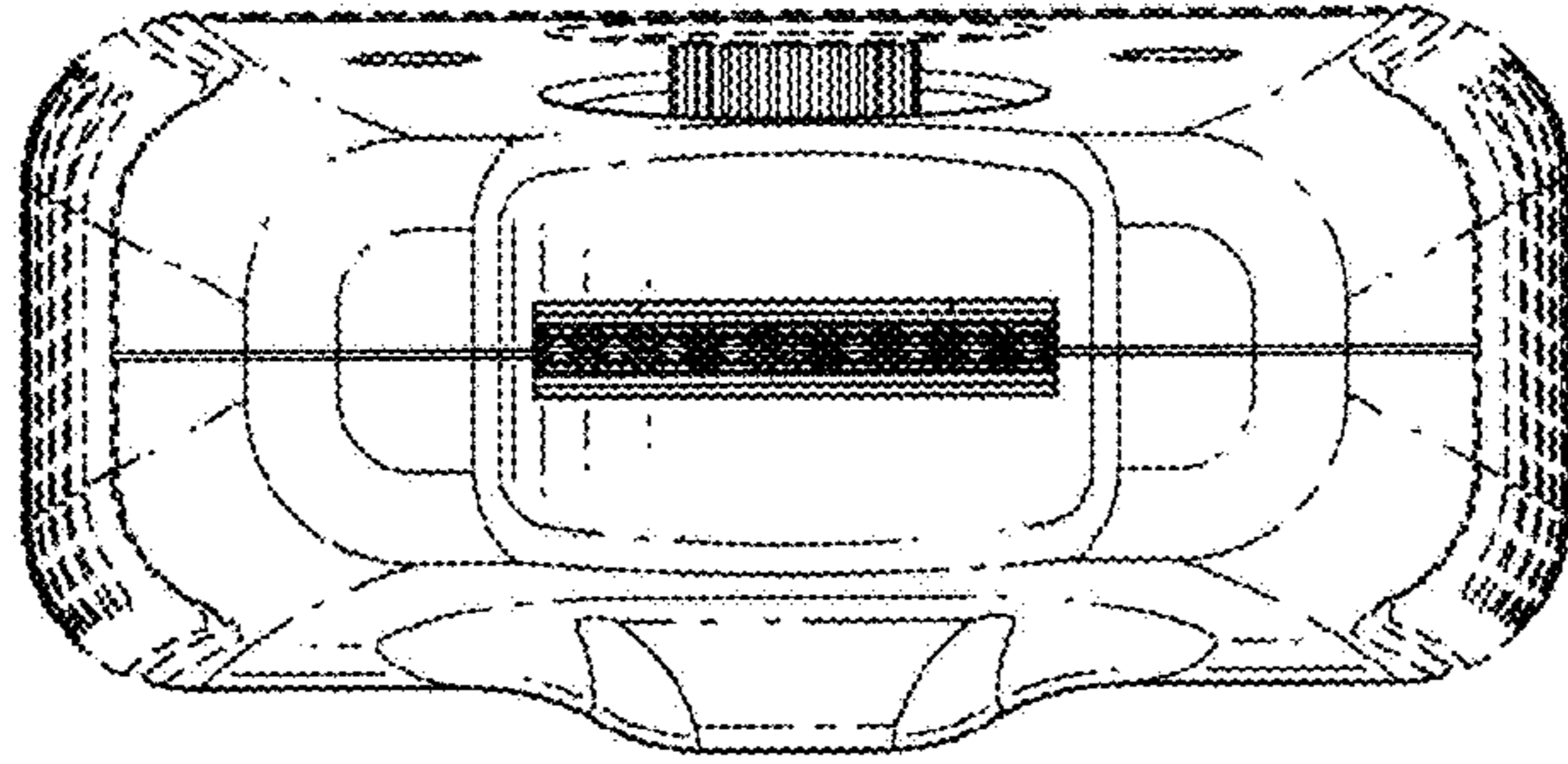

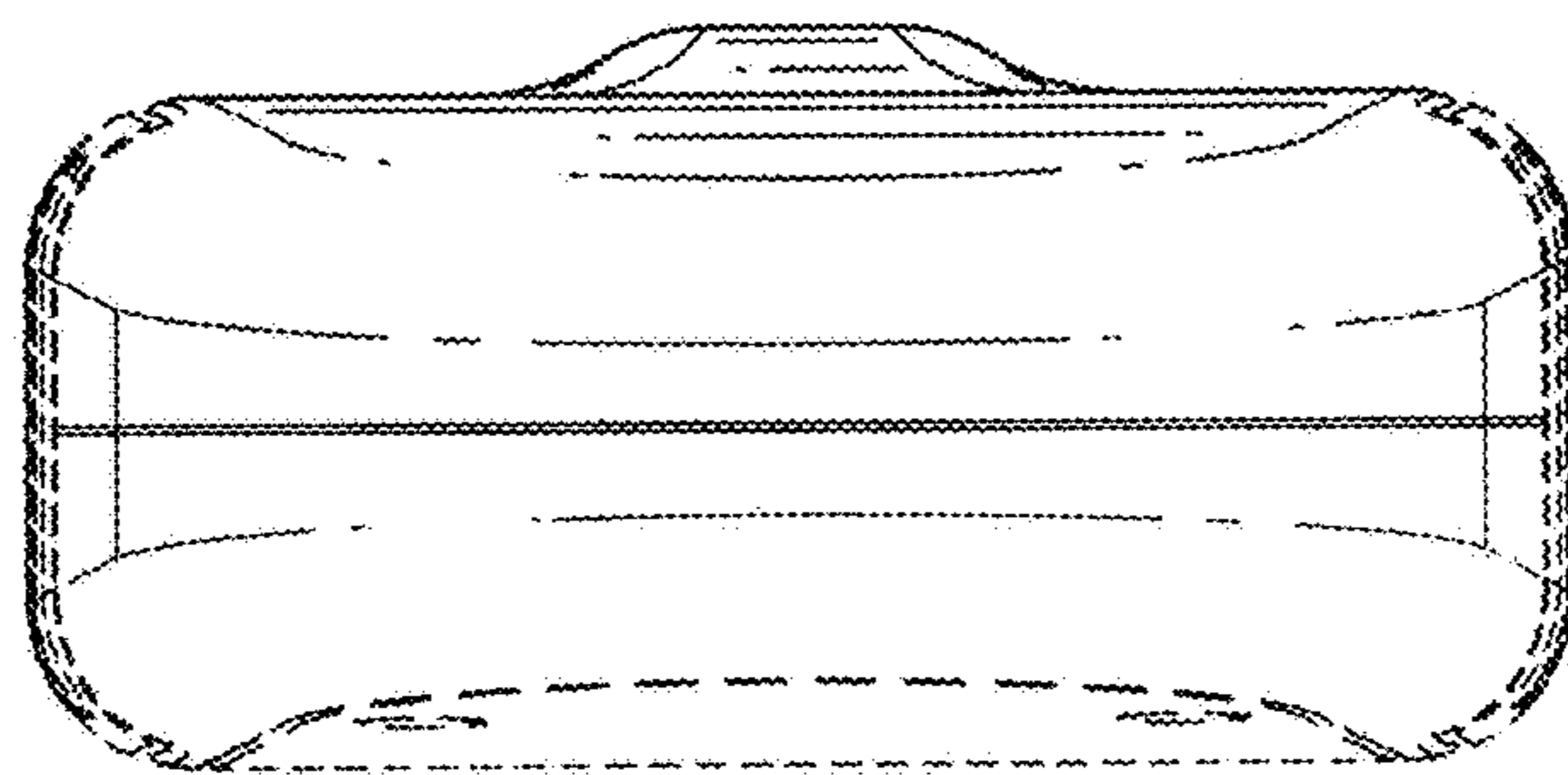

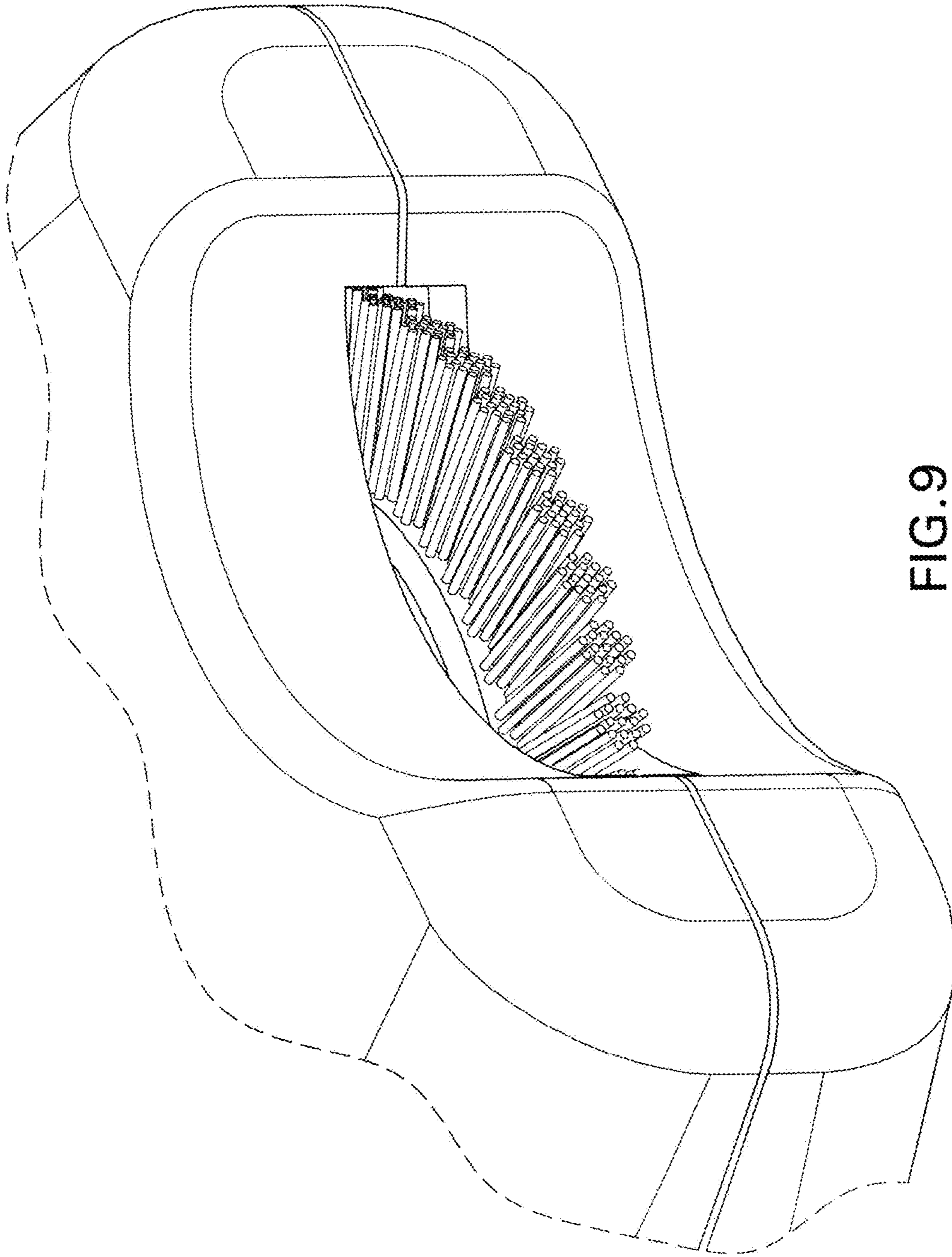

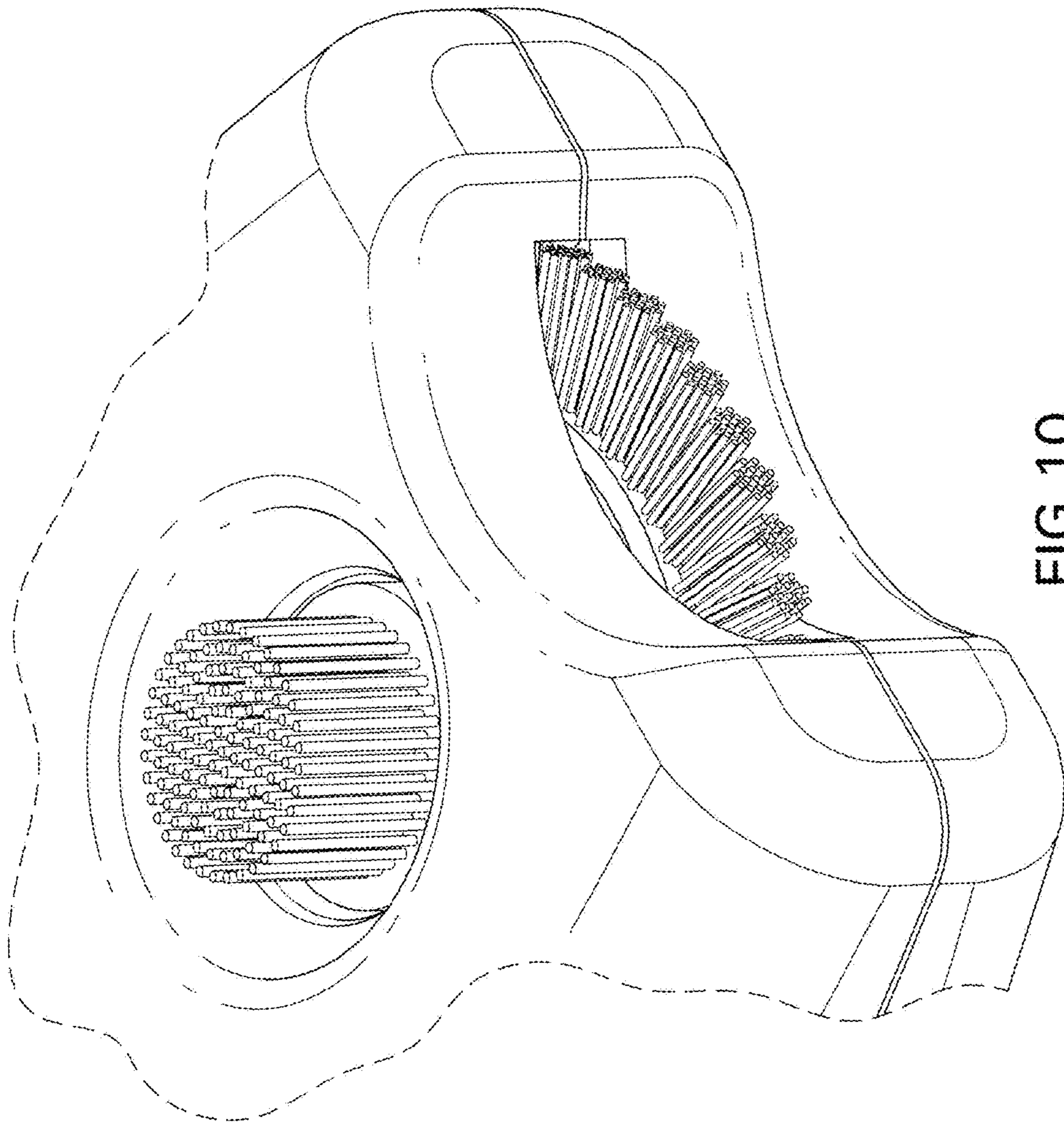
