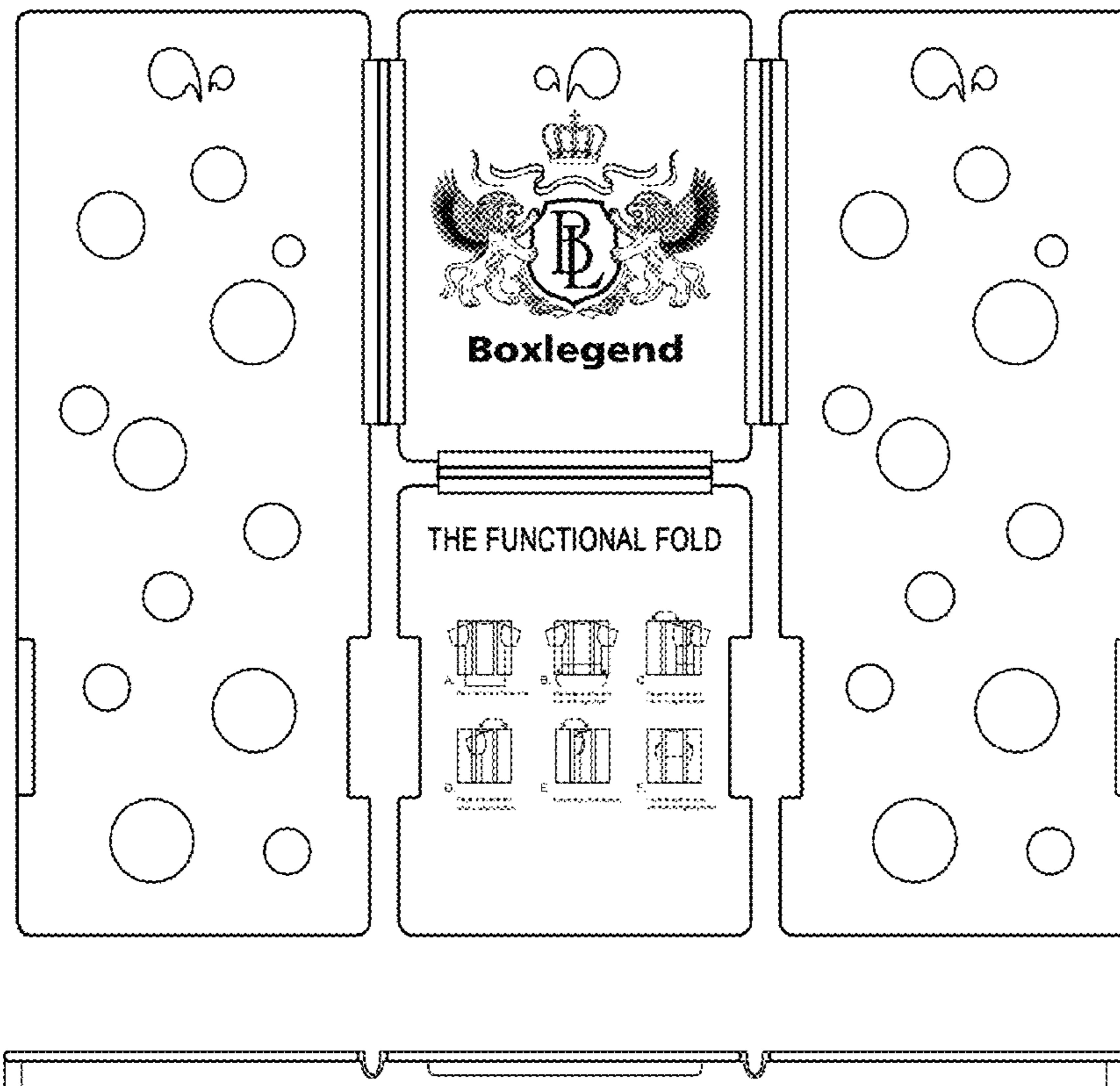
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a clothes folding board showing the new design;

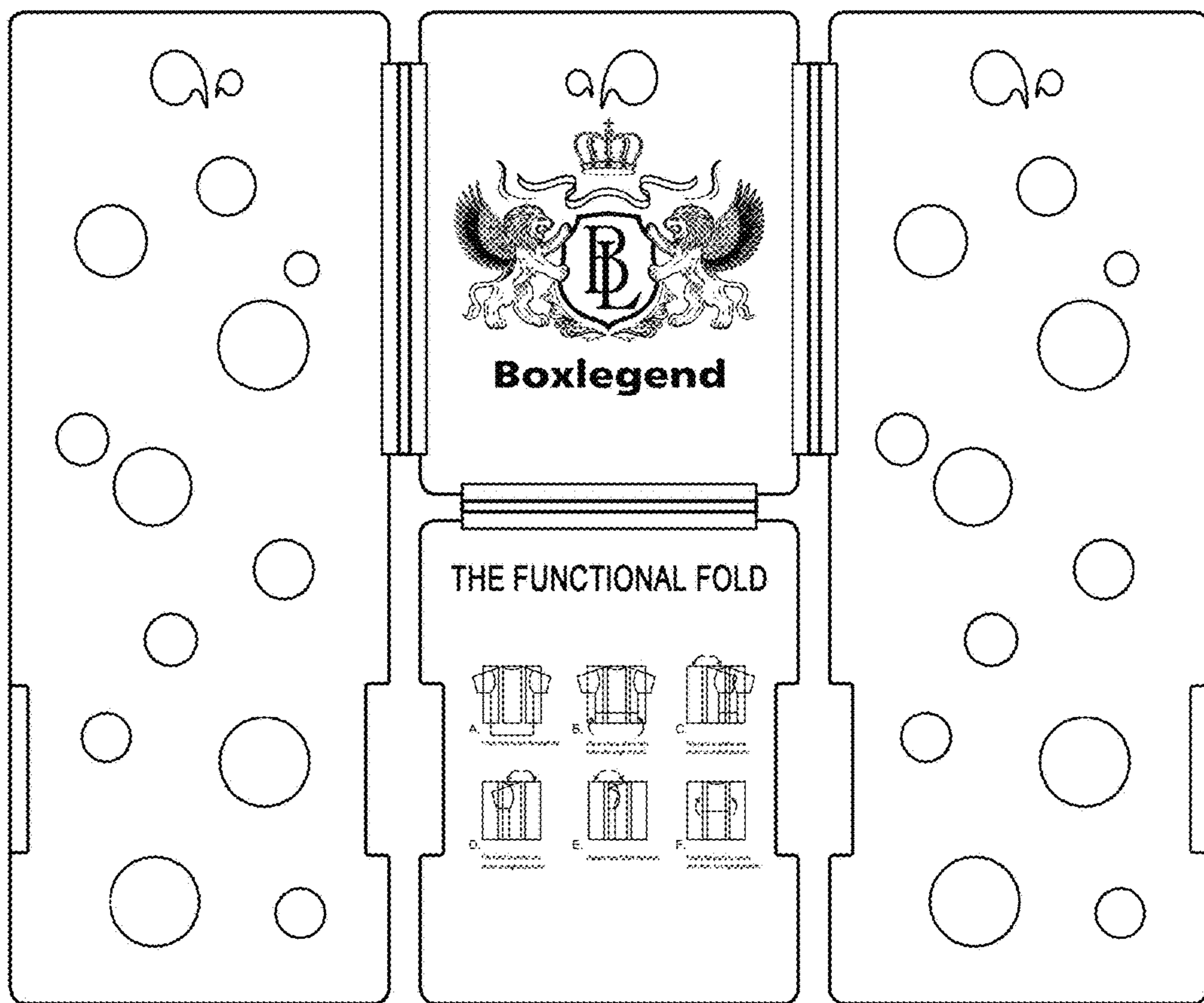

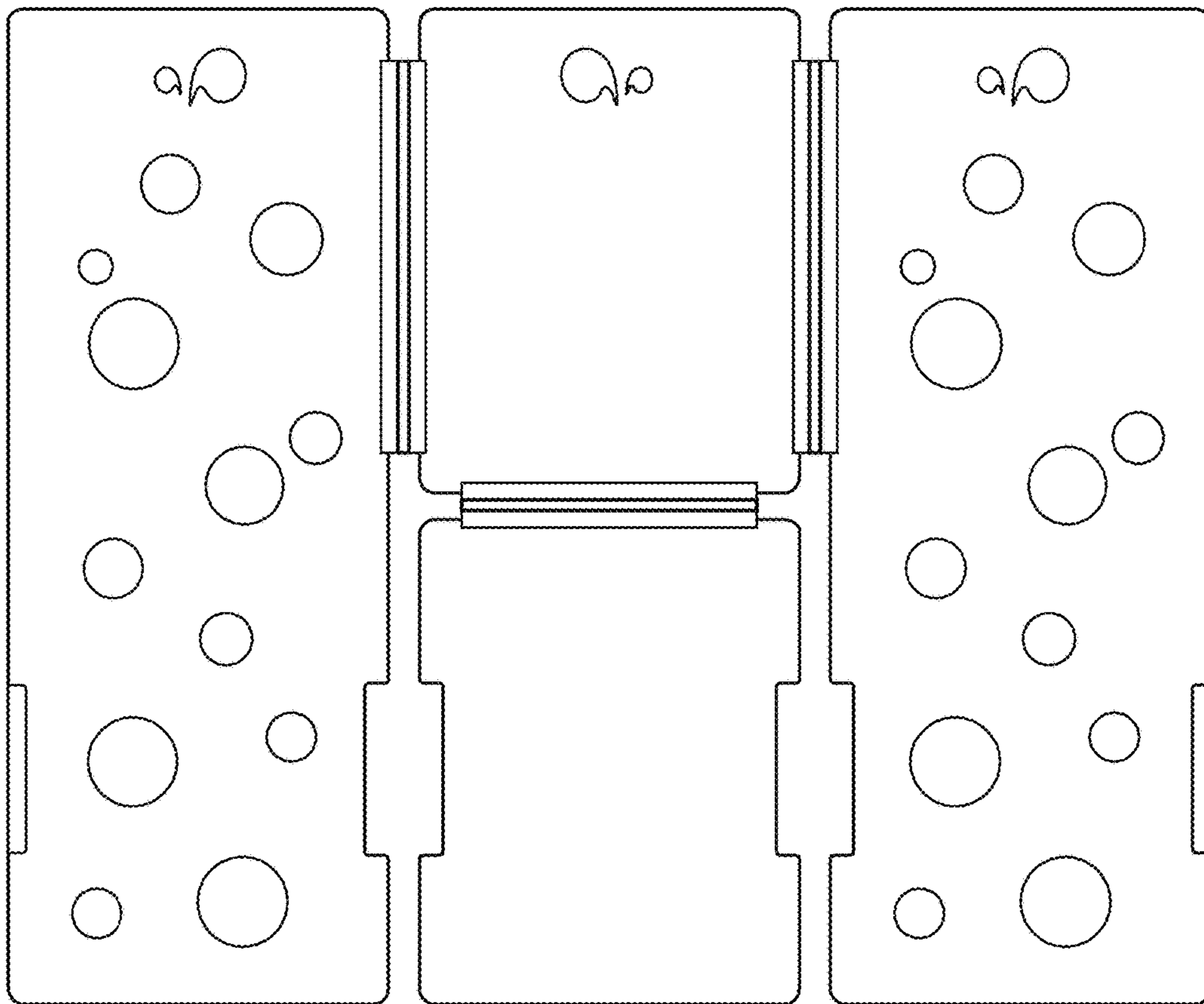

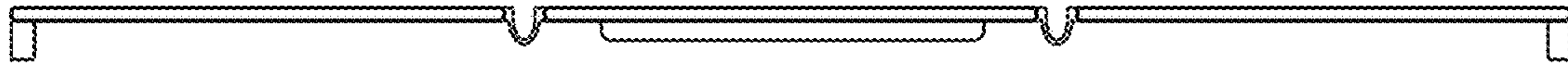

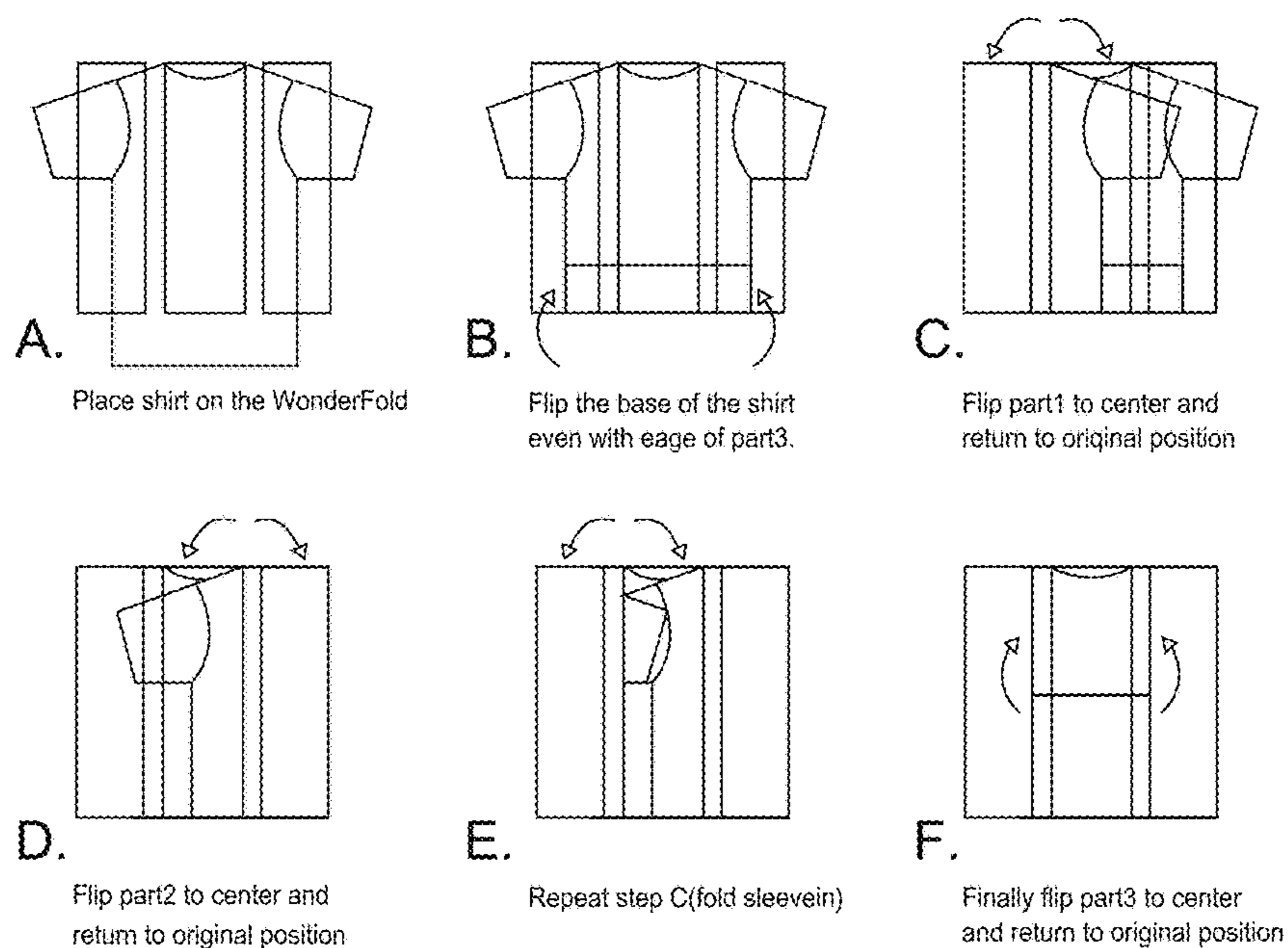
