DESCRIPTION

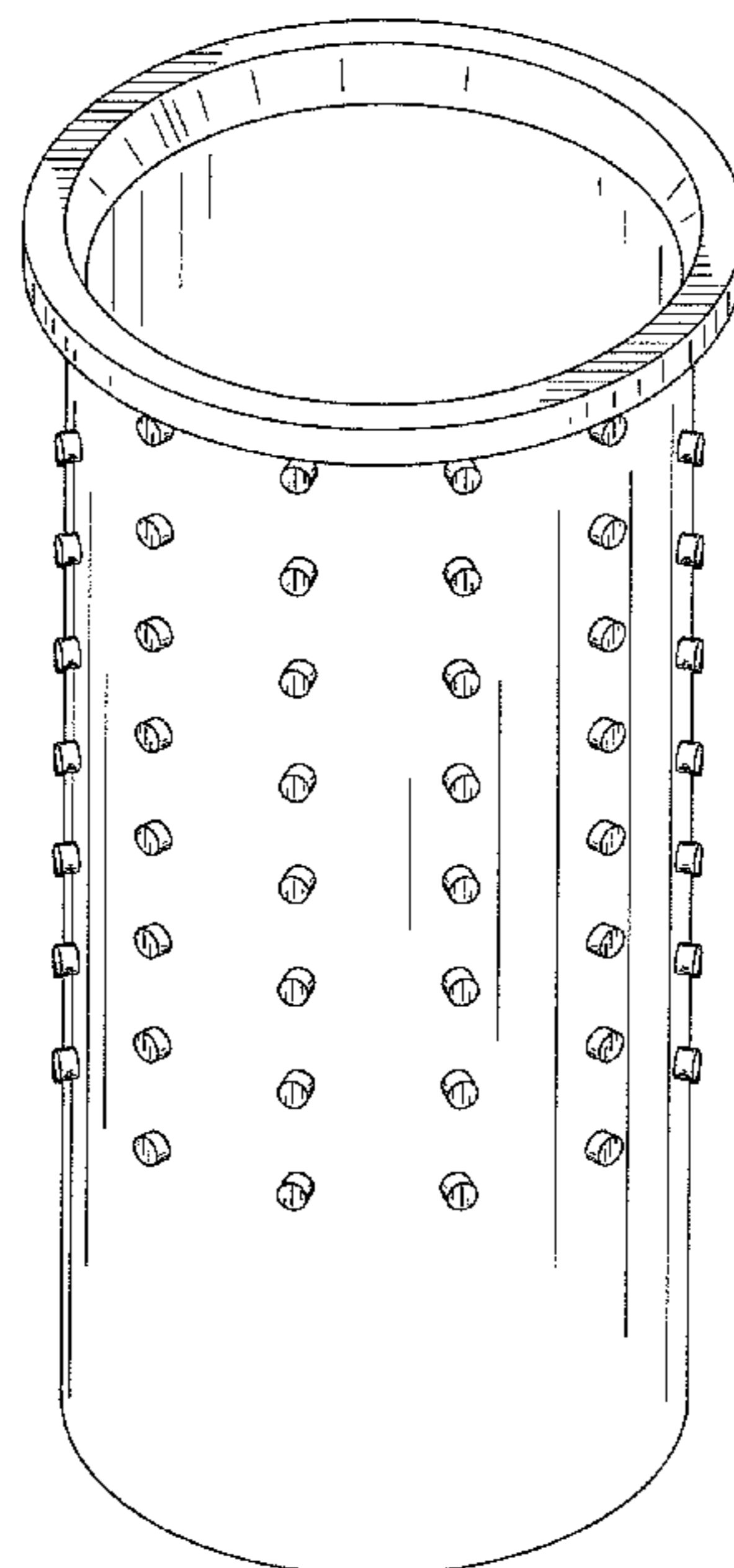
FIG. 1 is a top perspective view of the beverage container sleeve, according to the present design;

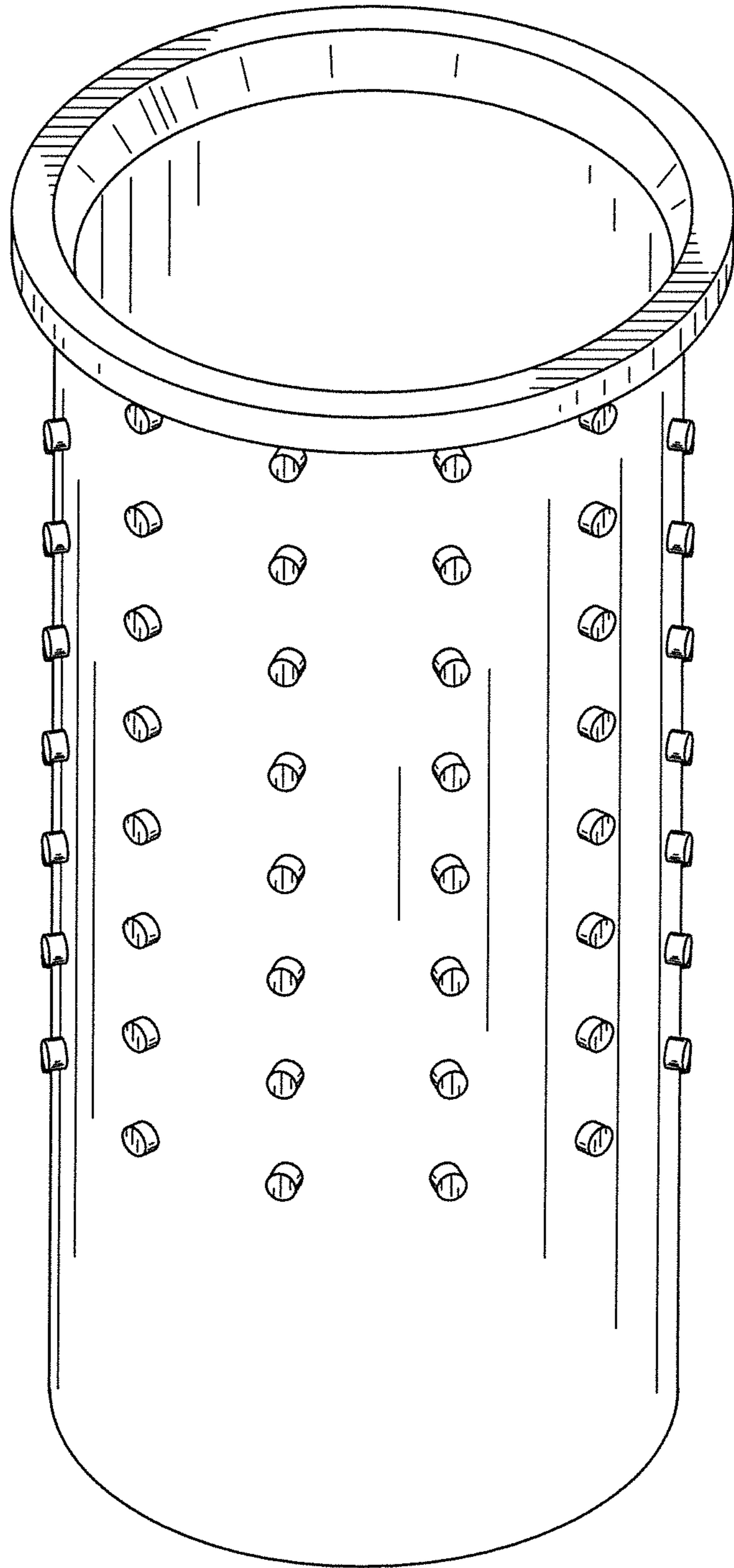

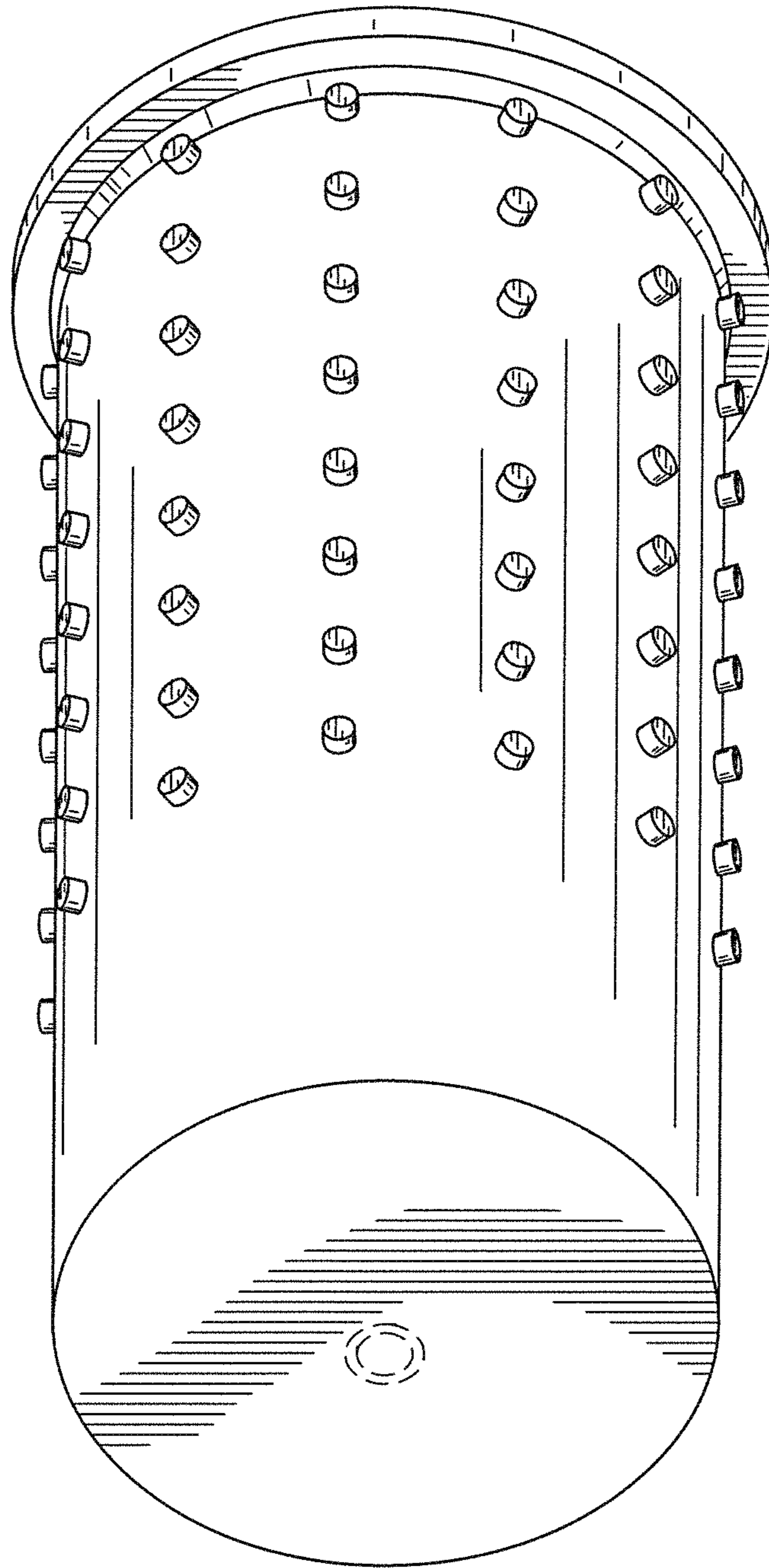

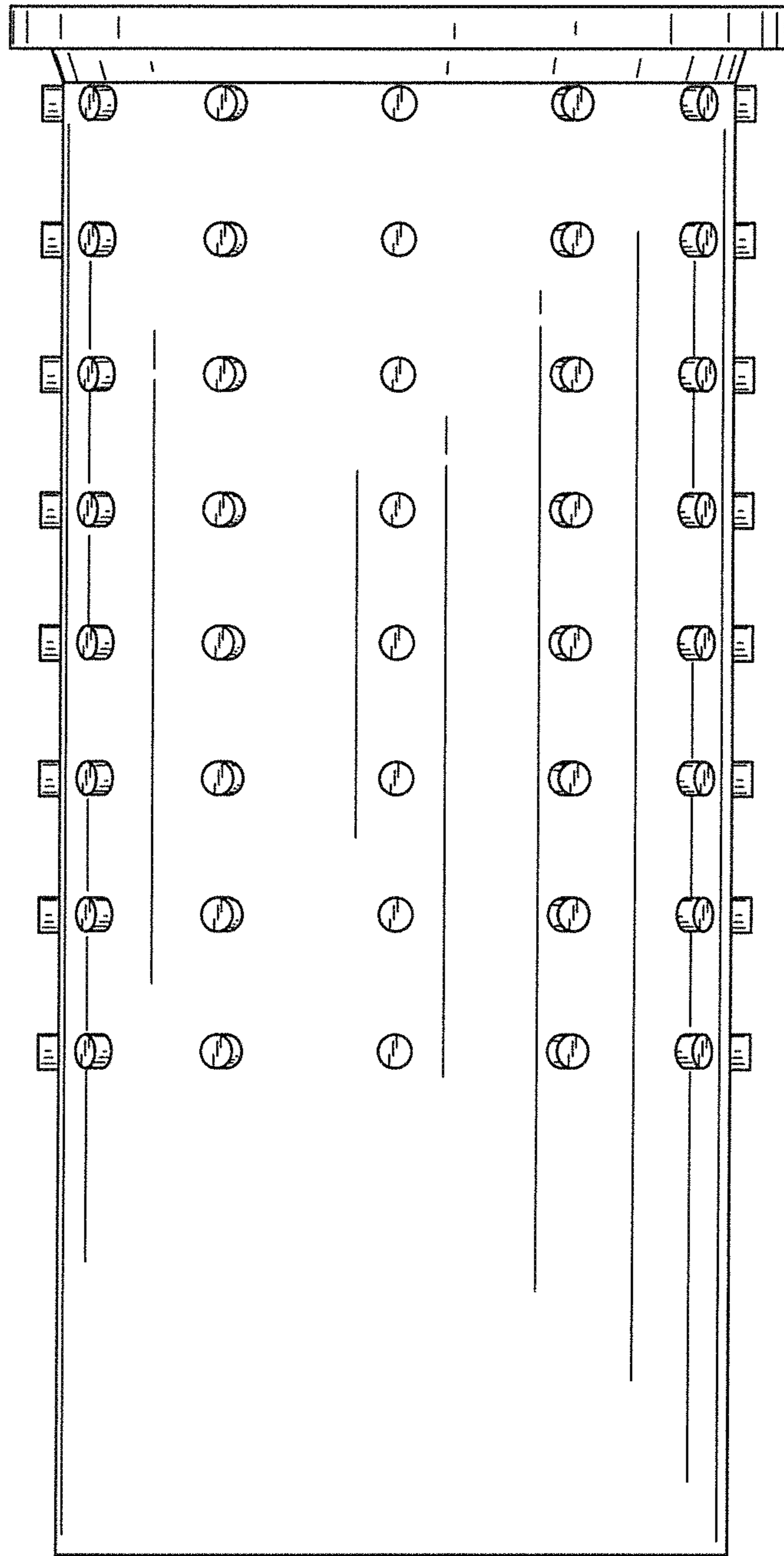

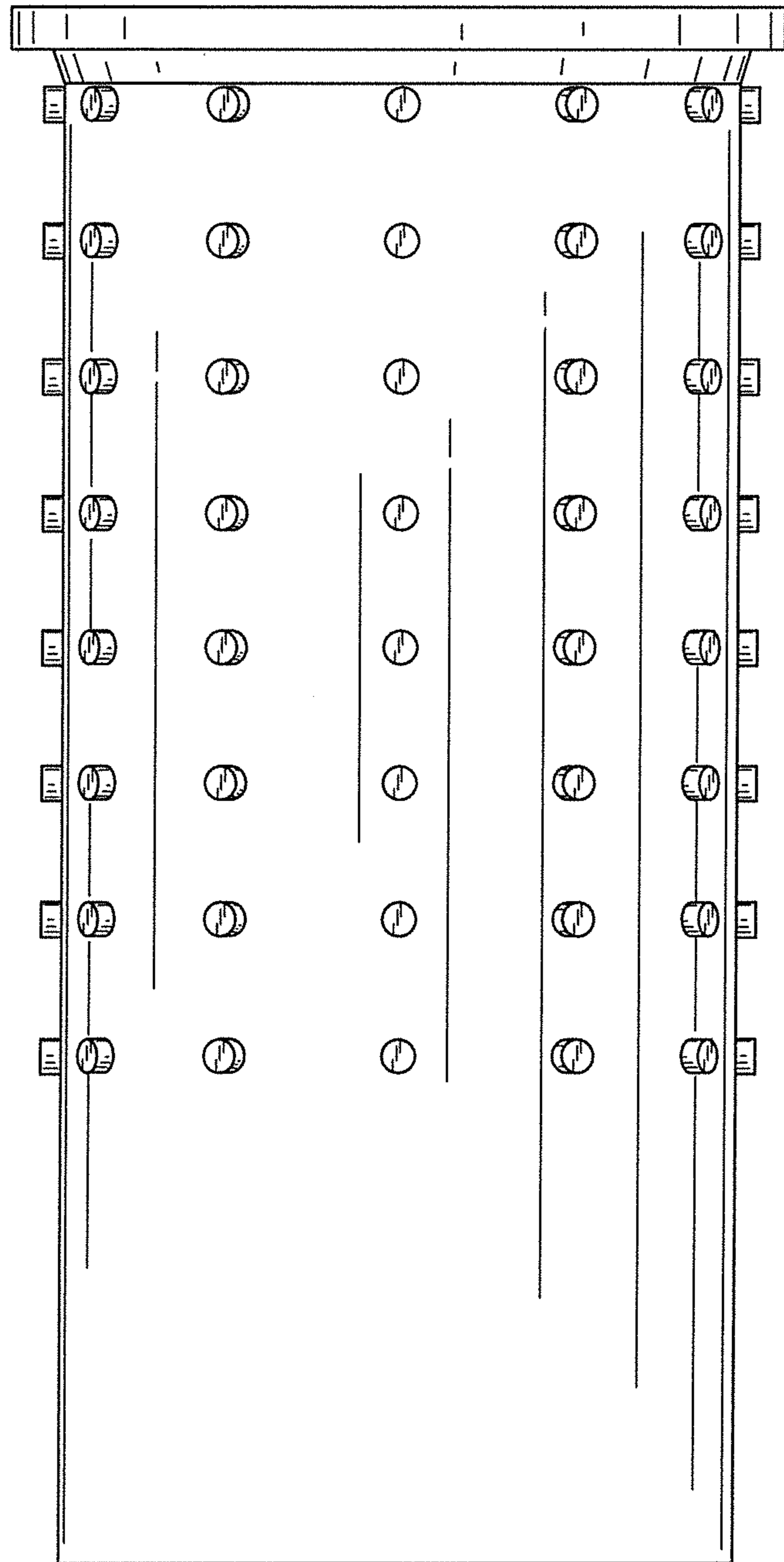

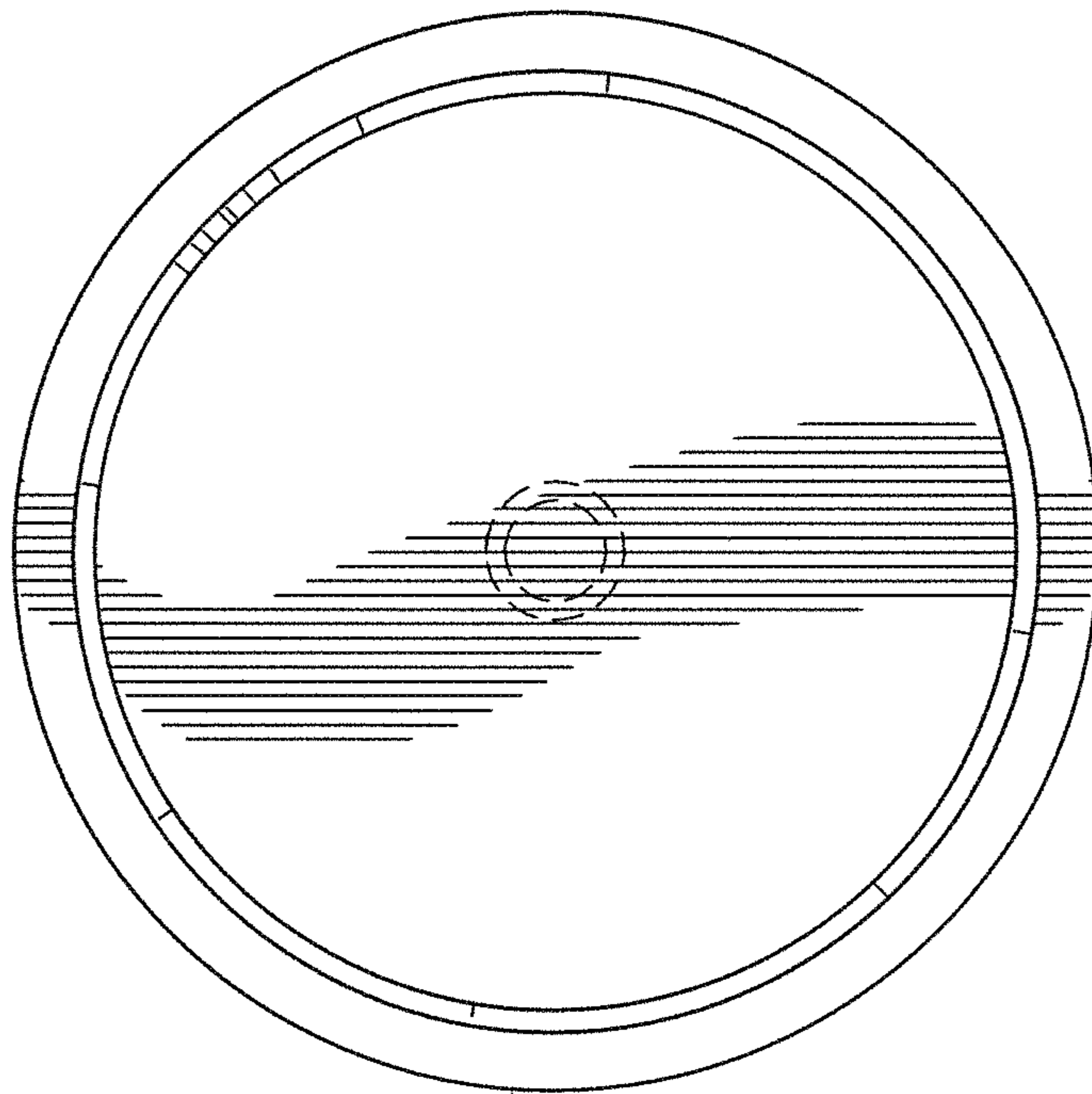

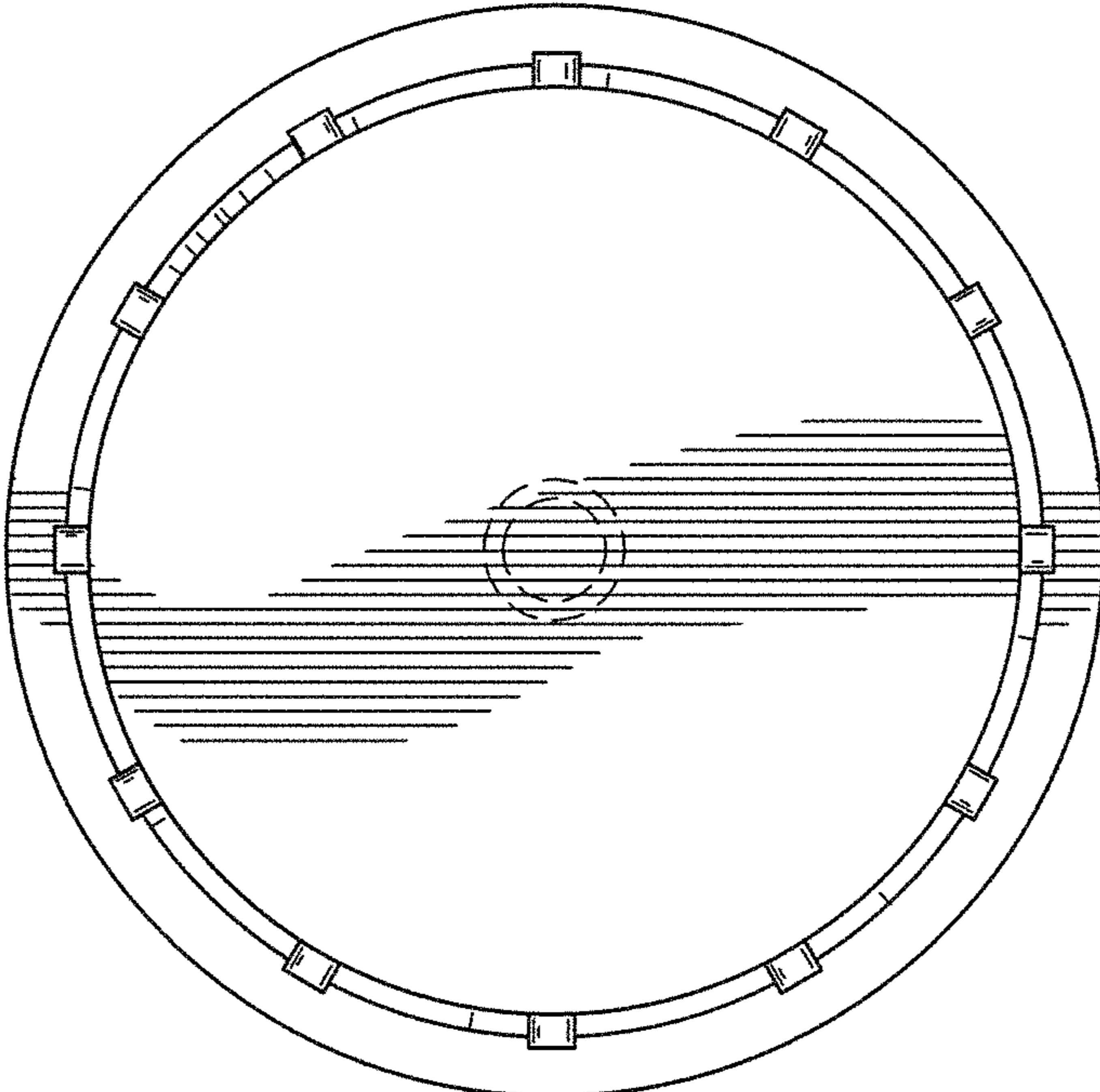

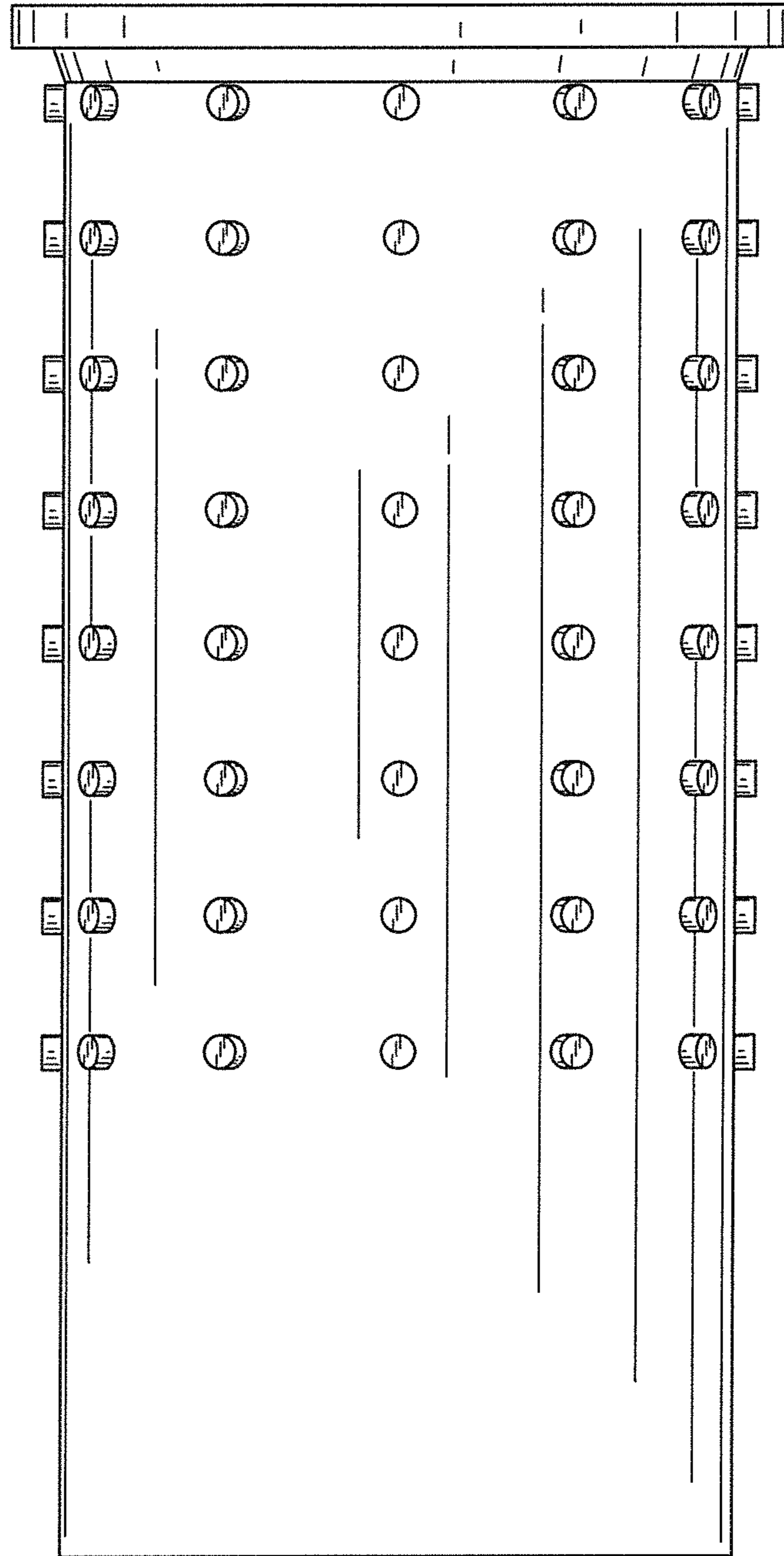

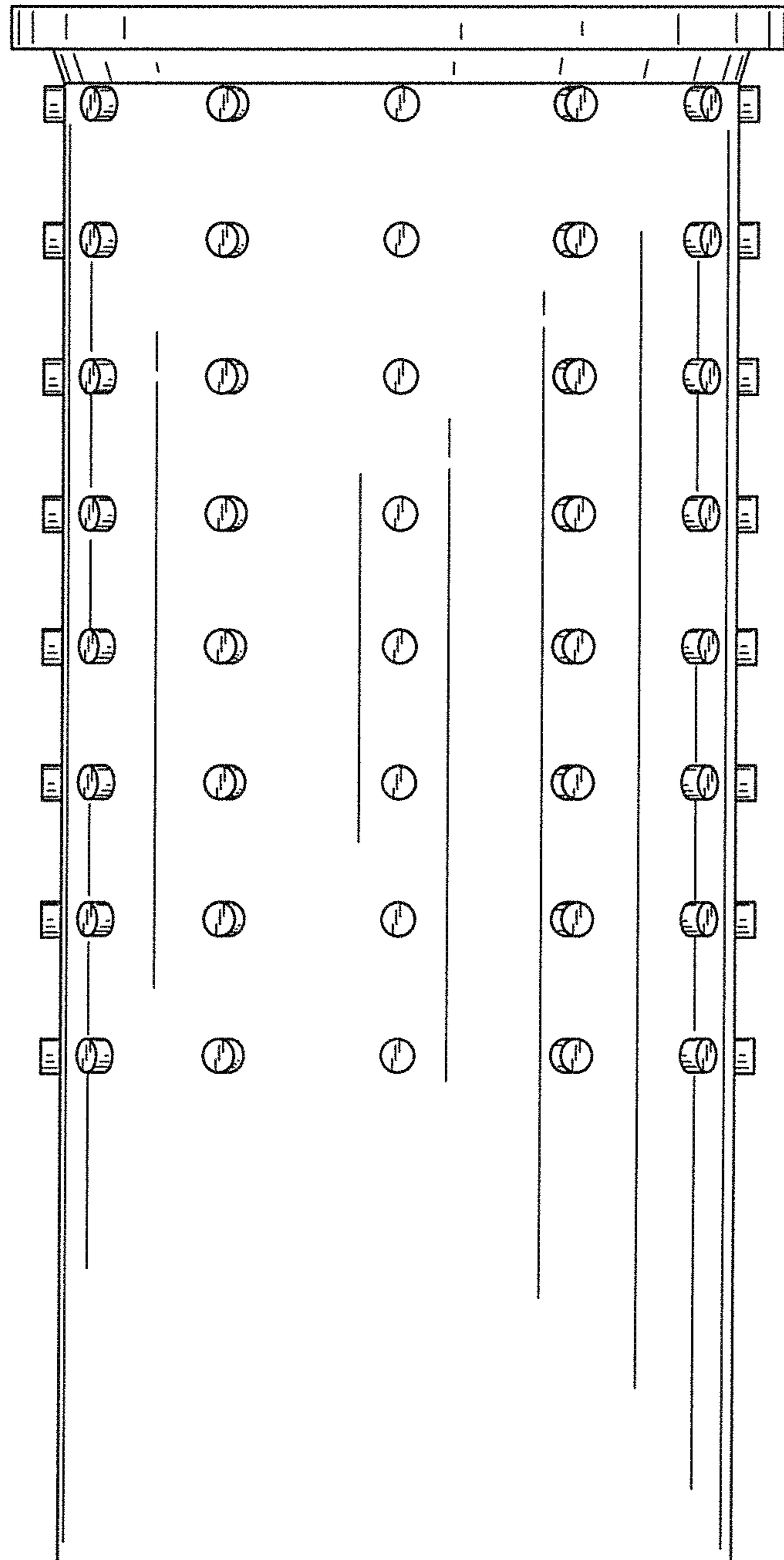
