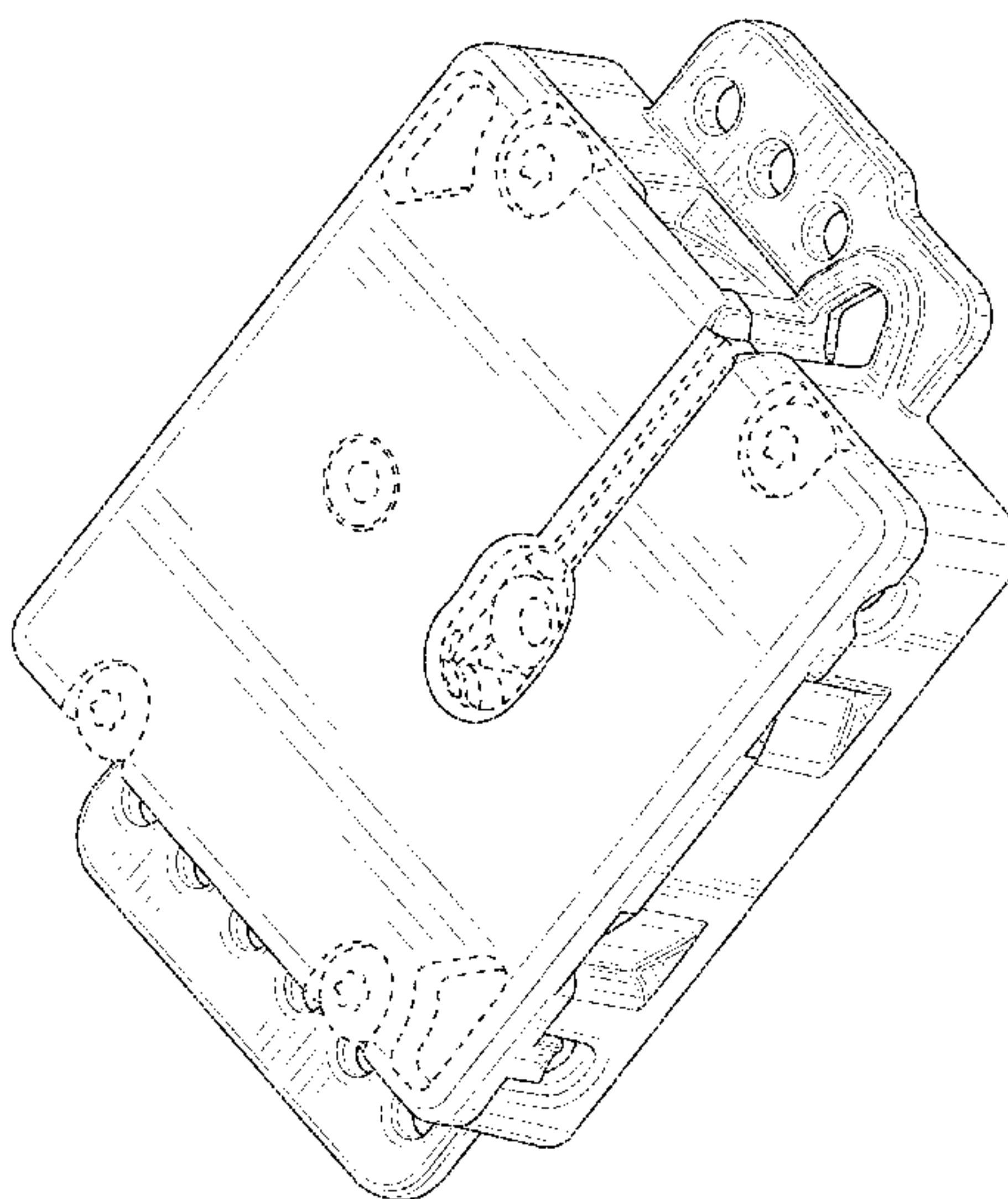
(57) **CLAIM**

The ornamental design for a housing for a cable lock, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a housing for a cable lock showing my new design;
 FIG. 2 is a rear bottom perspective view thereof;
 FIG. 3 is a front left perspective view thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a front view thereof;
 FIG. 7 is a rear view thereof;

 FIG. 9 is a left side view thereof.

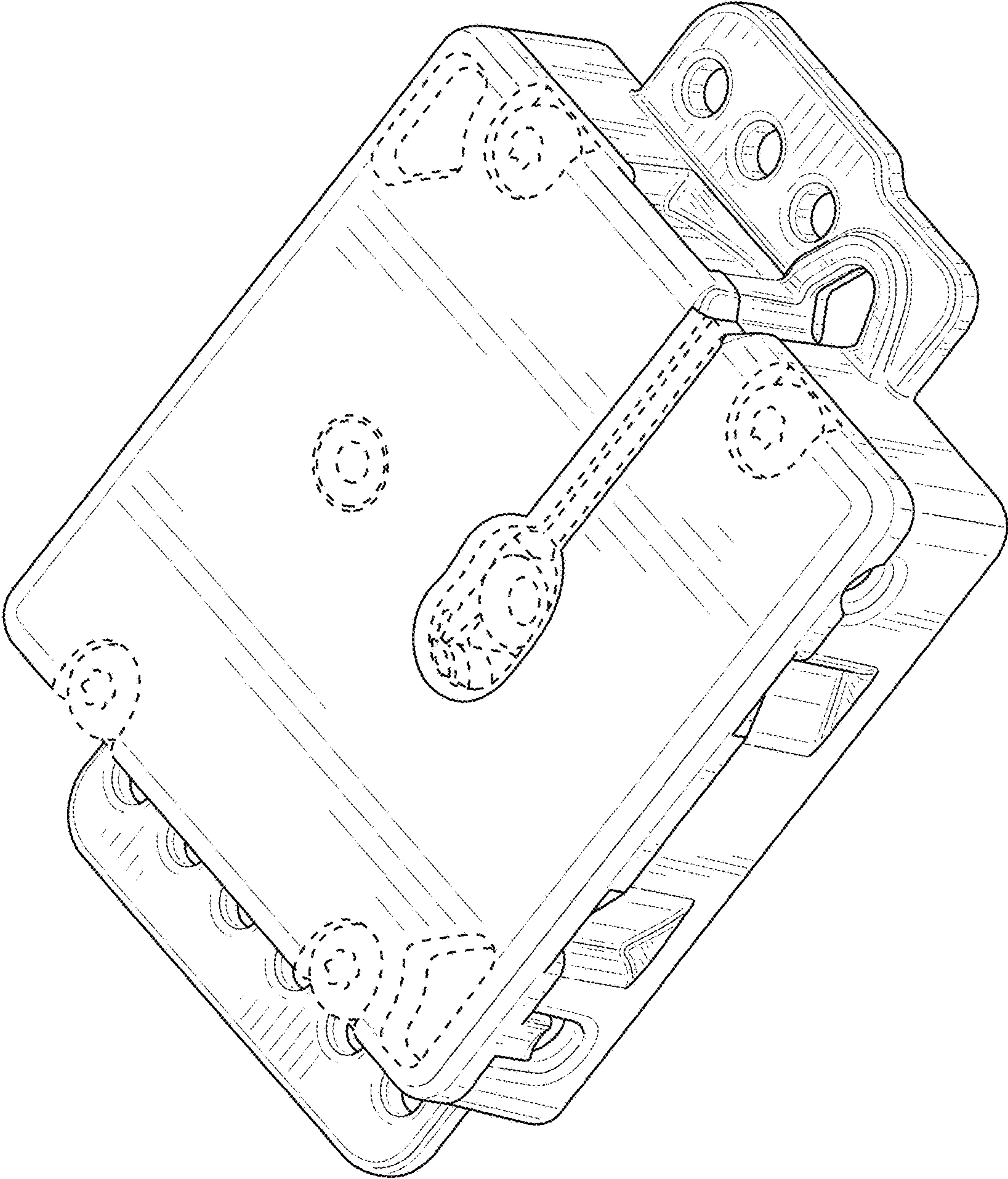

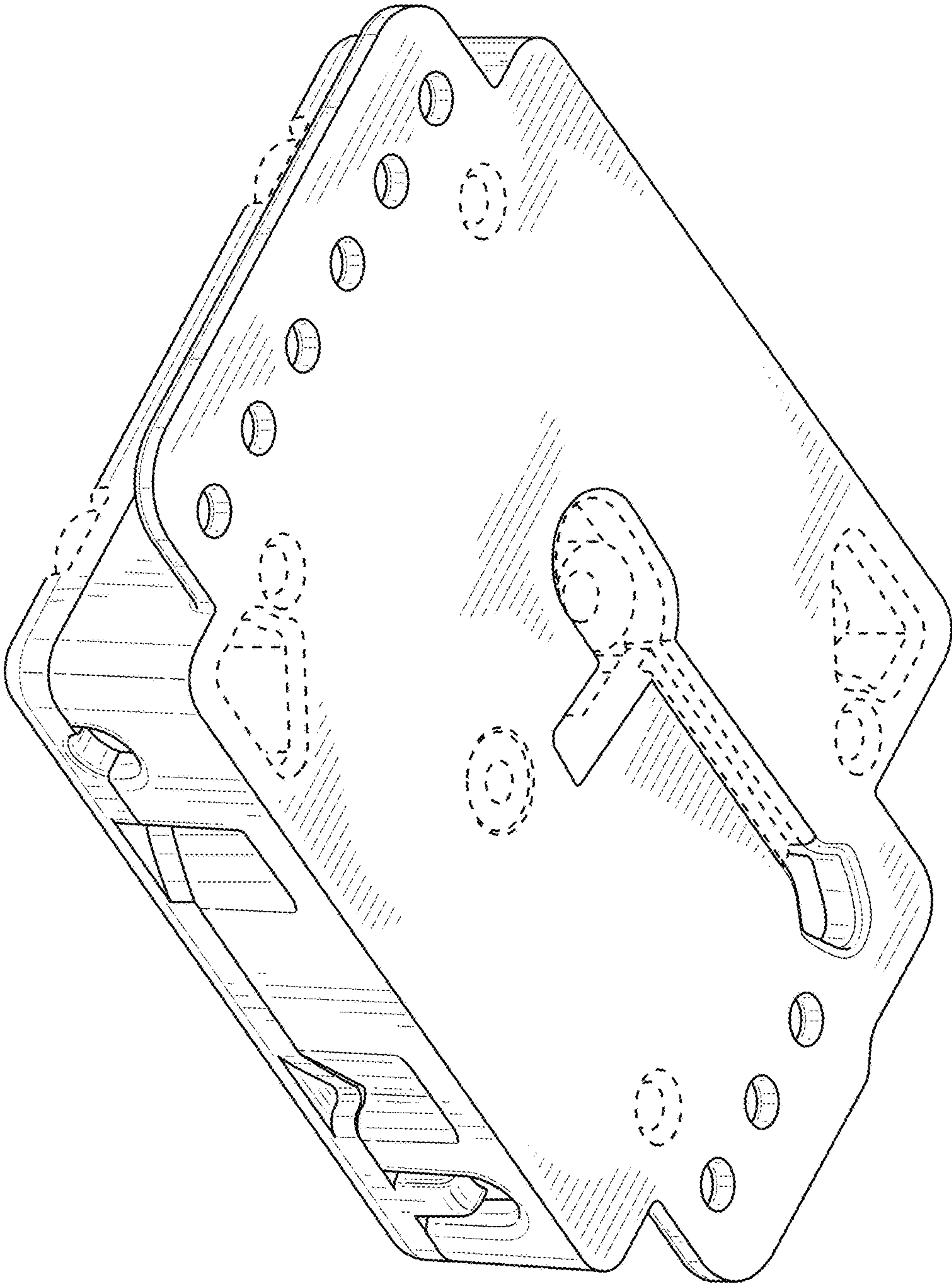

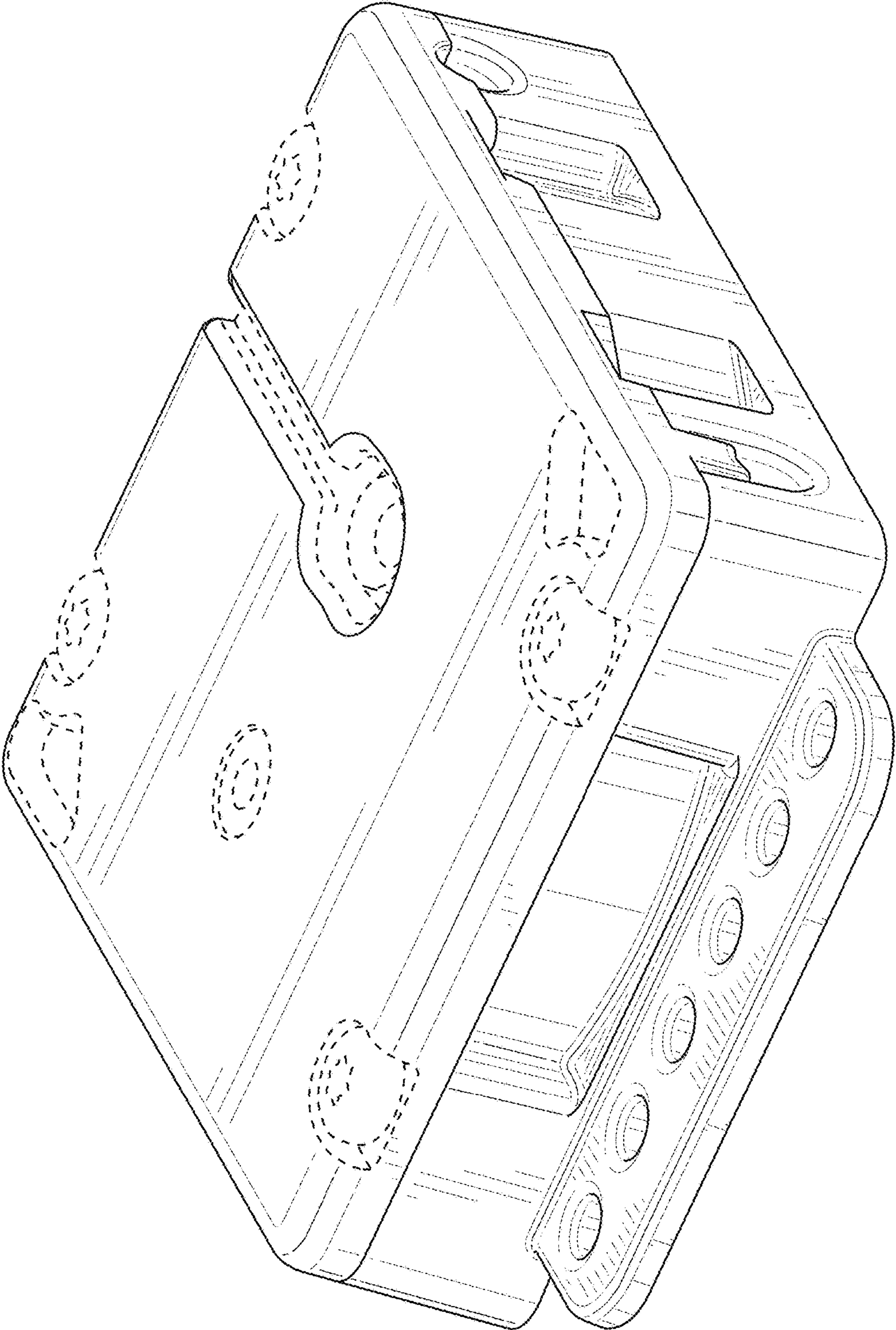

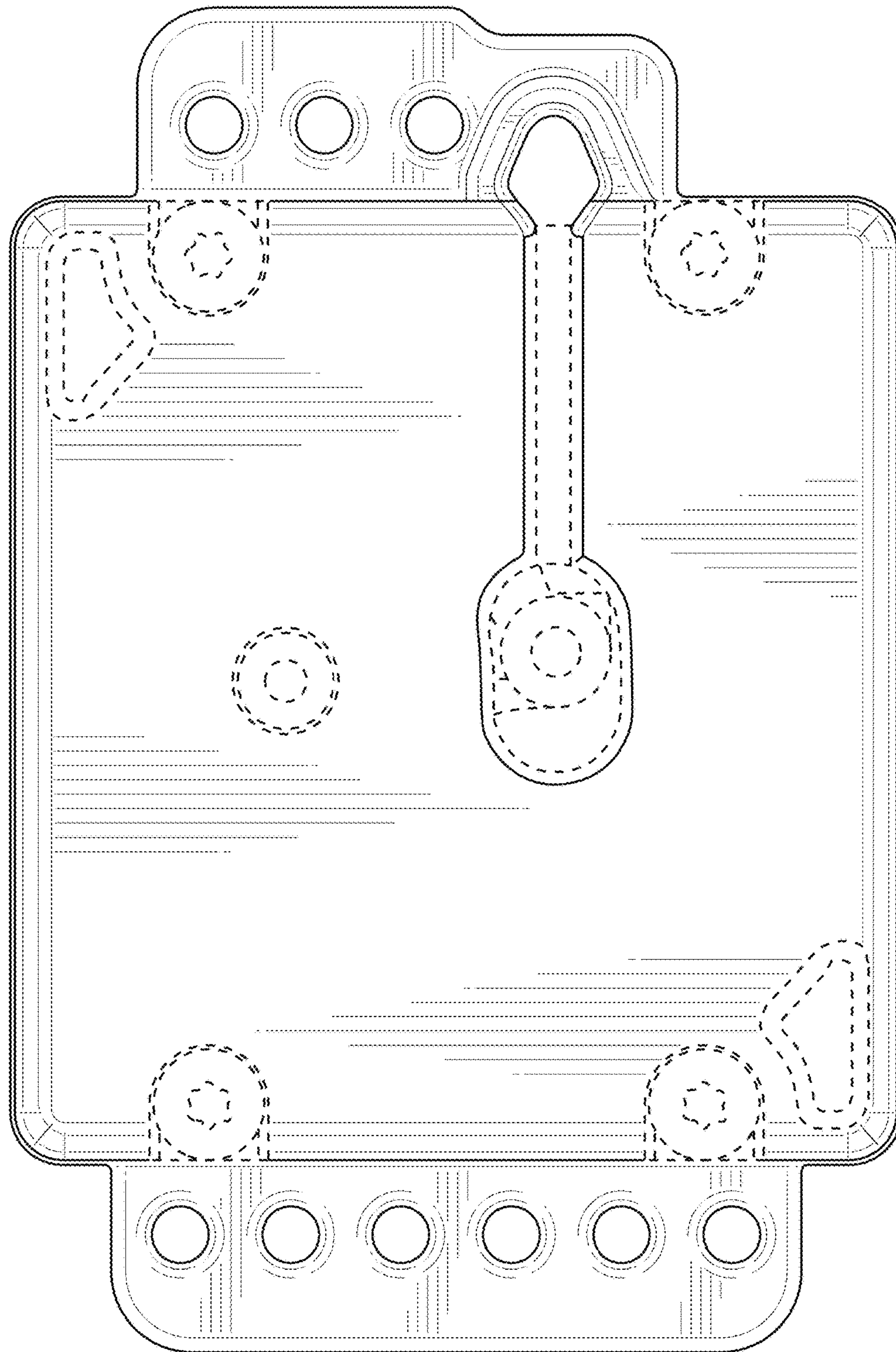

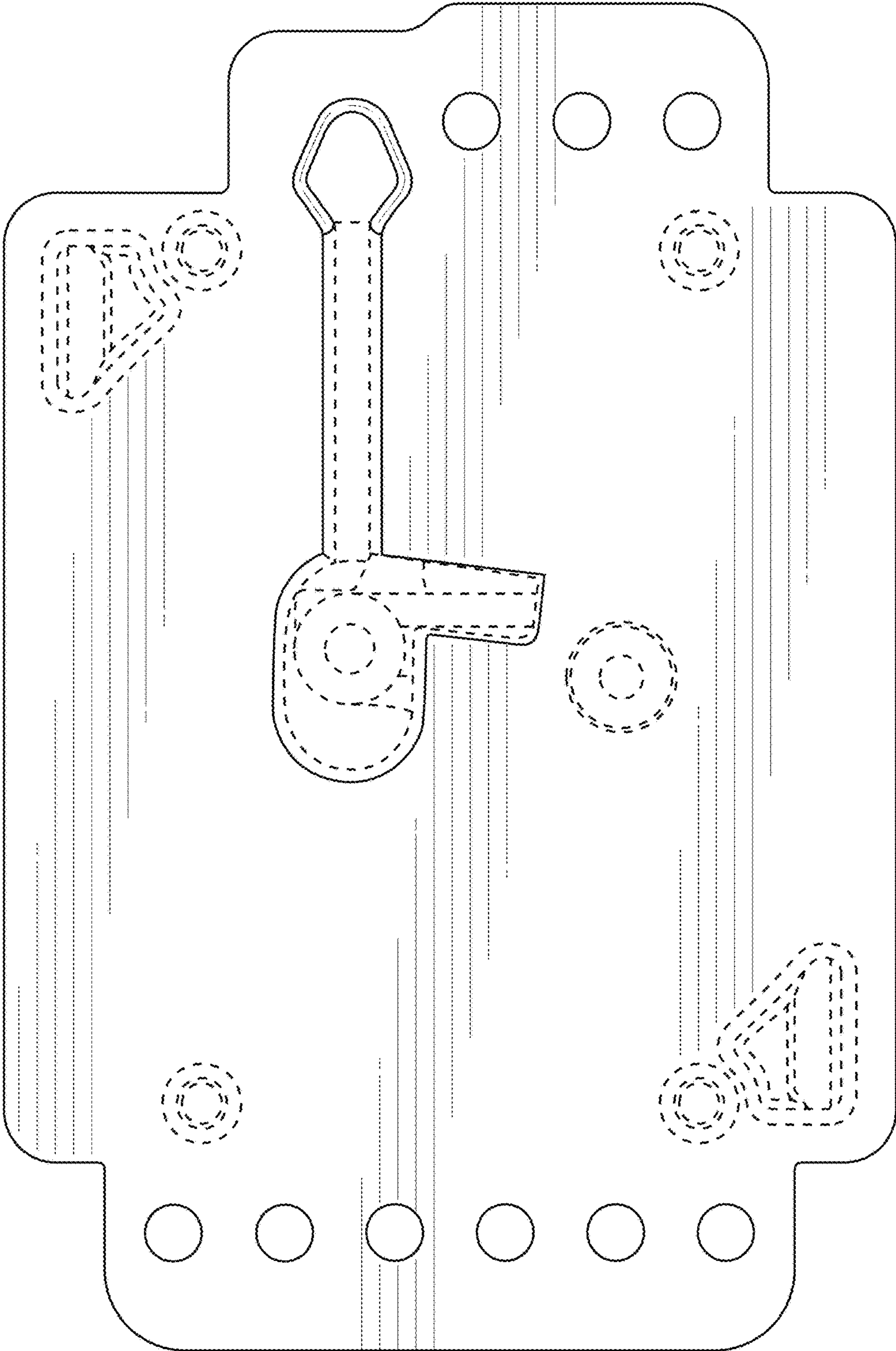

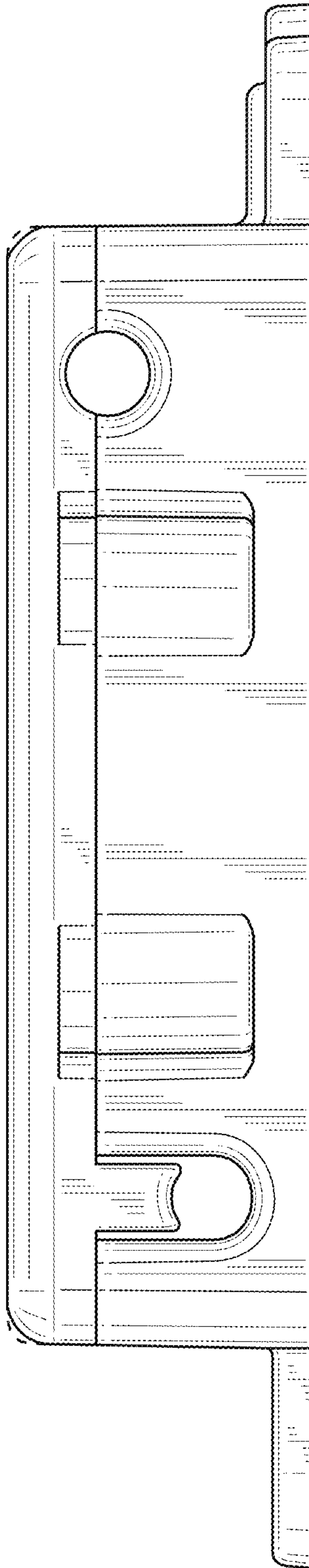

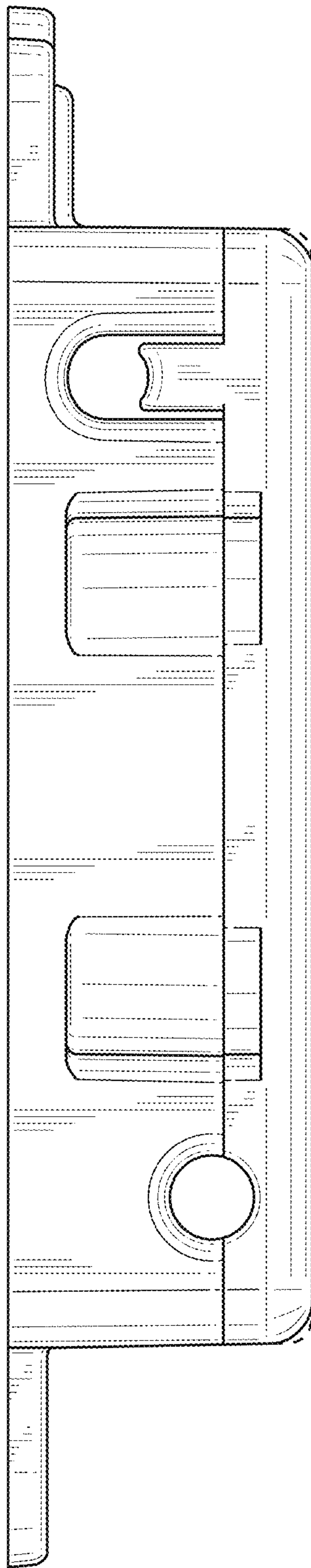

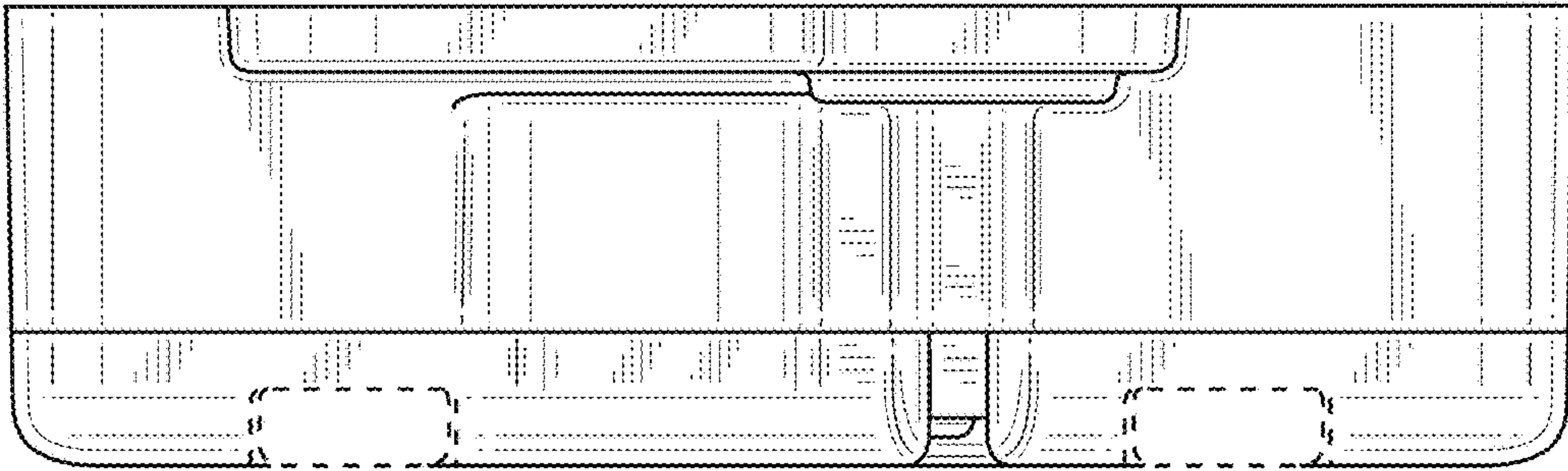

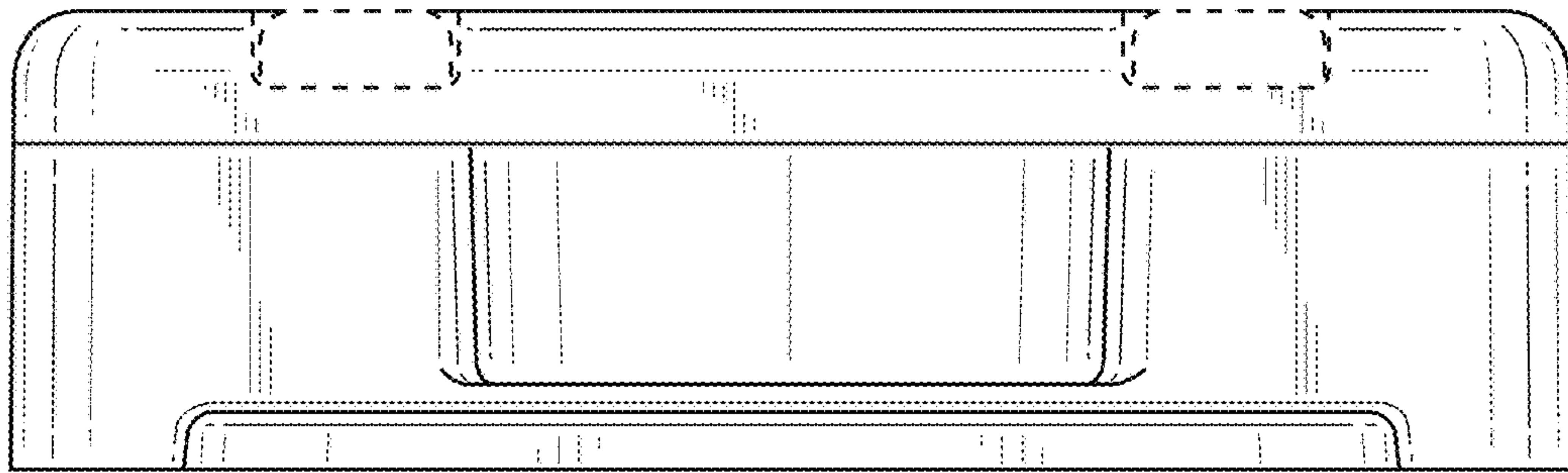
