The ornamental design for a product package for absorbent articles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a product package for absorbent articles;

FIG. 2 is a front view of the embodiment of the package shown in FIG. 1;

FIG. 3 is a left side view of the embodiment of the package shown in FIG. 1;

FIG. 11 is a rear view of the embodiment of the package shown in FIG. 8;


FIG. 12 is a right side view of the embodiment of the package shown in FIG. 8;




























