(57) **CLAIM**

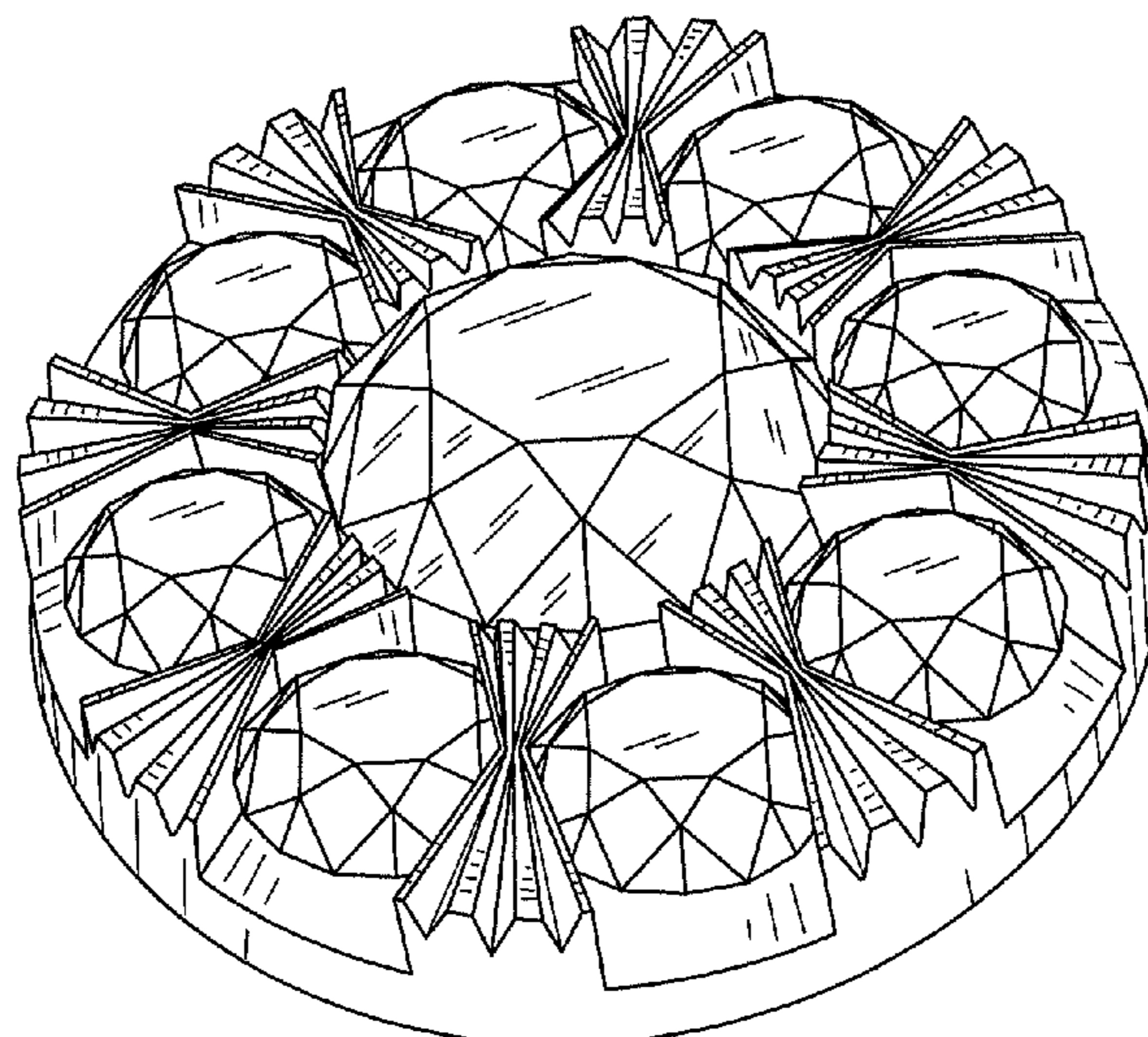
The ornamental design for a jewelry stone setting, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a jewelry stone setting showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left side elevation view thereof, the right side being identical thereto;

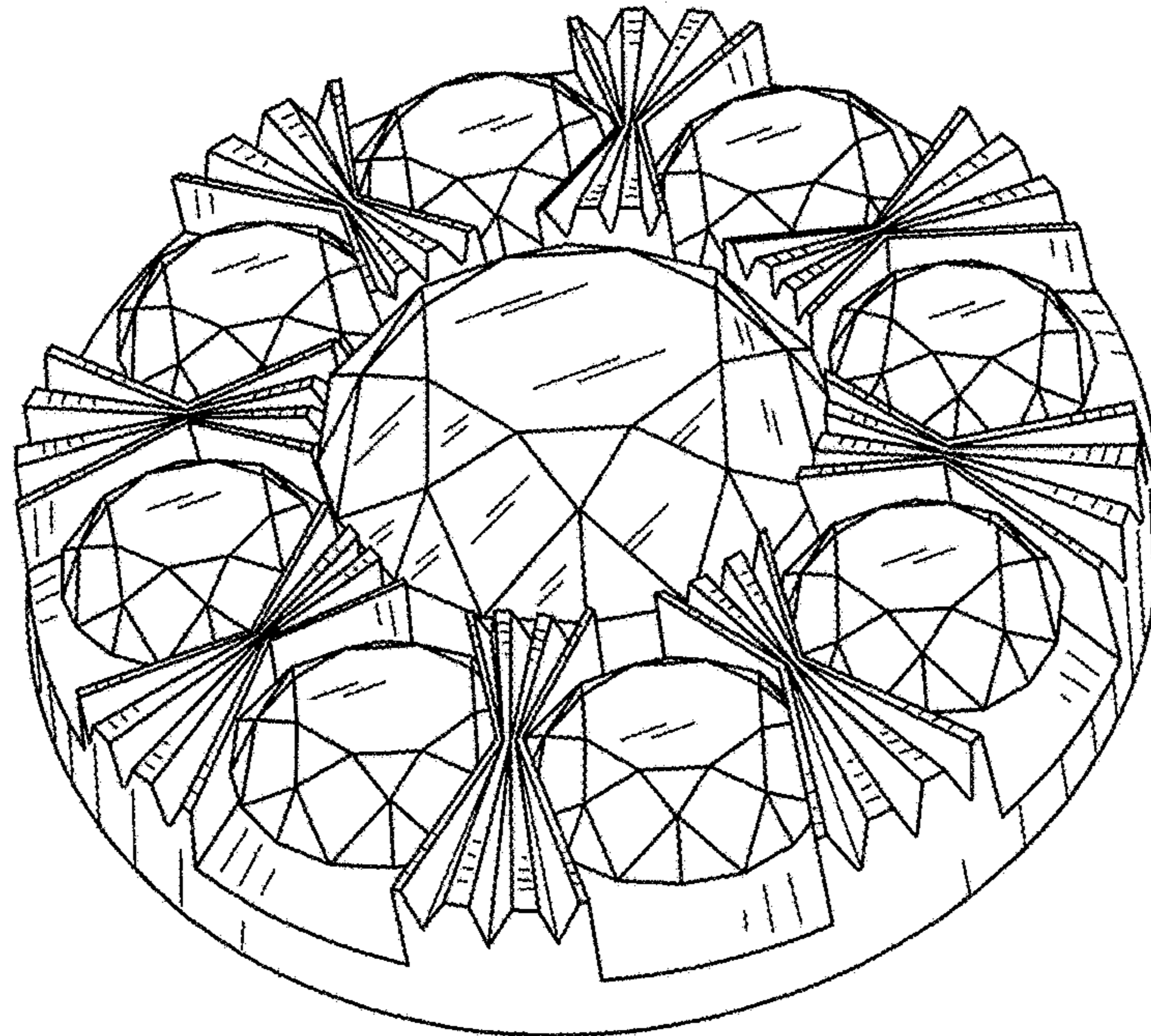

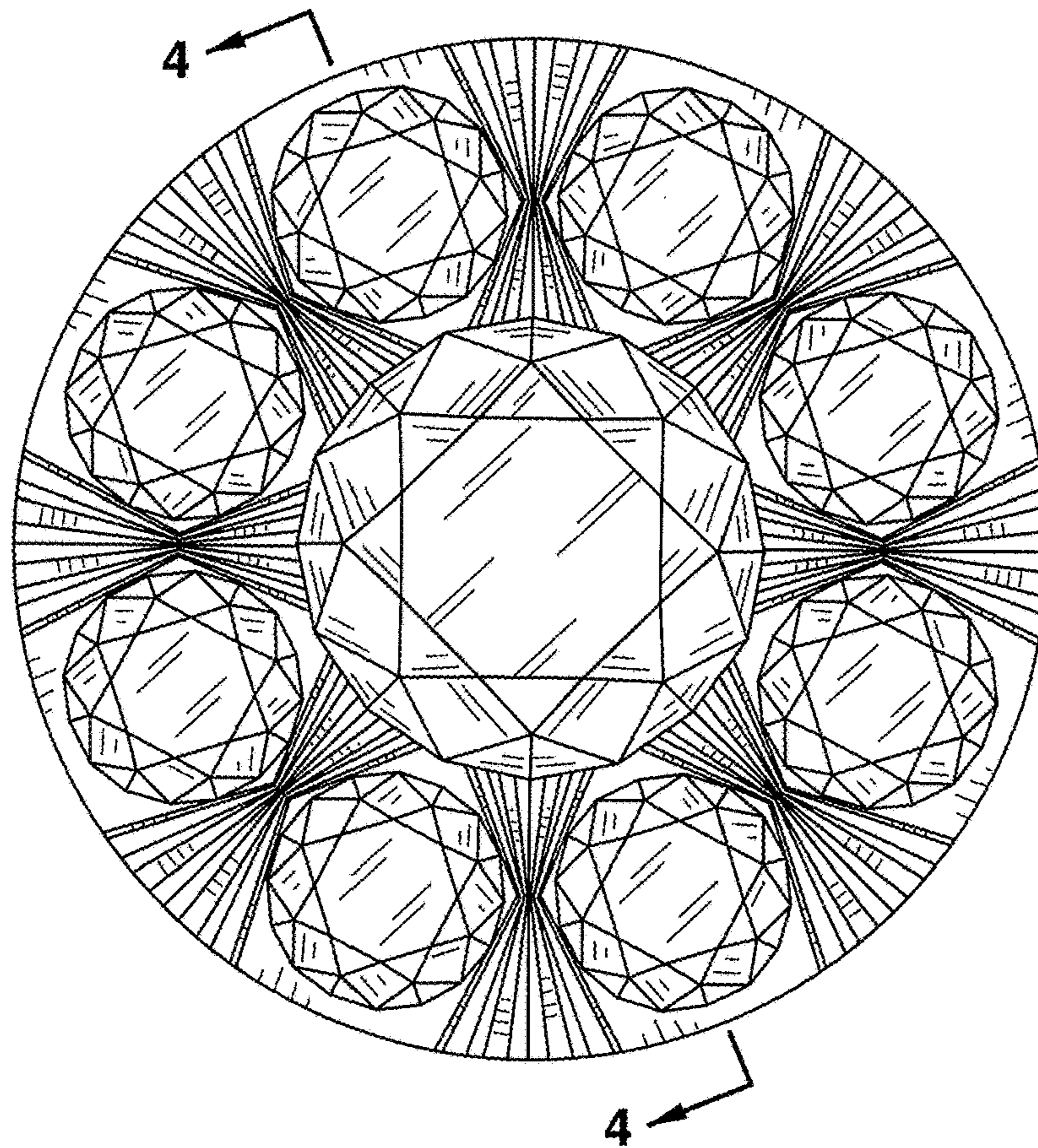

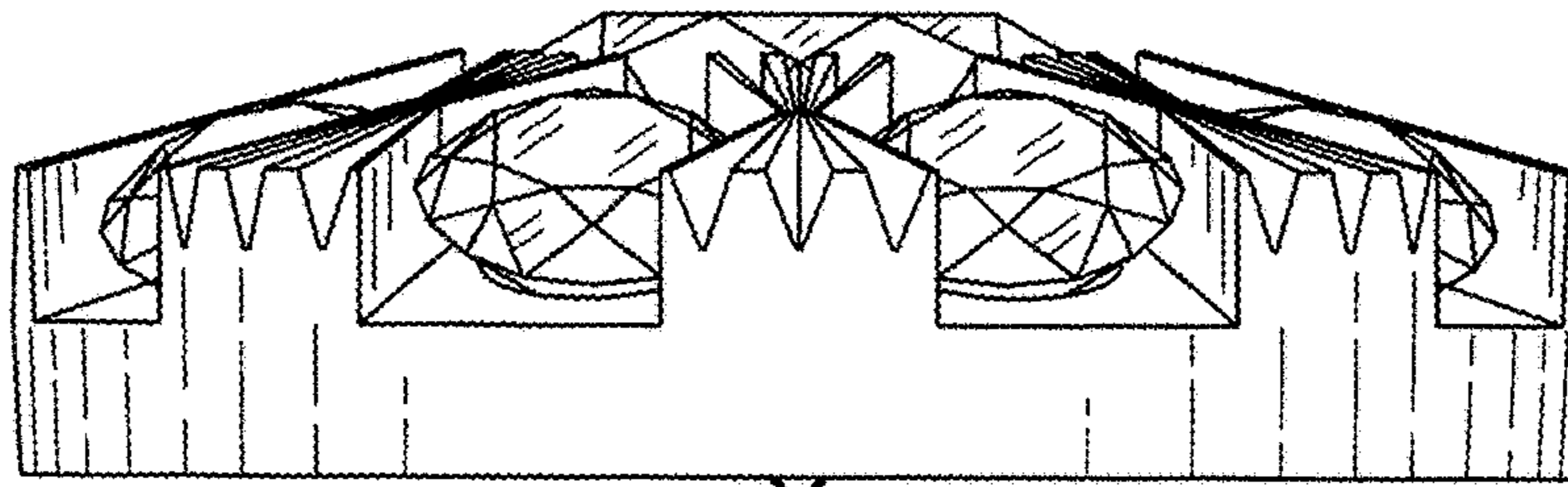

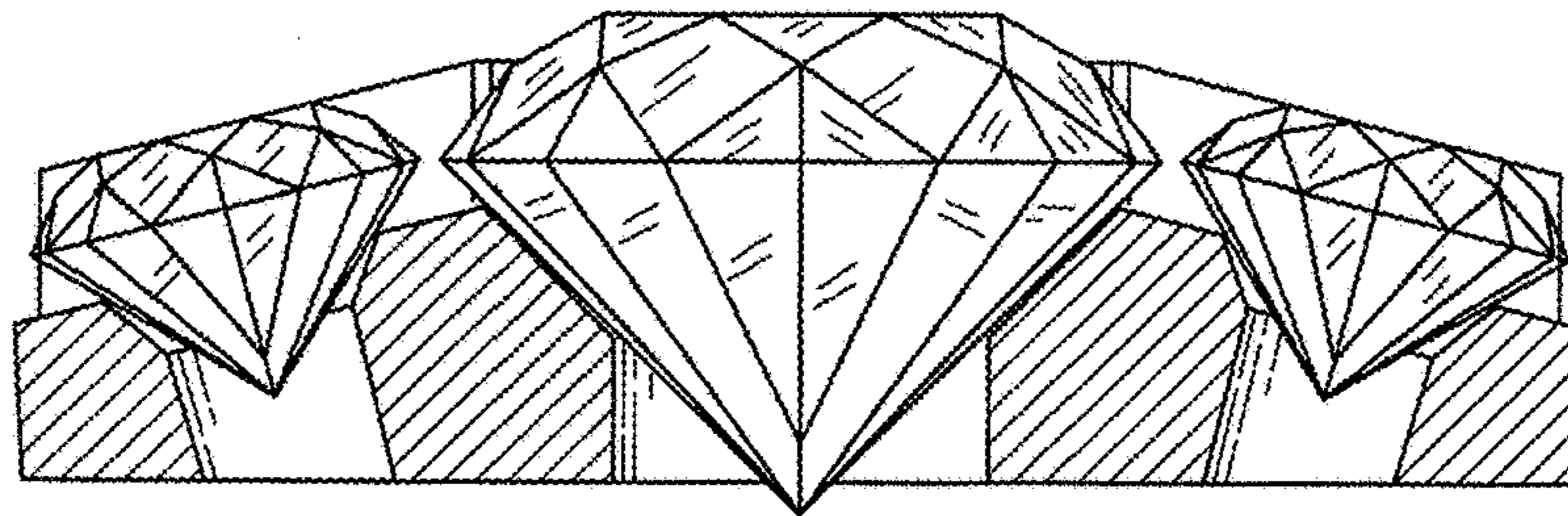

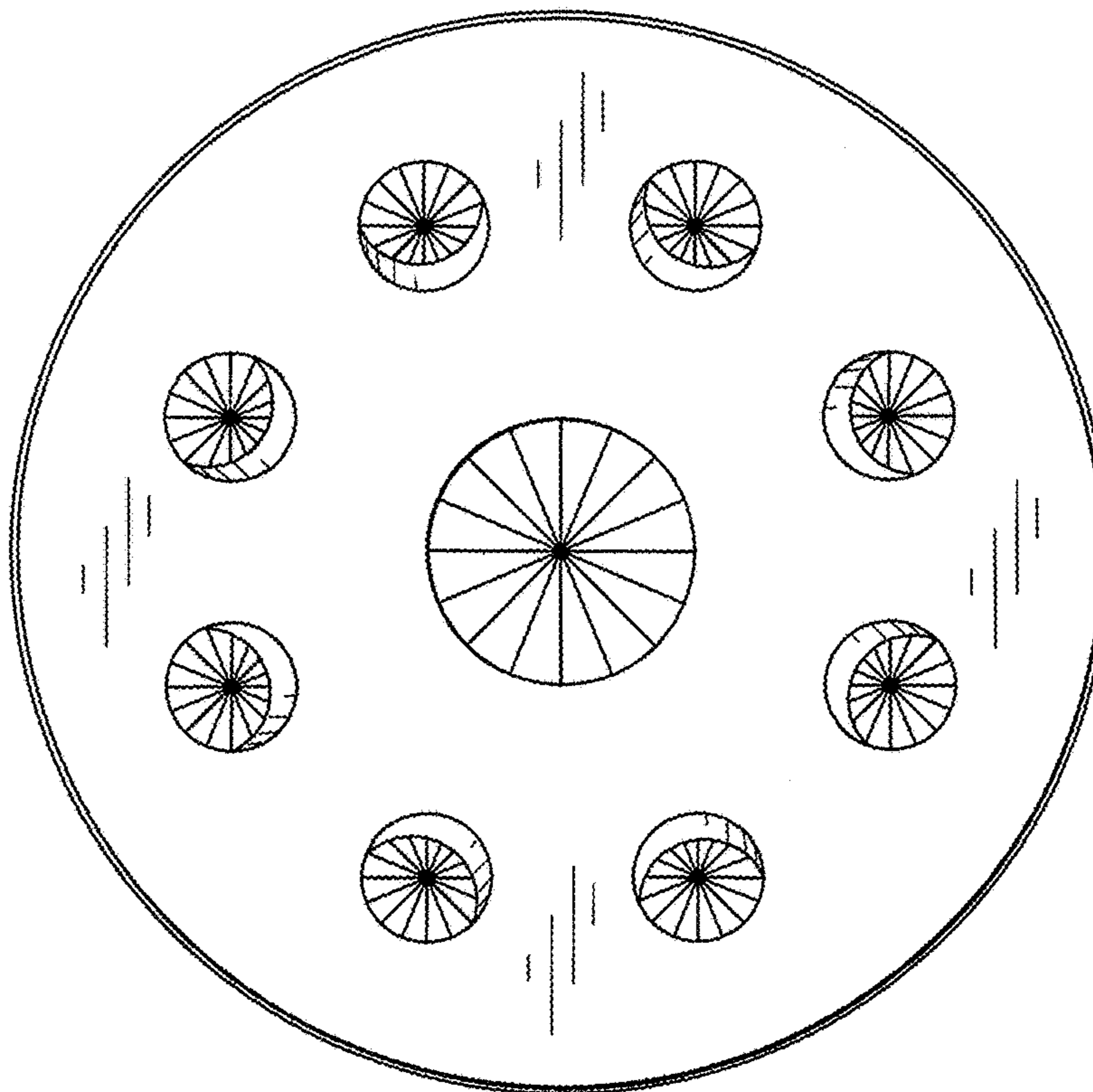
