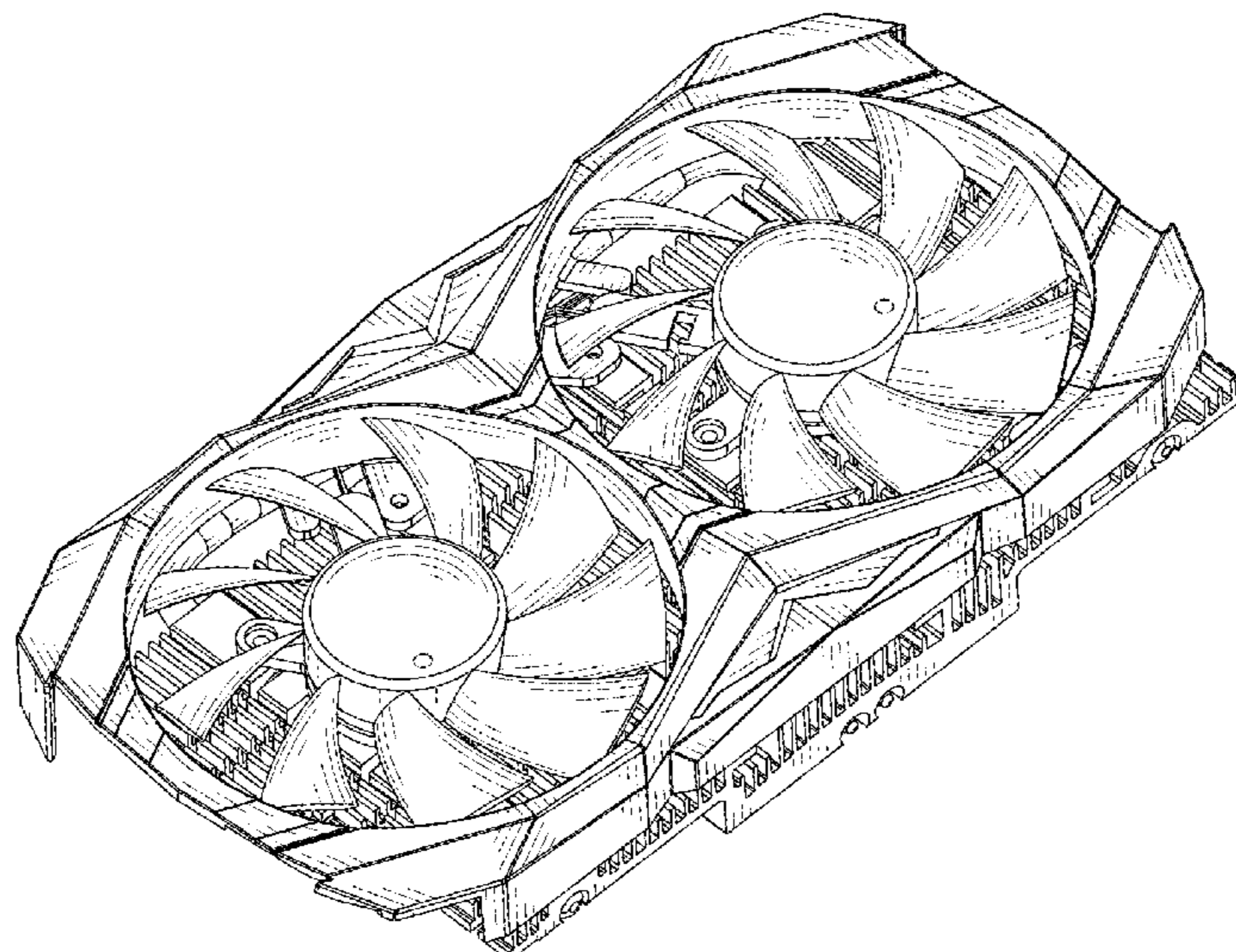
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a graphic card radiator, showing my new design;
FIG. 2 is a bottom perspective view thereof;

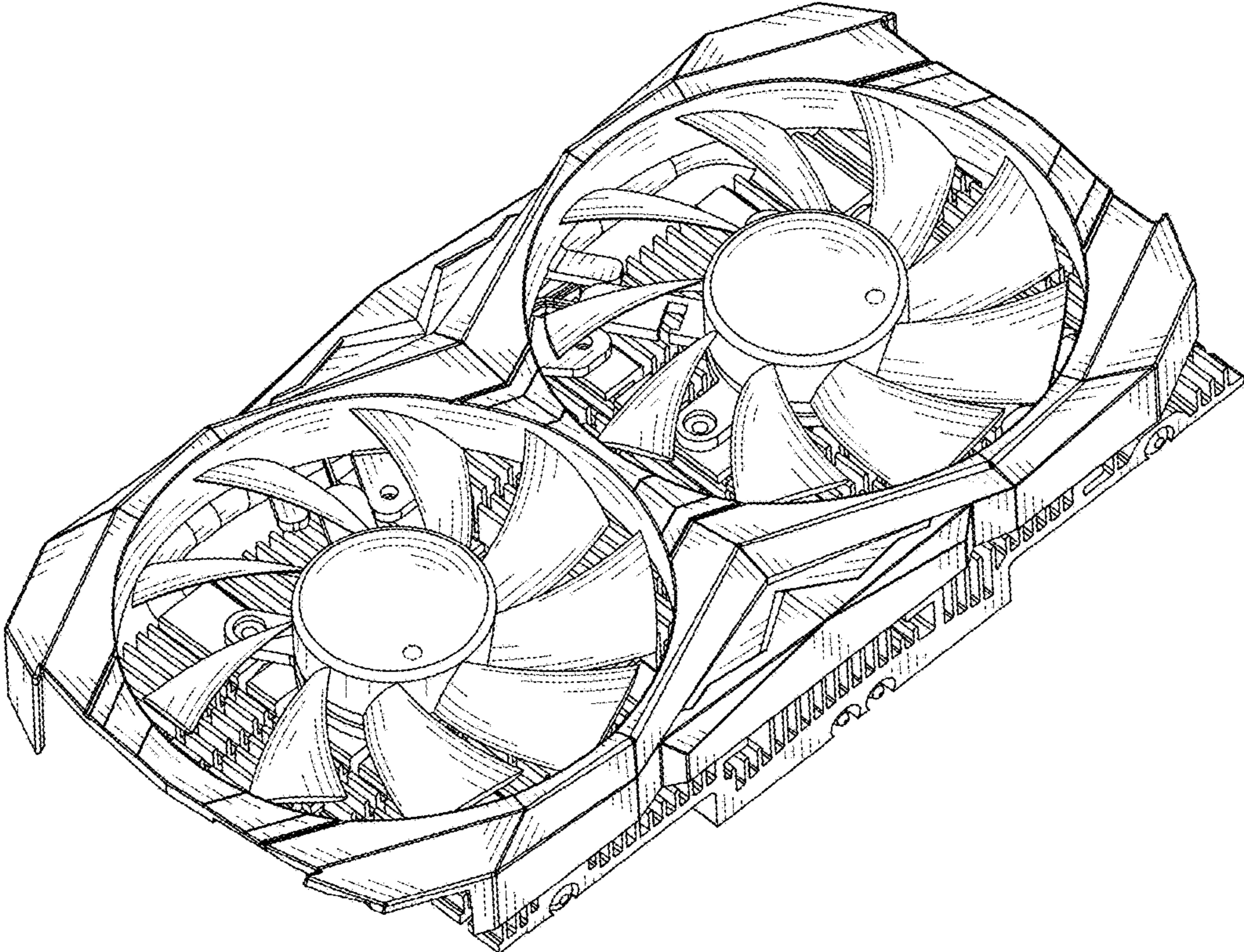

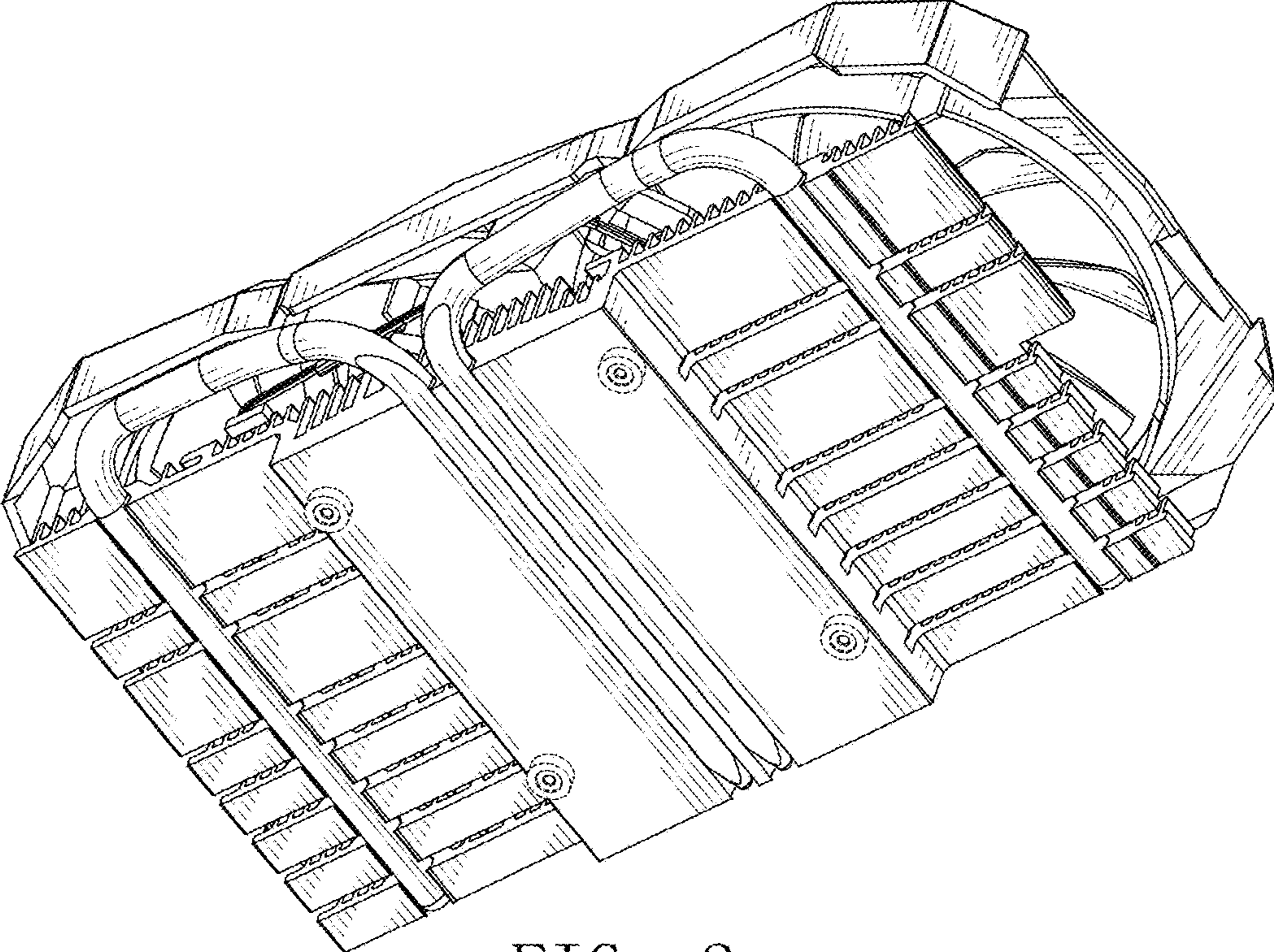

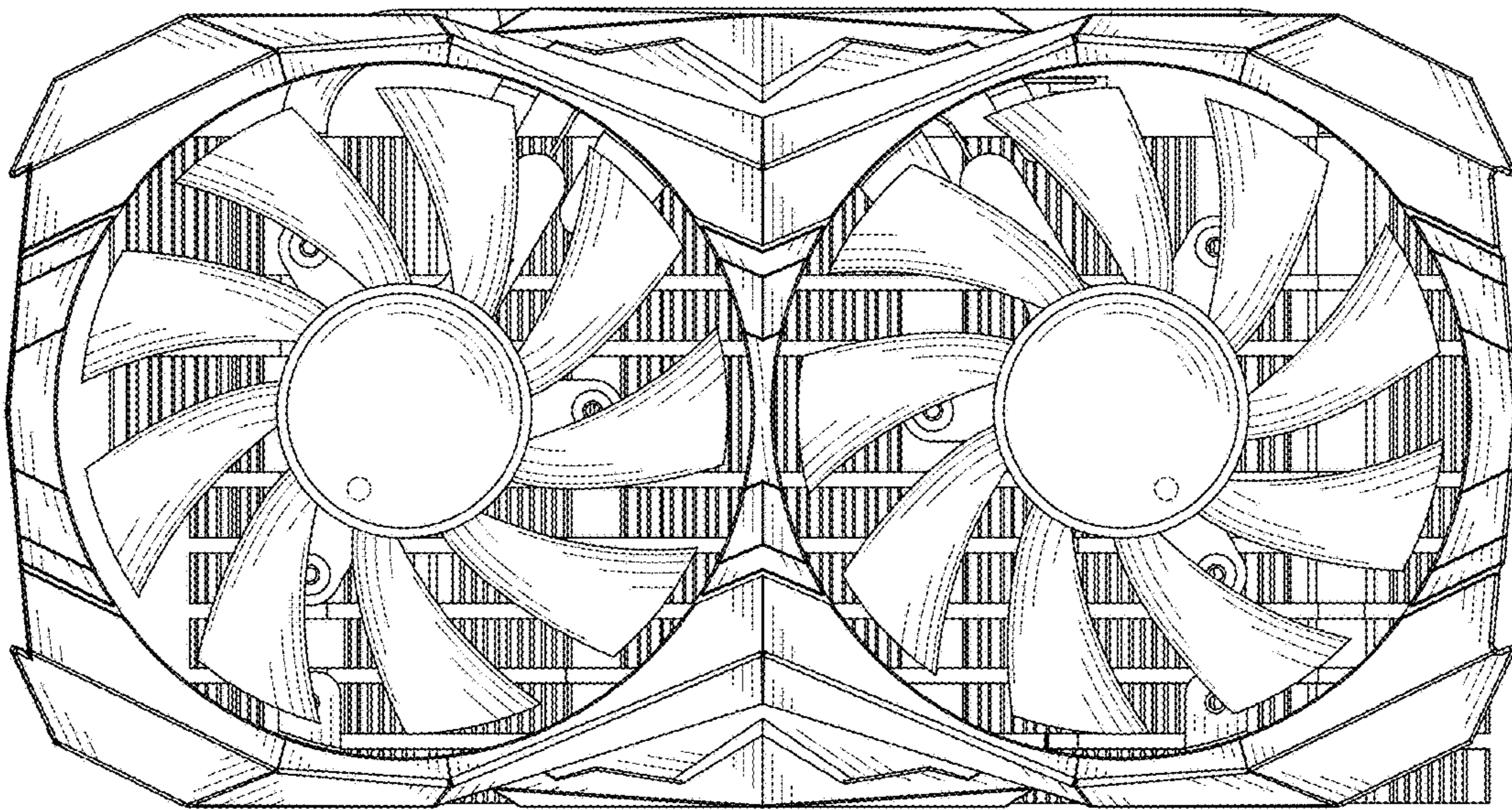

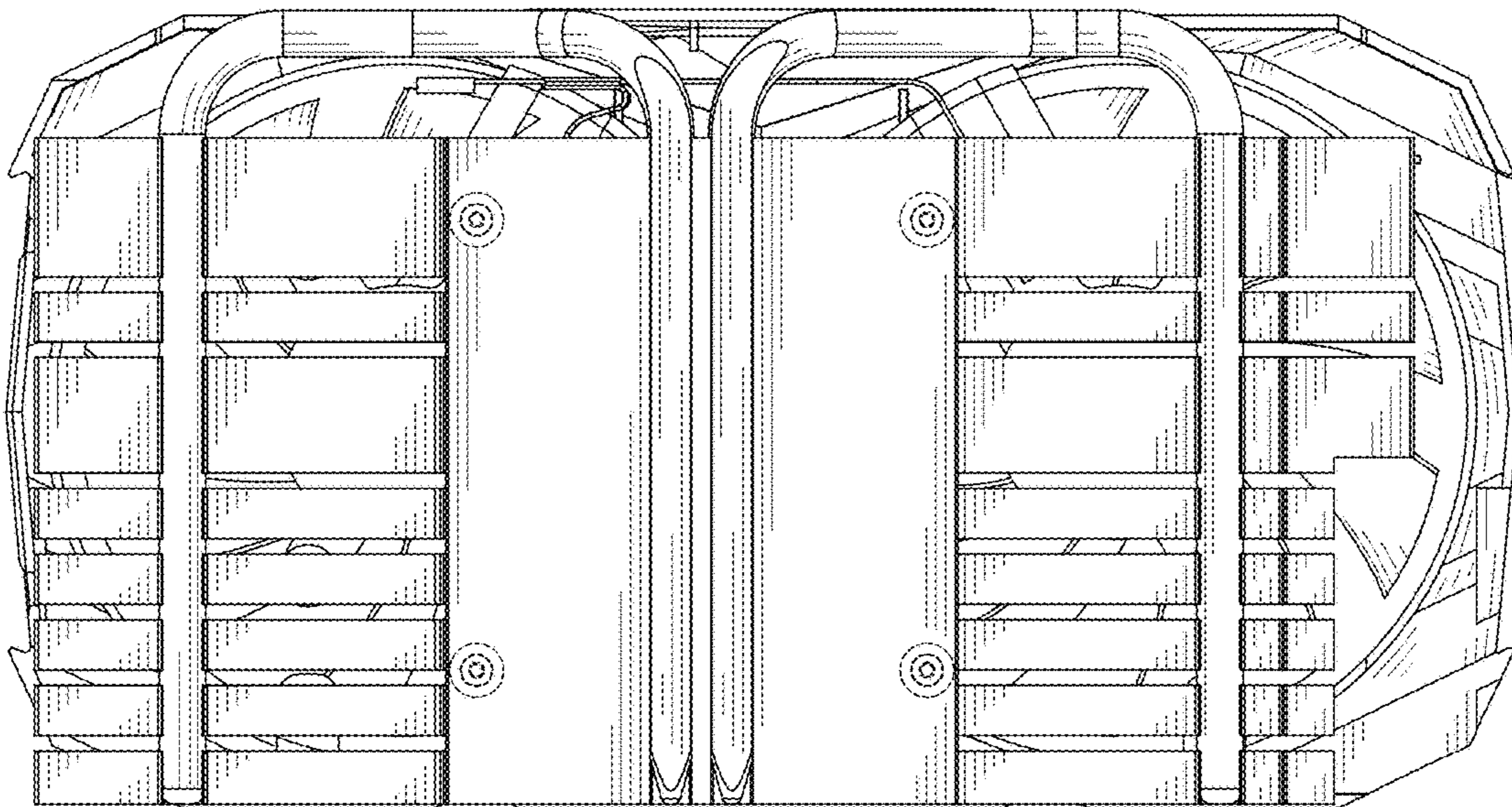

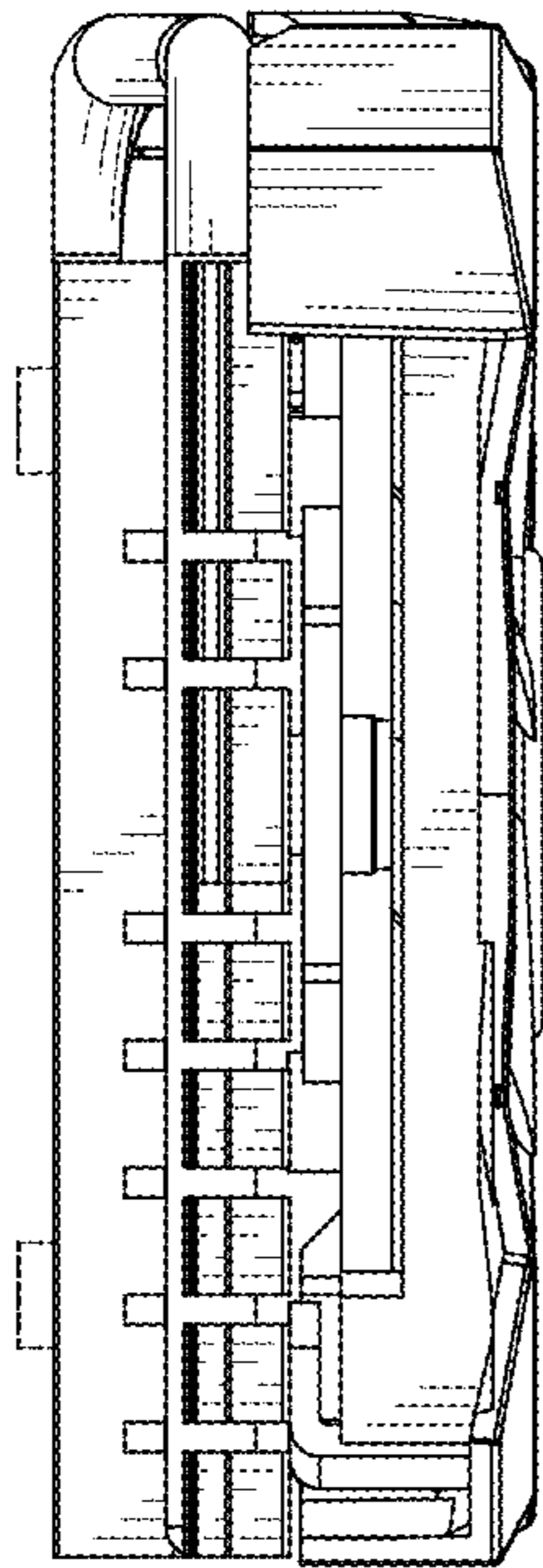

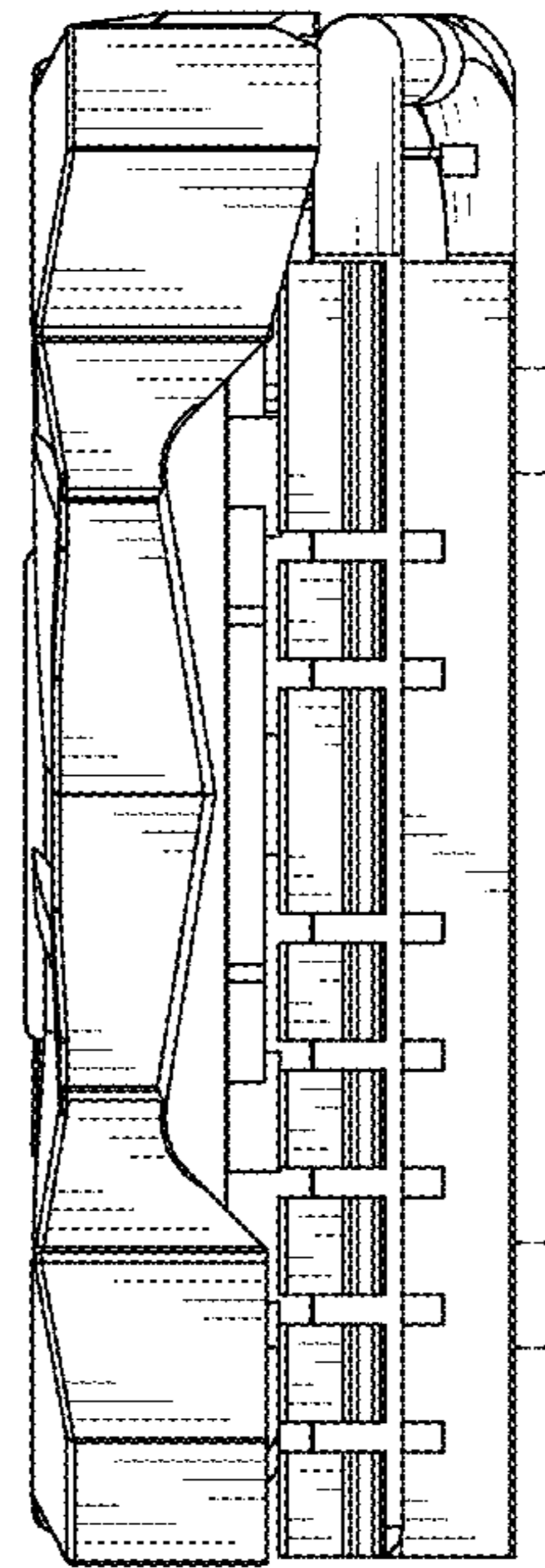

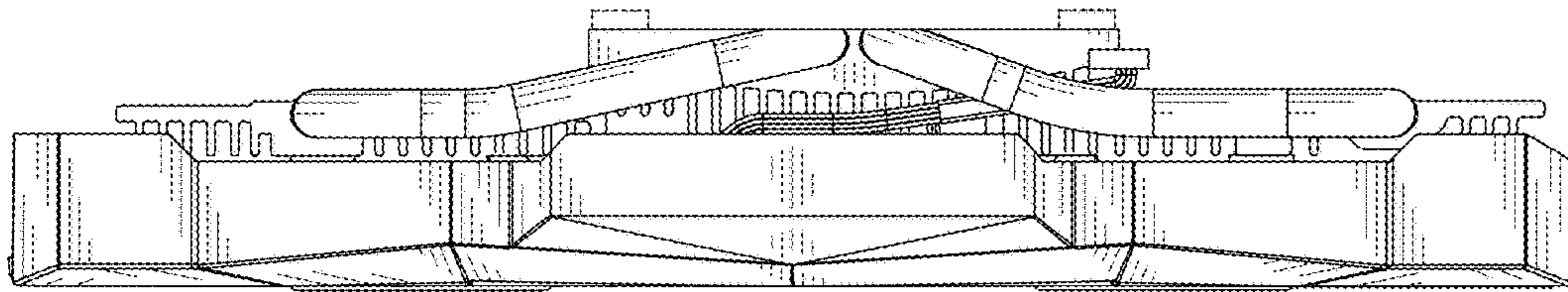

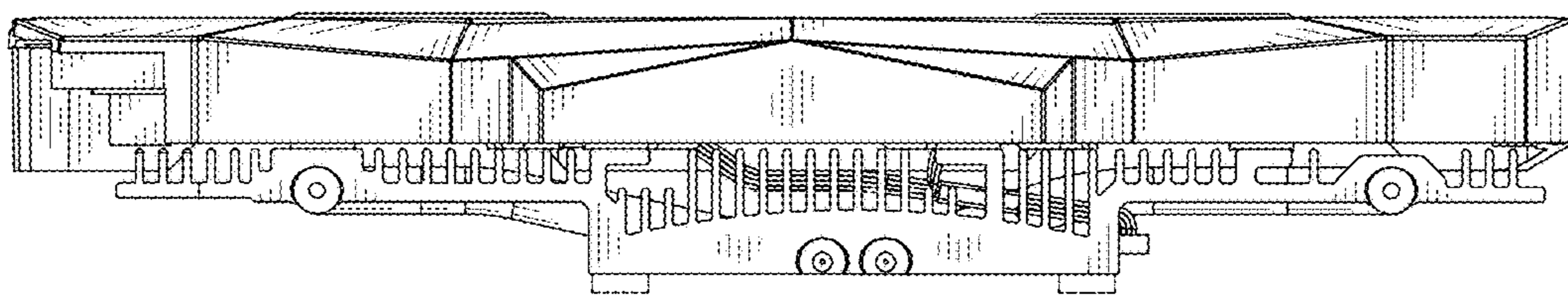
