FIG. 5 is a top view thereof;

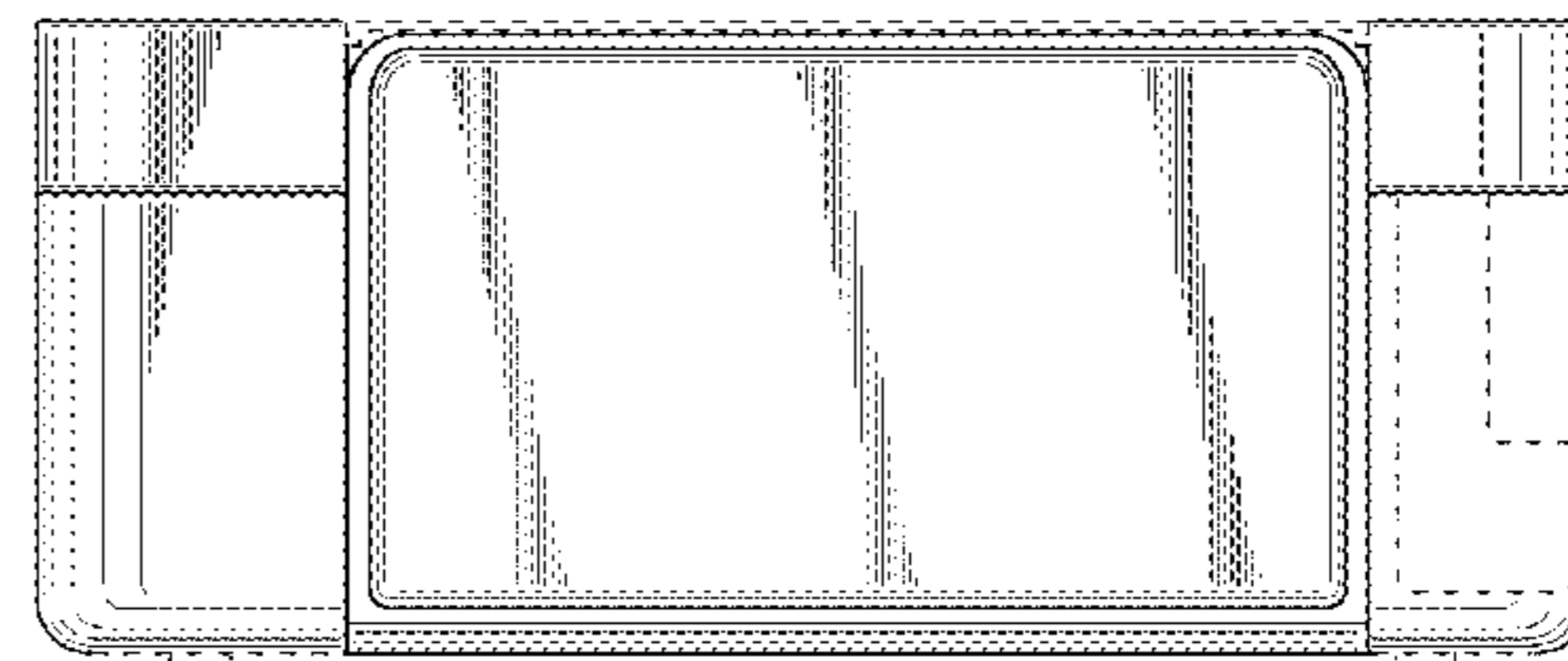
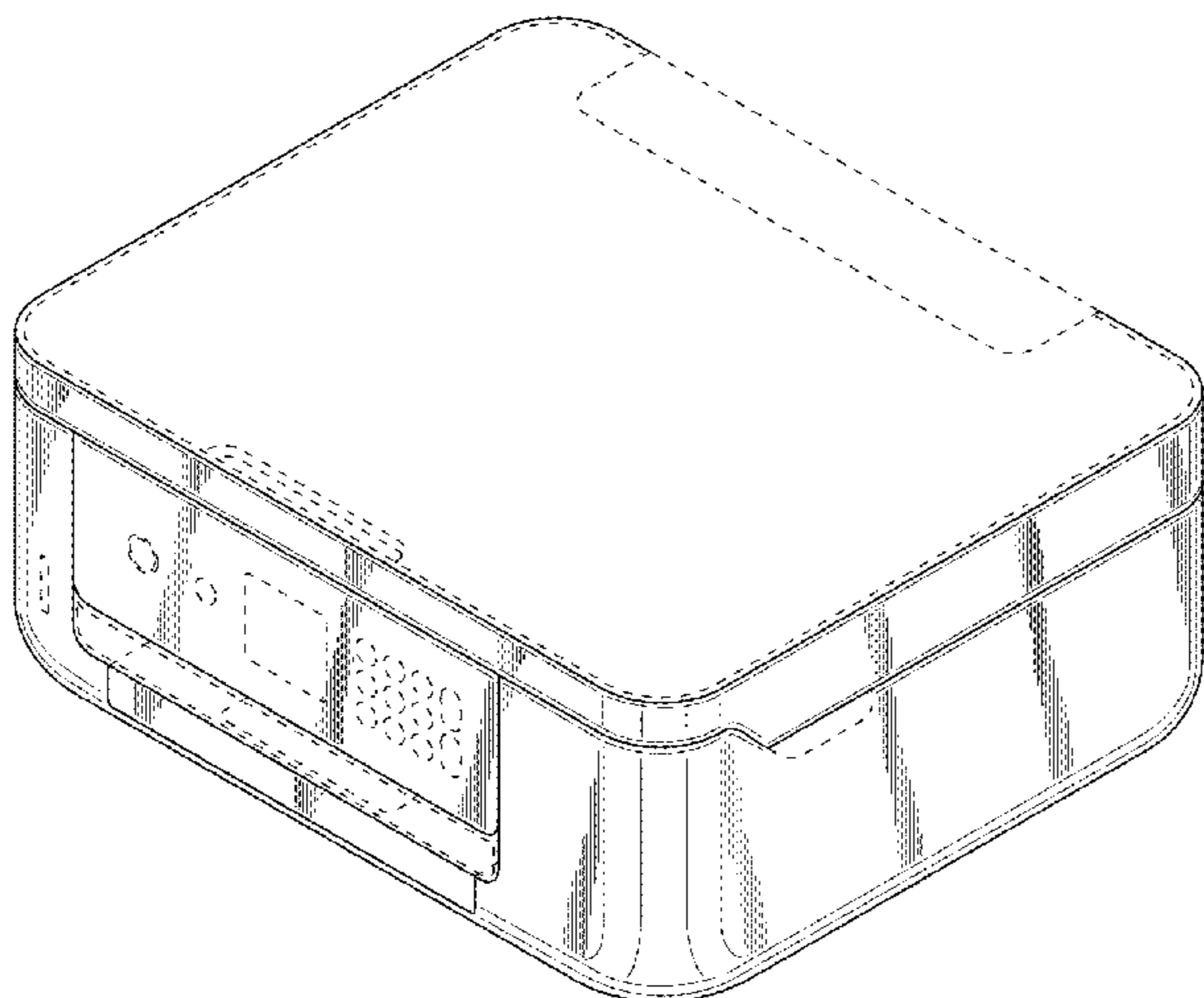
FIG. 6 is a bottom view thereof;

FIG. 7 is a right side view thereof; and,

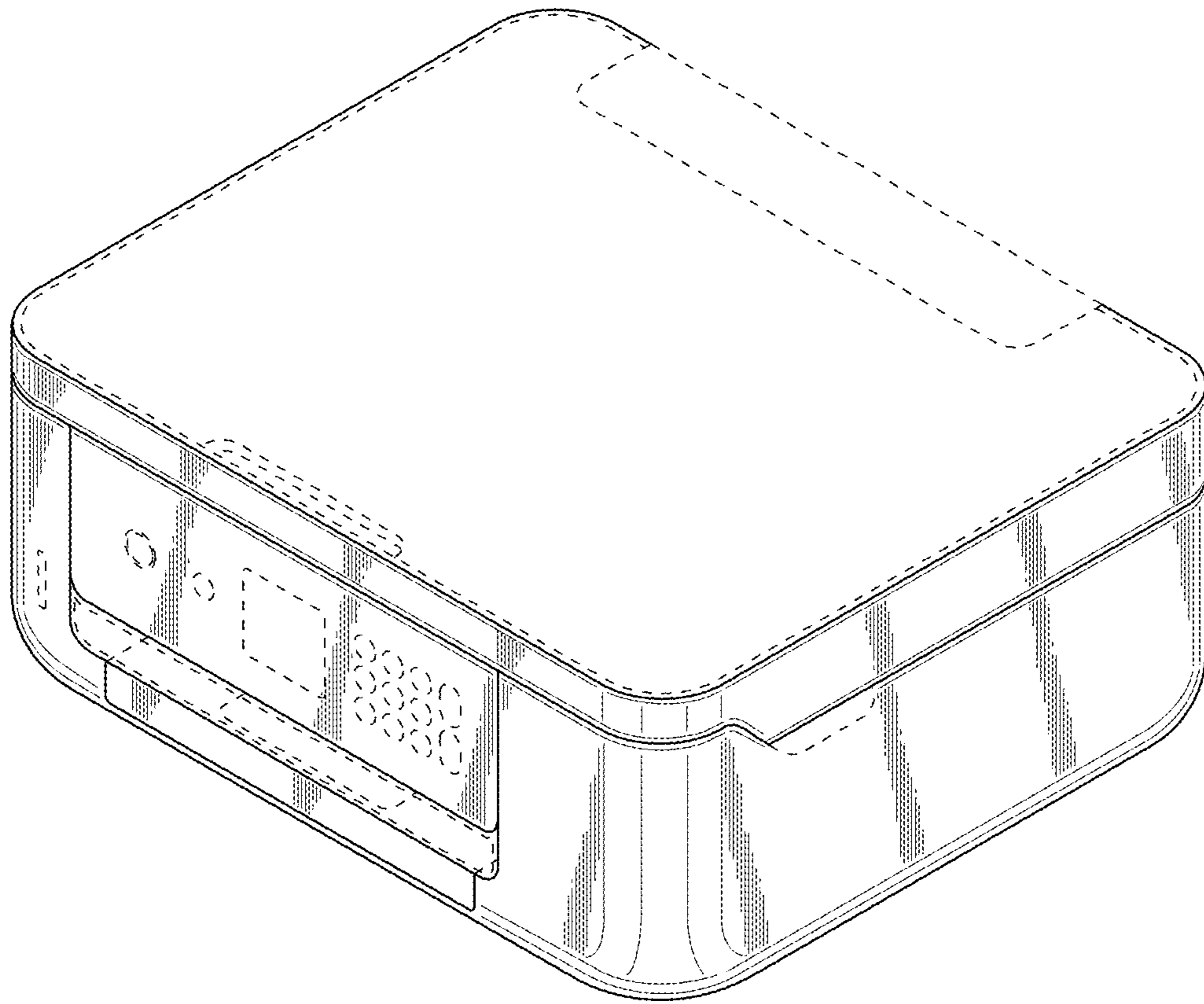
FIG. 8 is a left side view thereof.

The broken lines illustrate portions of the printer and form no part of the claimed design.

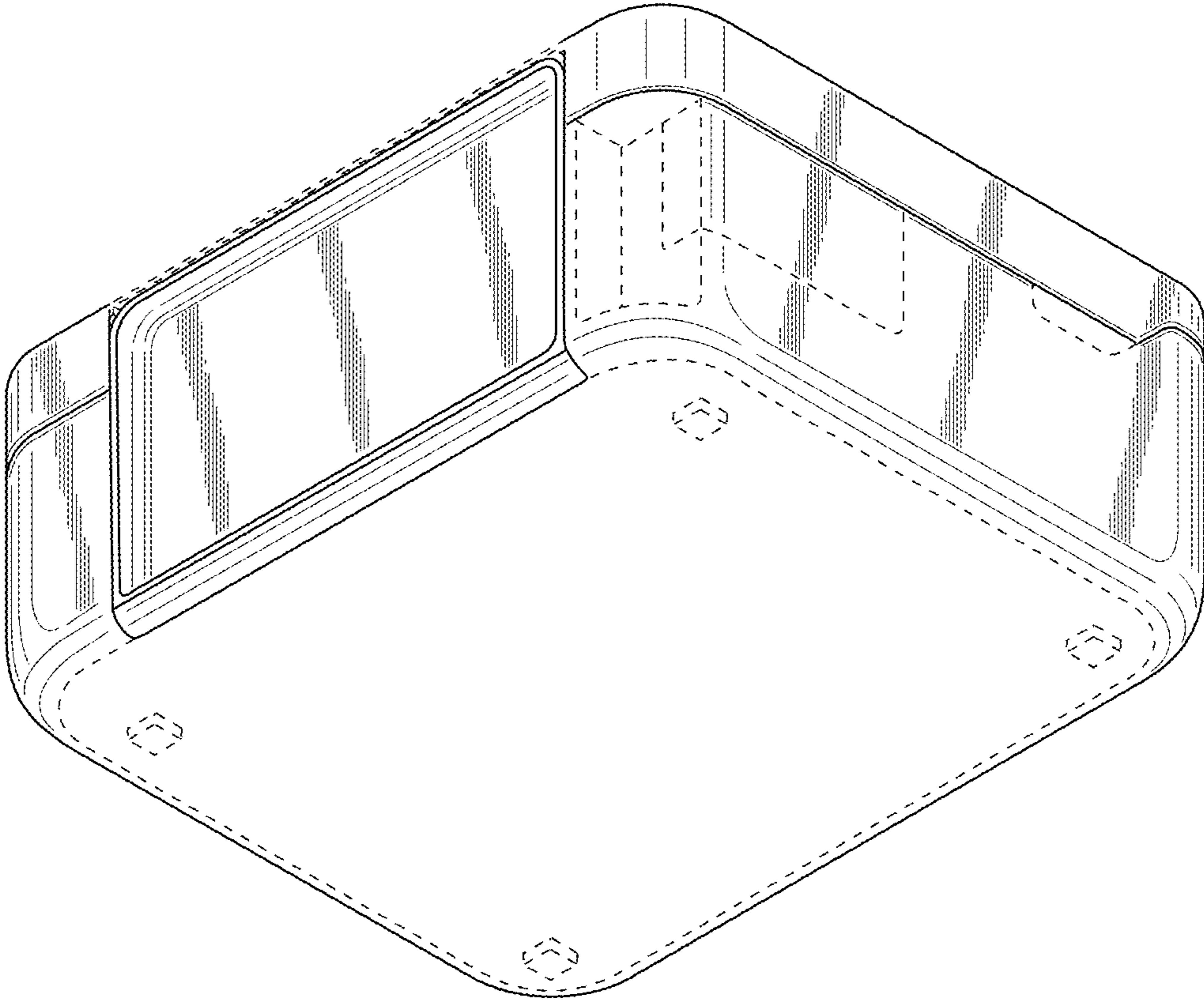

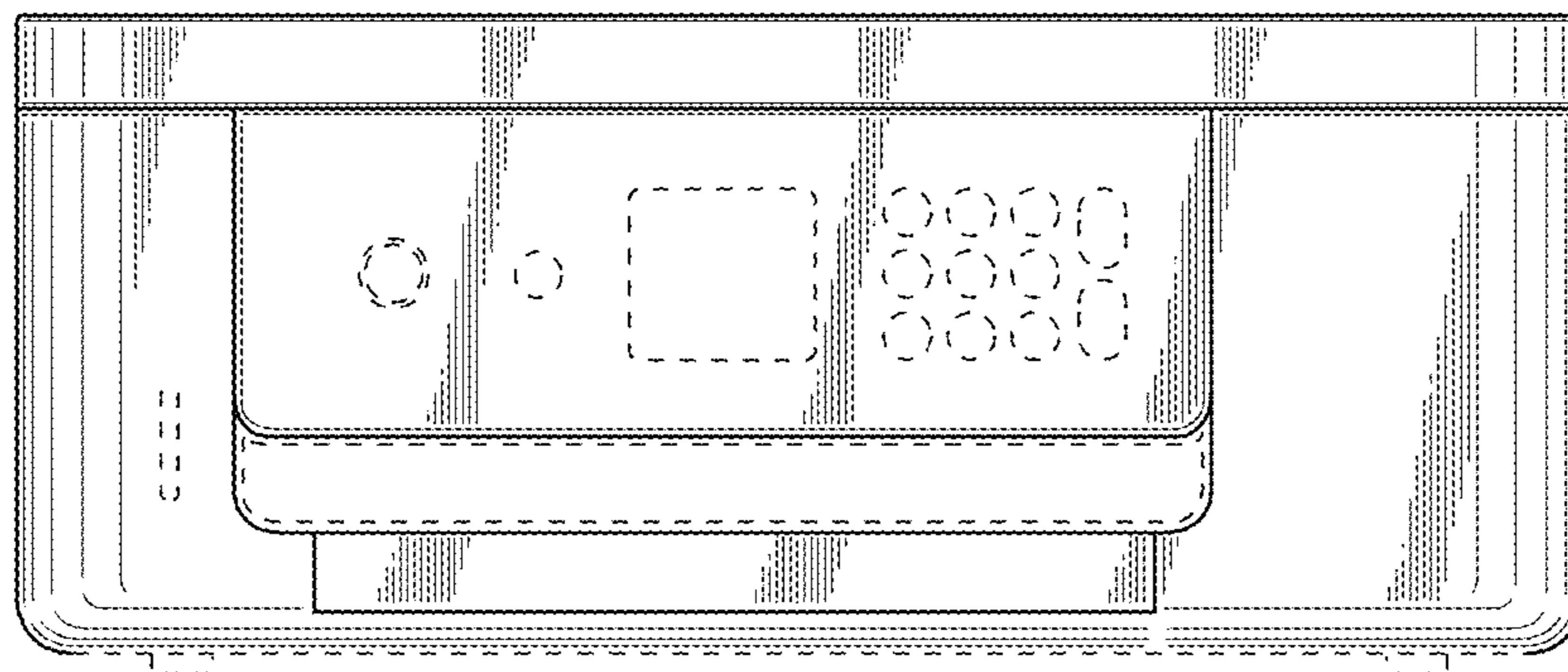

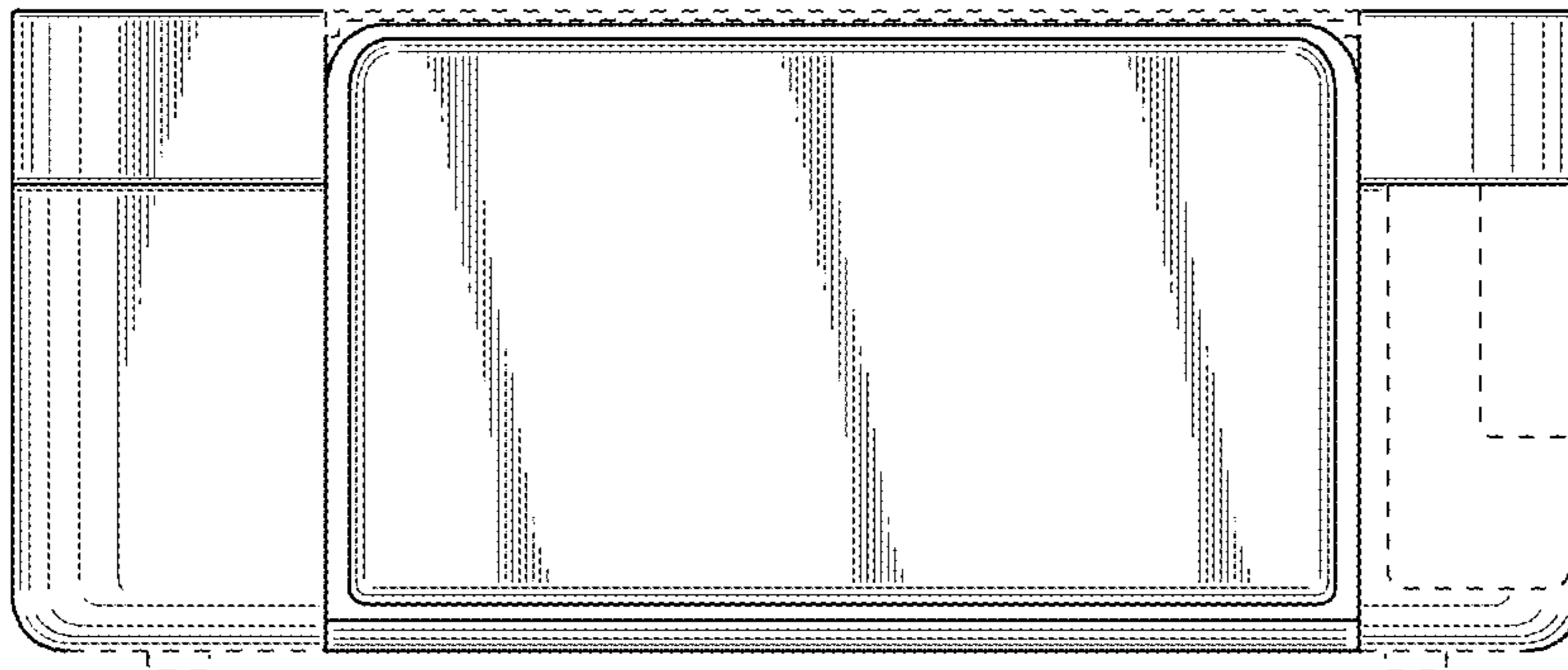

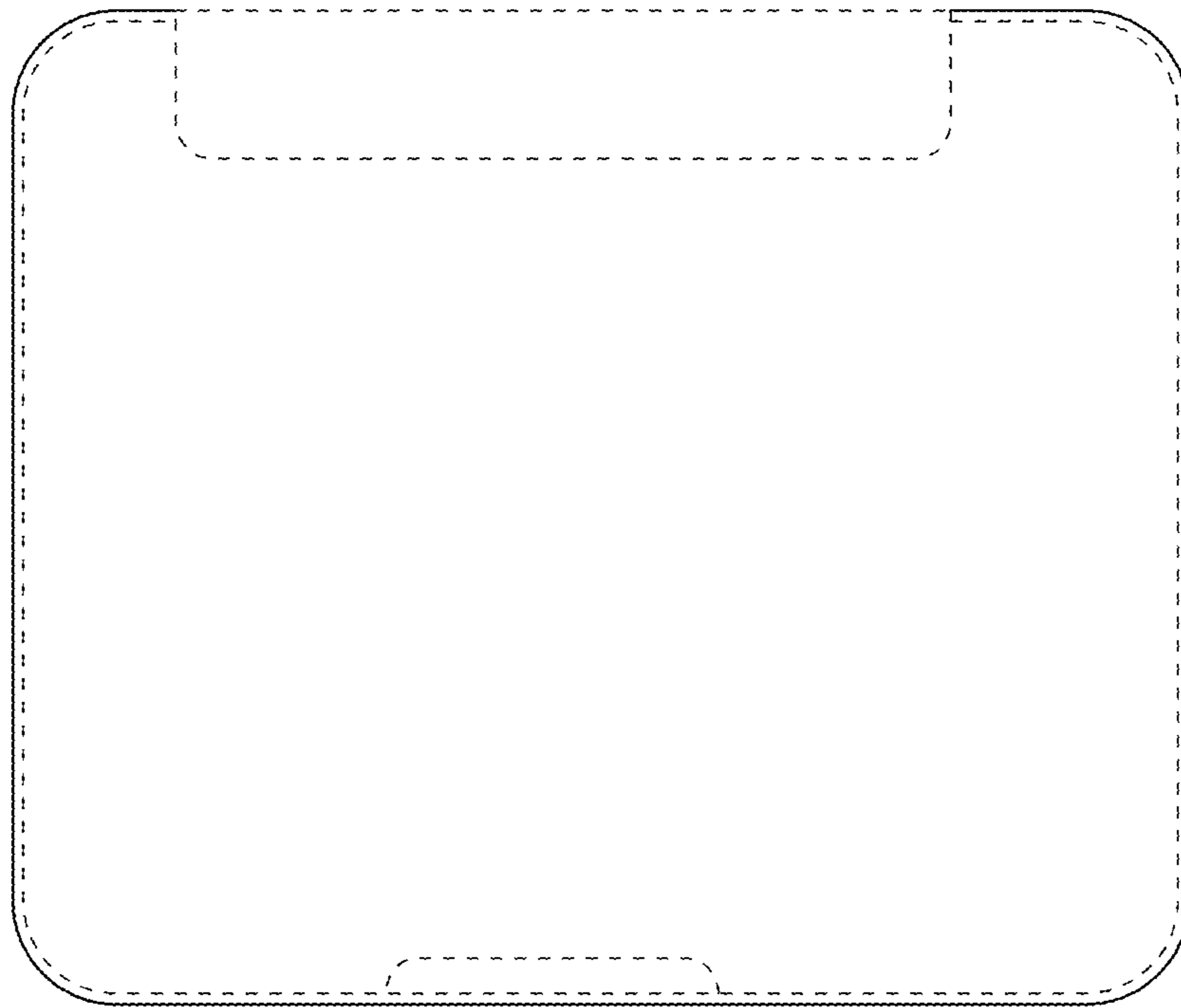

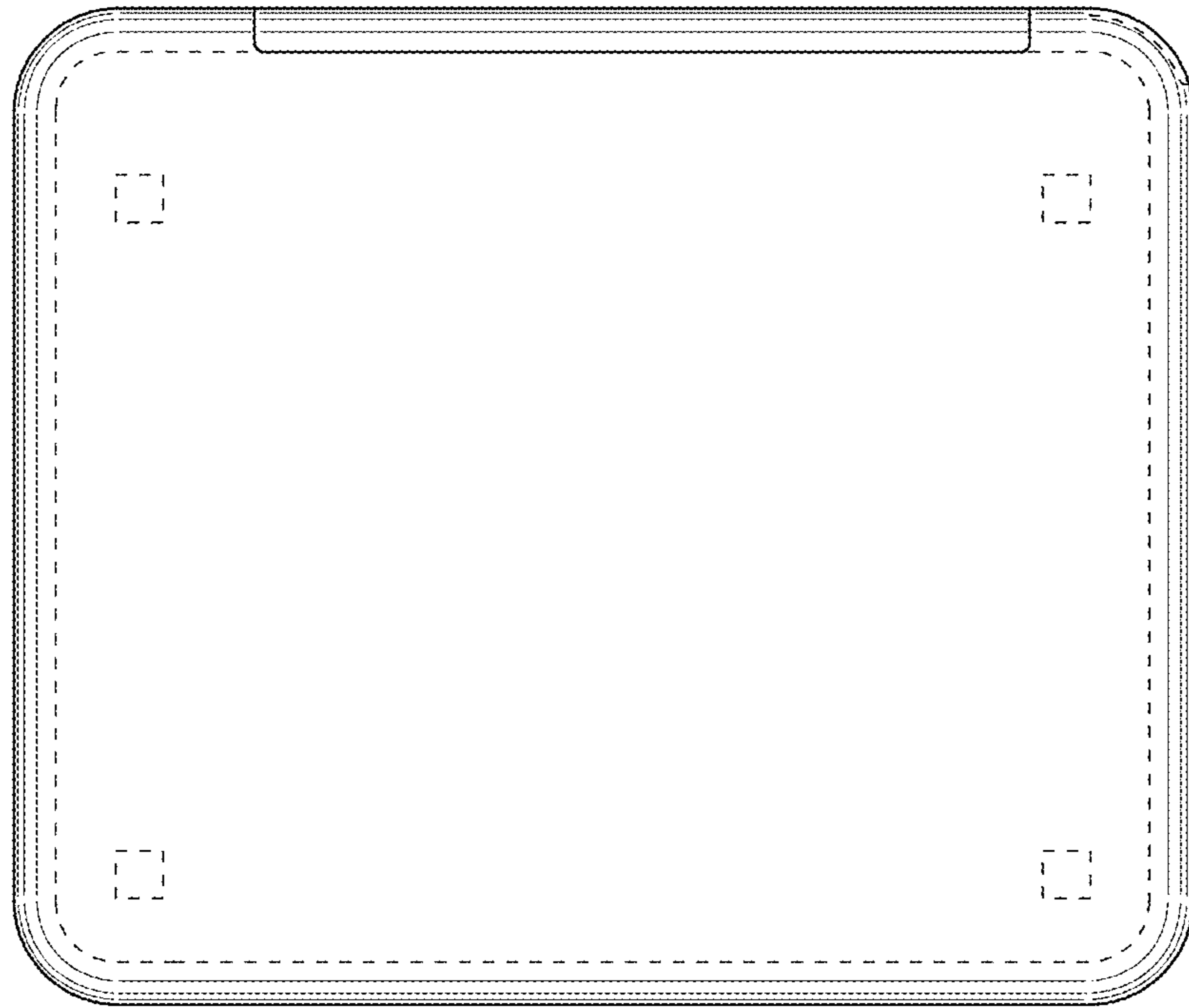

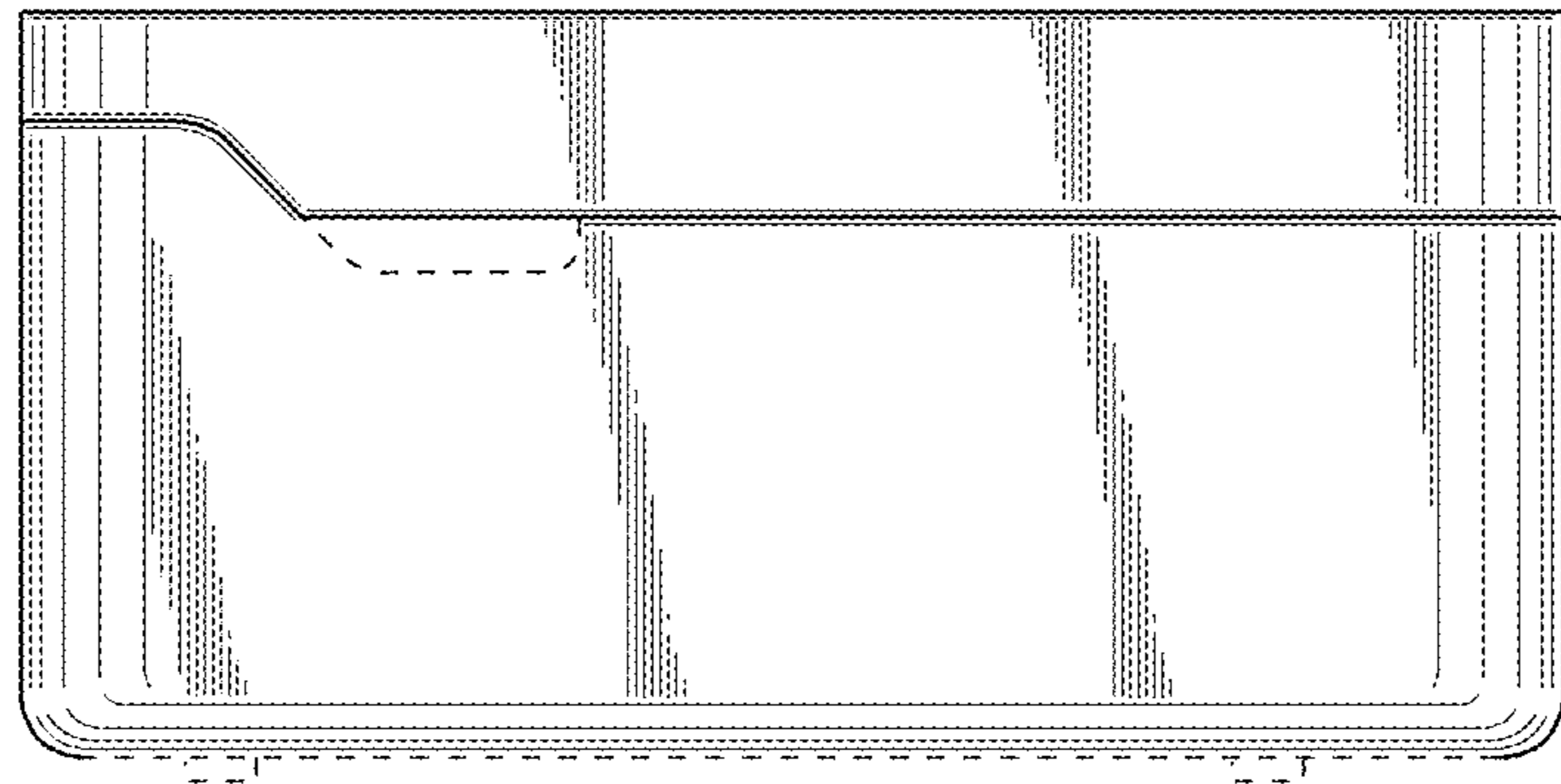
