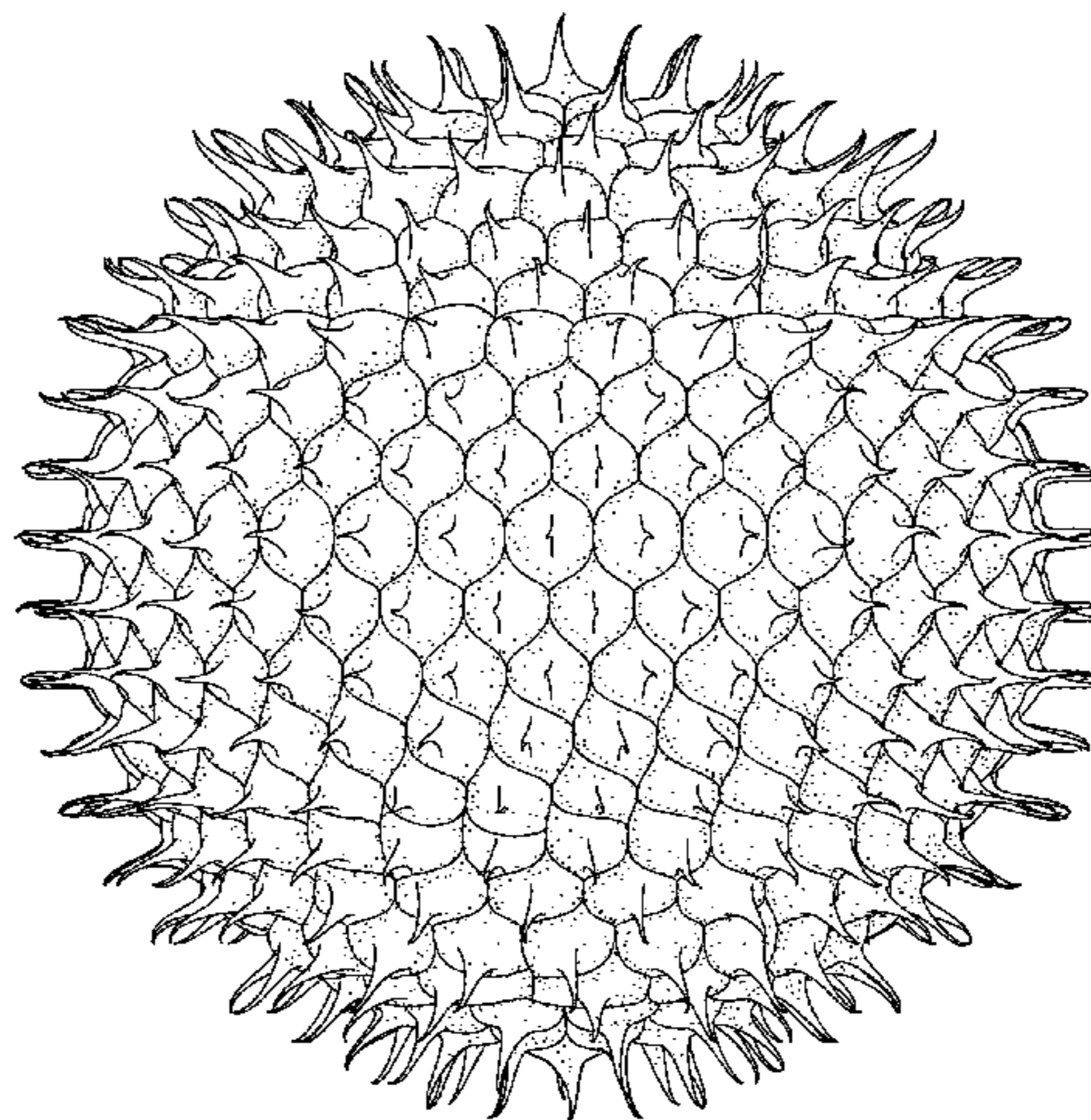
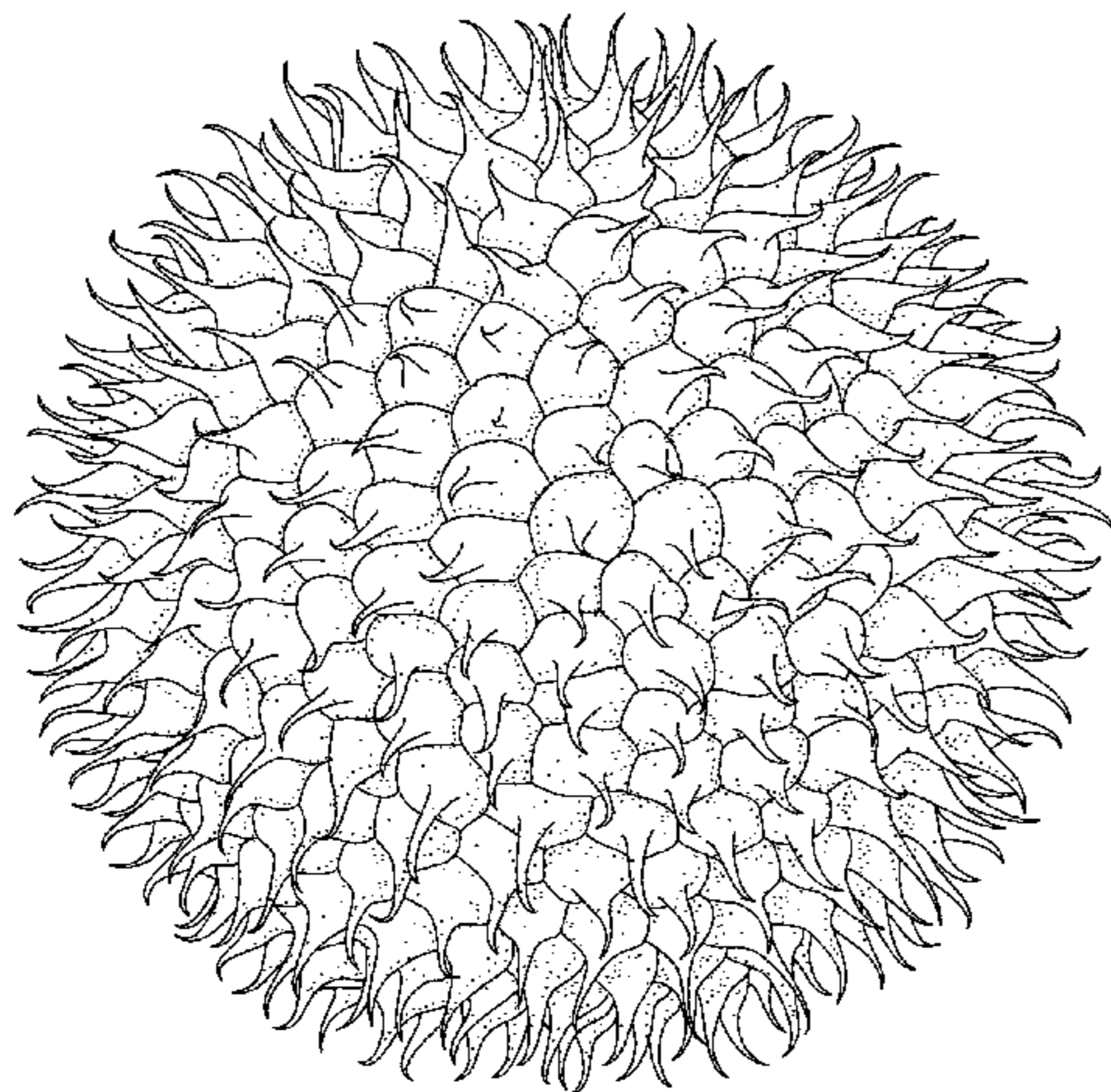

The ornamental design for a ball with tactile surface, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ball with tactile surface; FIG. 2 is a front view of the ball with tactile surface; FIG. 3 is a back view of the ball with tactile surface; FIG. 4 is a left view of the ball with tactile surface; FIG. 5 is a right view of the ball with tactile surface; FIG. 6 is a top view of the ball with tactile surface; and, FIG. 7 is a bottom view of the ball with tactile surface.

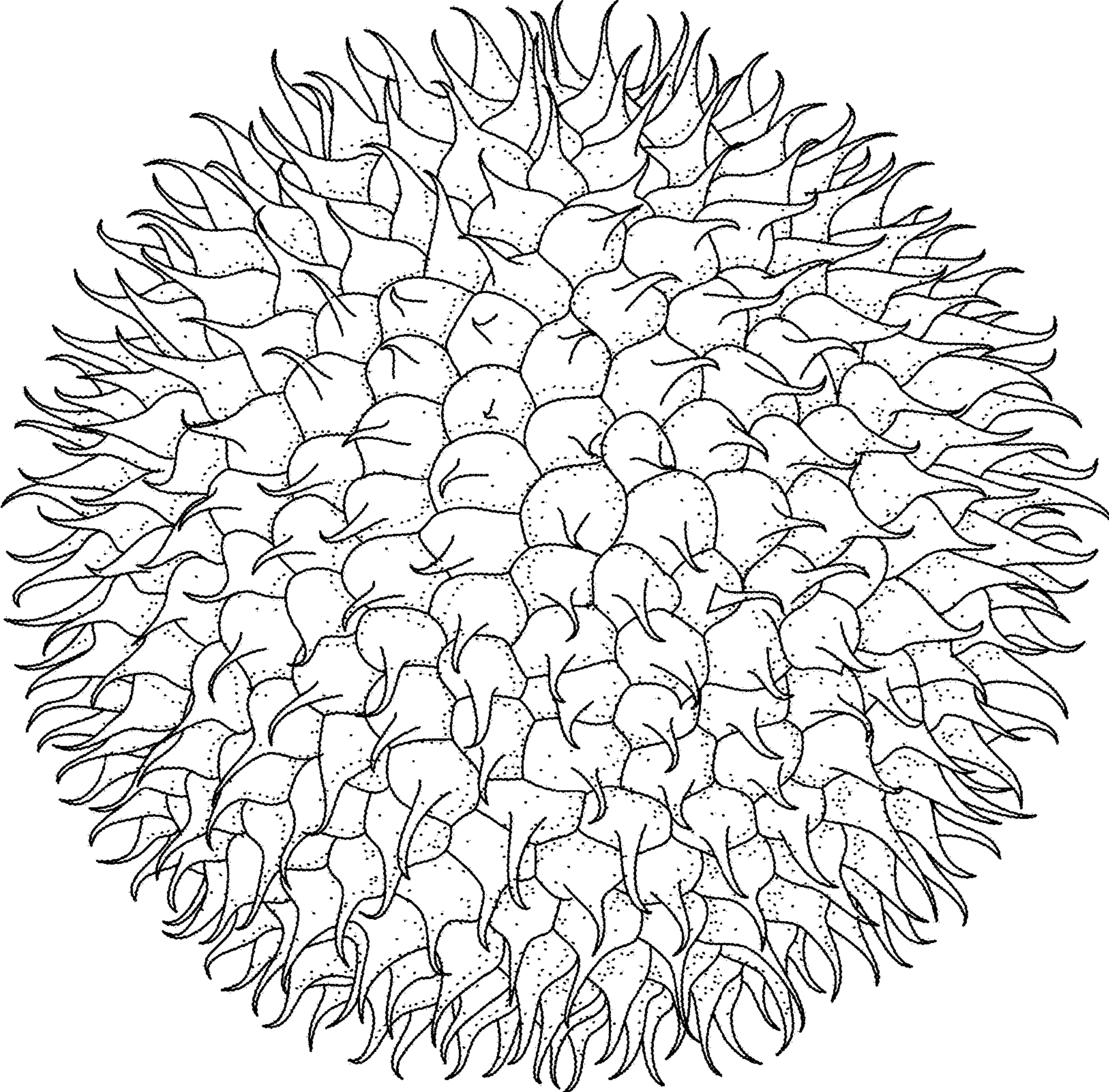

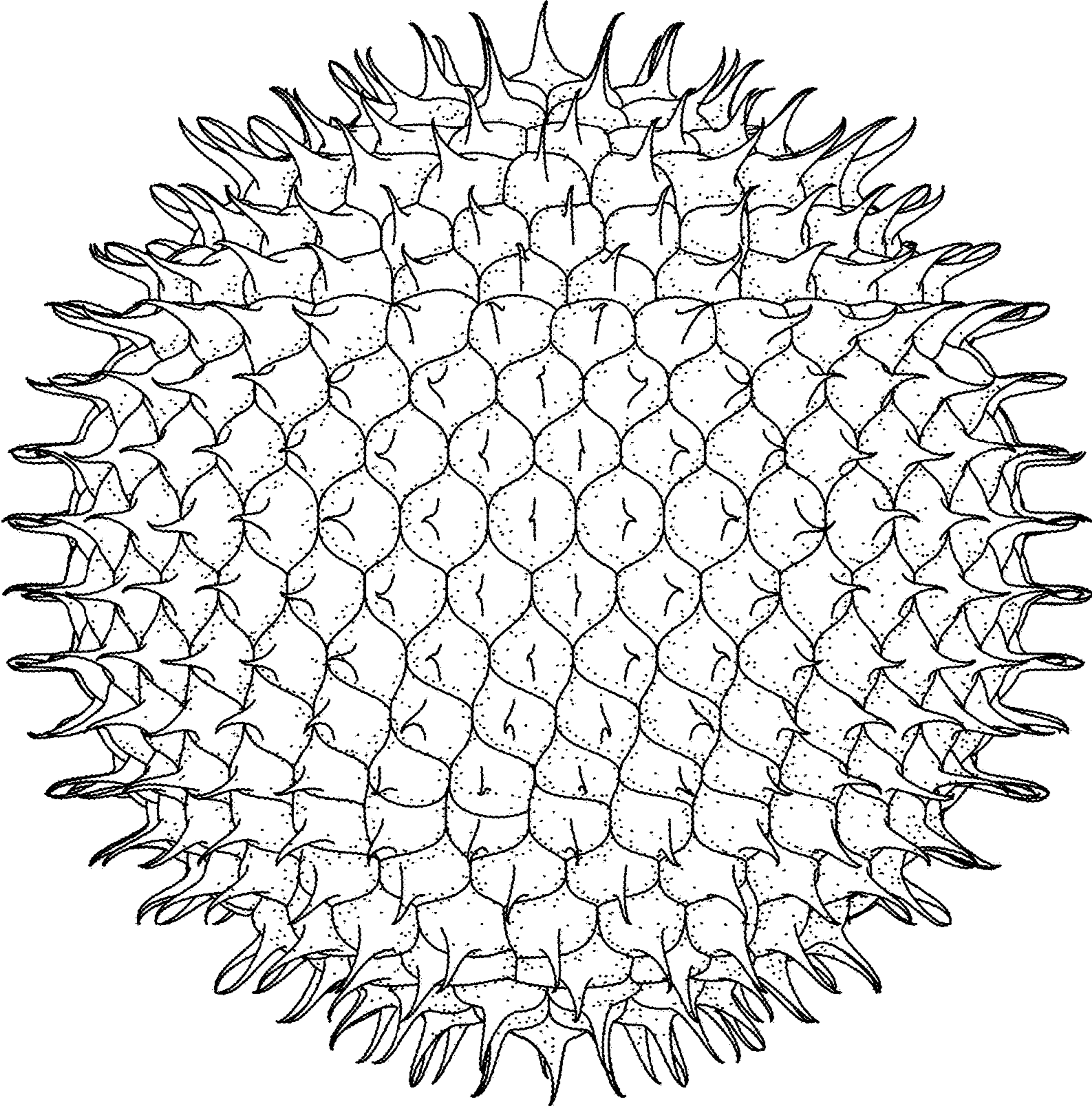

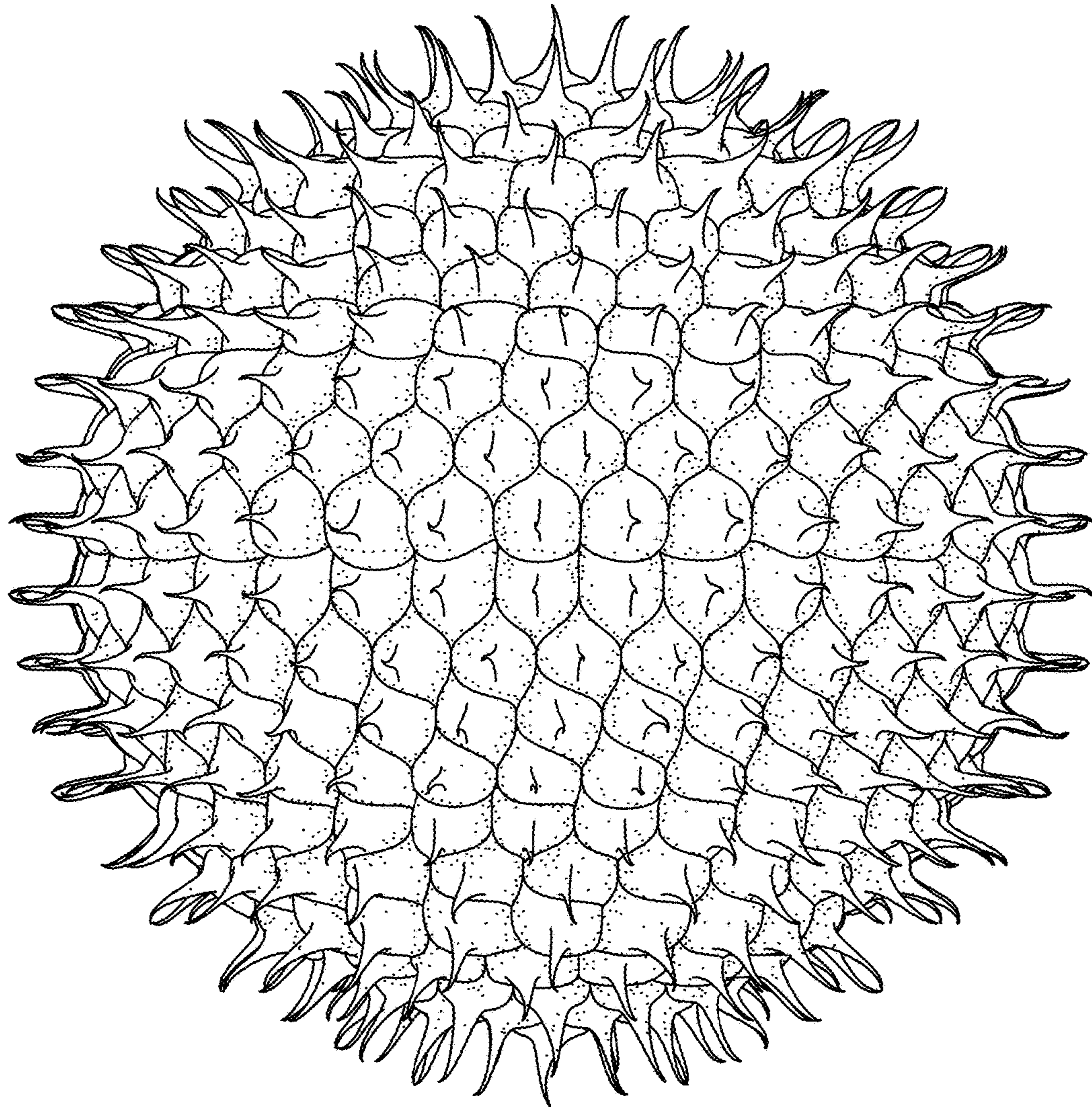

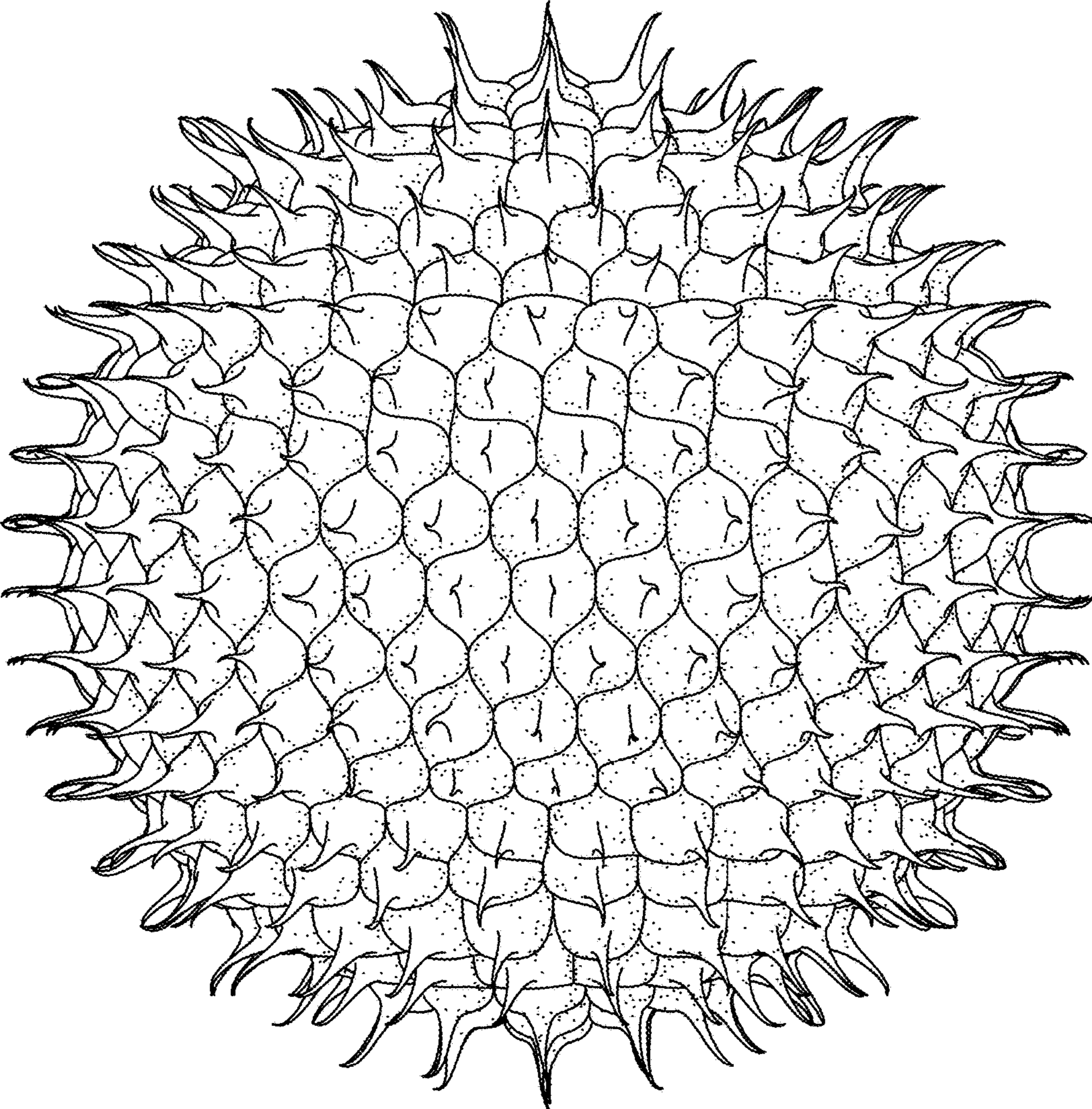

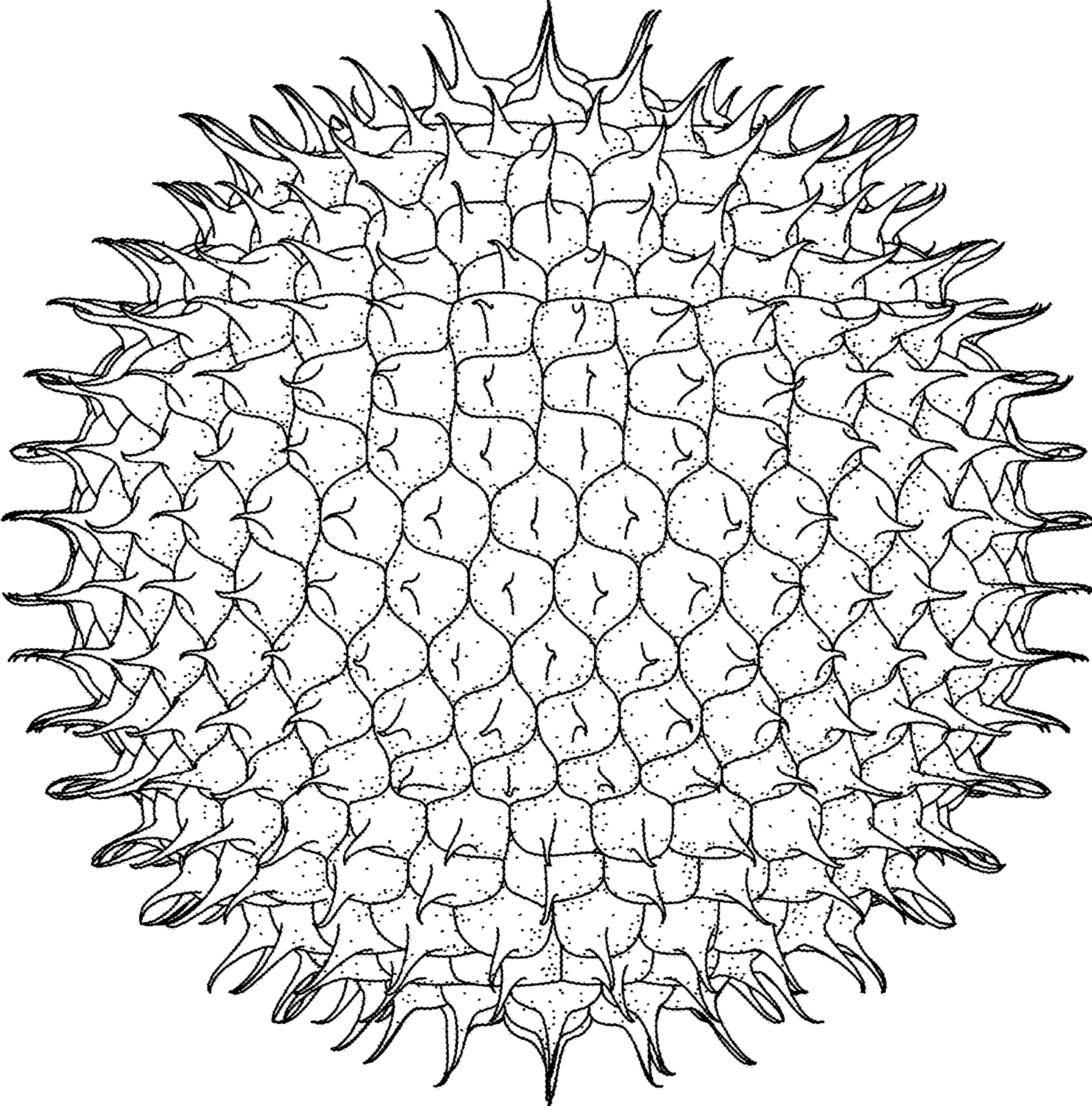

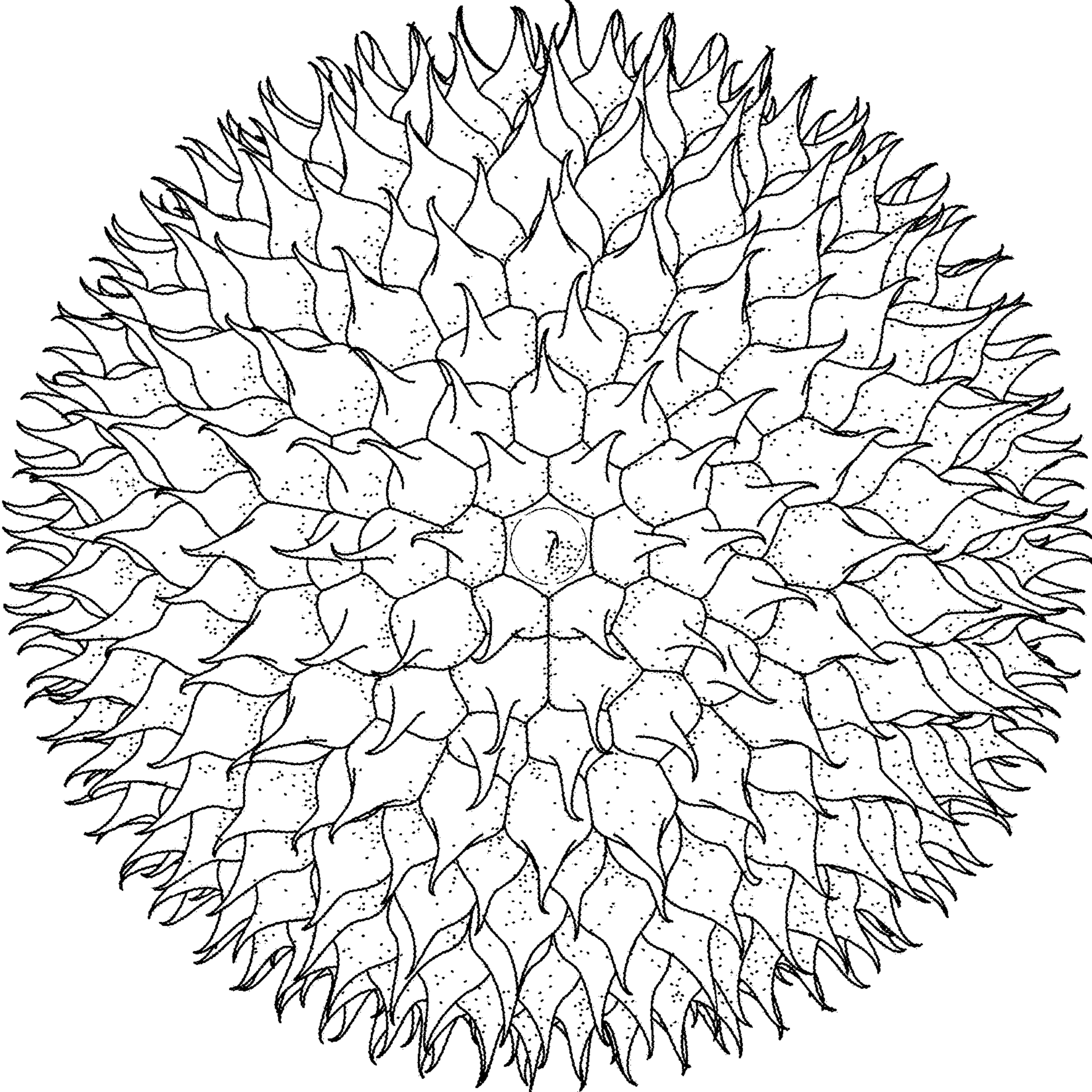

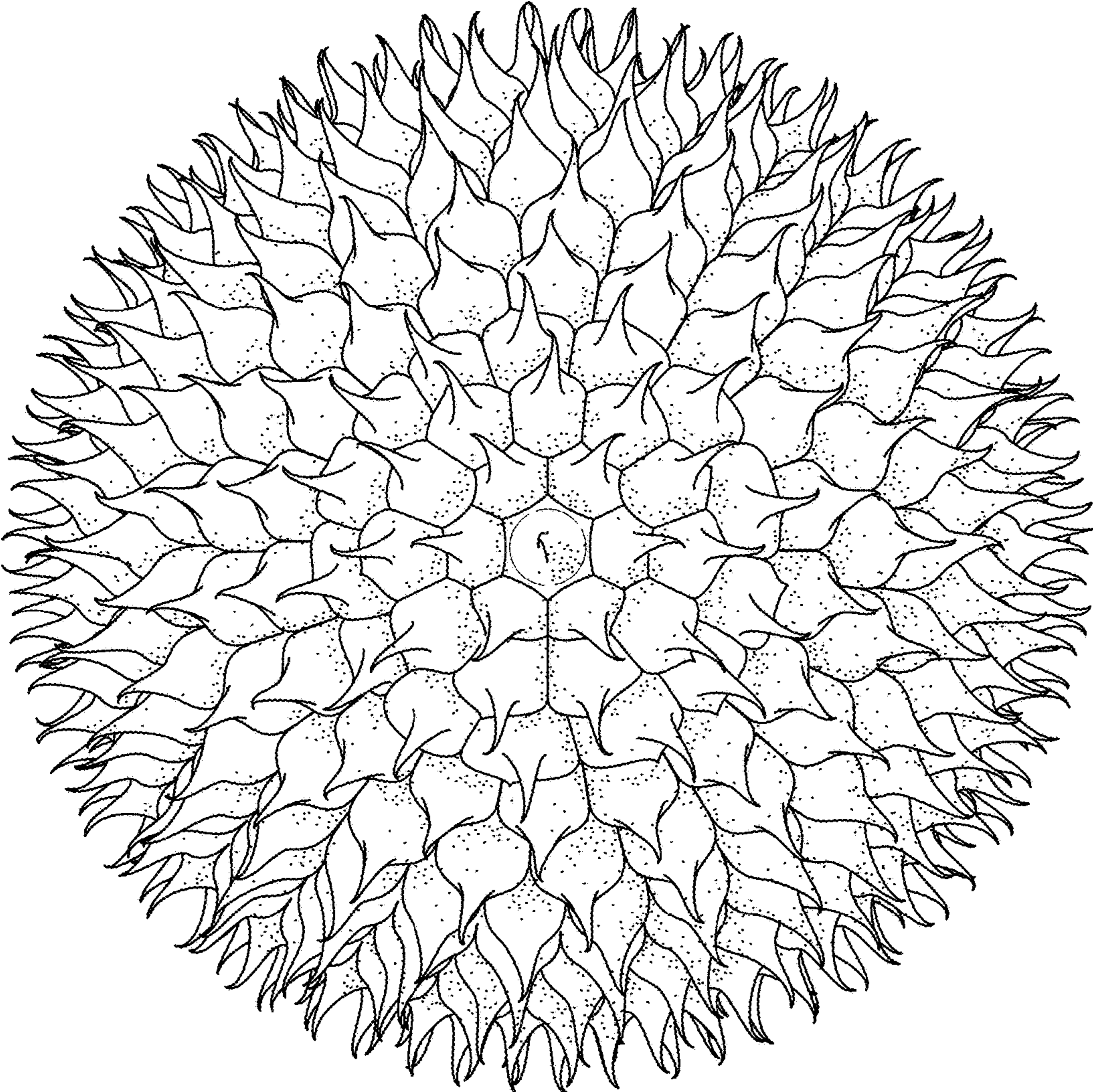
