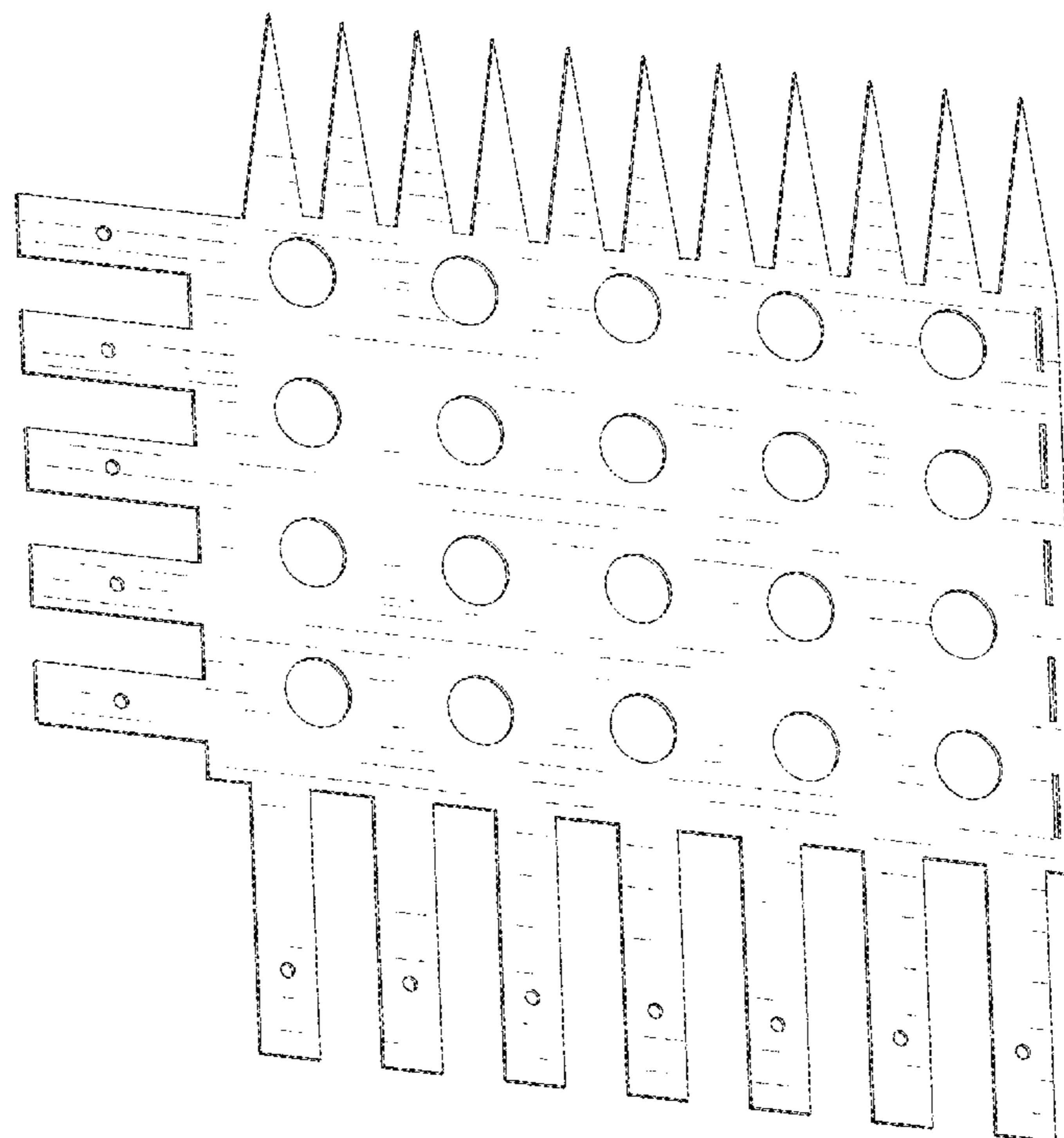
The ornamental design for a wildlife exclusion unit, as shown and described.

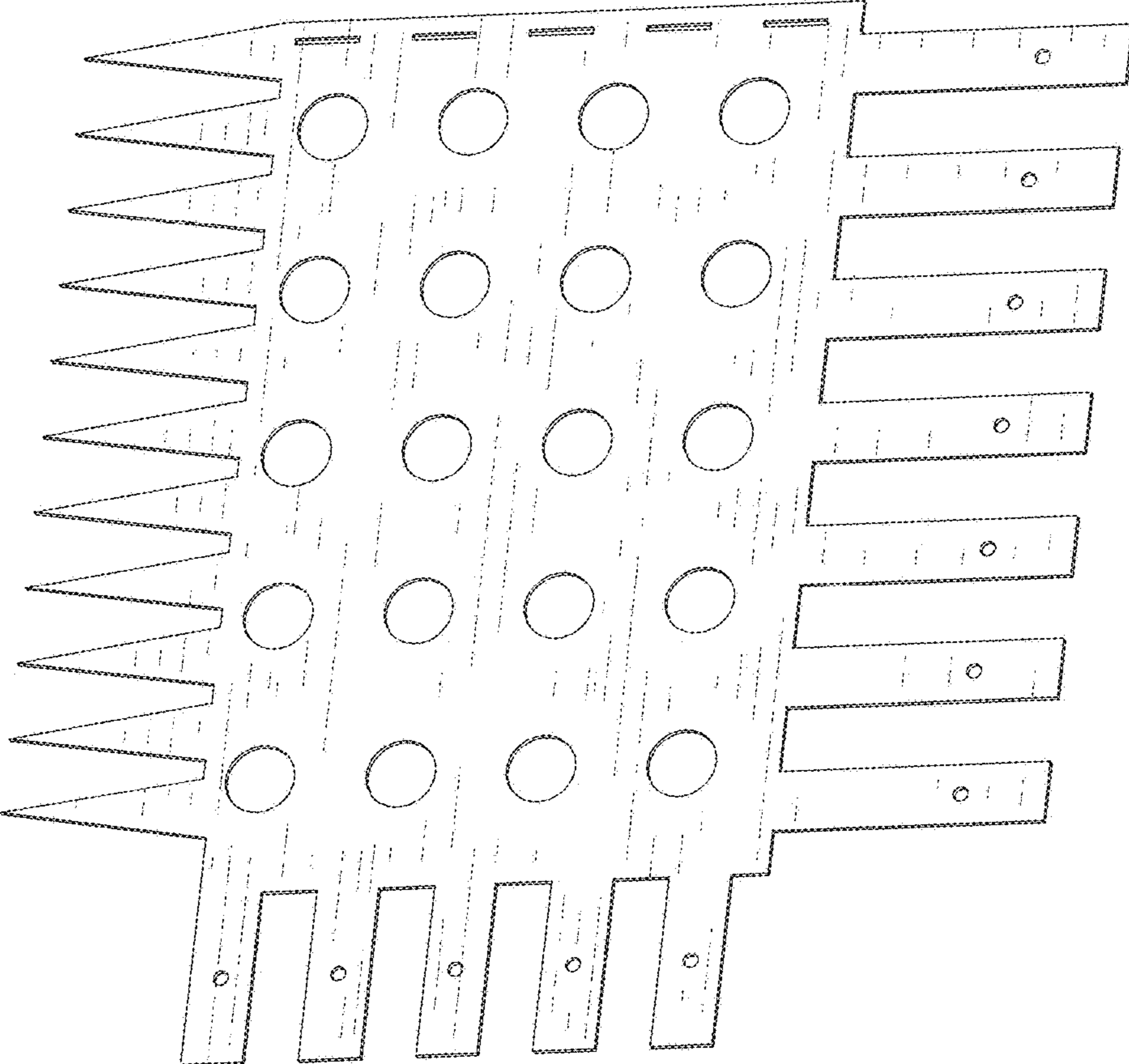

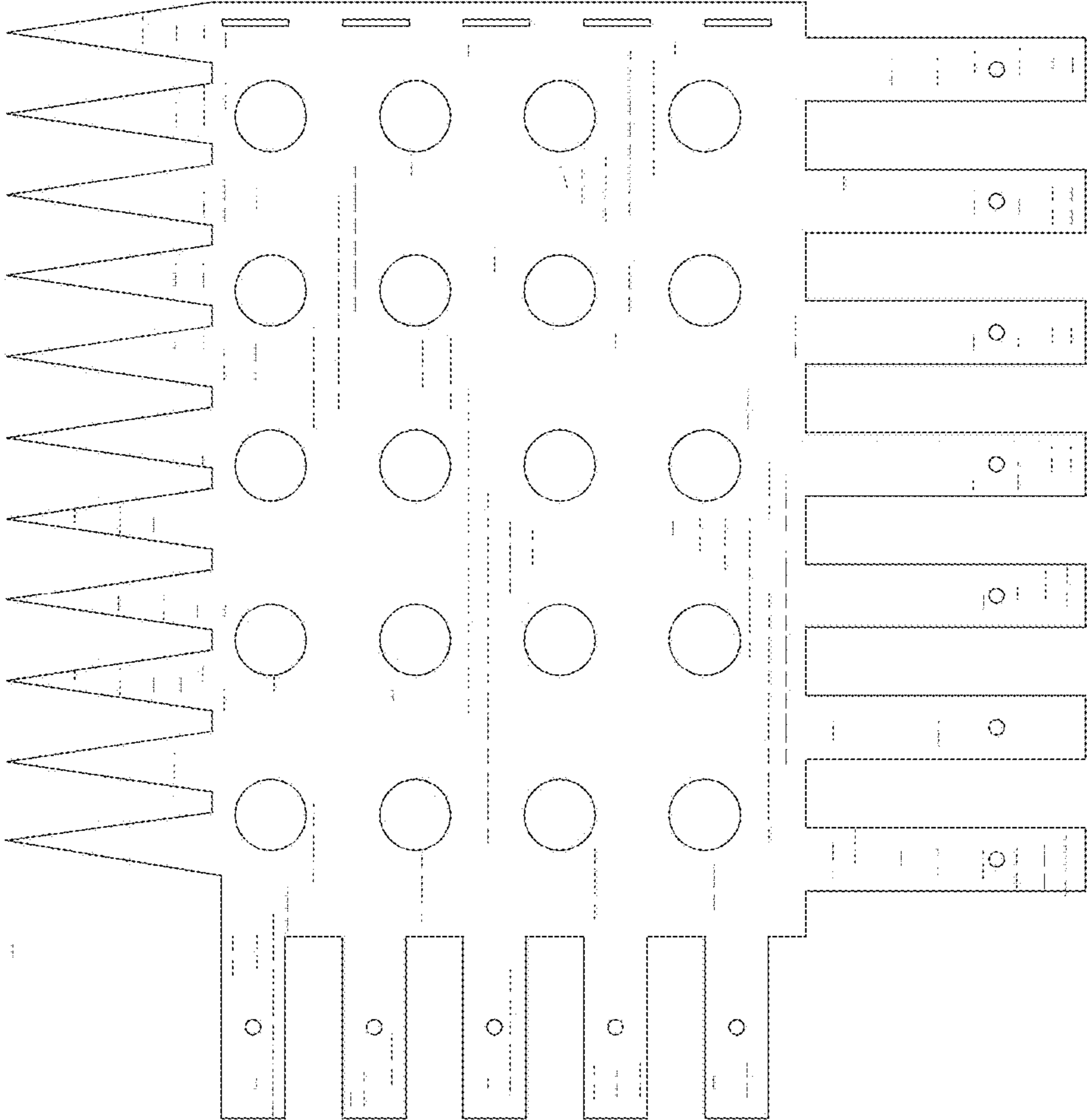

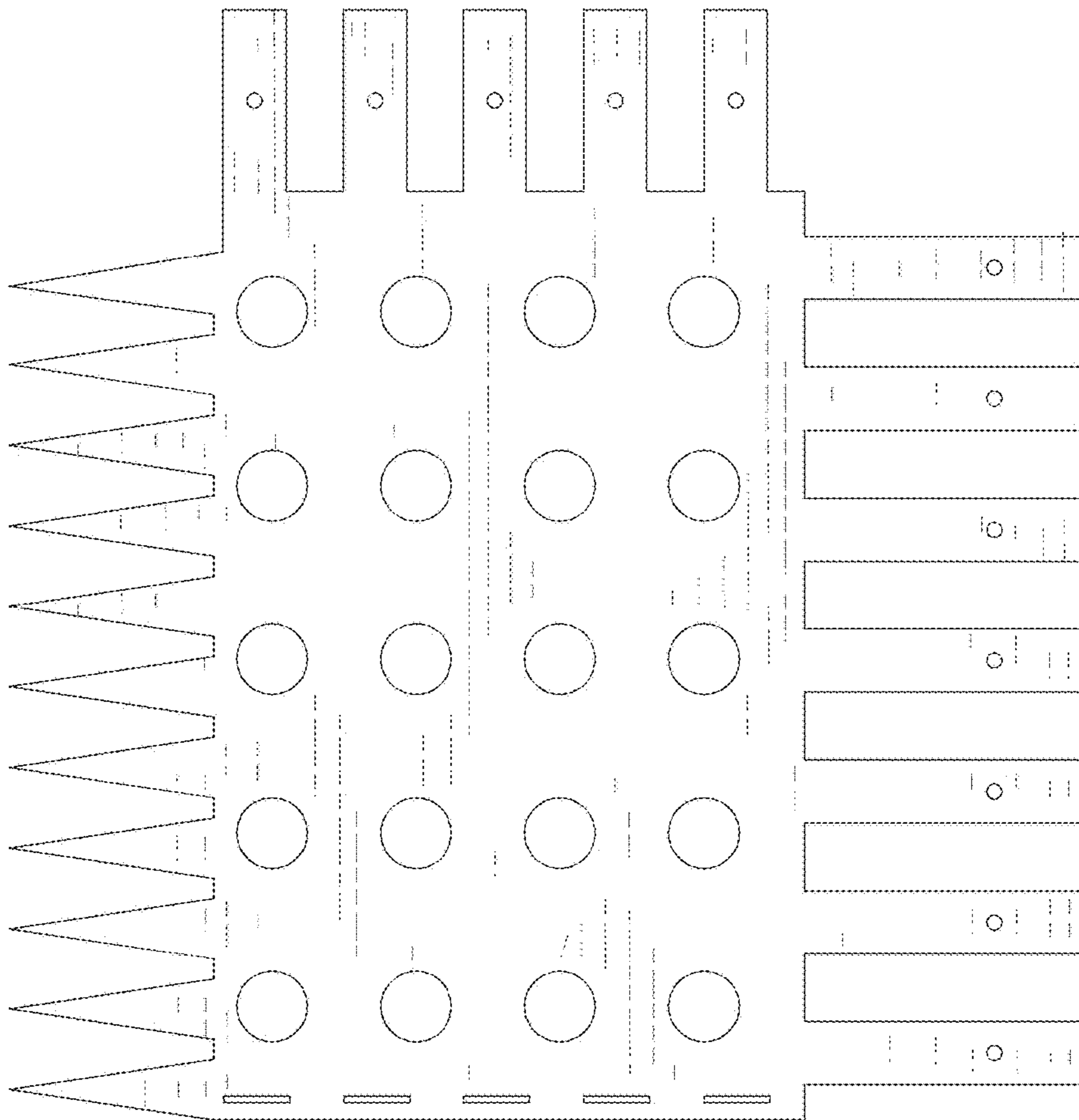

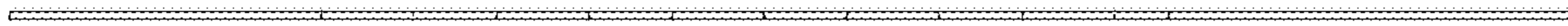

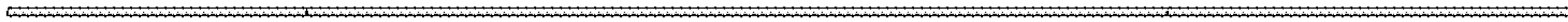
