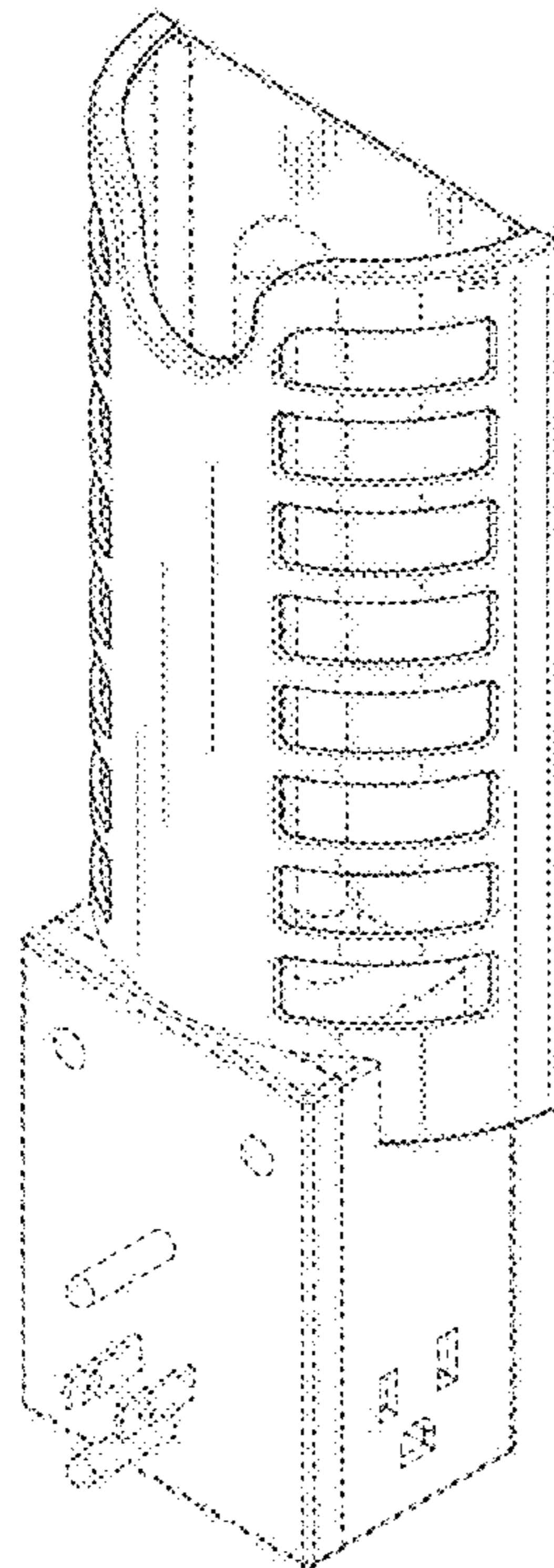
(57) **CLAIM**

The ornamental design for a plug in insect trap, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, rear and side isometric view of a plug in insect trap according to the present invention, with a light bulb installed within the trap.
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

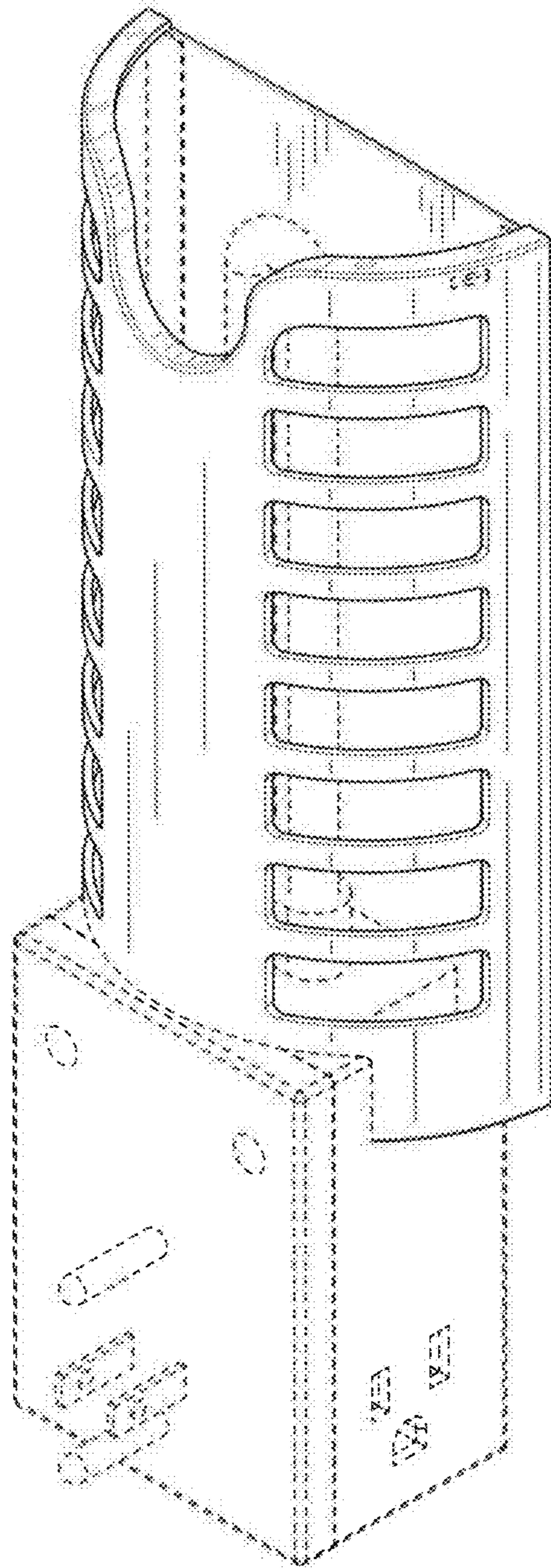

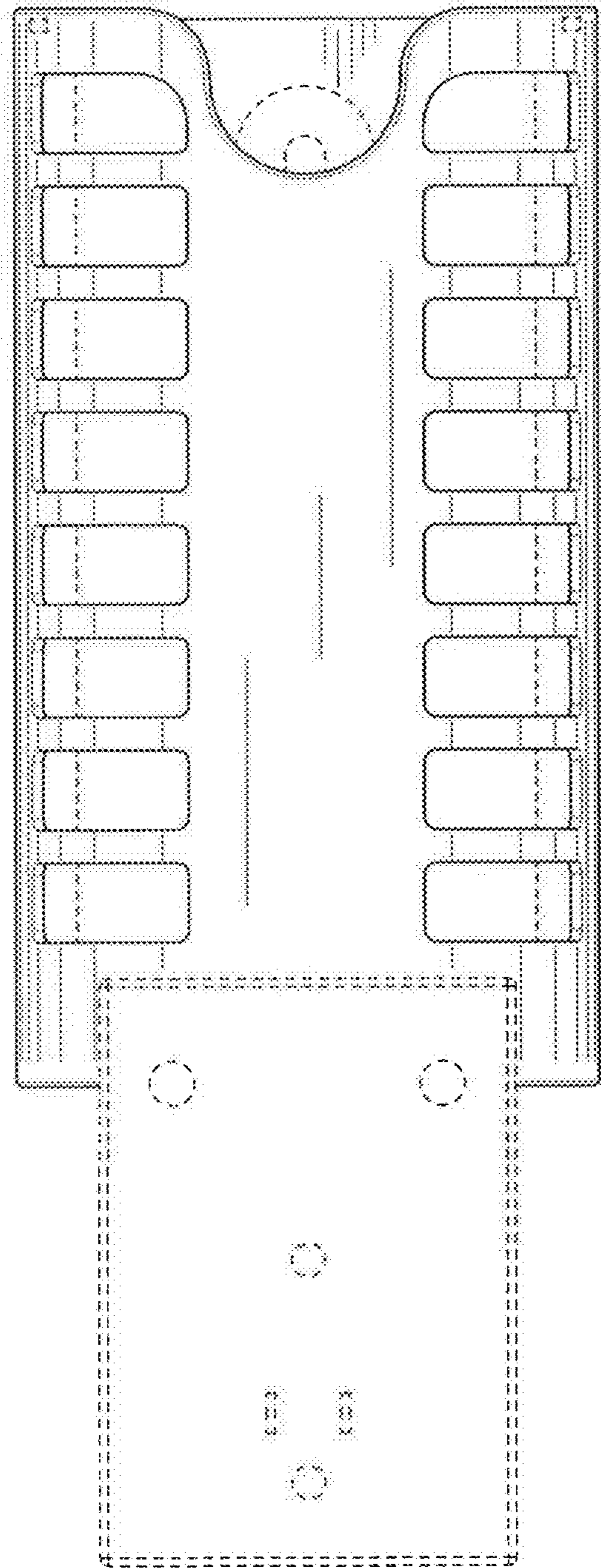

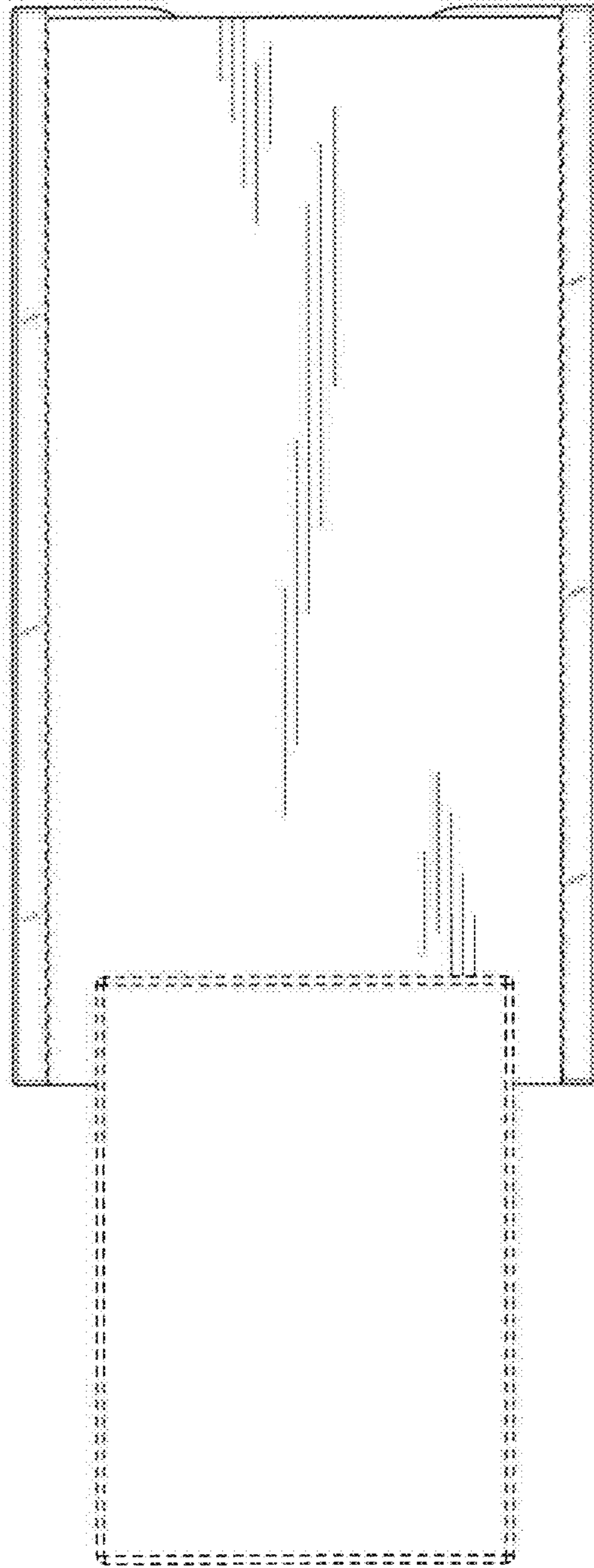

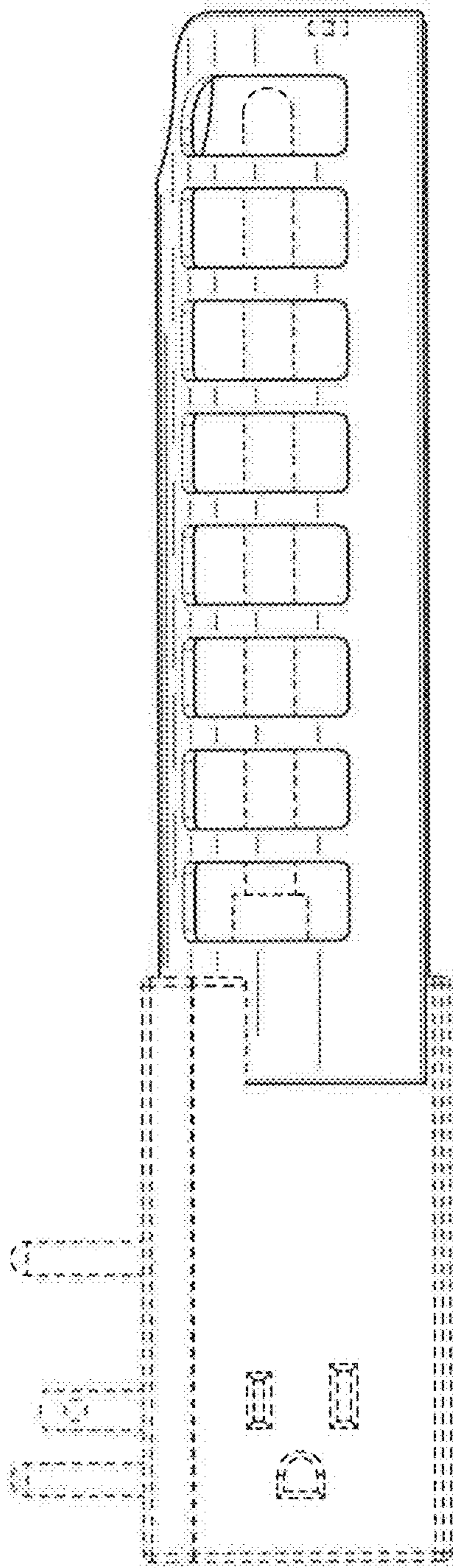

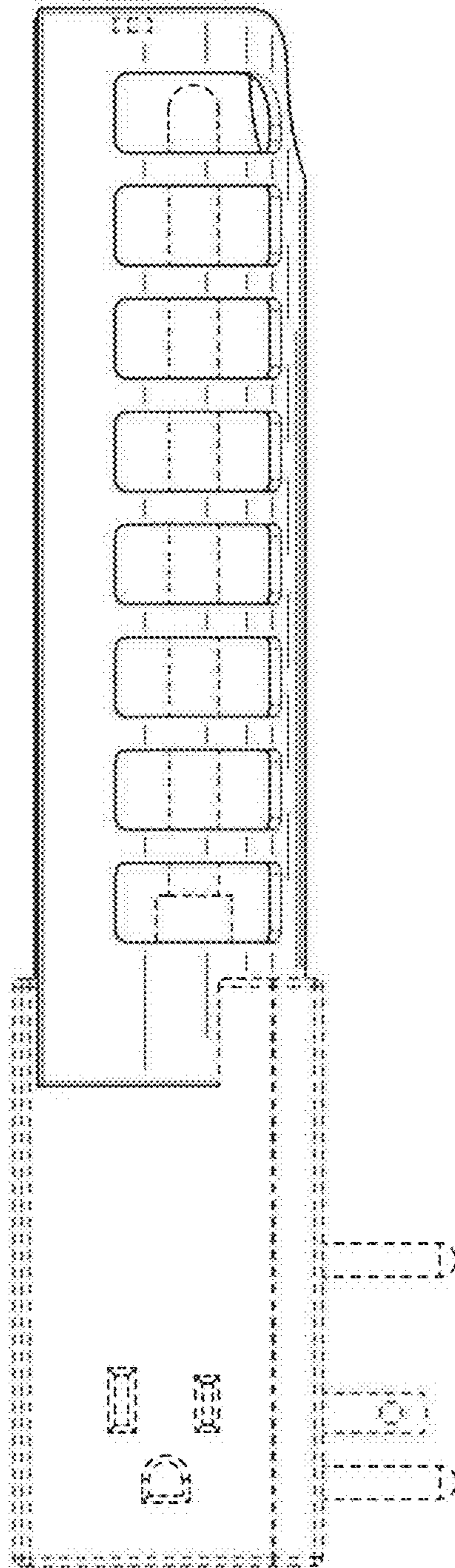

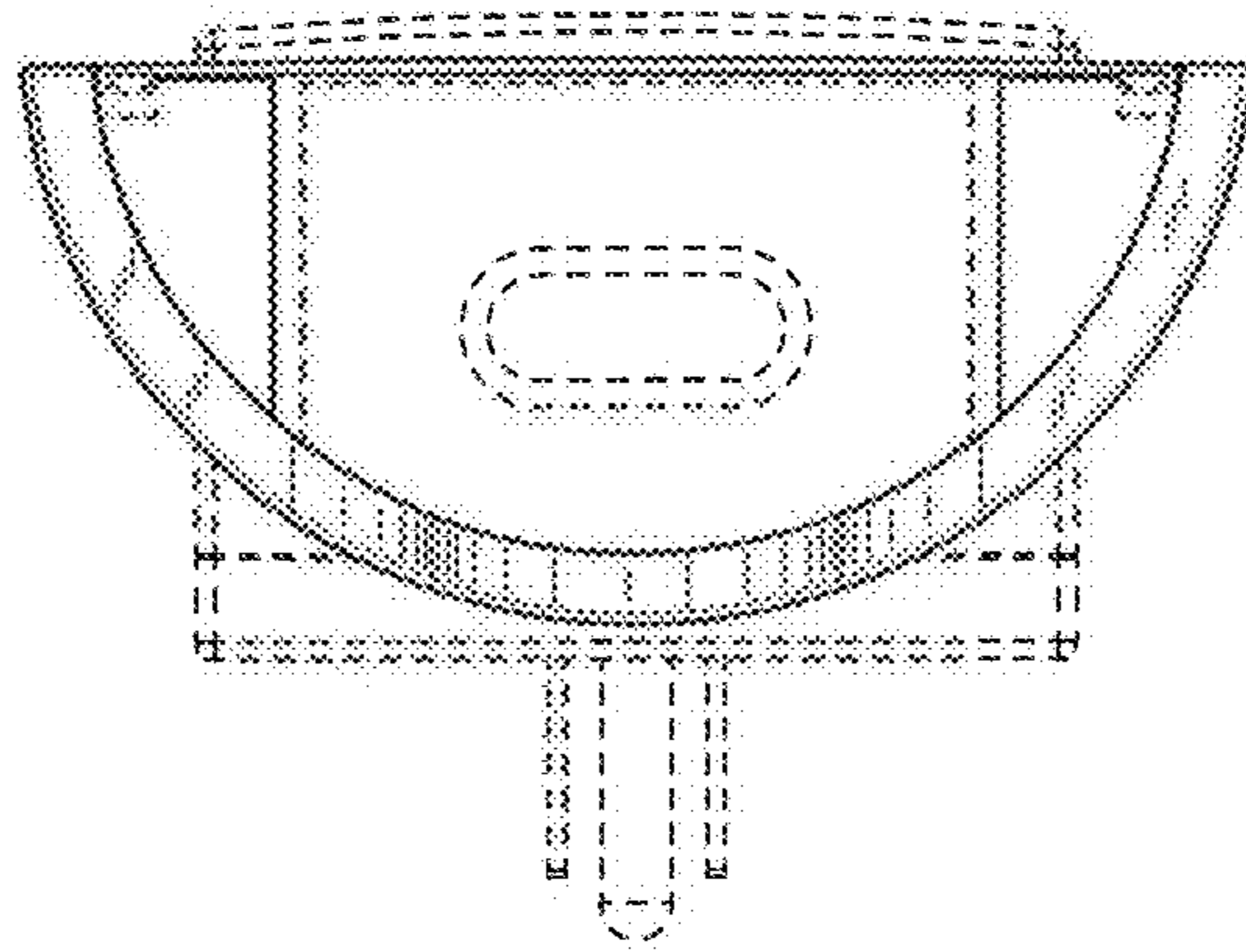

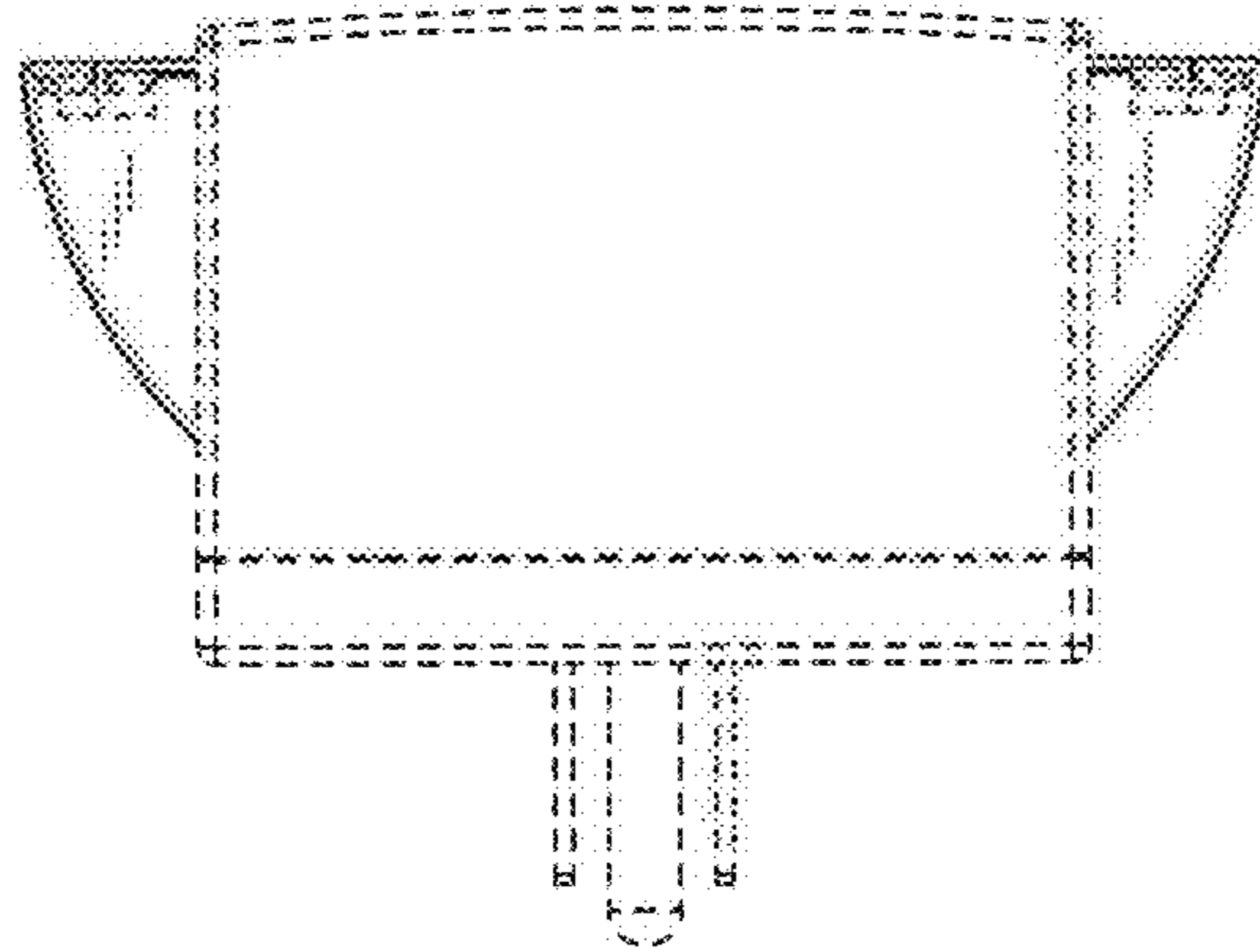
