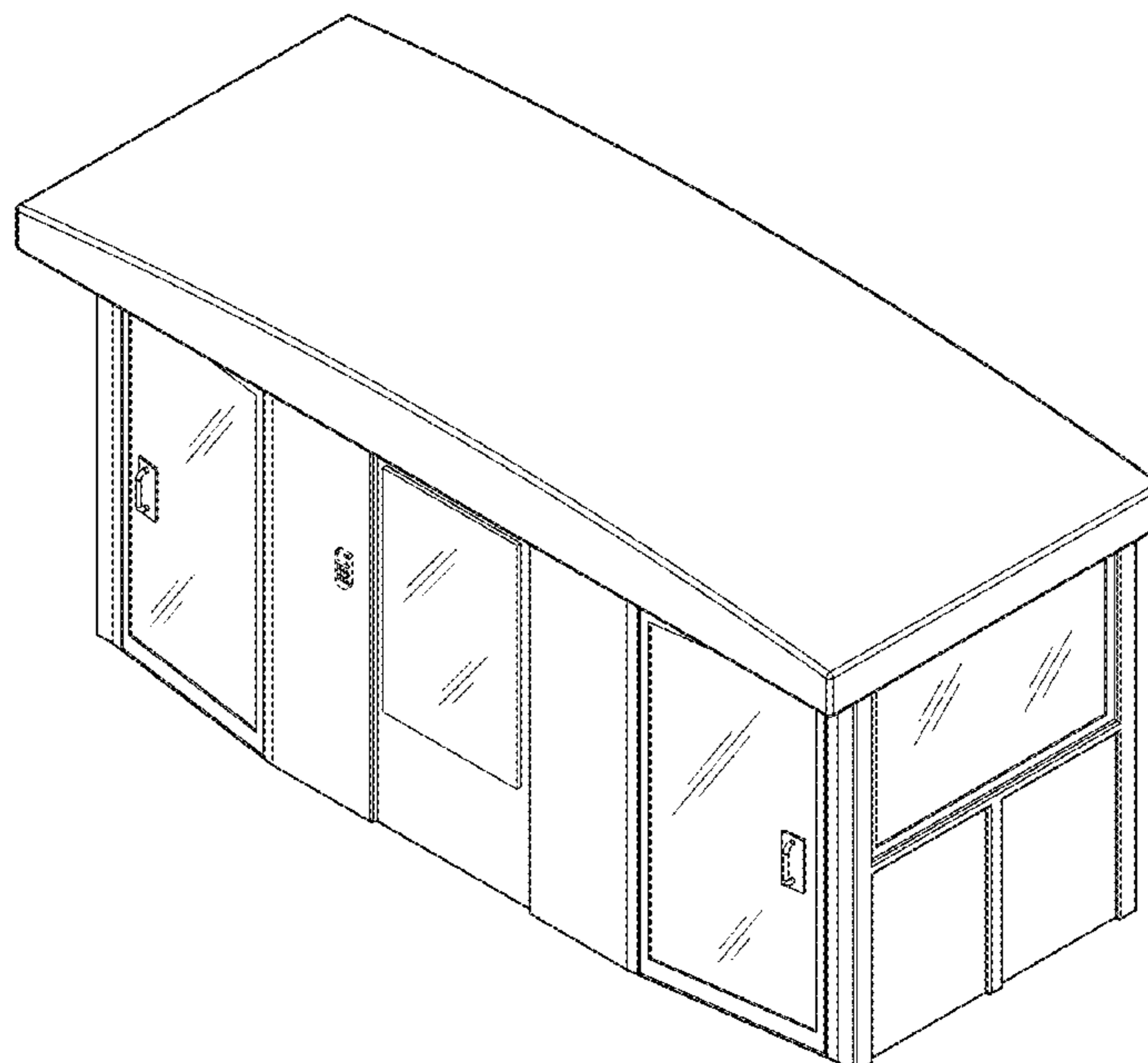
I claim the ornamental design for a booth, as shown and described.

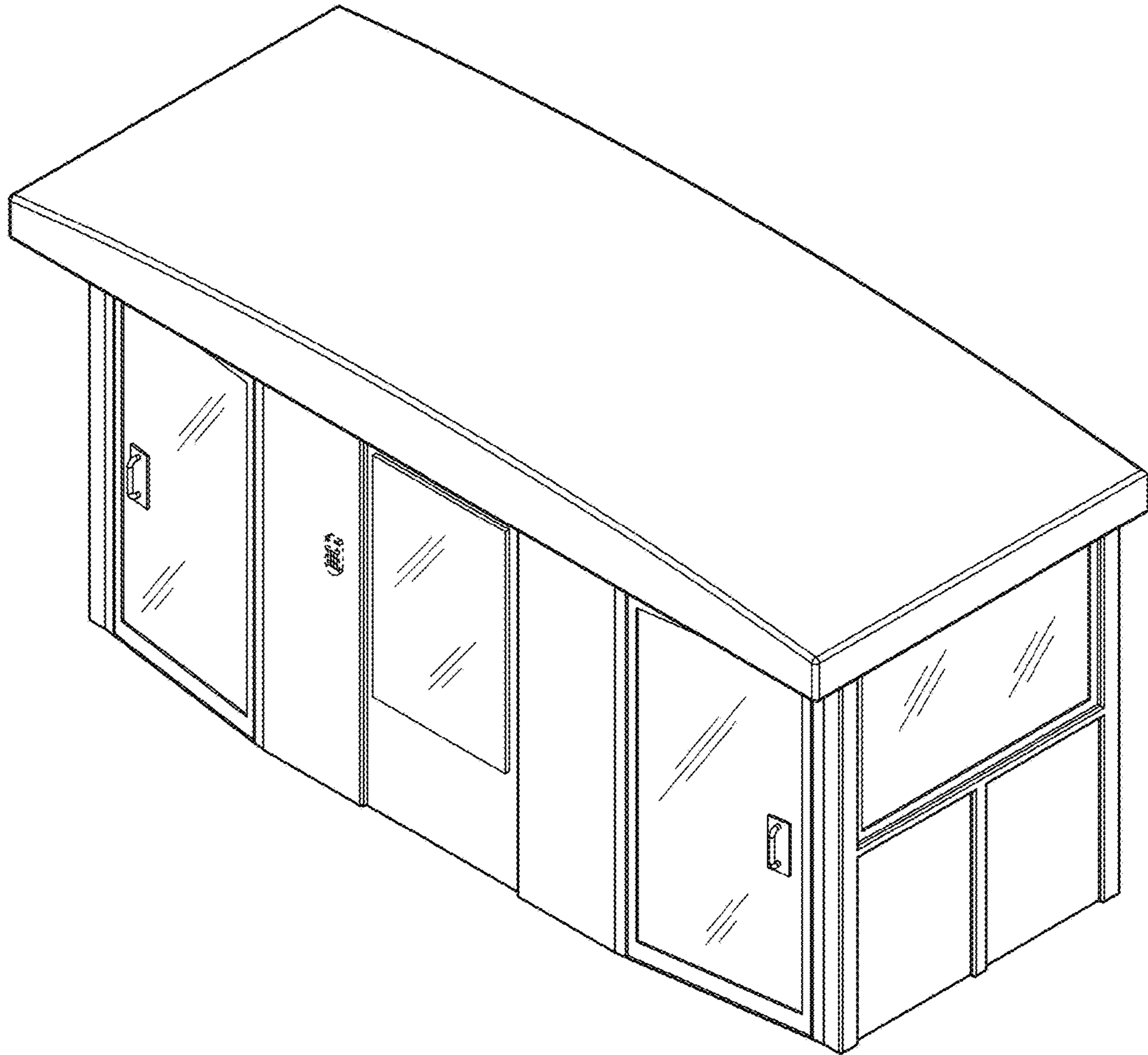

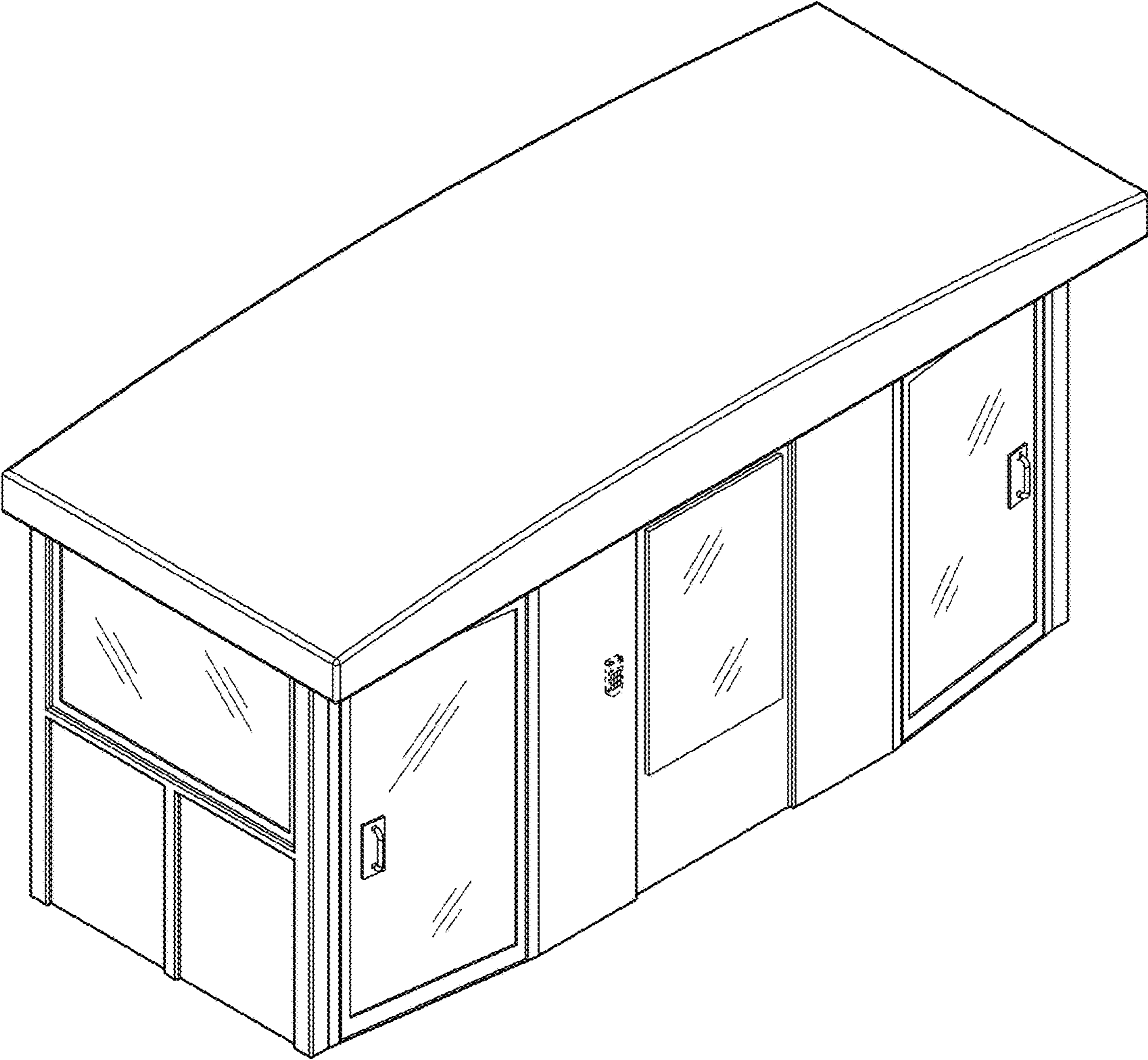

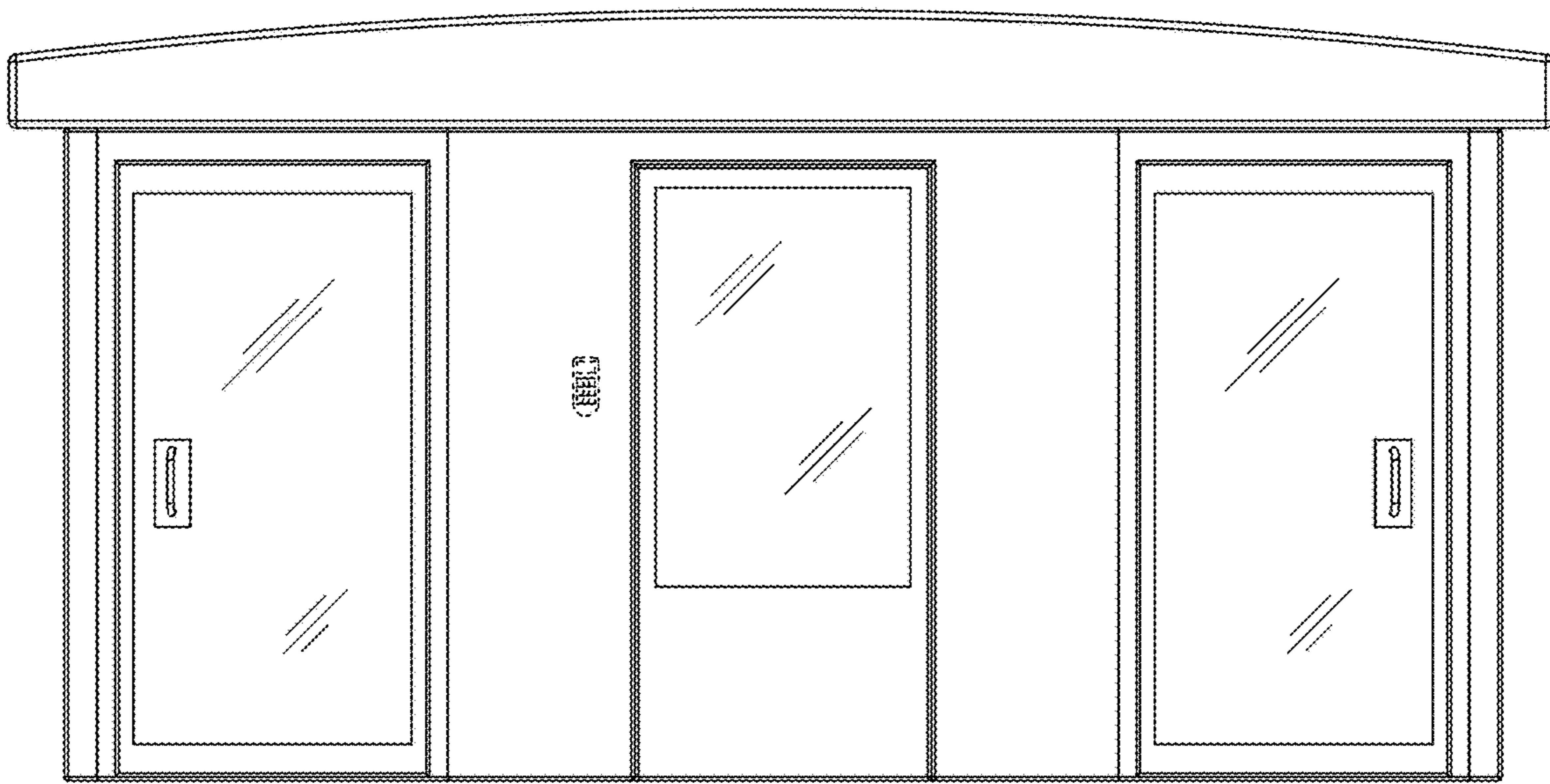

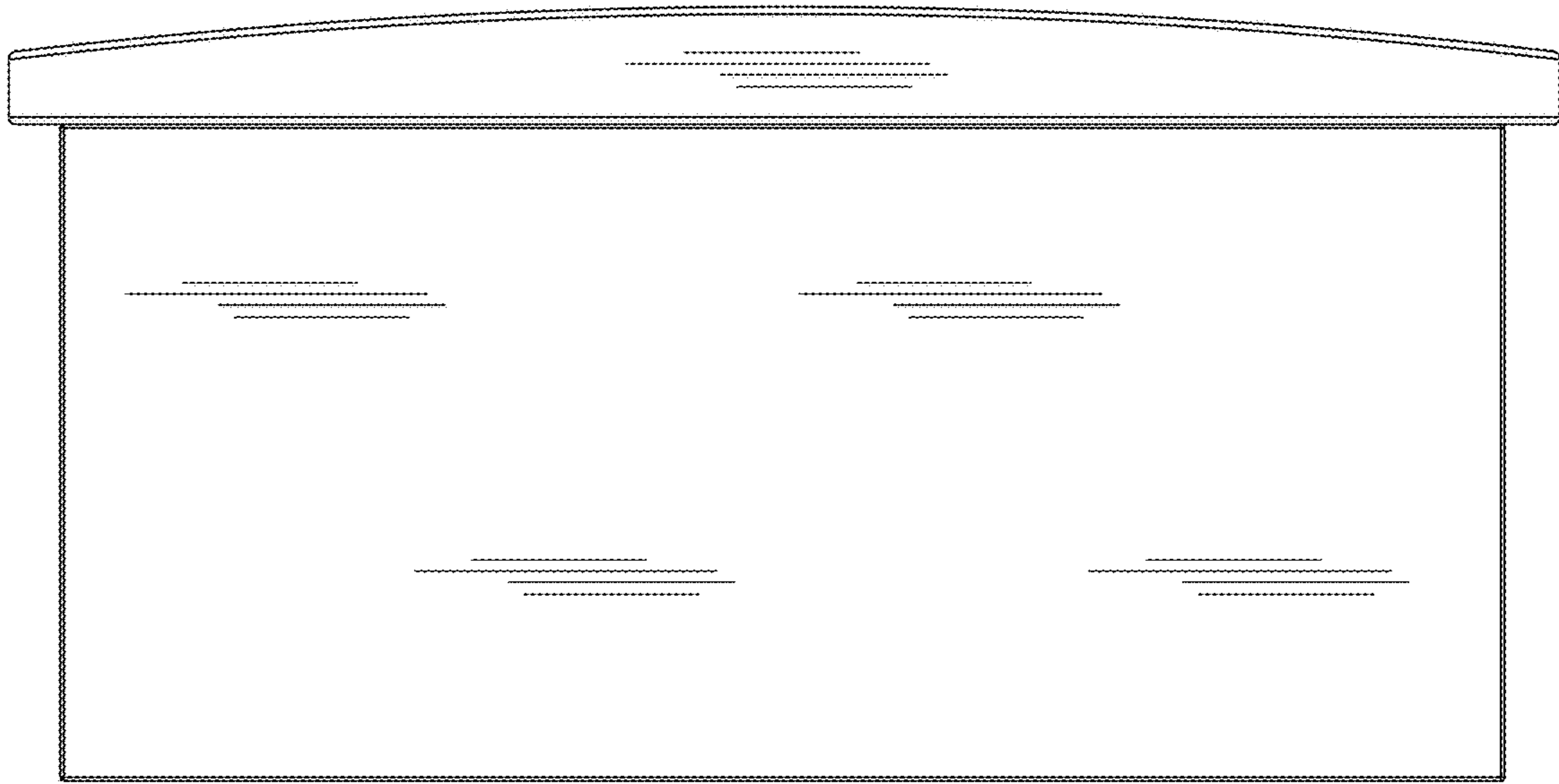

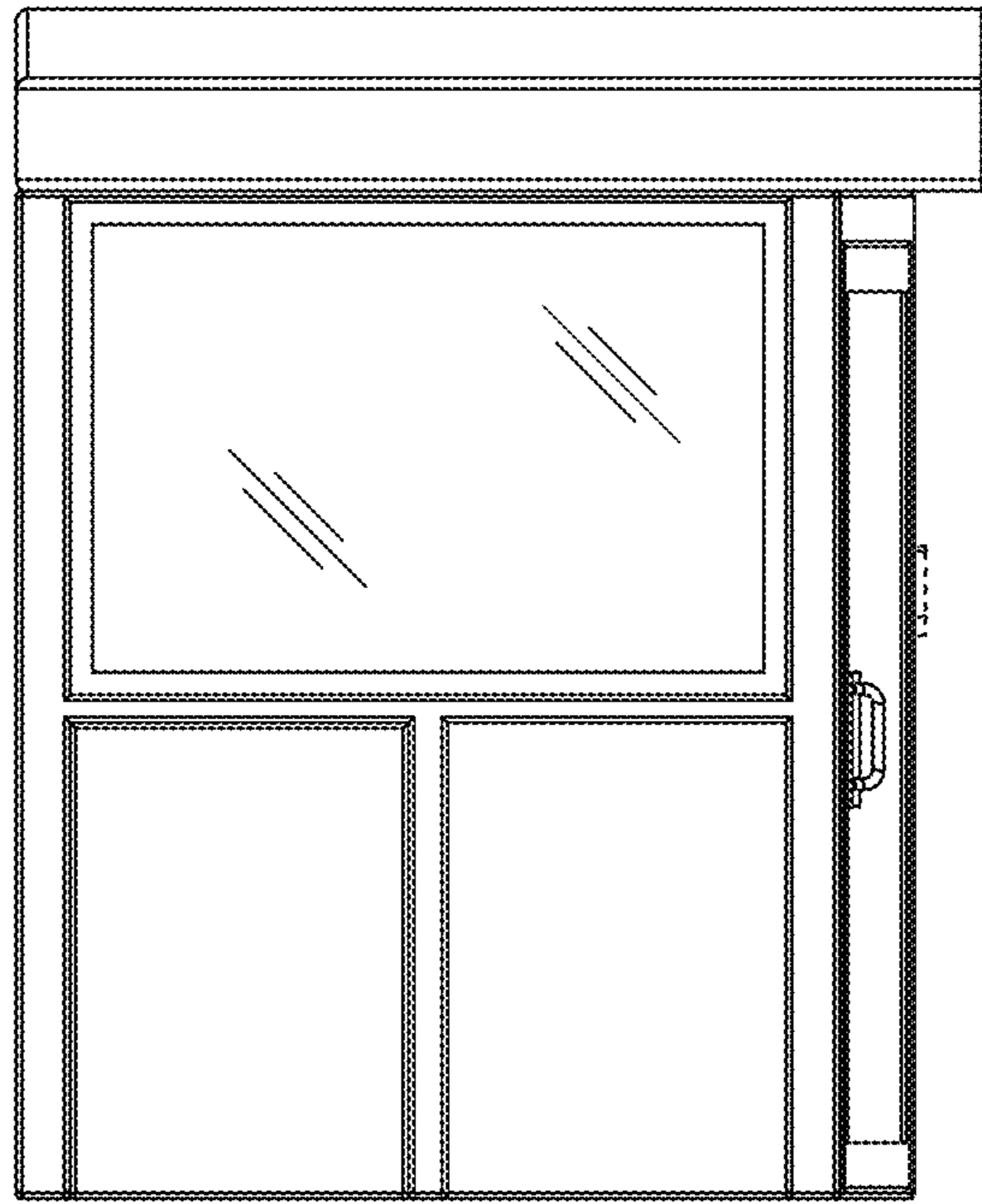

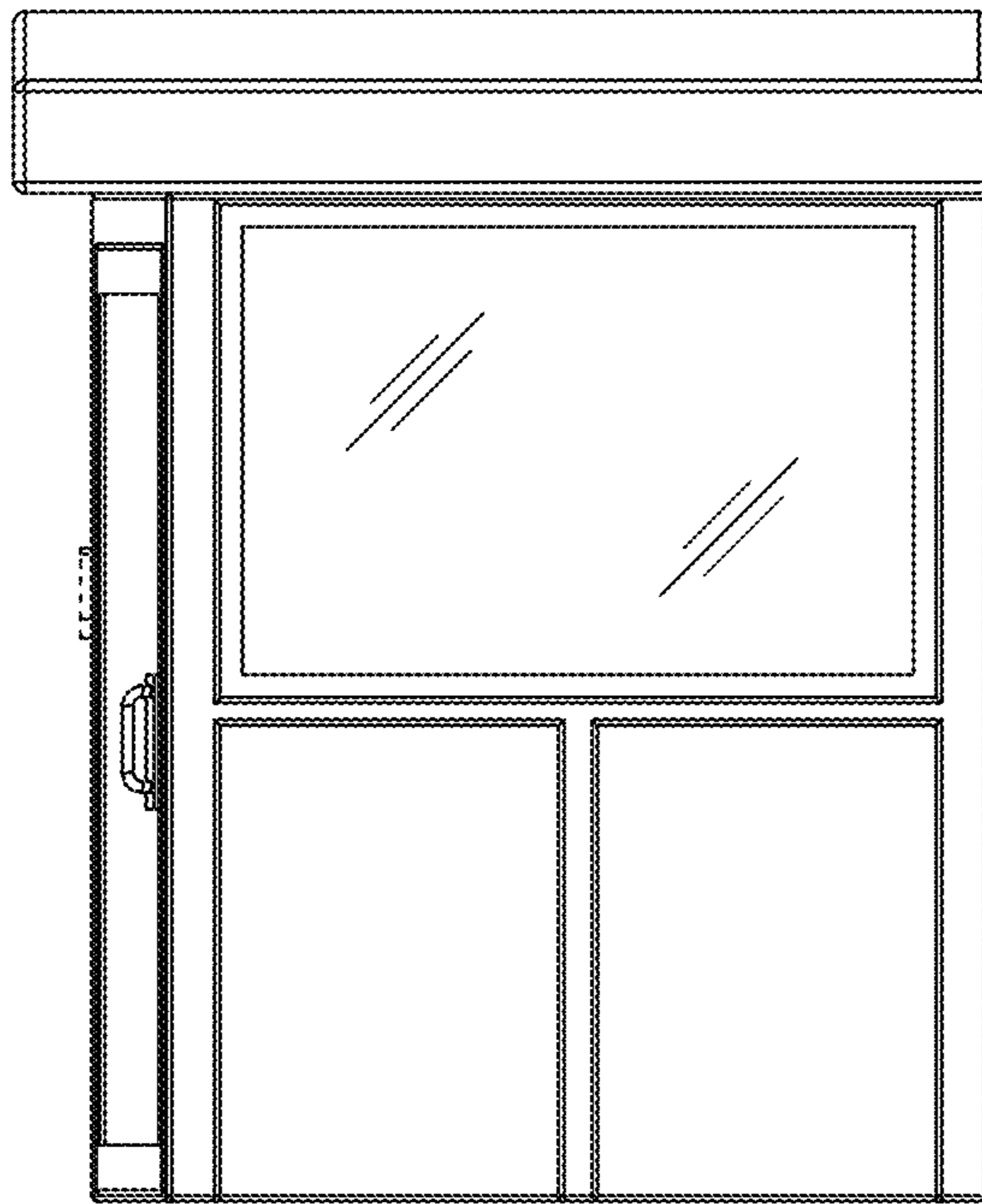

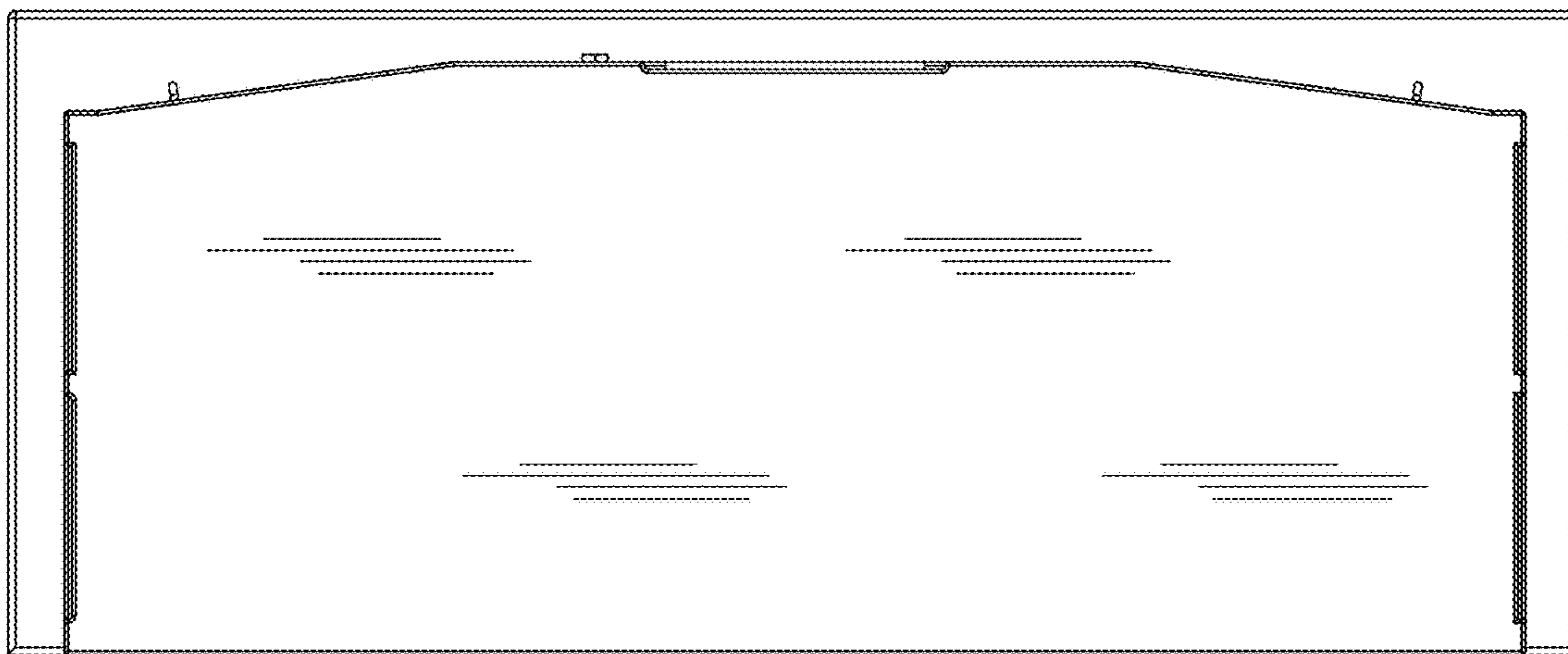
