The ornamental design for a support member for ceiling system, as shown and described.

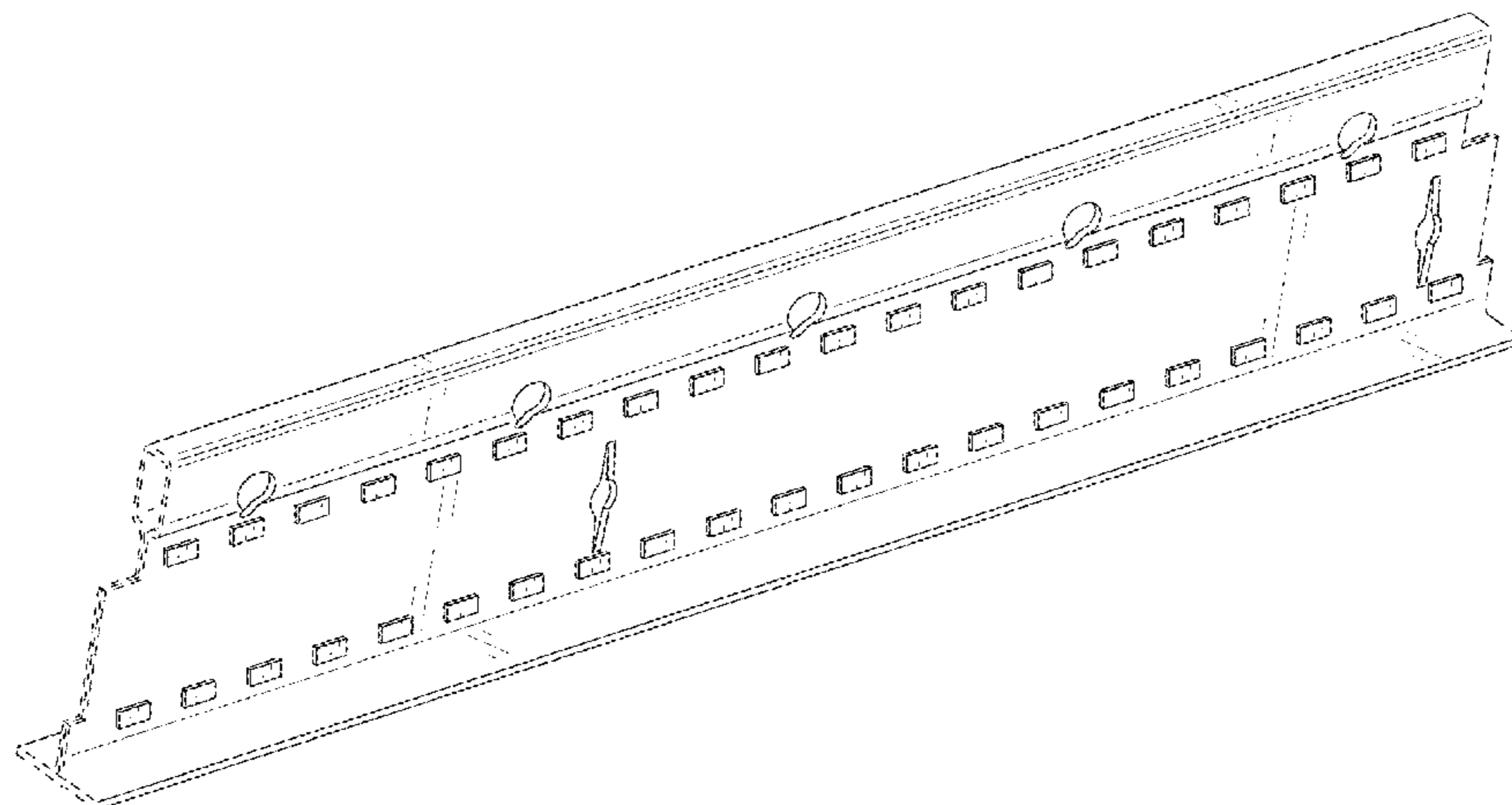
DESCRIPTION

FIG. 1 is a perspective view of a support member for ceiling system of the present design;
FIG. 2 is a top view thereof;

FIG. 6 is a rear view thereof; and,
FIG. 7 is a front view thereof.

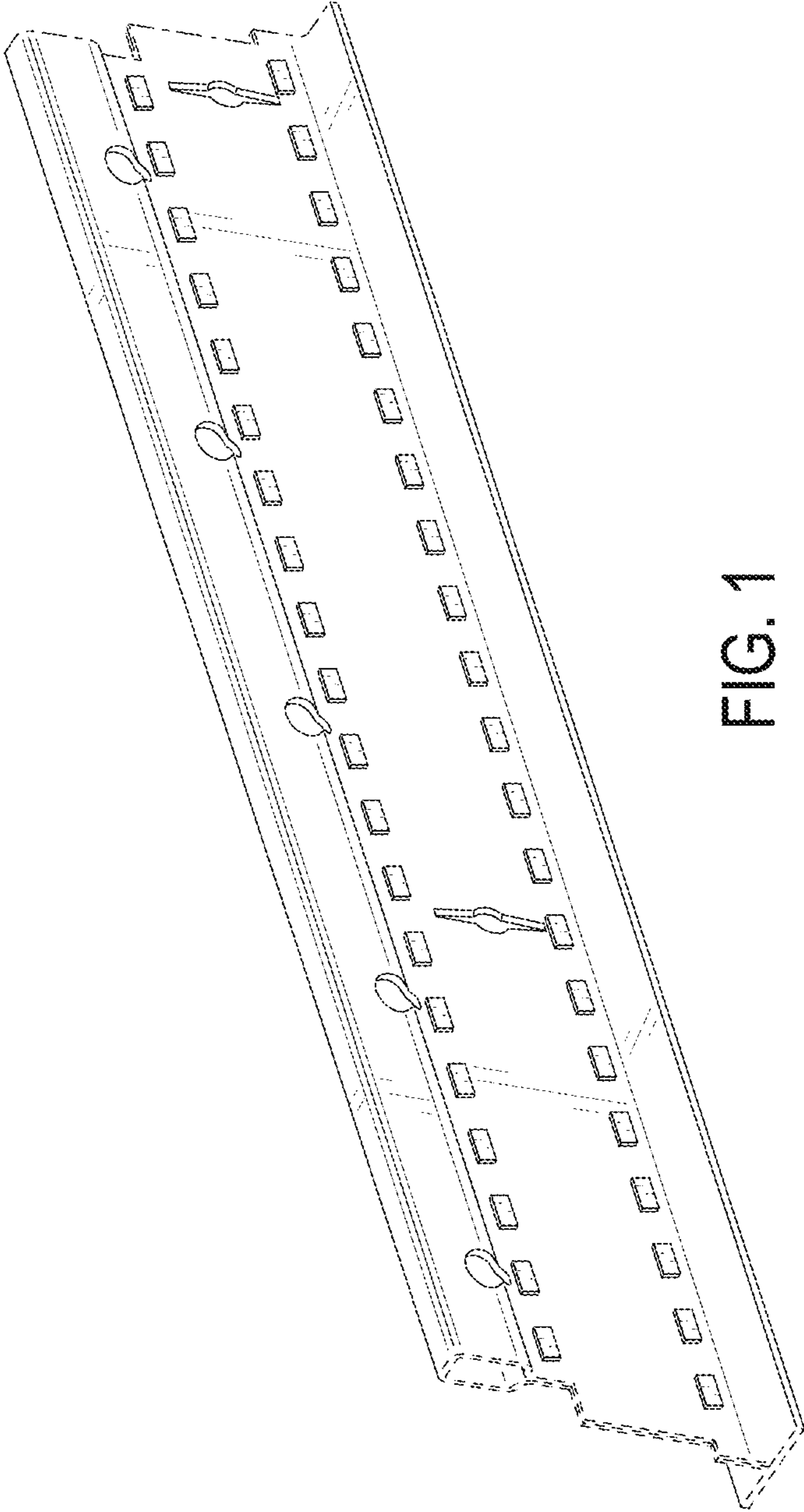

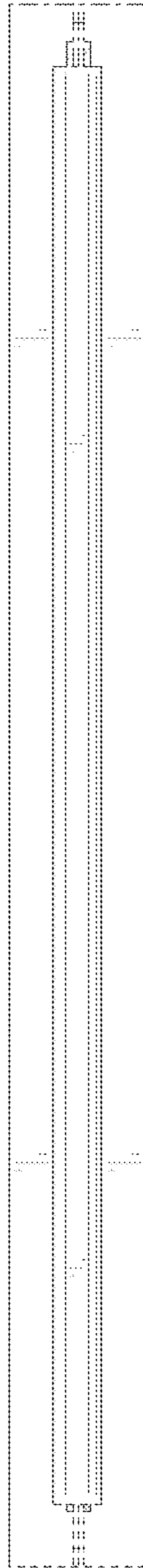

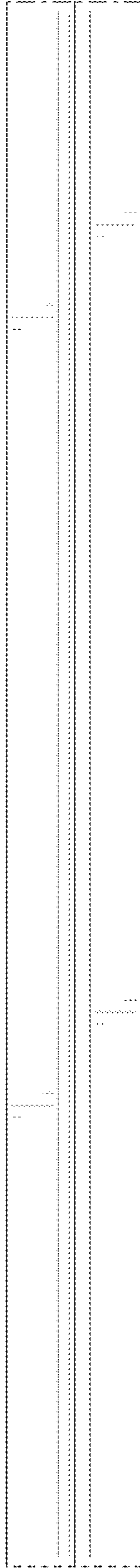

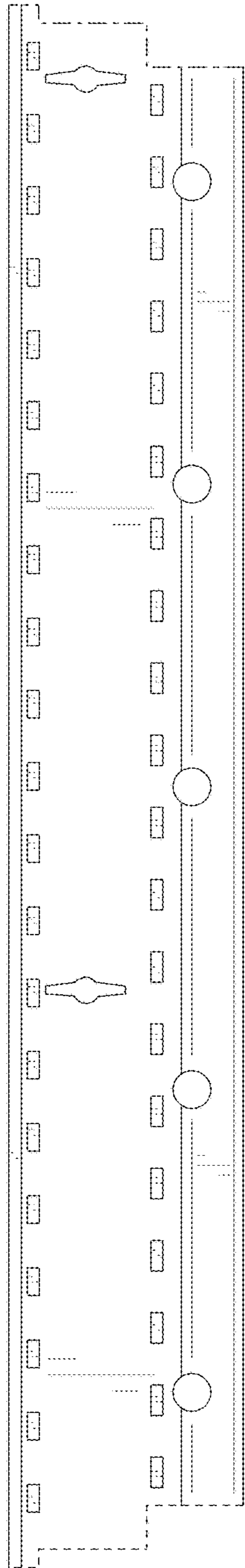

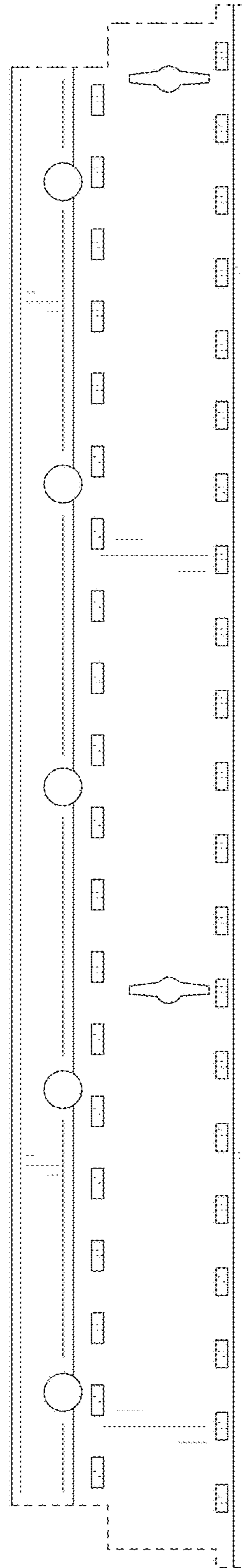

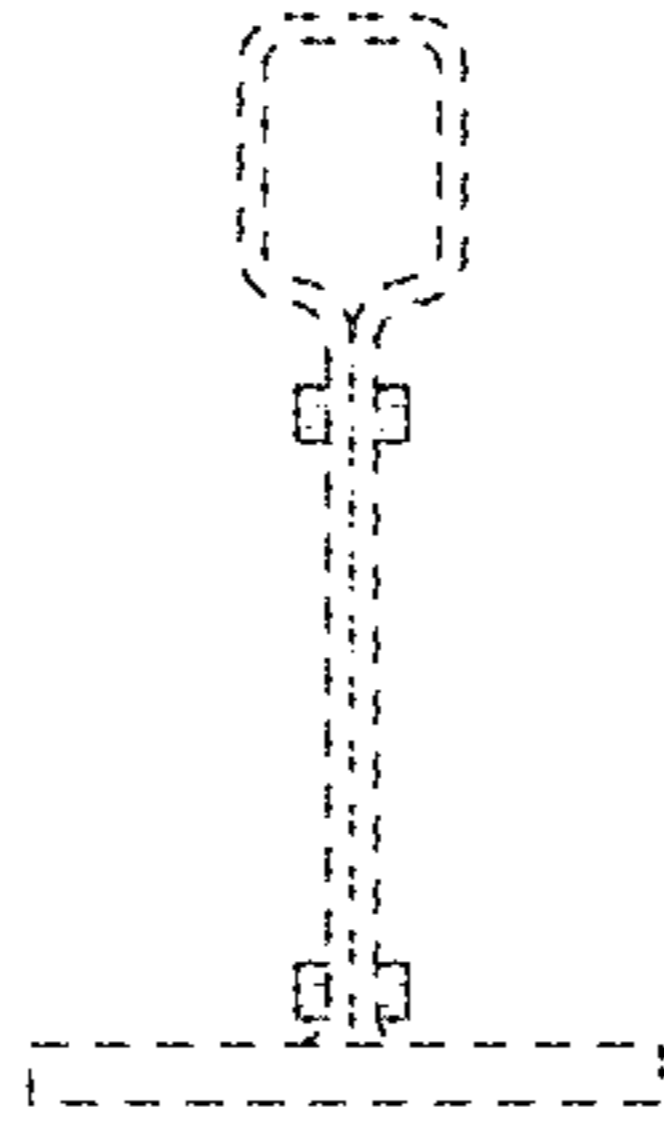

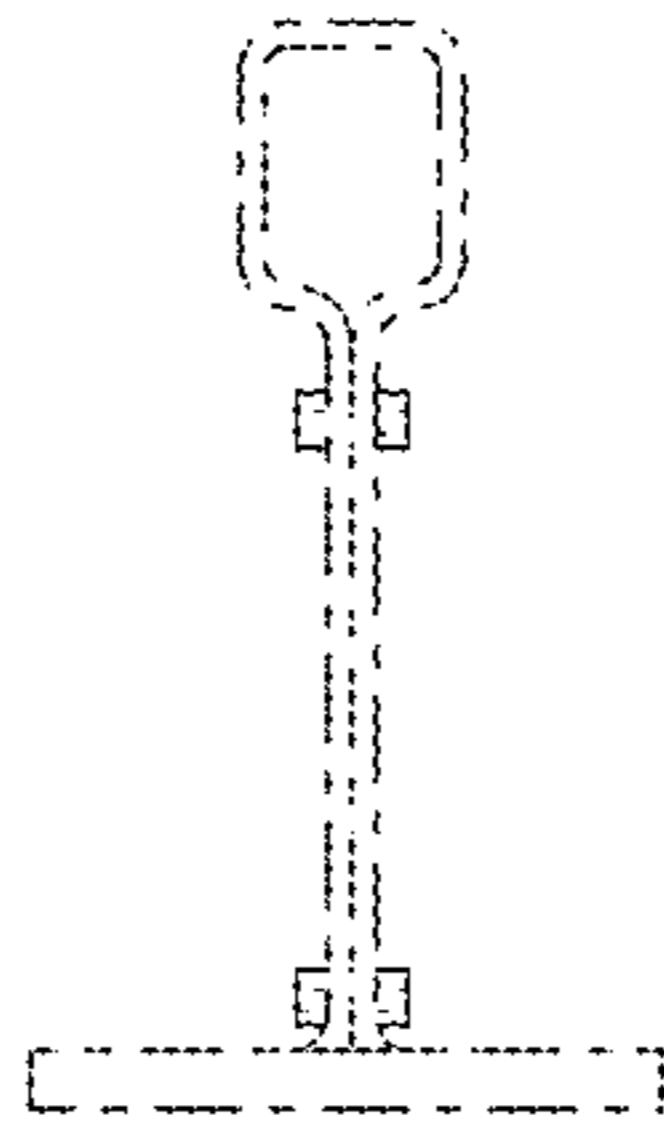
