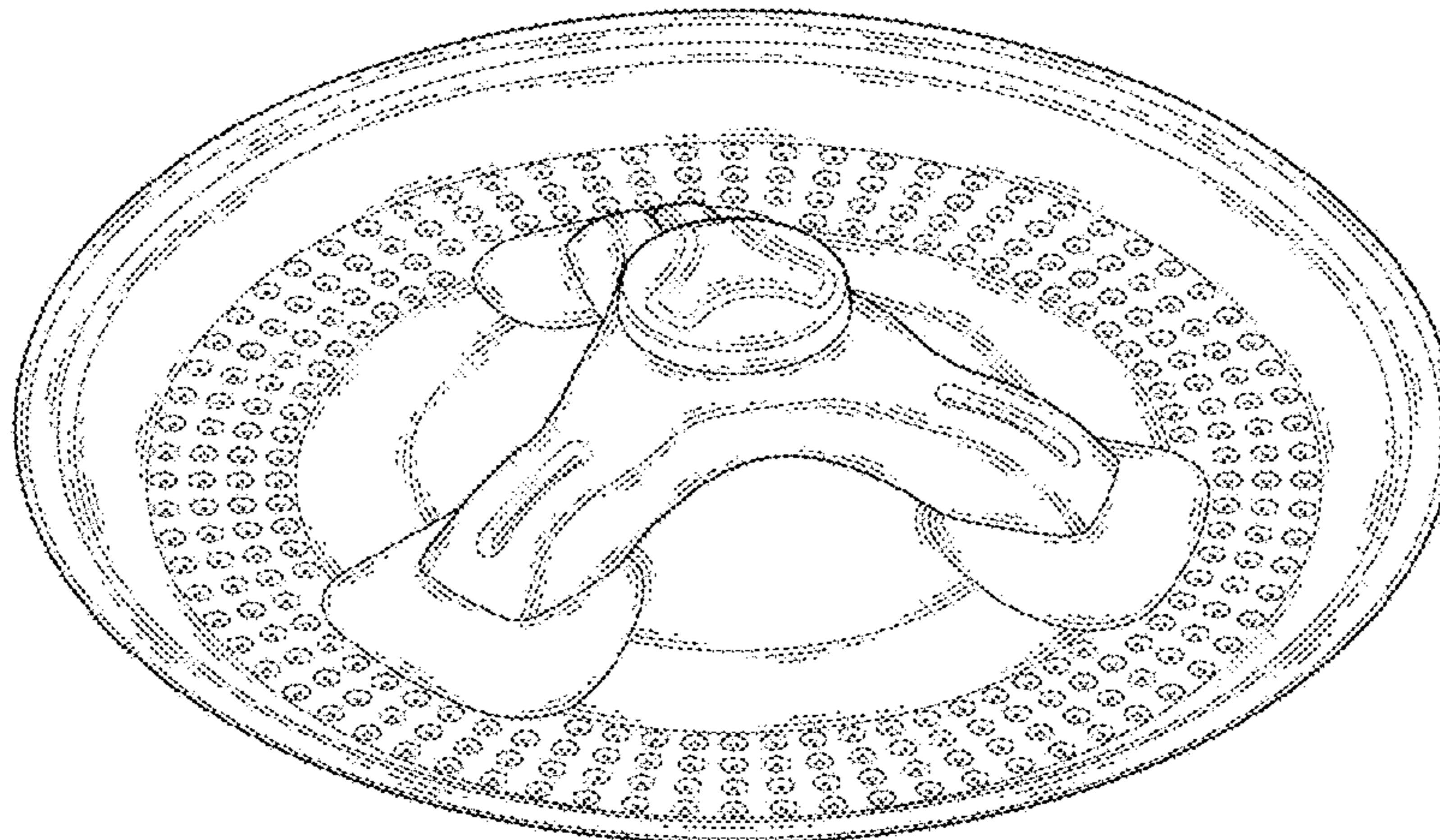
(57) **CLAIM**

The ornamental design for a pulsator for washing machine, as shown and described.

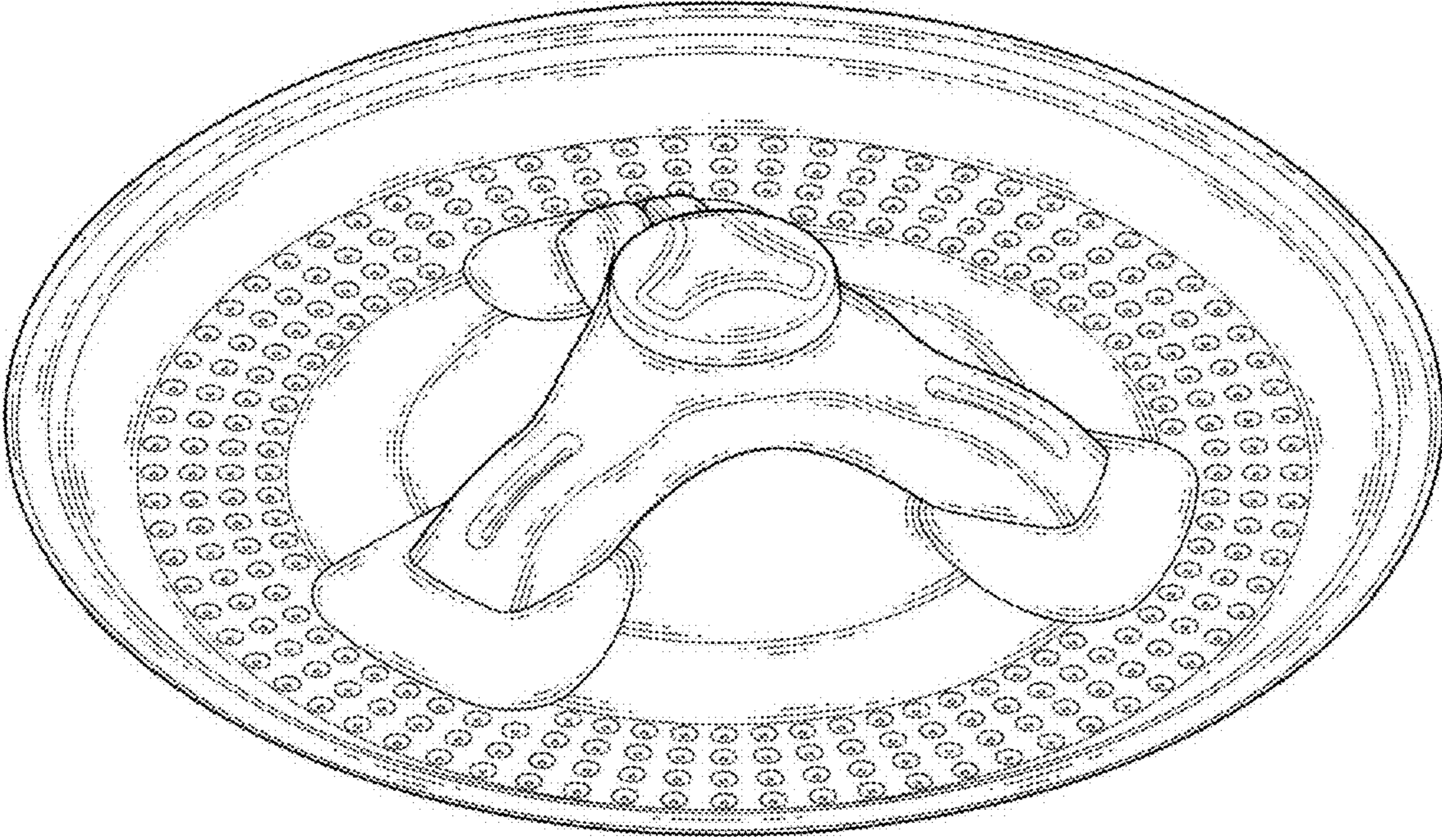
DESCRIPTION

- 1.7 is a bottom plan view thereof.

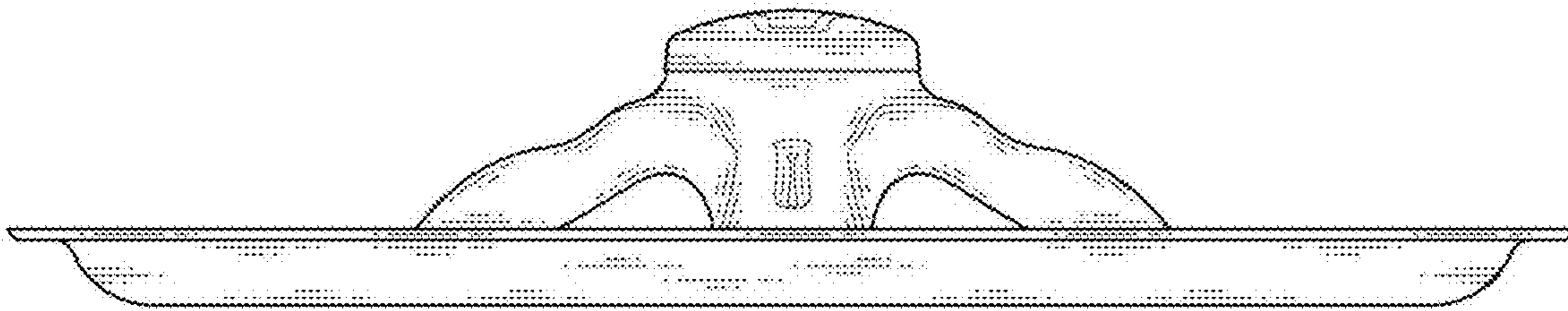

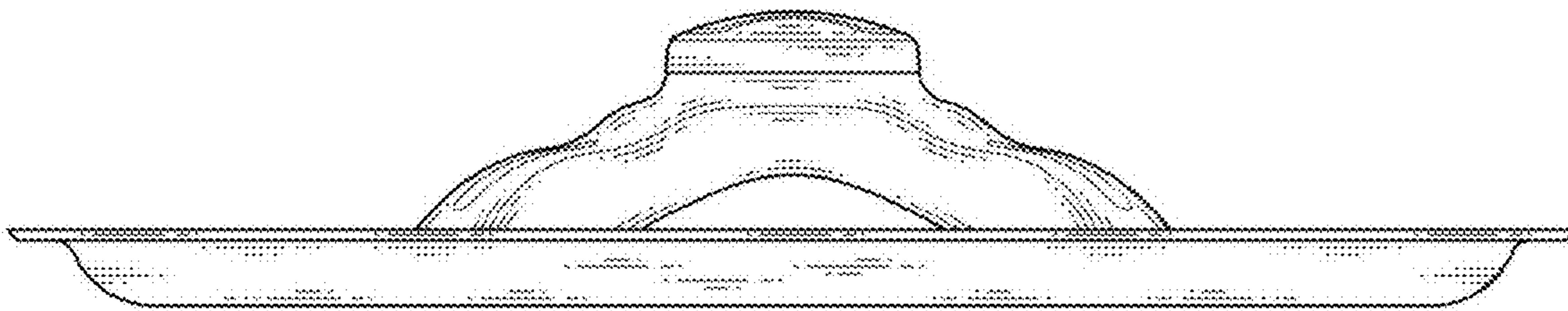

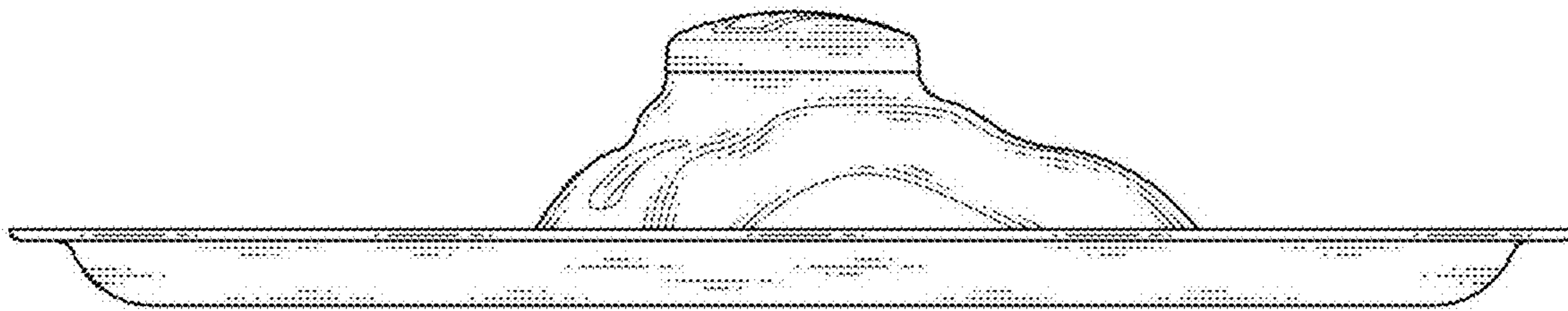

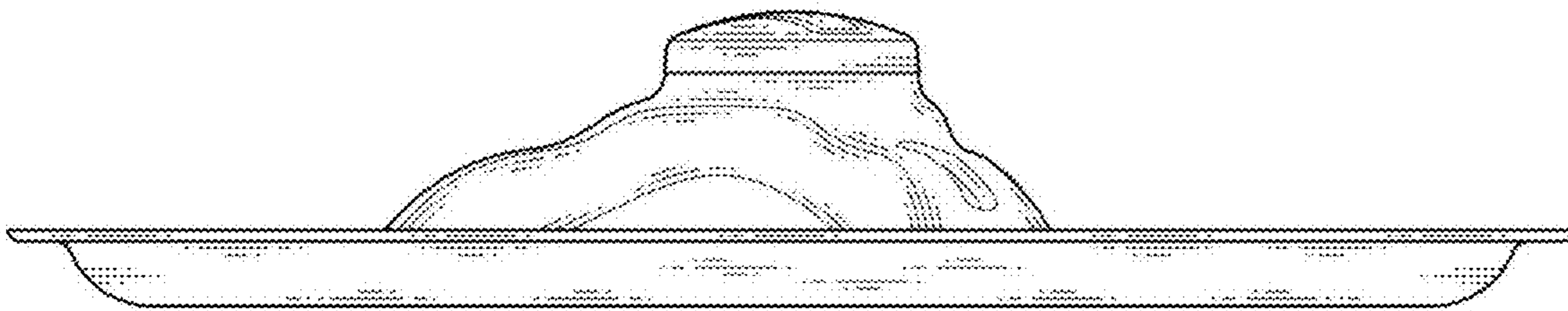

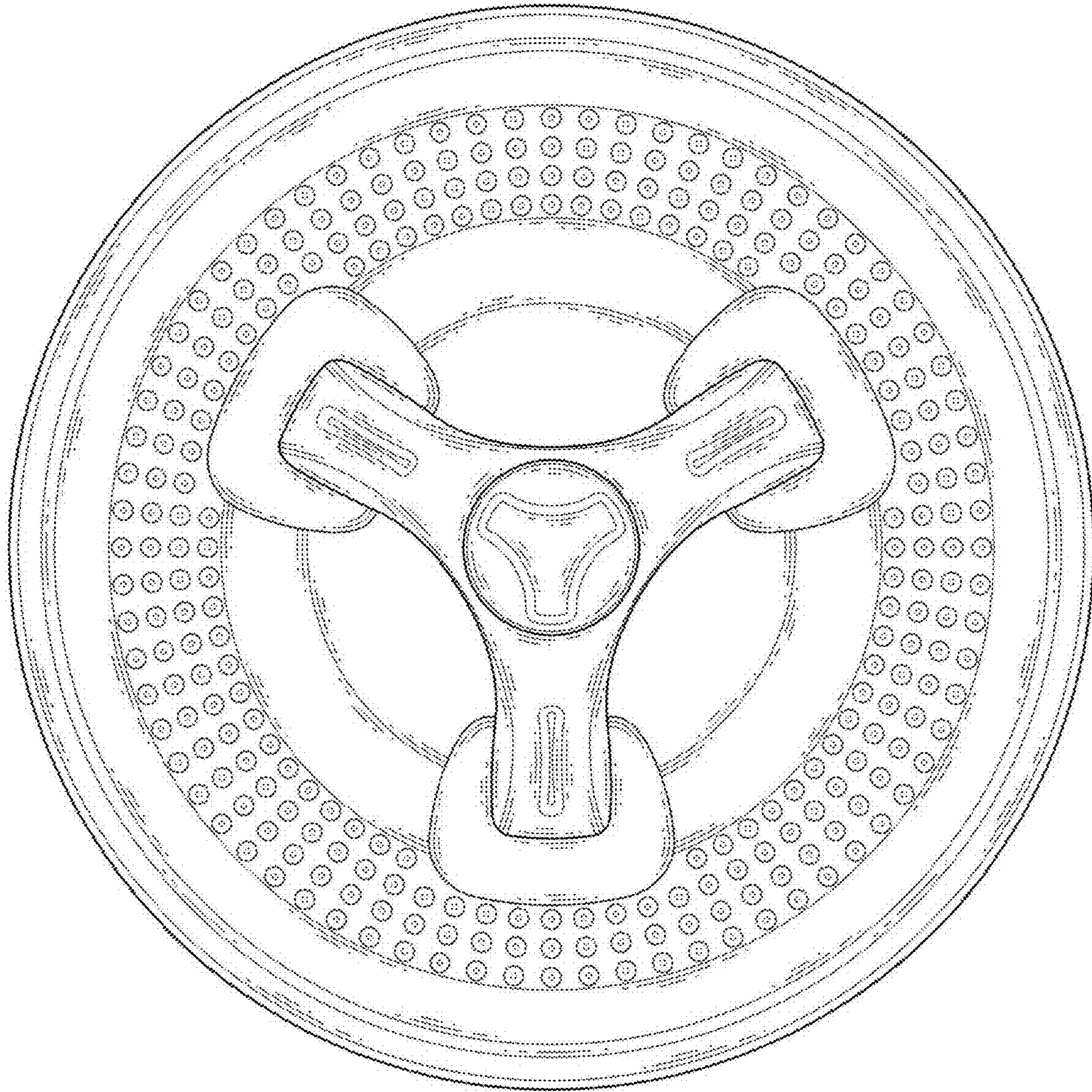
