(57) **CLAIM**

I claim the ornamental design for a pair of sports gloves, as shown and described.

DESCRIPTION

FIG. 1 shows a palm-side, right, and top perspective view of a right hand sports glove in accordance with the present invention;

FIG. 2 shows an elevational palm-side view of the right hand sports glove of FIG. 1;

FIG. 3 shows an elevational backhand view of the right hand sports glove of FIG. 1;

FIG. 4 shows an elevational right side view of the right hand sports glove of FIG. 1;

FIG. 5 shows an elevational left side view of the right hand sports glove of FIG. 1;

FIG. 6 shows an elevational top view of the right hand sports glove of FIG. 1;

FIG. 7 shows an elevational bottom view of the right hand sports glove of FIG. 1;

FIG. 8 shows a palm-side, left, and top perspective view of a left hand sports glove in accordance with the present invention;

FIG. 9 shows an elevational palm-side view of the left hand sports glove of FIG. 8;

FIG. 10 shows an elevational backhand view of the left hand sports glove of FIG. 8;

FIG. 11 shows an elevational left side view of the left hand sports glove of FIG. 8;

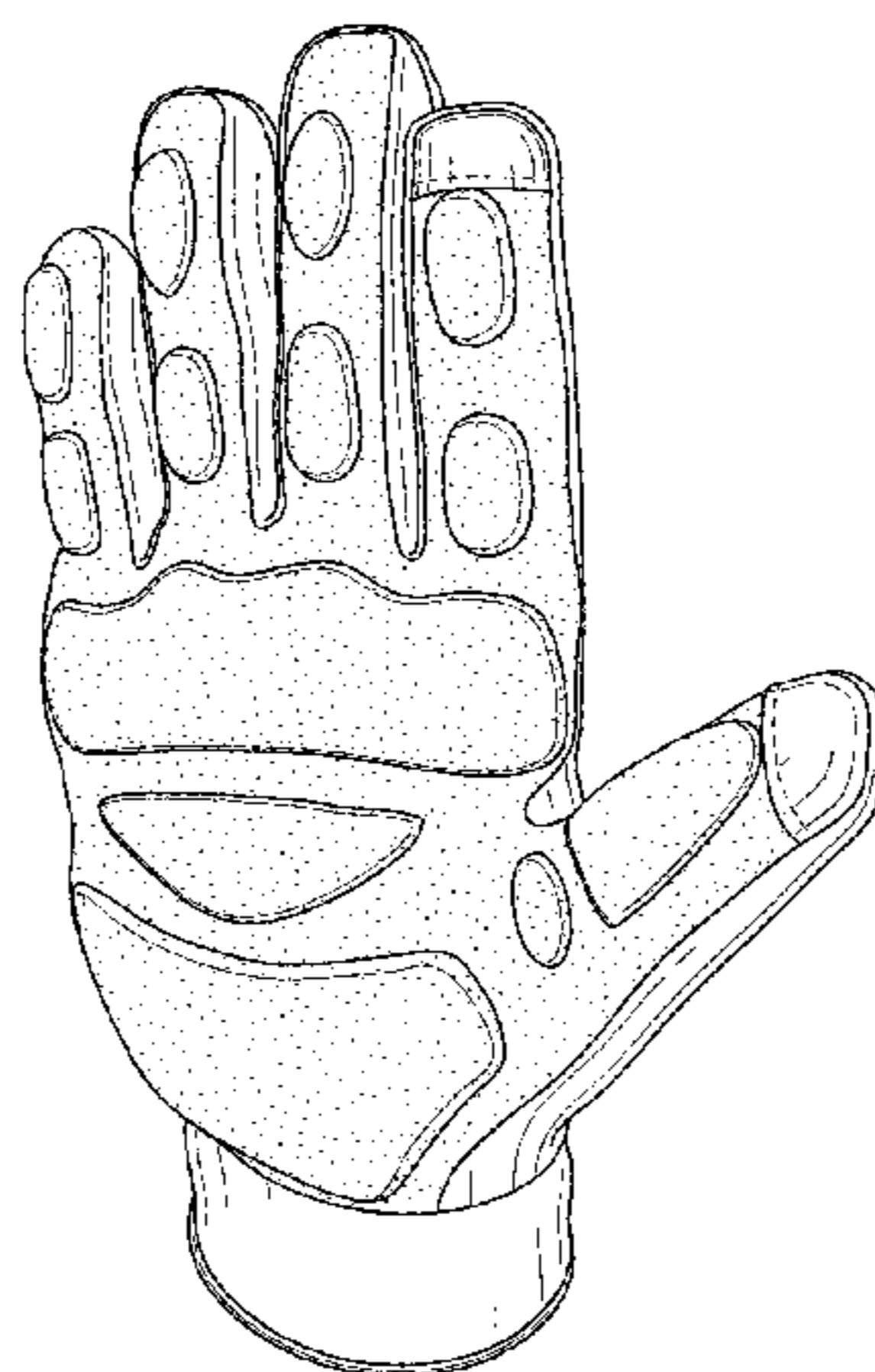
FIG. 12 shows an elevational right side view of the left hand sports glove of FIG. 8;

FIG. 13 shows an elevational top view of the left hand sports glove of FIG. 8;

FIG. 14 shows an elevational bottom view of the left hand sports glove of FIG. 8; and,

FIG. 15 shows an elevational backhand view of the right hand sports glove of FIG. 1 worn on a right hand of a person, and the left hand sport glove of FIG. 8 worn on a left hand of the person, with the person shown in a simplified form. The right-hand sports glove of FIGS. 1-7 and the left-hand sports glove of FIGS. 8-14 are shown separately from one another for ease of illustration. The person shown in broken

lines in FIG. 15 illustrates the claimed design in use. The broken-line subject matter forms no part of the claim. The broken lines on the surface of the glove illustrate stitching on the glove and form no part of the claimed design.

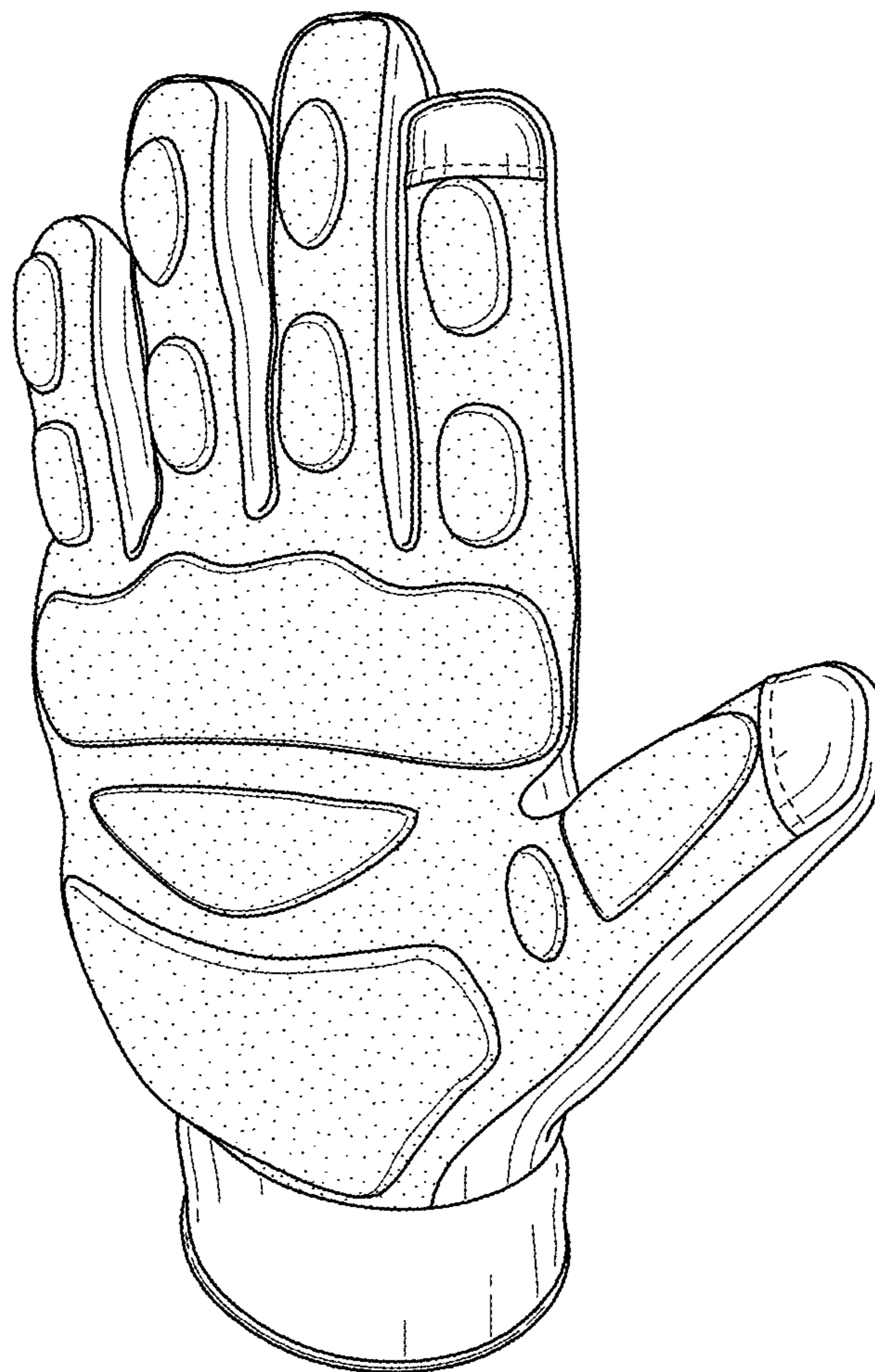

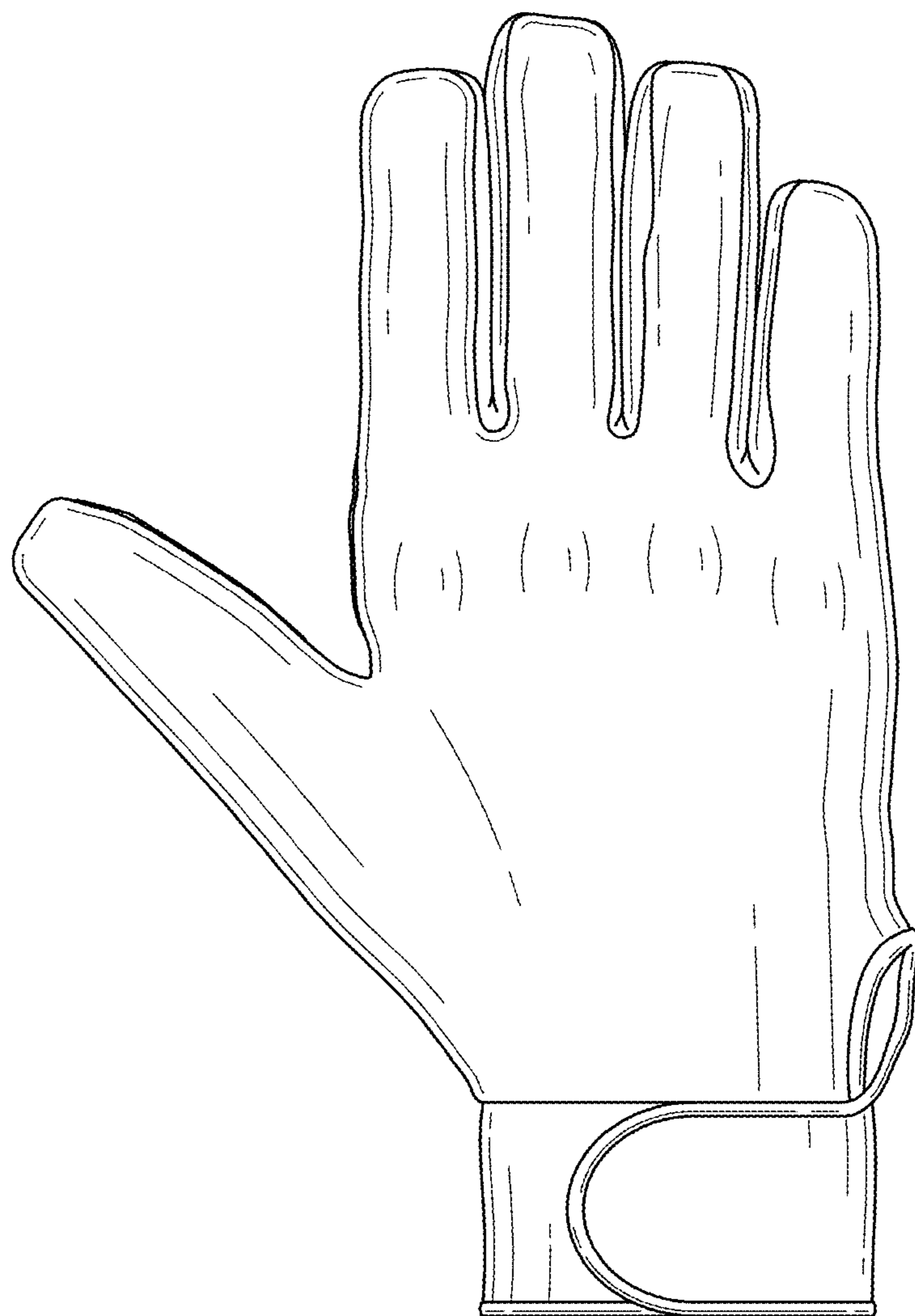

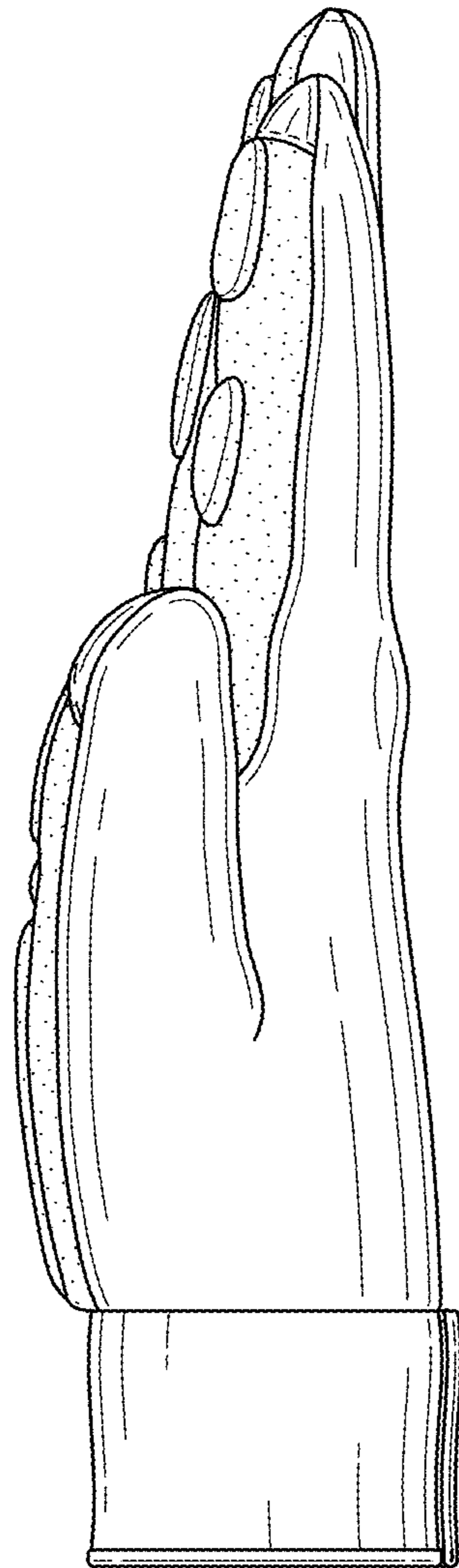

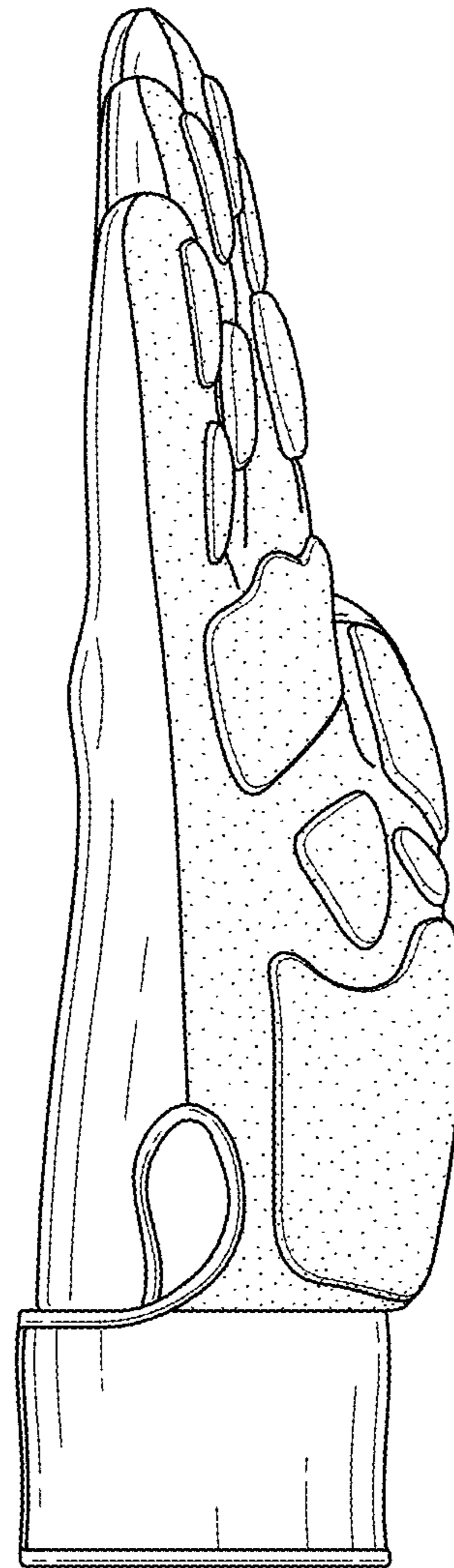

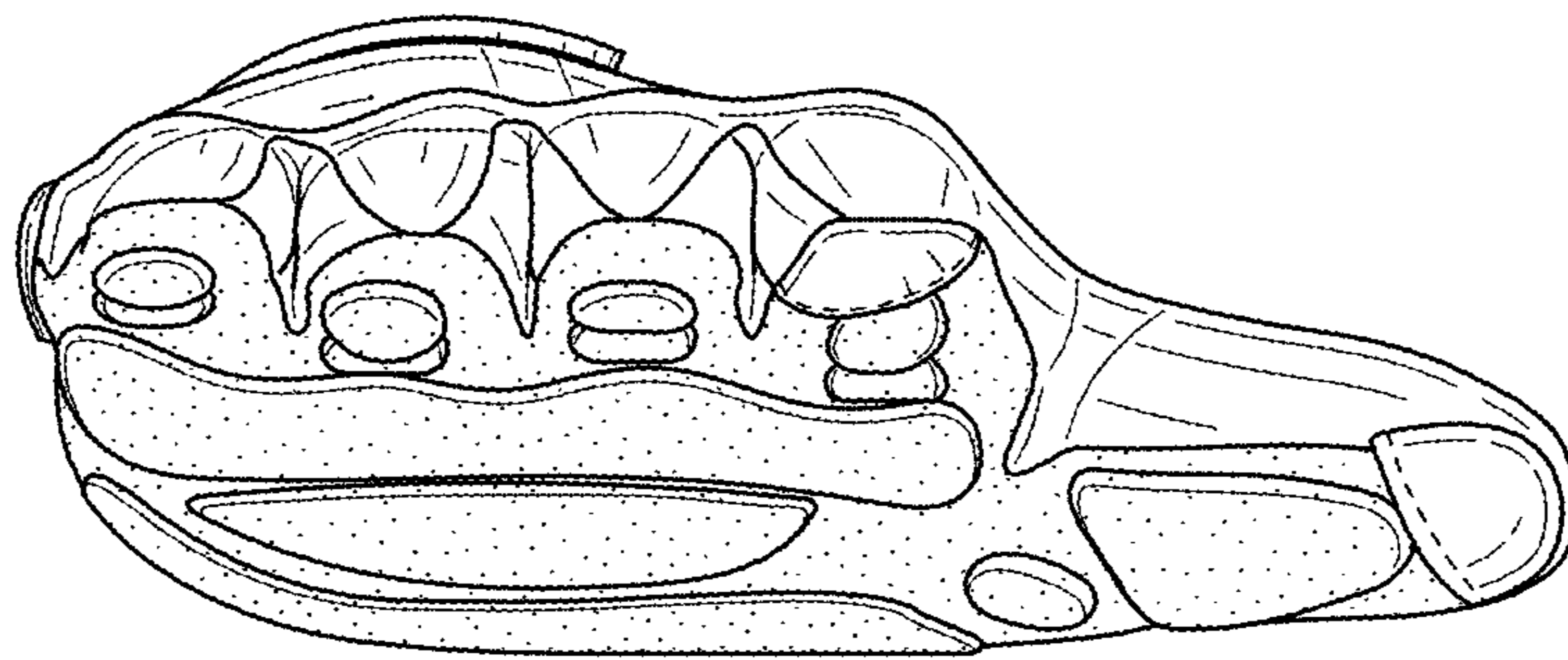

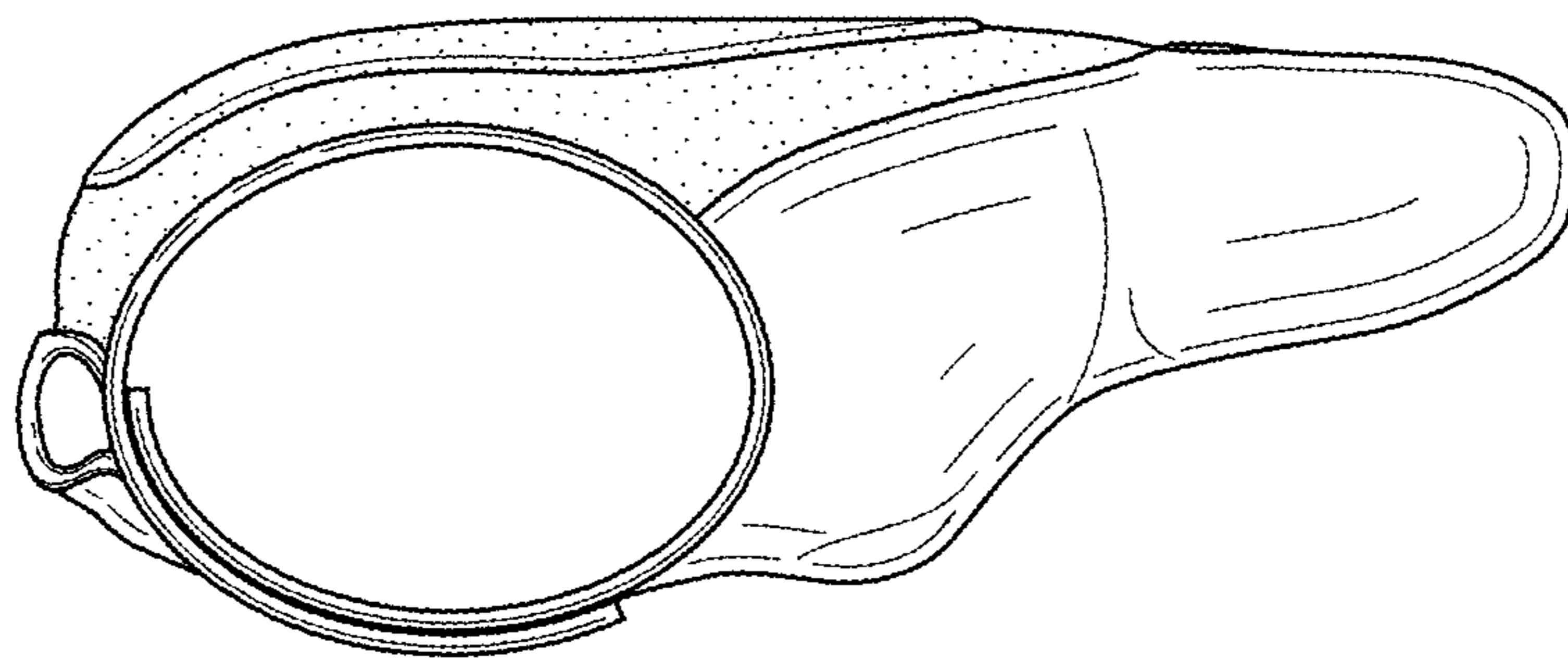

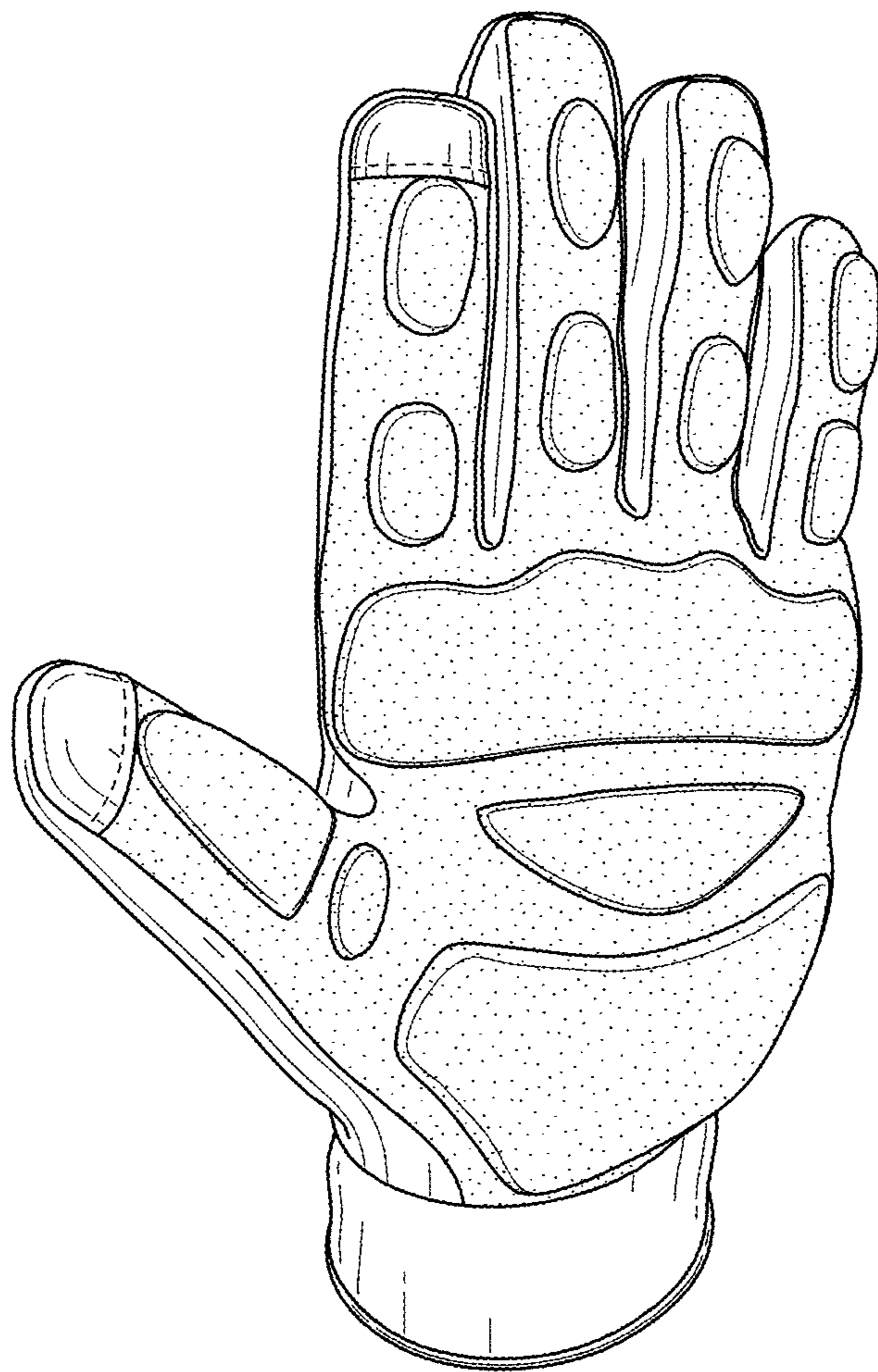

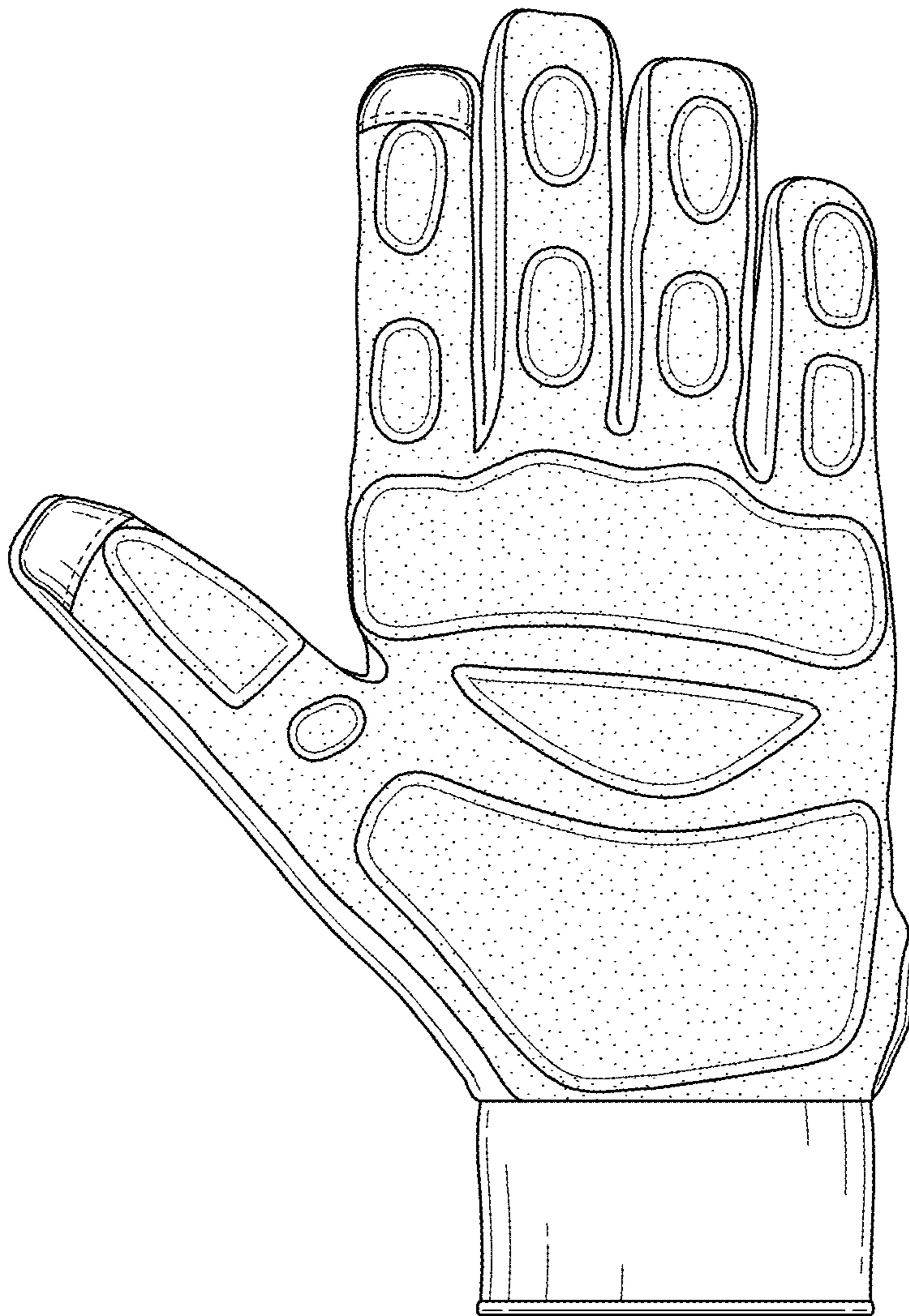

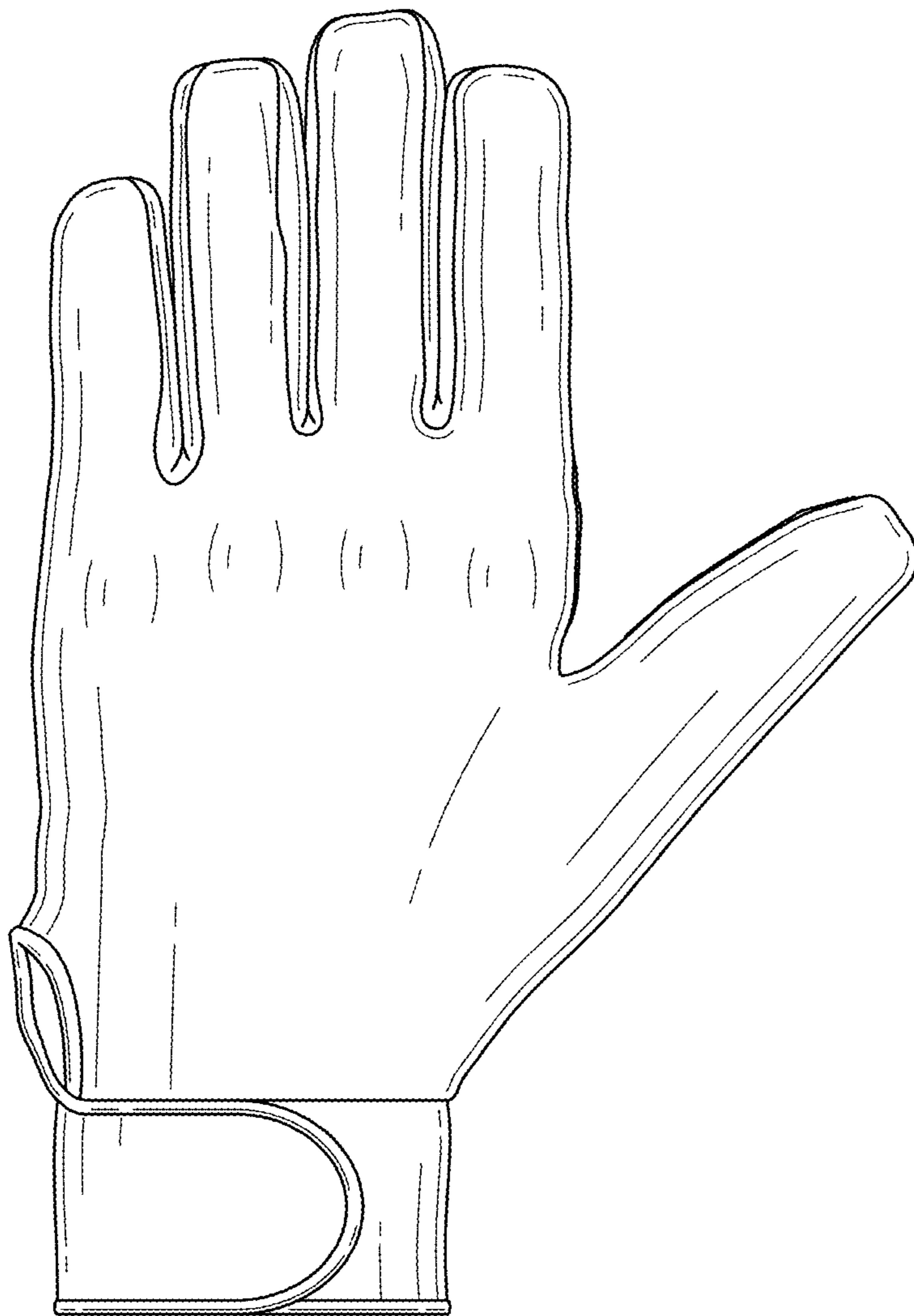

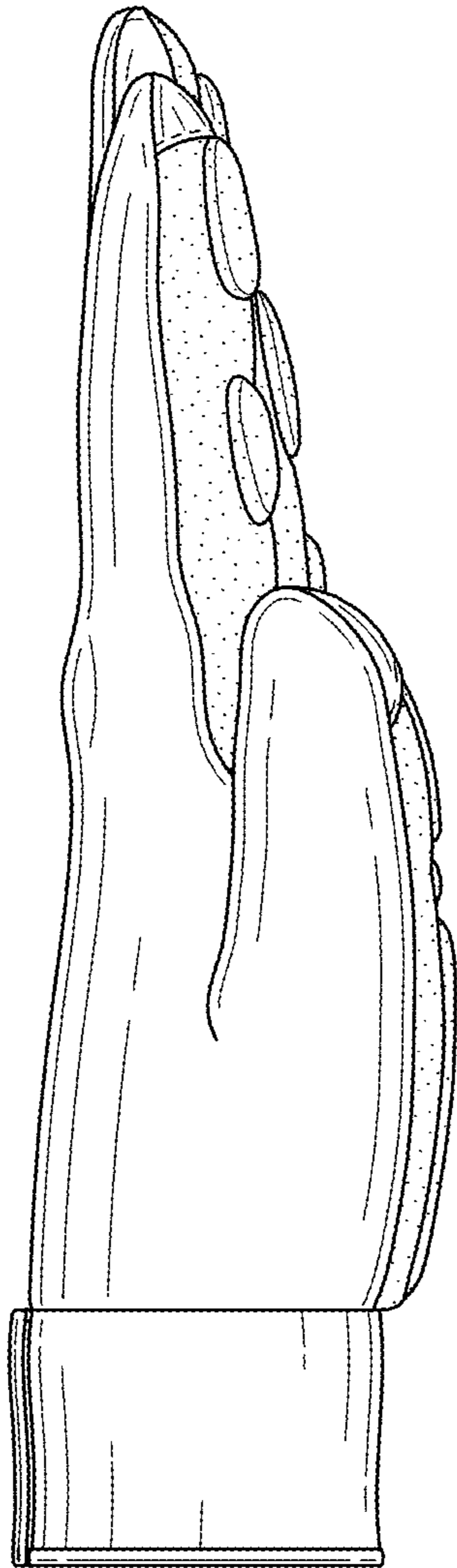

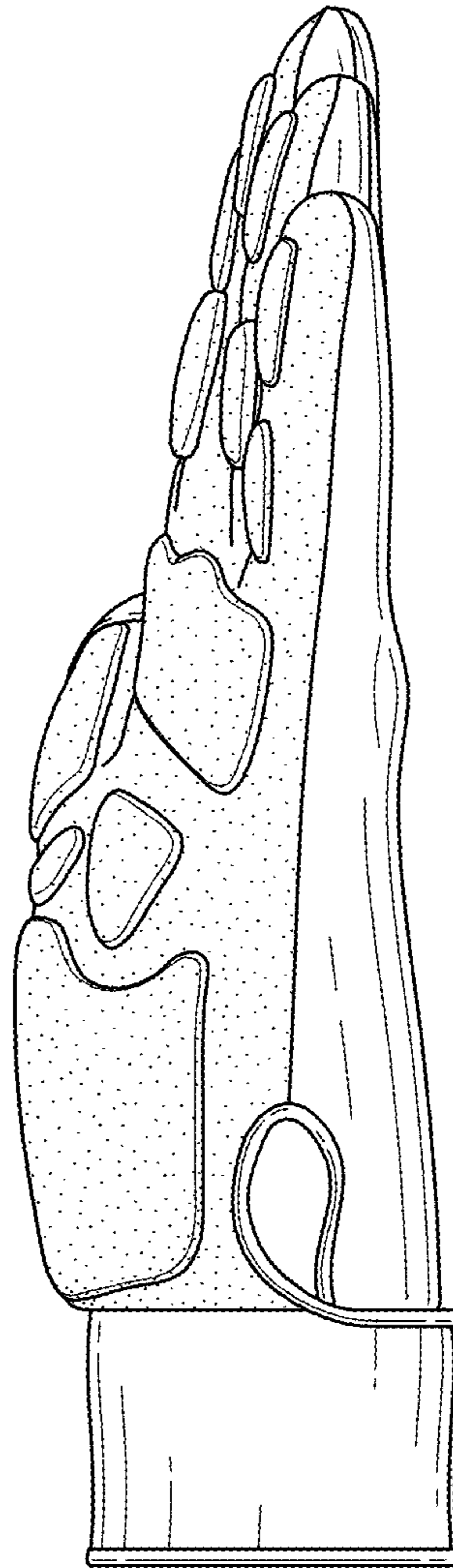

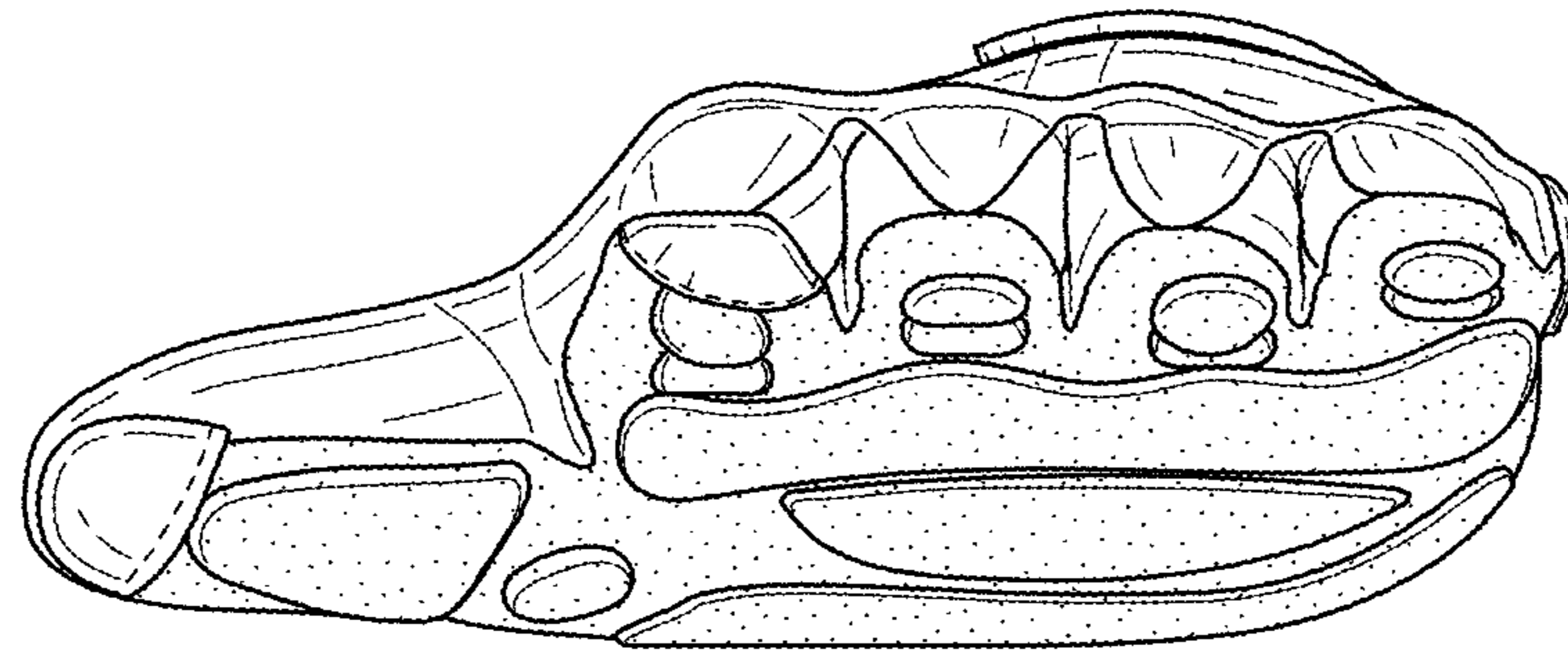

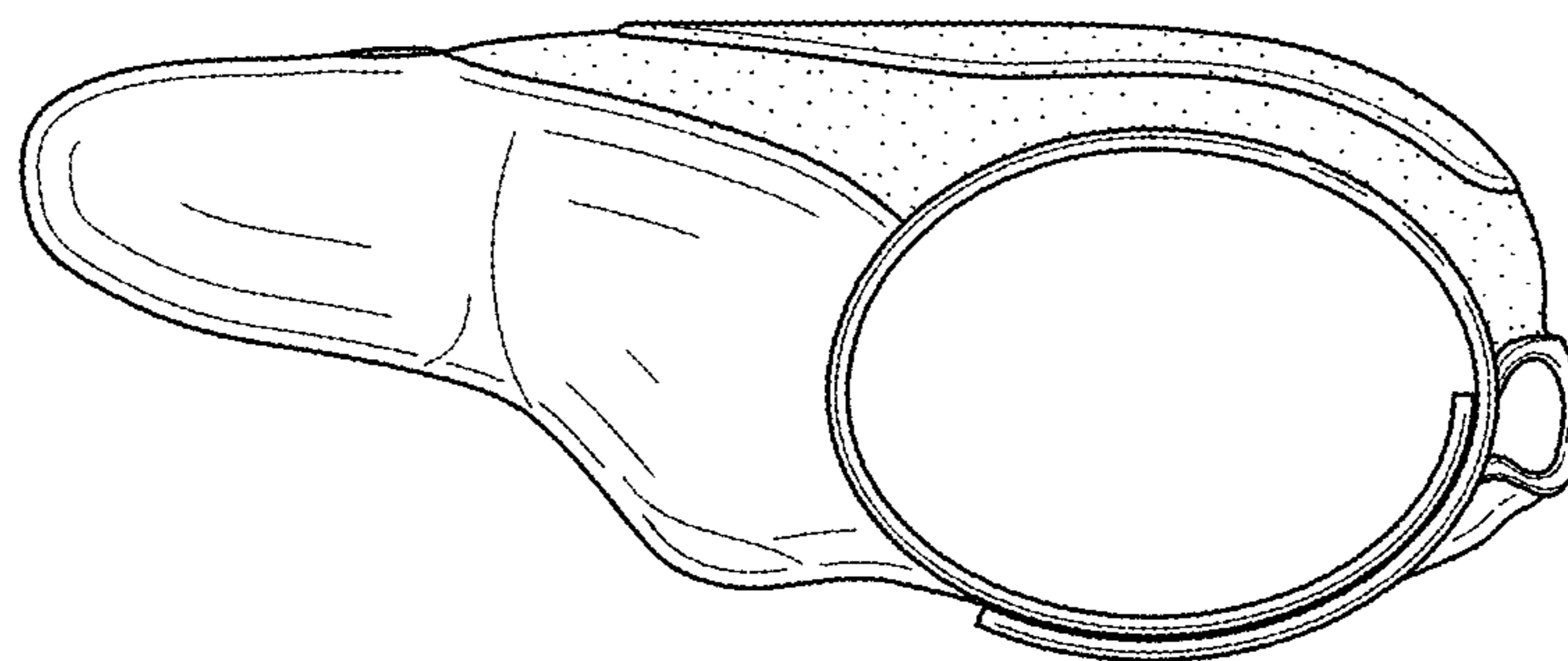
