(57) **CLAIM**

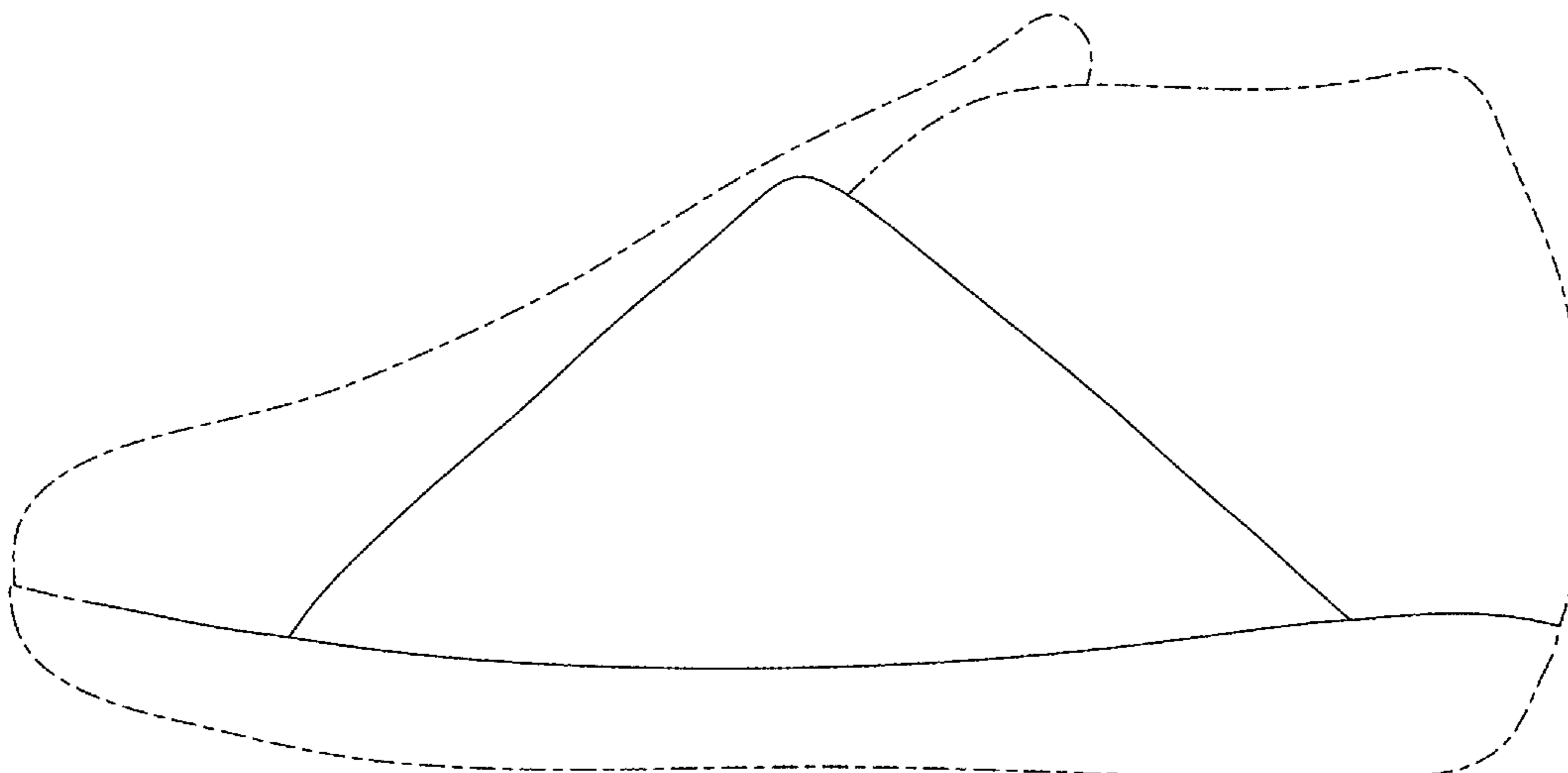
The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a shoe upper showing our new design; and,

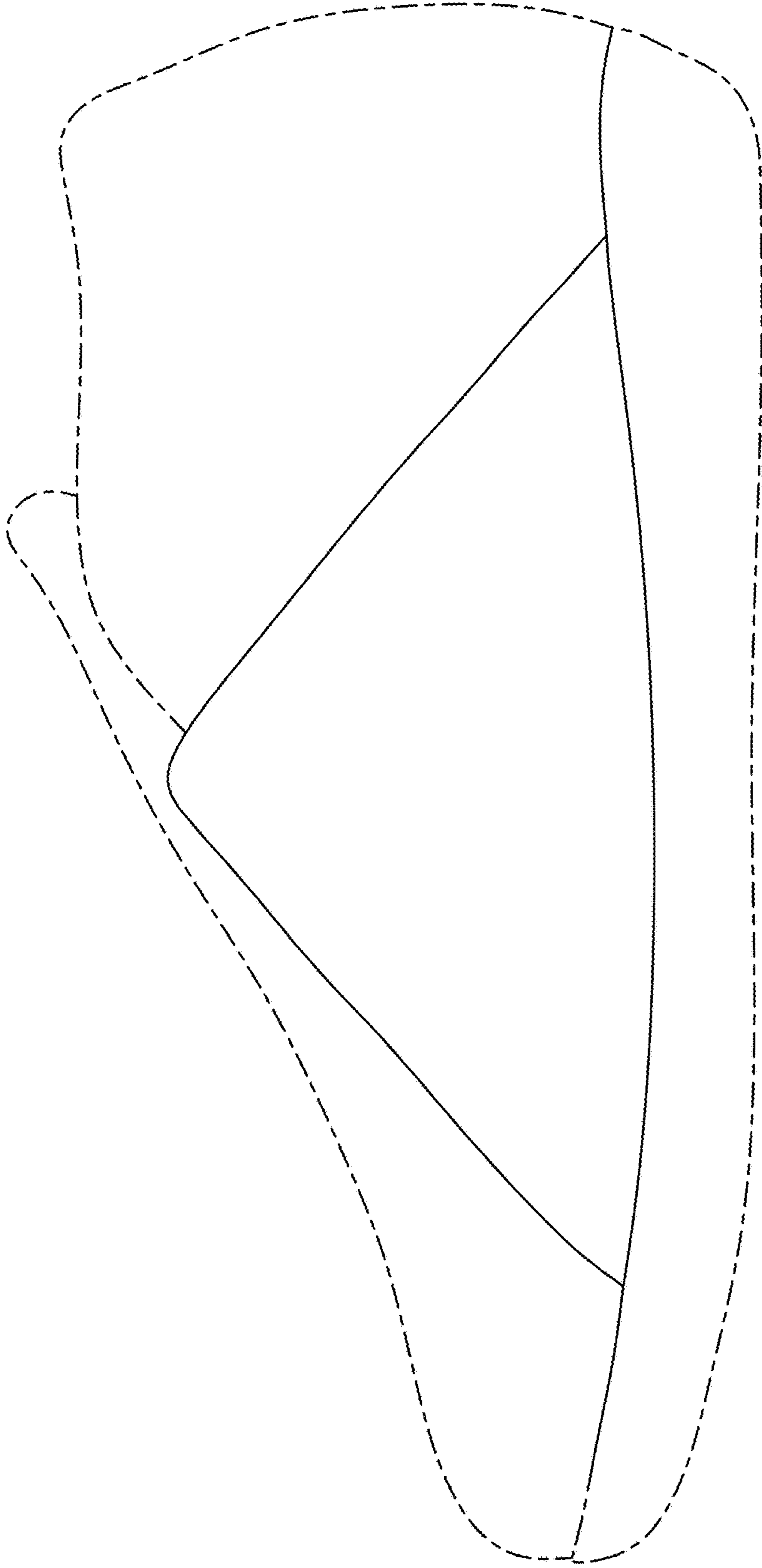

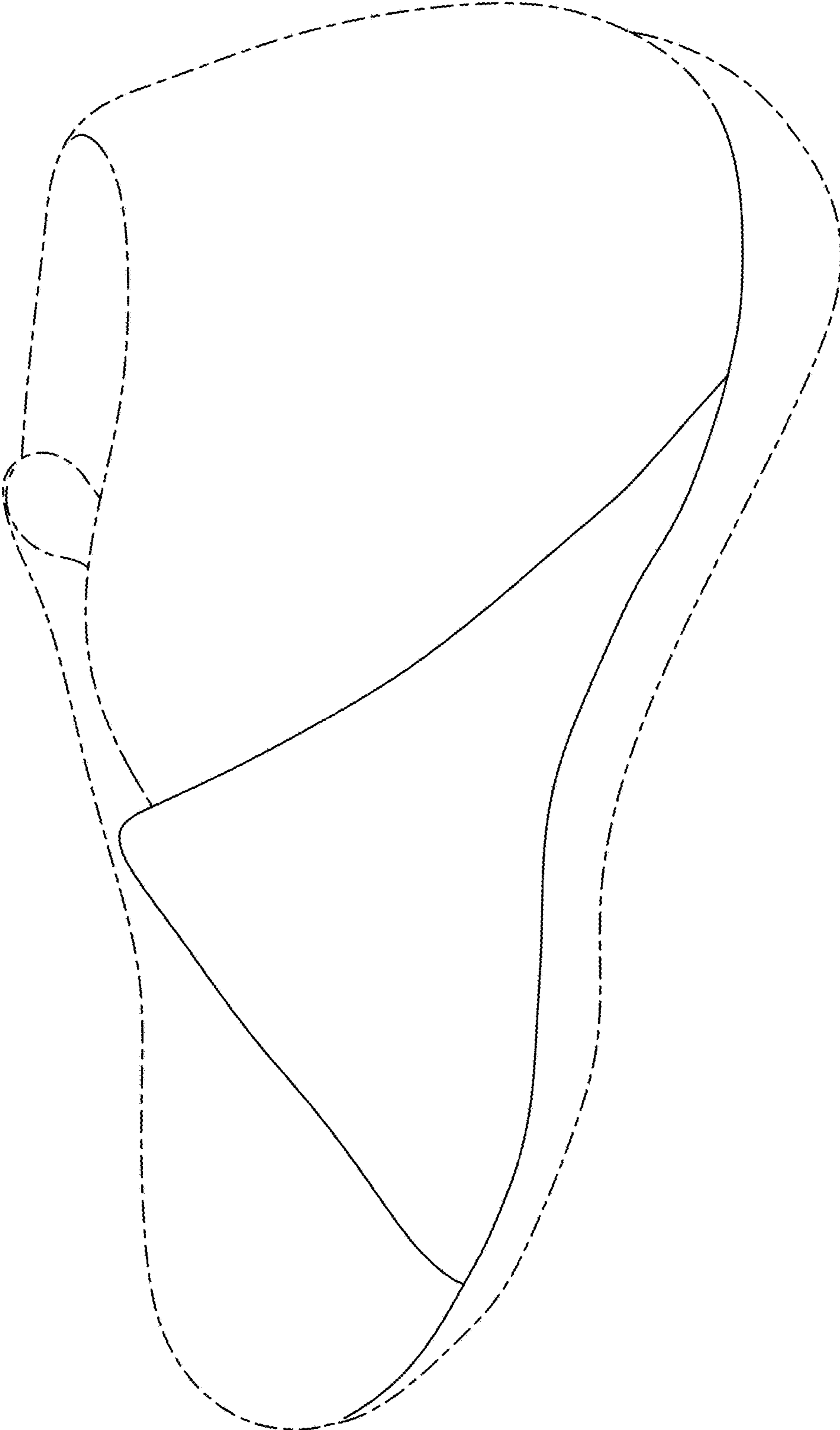
