(57) **CLAIM**

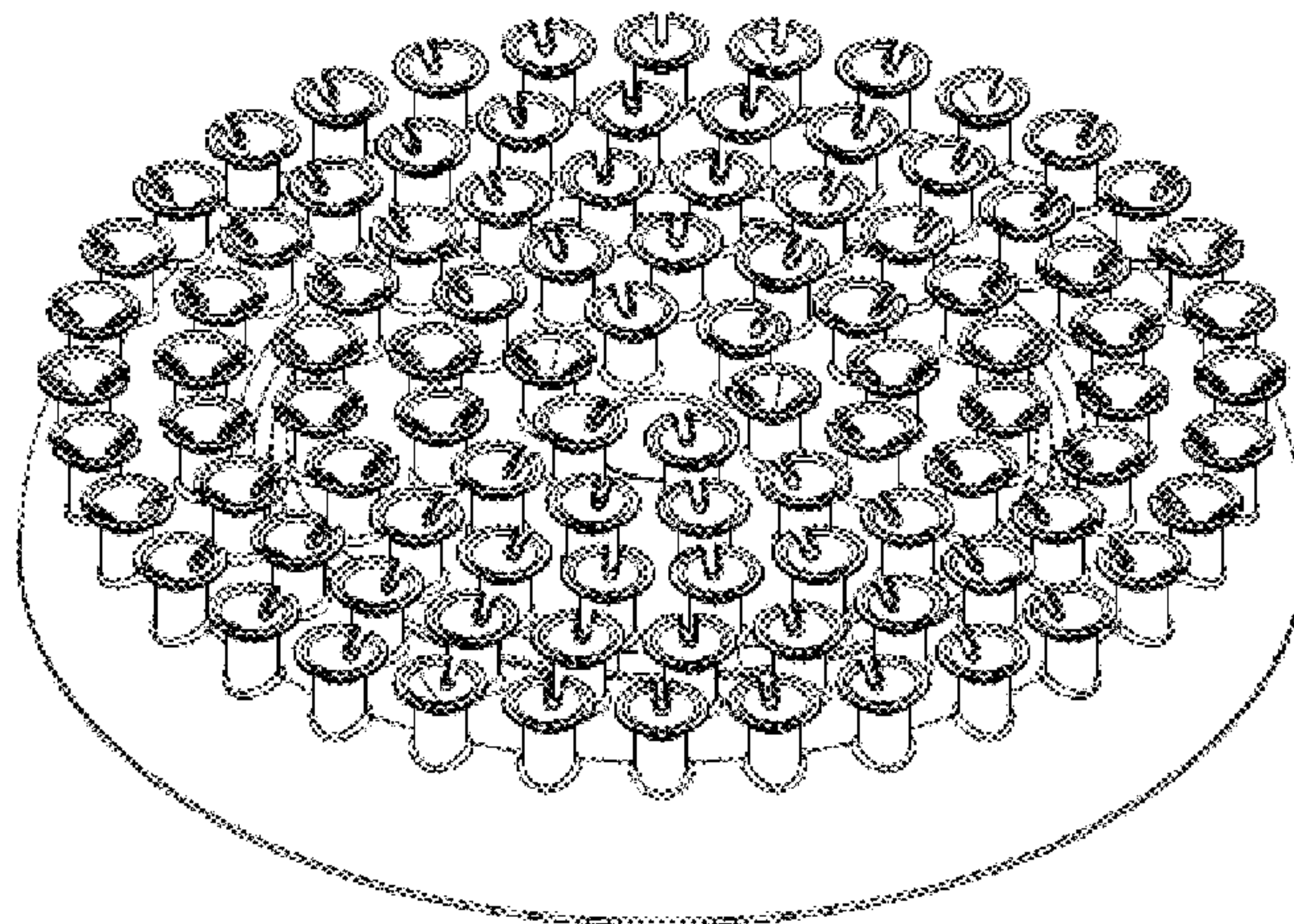
We claim the ornamental design for a treatment brush head,
as shown and described.

DESCRIPTION

This application is related to U.S. Non-provisional patent
application Ser. No. 14/825,316, filed Aug. 13, 2015, each of
which is incorporated by reference herein, in the entirety and
for all purposes.

FIG. 1 is an isometric view of a treatment brush head.
FIG. 2 is a top view of the treatment brush head of FIG. 1.
FIG. 3 is a front elevation view of the treatment brush head
of FIG. 1.
FIG. 4 is a right-side elevation view of the treatment brush
head of FIG. 1.
FIG. 5 is a left-side elevation view of the treatment brush
head of FIG. 1.
FIG. 6 is a rear elevation view of the treatment brush head
of FIG. 1.
FIG. 7 is a bottom view of the treatment brush head of FIG.
1; and,
FIG. 8 is a cross-section view of the treatment brush head of
FIG. 1 taken from a cutting plane as indicated in FIG. 3 that
cuts the treatment brush head in half.
The broken lines depict portions of the article that form no
part of the claimed design.

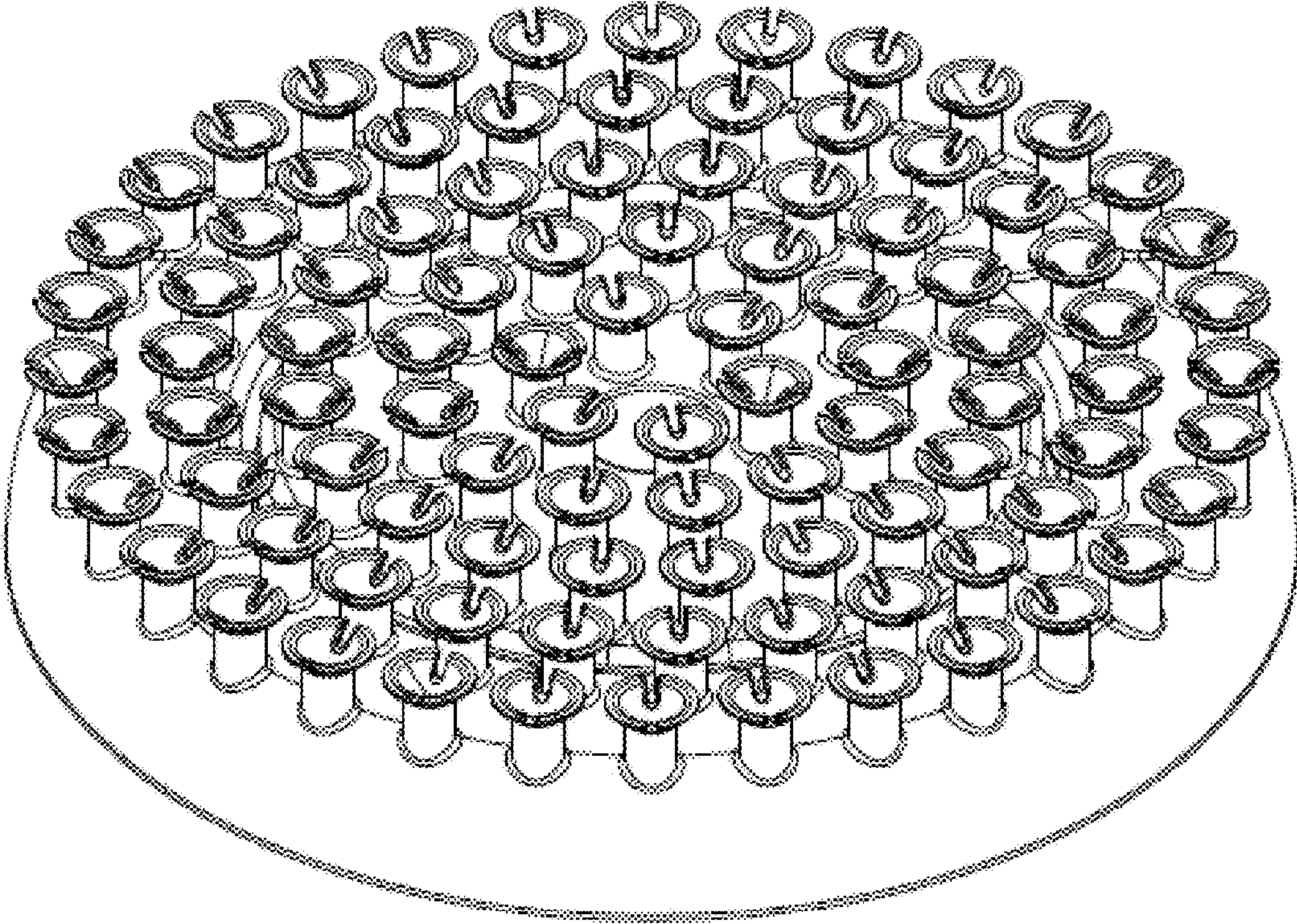

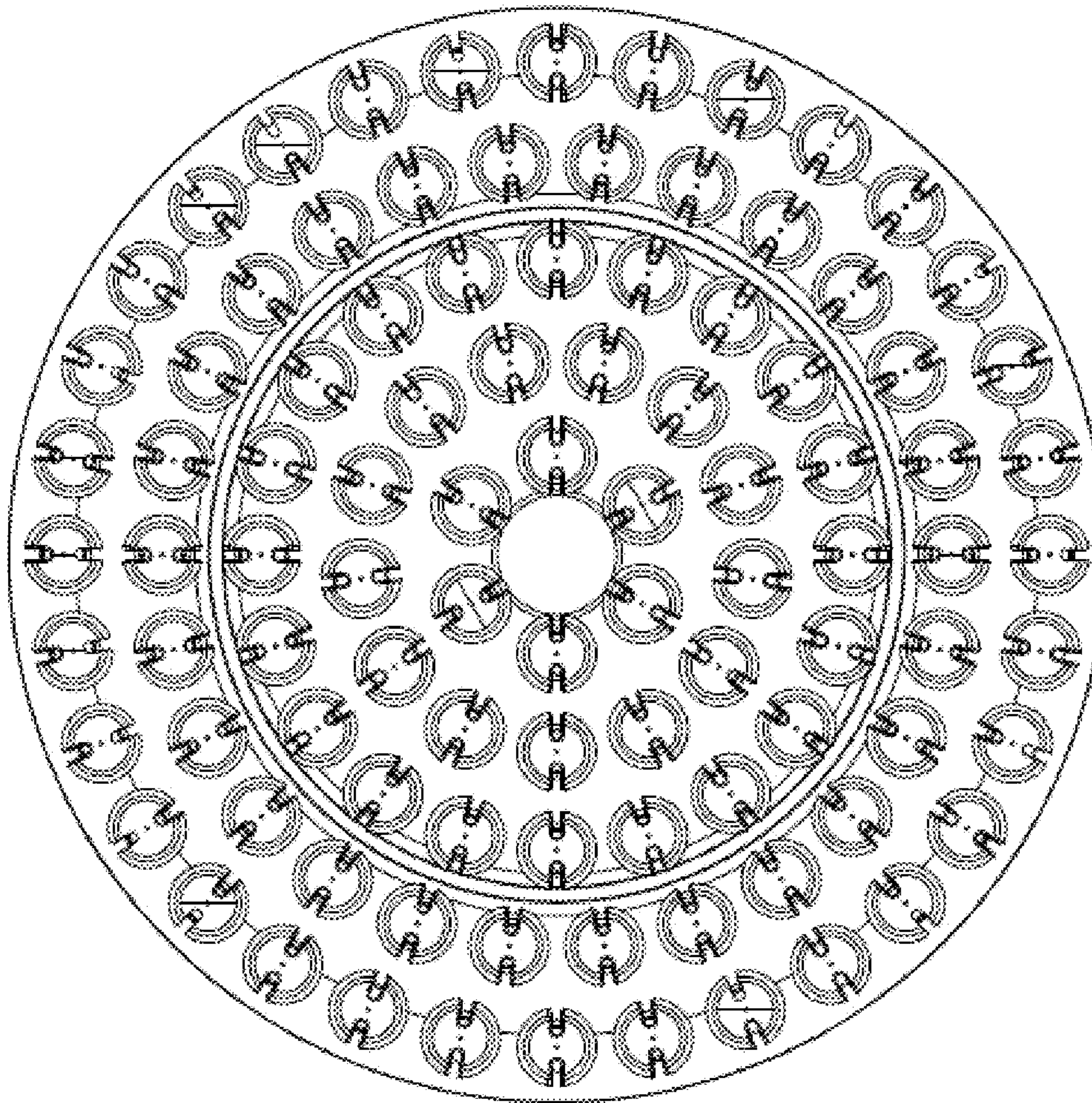

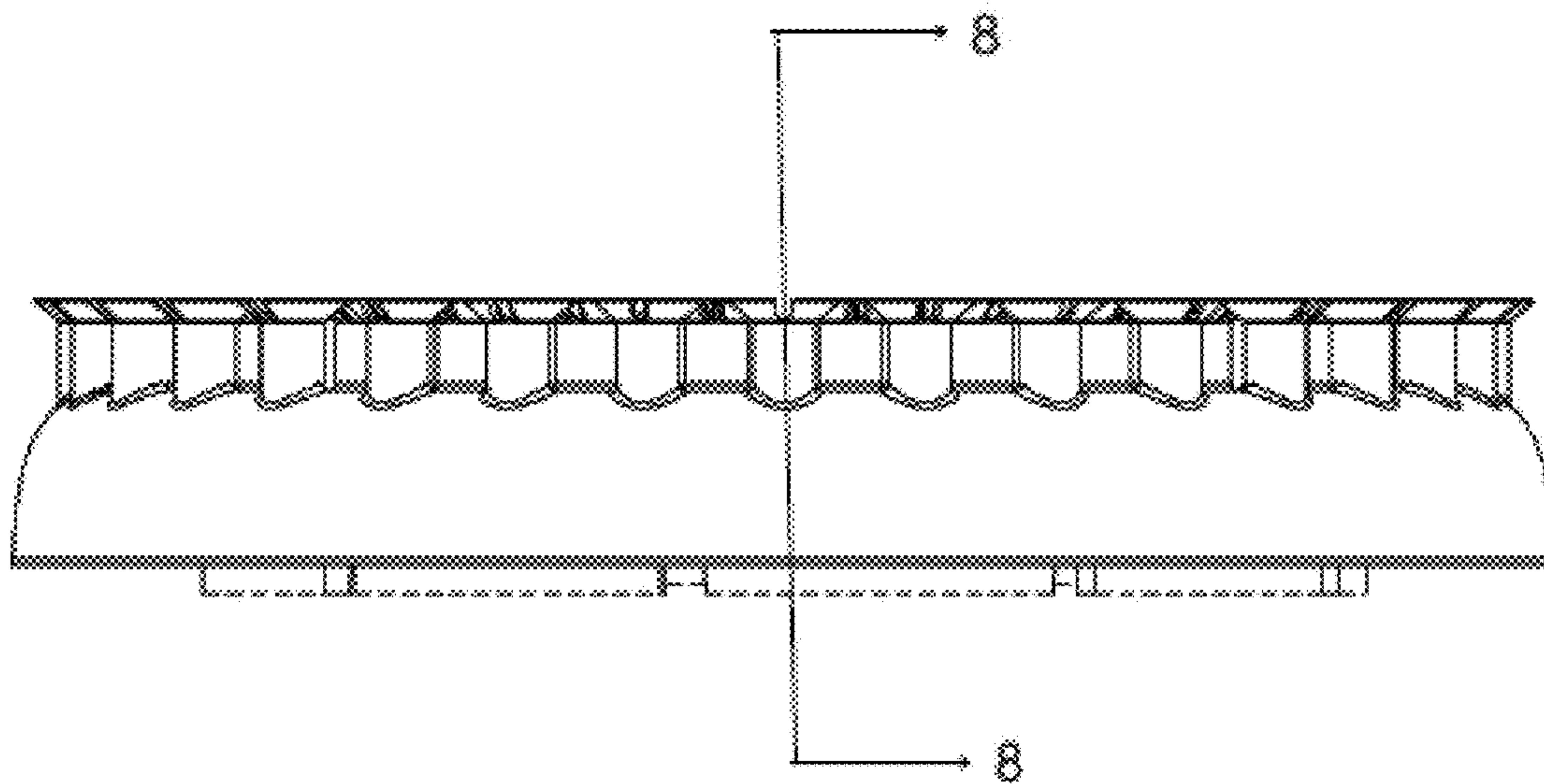

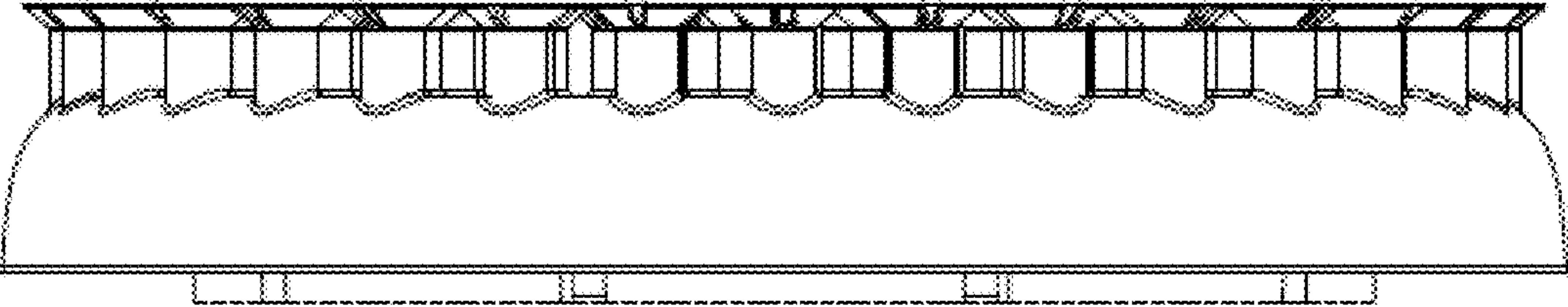

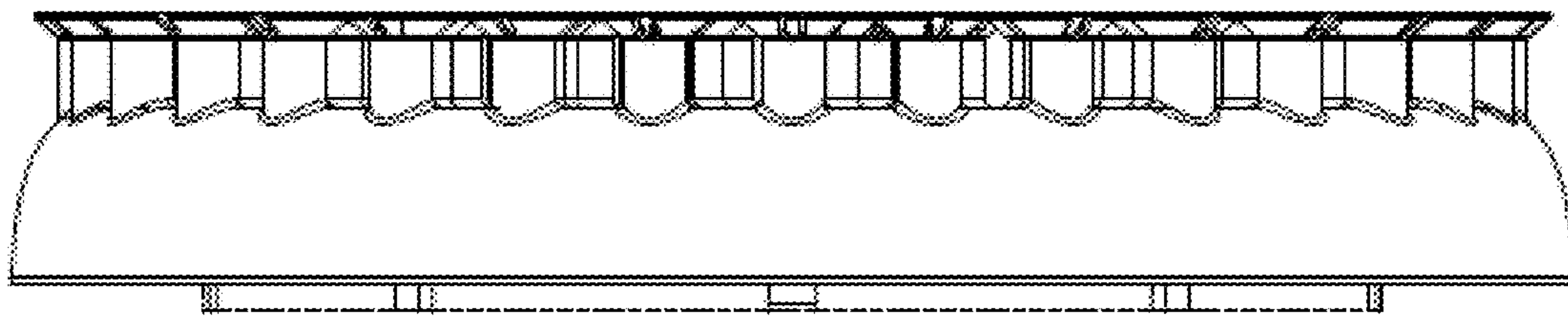

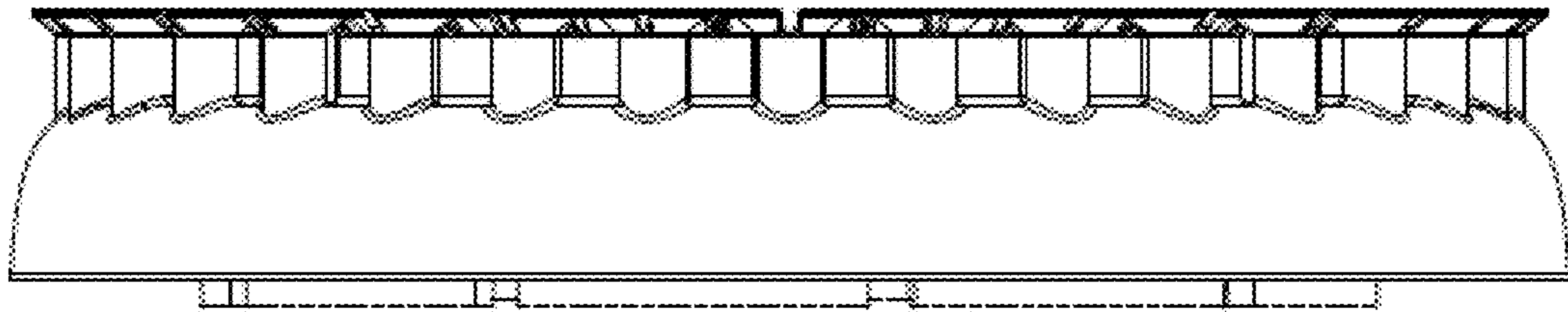

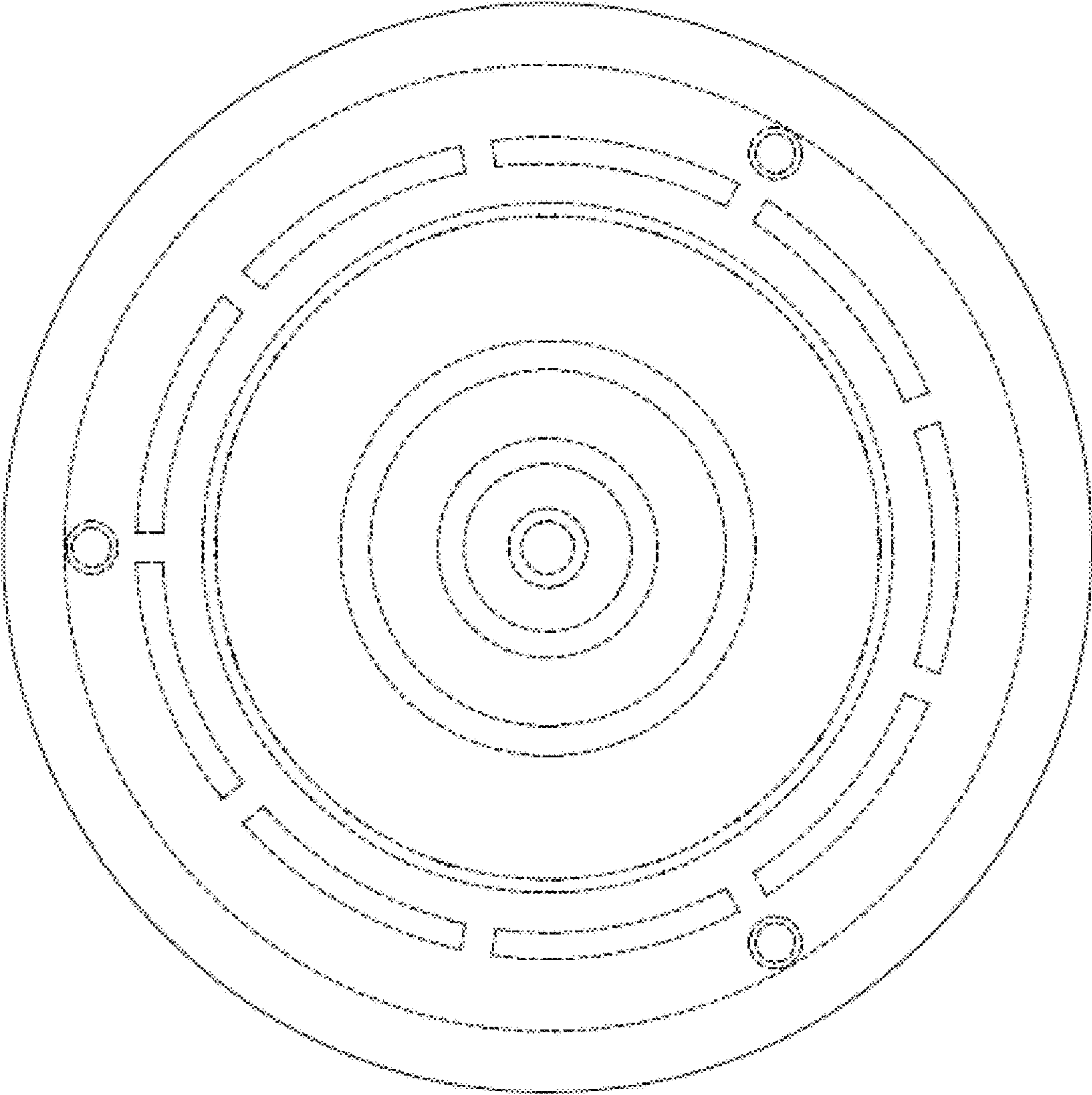

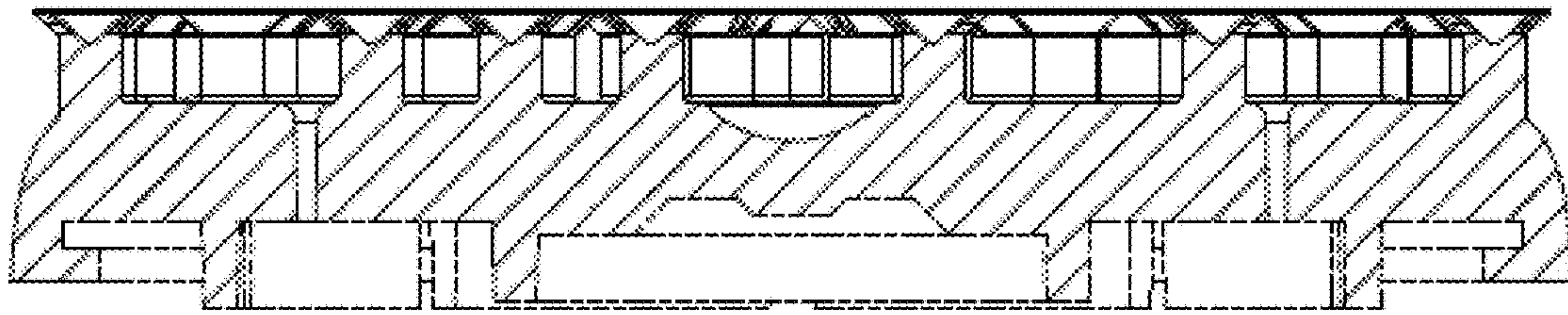
