(57) **CLAIM**

The ornamental design for an inflatable chaise lounge, as shown and described.

DESCRIPTION

FIG. 1 is an upper side perspective of an inflatable chaise lounge embodying my design;

FIG. 2 is a side elevation of the inflatable chaise lounge shown in FIG. 1, with the opposite side elevation being substantially identical thereof;

FIG. 3 is a rear elevation of the inflatable chaise lounge shown in FIGS. 1 and 2;

FIG. 4 is a front elevation of the inflatable chaise lounge shown in FIGS. 1-3;

FIG. 5 is a top view of the inflatable chaise lounge shown in FIGS. 1-4;

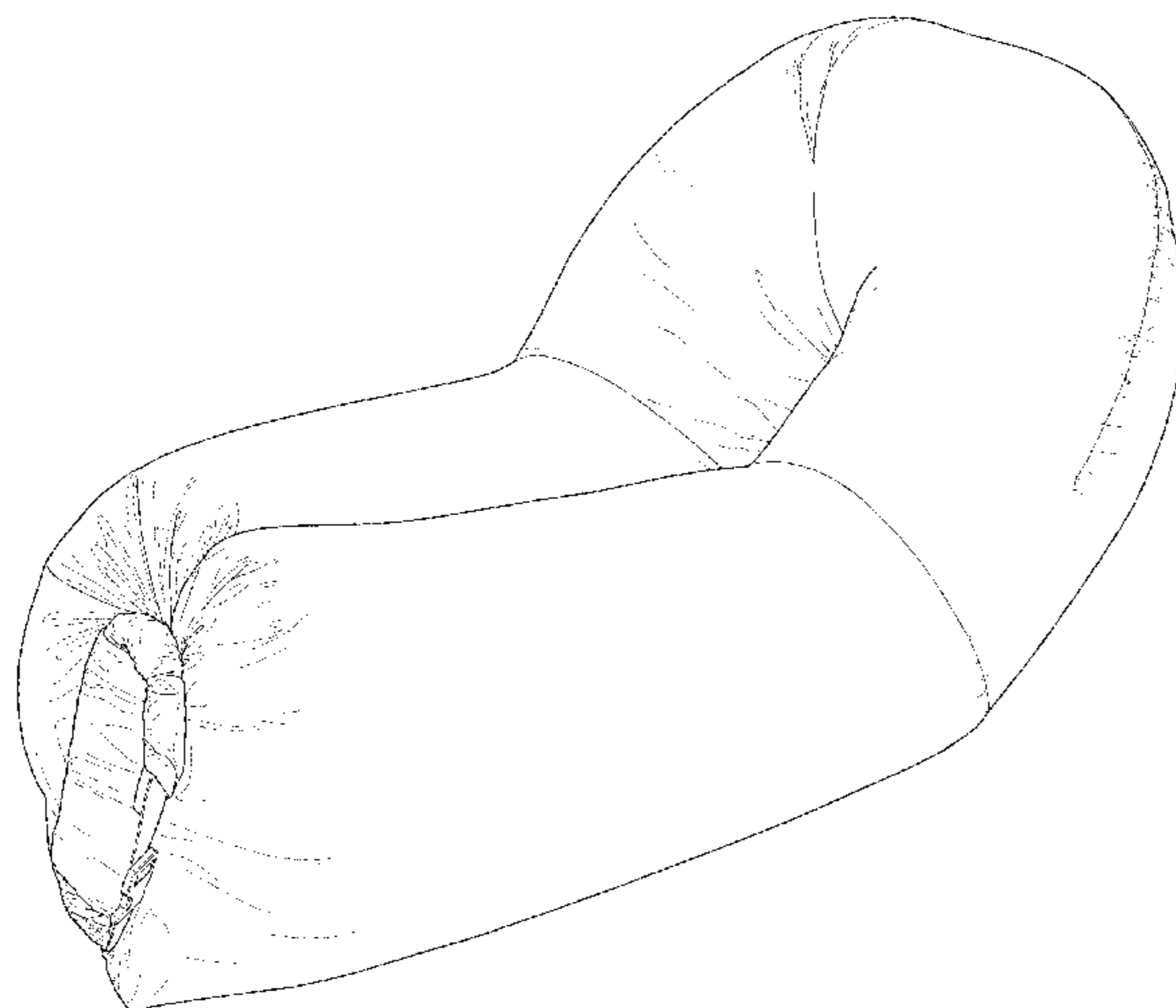
FIG. 6 is a bottom view of the inflatable chaise lounge shown in FIGS. 1-5; and,

FIG. 7 is a fragmentary, enlarged front perspective of the inflatable chaise lounge shown in FIGS. 1-6.

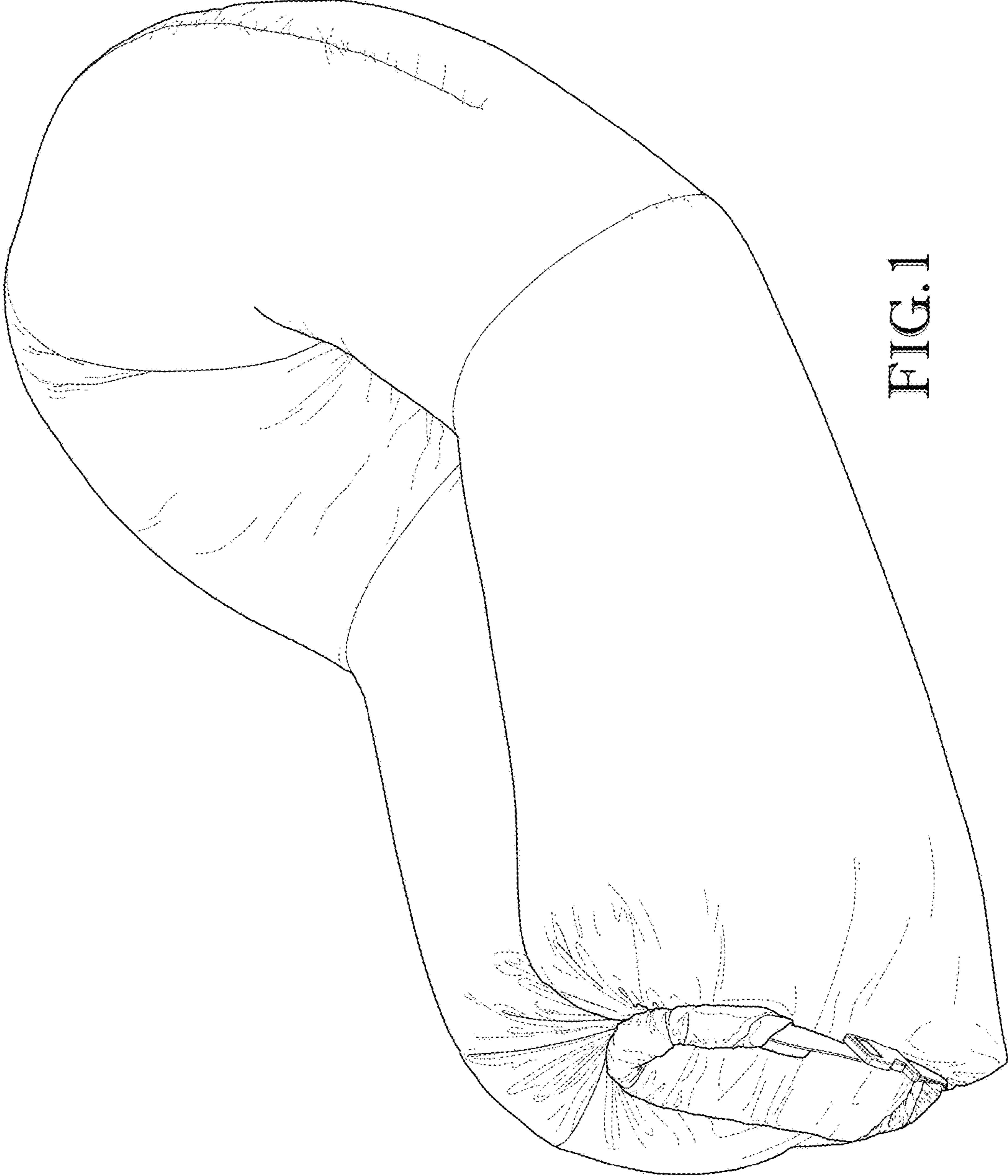

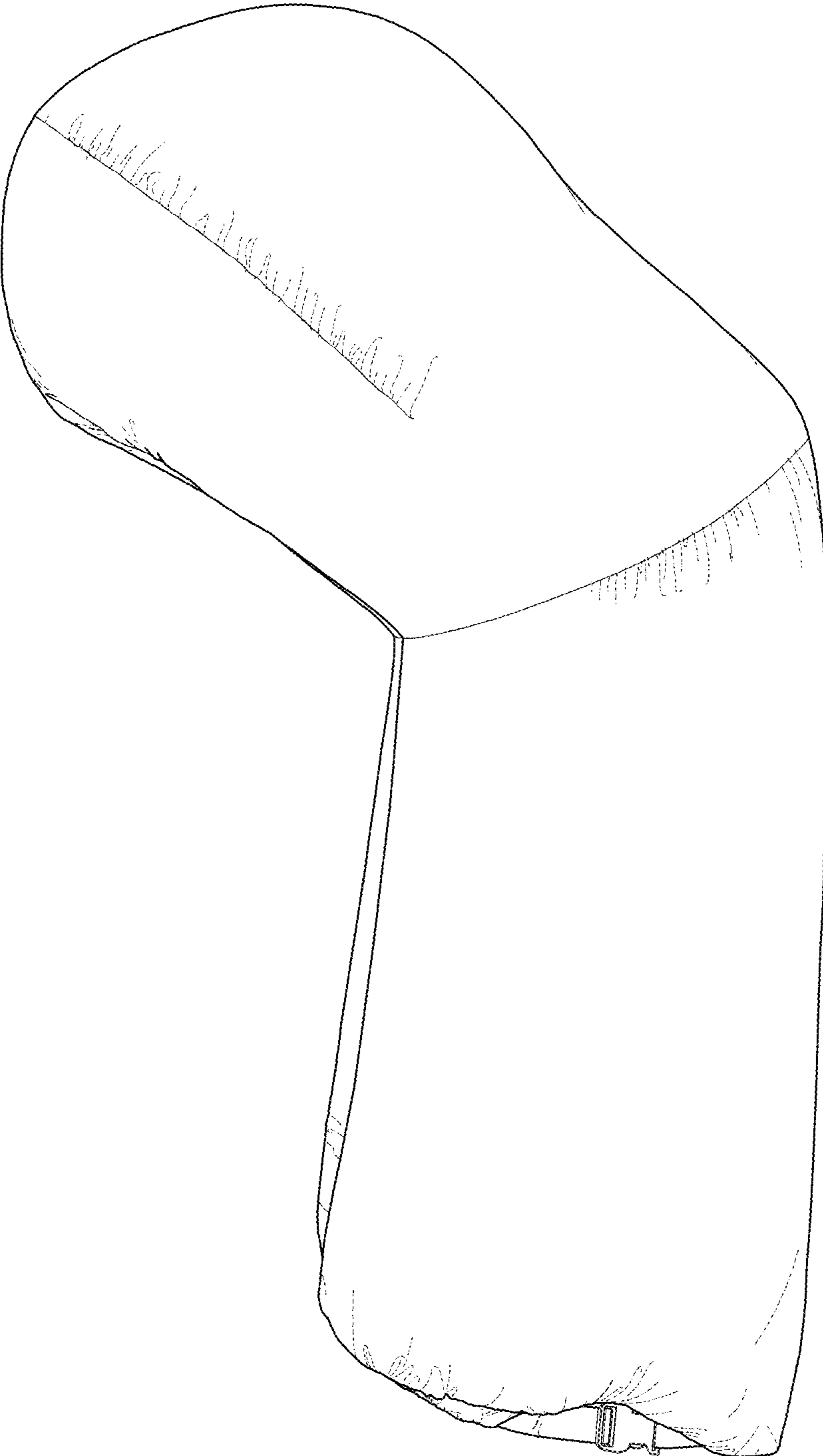

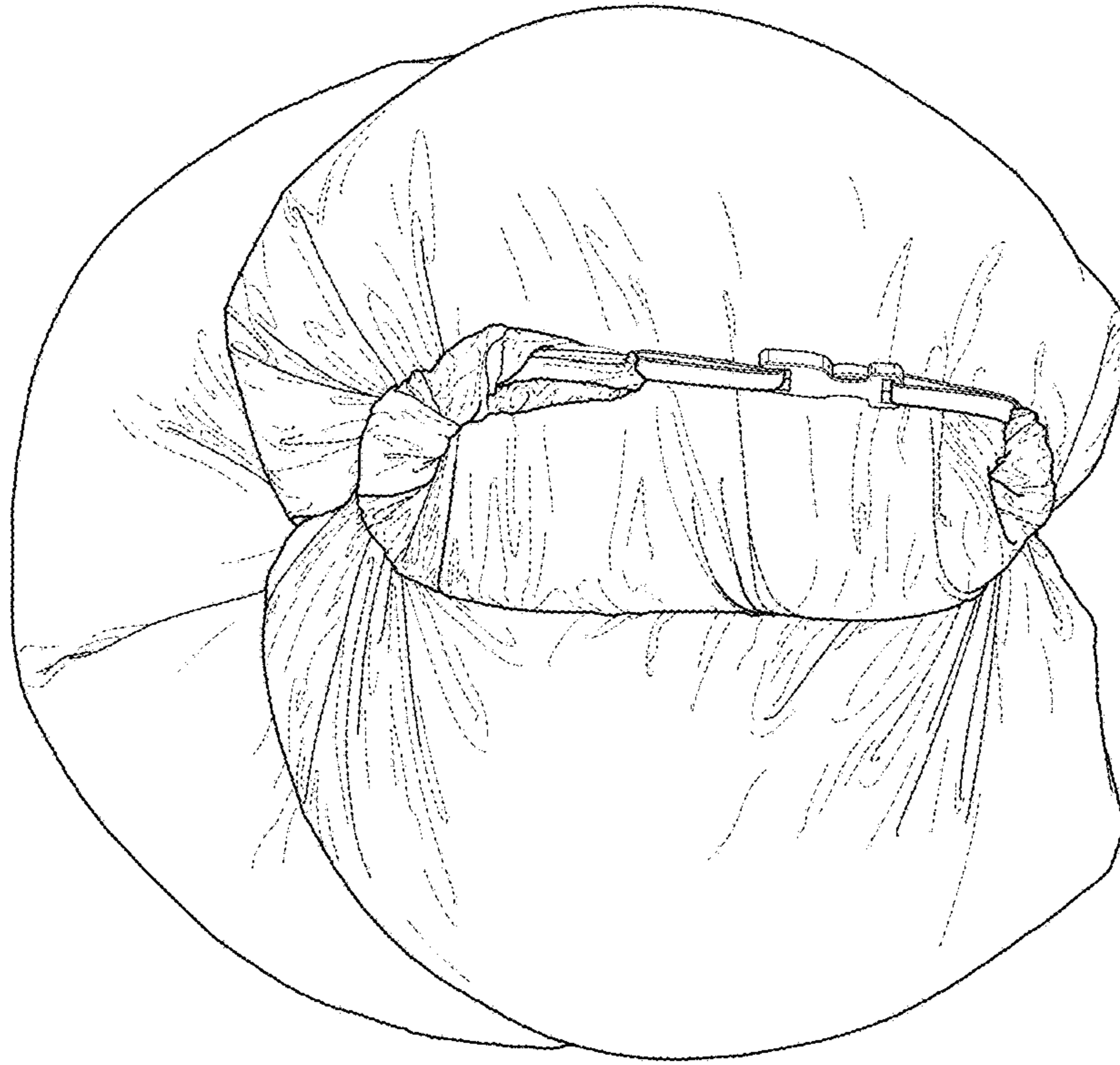

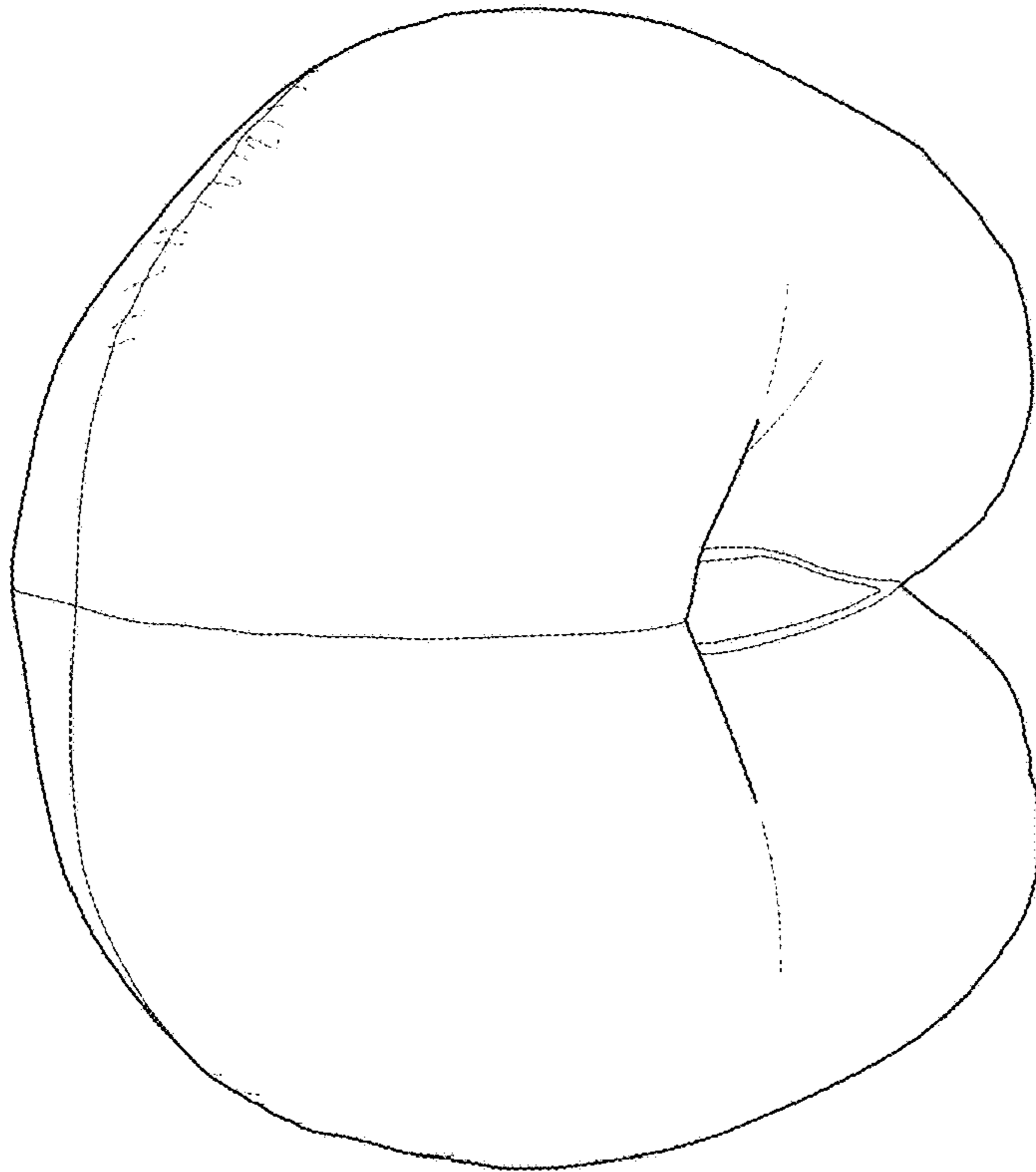

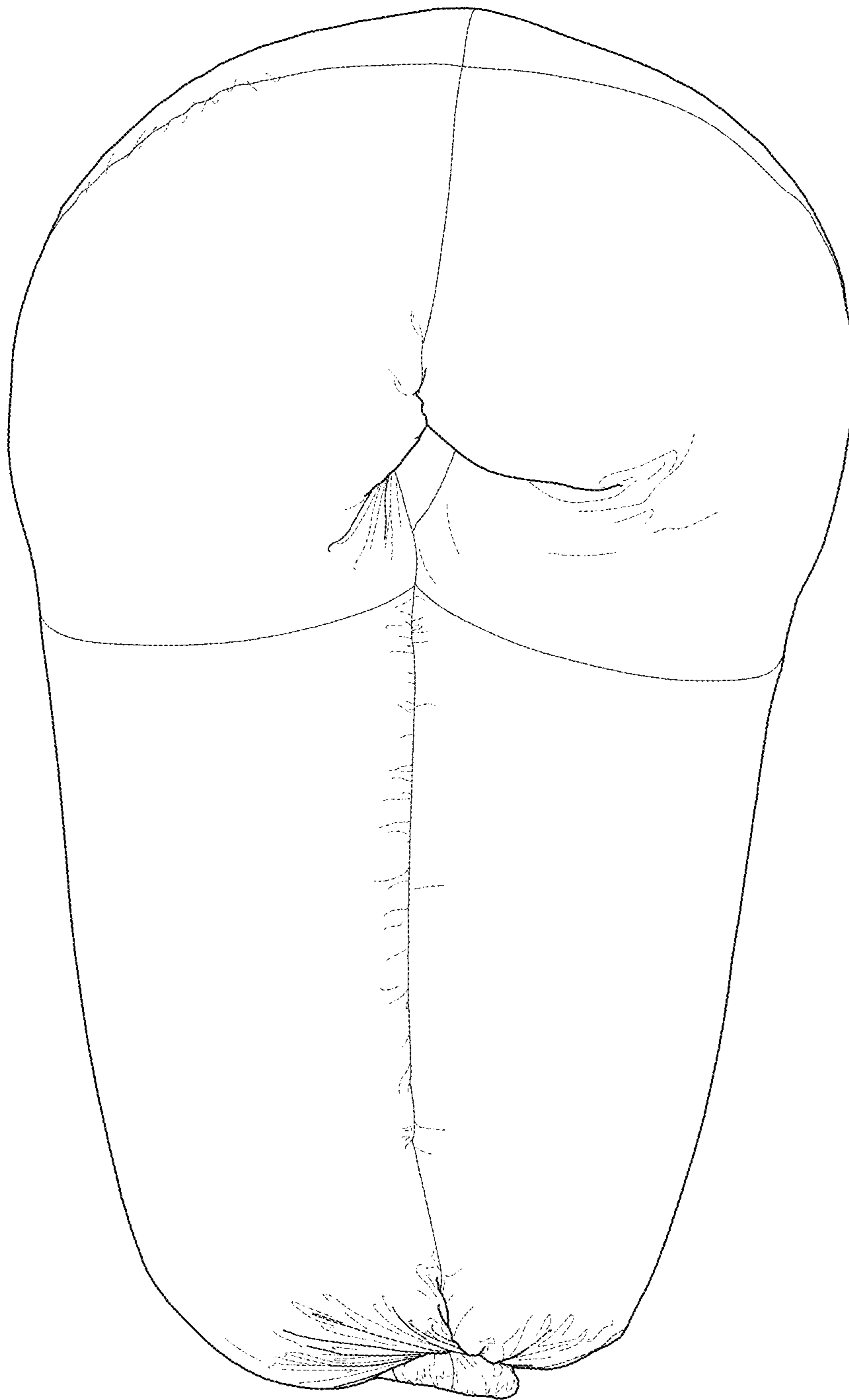

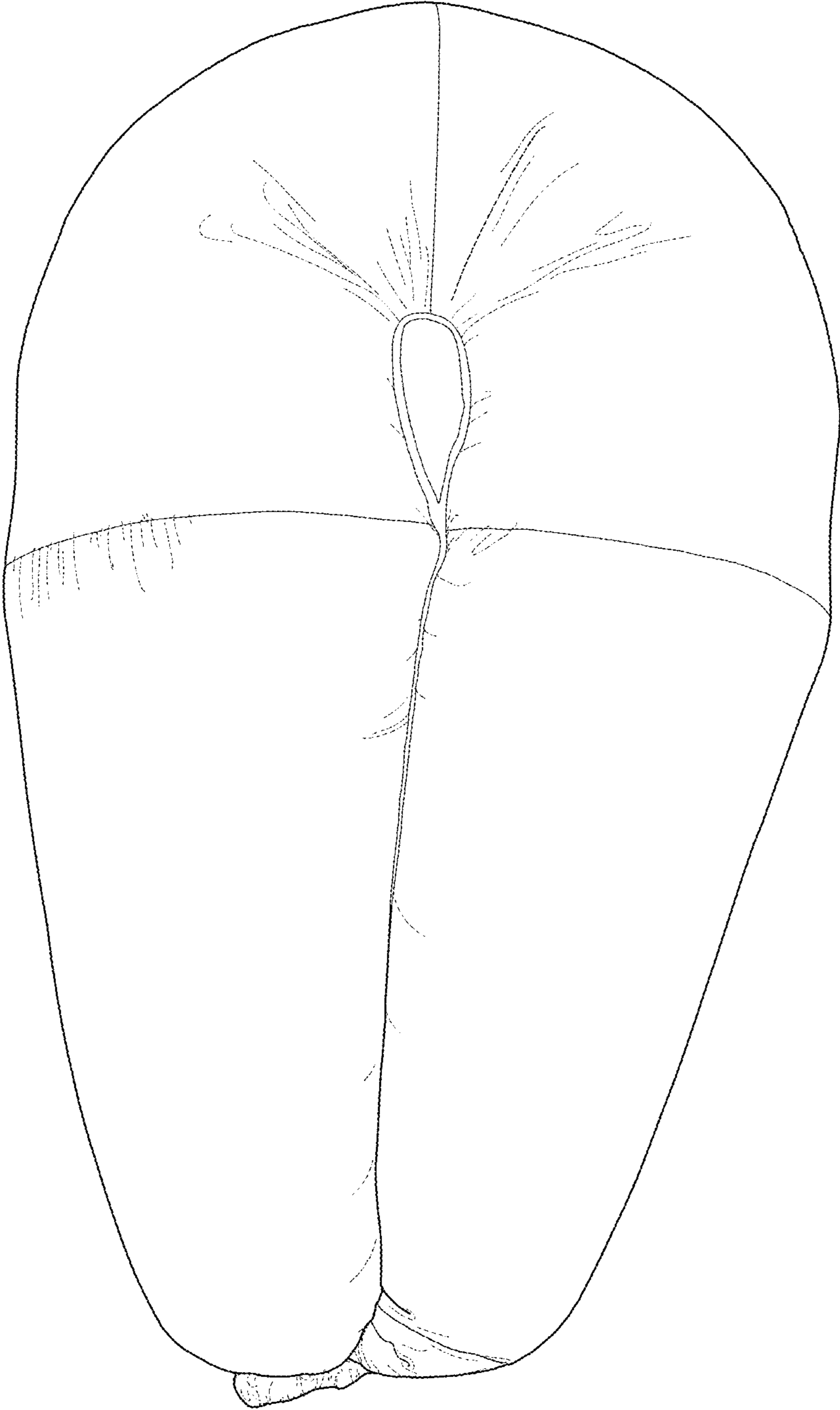

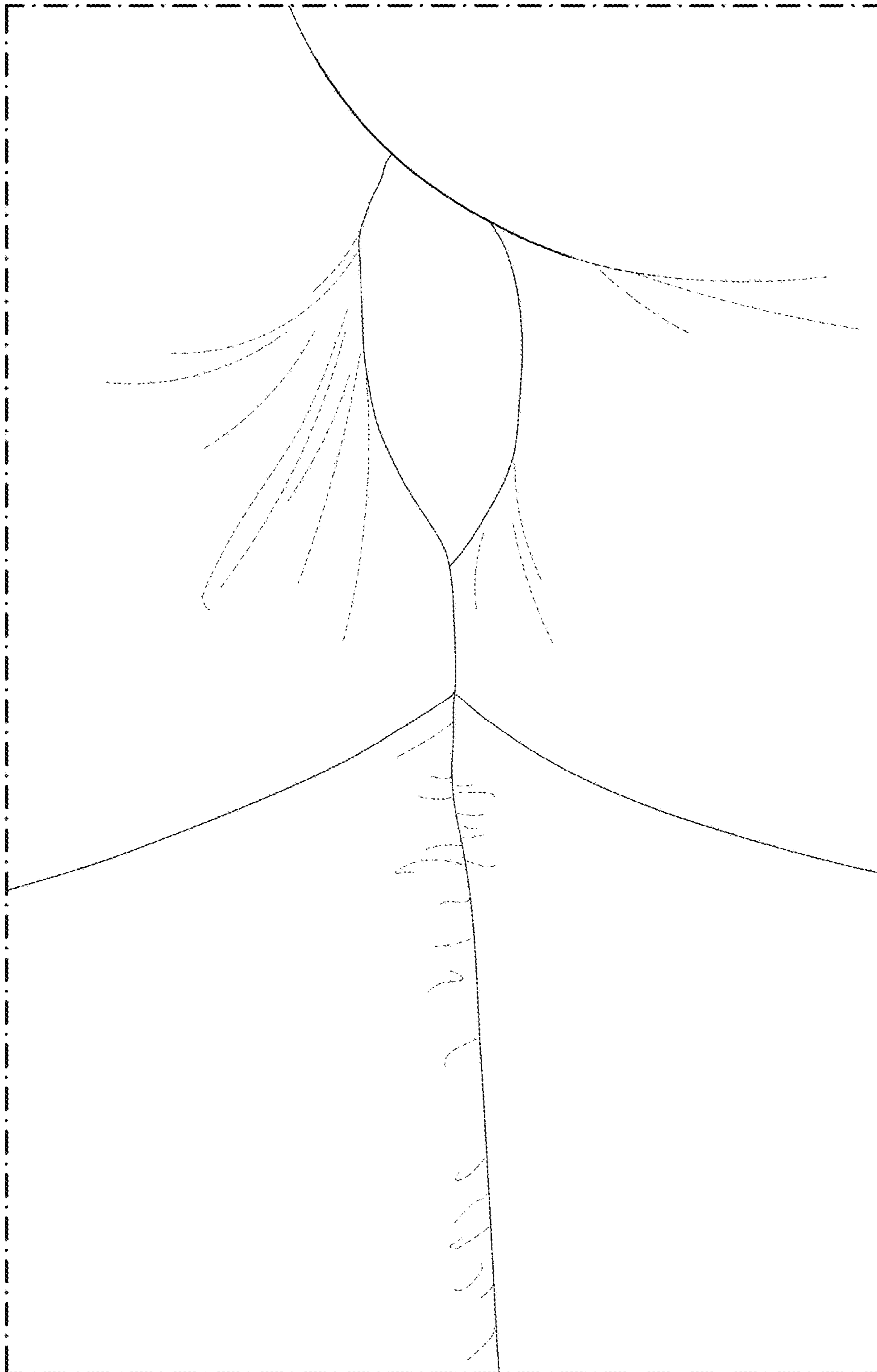
