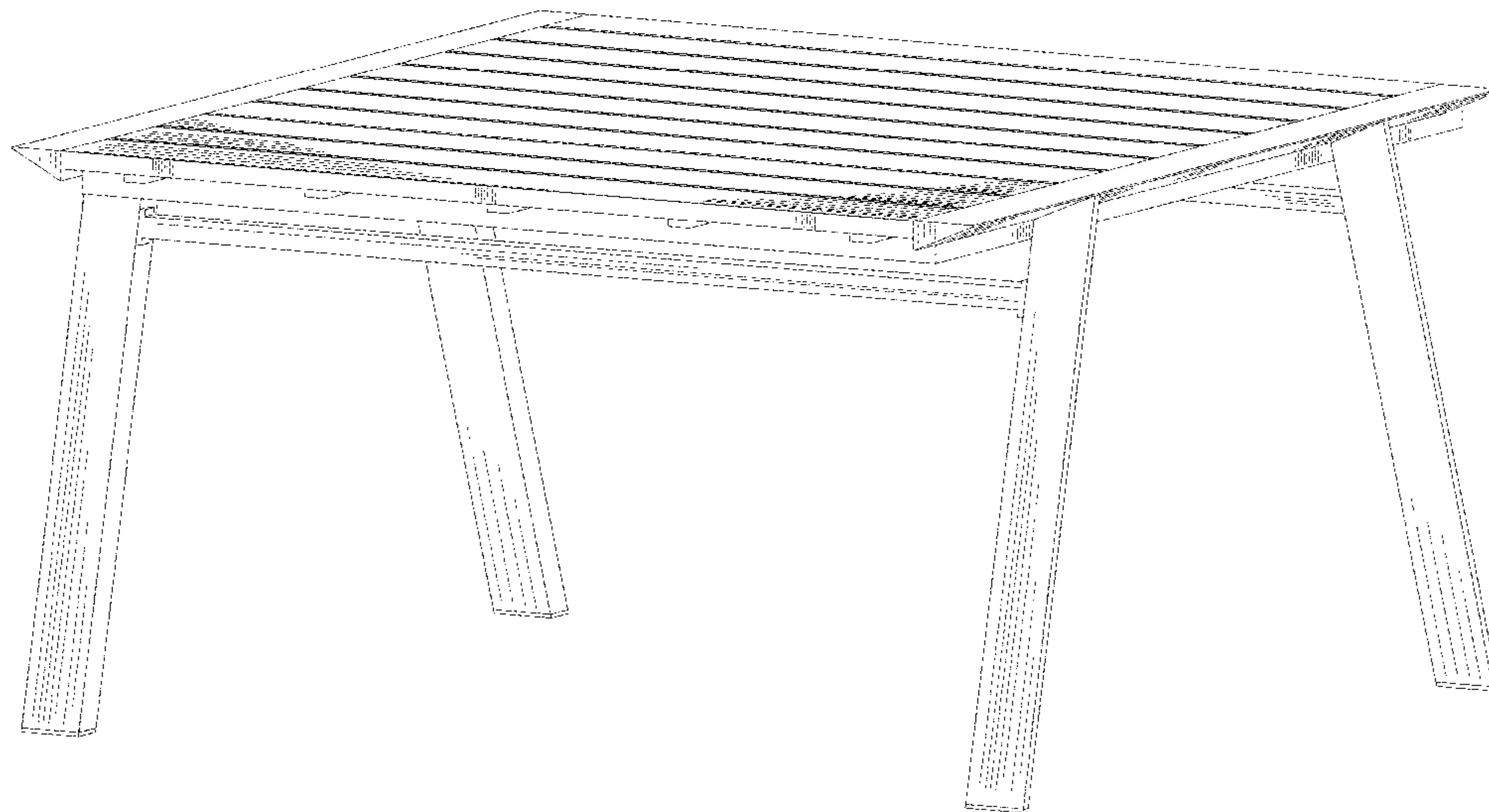
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the present invention;
FIG. 2 is a right side elevation view thereof;

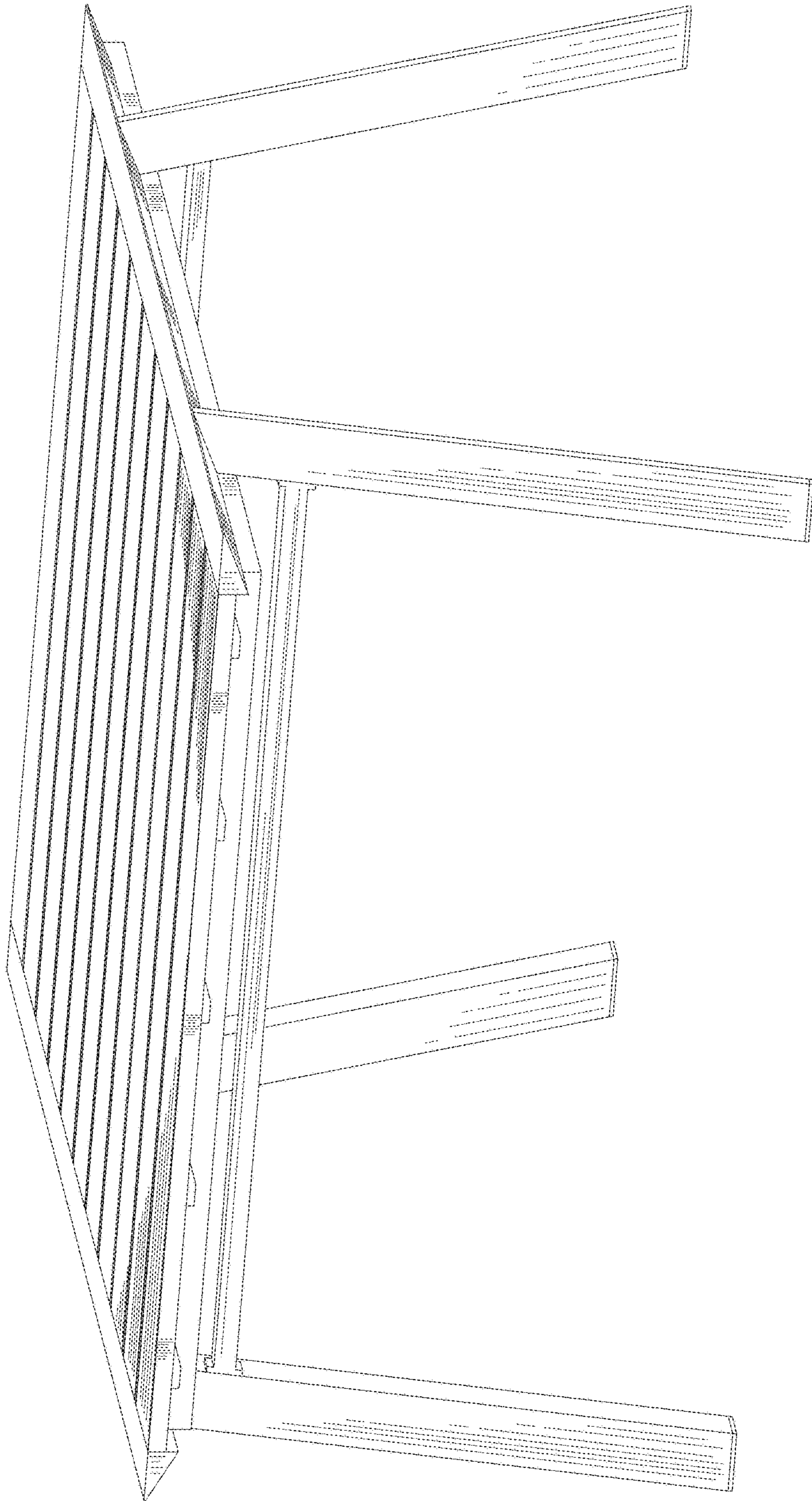

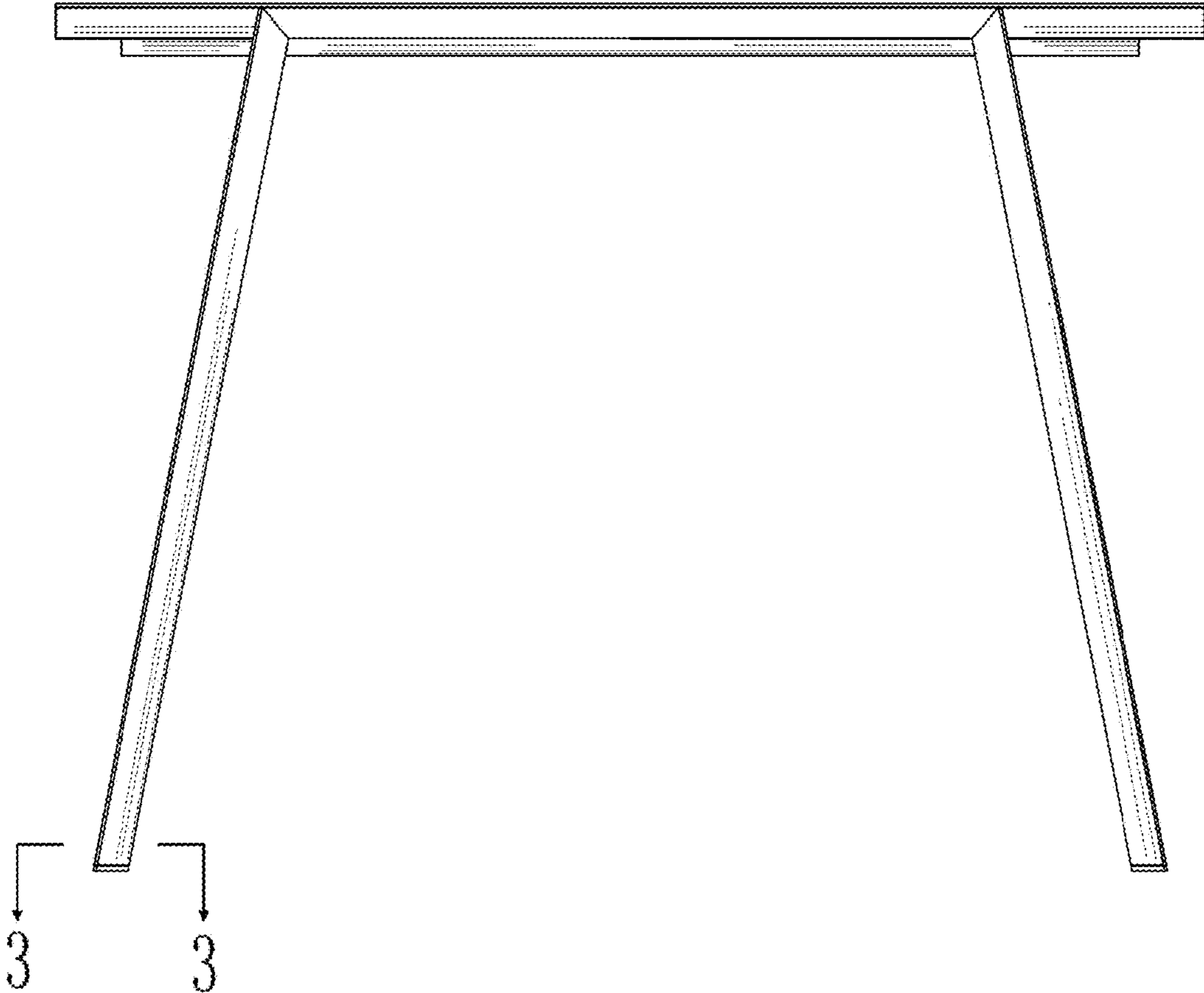

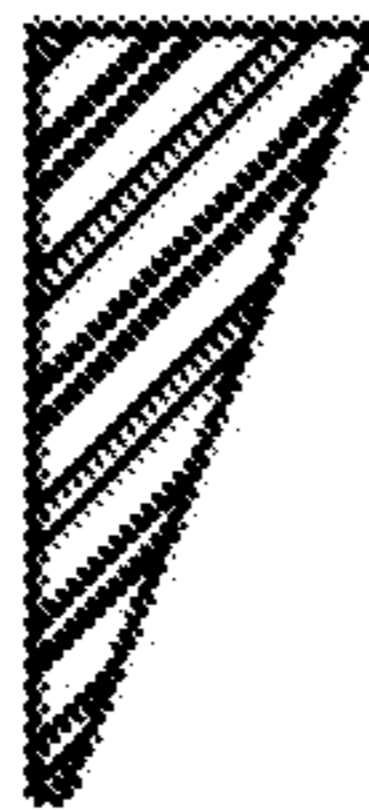

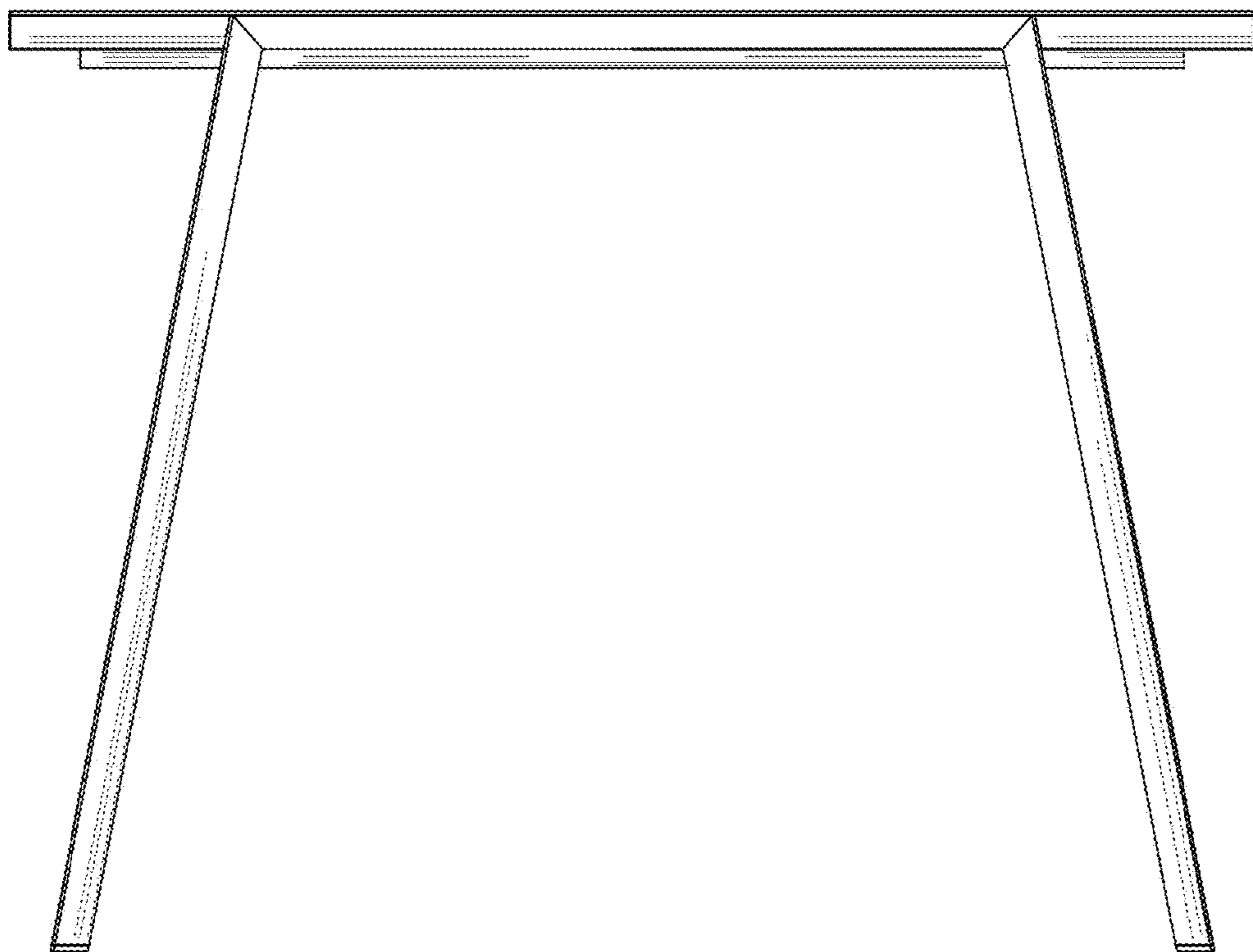

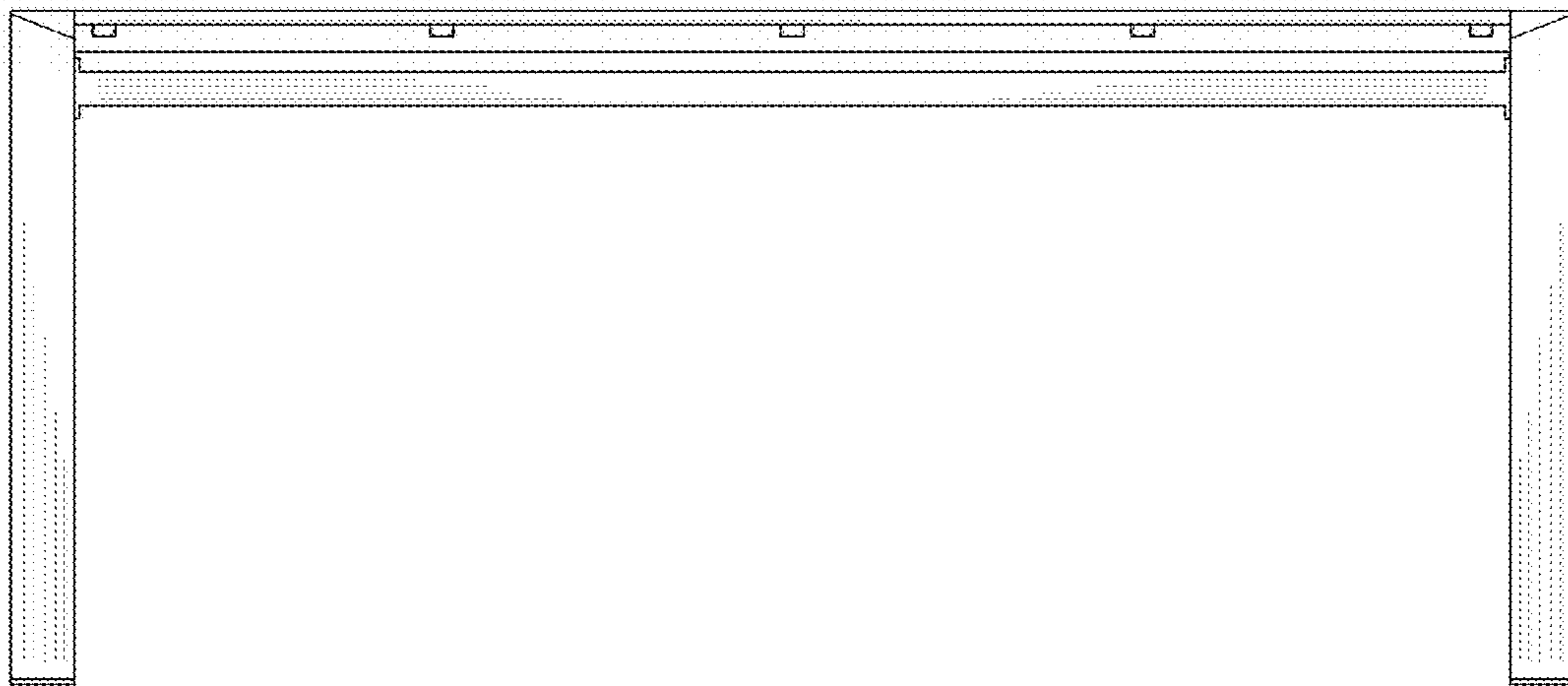

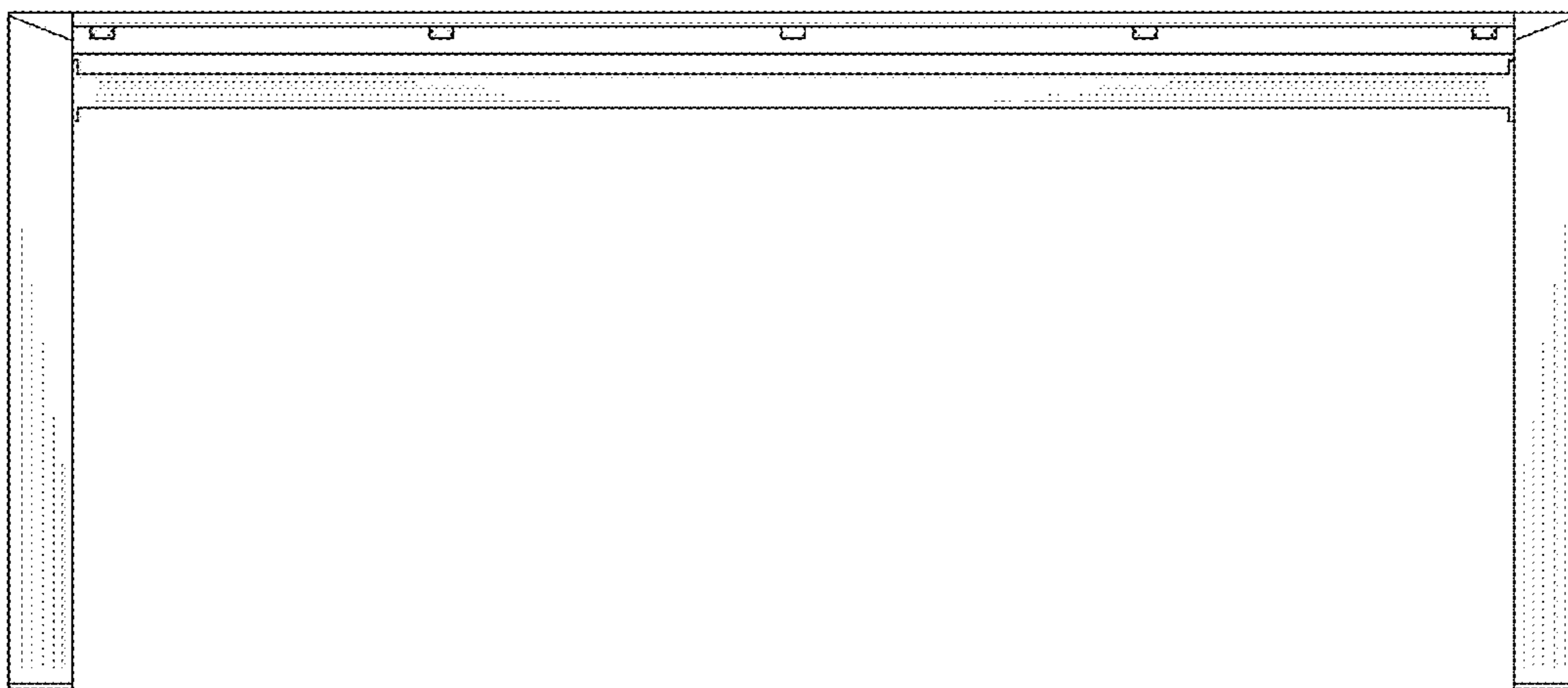

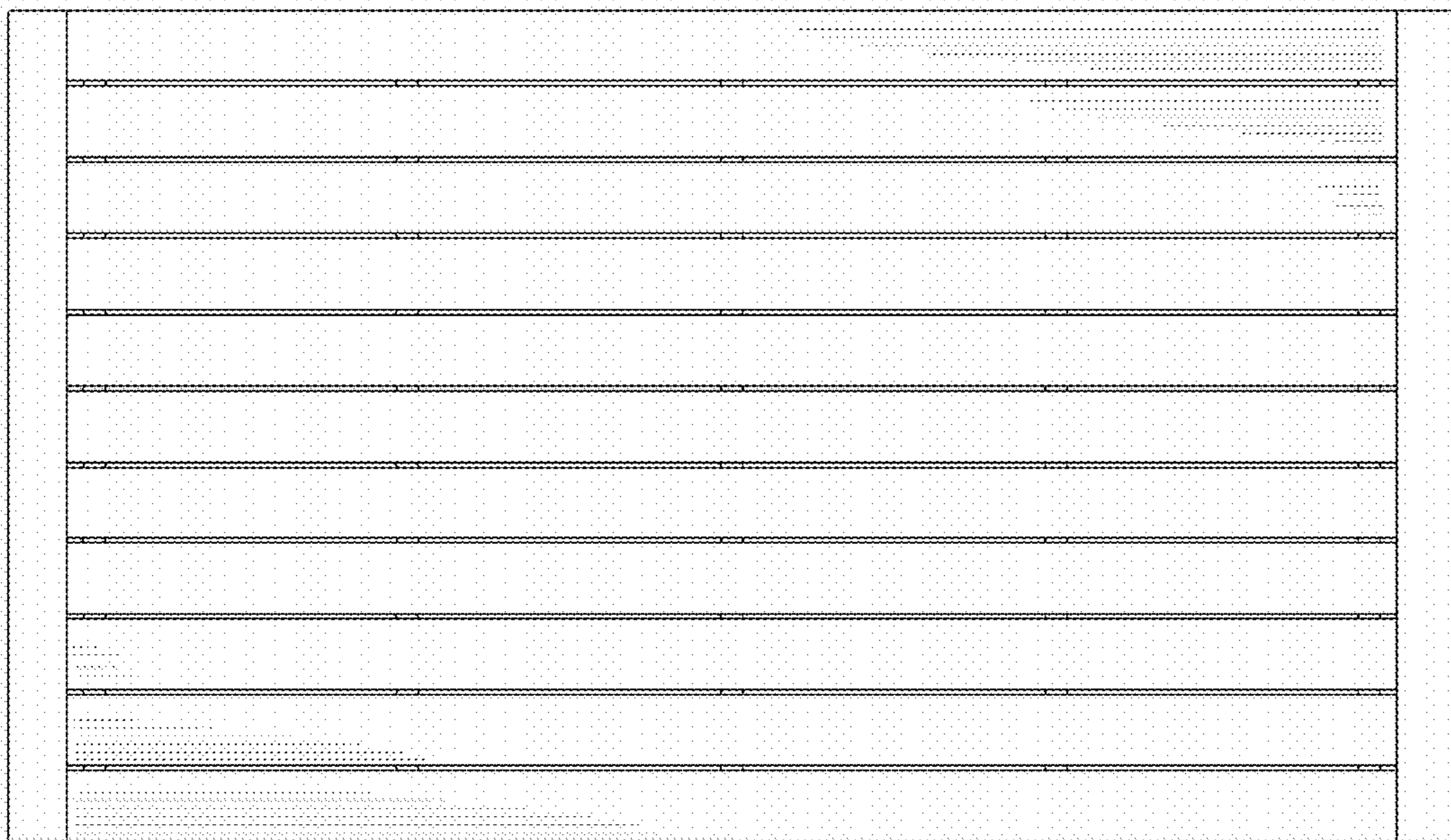
