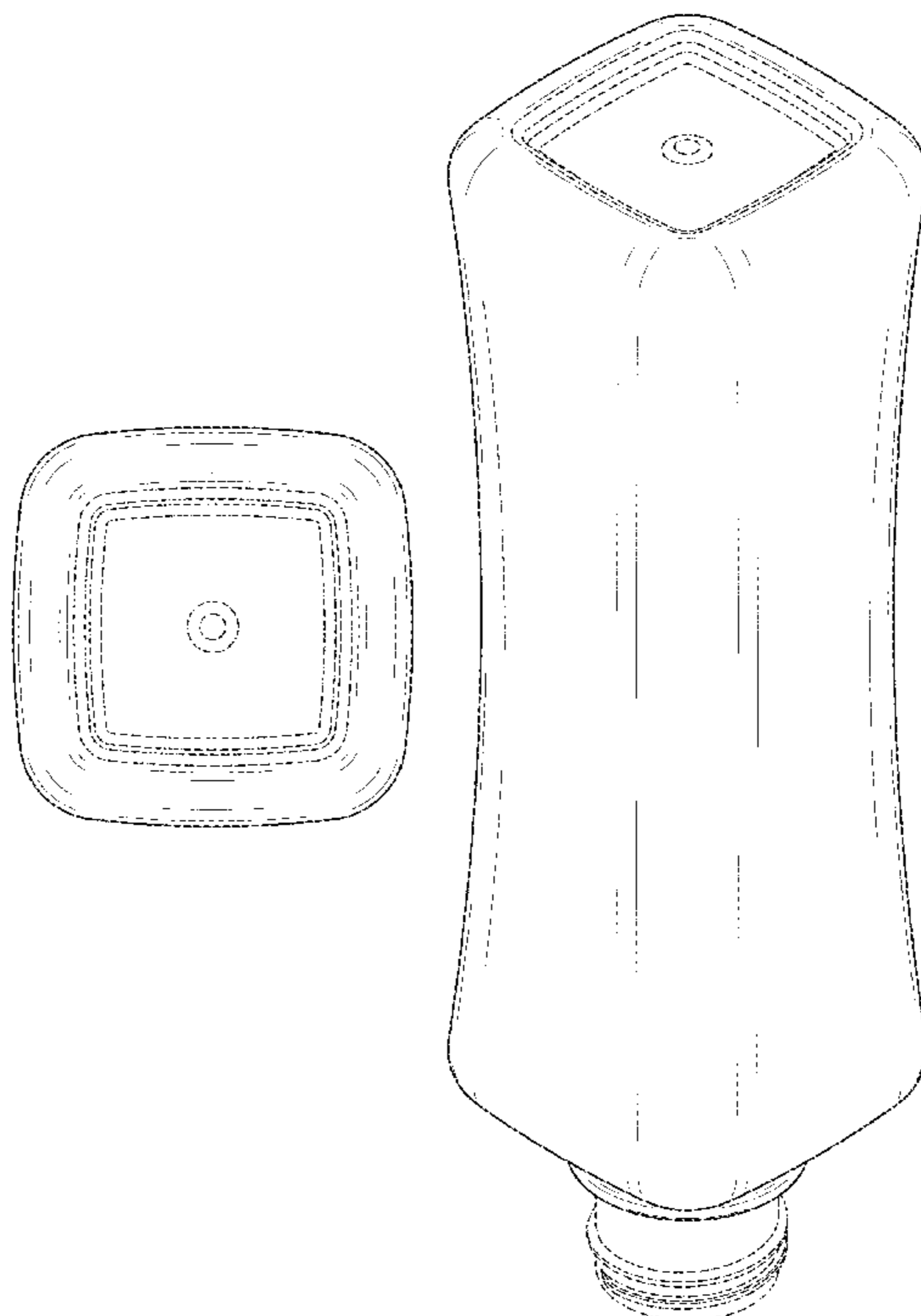
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a cooking spray container showing our new design;

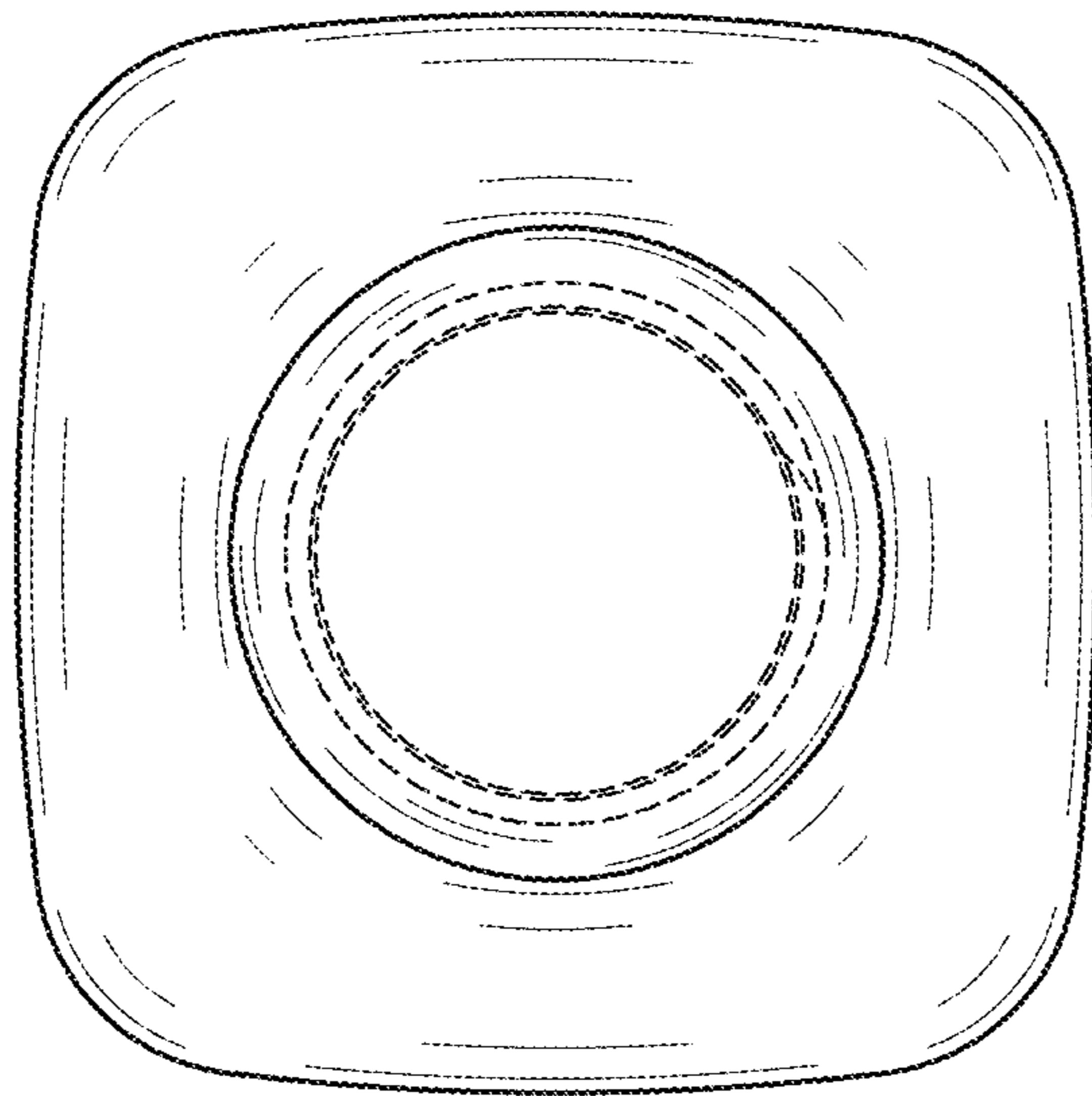

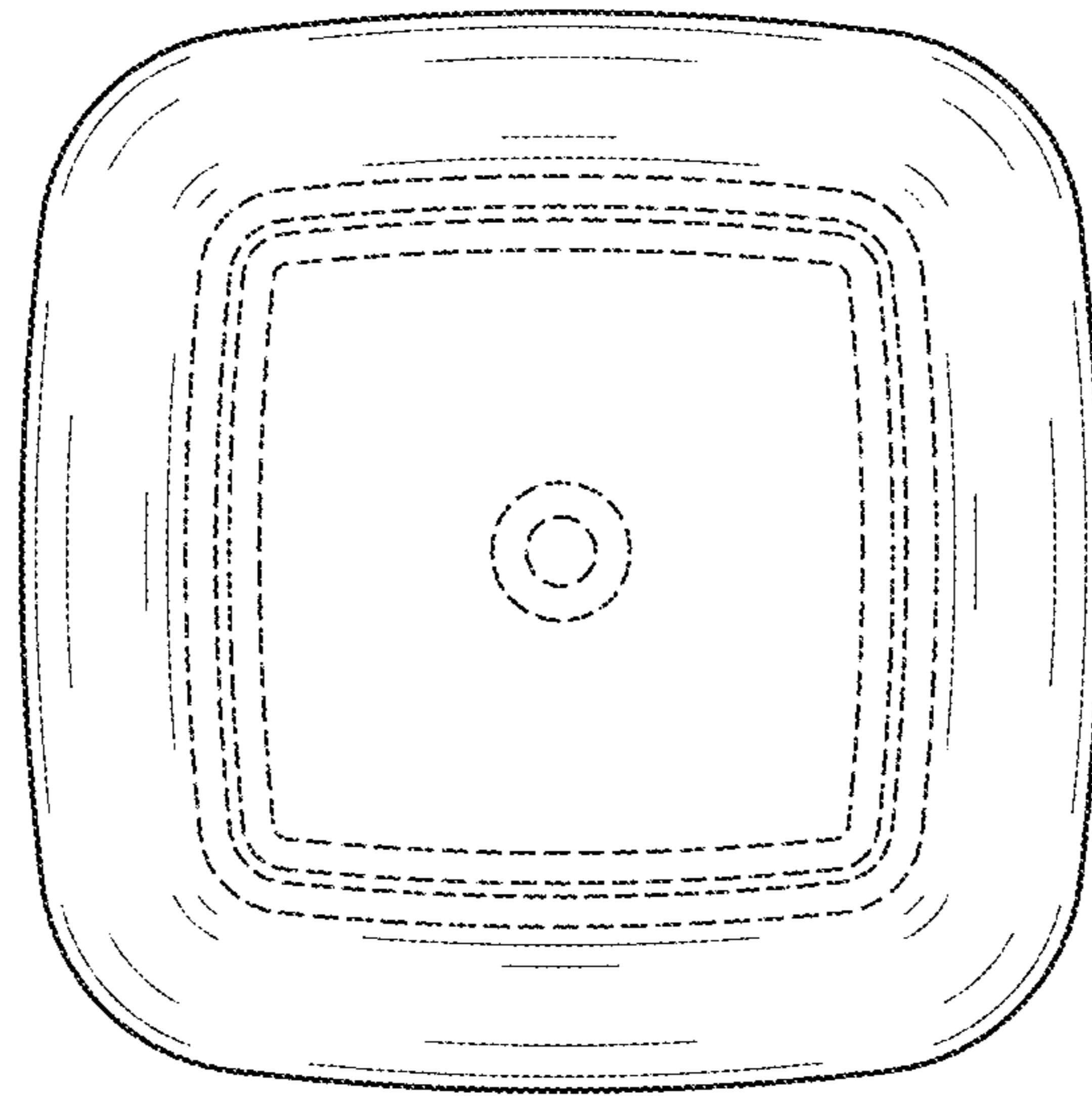

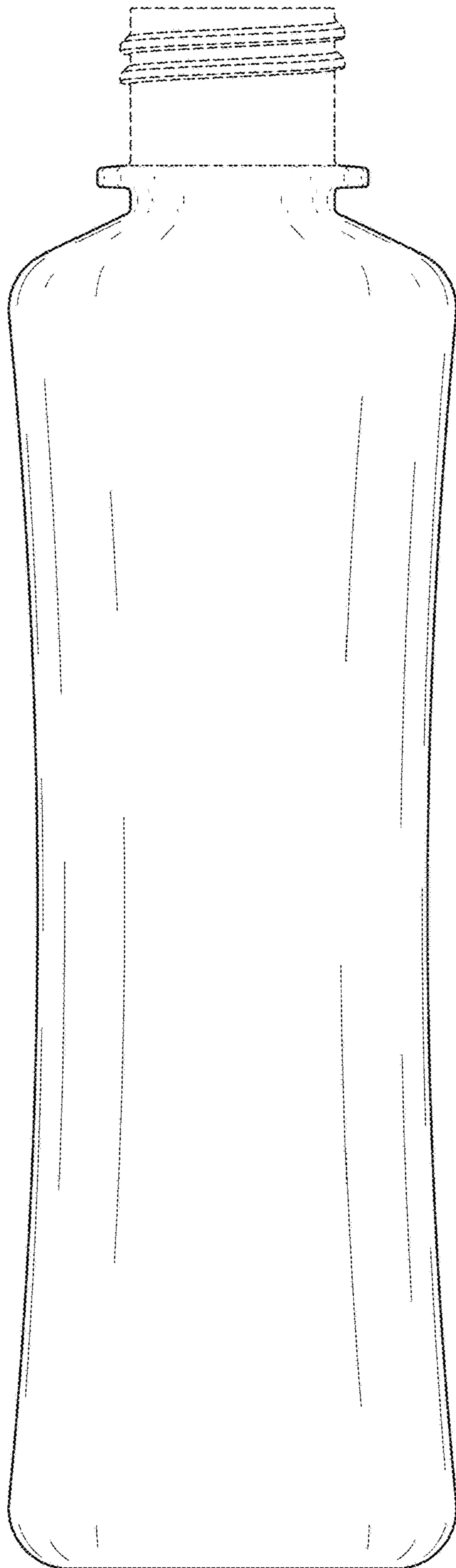

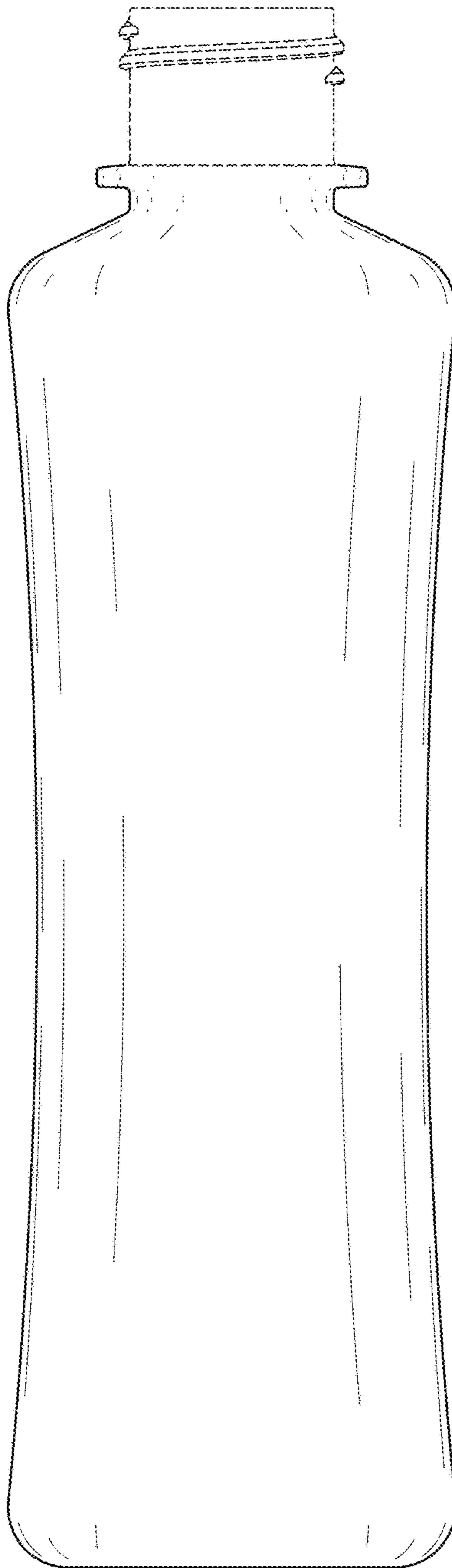

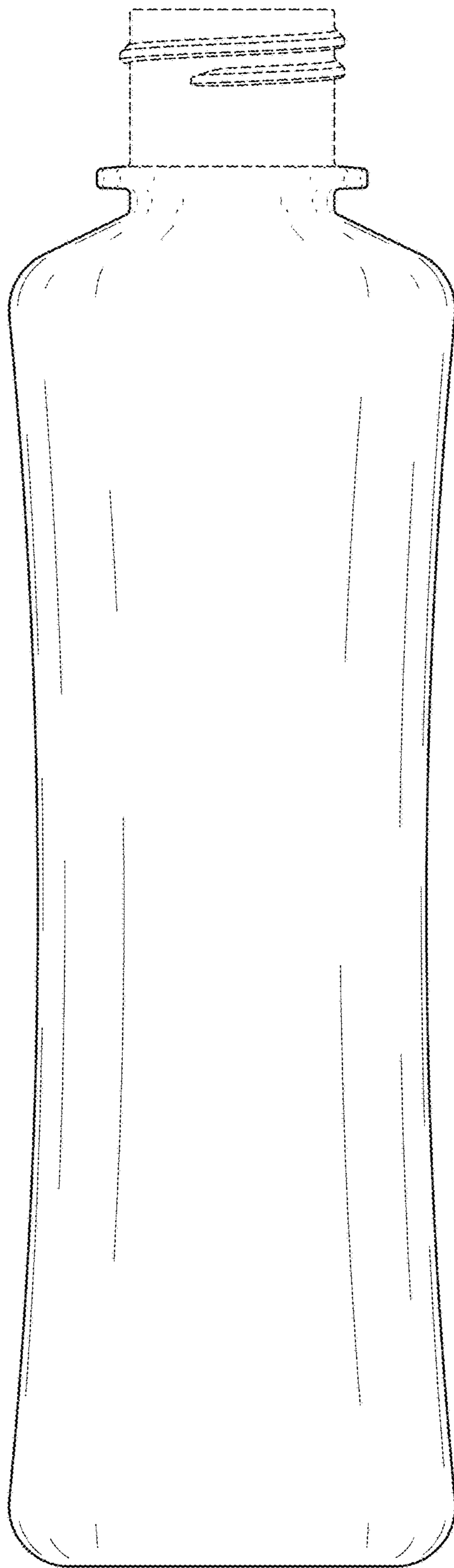

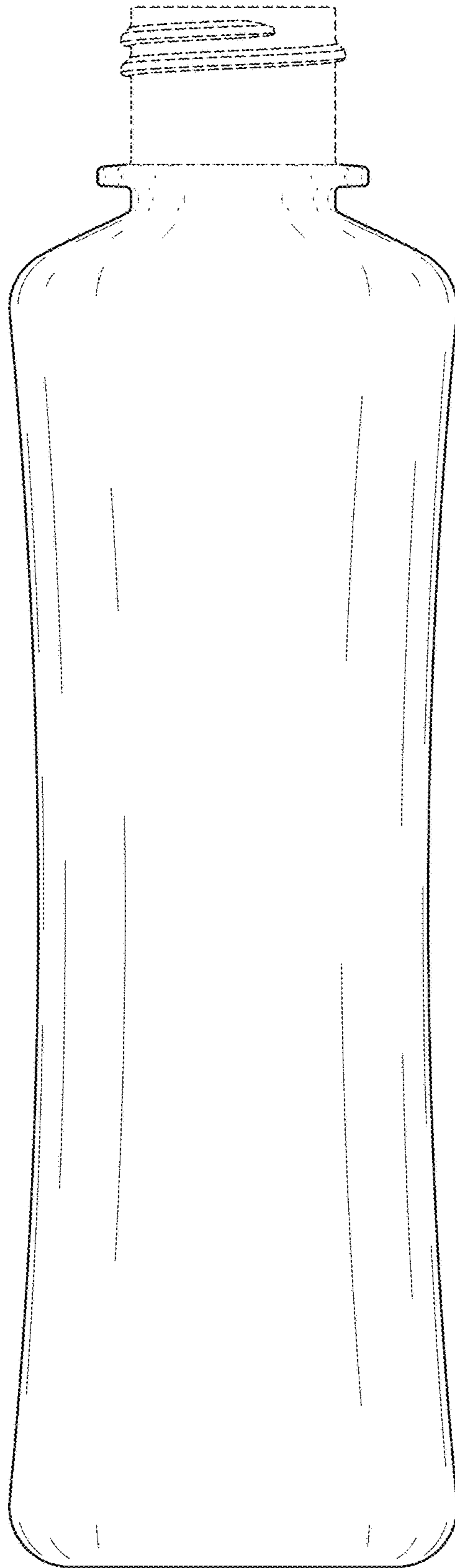

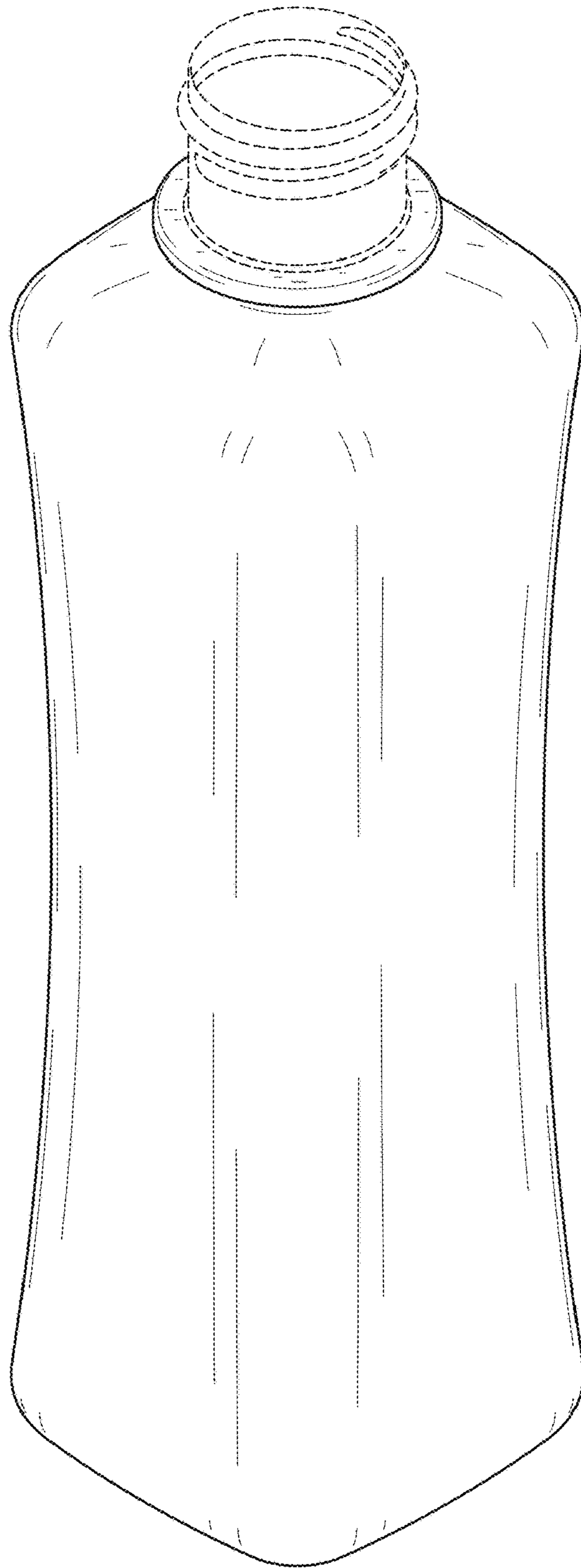

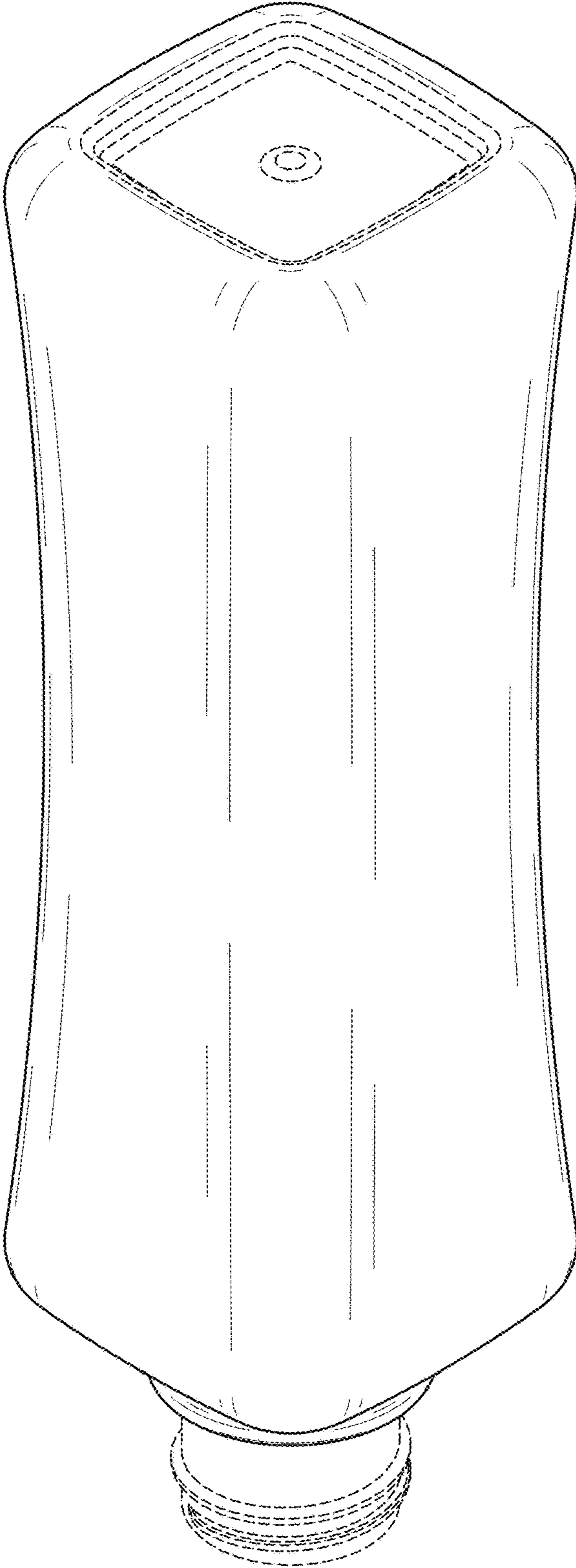
