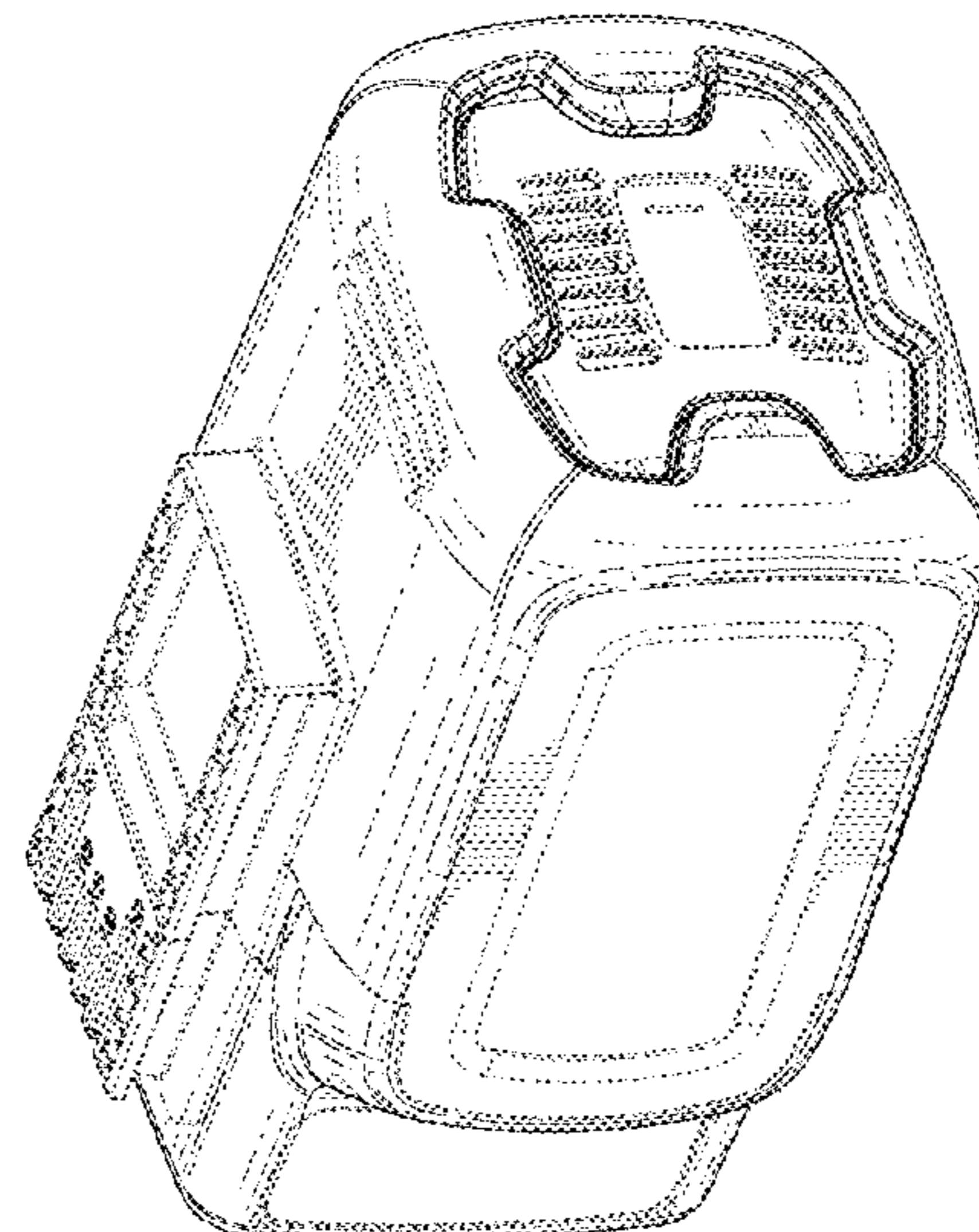
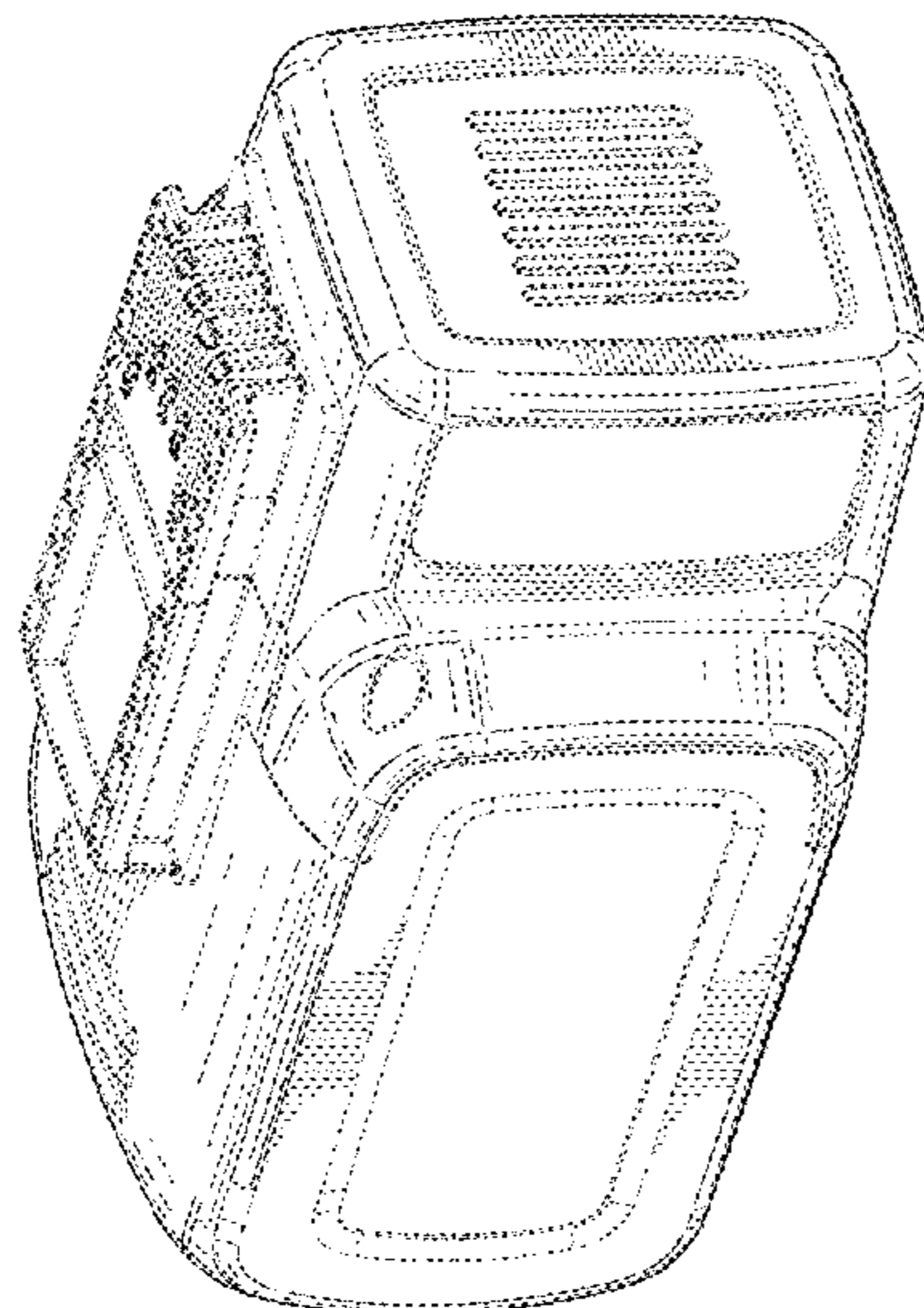
(57) **CLAIM**

The ornamental design for a battery pack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of a battery pack in accordance with an embodiment of the present invention; FIG. 2 is a perspective rear view of the top of the battery pack of FIG. 1; FIG. 3 is a perspective rear view of the bottom of the battery pack of FIG. 1; FIG. 4 is a right side view of the battery pack of FIG. 1; FIG. 5 is a left side view of the battery pack of FIG. 1; FIG. 6 is a bottom view of the battery pack of FIG. 1; FIG. 7 is a top view of the battery pack of FIG. 1; FIG. 8 is a front view of the battery pack of FIG. 1; FIG. 9 is a rear view of the battery pack of FIG. 1; FIG. 10 is a perspective view of the battery pack shown attached to a blower illustrated in broken lines; and, FIG. 11 is a perspective view of the battery pack shown attached to a chainsaw illustrated in broken lines. The broken lines showing portions of the battery pack in FIGS. 1-11 are for the purposes of illustrating portions of the article that form no part of the claimed design. The broken lines showing a blower and a chainsaw in FIGS. 10 and 11 are for purposes of illustrating environmental structure, and form no part of the claimed design.

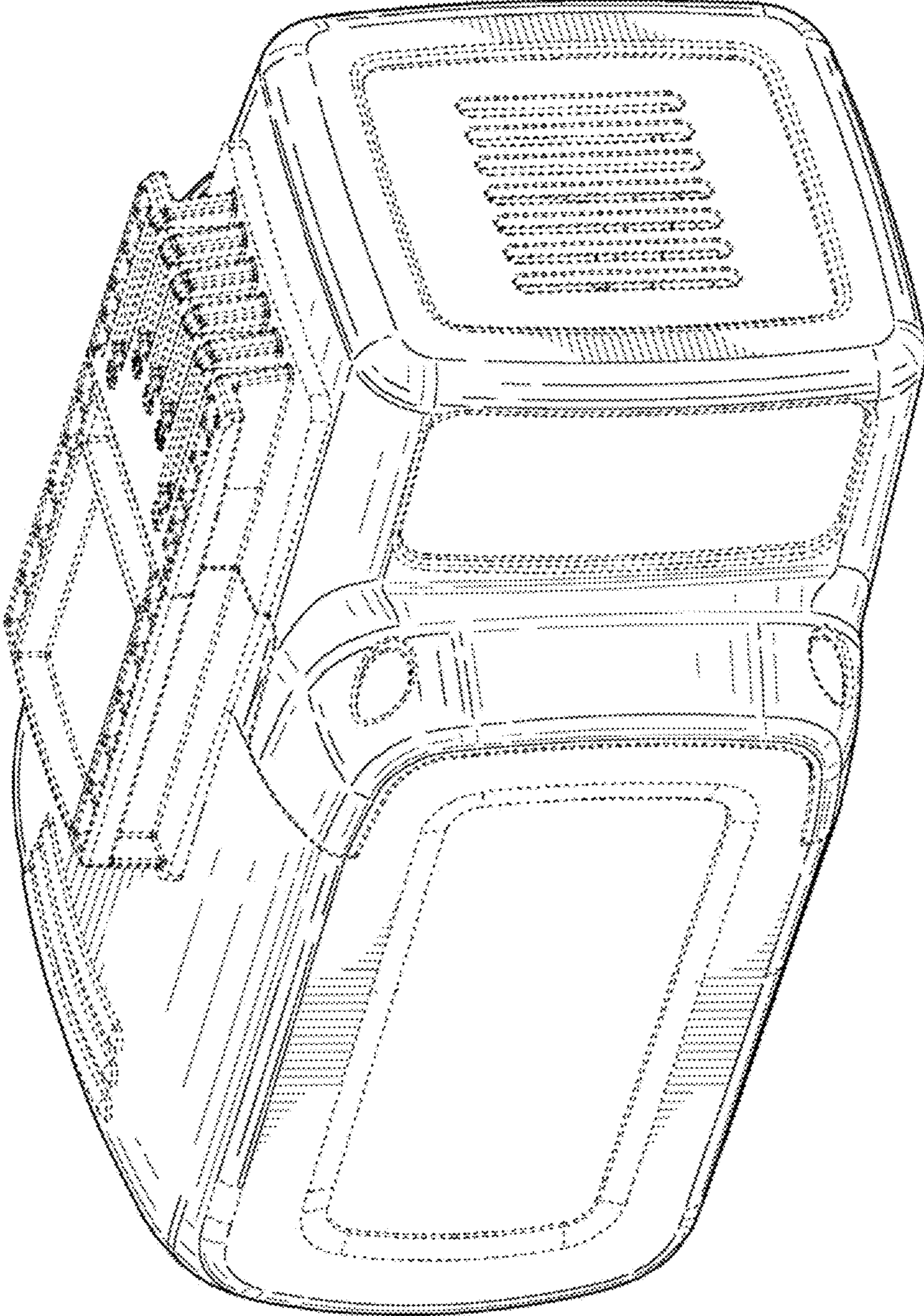

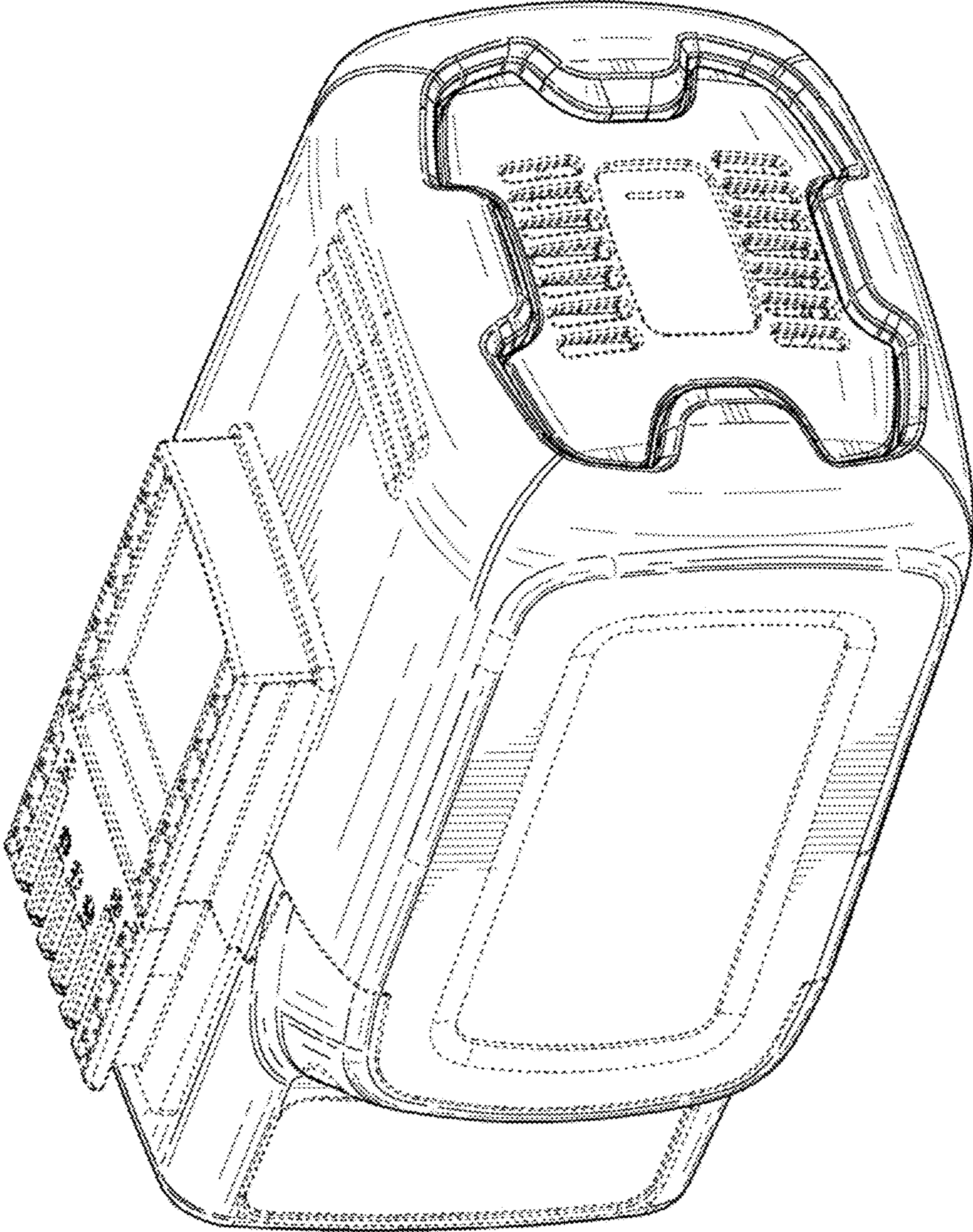

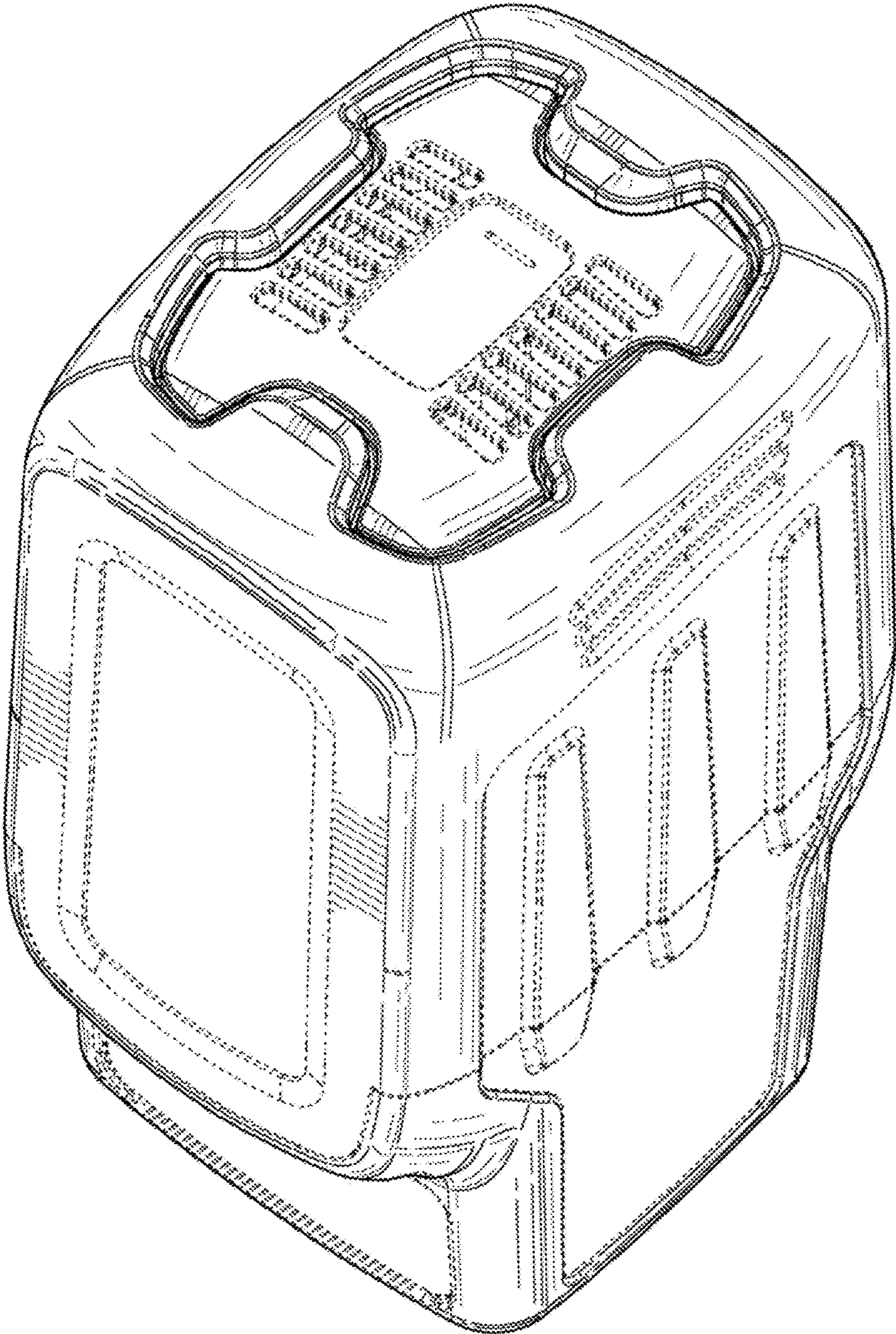

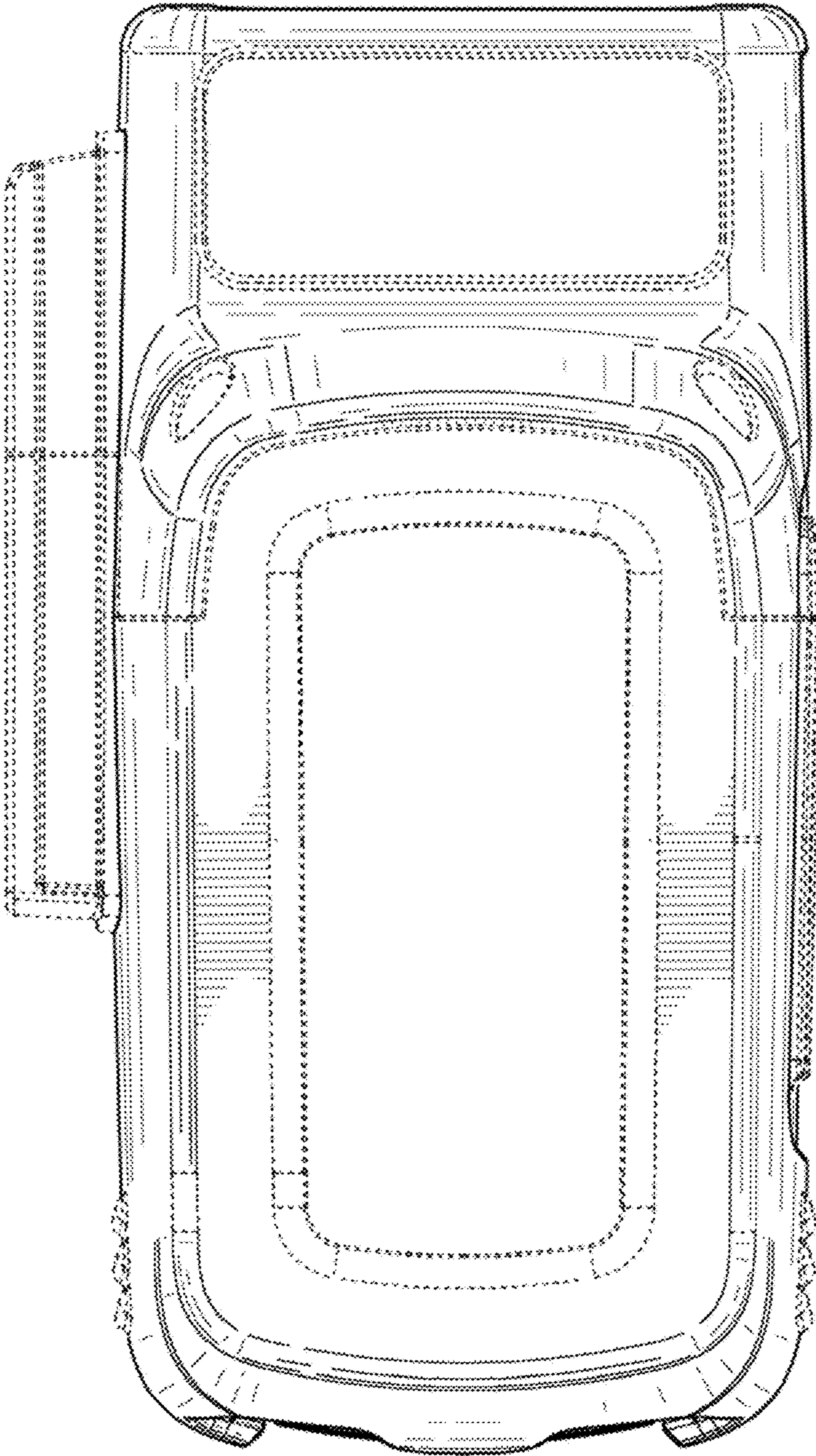

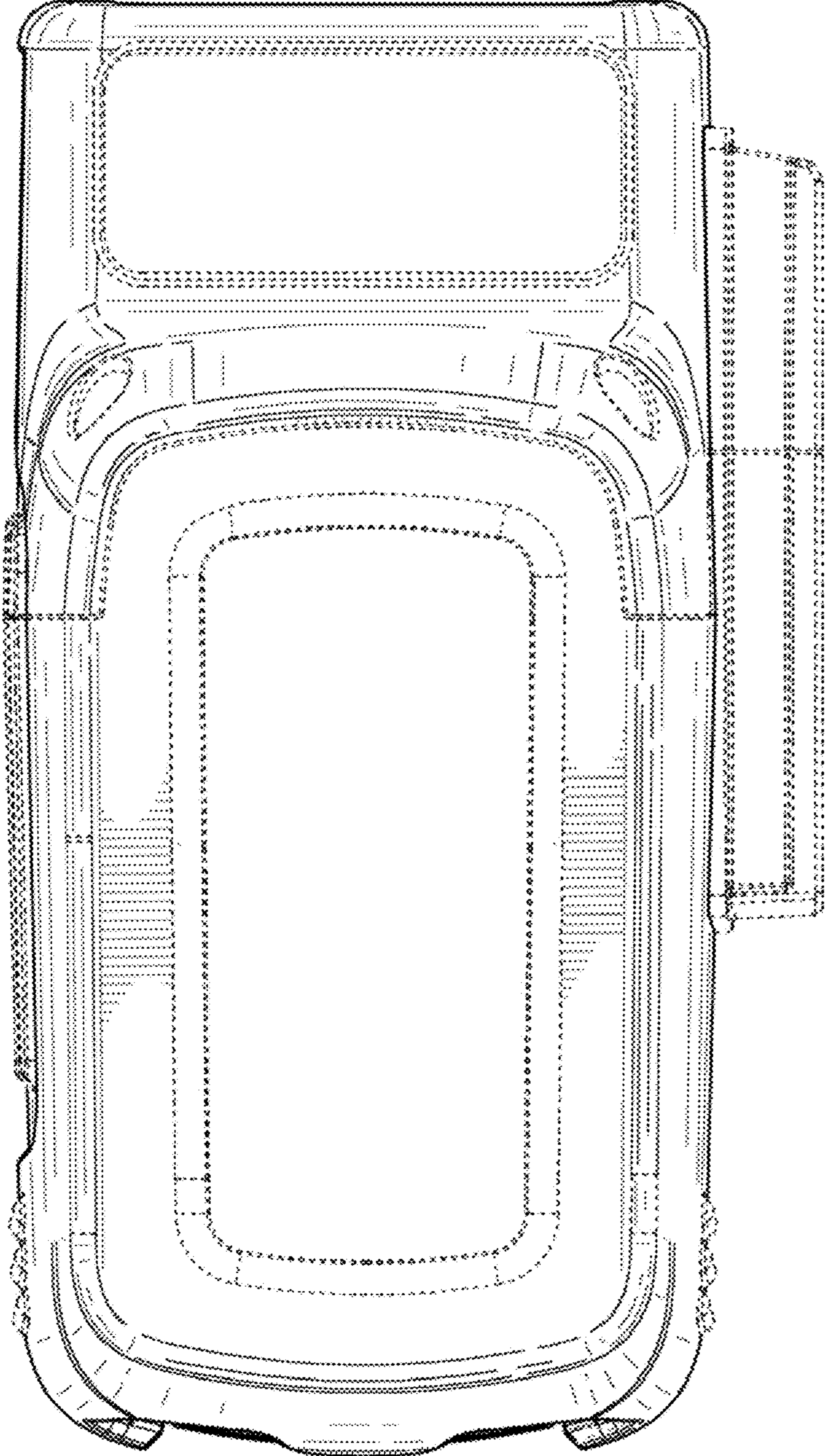

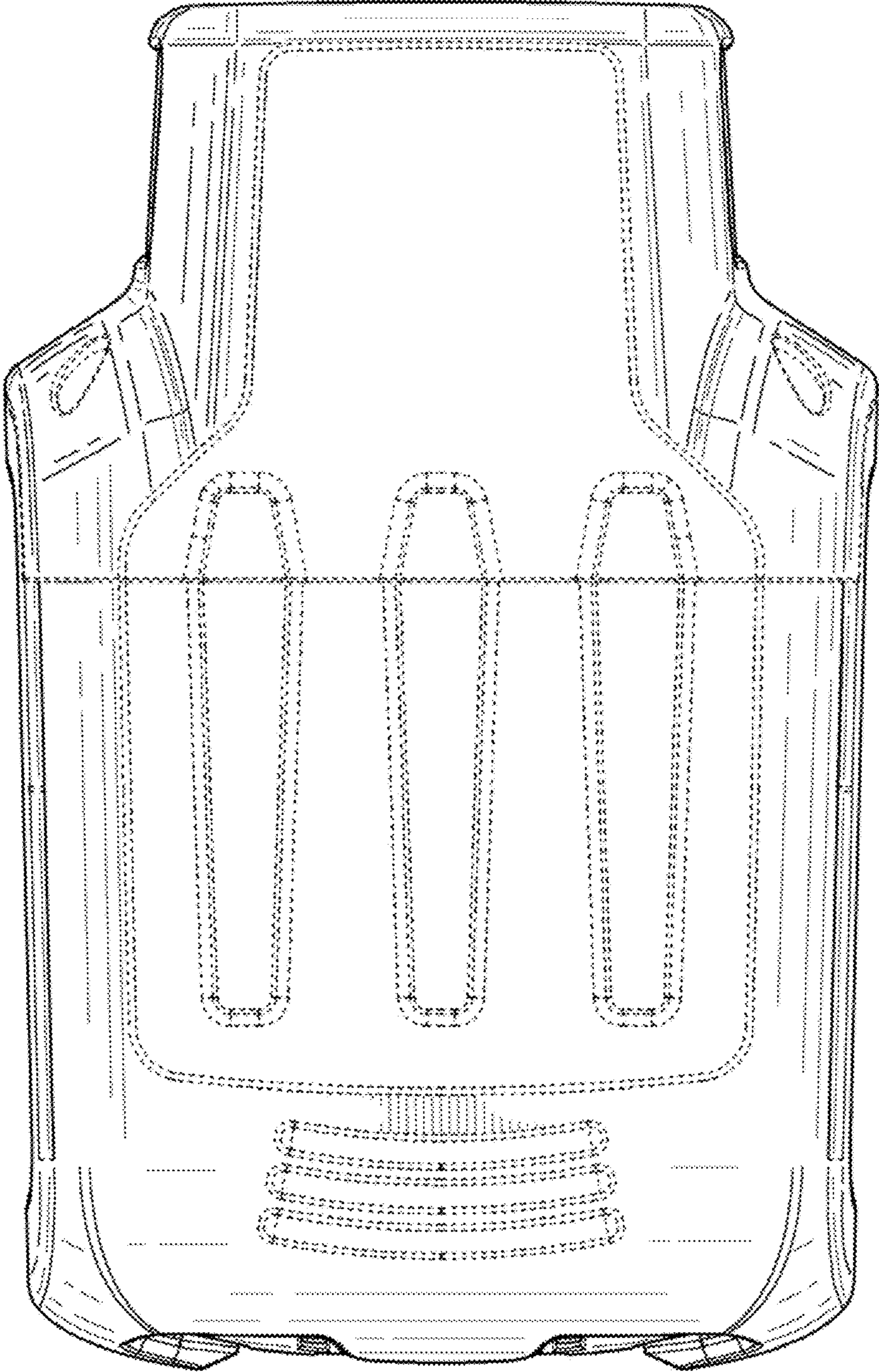

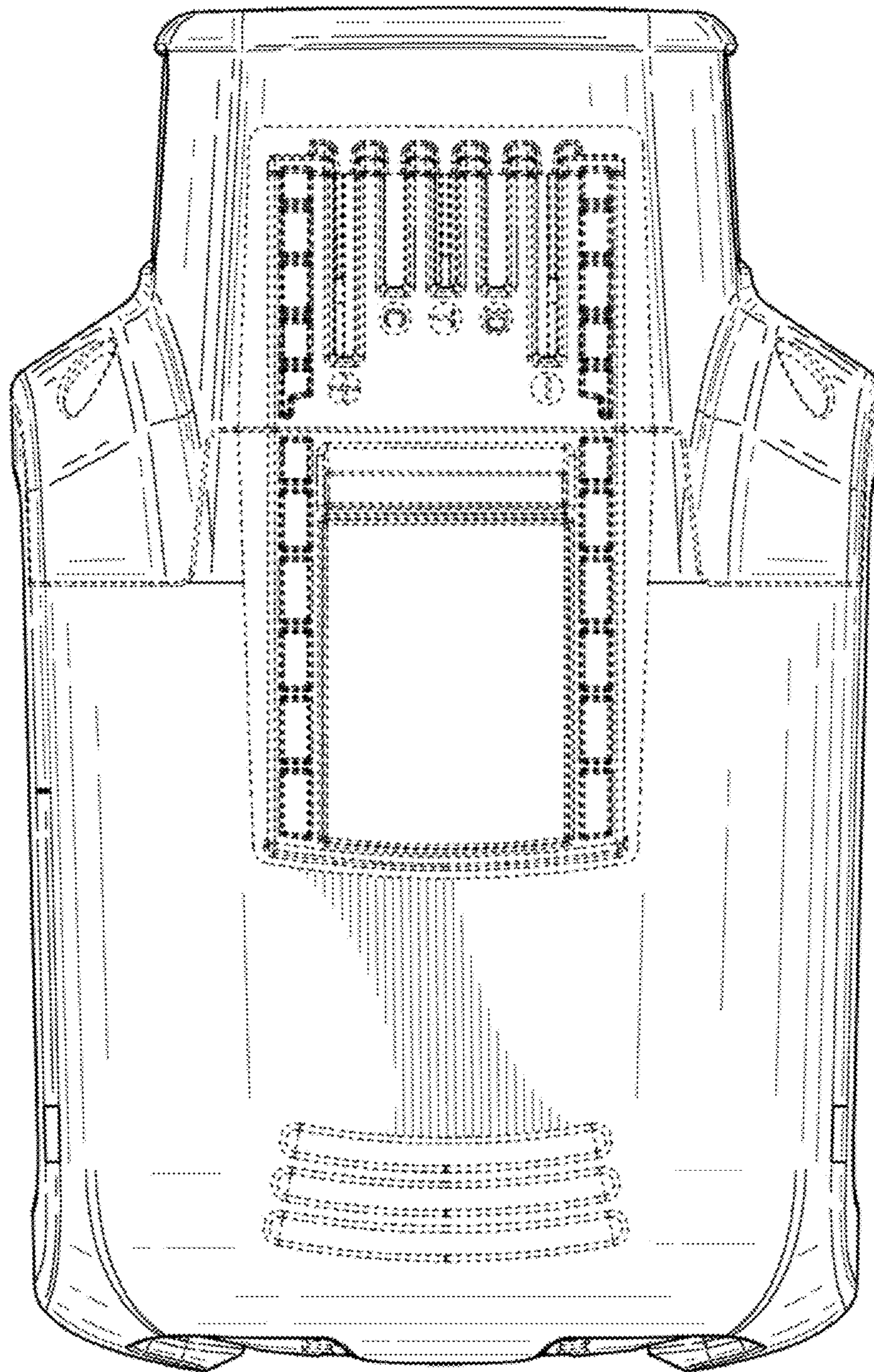

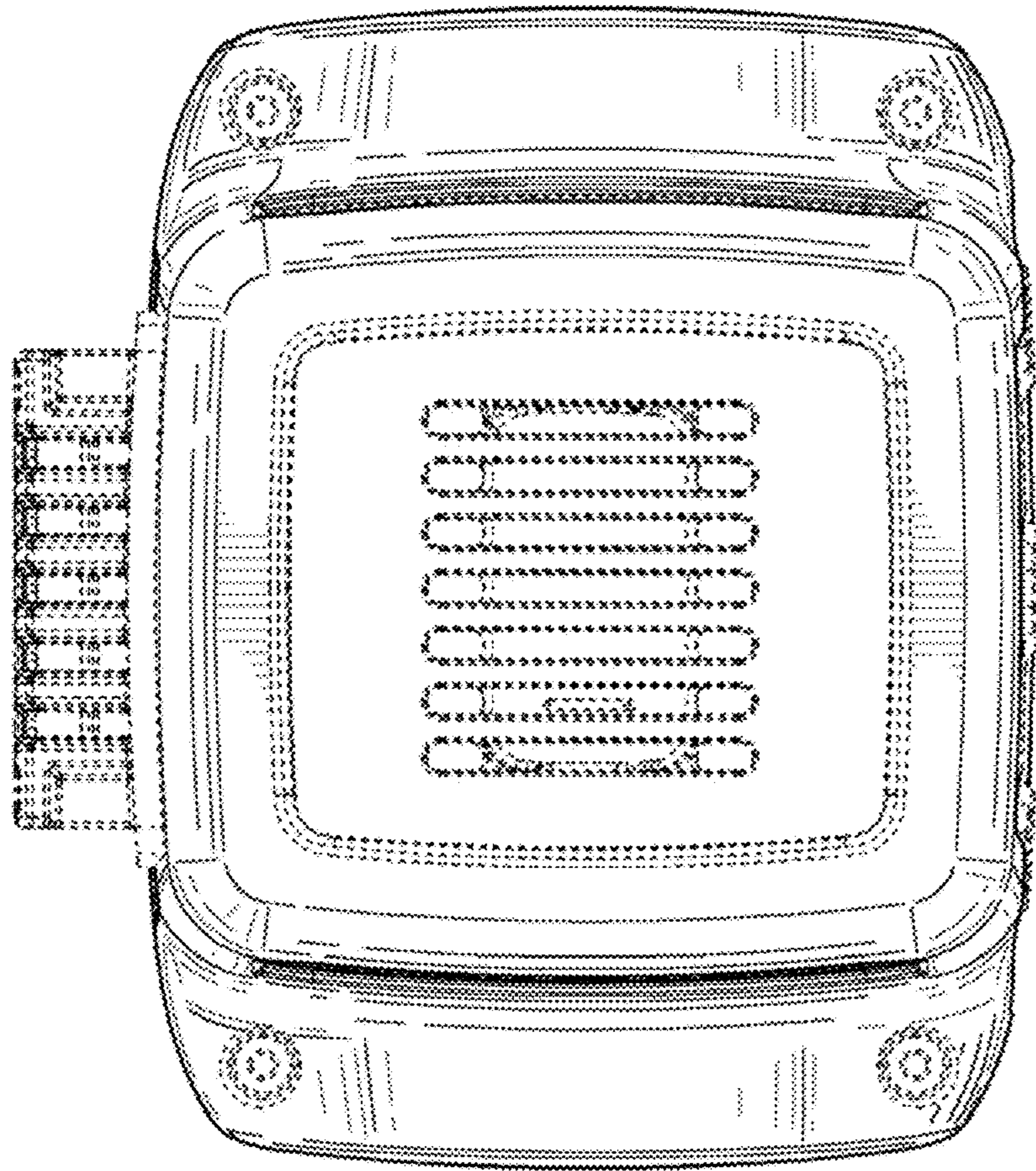

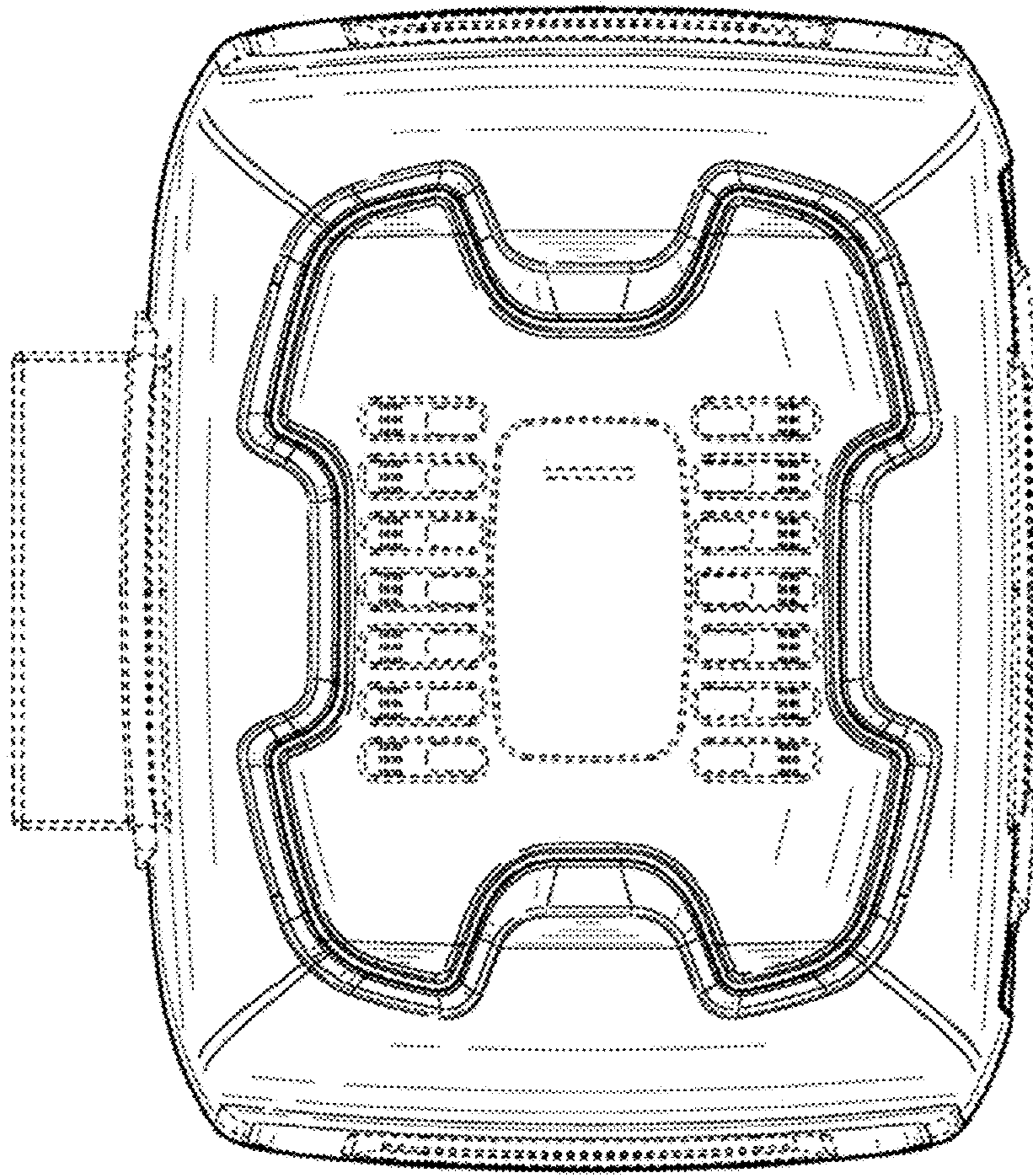

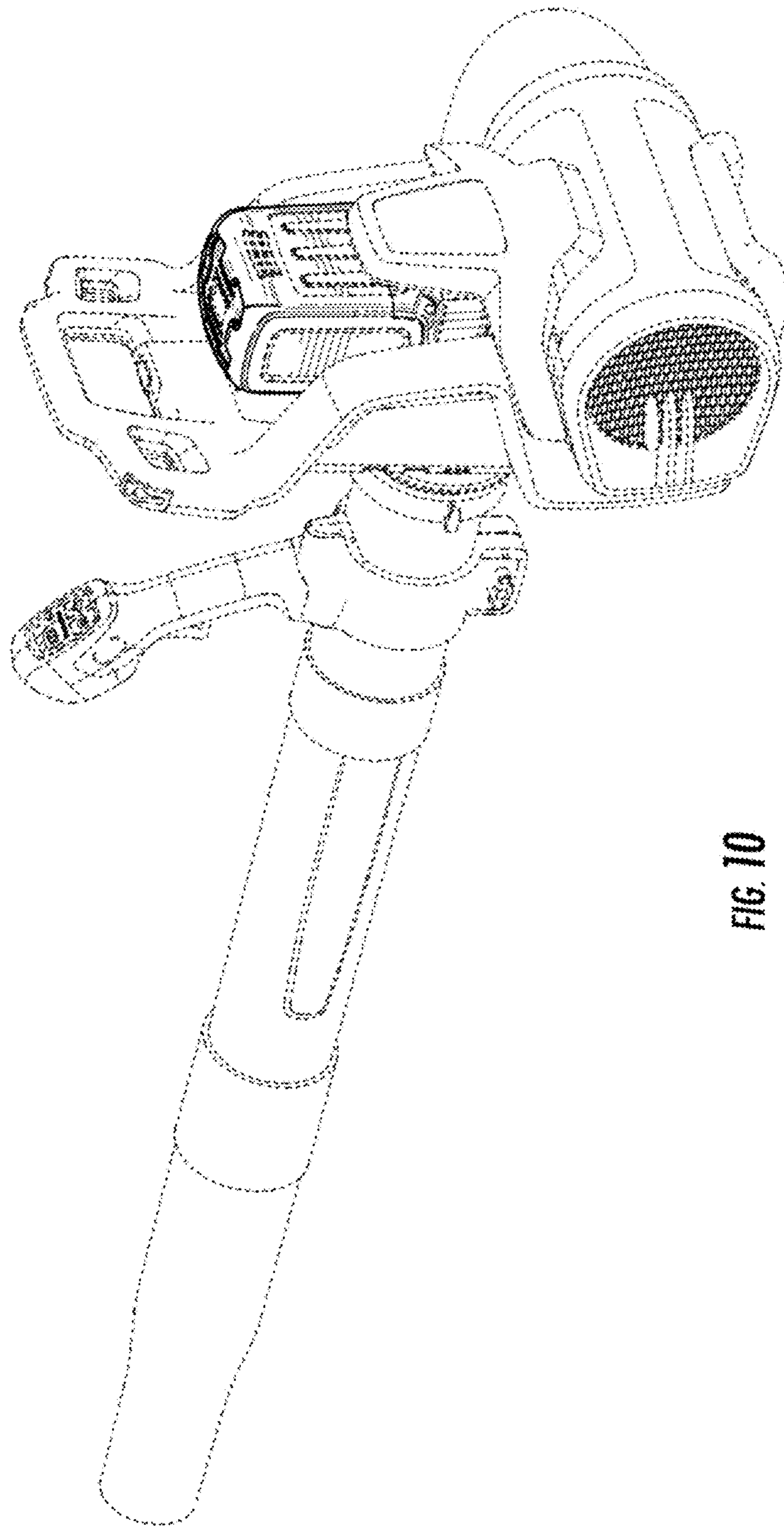

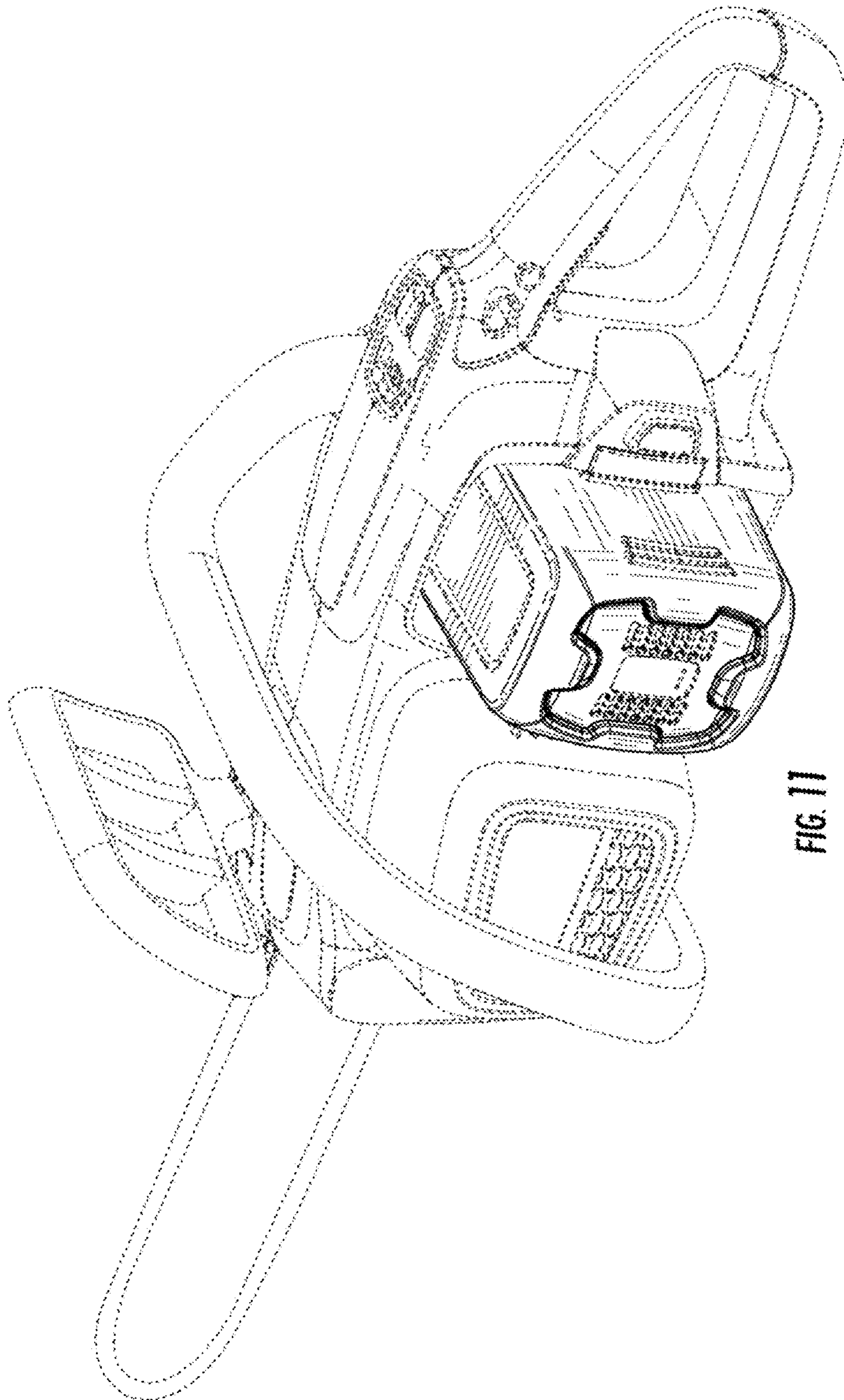
