(57) **CLAIM**

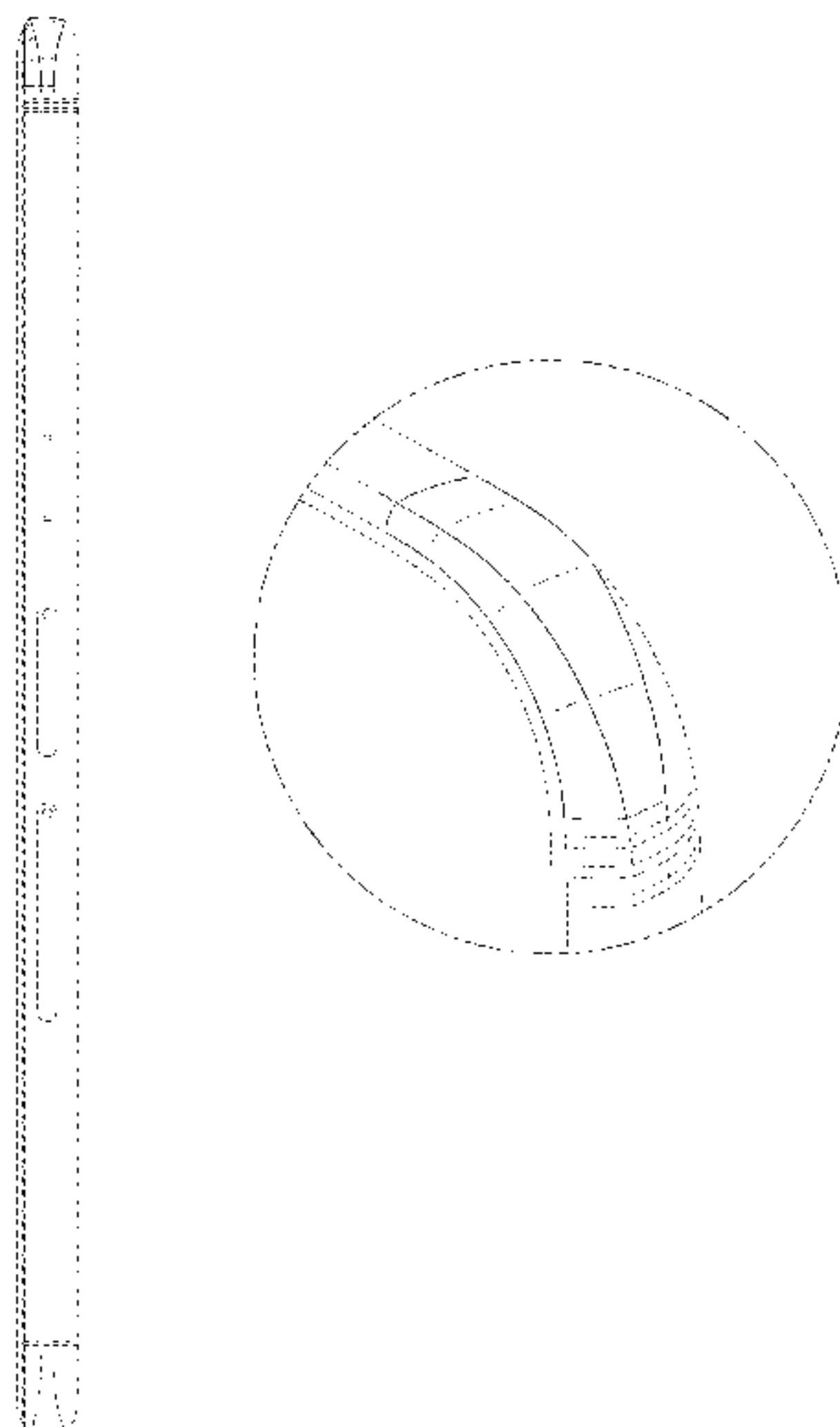
We claim the ornamental design for an electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is the front perspective view of an electronic device showing our new design;

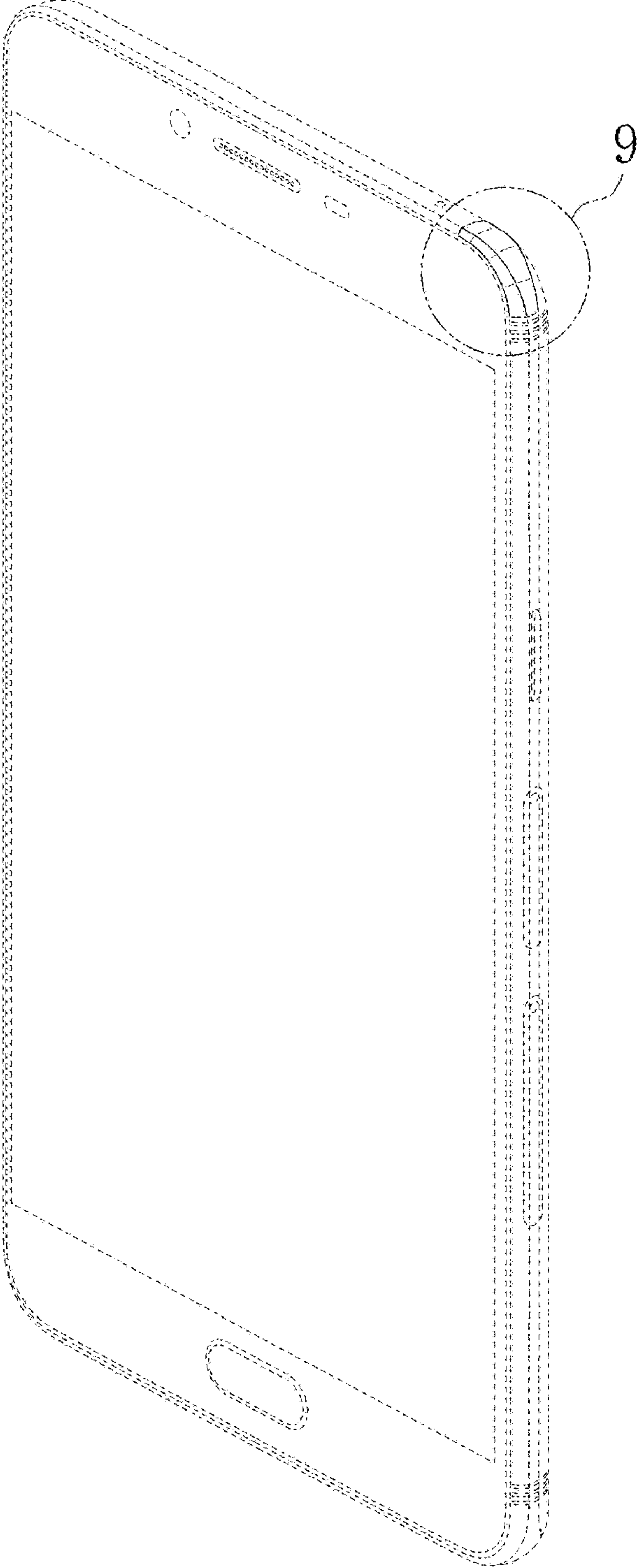

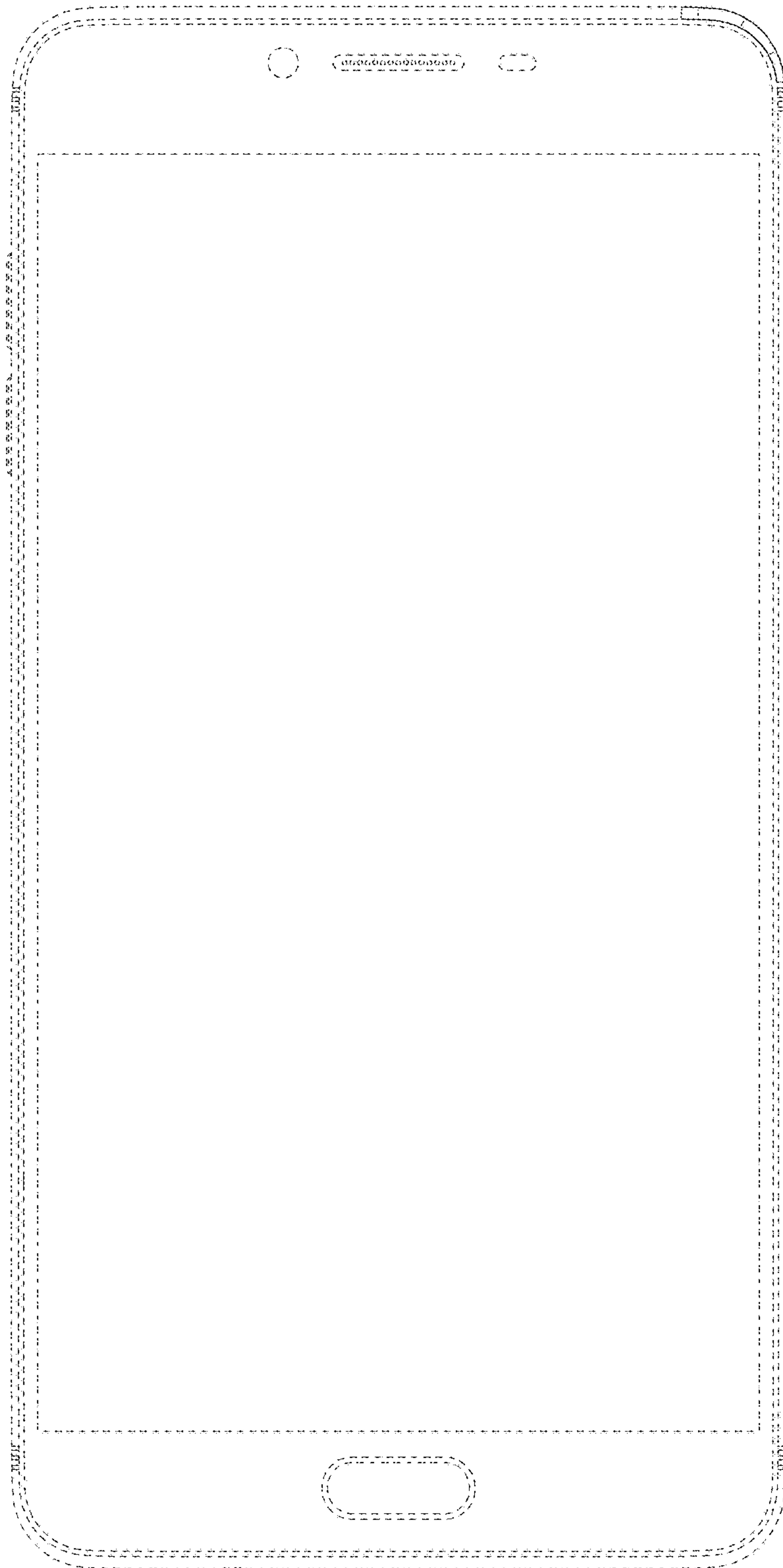

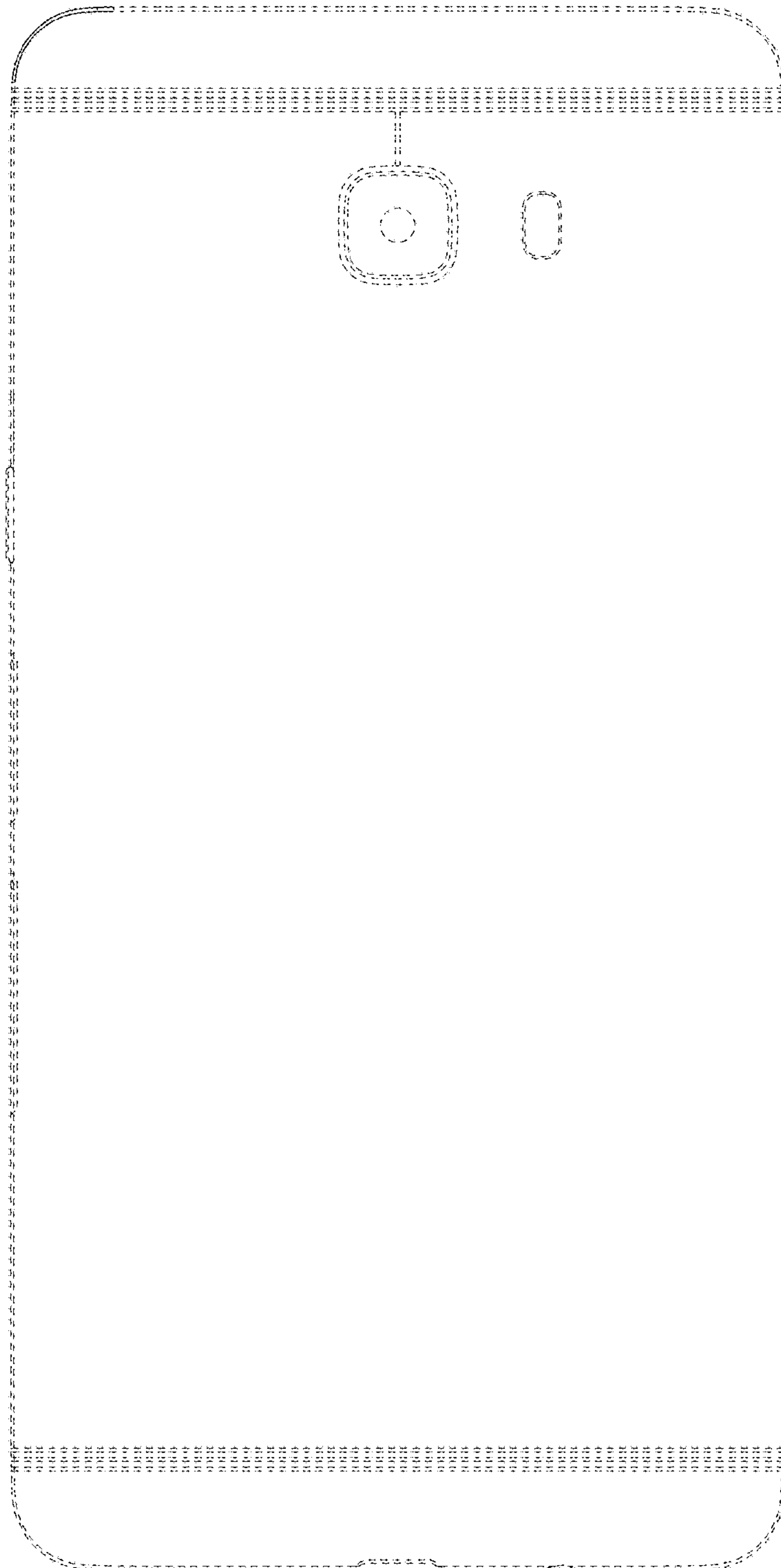

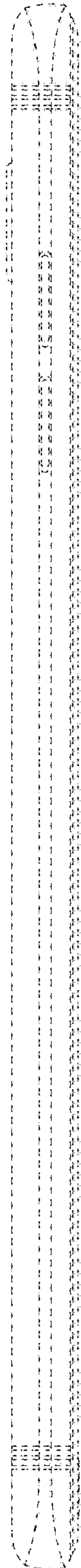

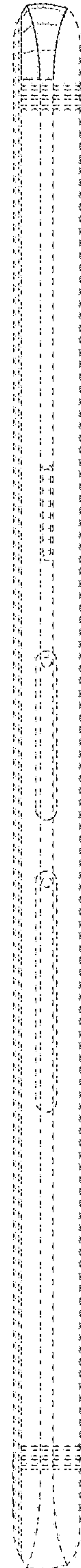

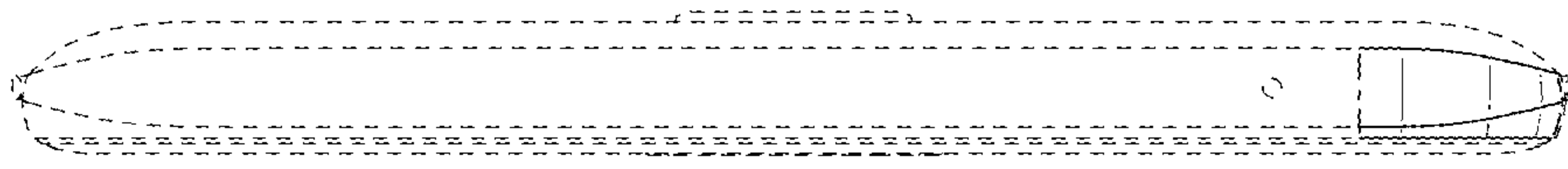

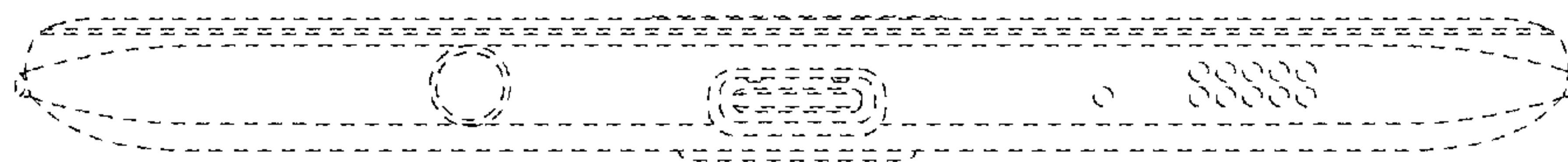

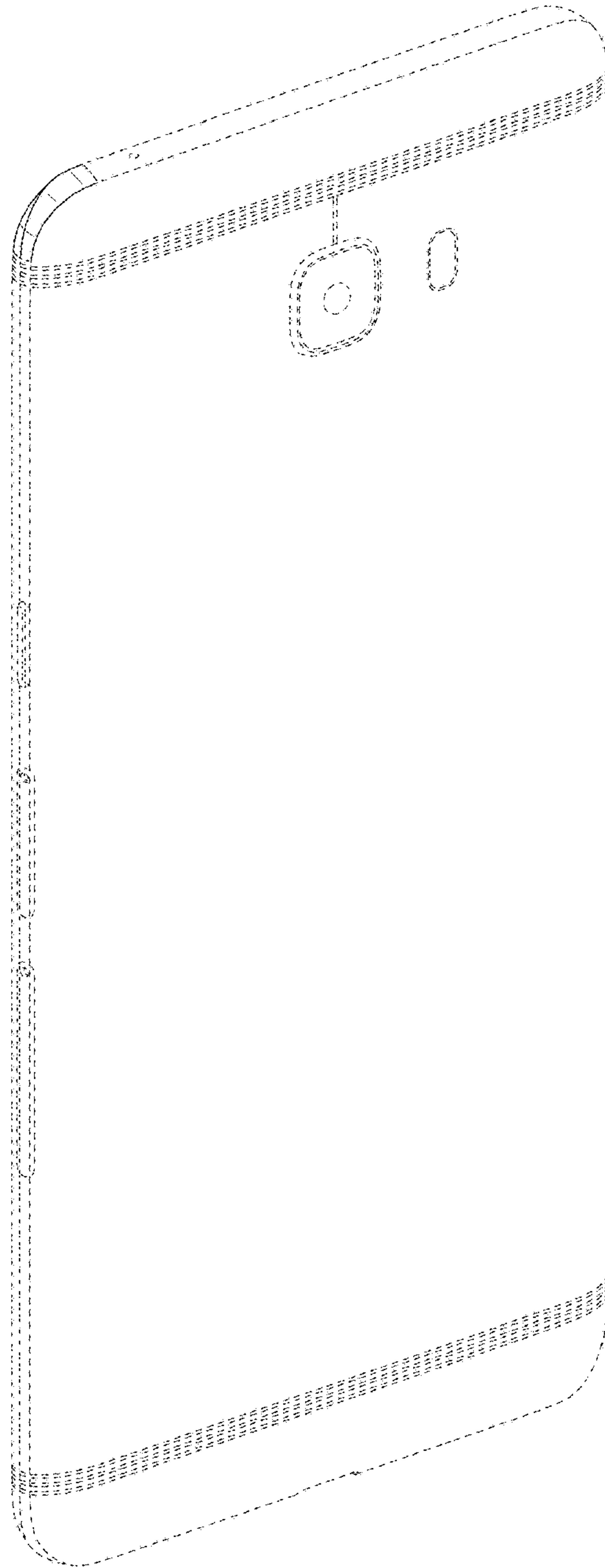
