DESCRIPTION

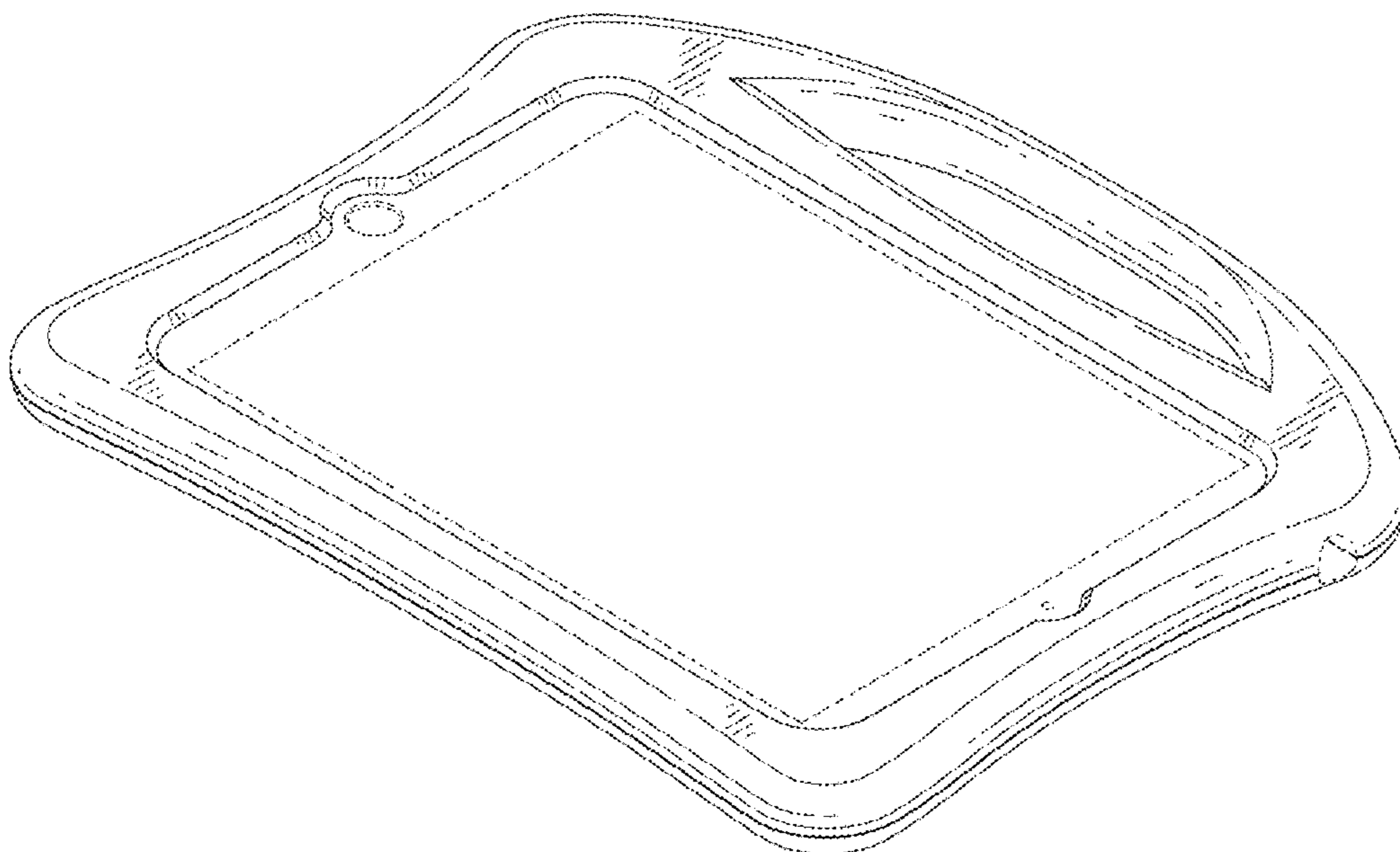
FIG. 1 is a perspective view of the tablet computer case with handle showing my new design;

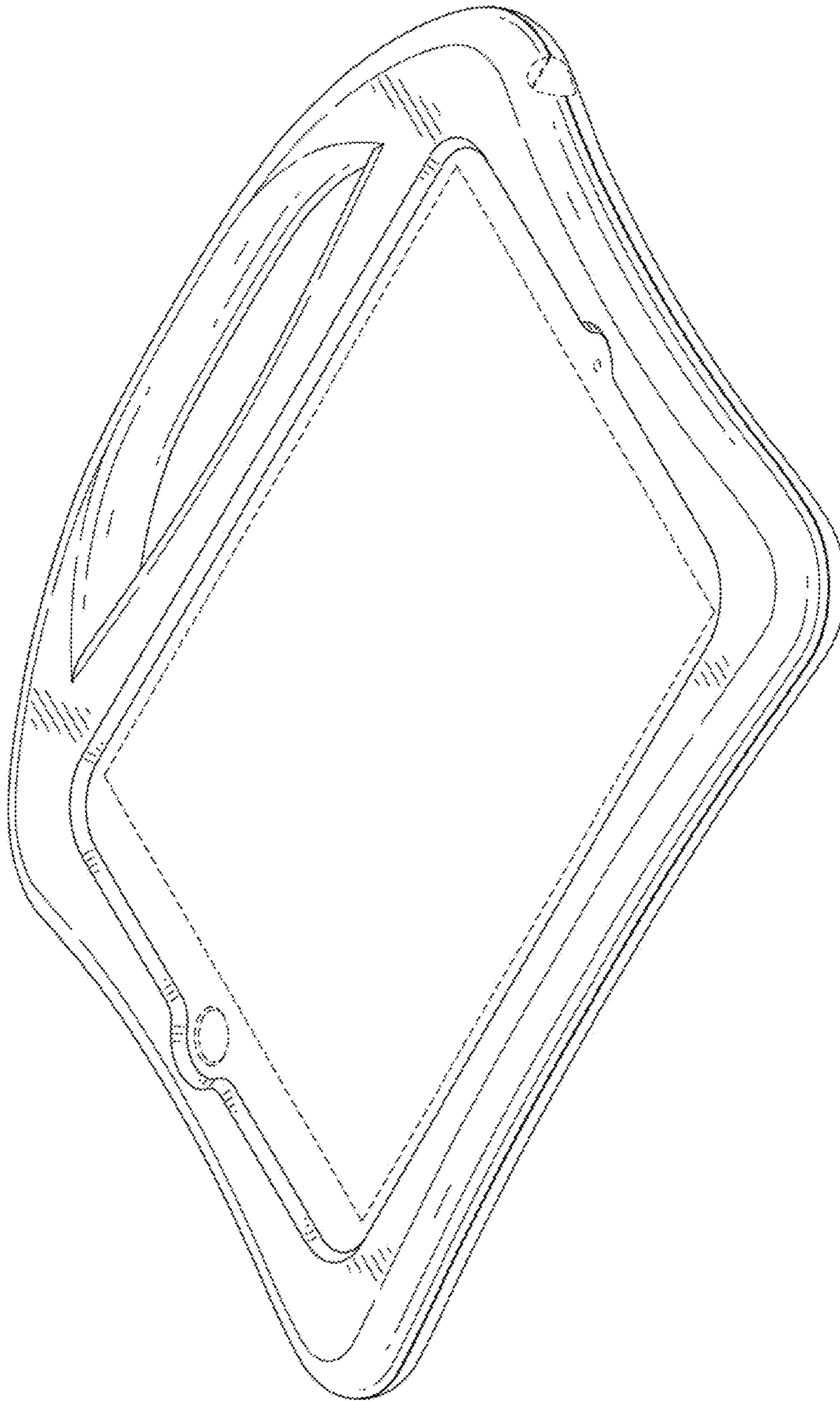

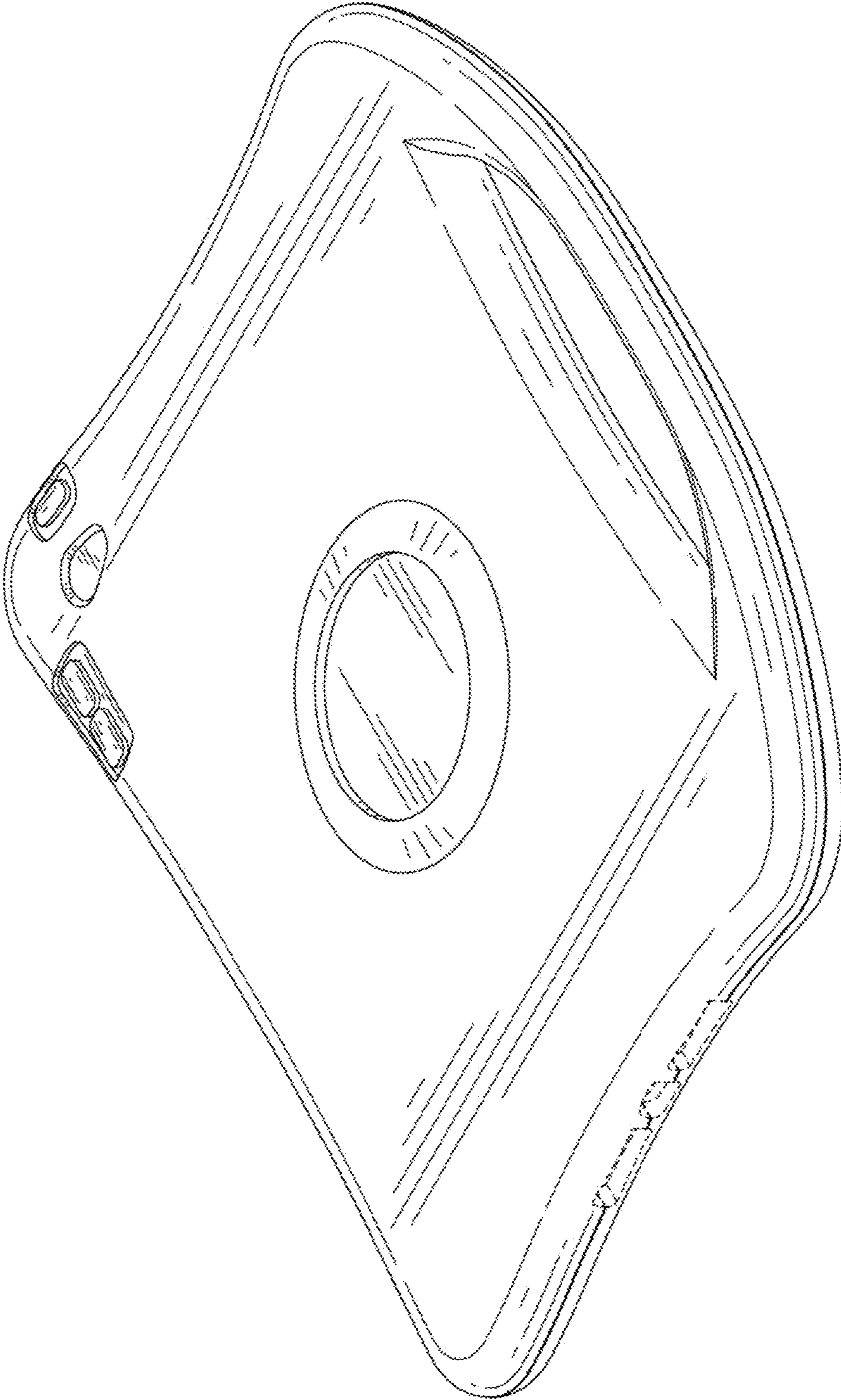

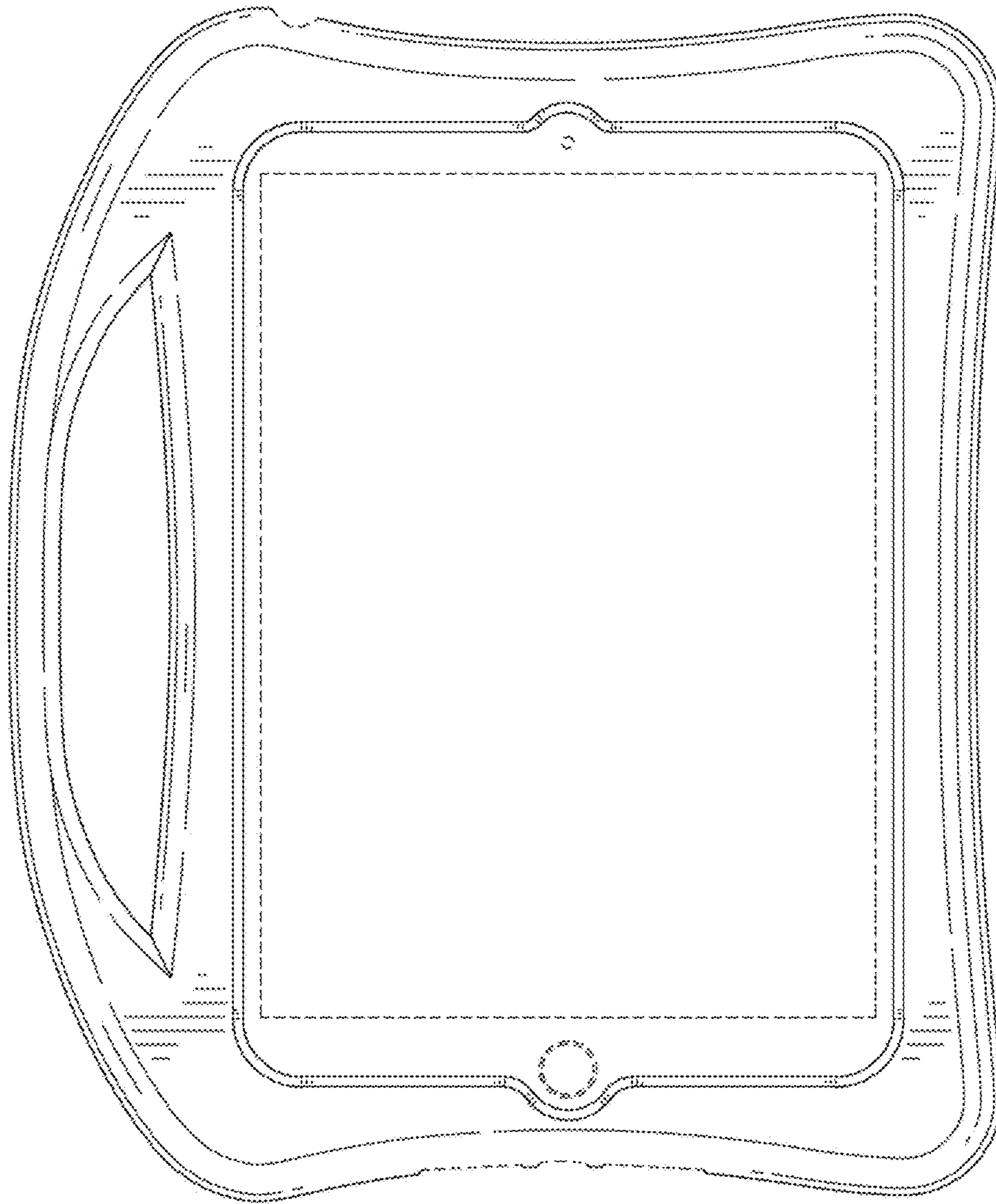

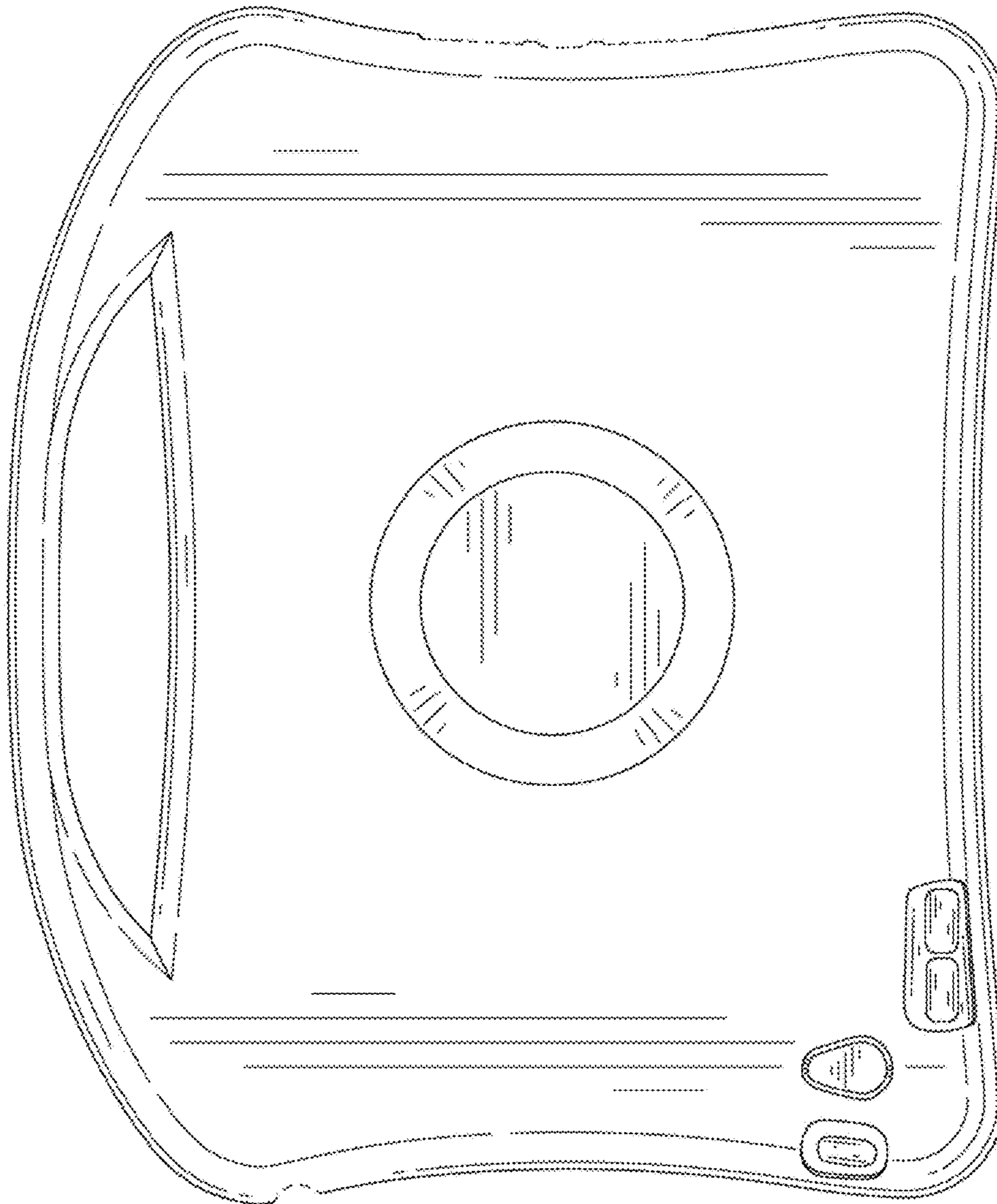

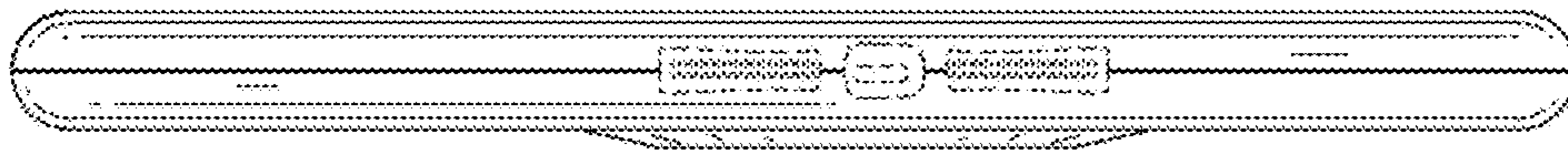

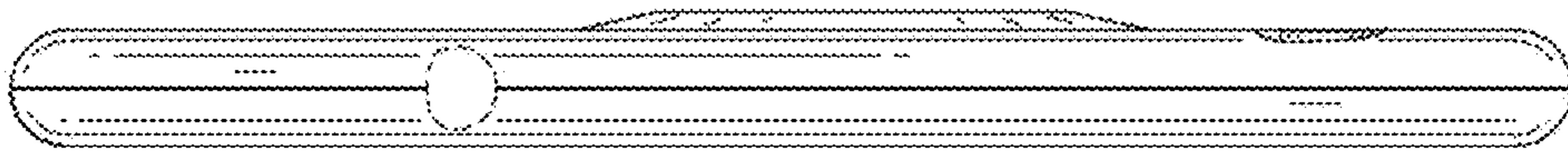

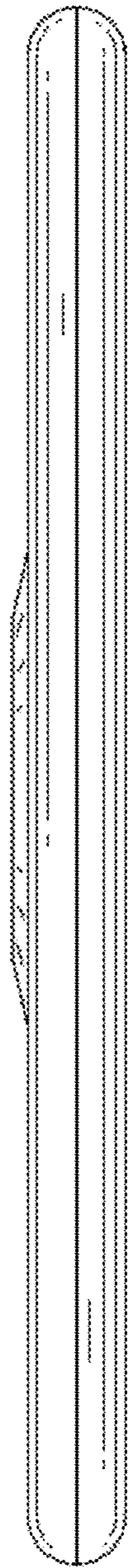

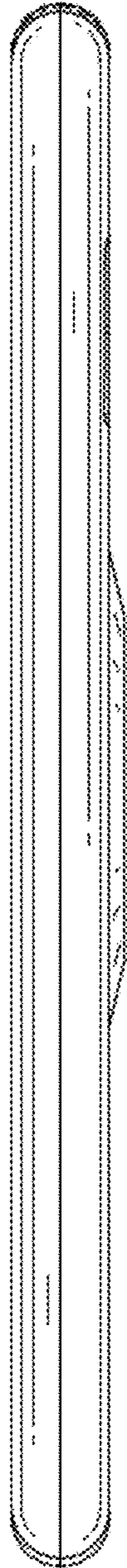
