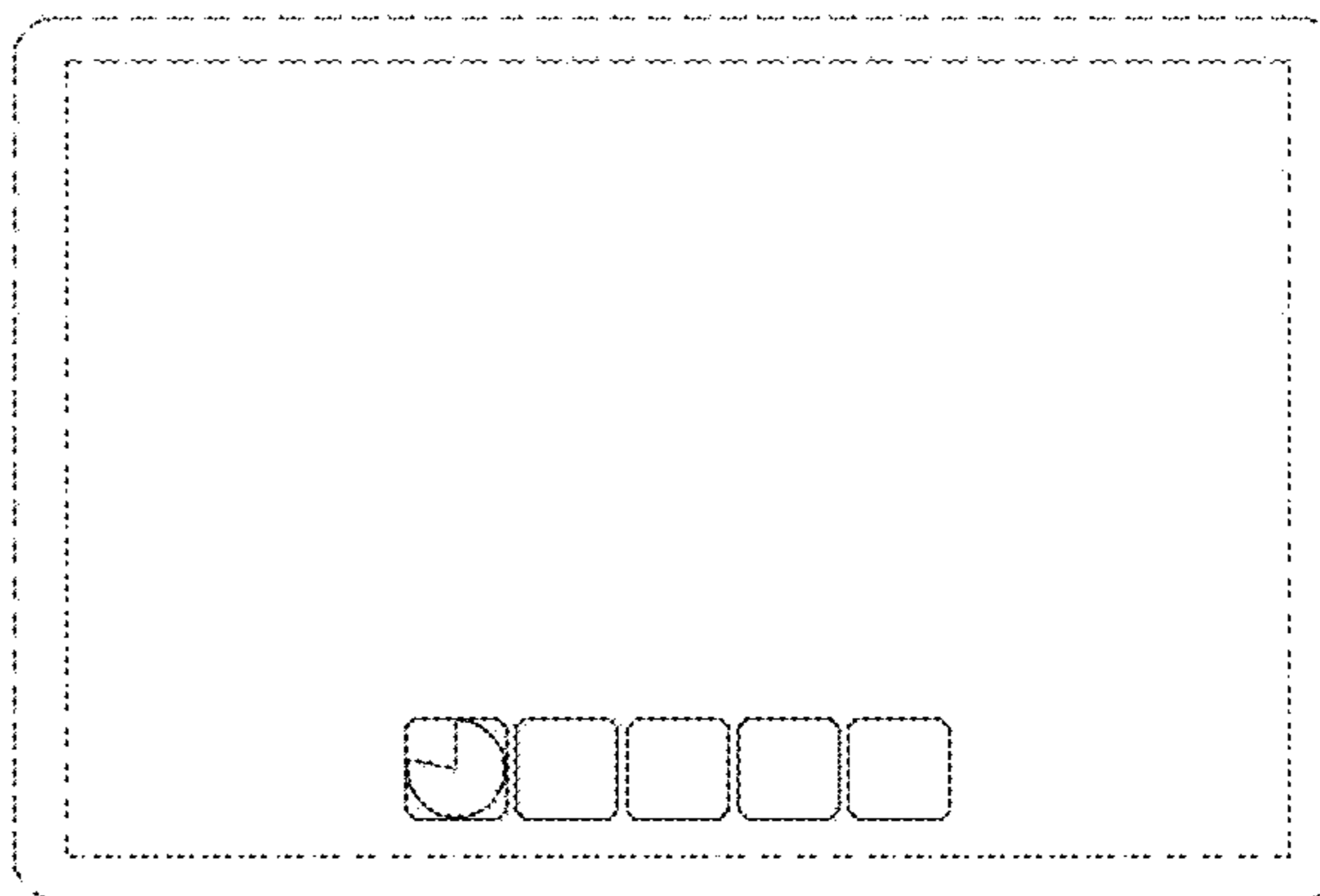
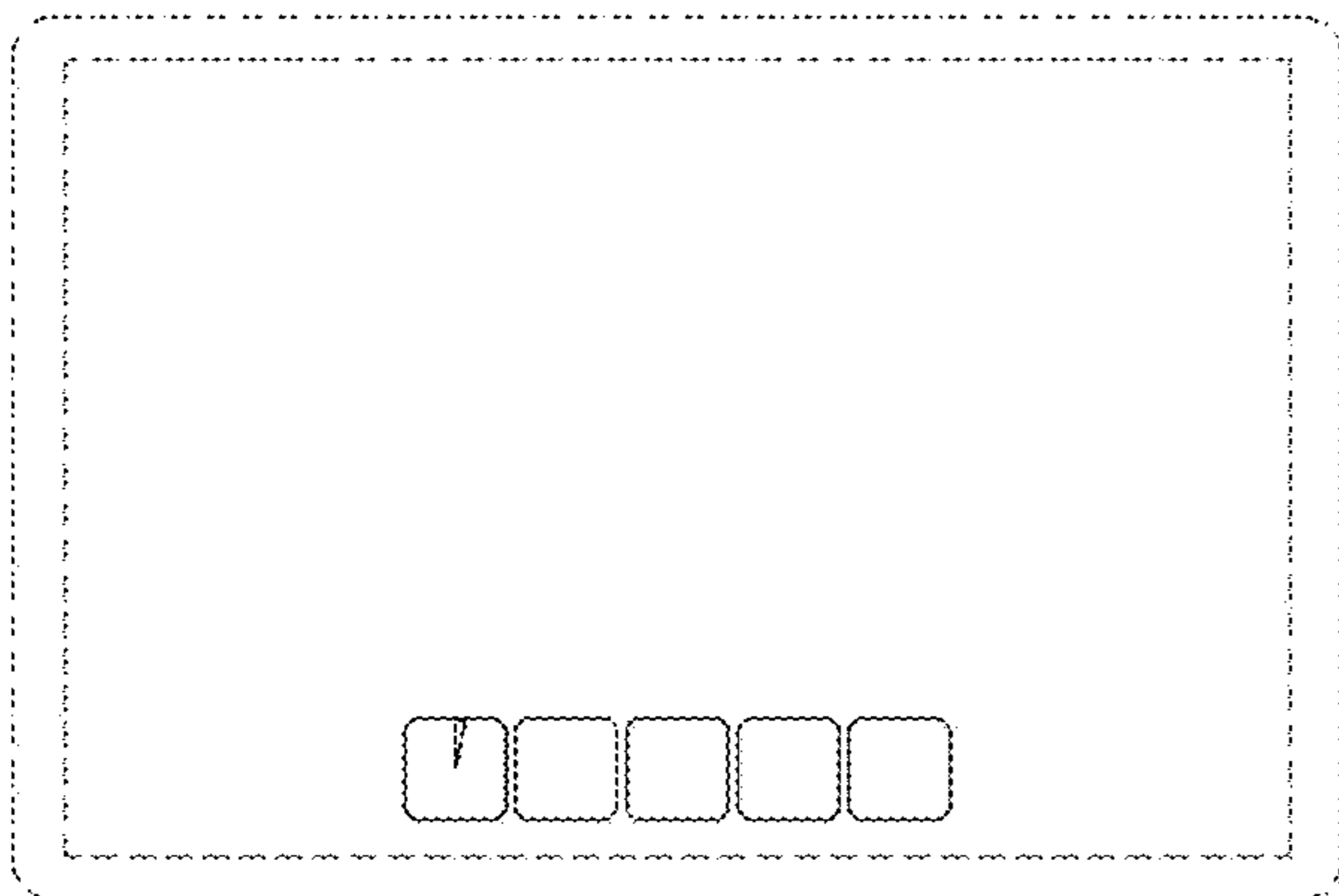
(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

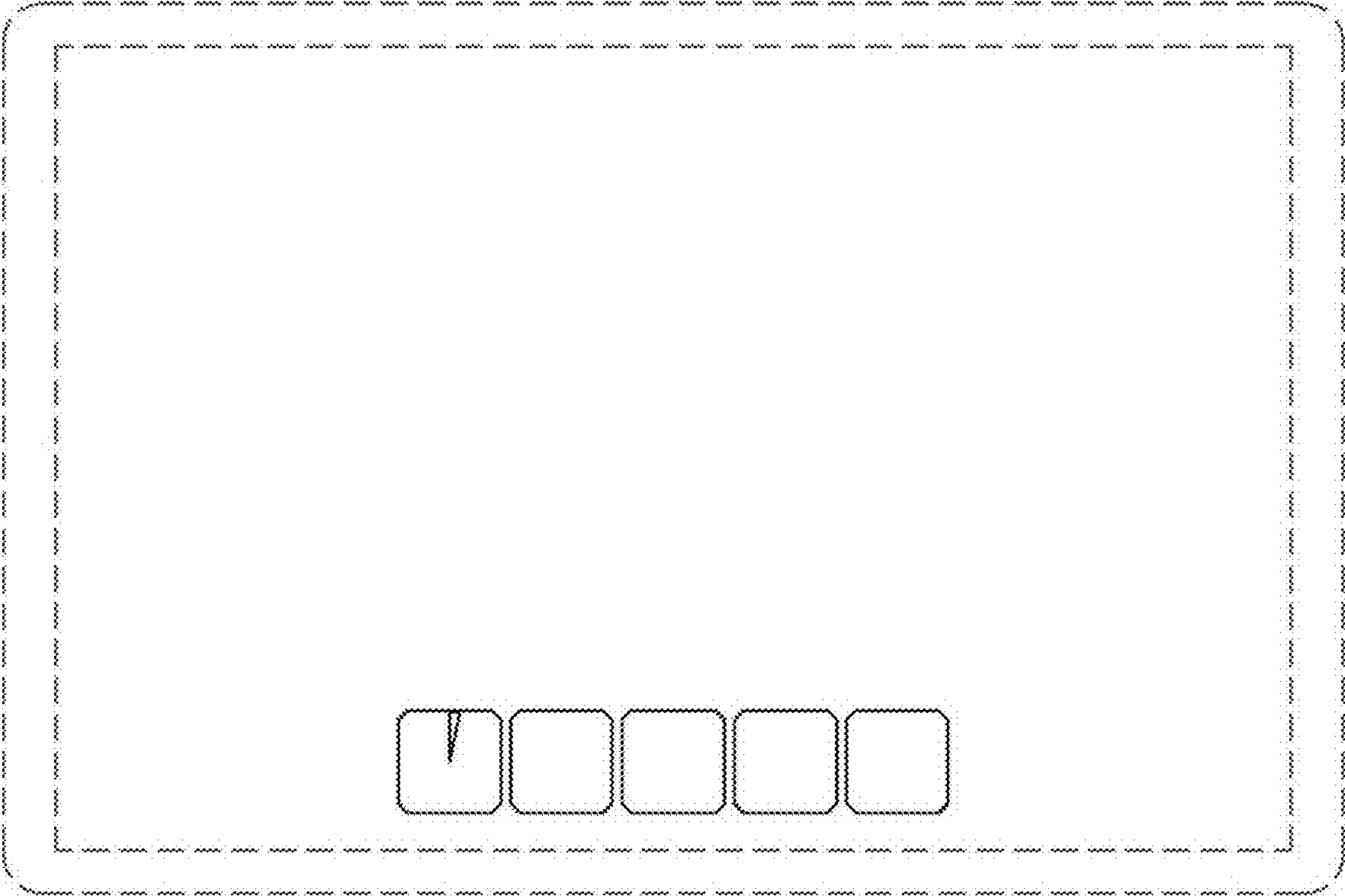
DESCRIPTION

The broken lines in the Figures show a display screen and form no part of the claimed design. The process or period in which one image transitions to another forms no part of the claimed design.

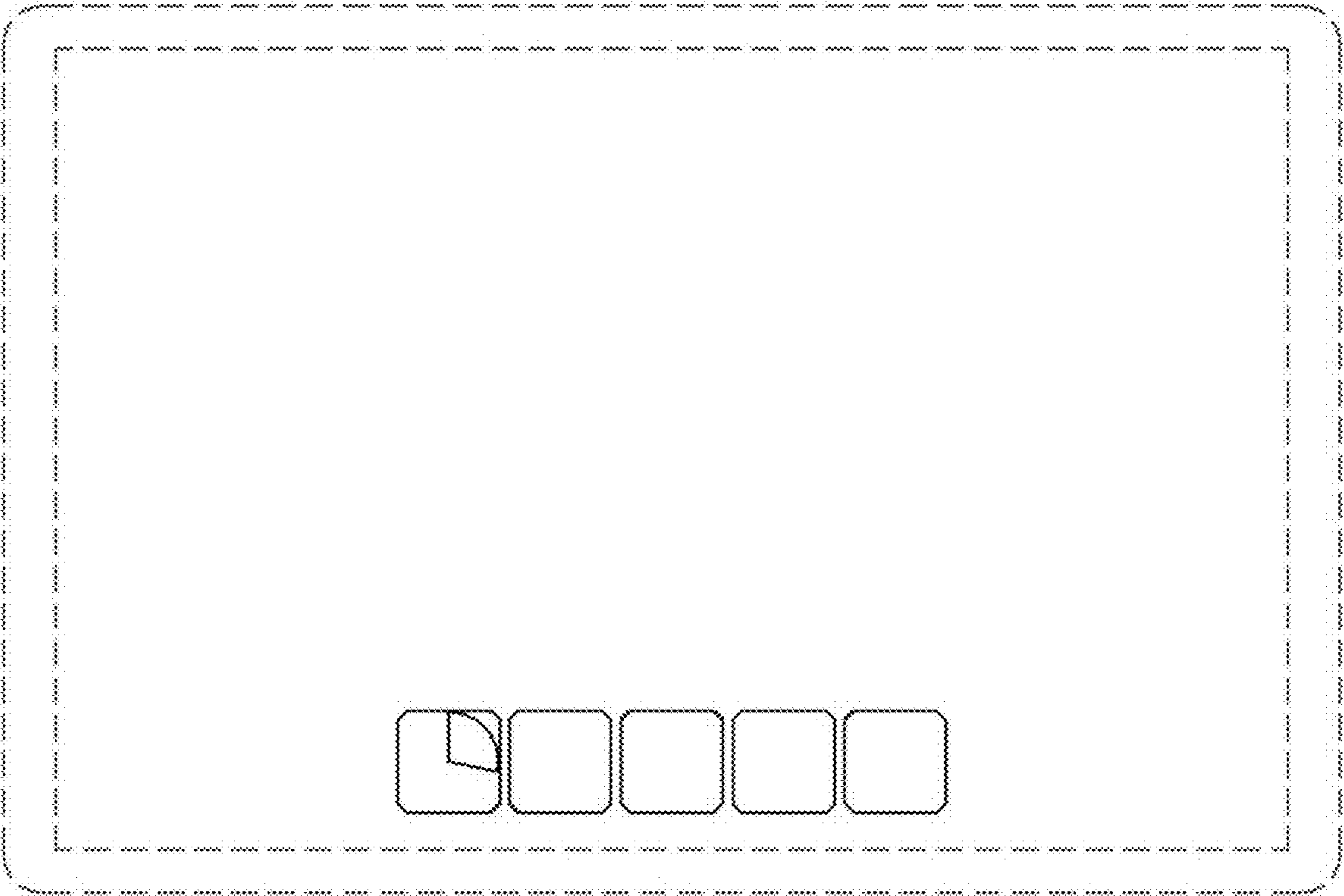

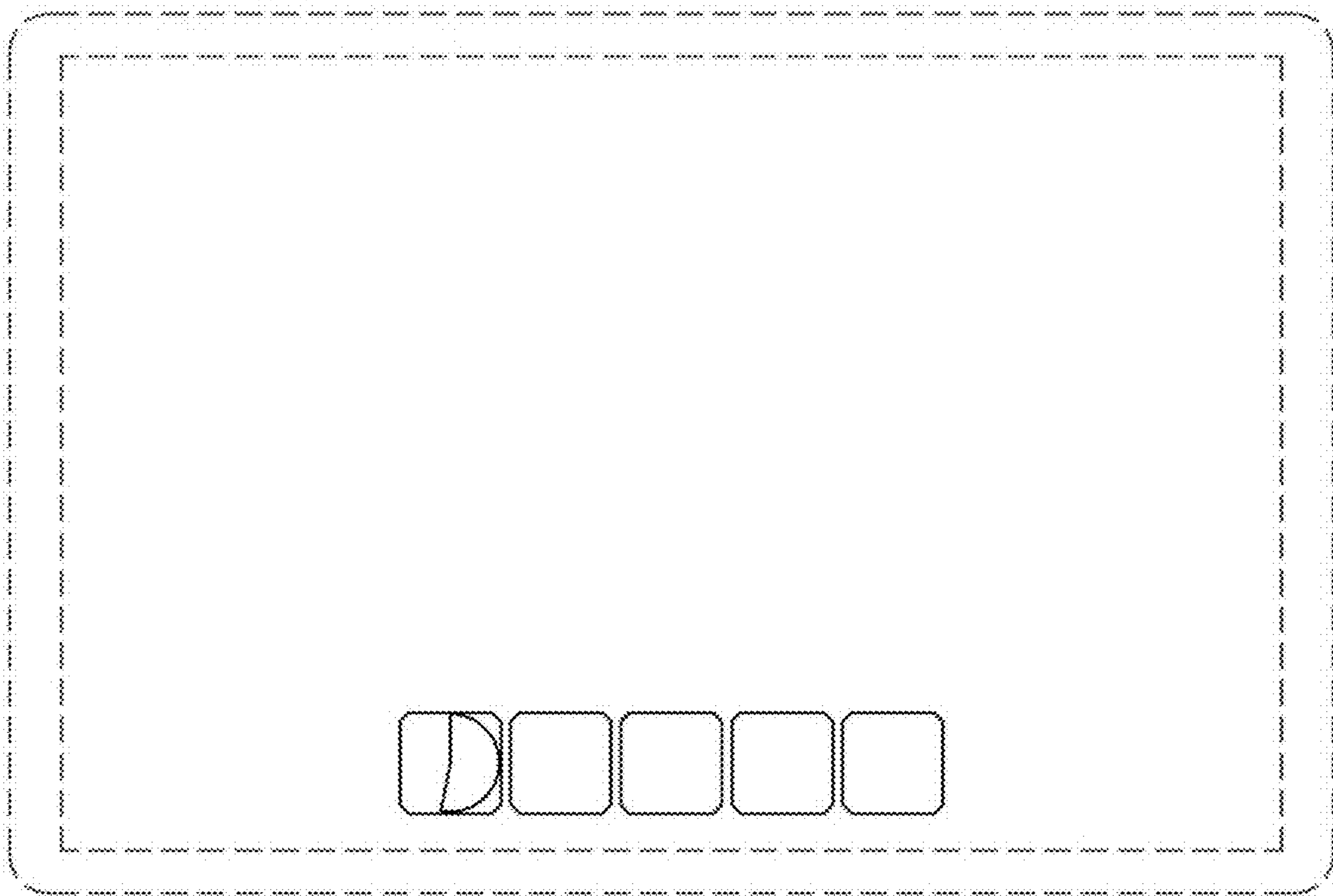

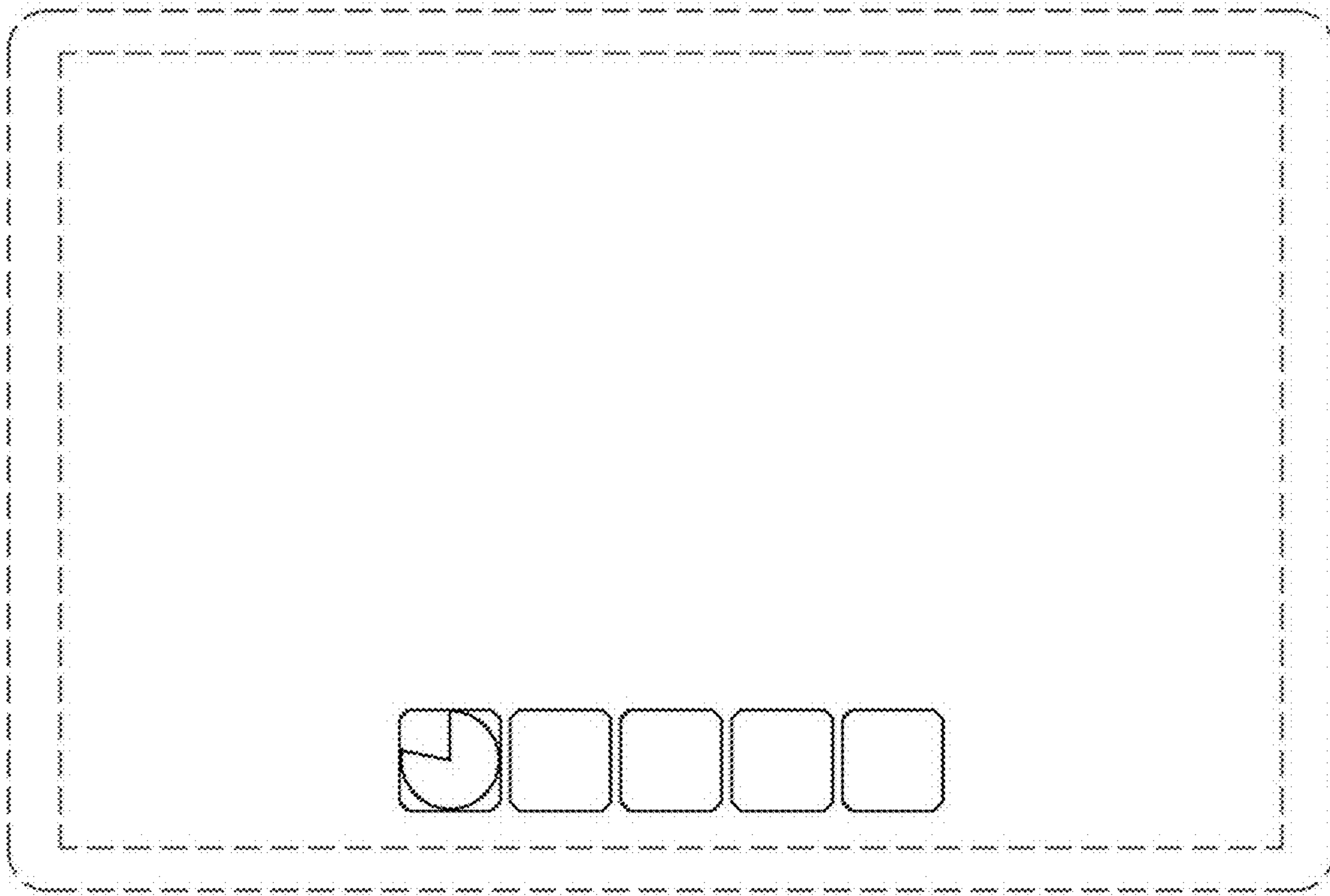

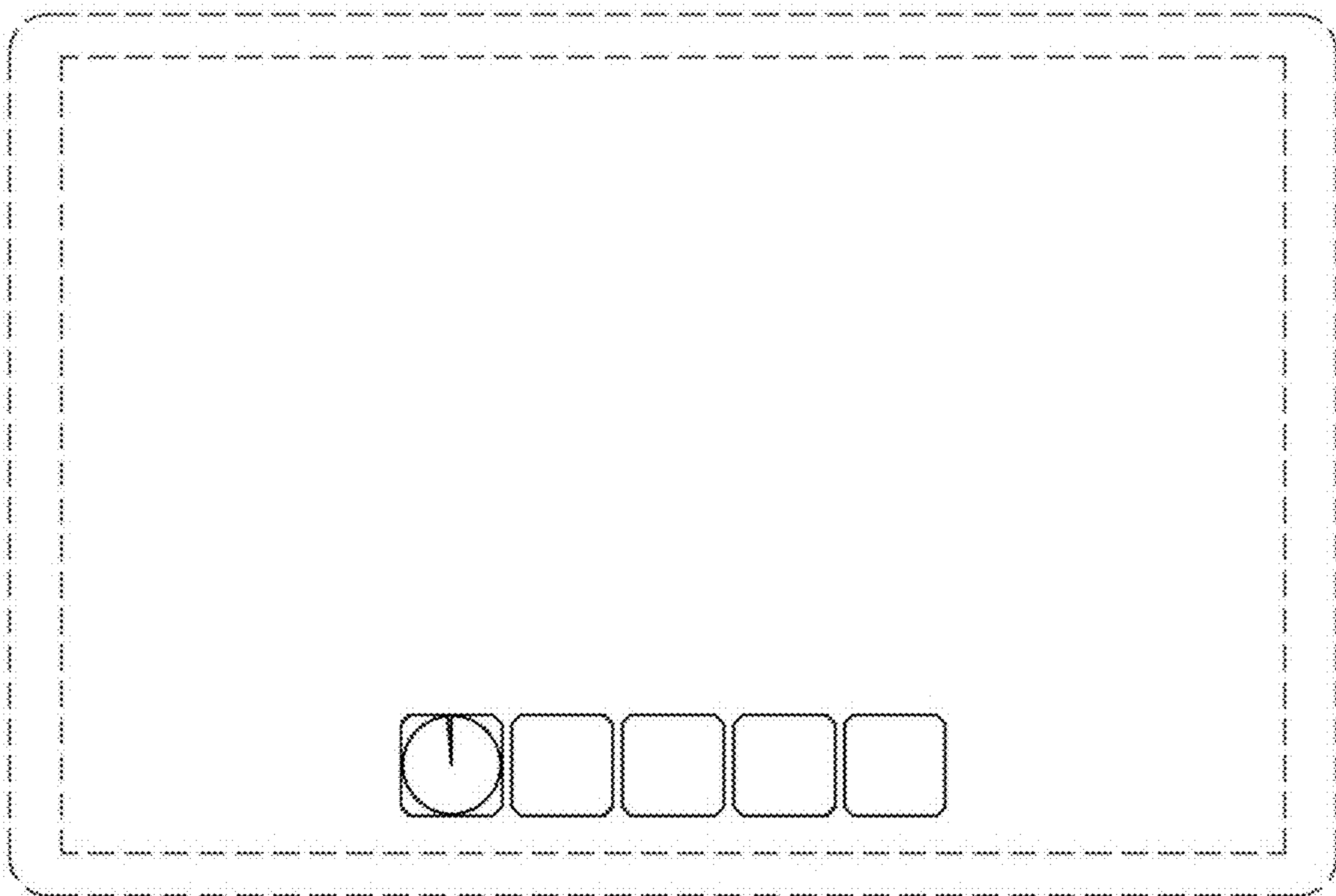
