The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image according to a first embodiment of the claimed design;

FIG. 2 is a second image thereof;

FIG. 3 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image according to a second embodiment of the claimed design; and,

FIG. 4 is a second image thereof.

The outermost dashed broken lines in the figures show a display screen or portion thereof, and form no part of the claimed design. The dot dash lines and the areas within the dot dash lines in the figures show portions of the graphical user interface that form no part of the claimed design.

The appearance of the animated image of FIGS. 1 and 2 sequentially transitions between the images shown in FIGS. 1-2. The appearance of the animated image of FIGS. 3 and 4 sequentially transitions between the images shown in FIGS. 3-4. The process or period in which one image transitions to another forms no part of the claimed design.
