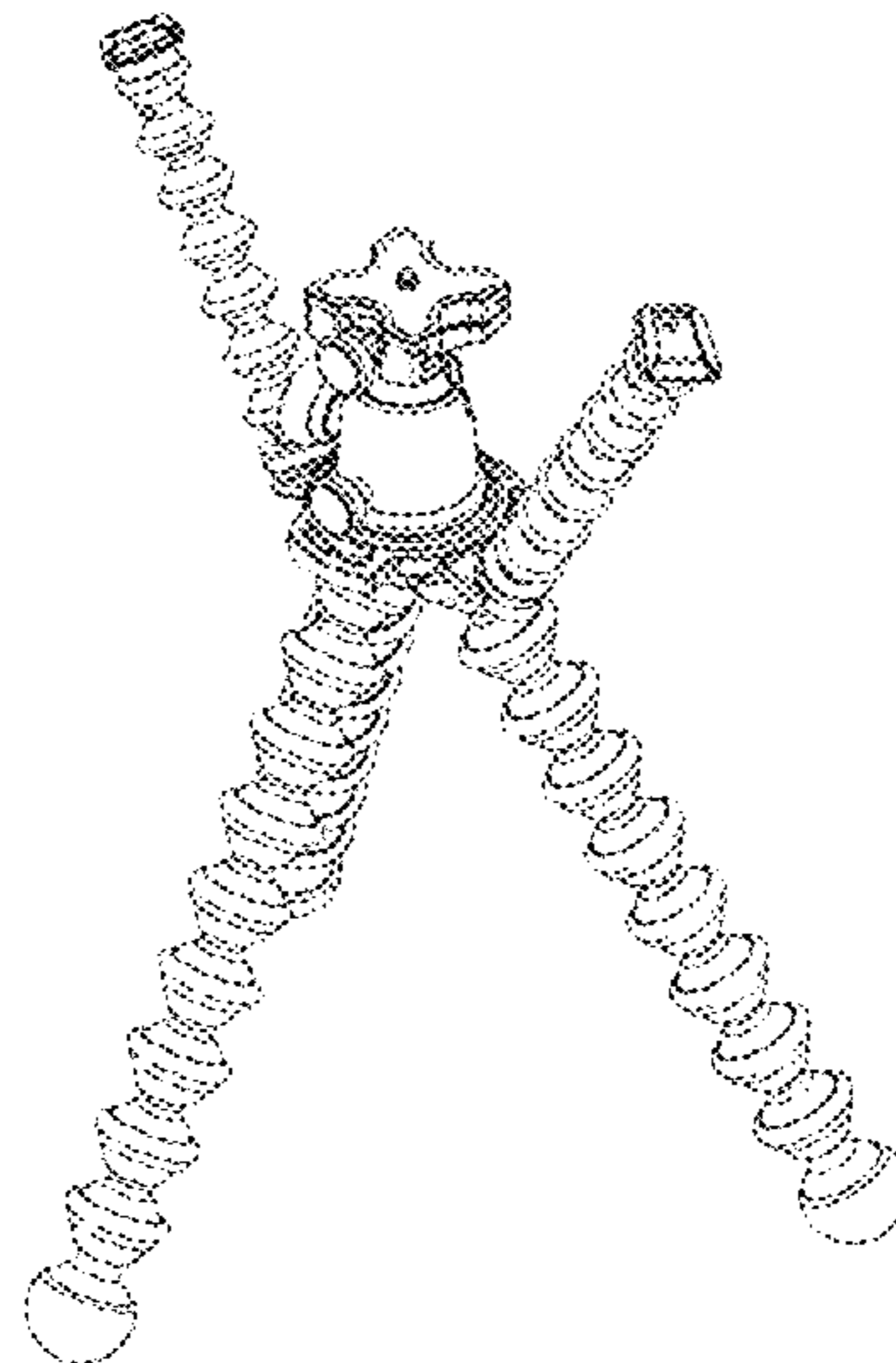
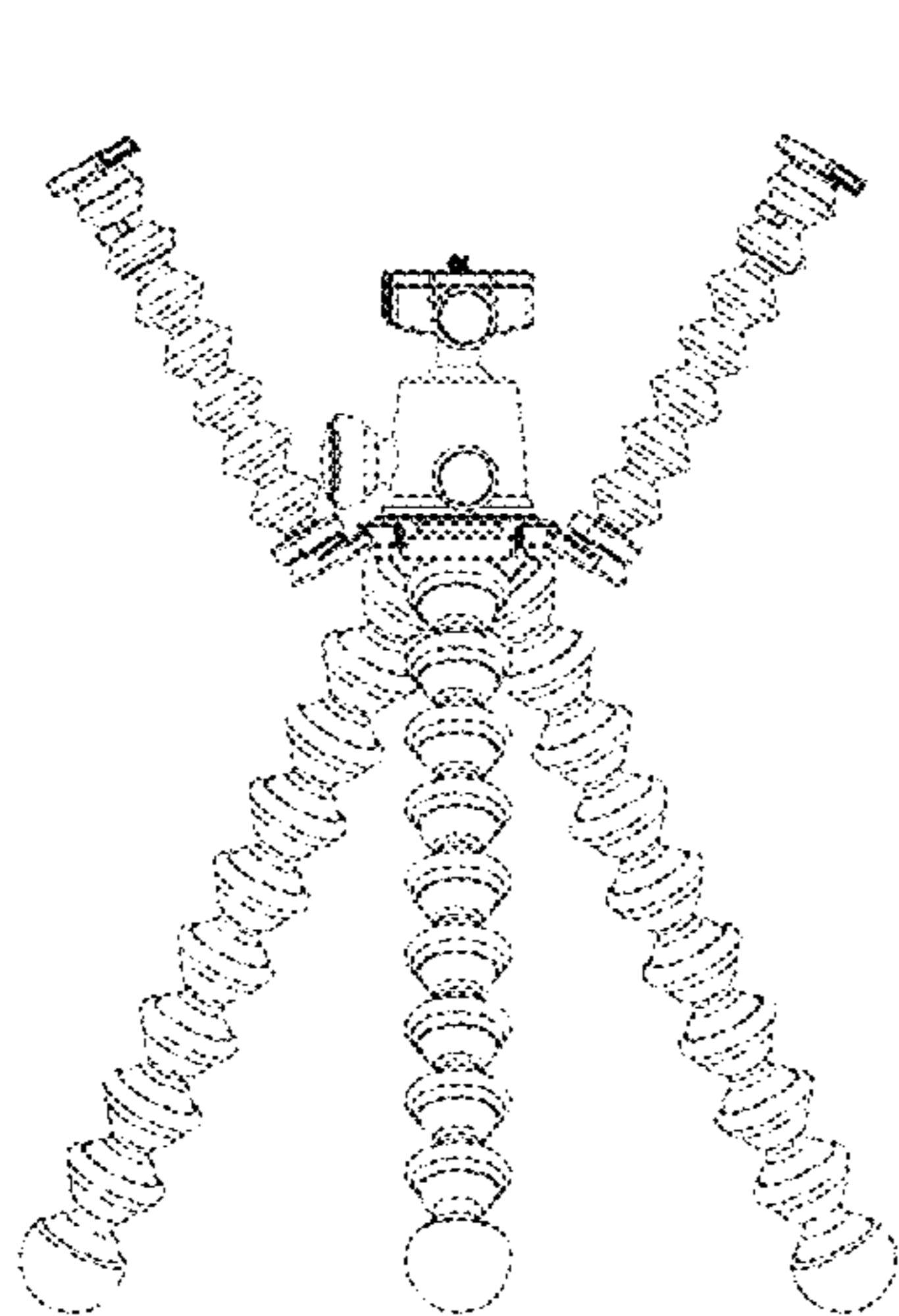
(57) **CLAIM**

The ornamental design for a mounting ring with extensions on a tripod, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a mounting ring with extensions on a tripod.

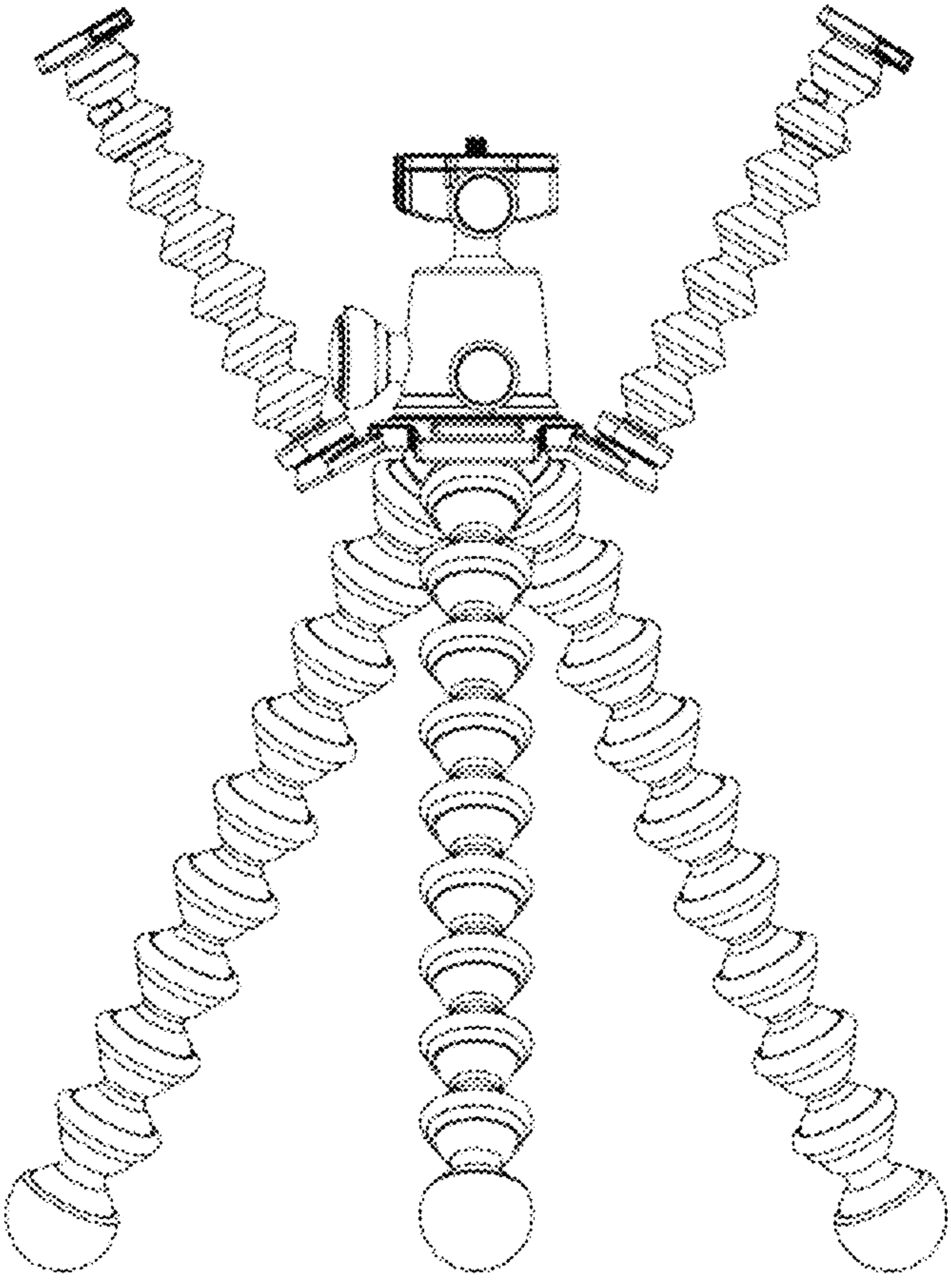

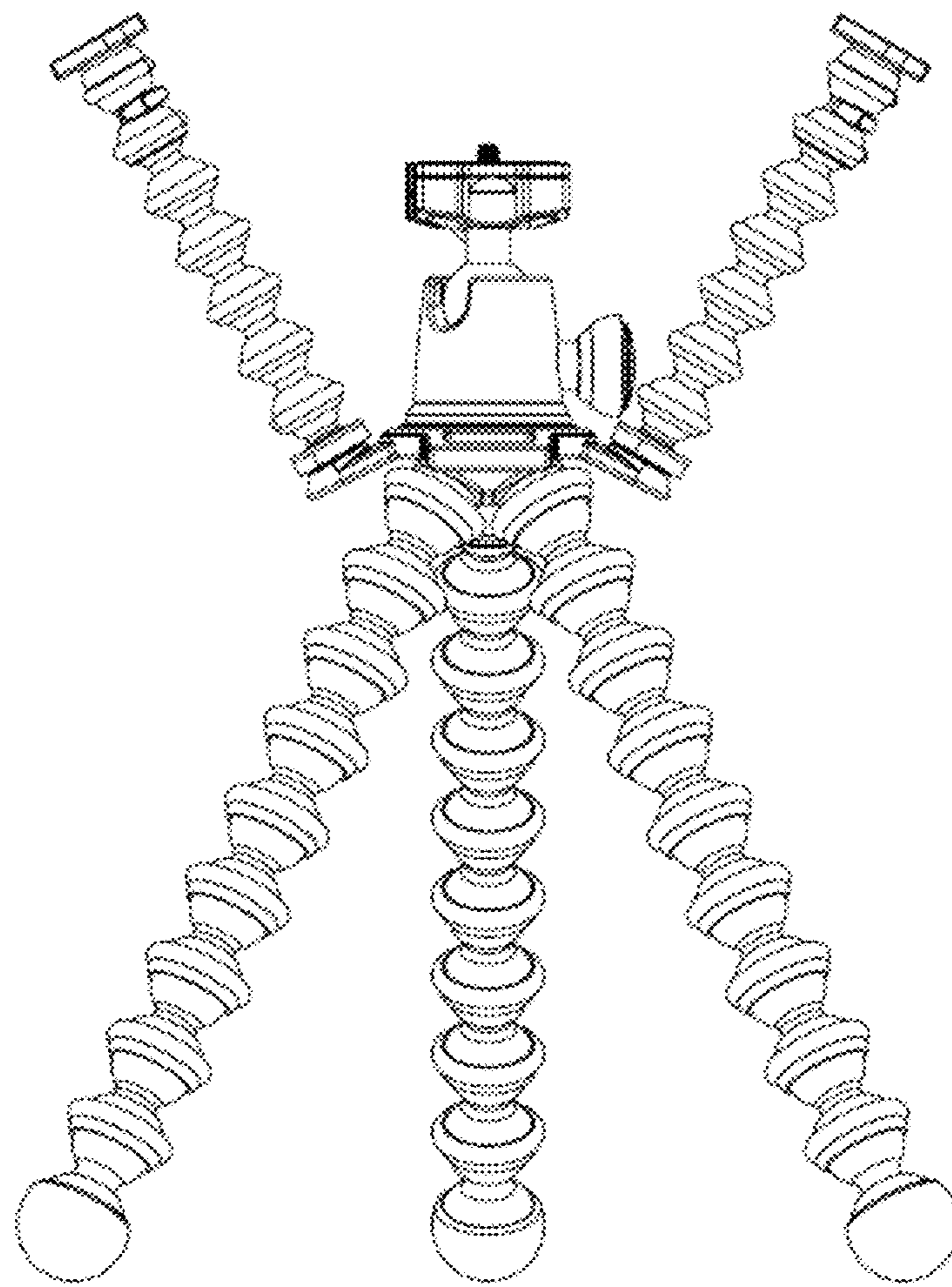

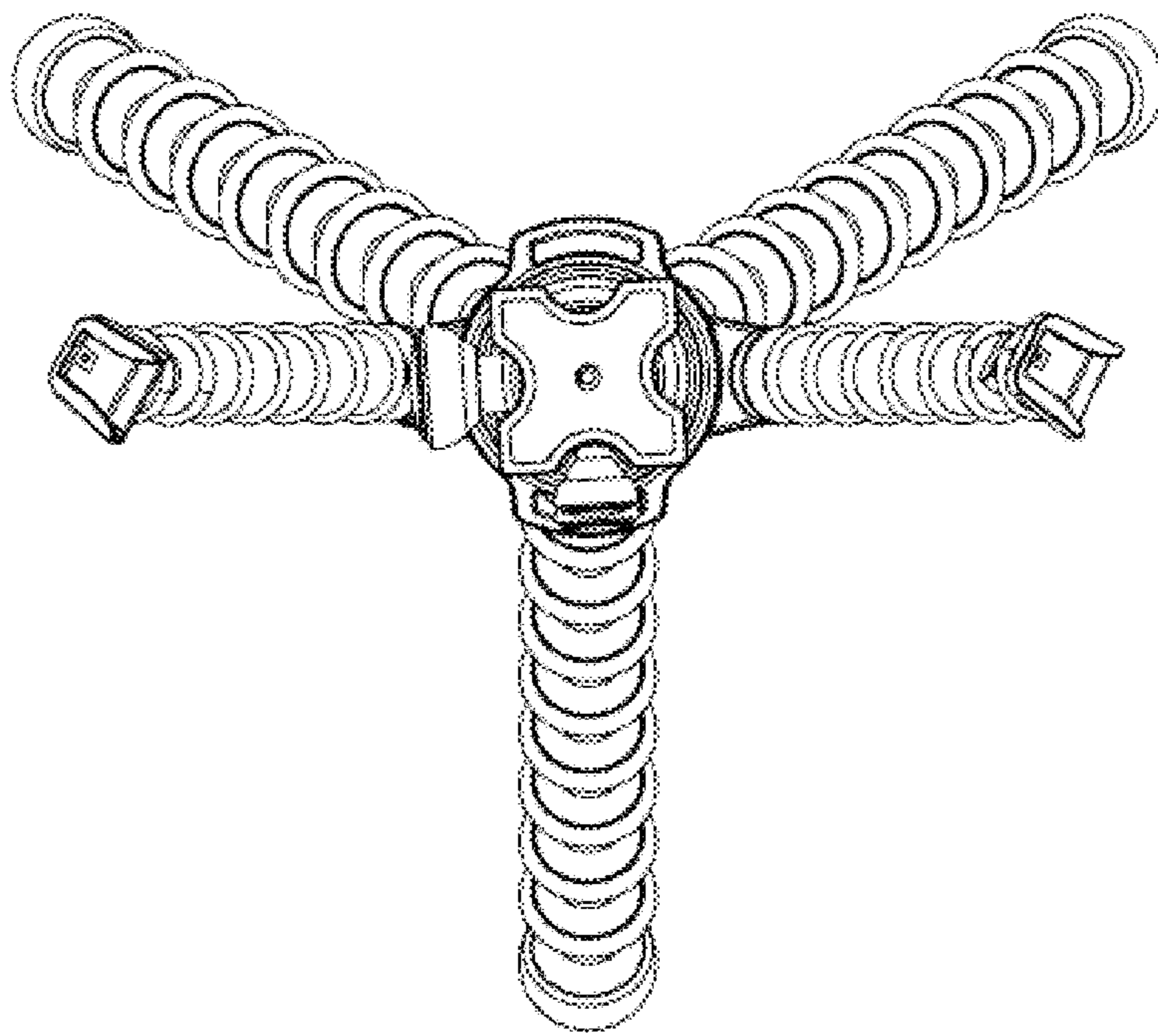

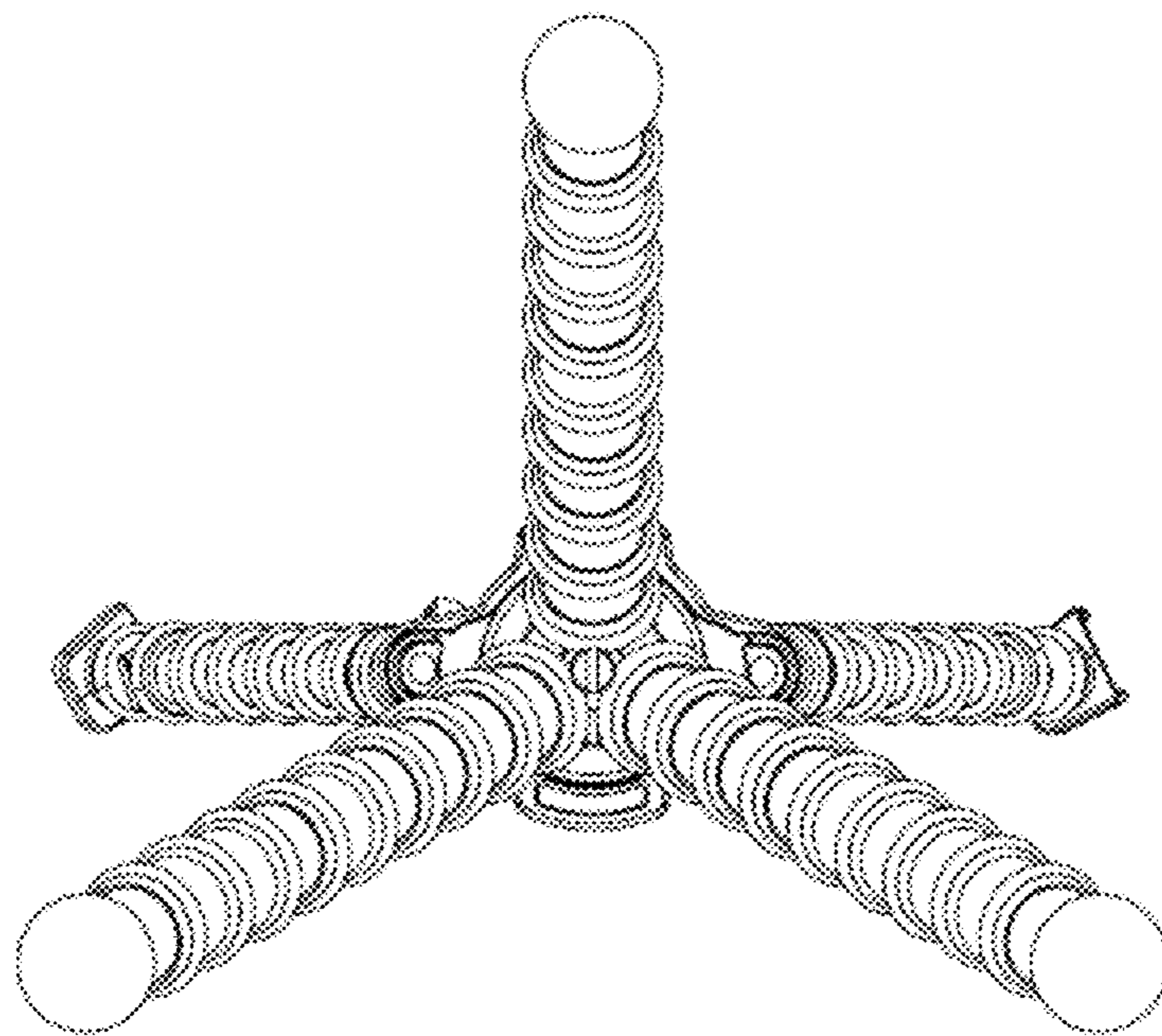

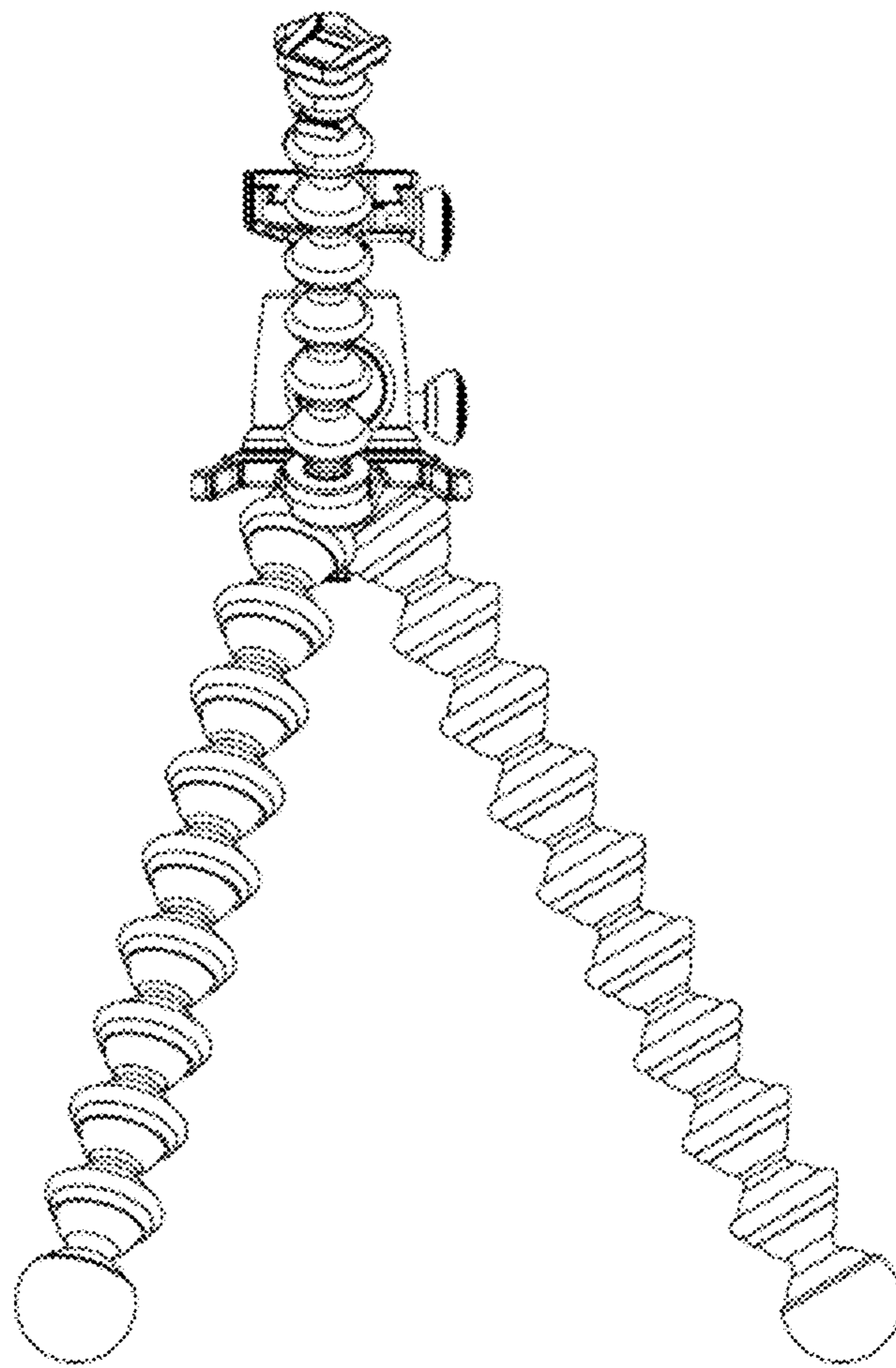

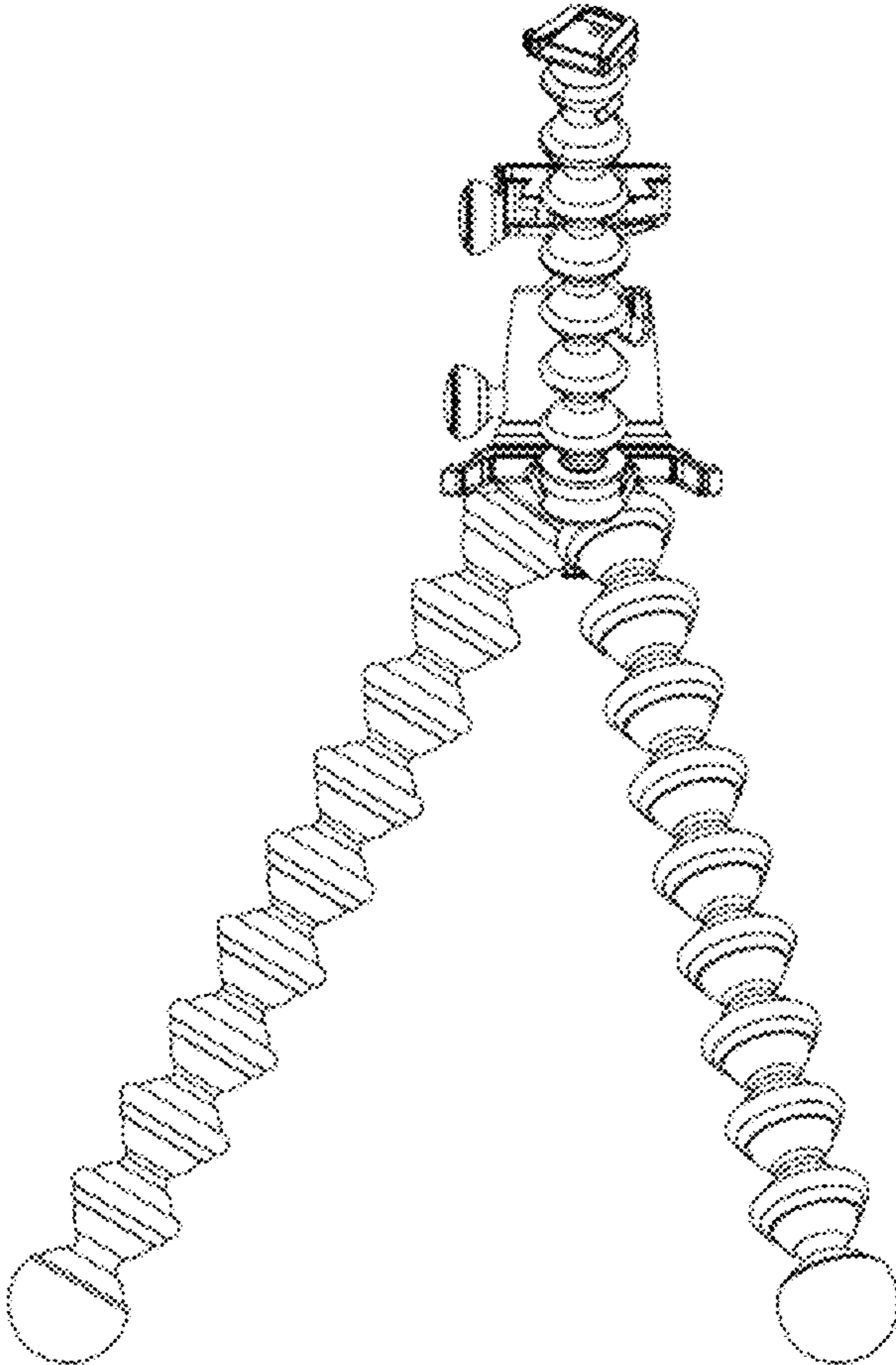

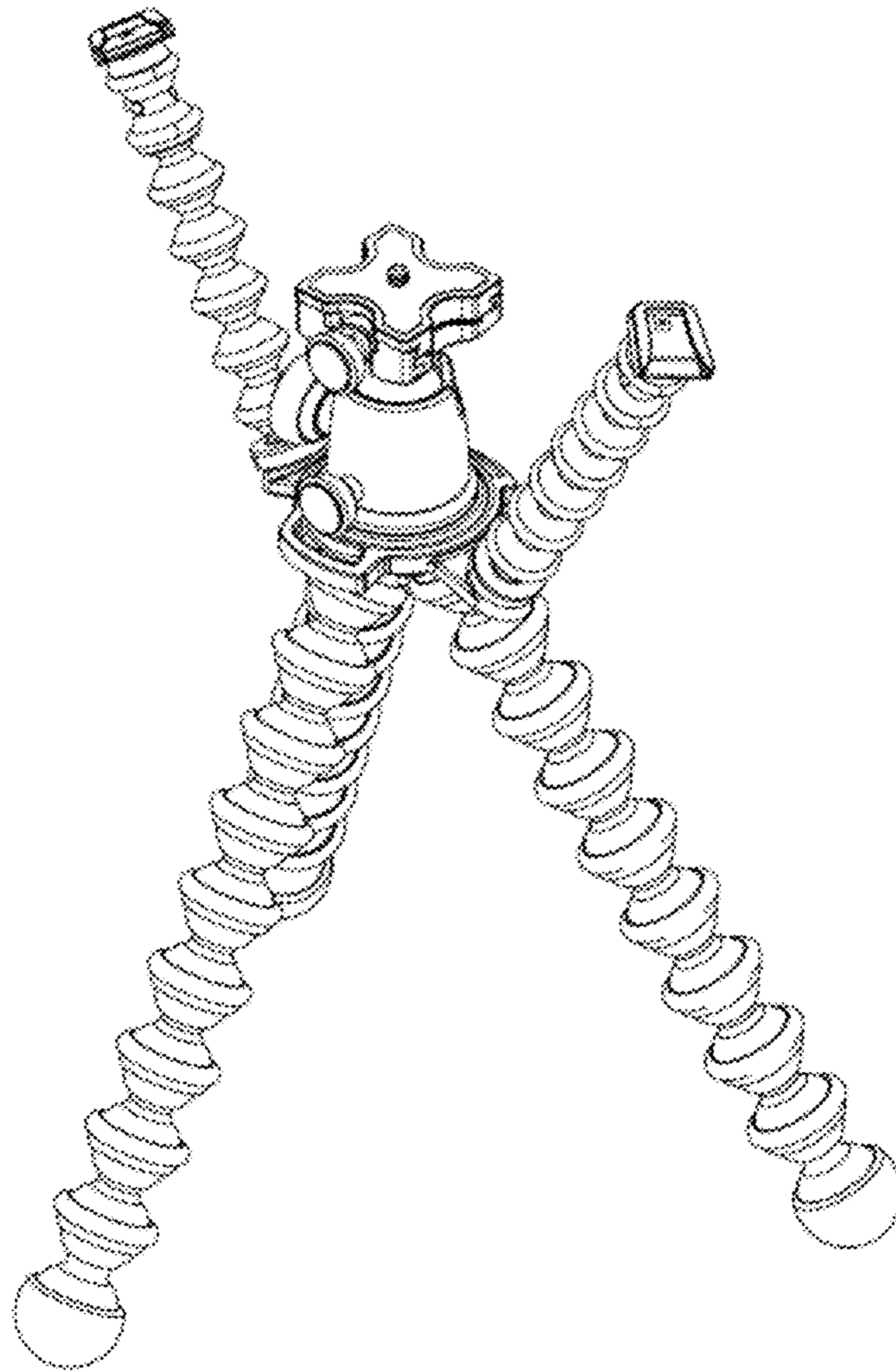

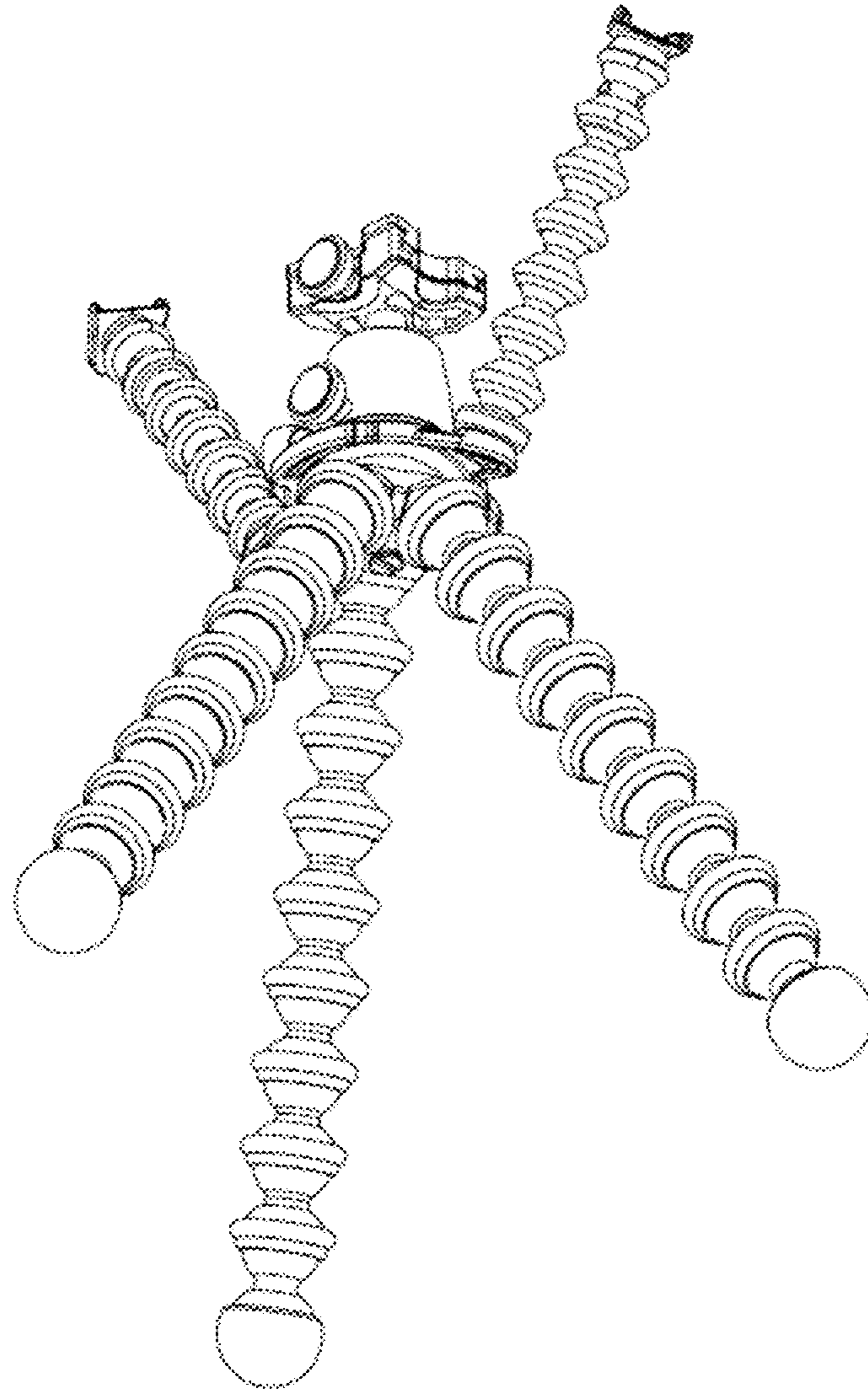
