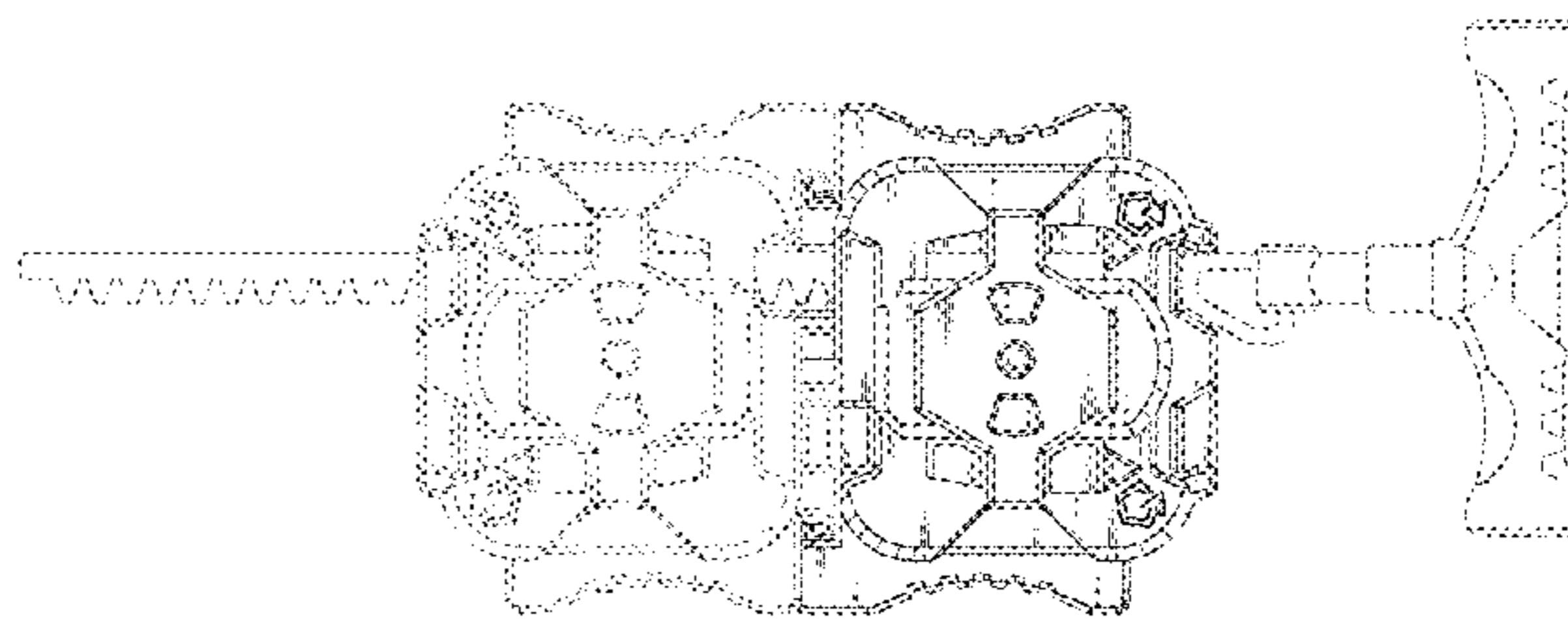
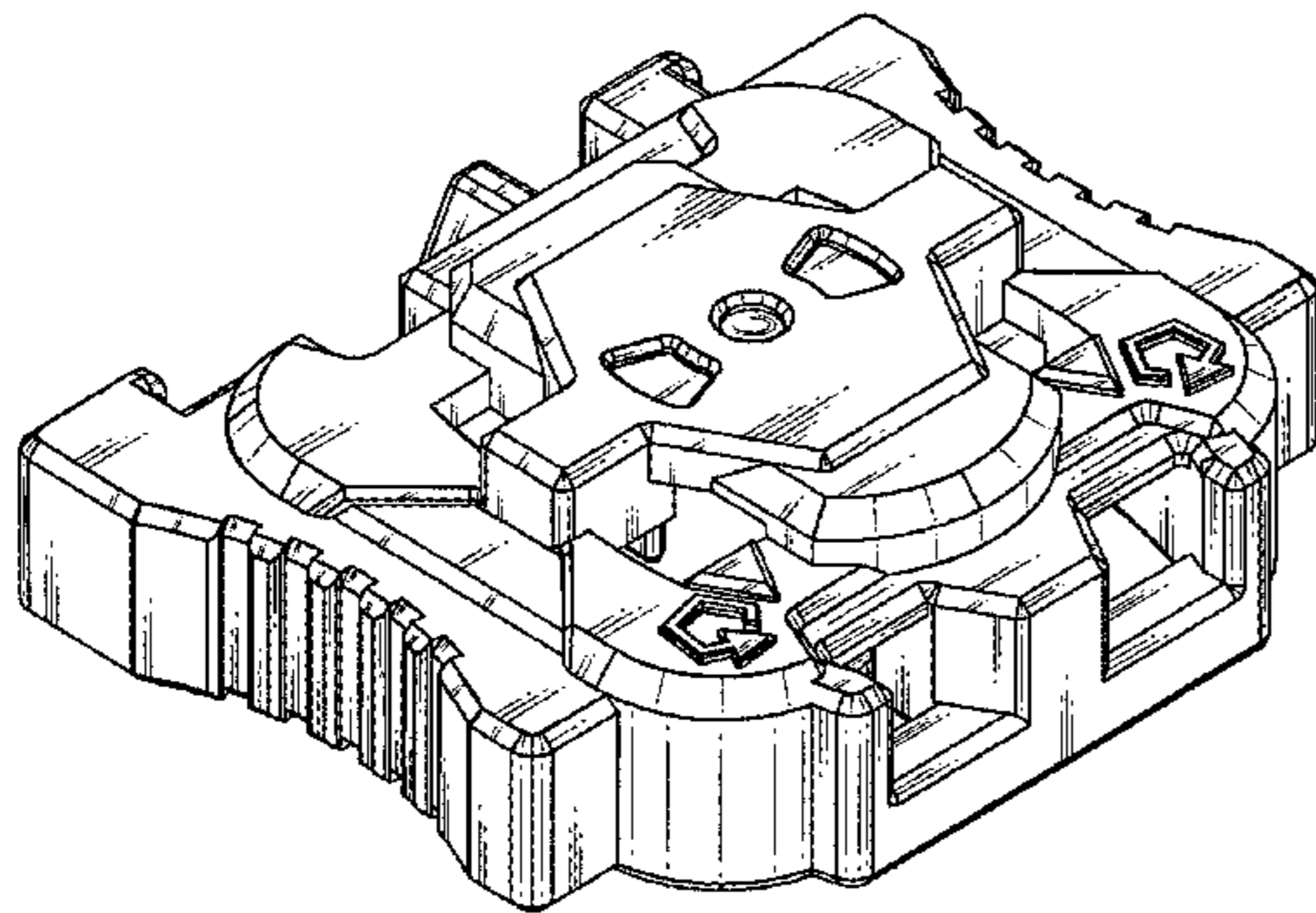
(57) **CLAIM**

The ornamental design for a launch apparatus for spinning top toy, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the launch apparatus for spinning top toy showing my design;

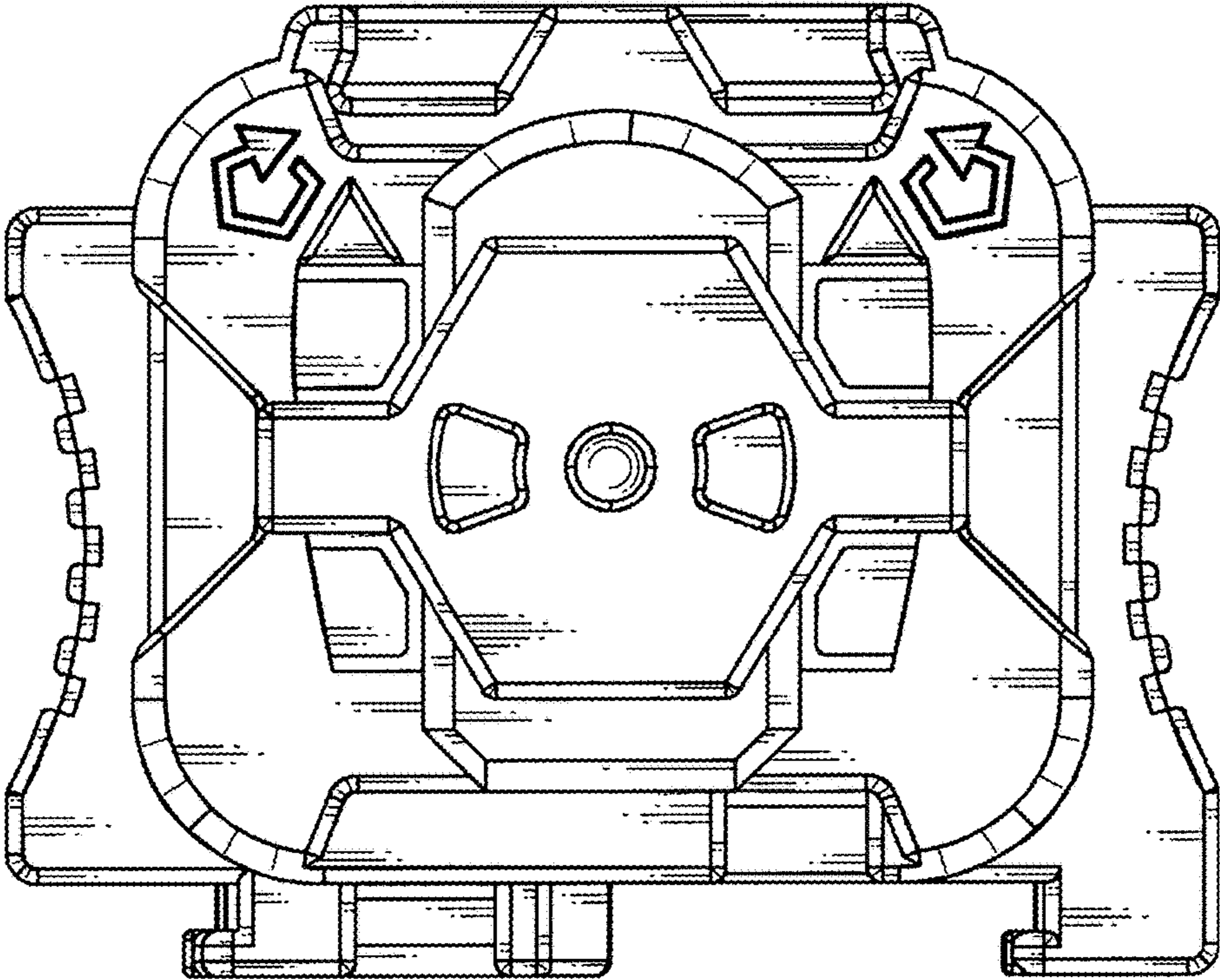

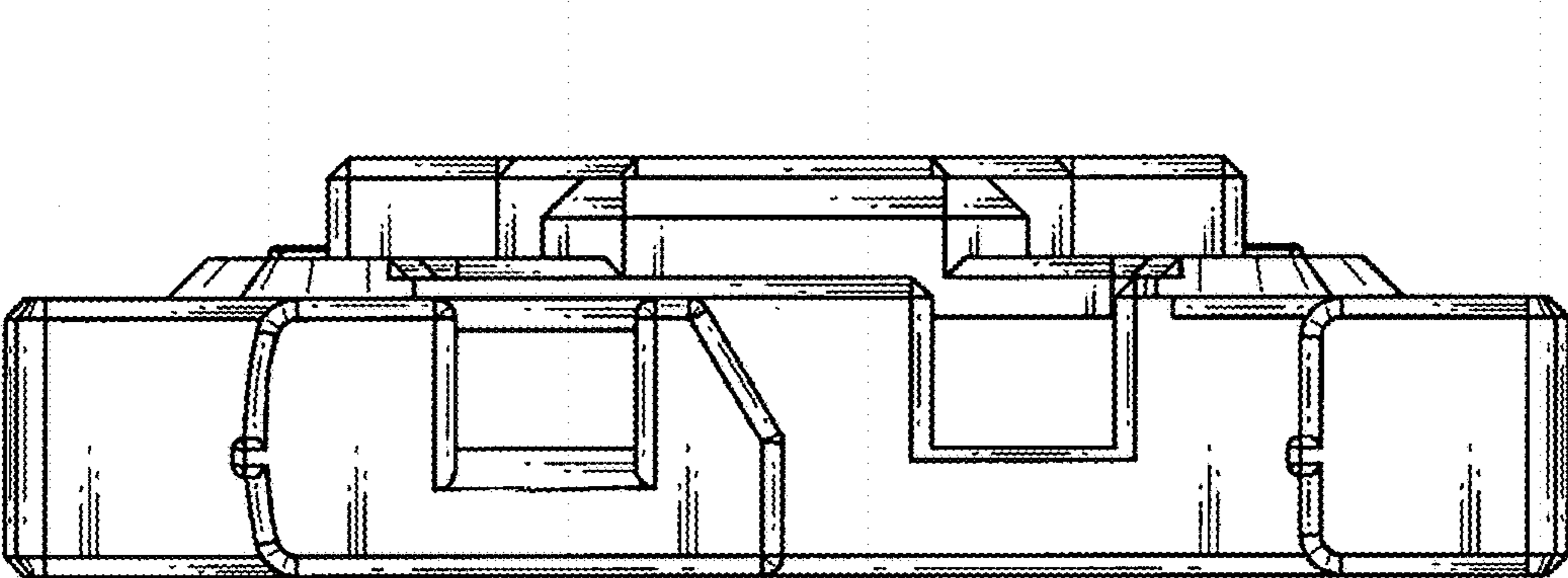

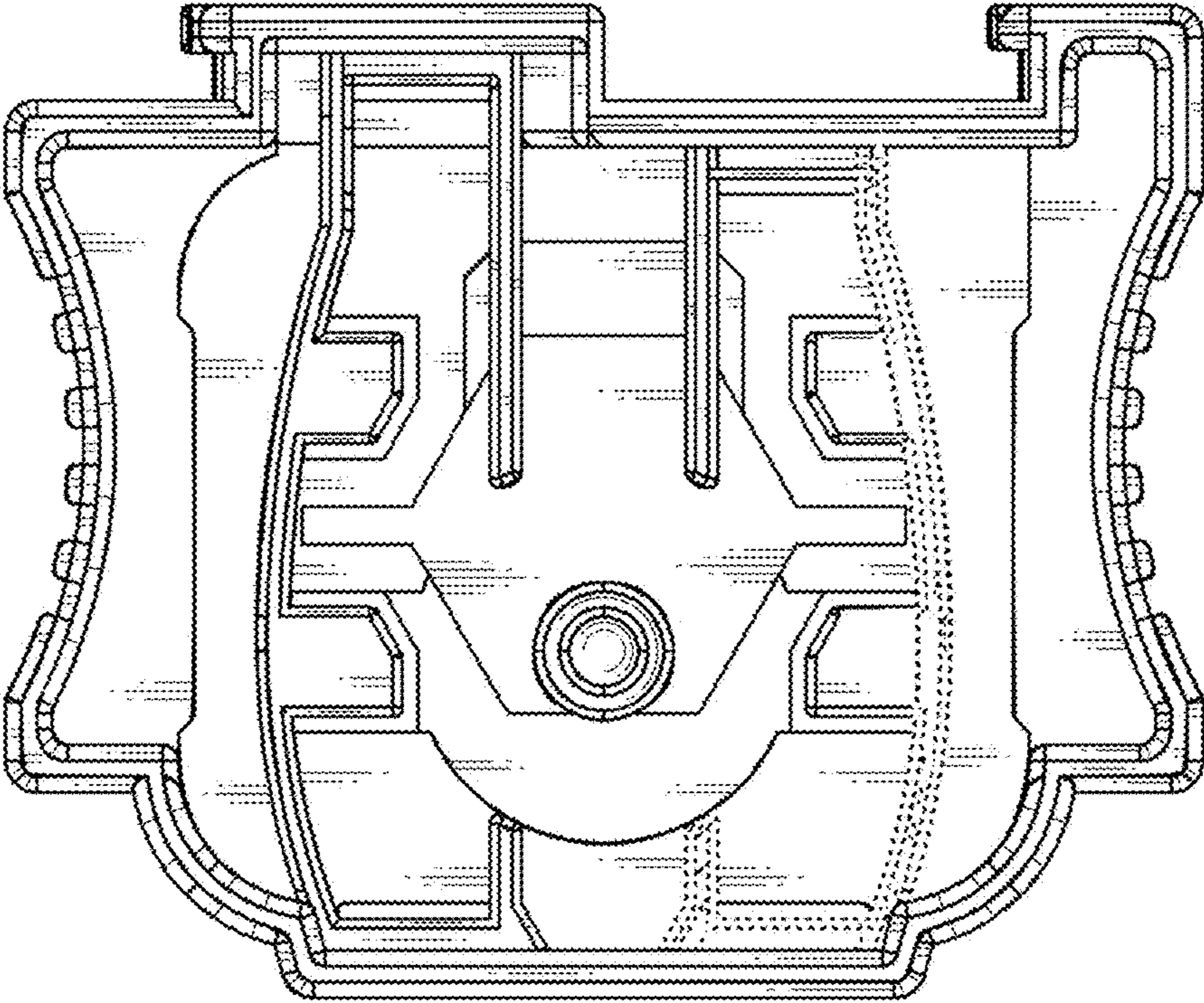

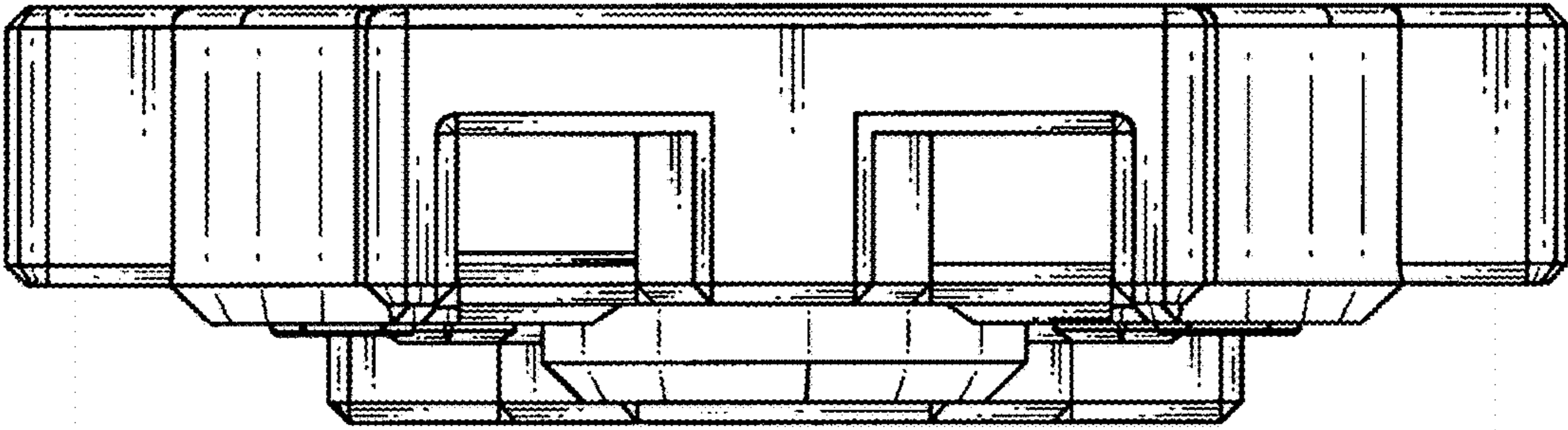

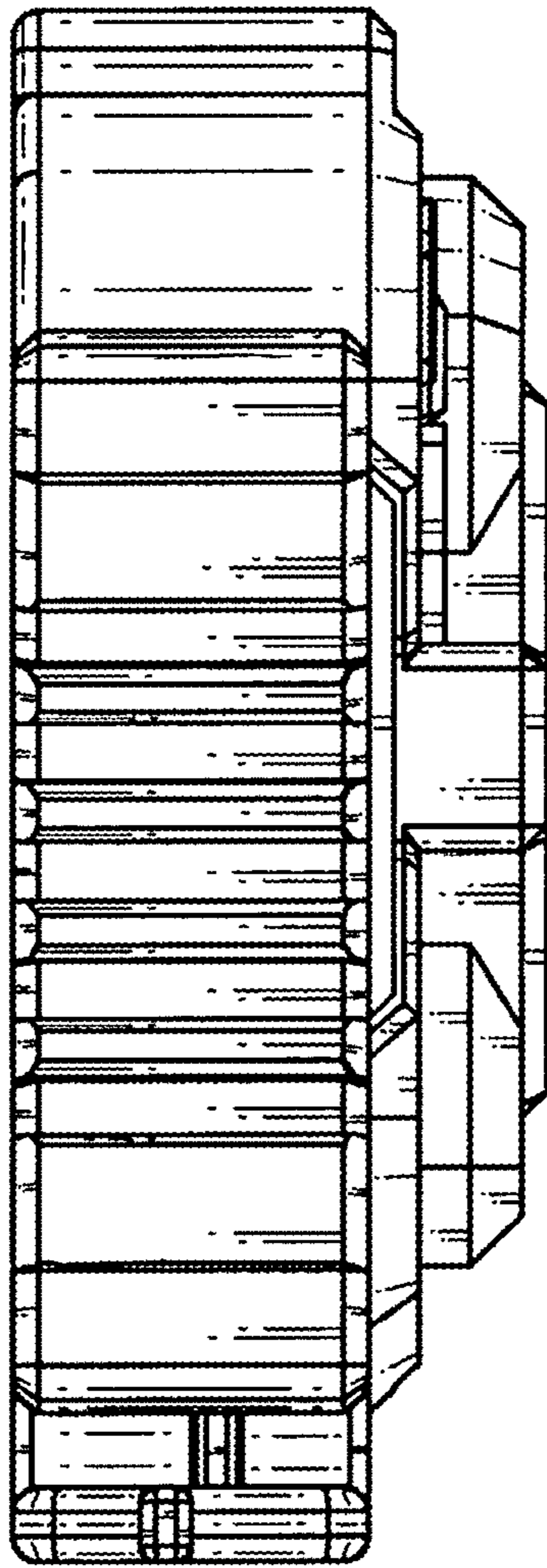

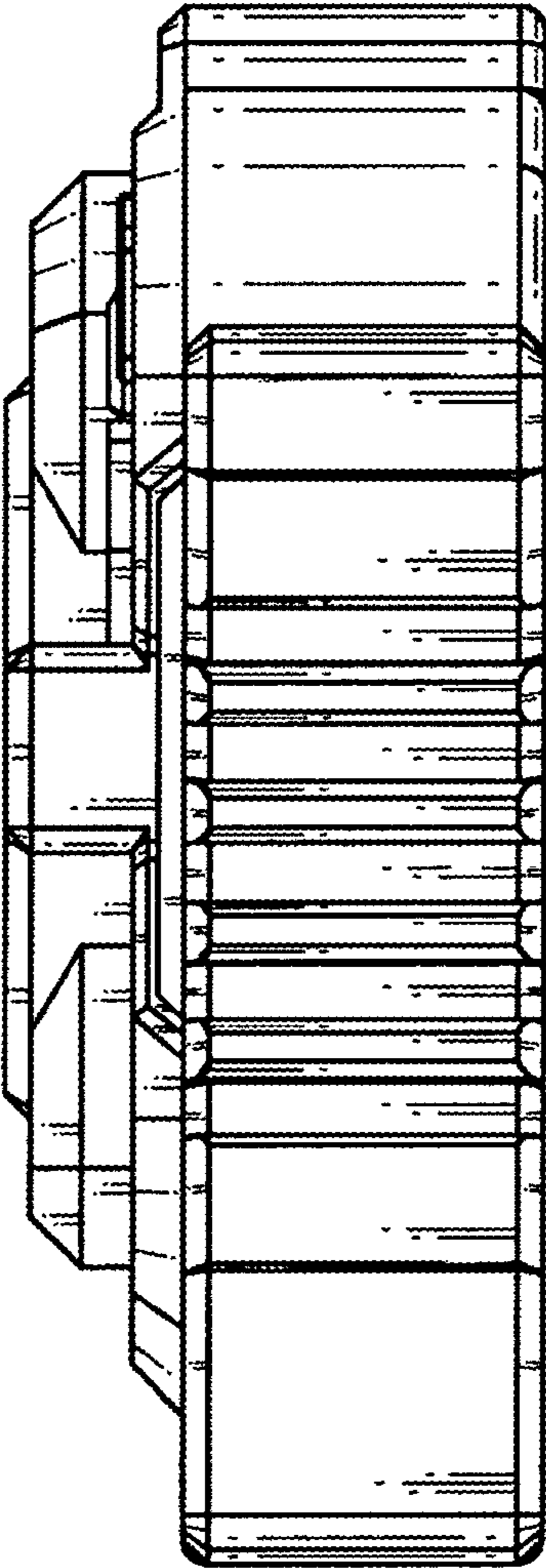

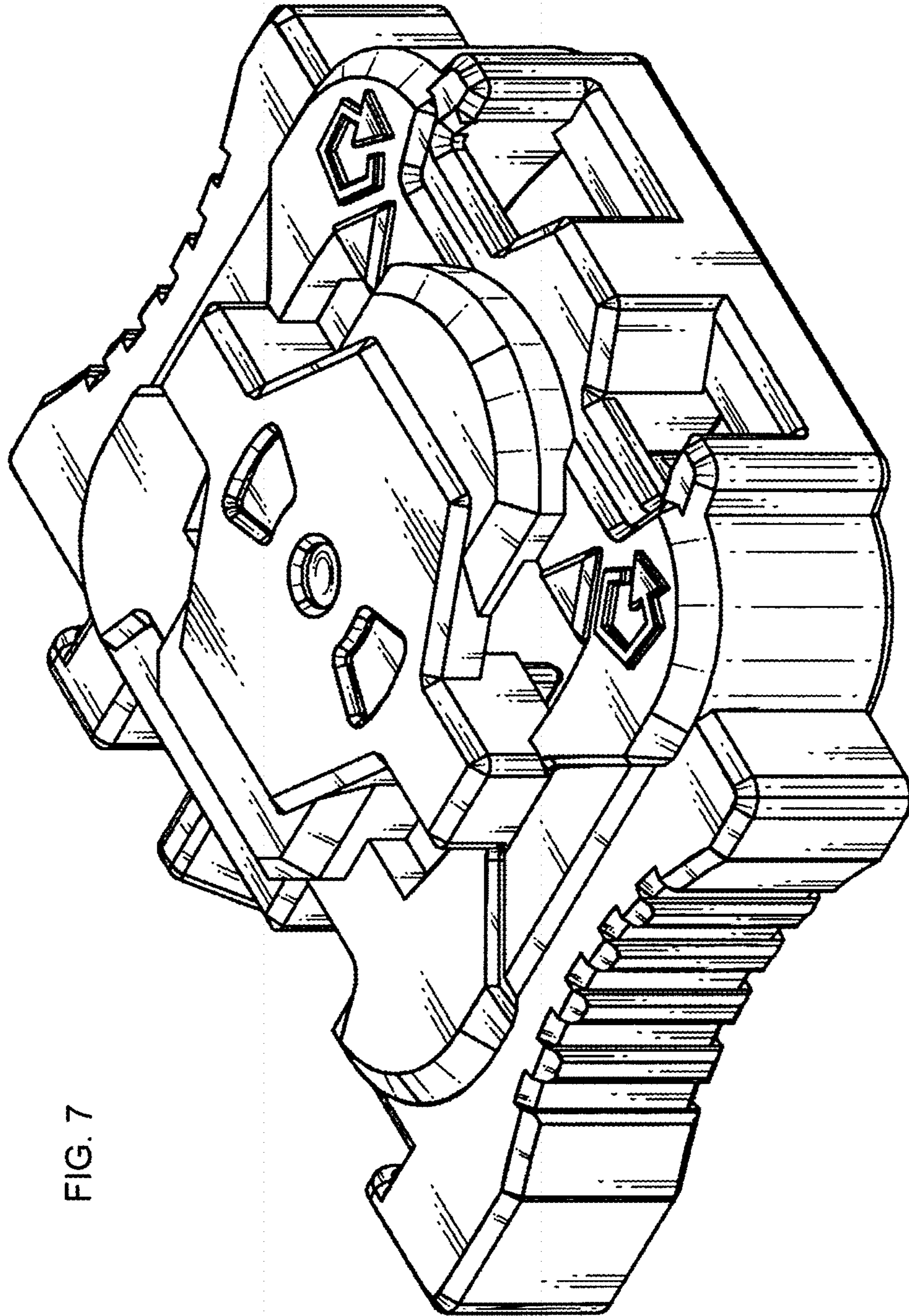

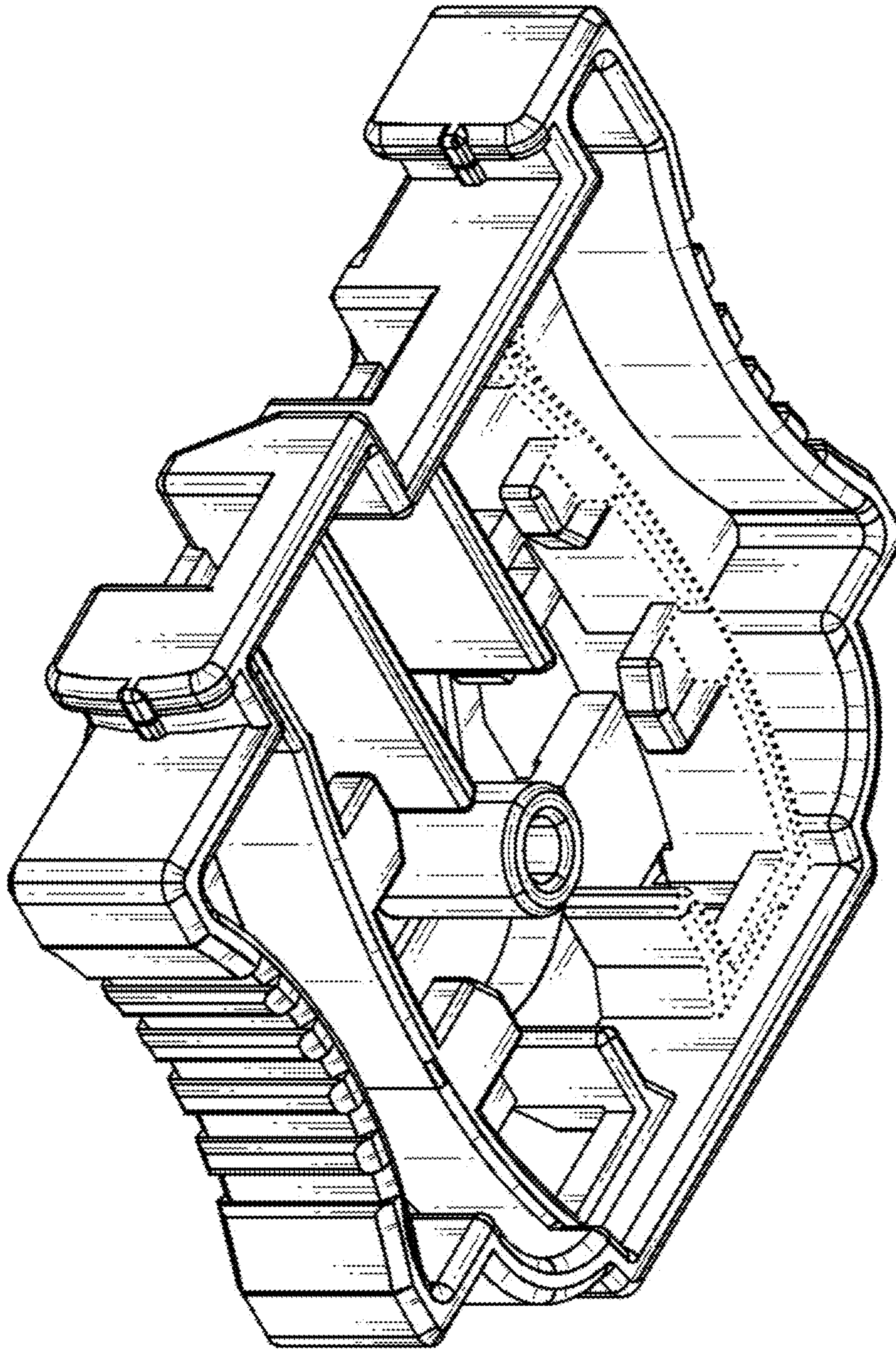
