FIG. 5 is a left side end view thereof.

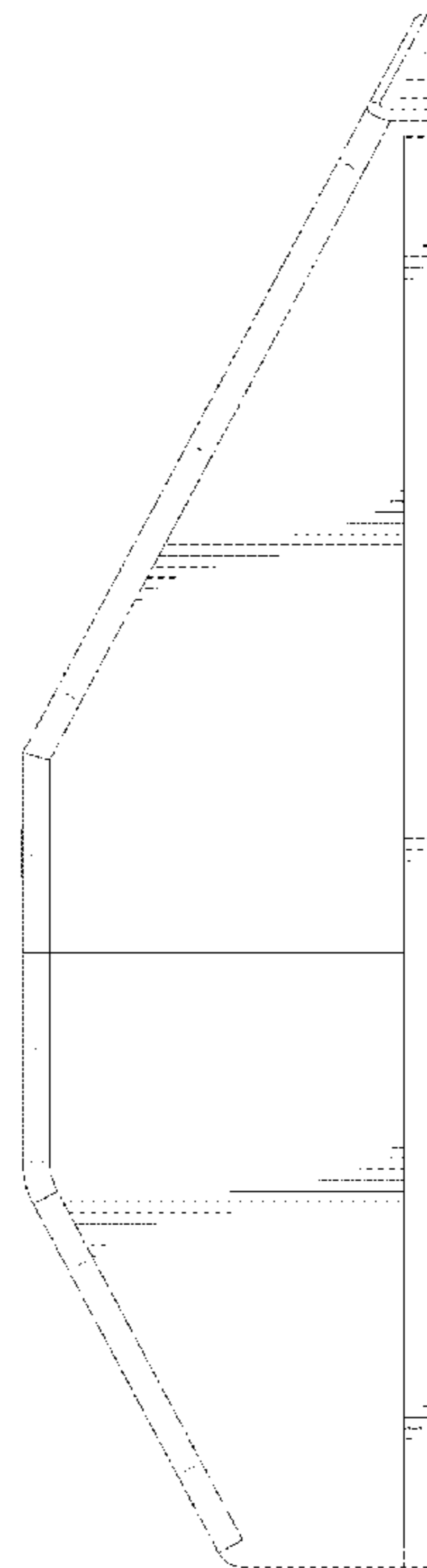
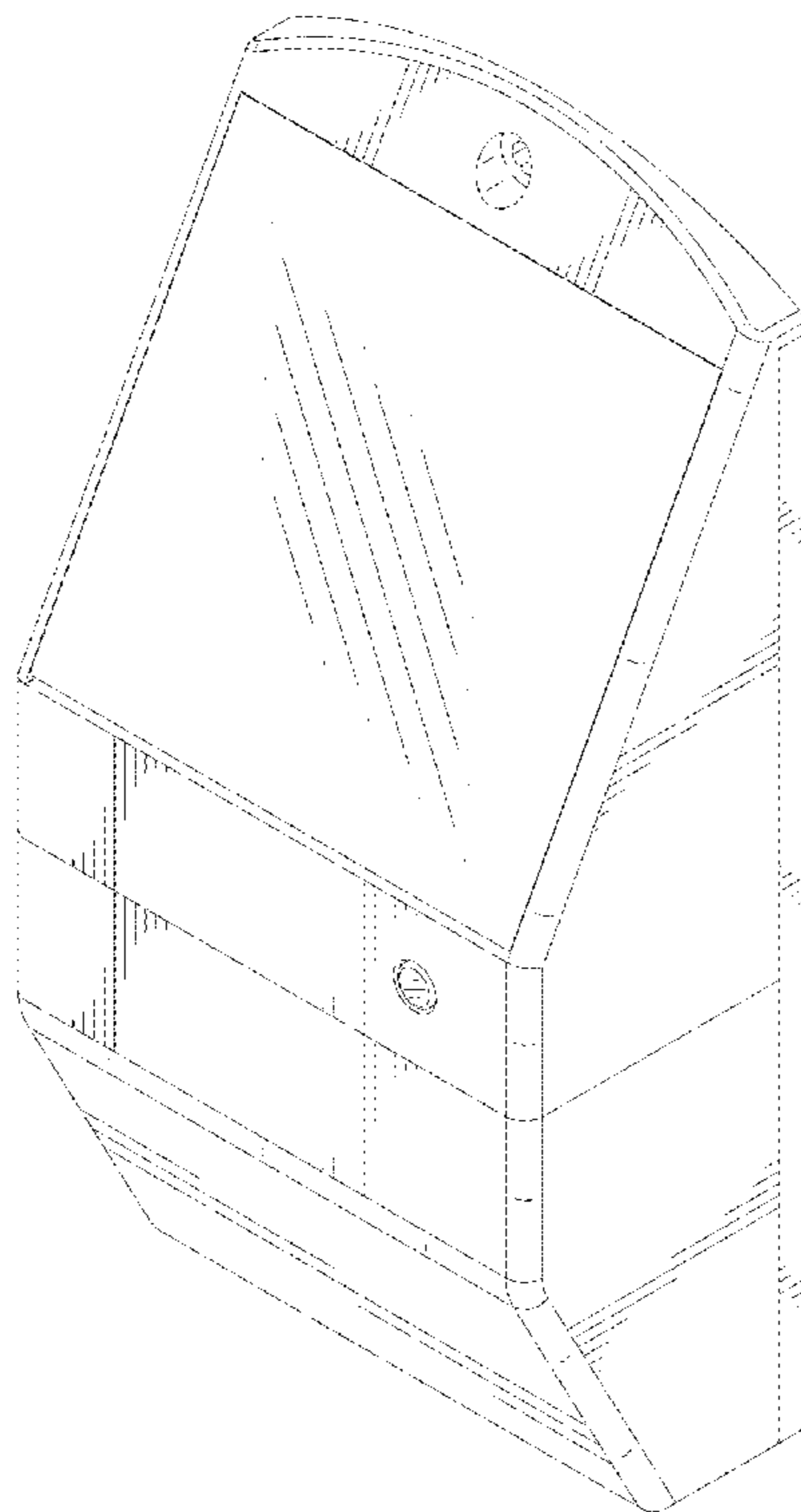
FIG. 6 is a right side end view thereof.

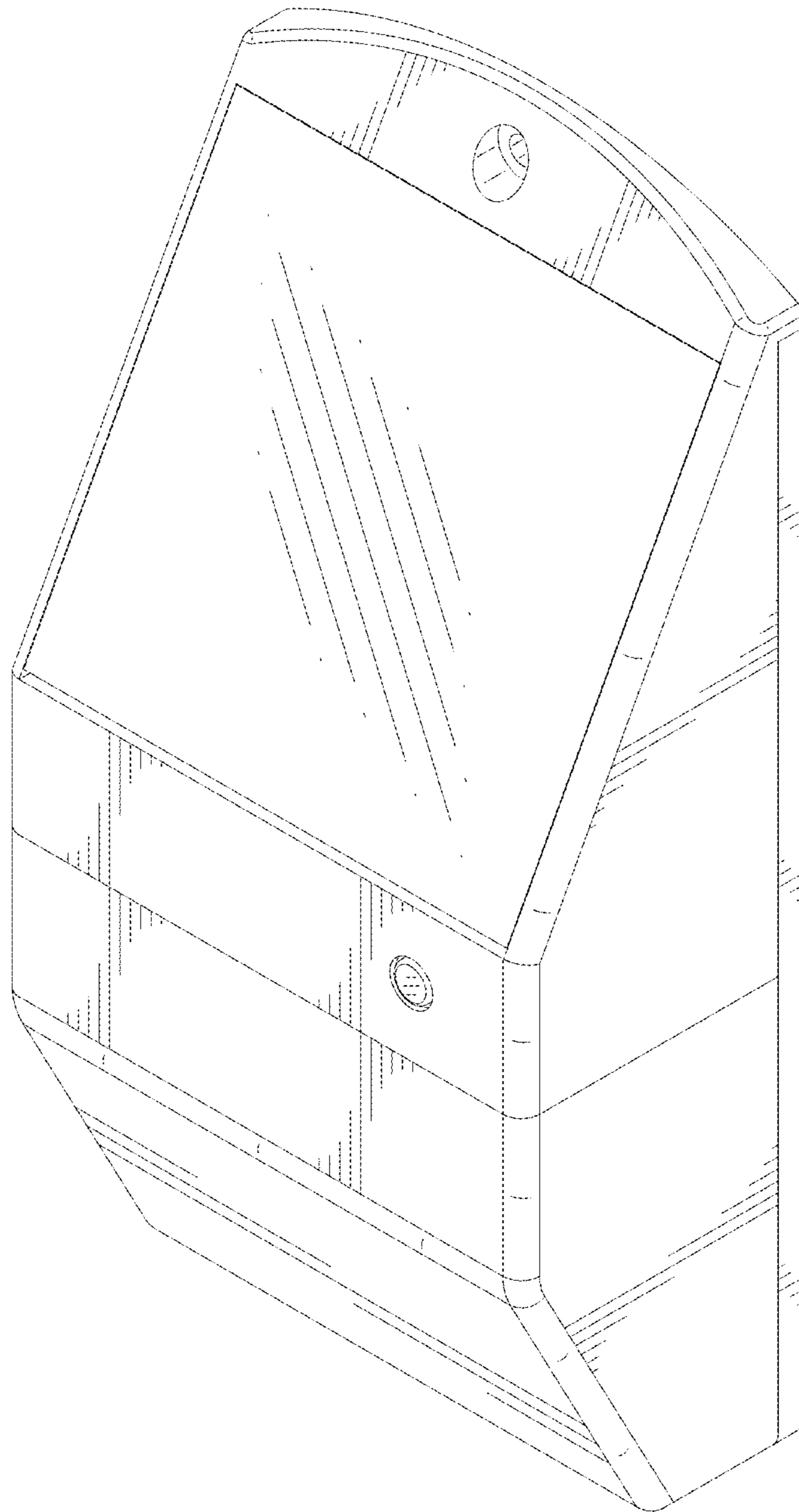

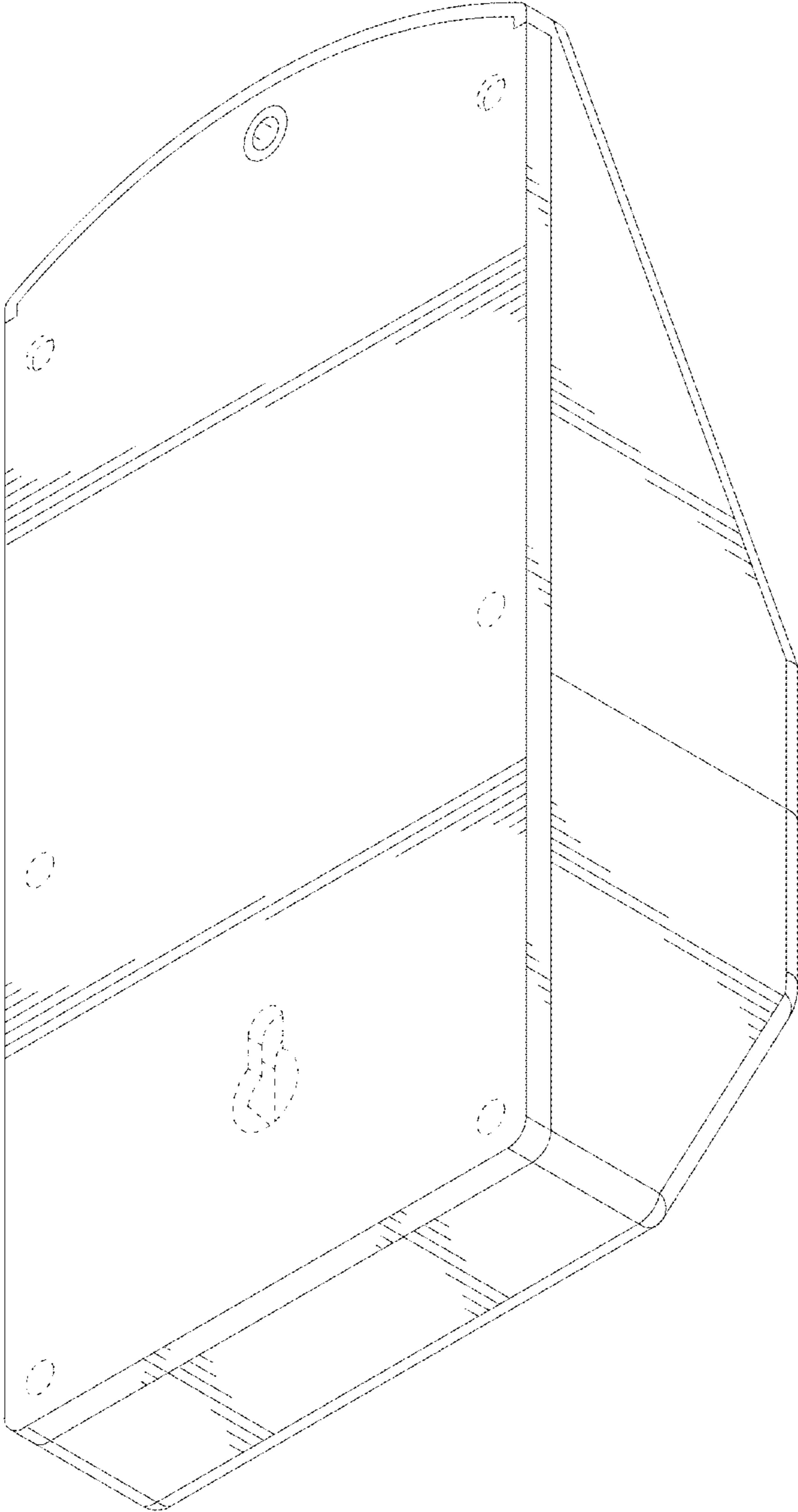

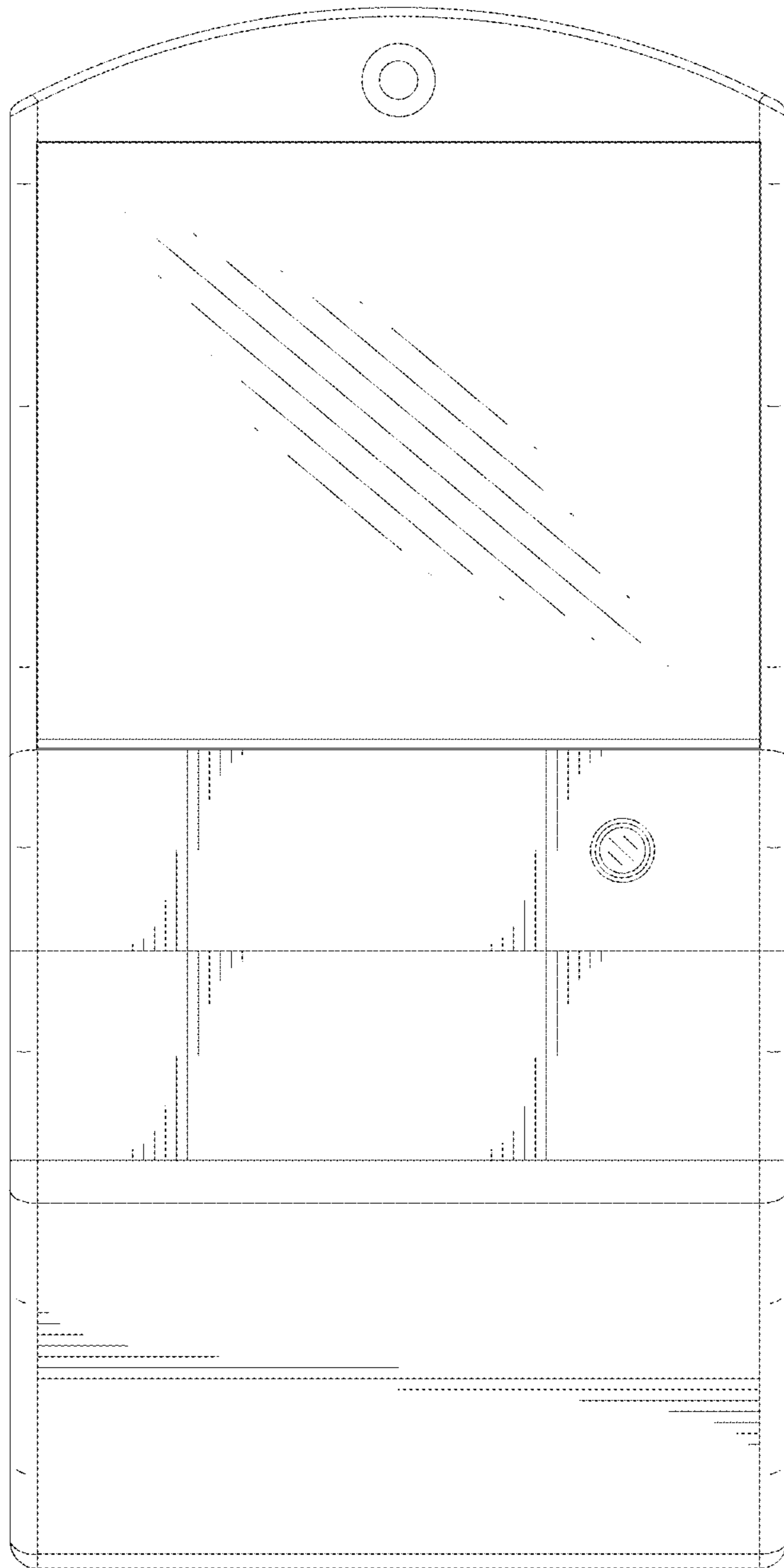

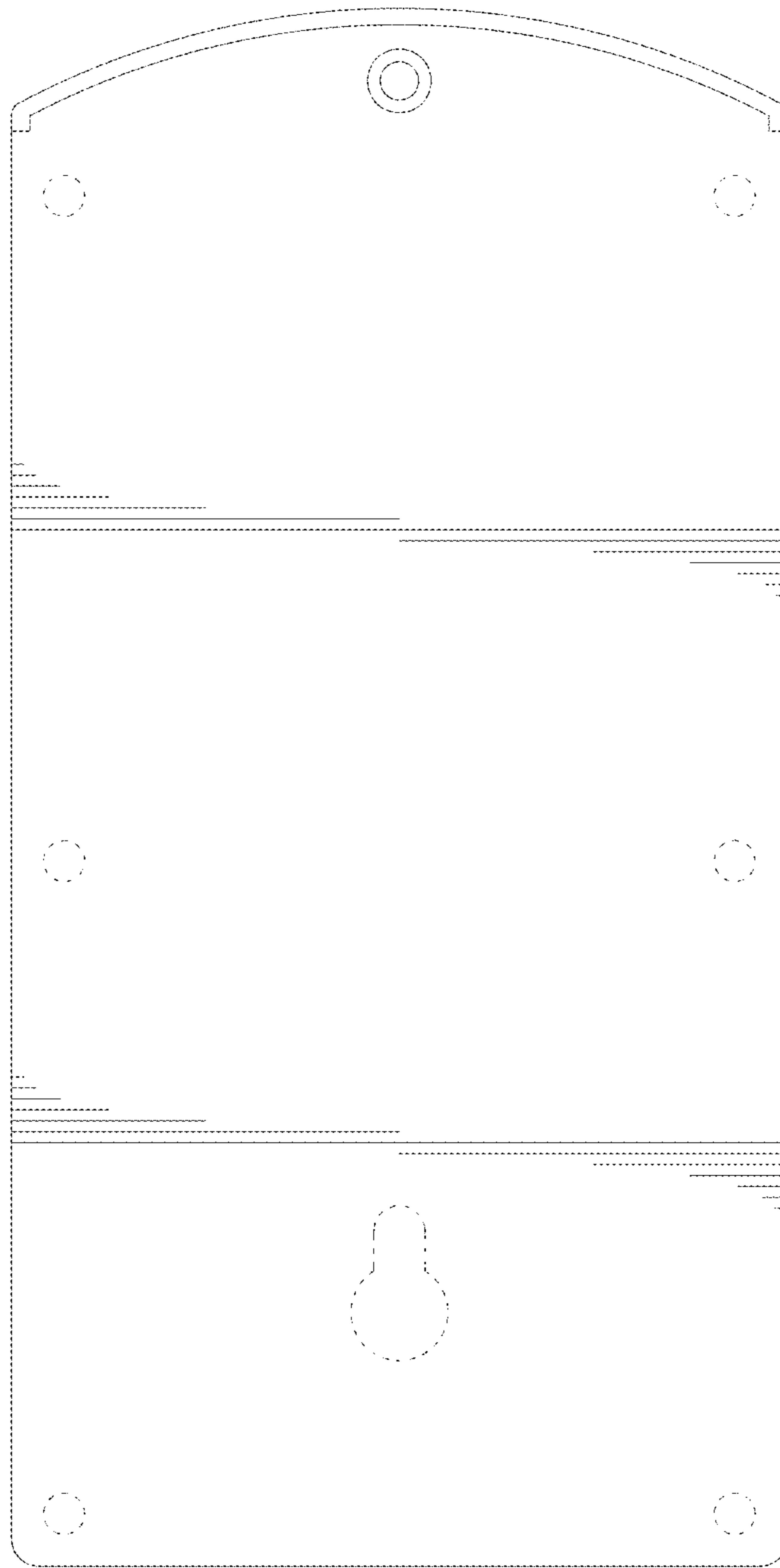

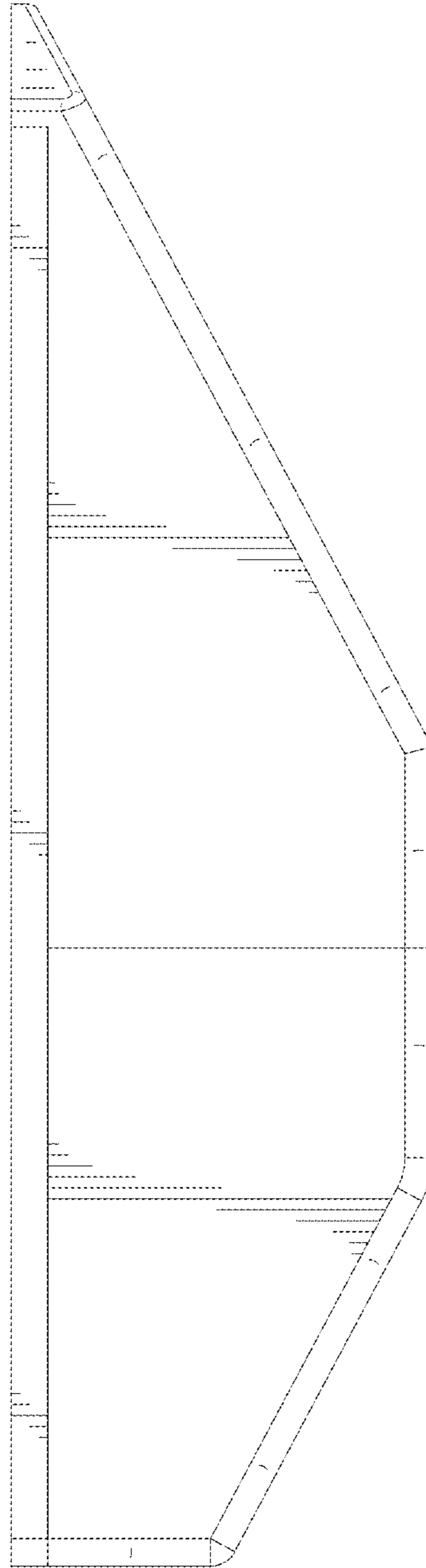

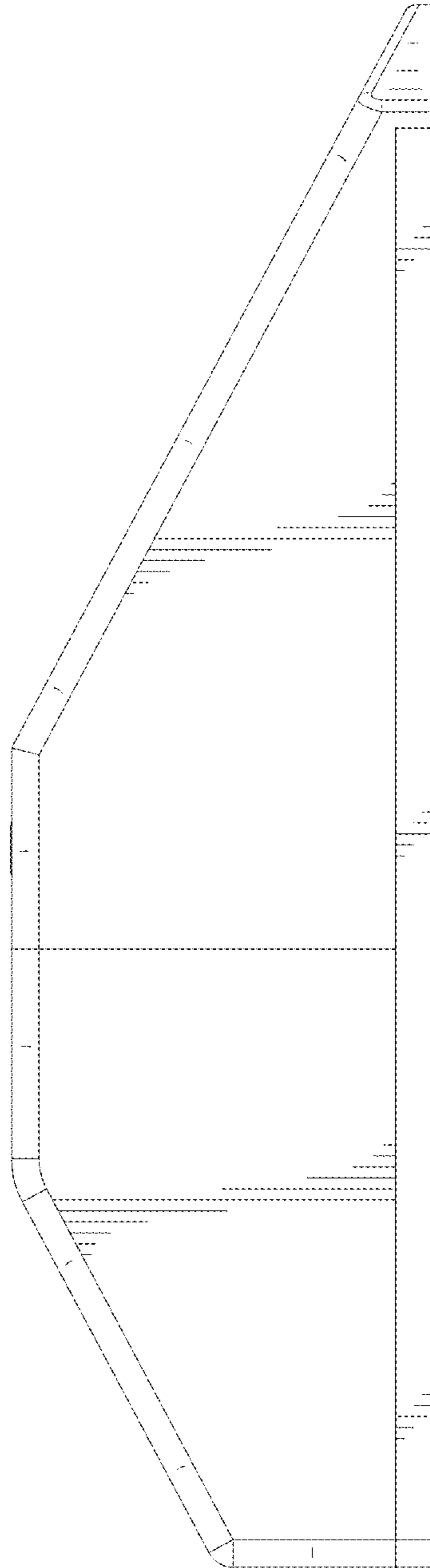

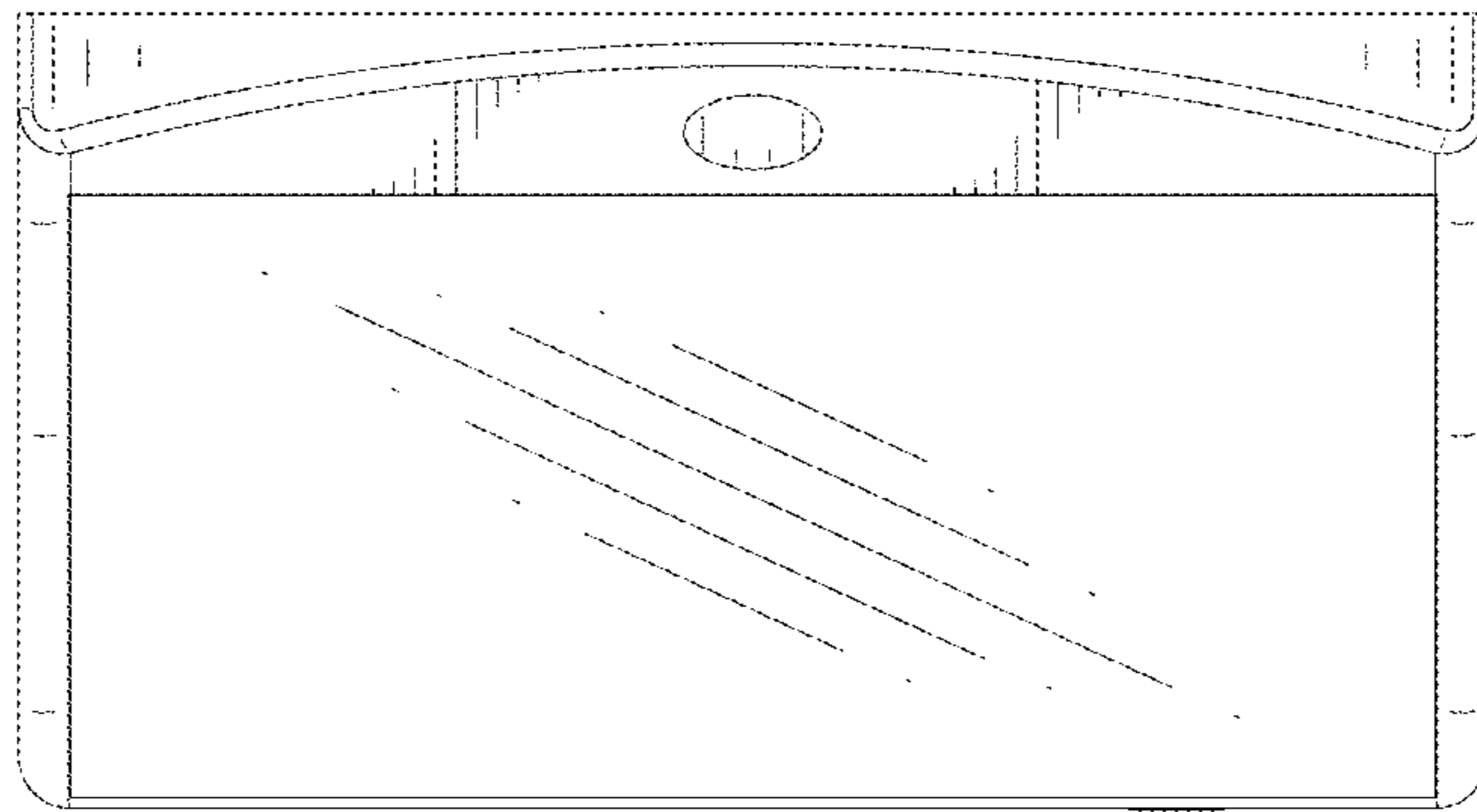

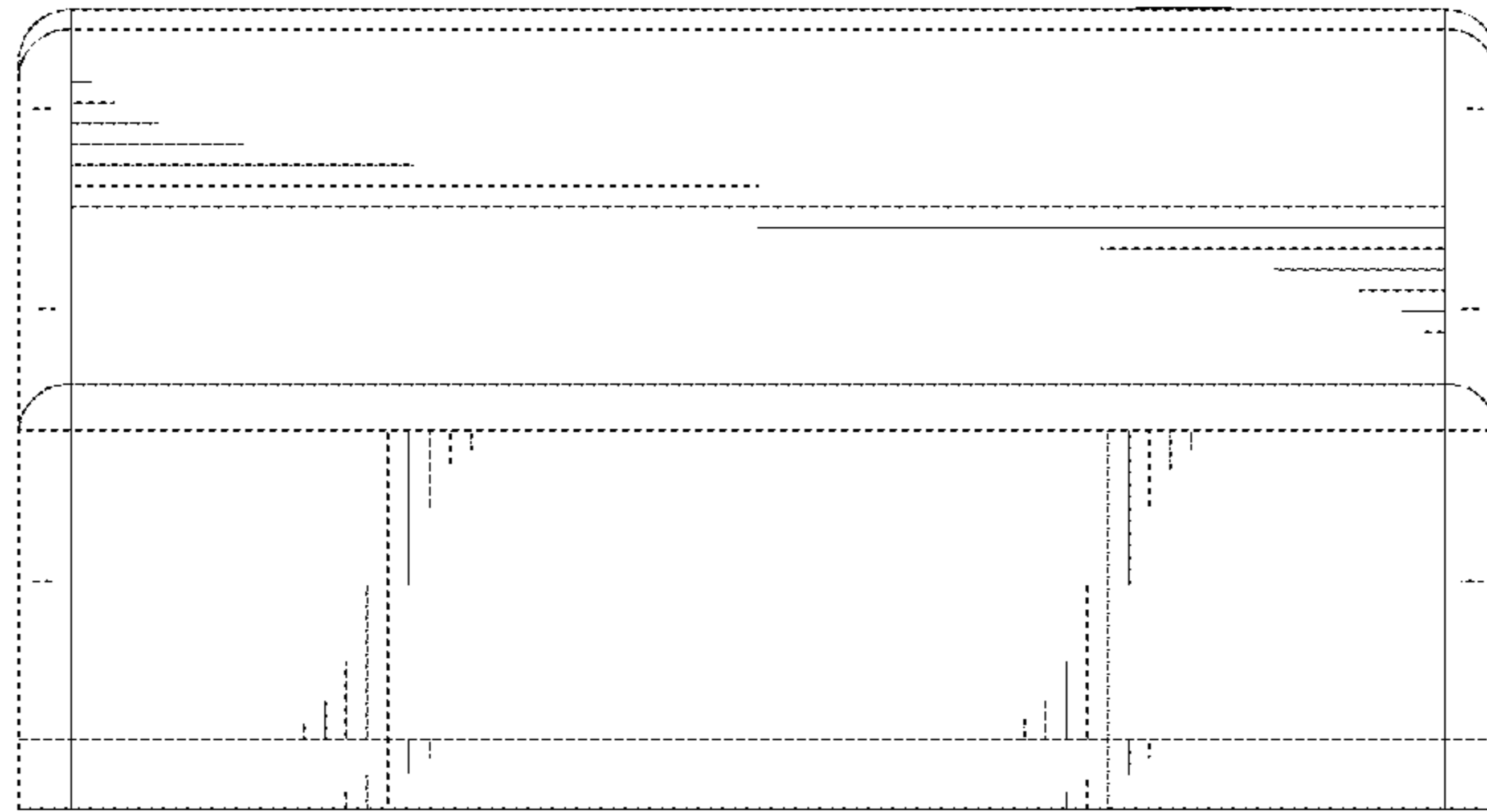
