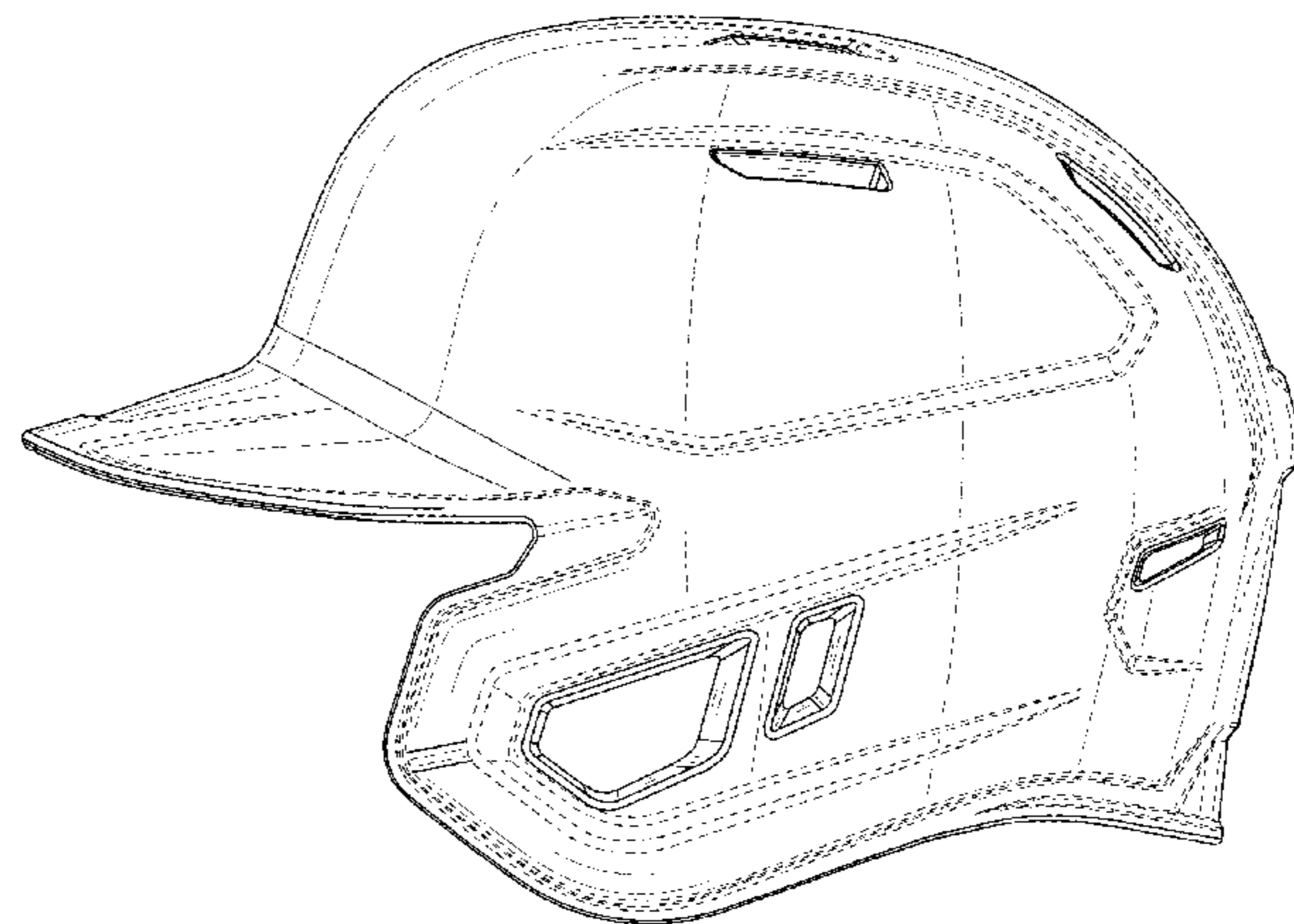
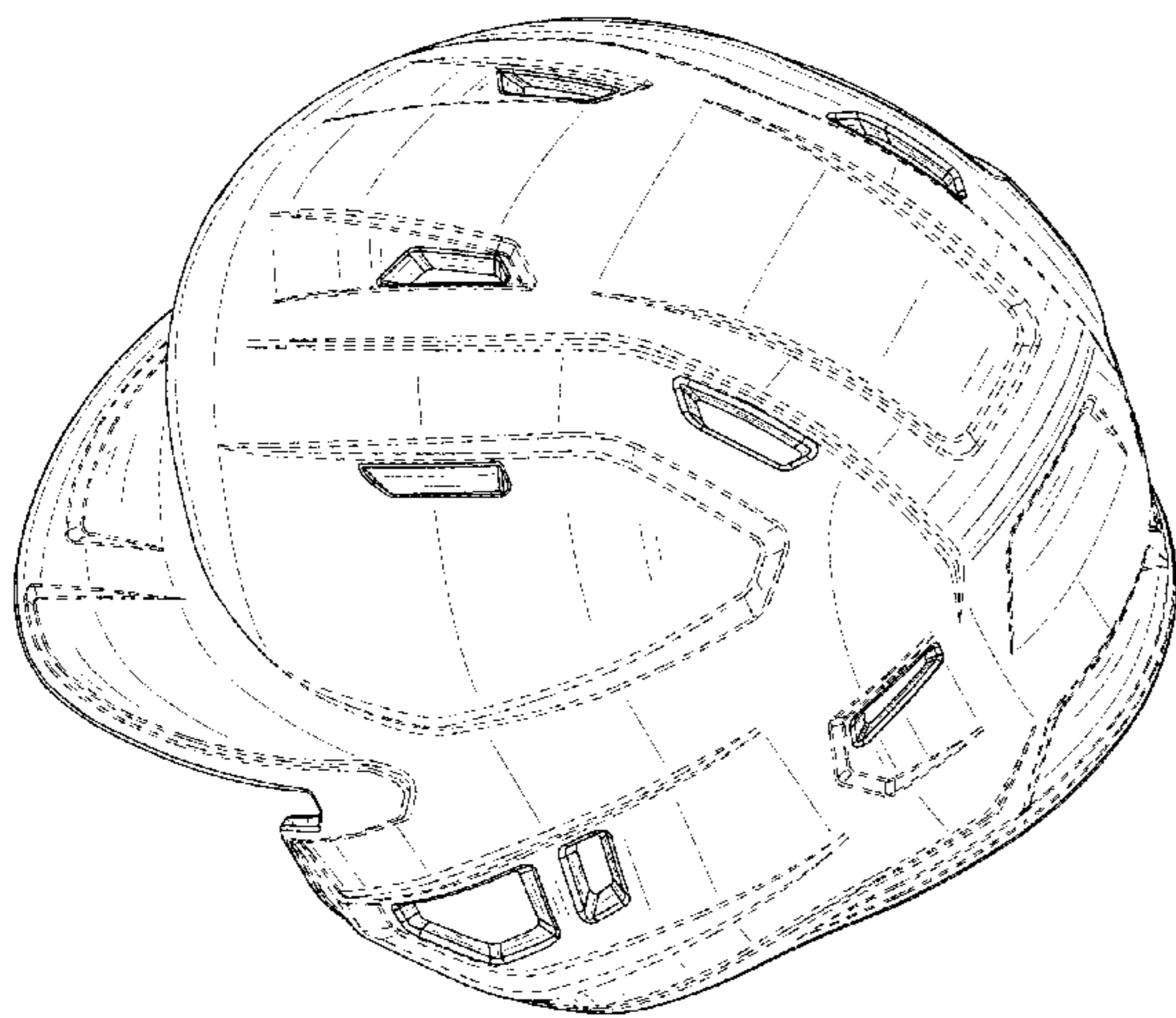
The ornamental design for a baseball helmet, as shown and described.

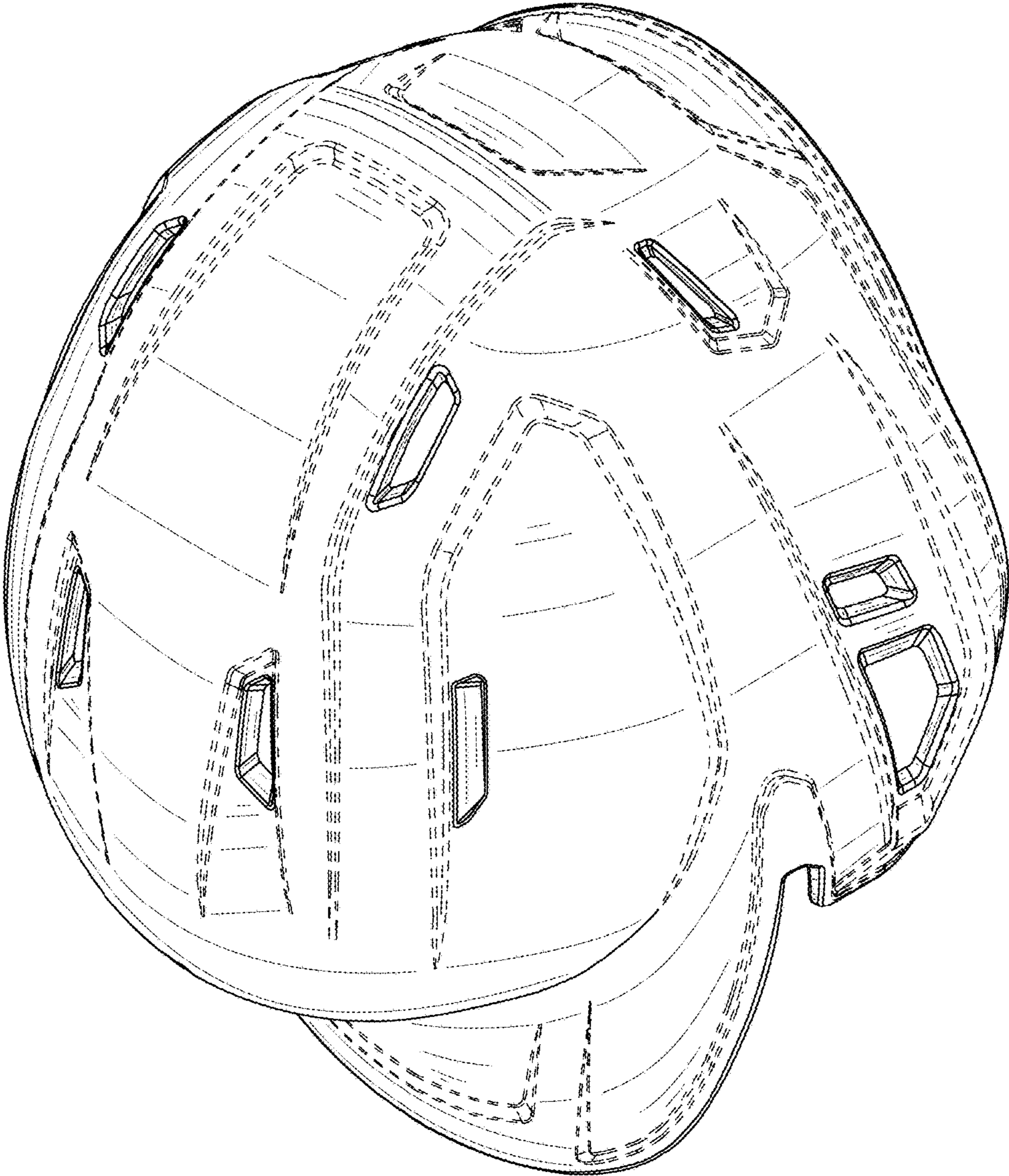

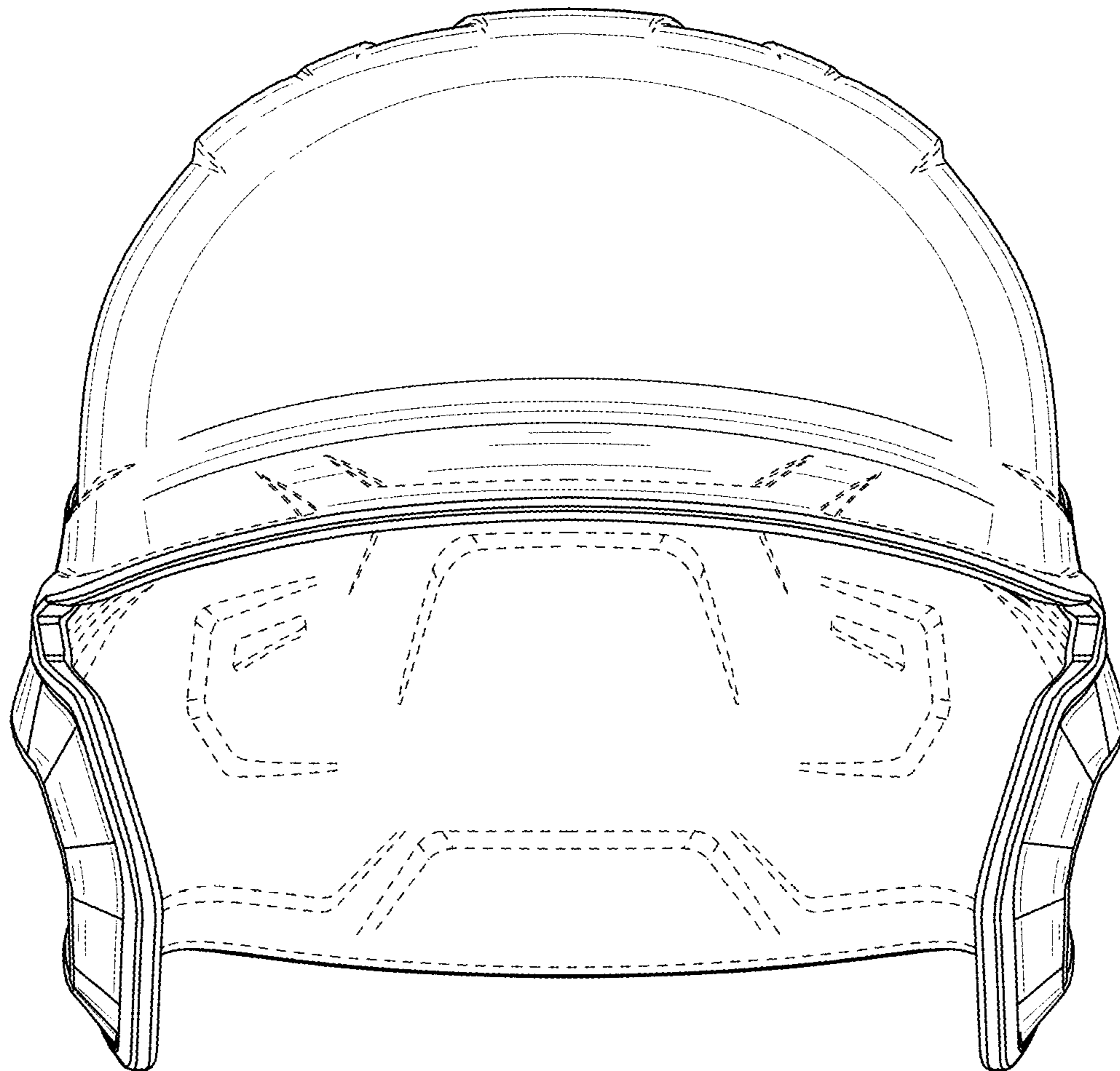

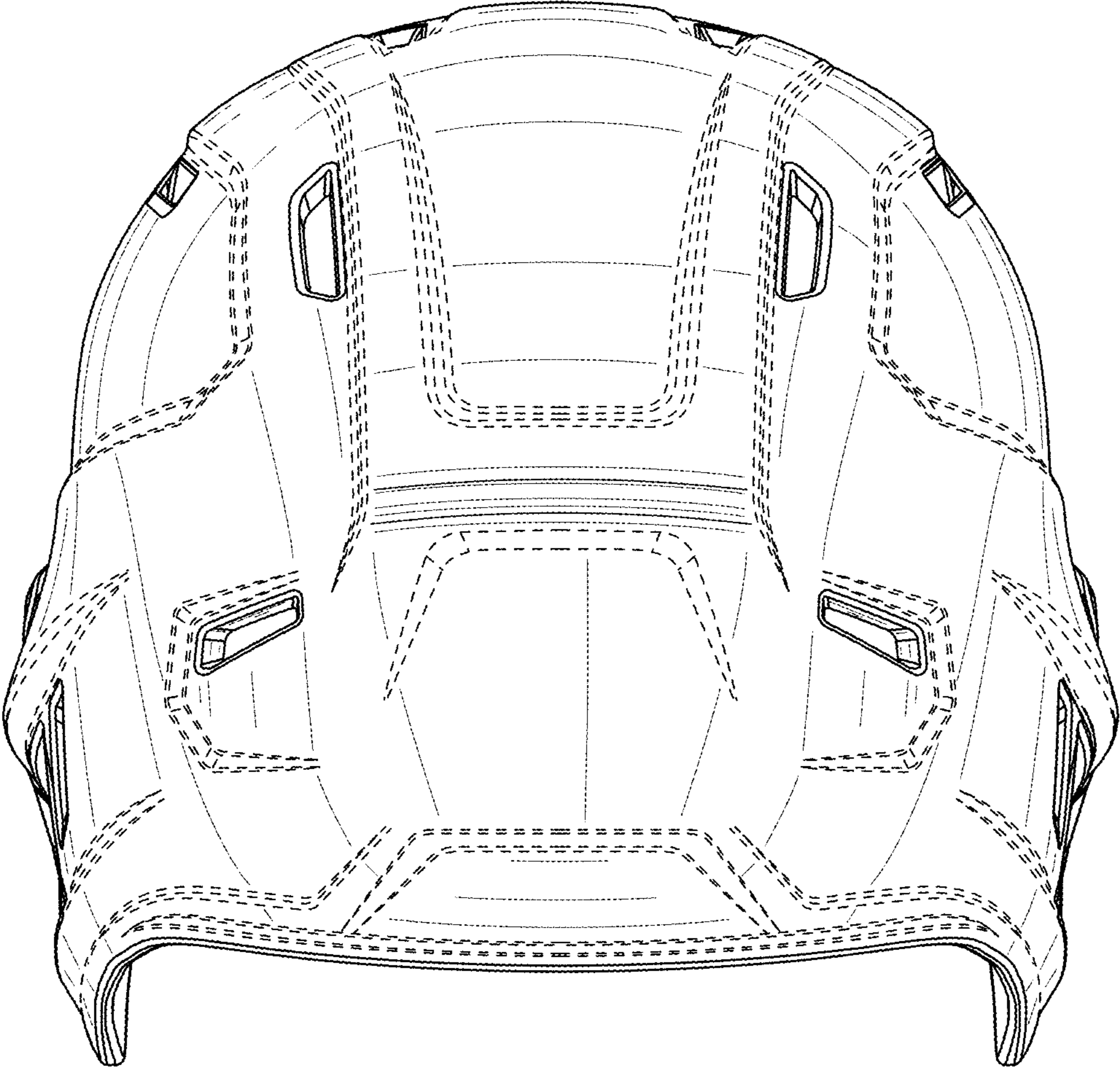

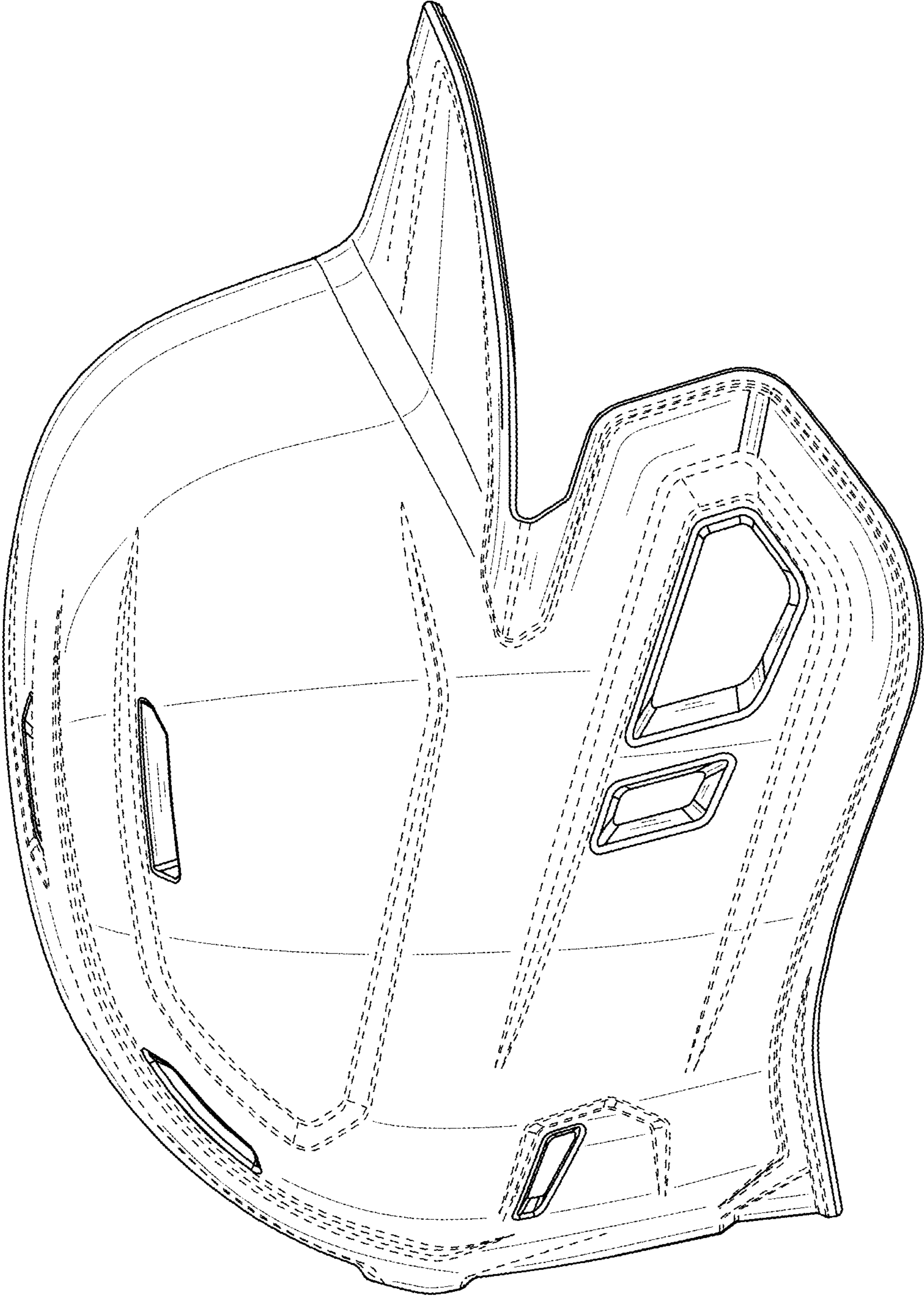

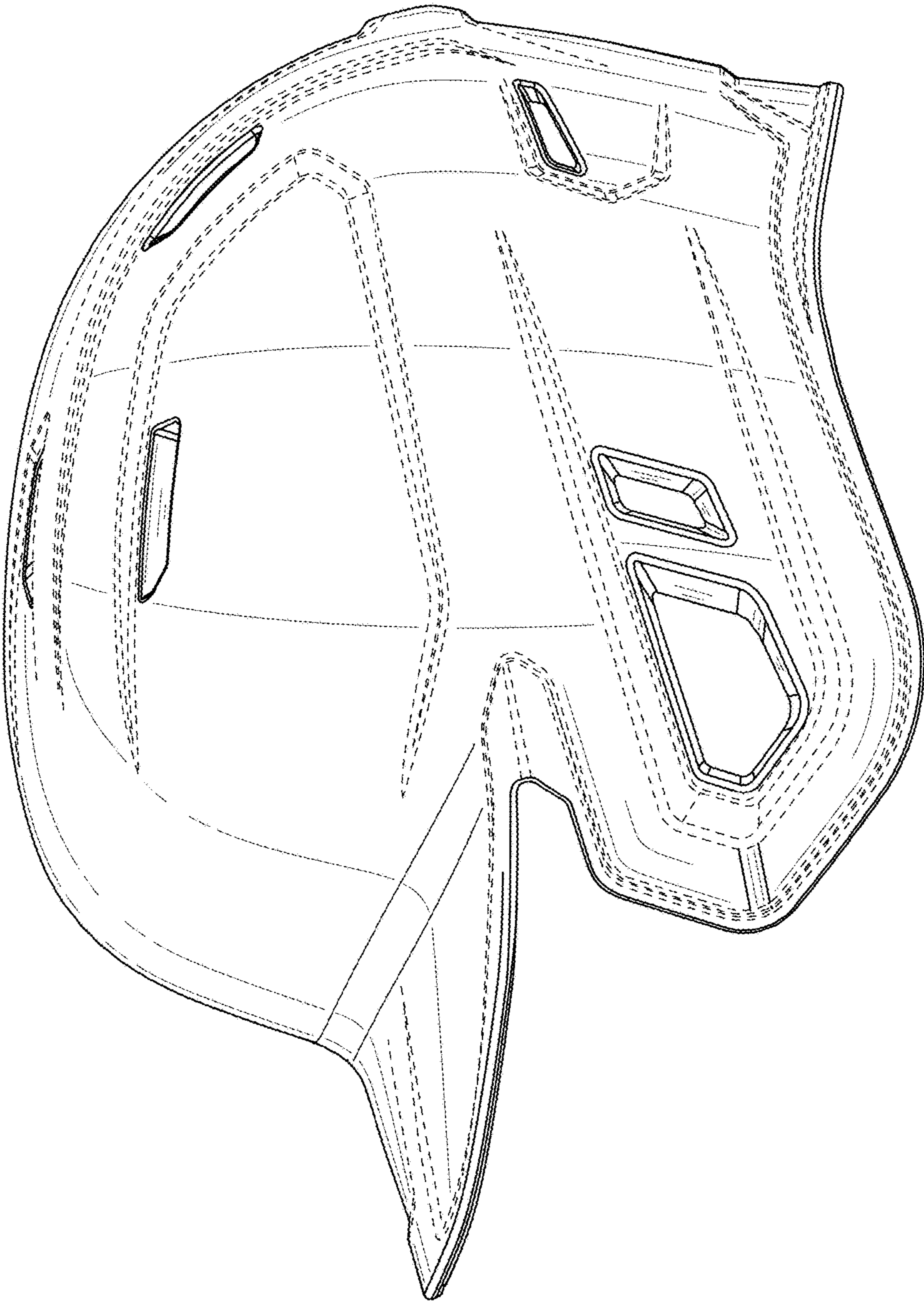

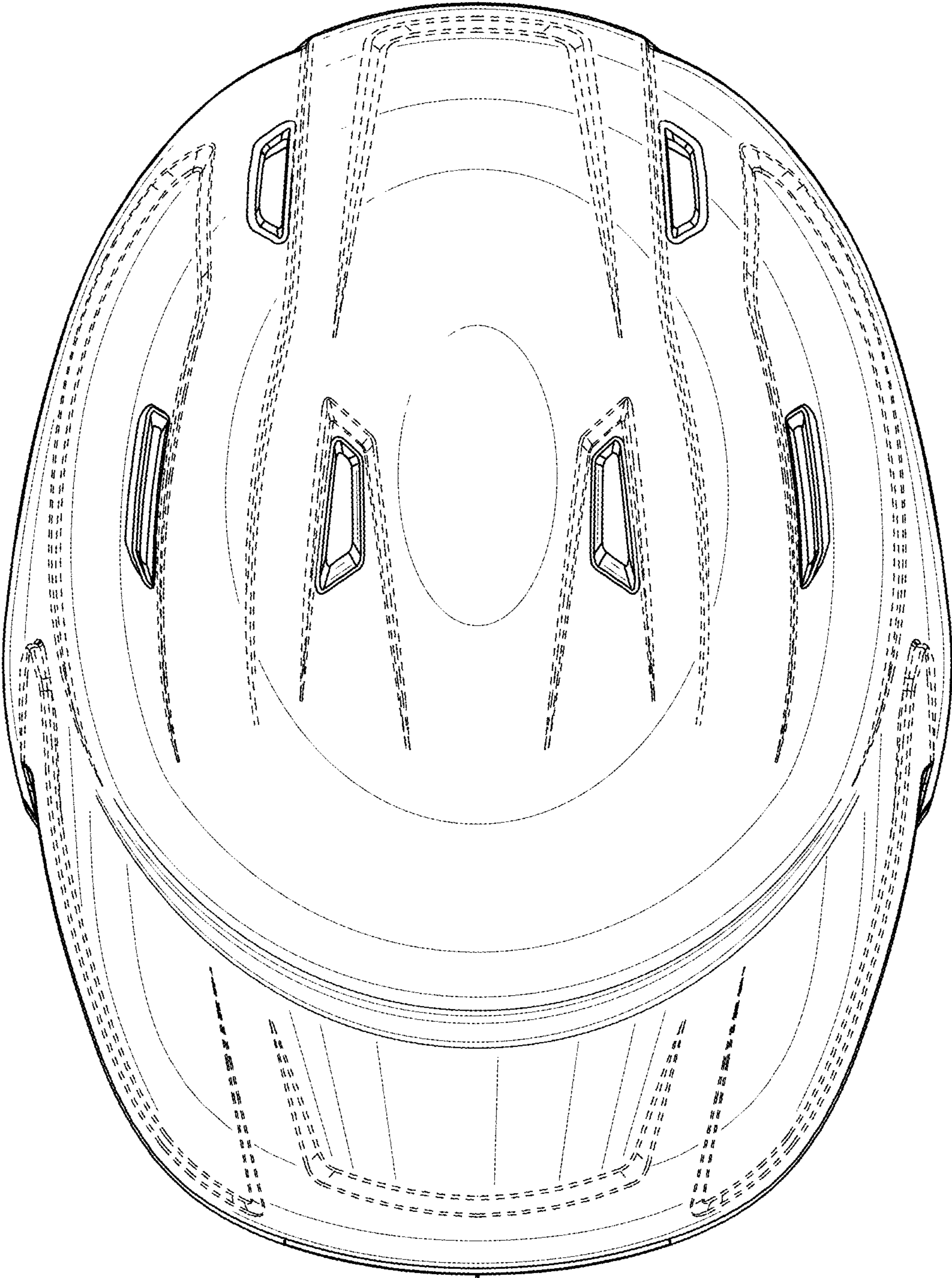
