DESCRIPTION

FIG. 1 is a front right perspective view for a light illuminating T-shirt, showing my new design;

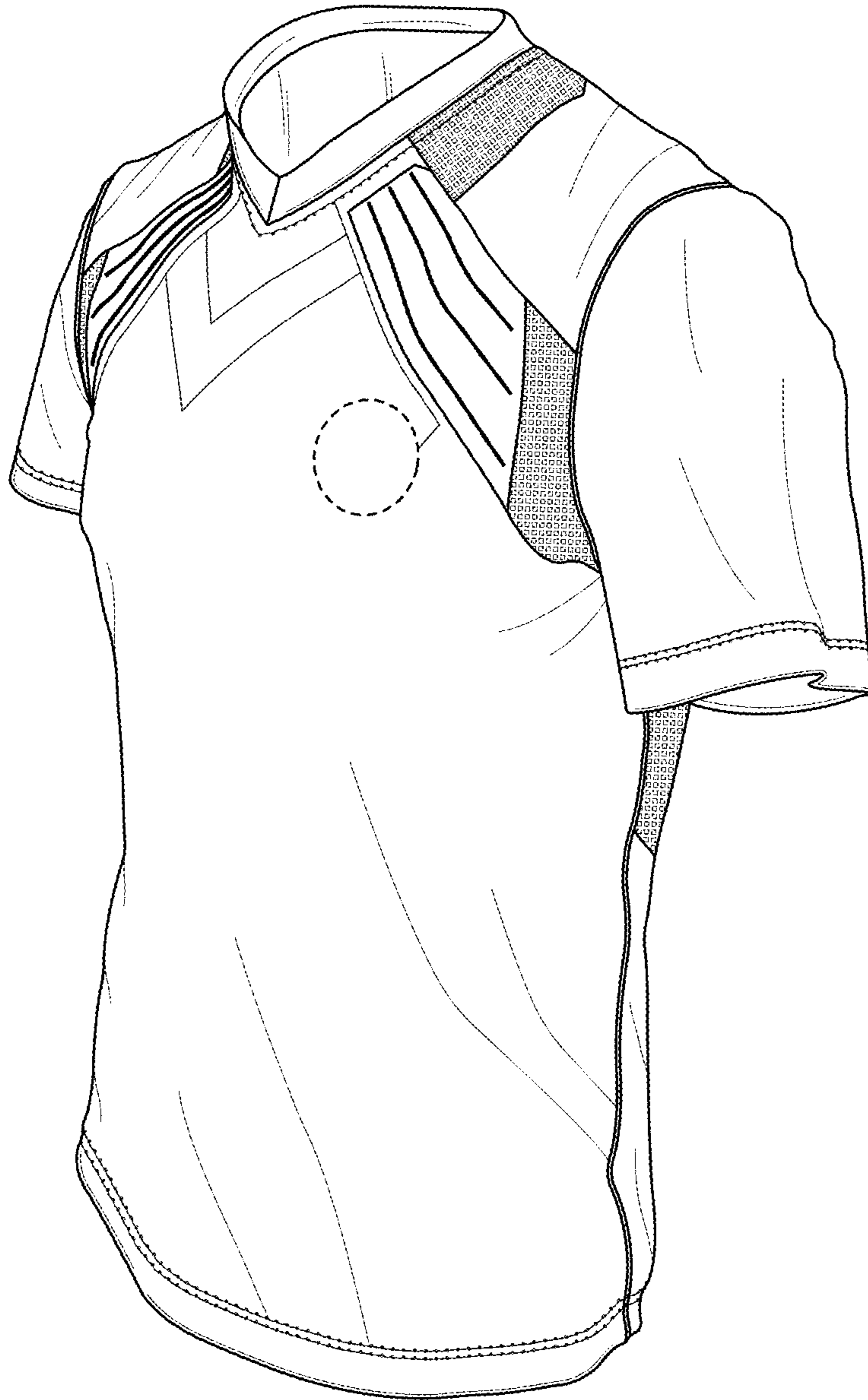

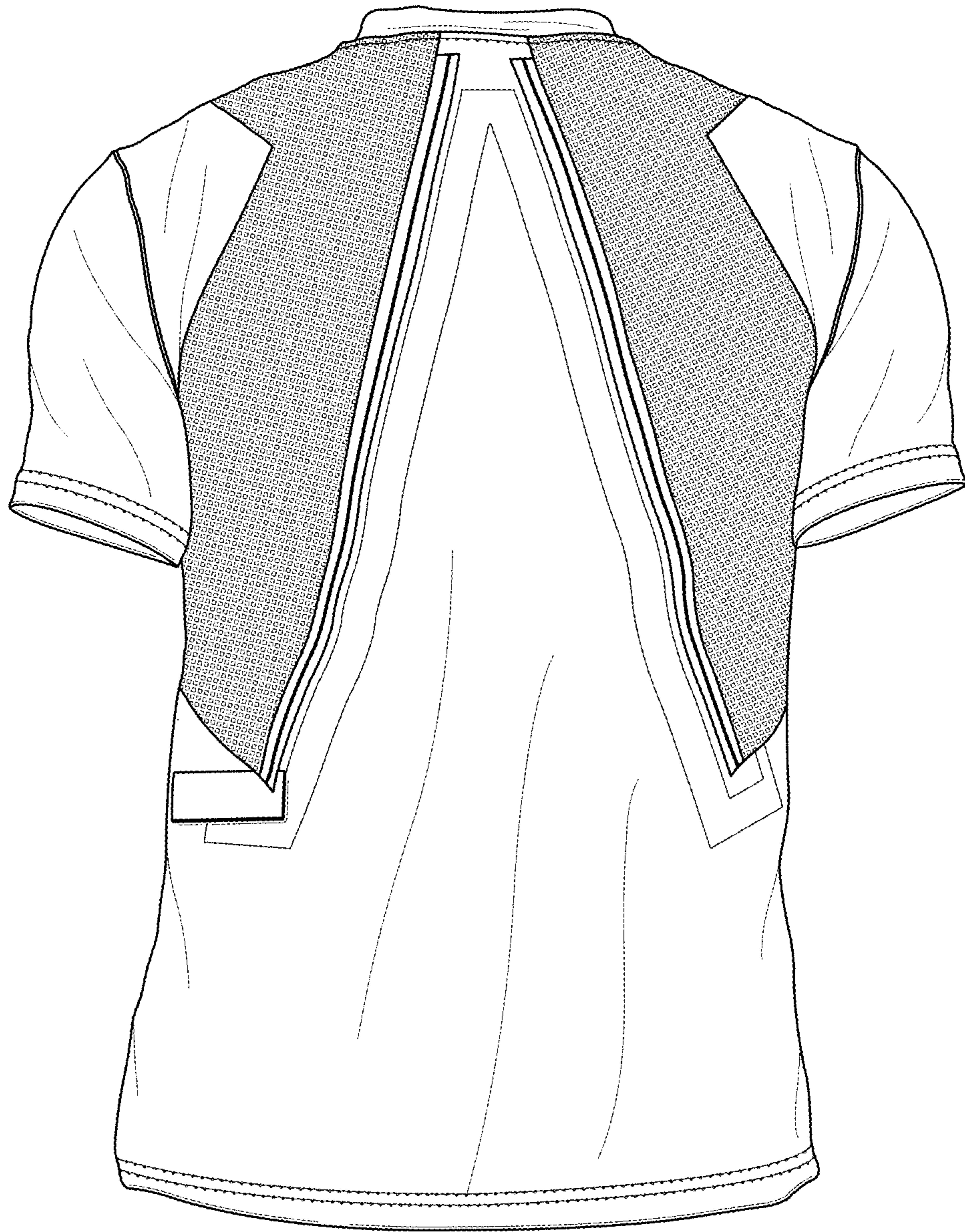

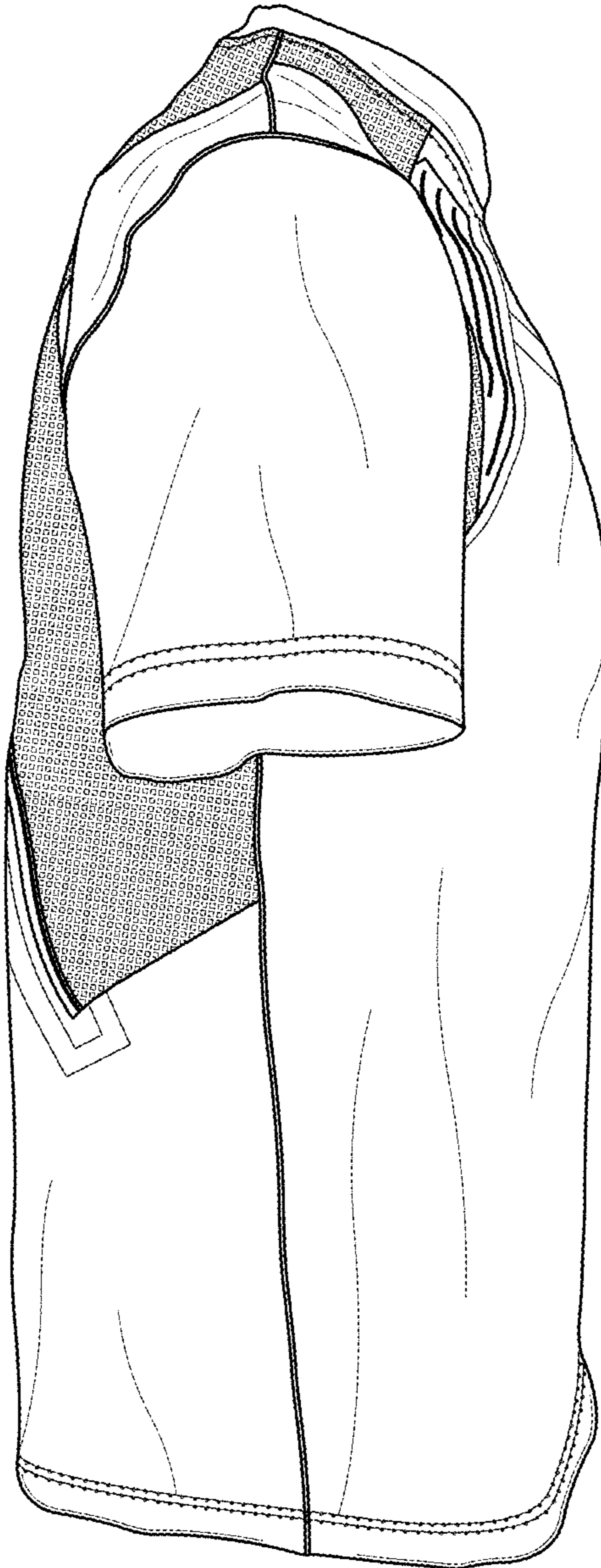

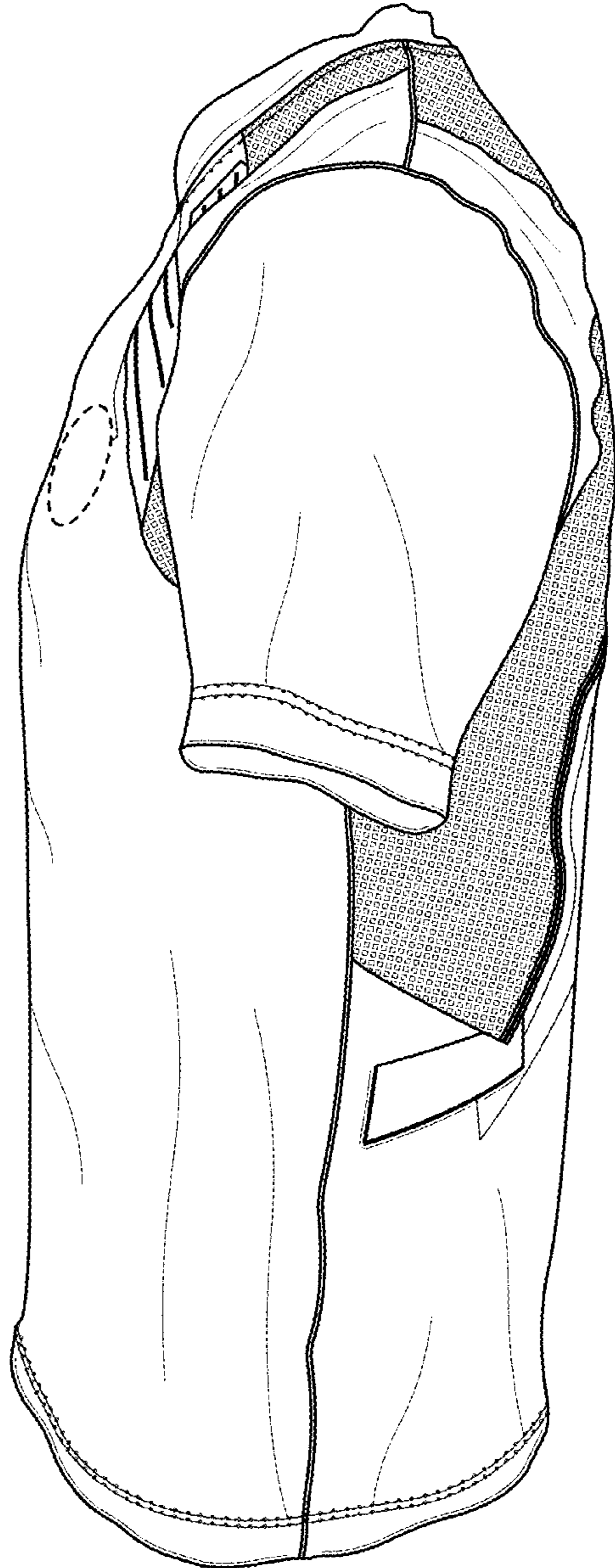

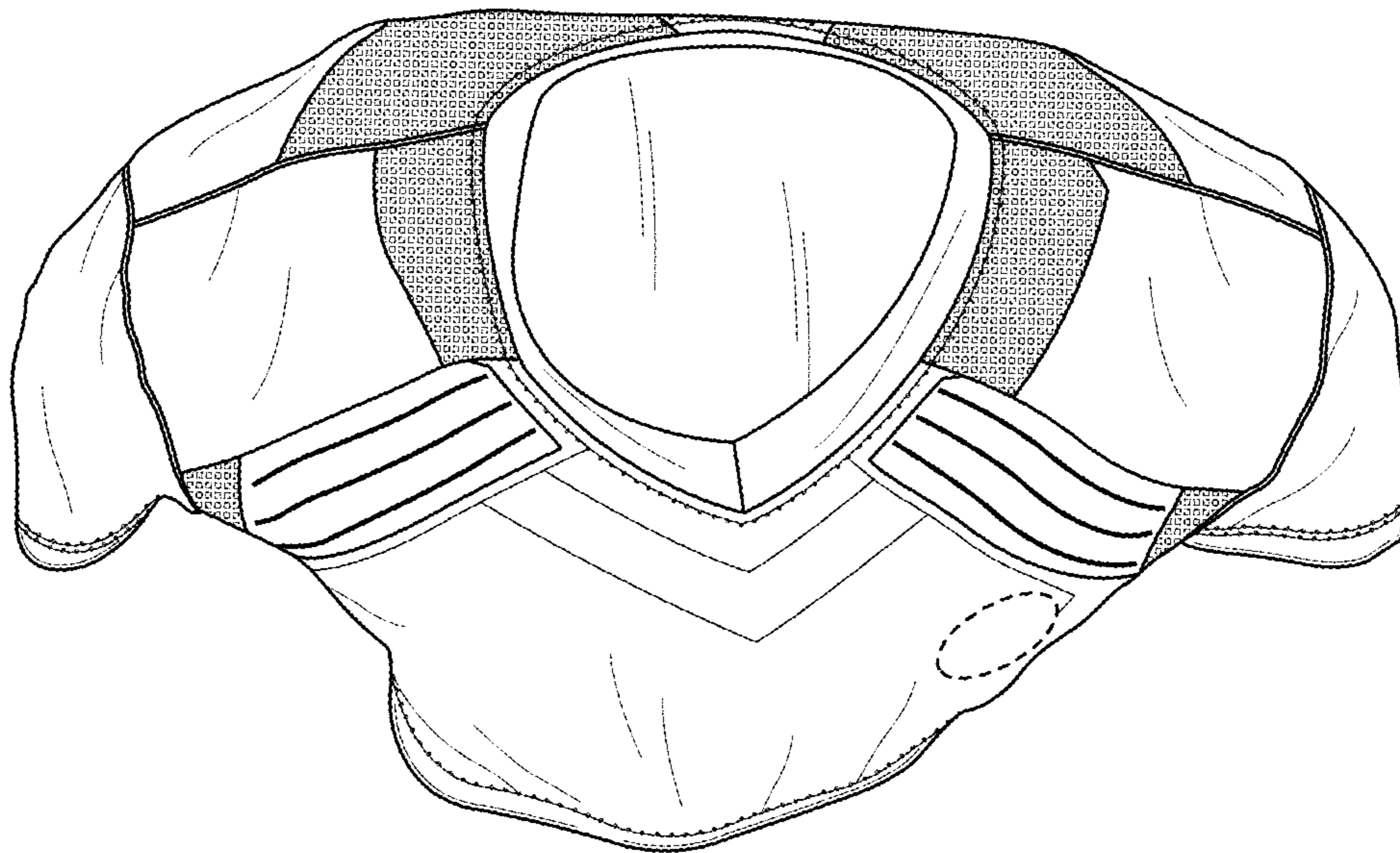
